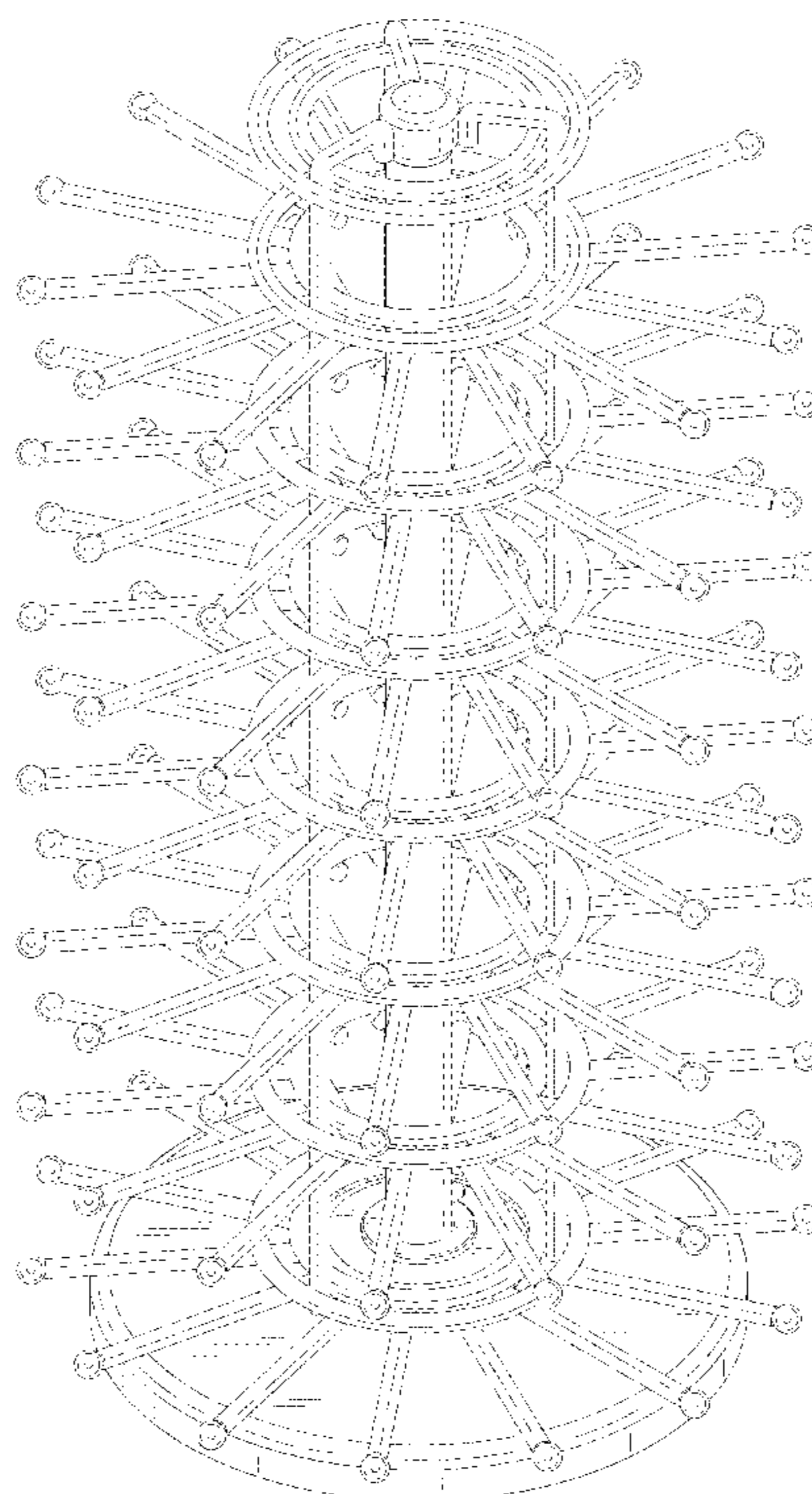
FIG. 1 is a Front Perspective view of a coffee capsule storage display rack showing my new design;

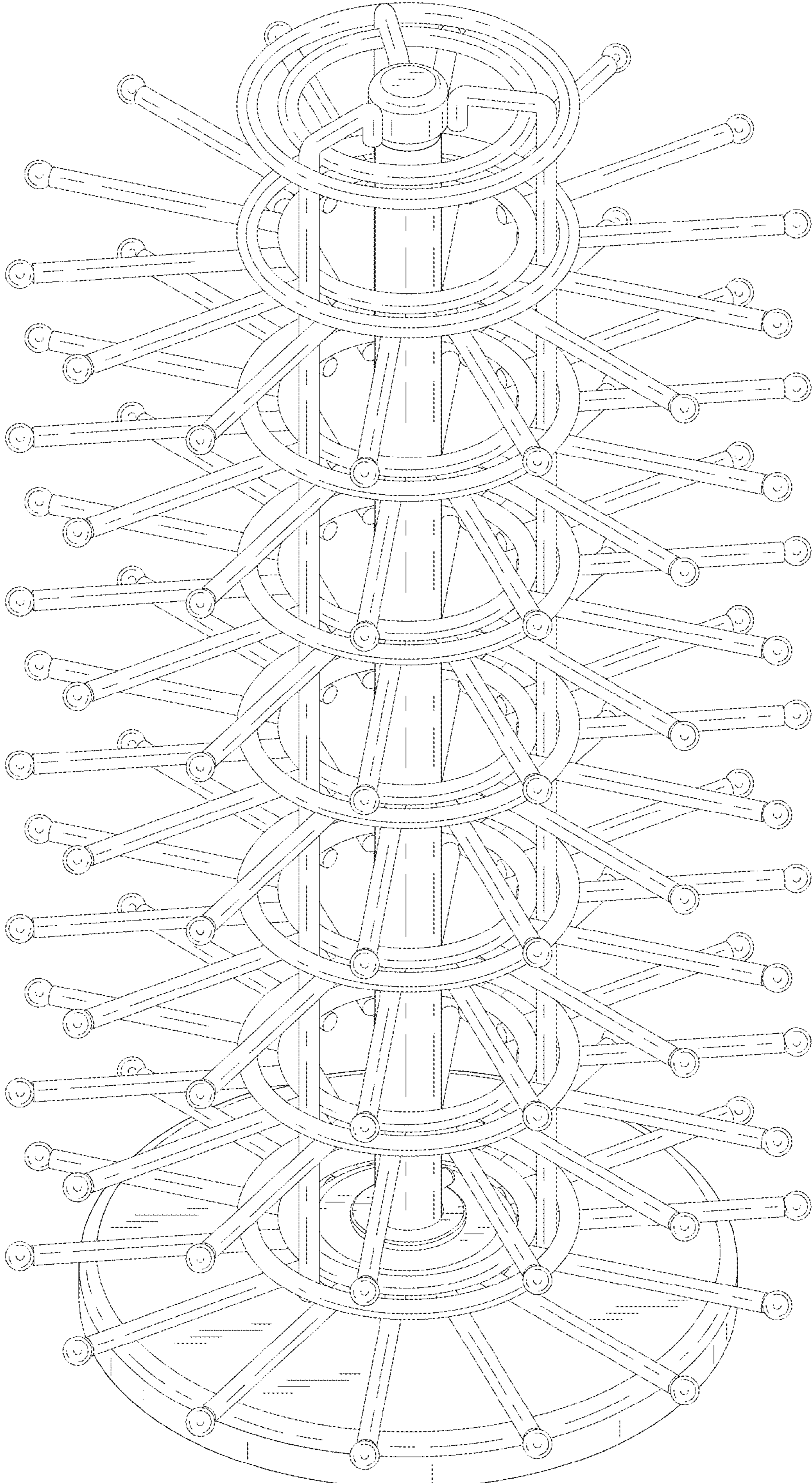

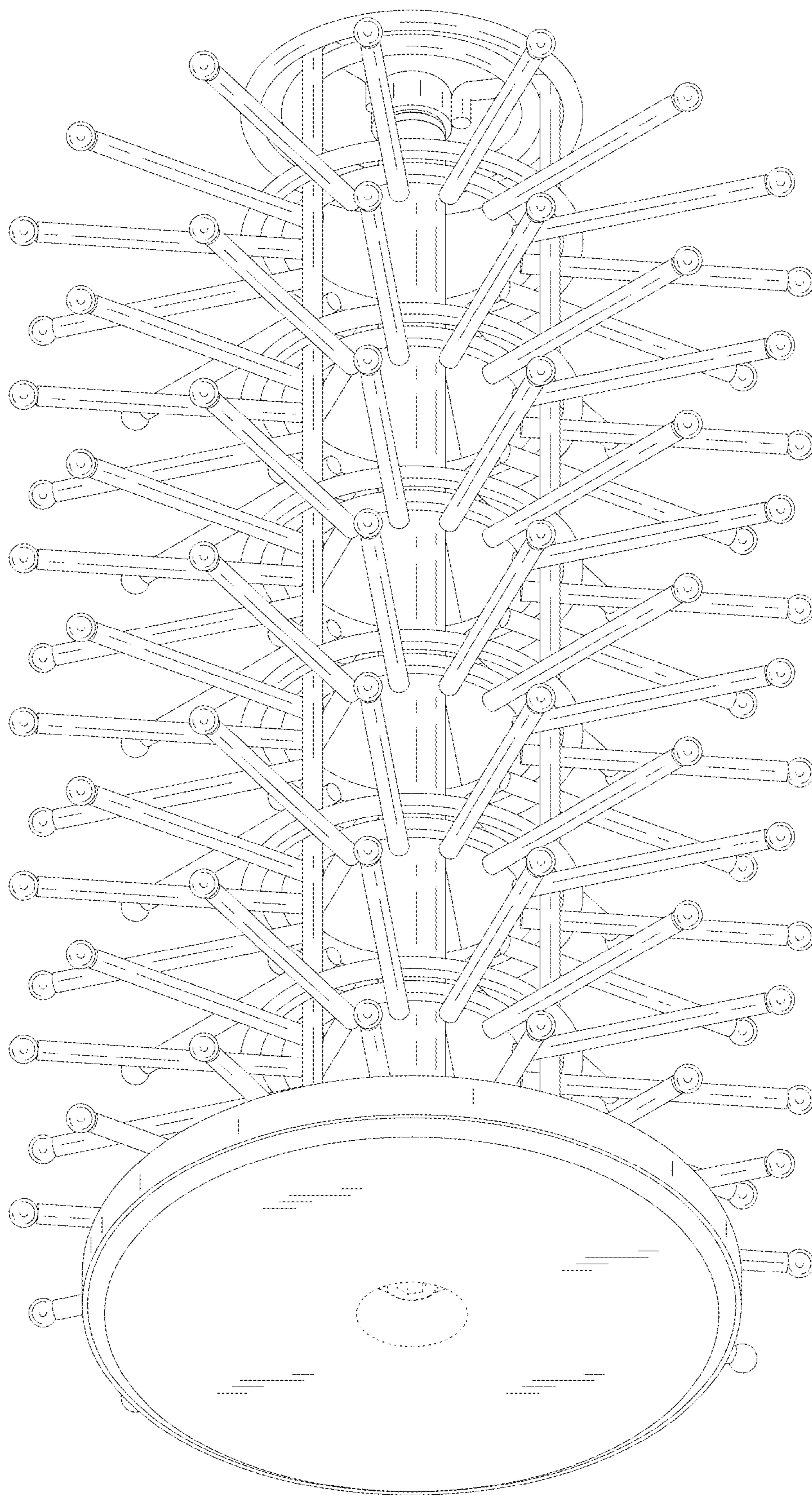

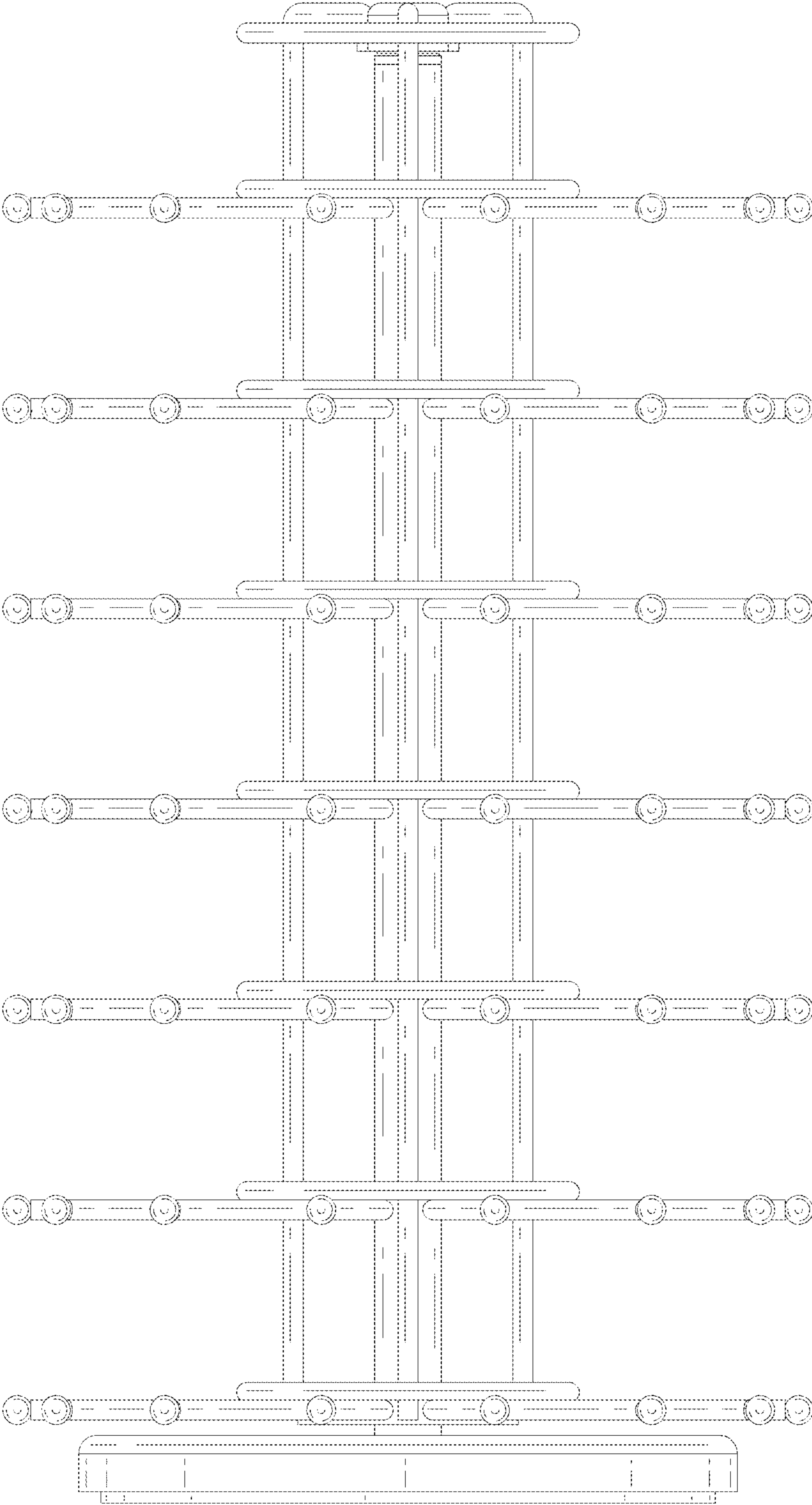

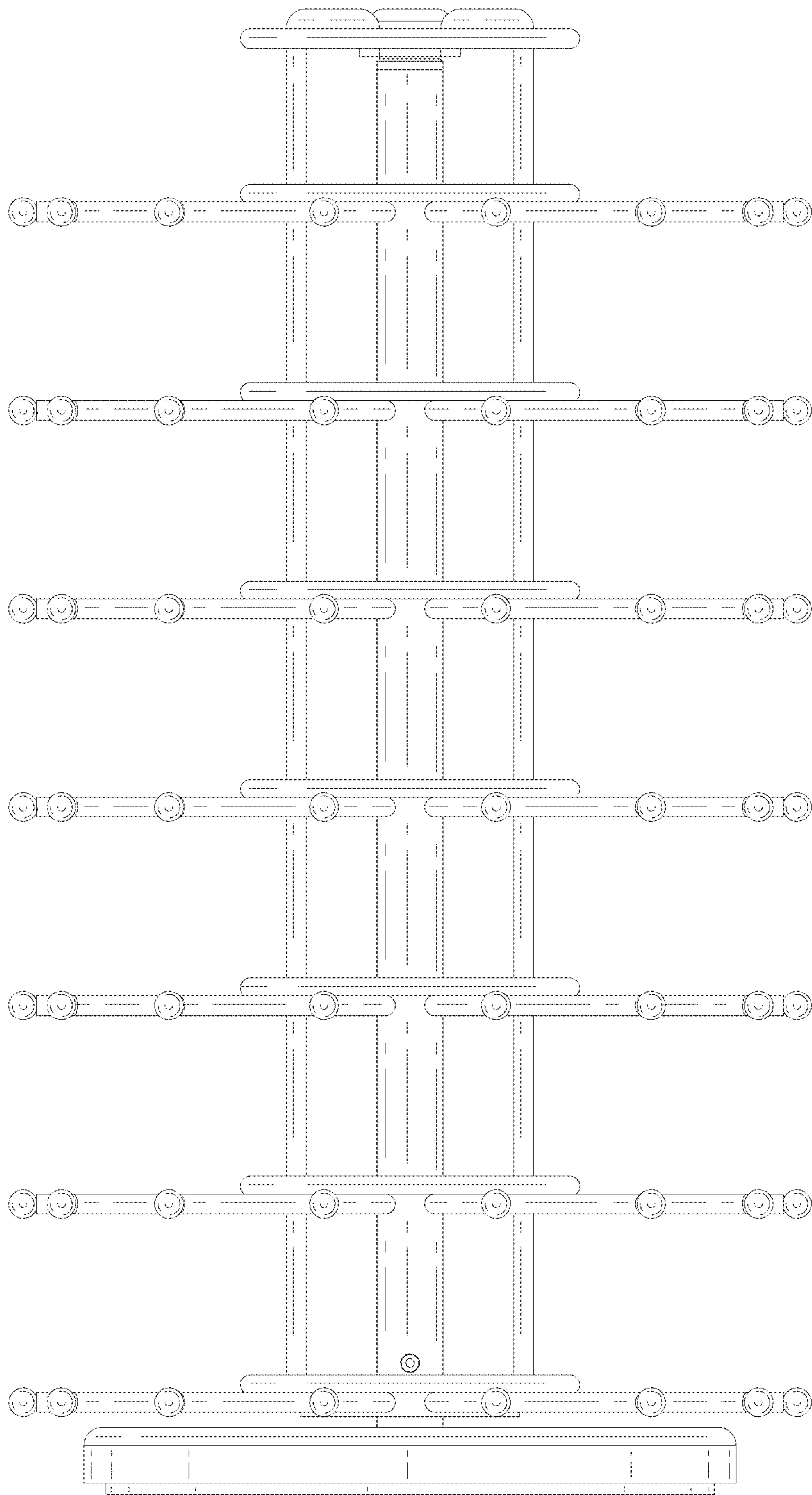

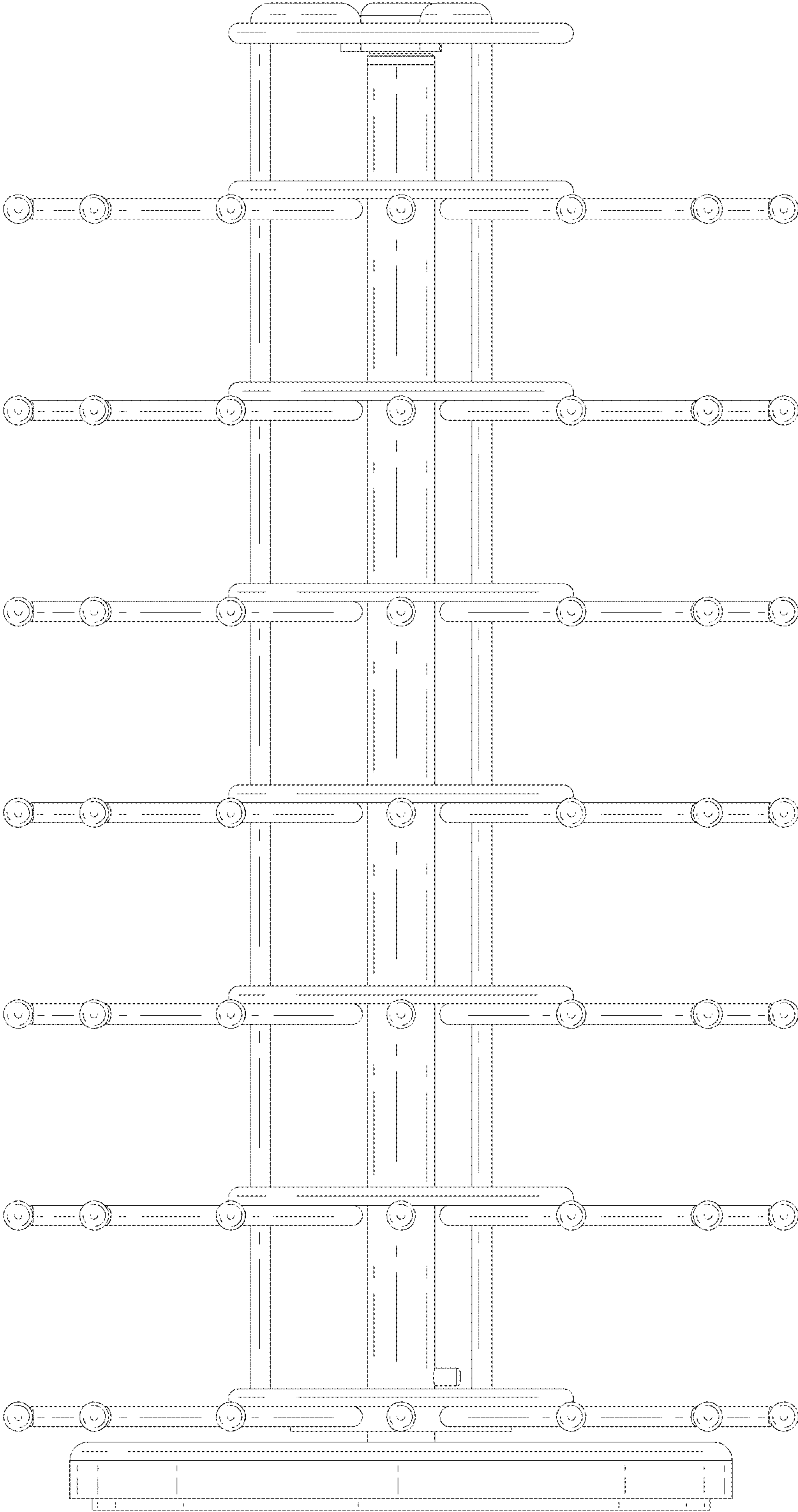

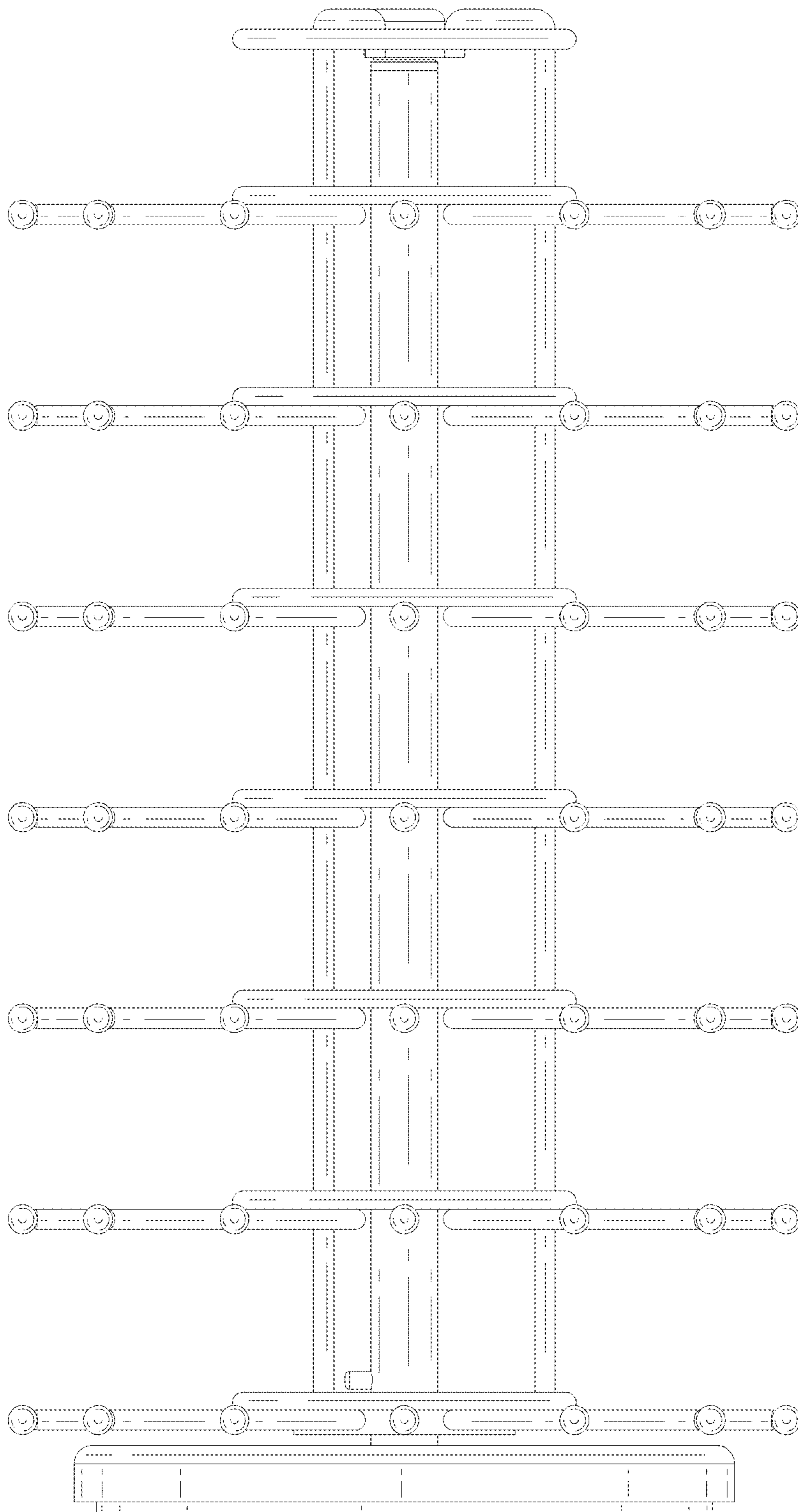

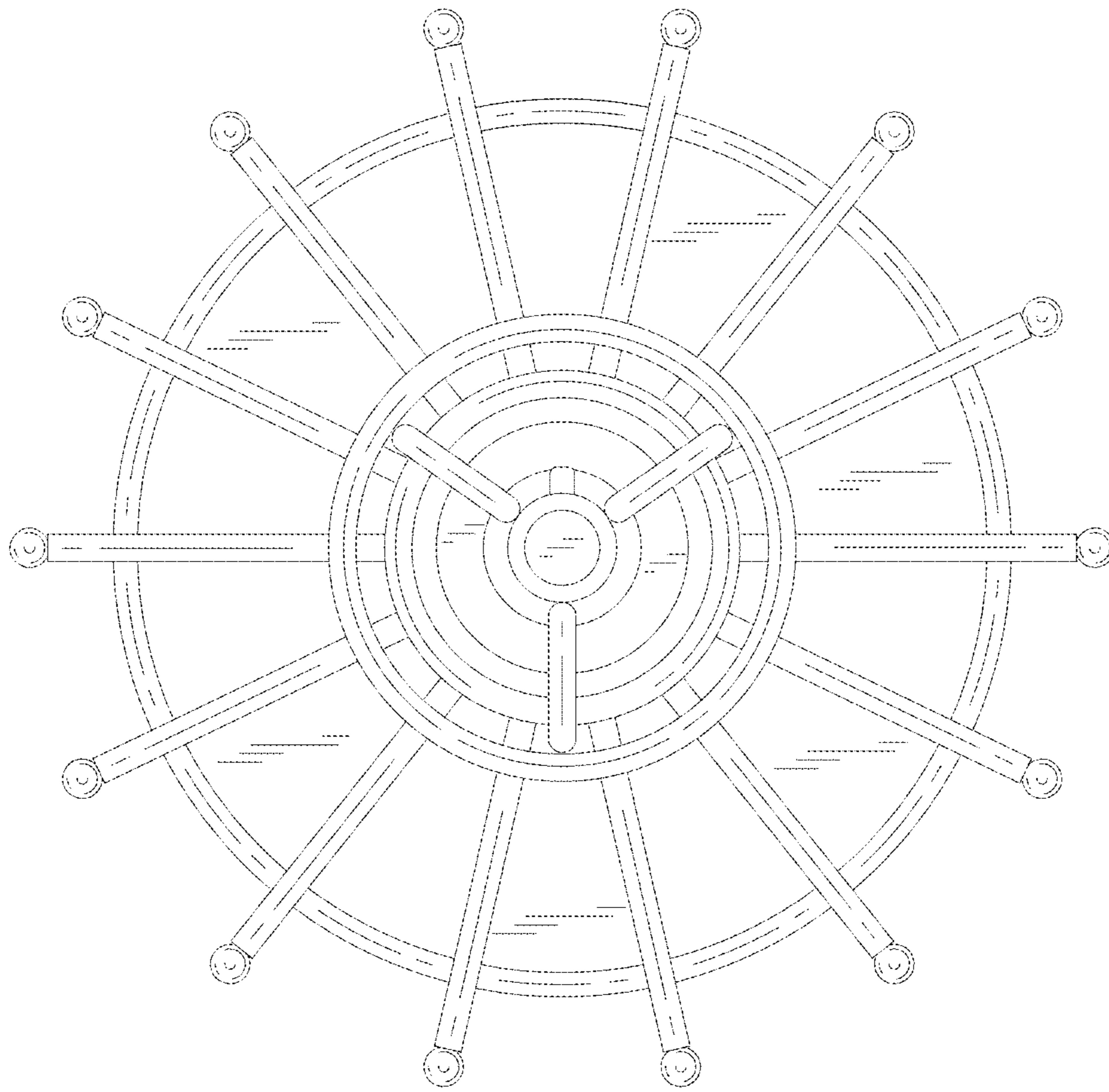

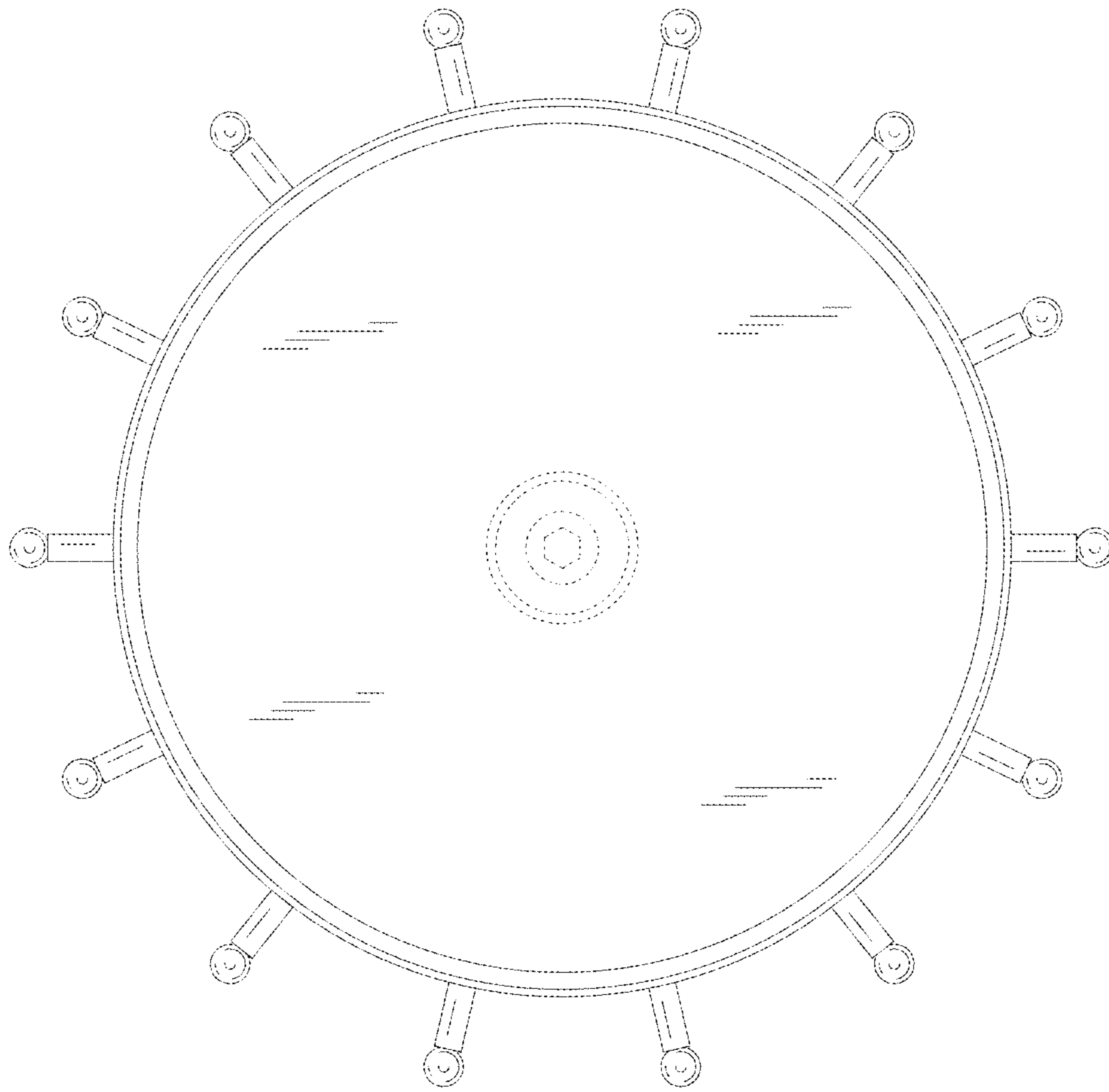

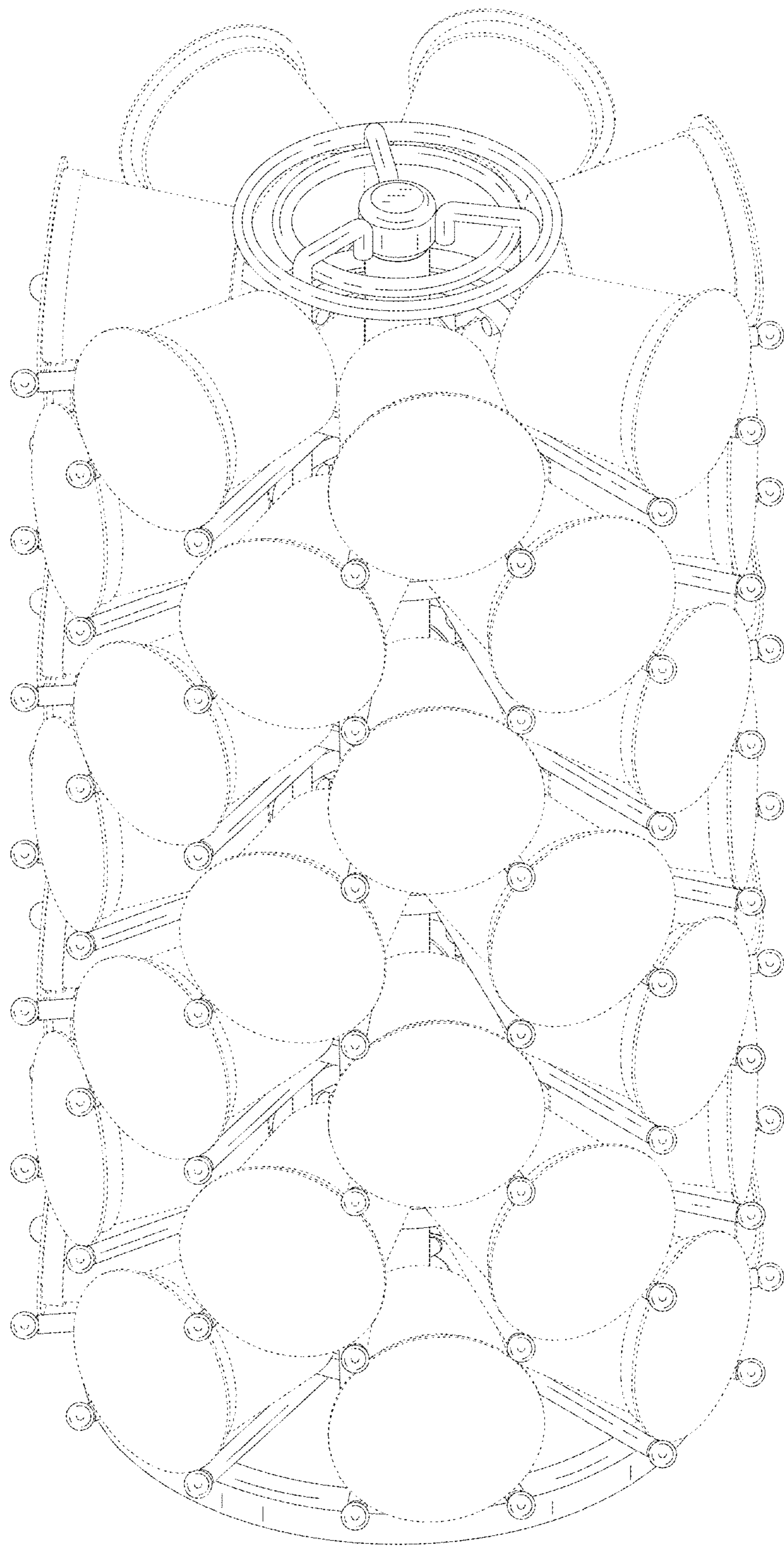
