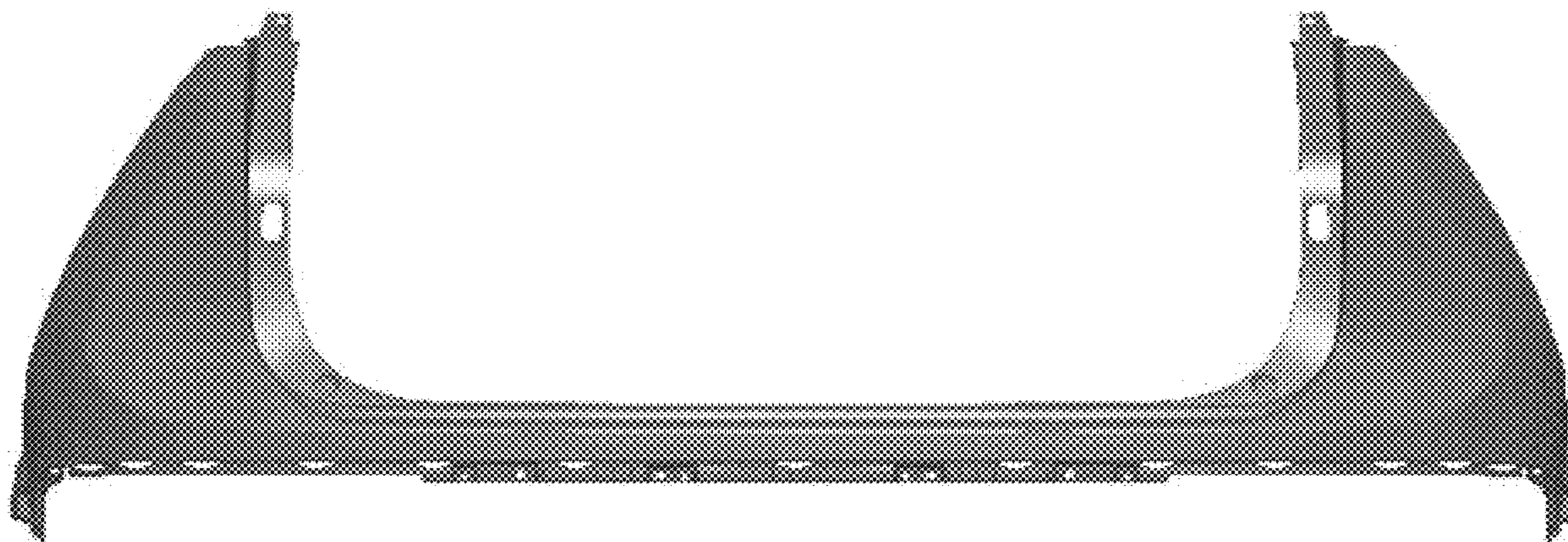
The ornamental design for a rear bumper upper cover for automobile, as shown and described.

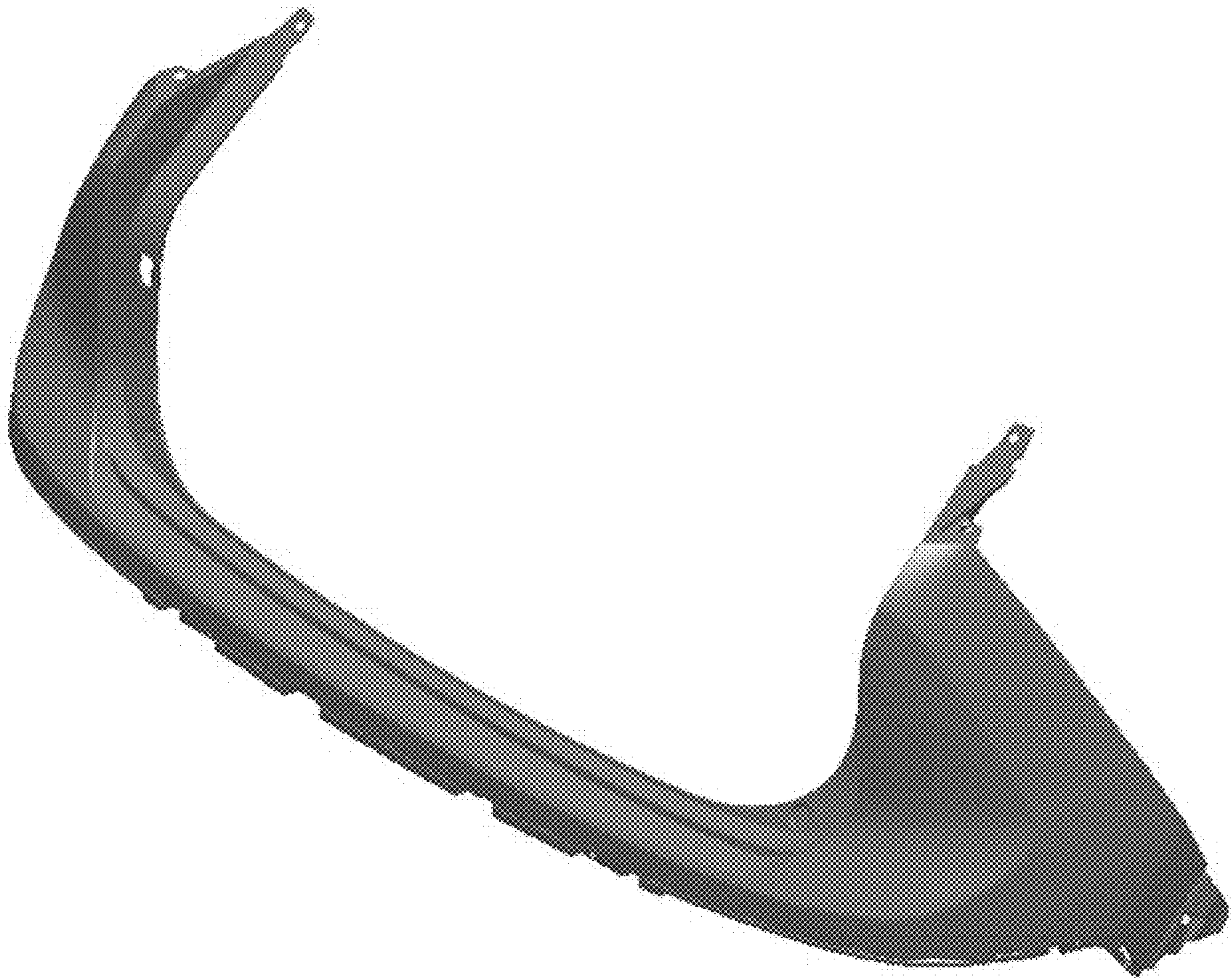

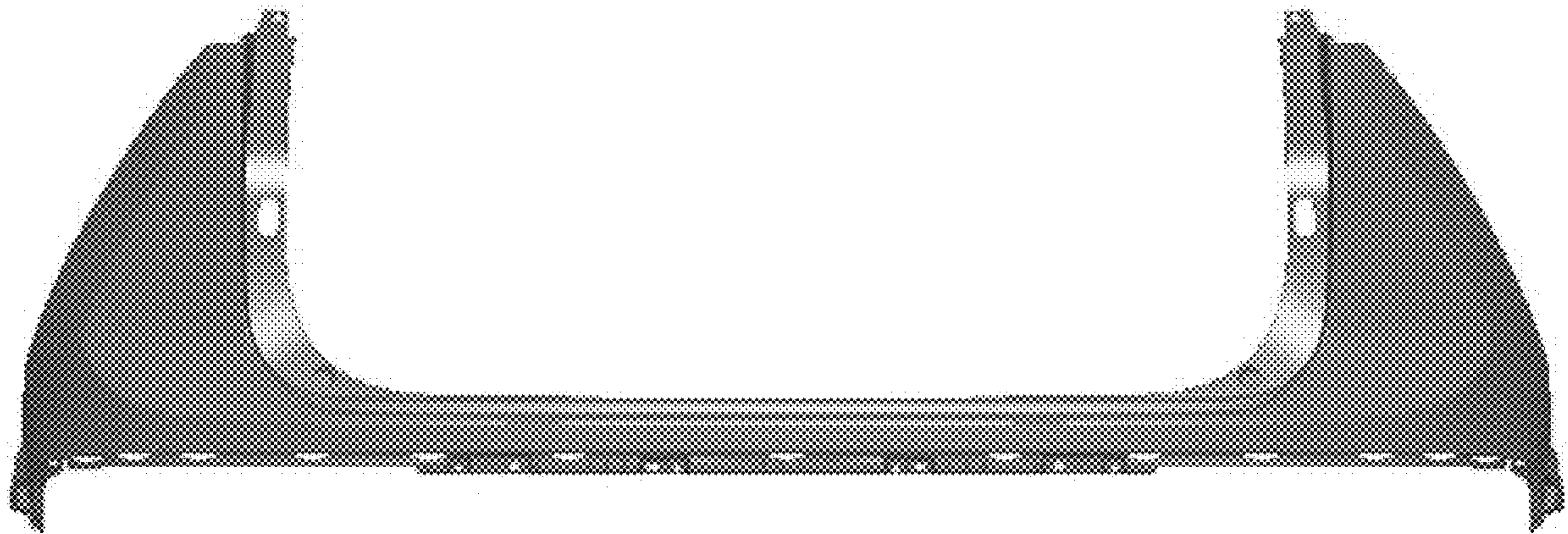

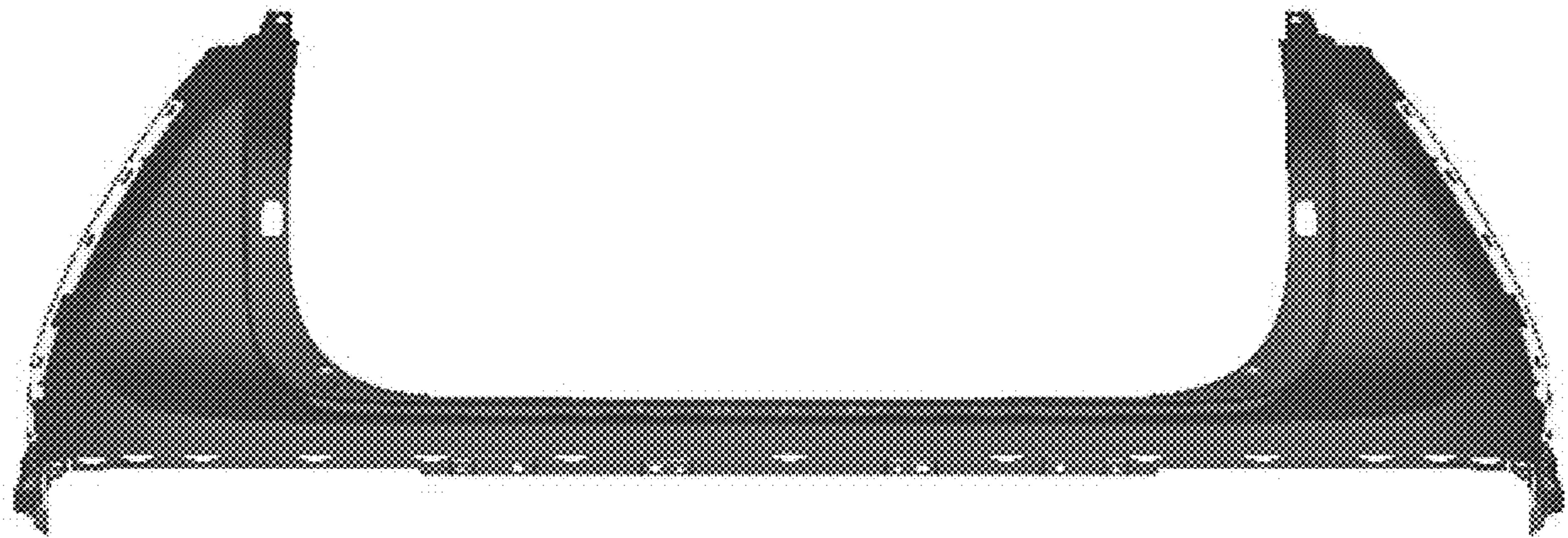

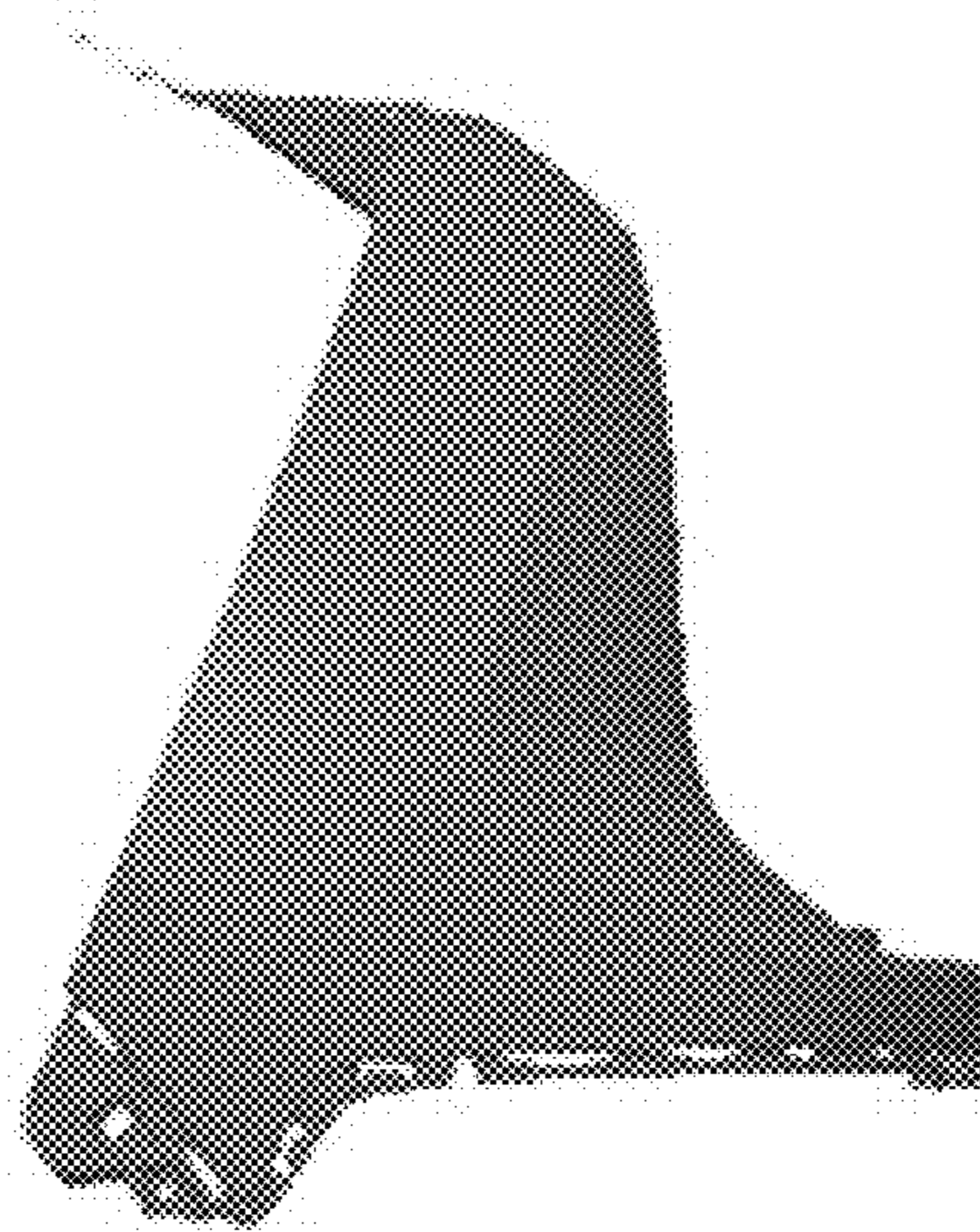

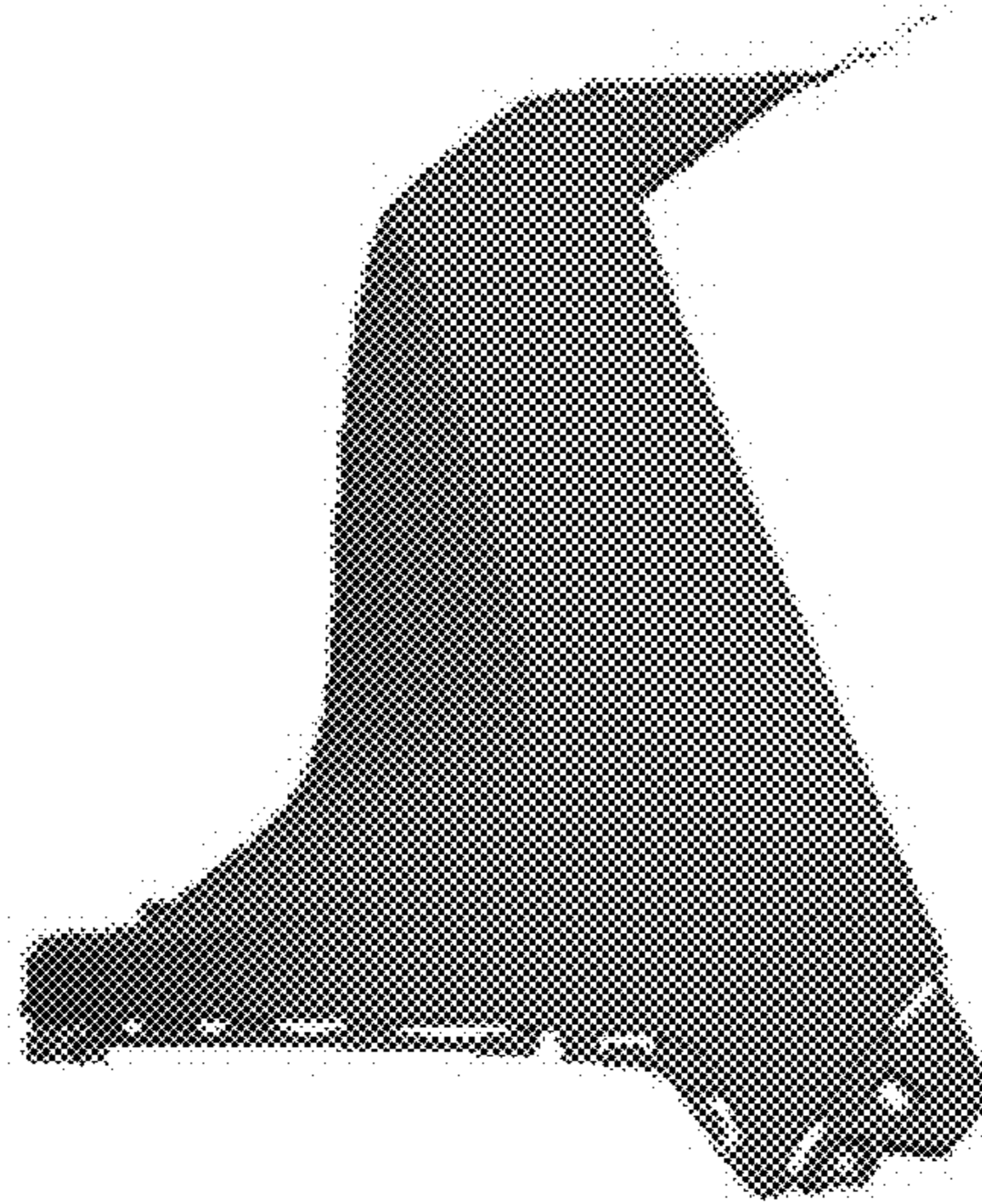
