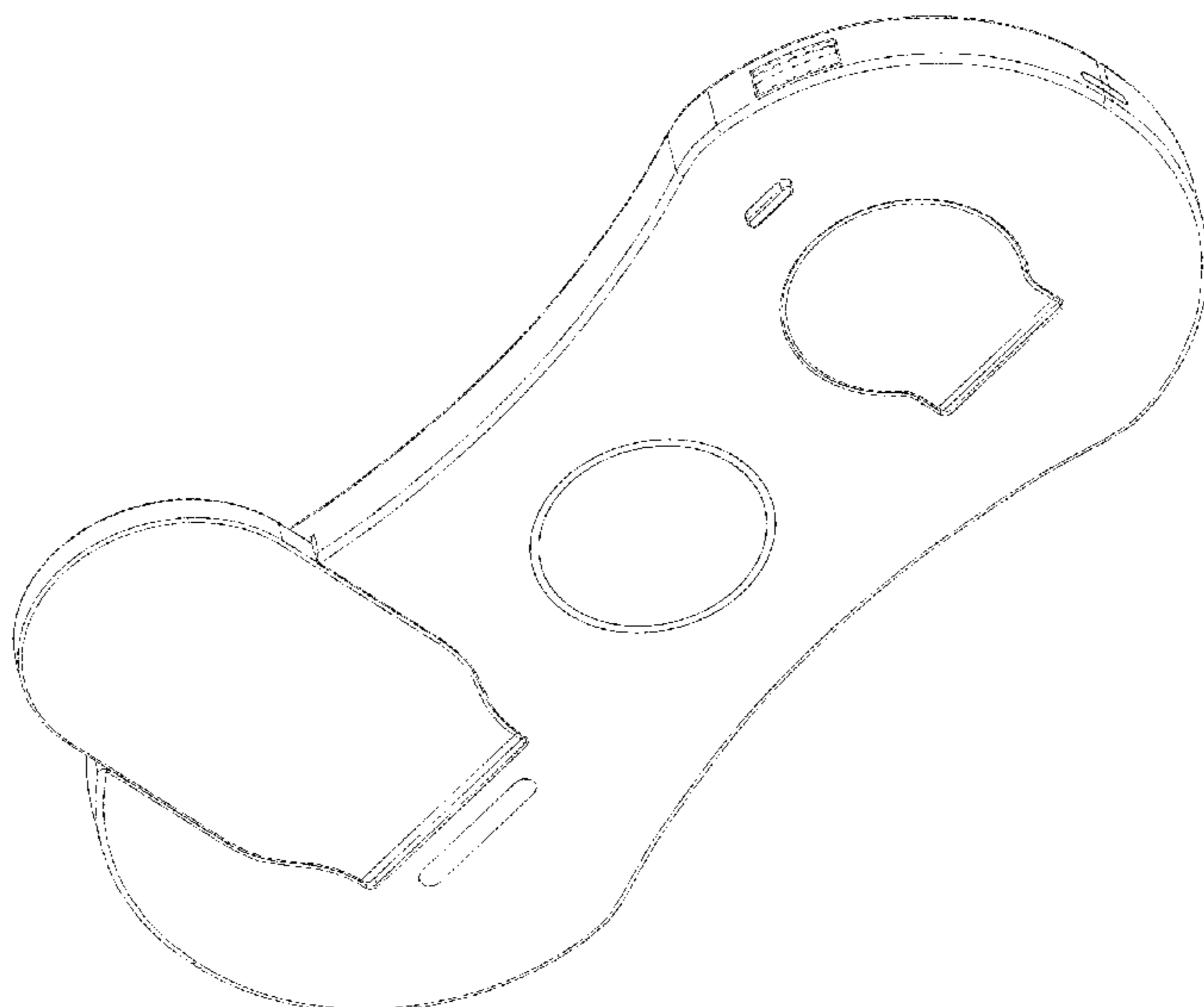
(57) **CLAIM**

The ornamental design for a multifunctional wireless charger holder, as shown and described.

**DESCRIPTION**

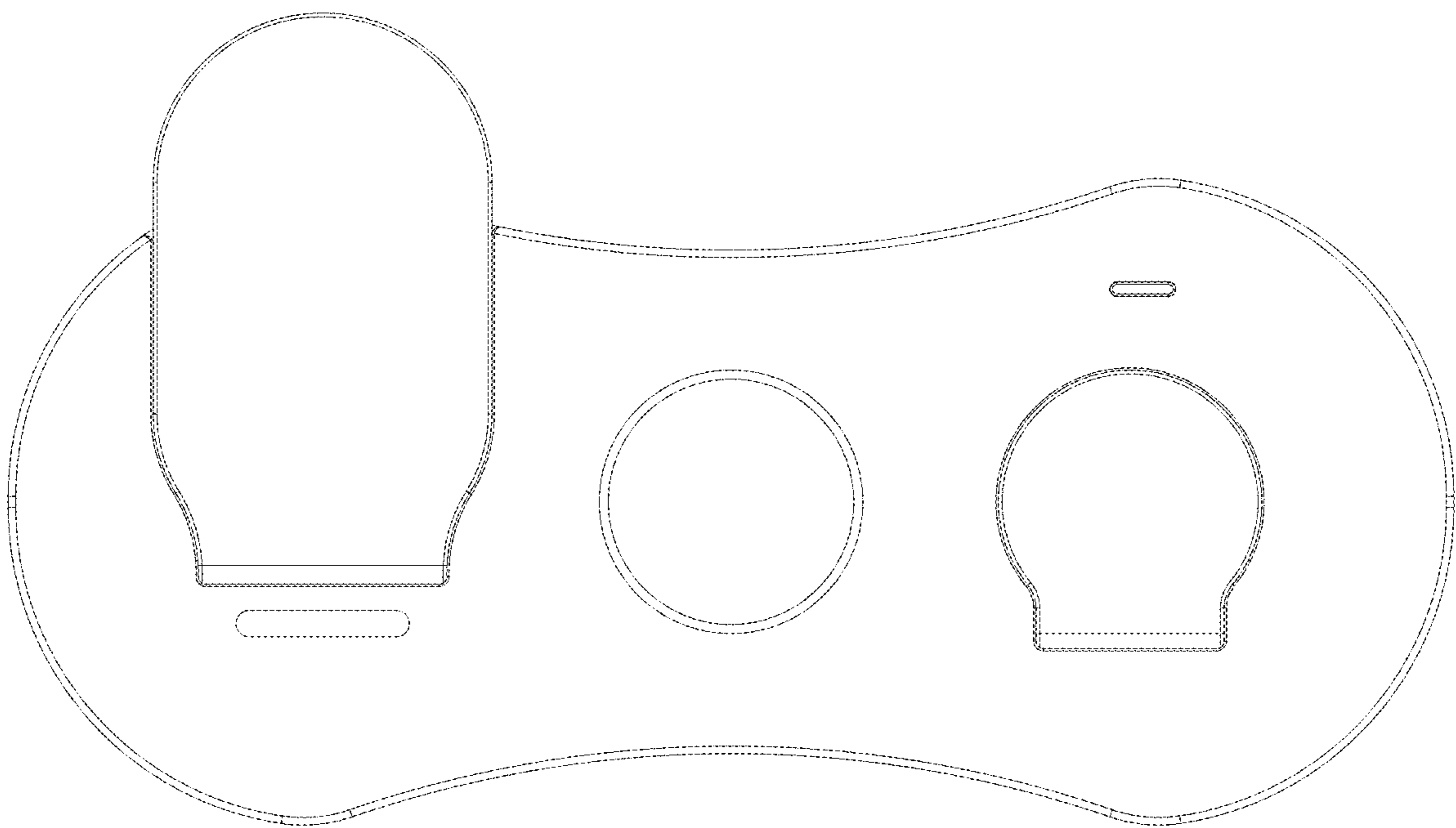

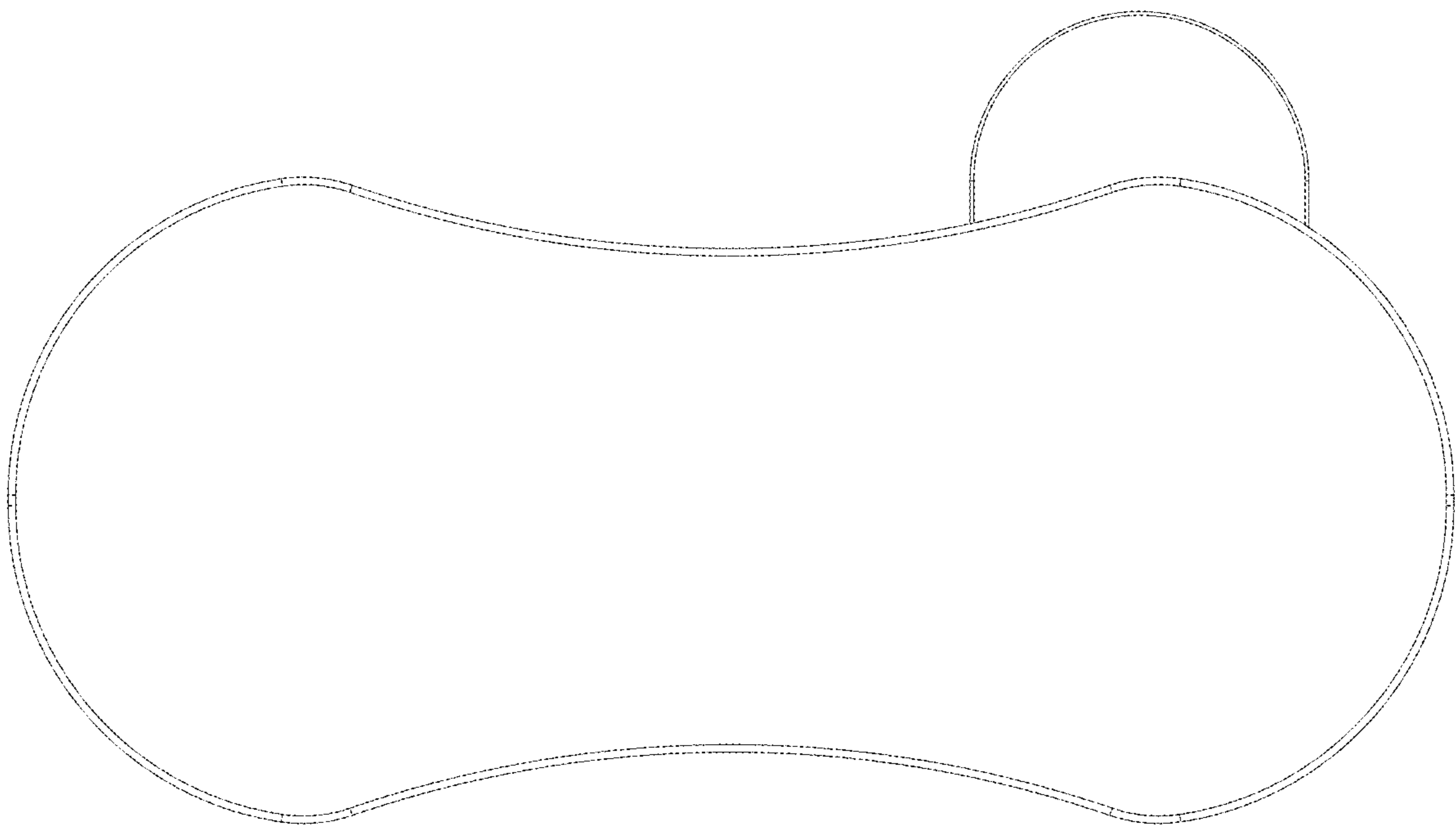

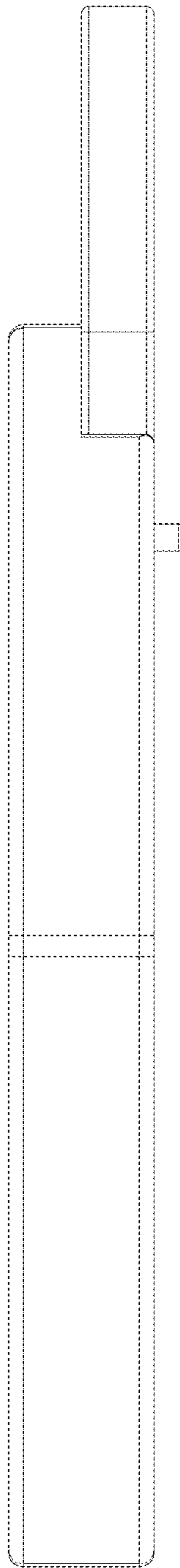

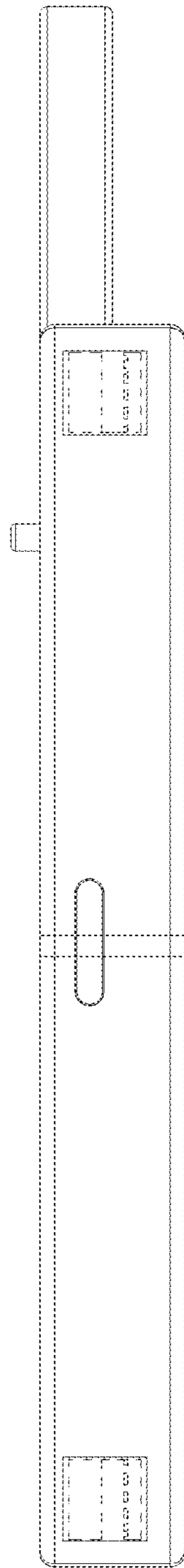

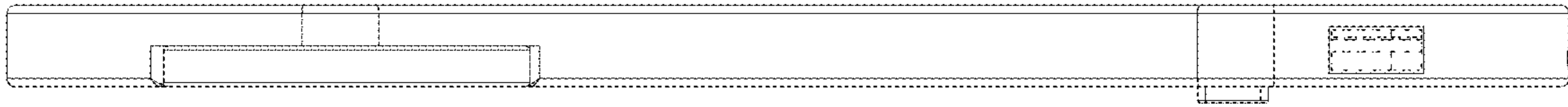

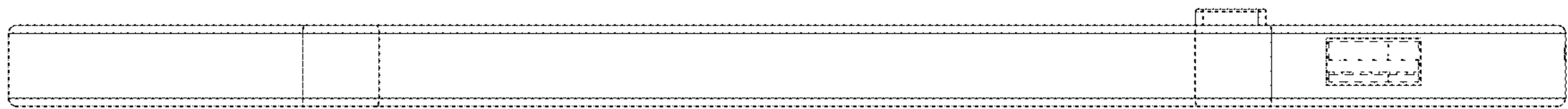

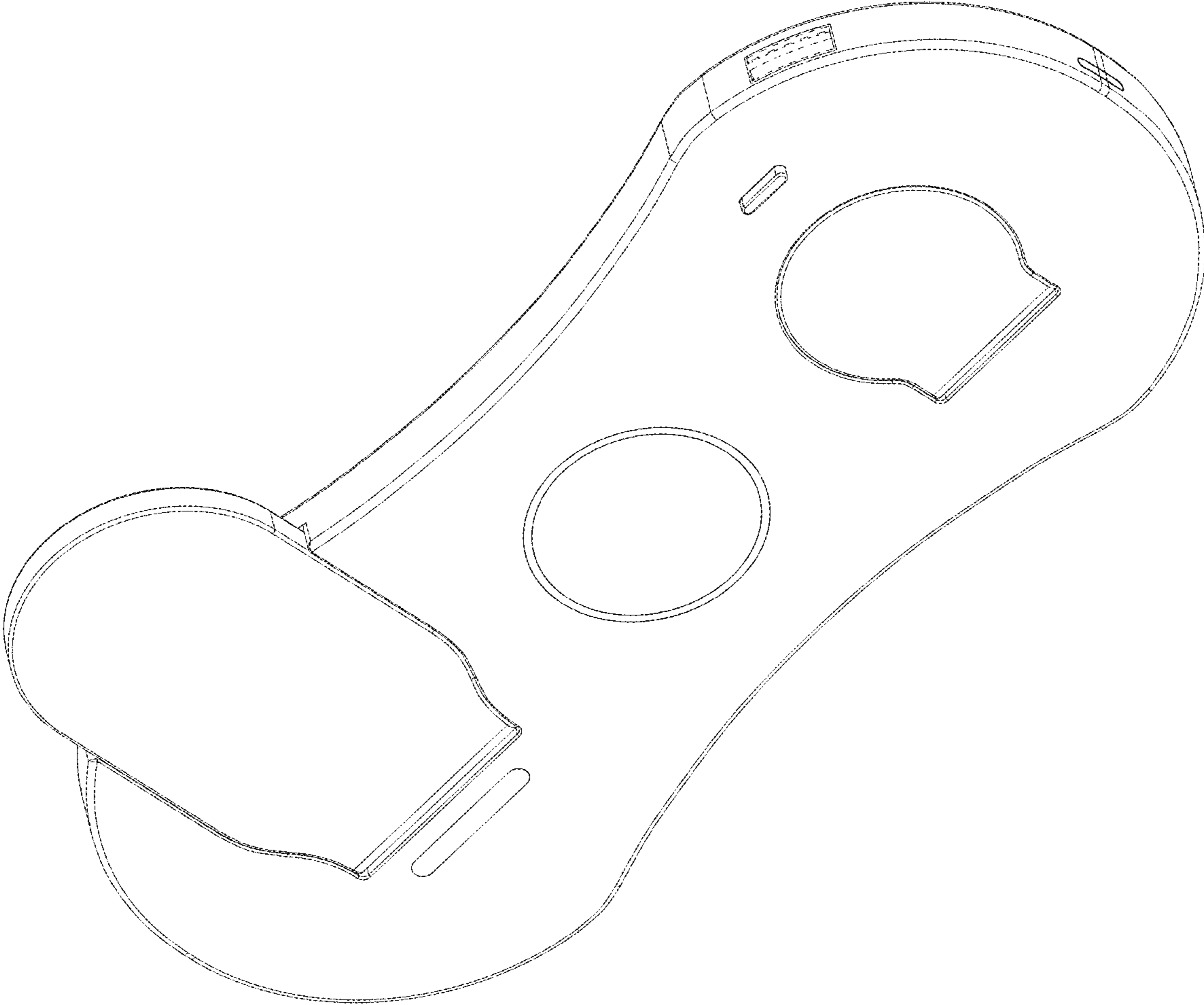

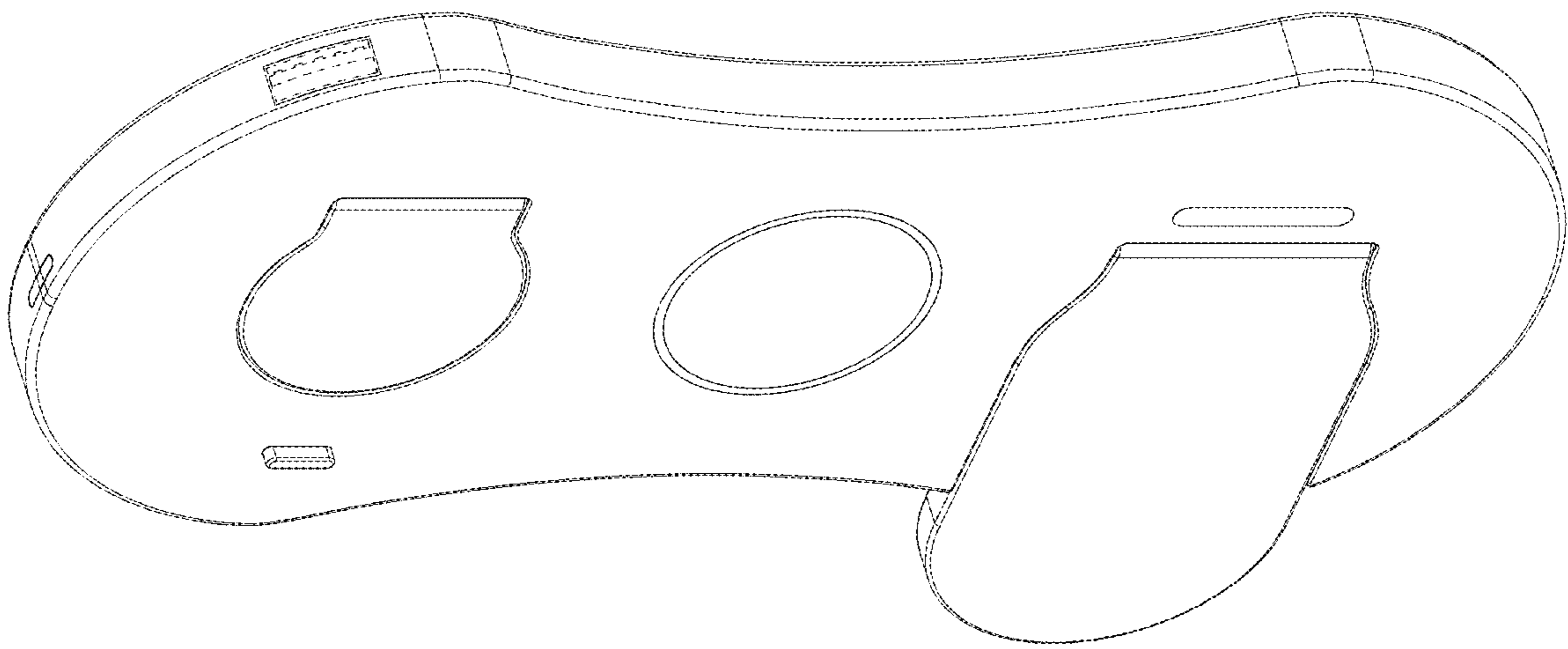
