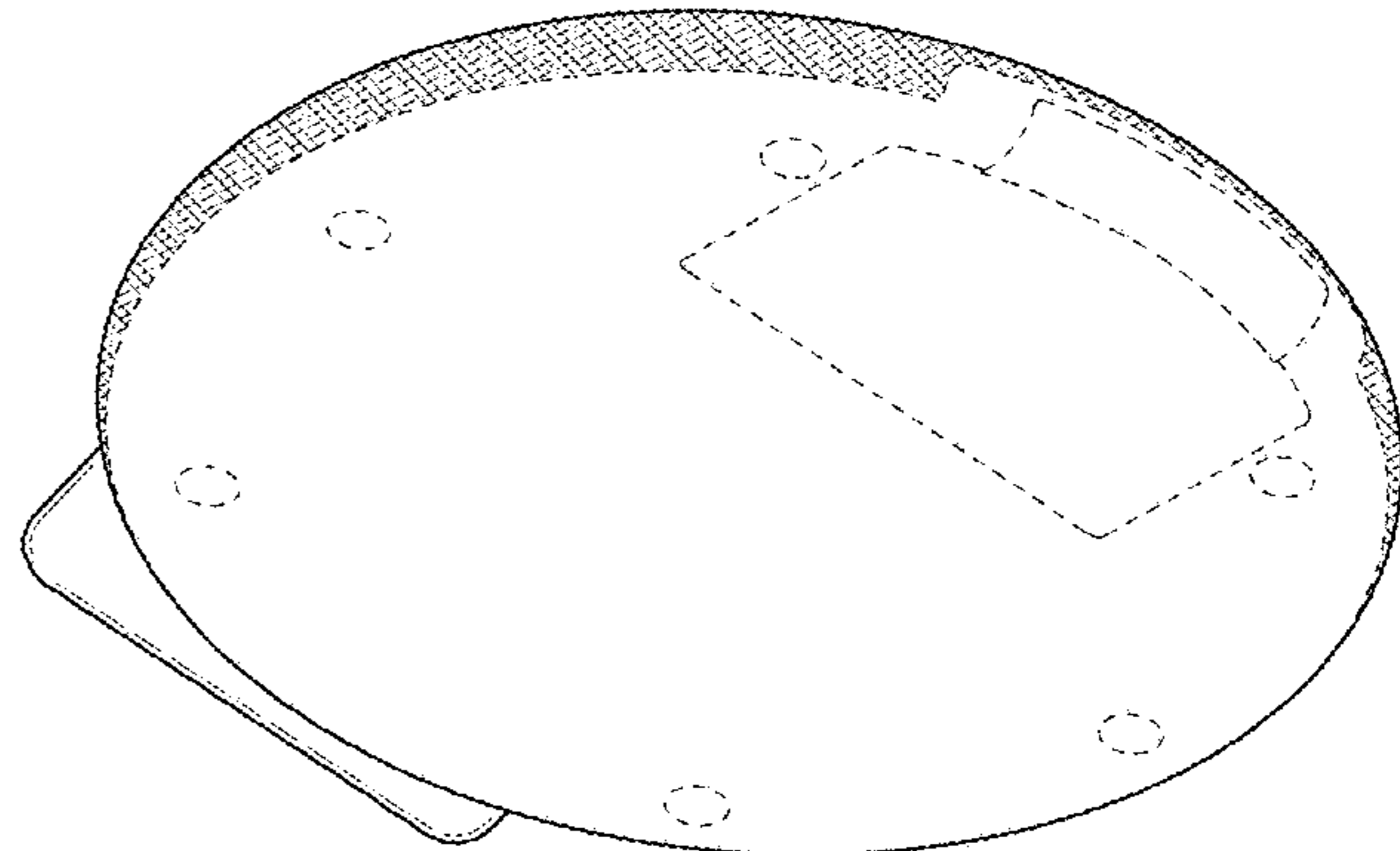
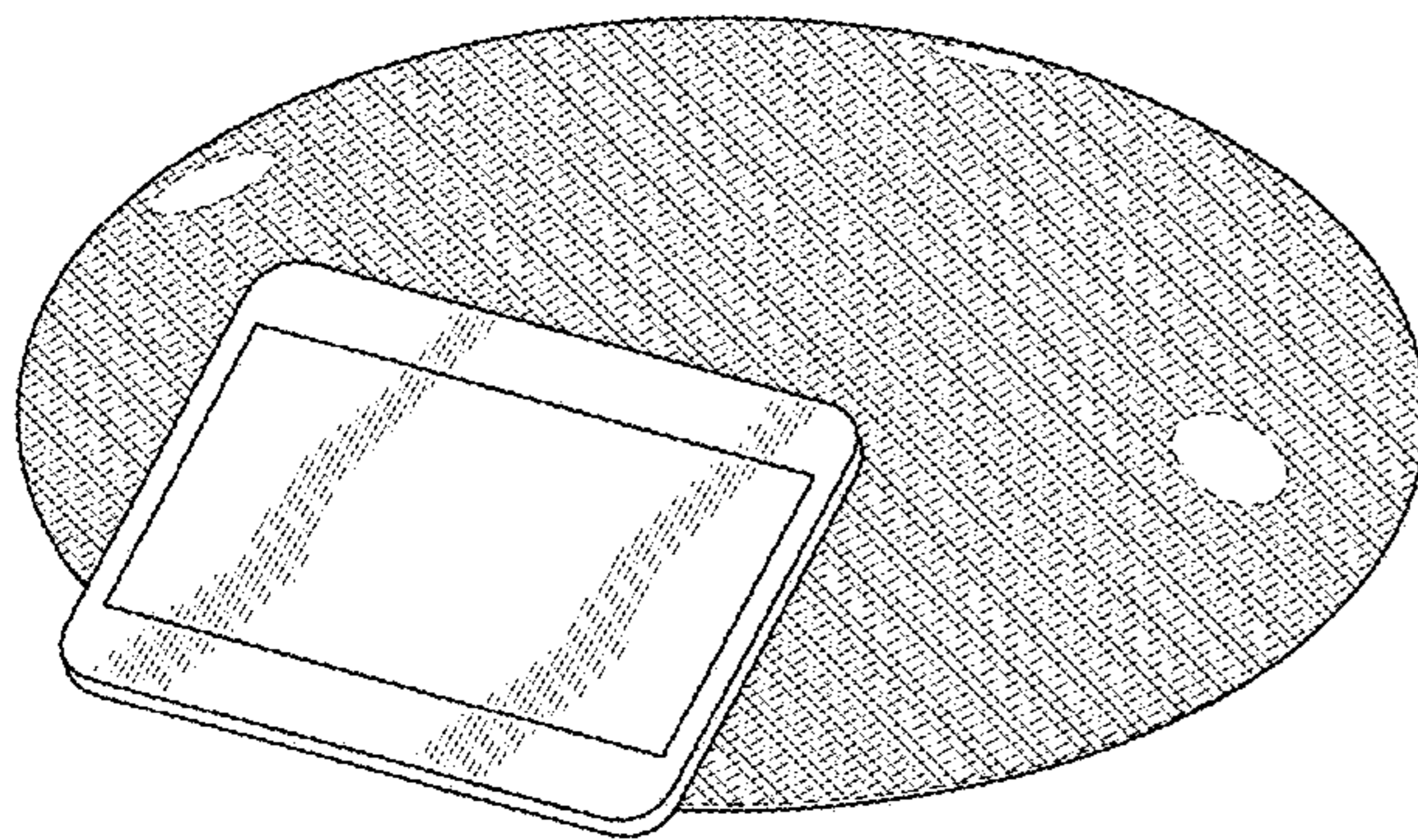
The ornamental design for a conferencing device, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front side perspective view of a conferencing device showing our new design;

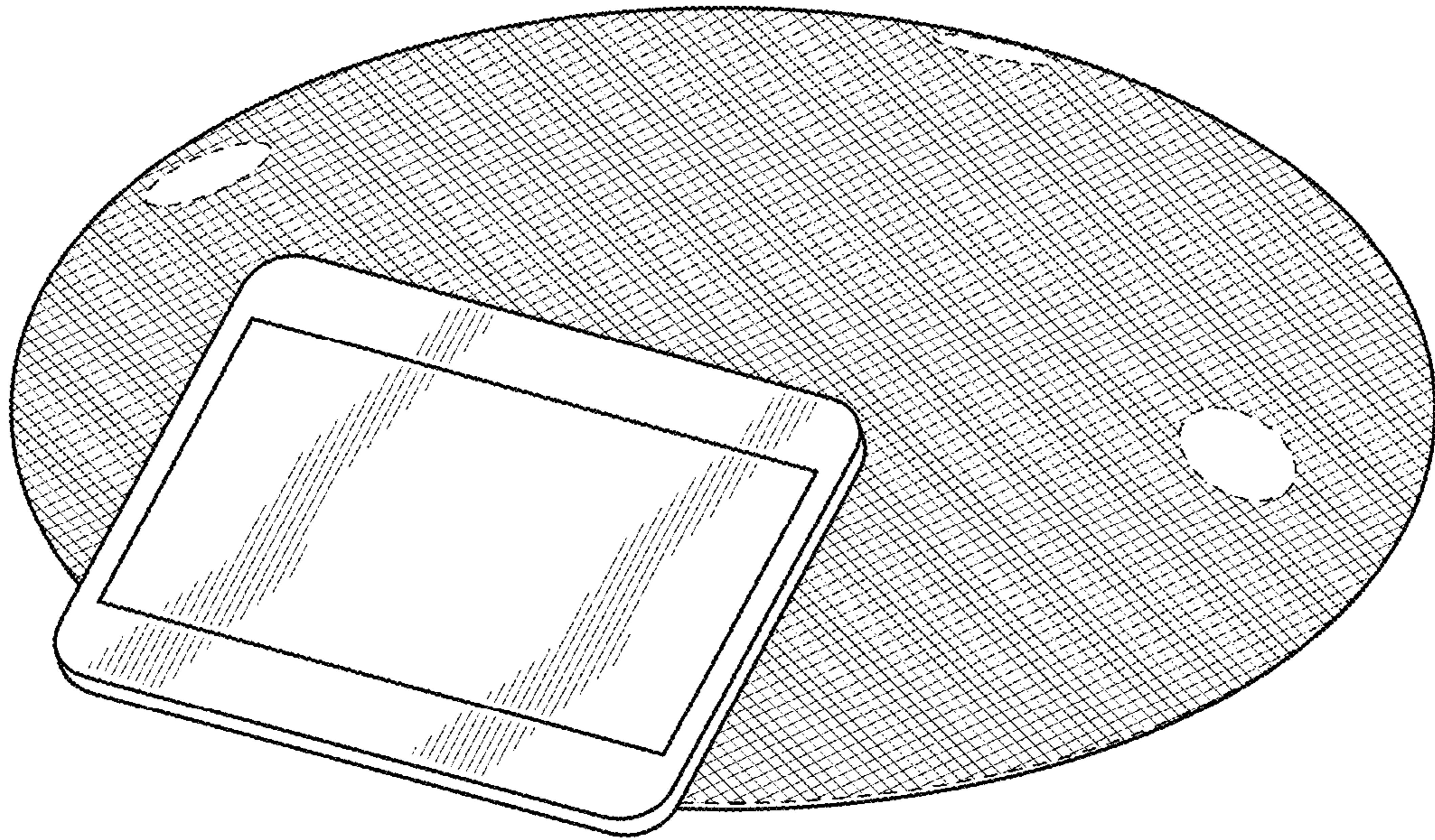

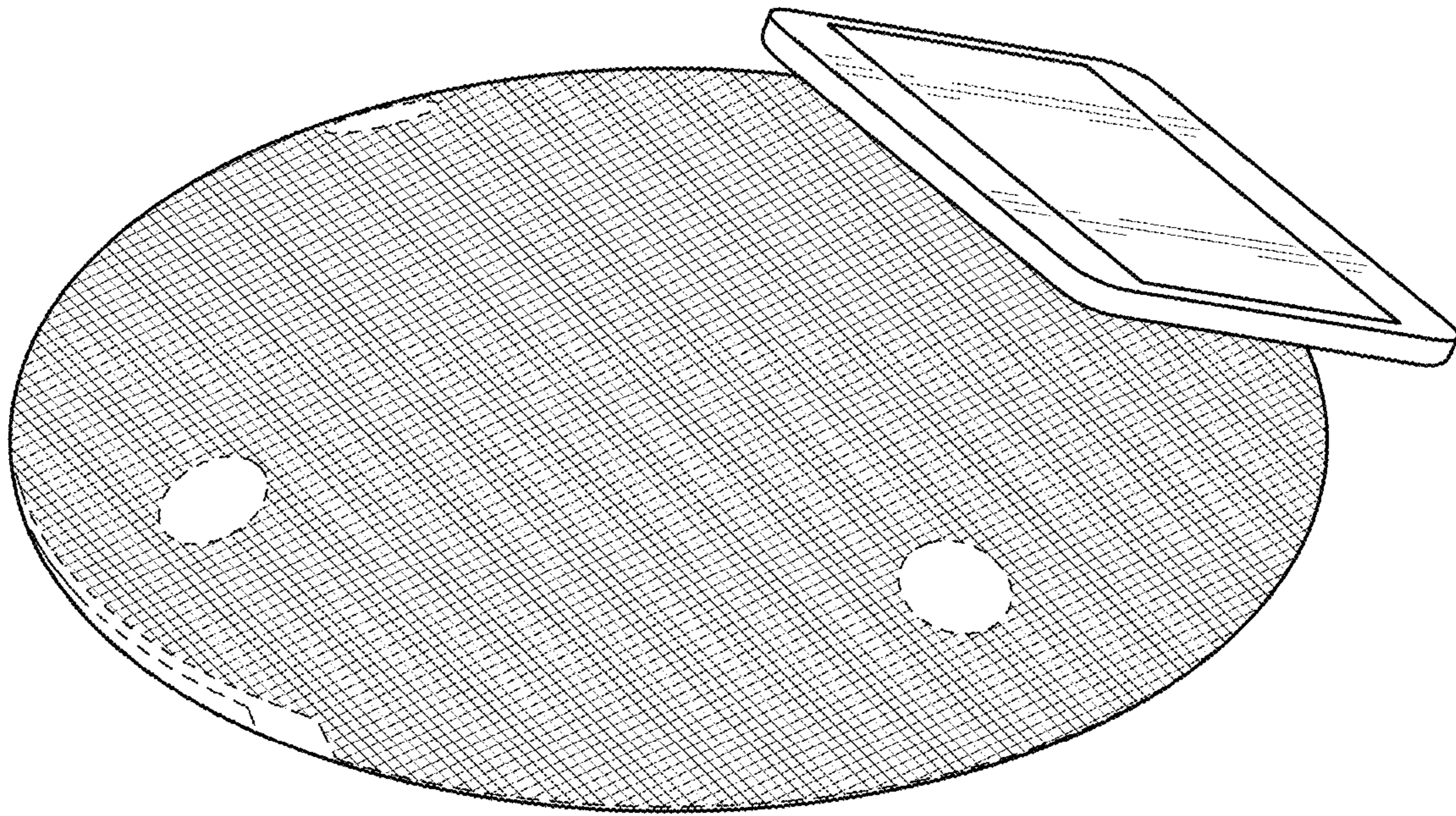

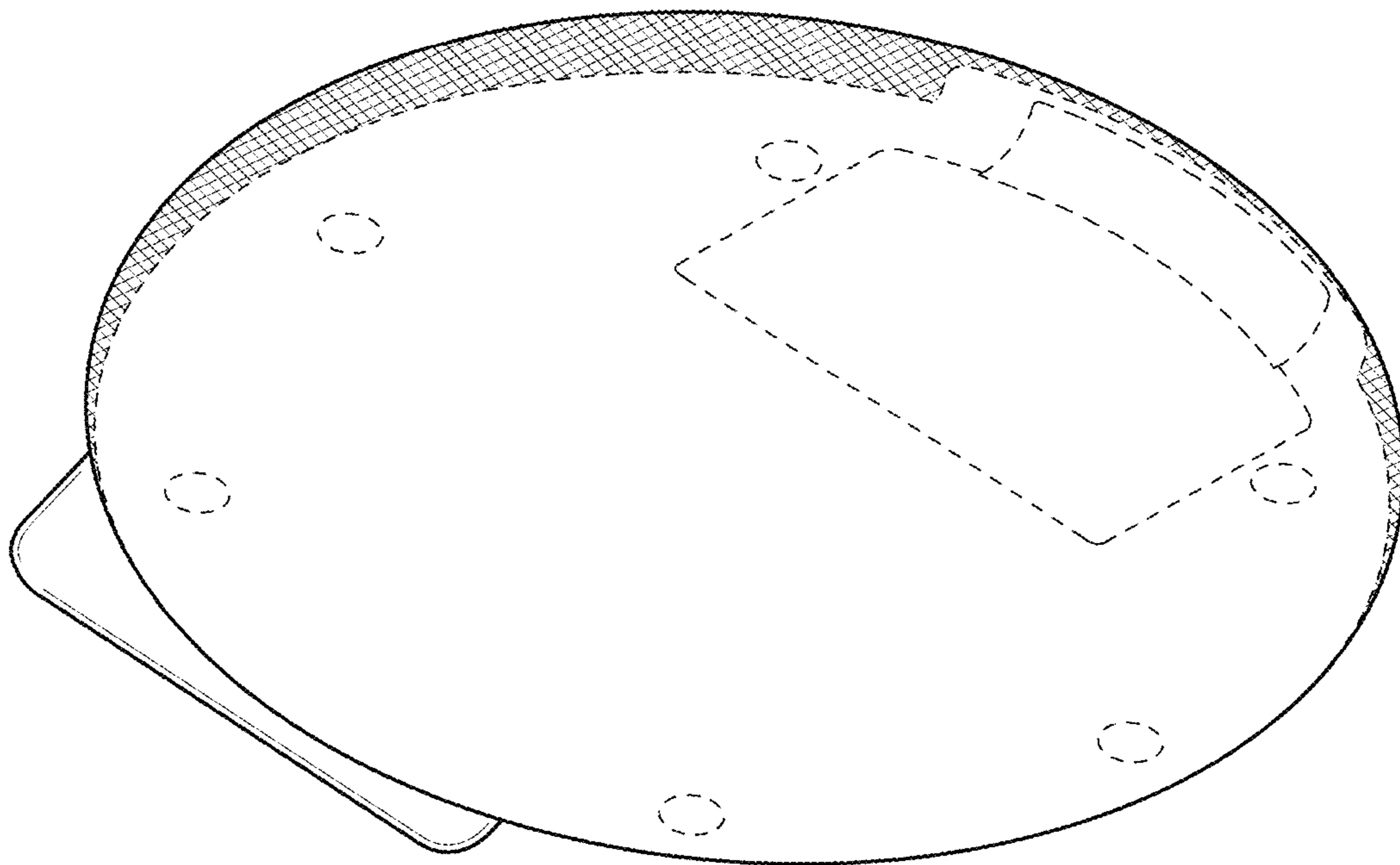

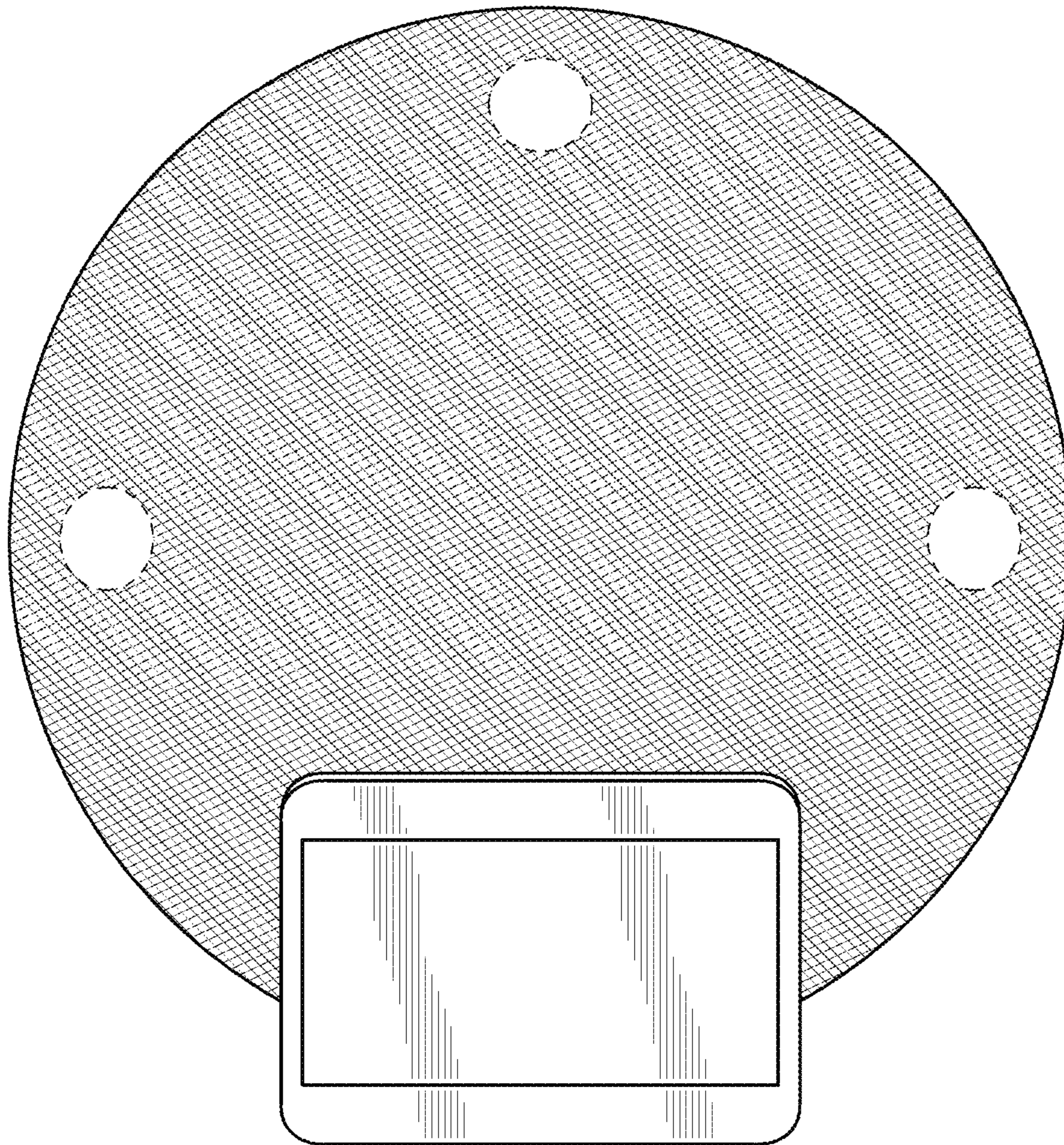

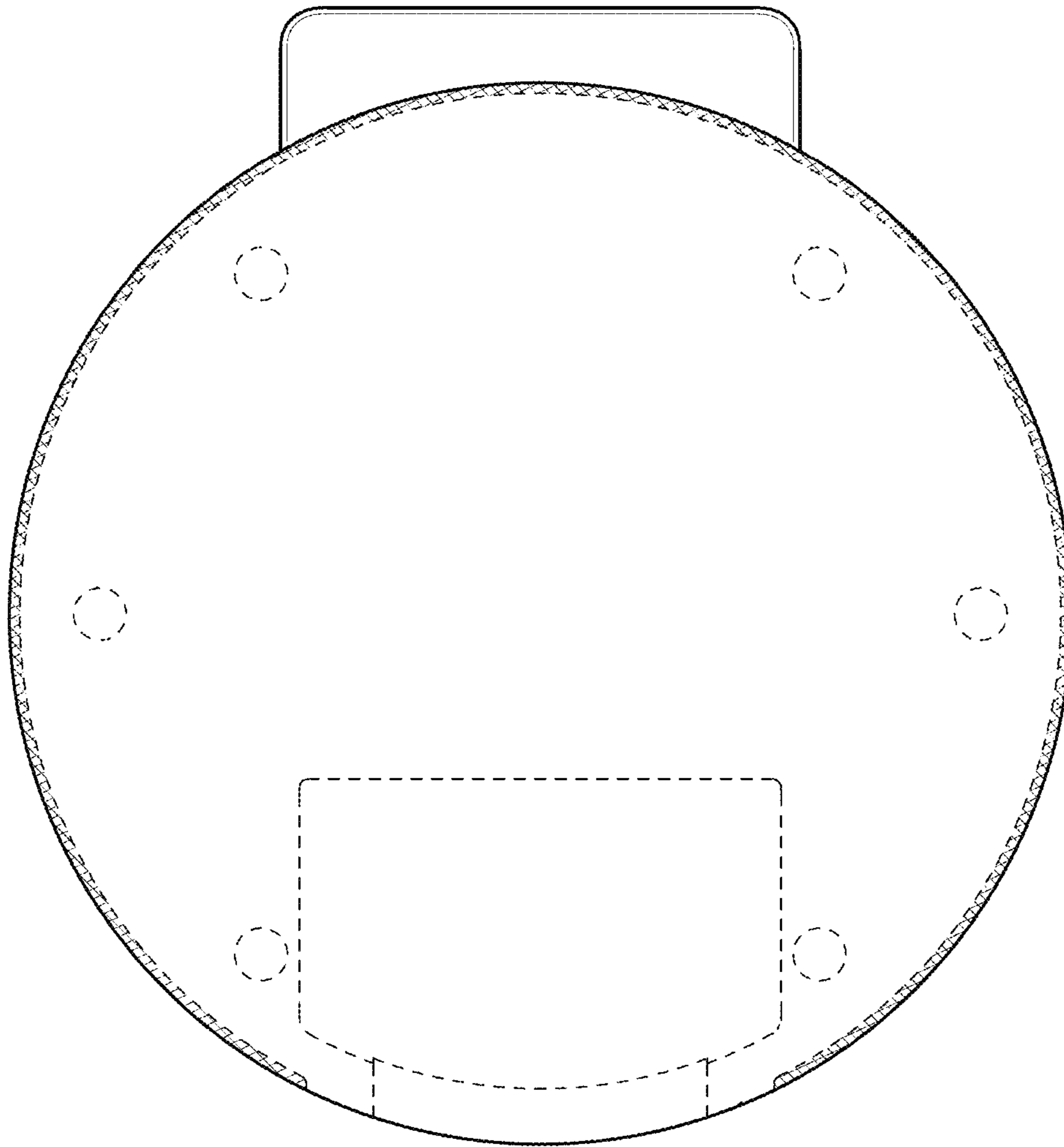

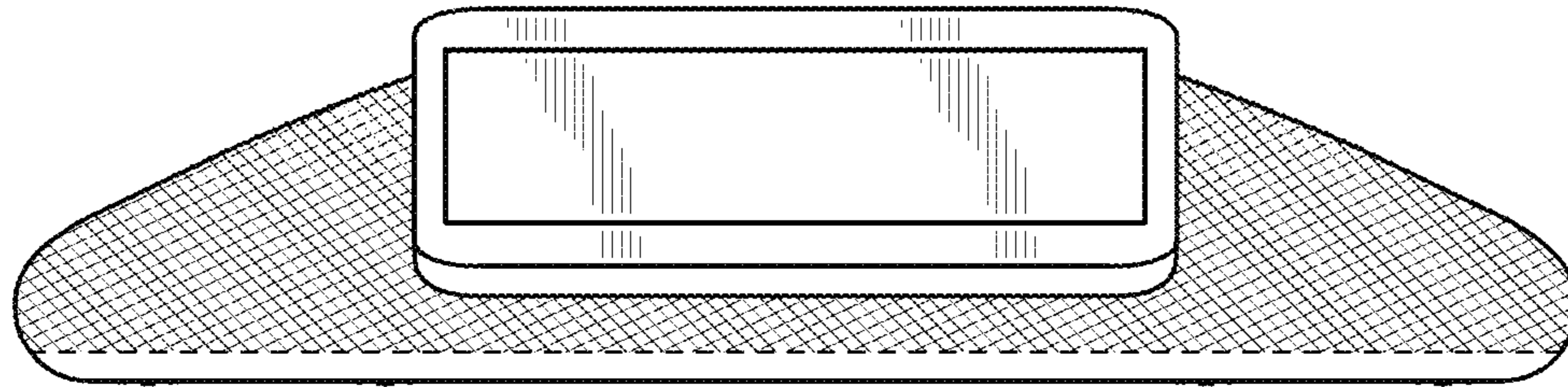

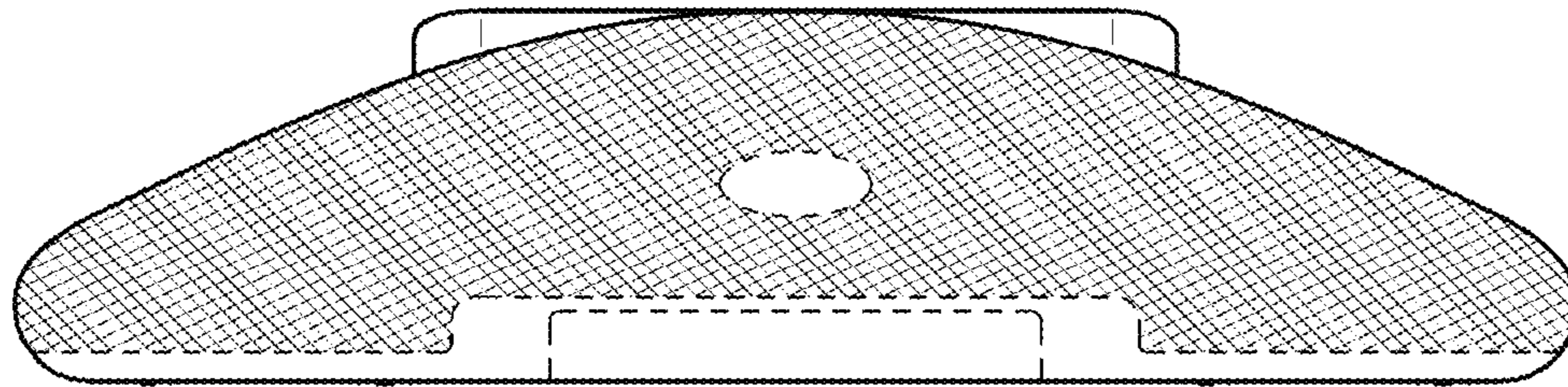

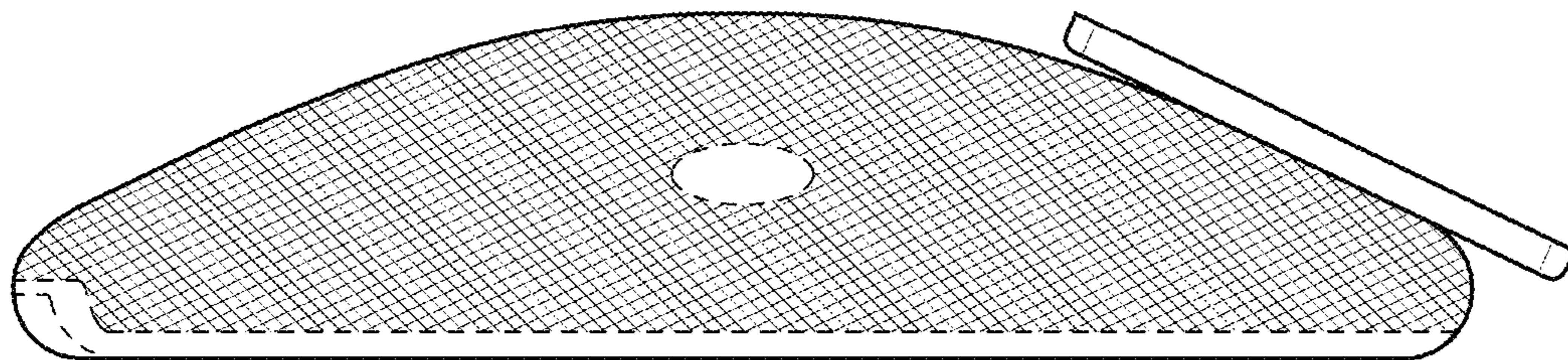

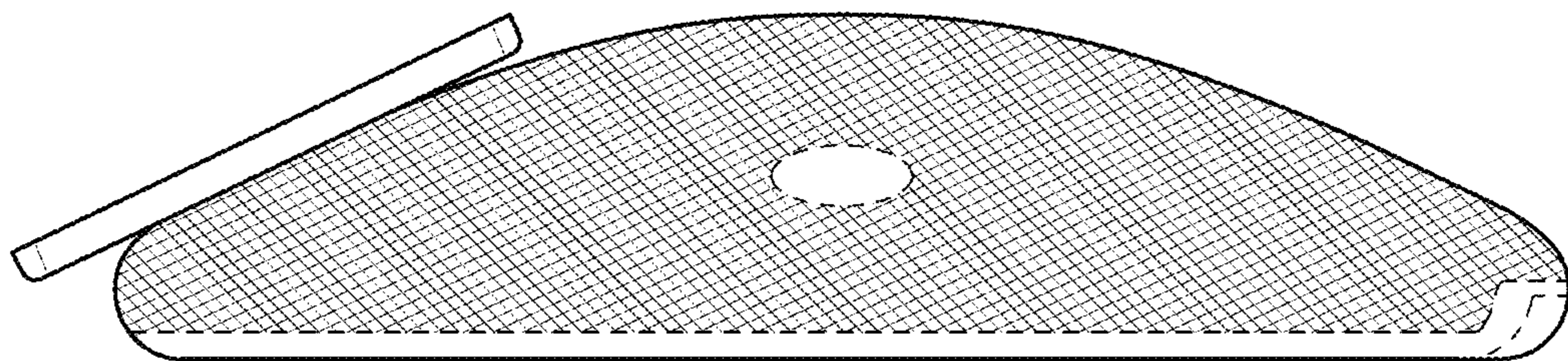
