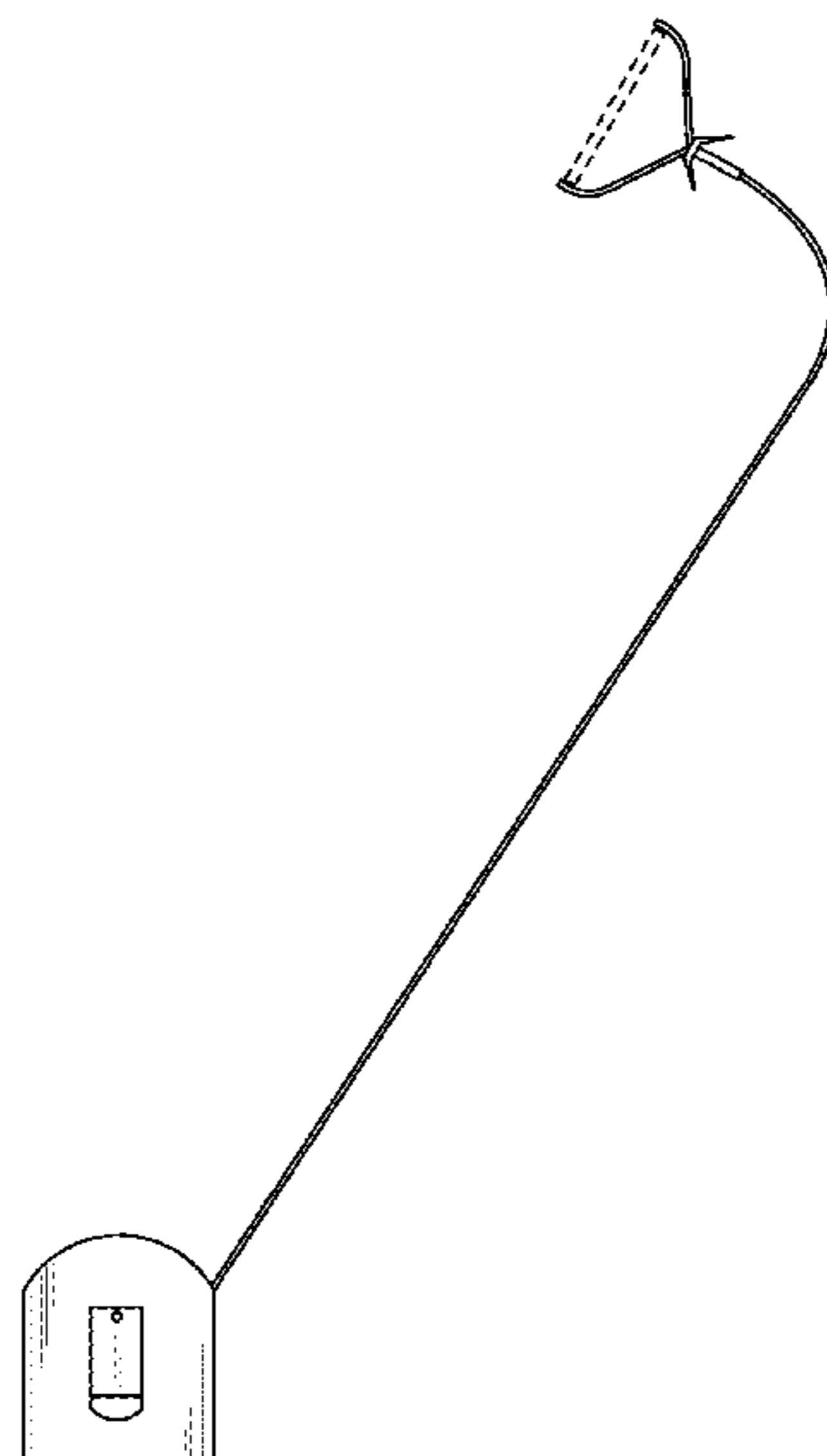
(57) **CLAIM**

The ornamental design for an accessory holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a right side elevational view of an accessory holder shown in an extended position;  
FIG. 2 is a left side elevational view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a front elevation view thereof;  
FIG. 6 is a rear elevation view thereof;  
FIG. 7 is a right side elevation view thereof shown in a retracted position;  
FIG. 8 is a left side elevation view thereof;  
FIG. 9 is a top plan view thereof;  
FIG. 10 is a bottom plan view thereof;

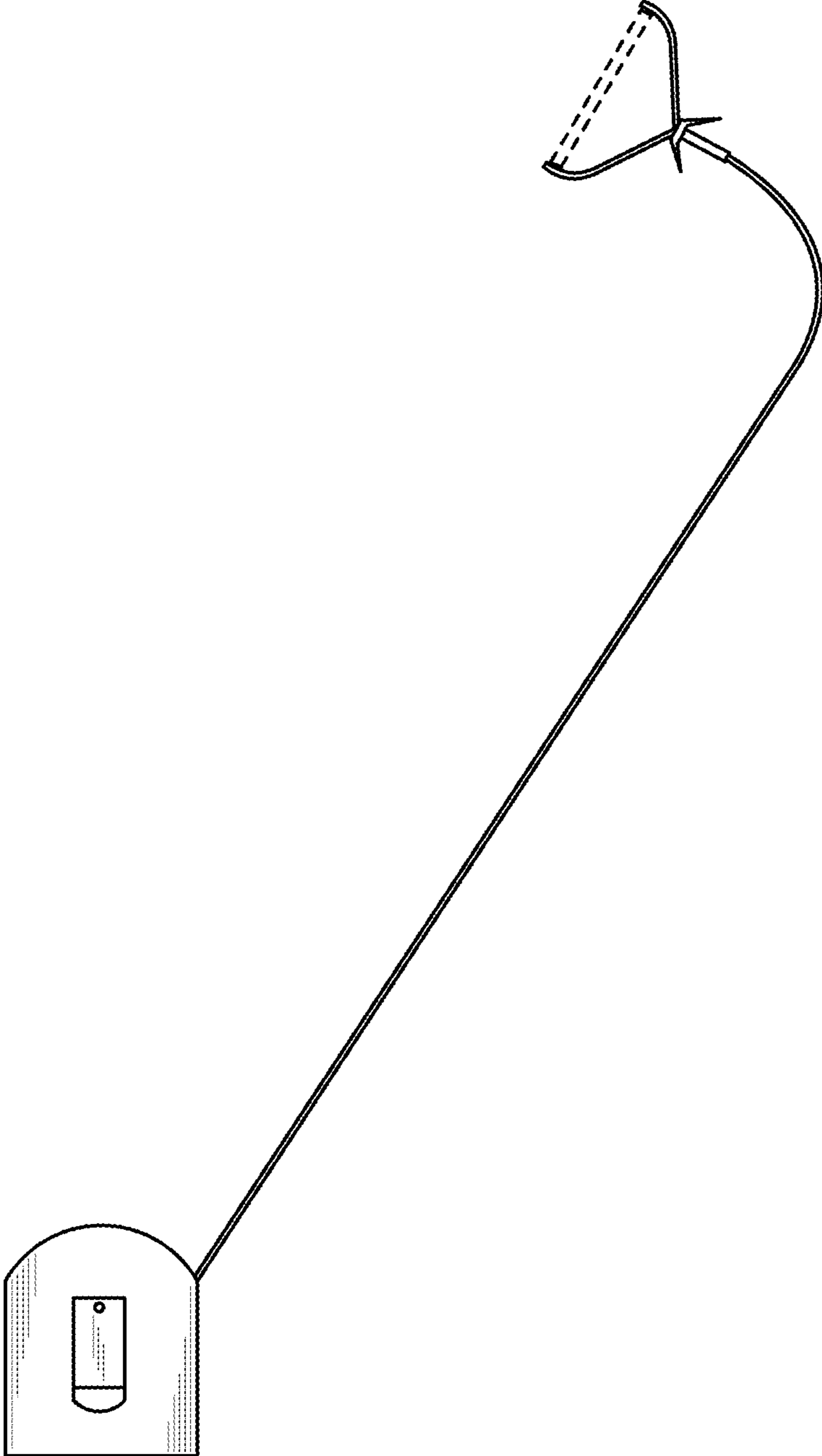

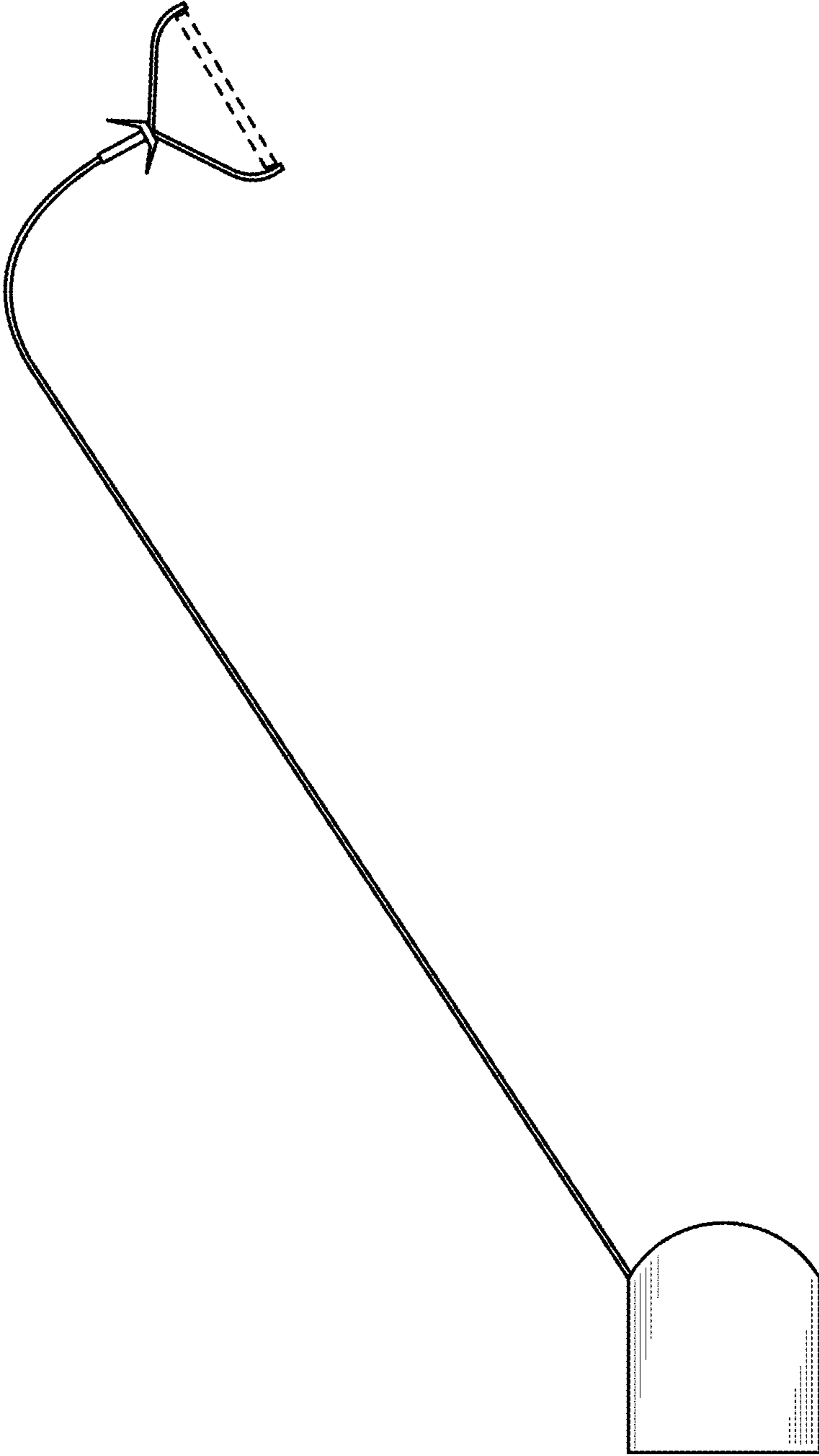

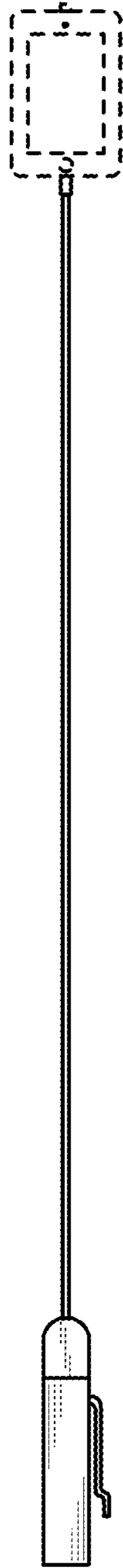

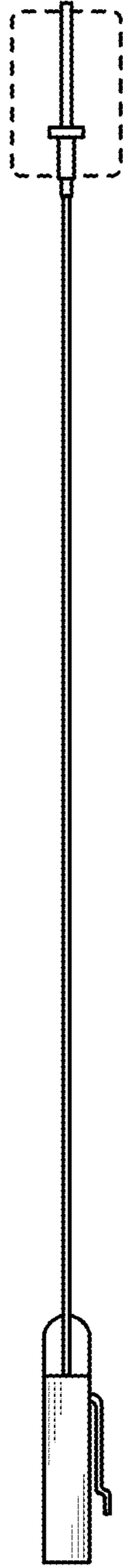

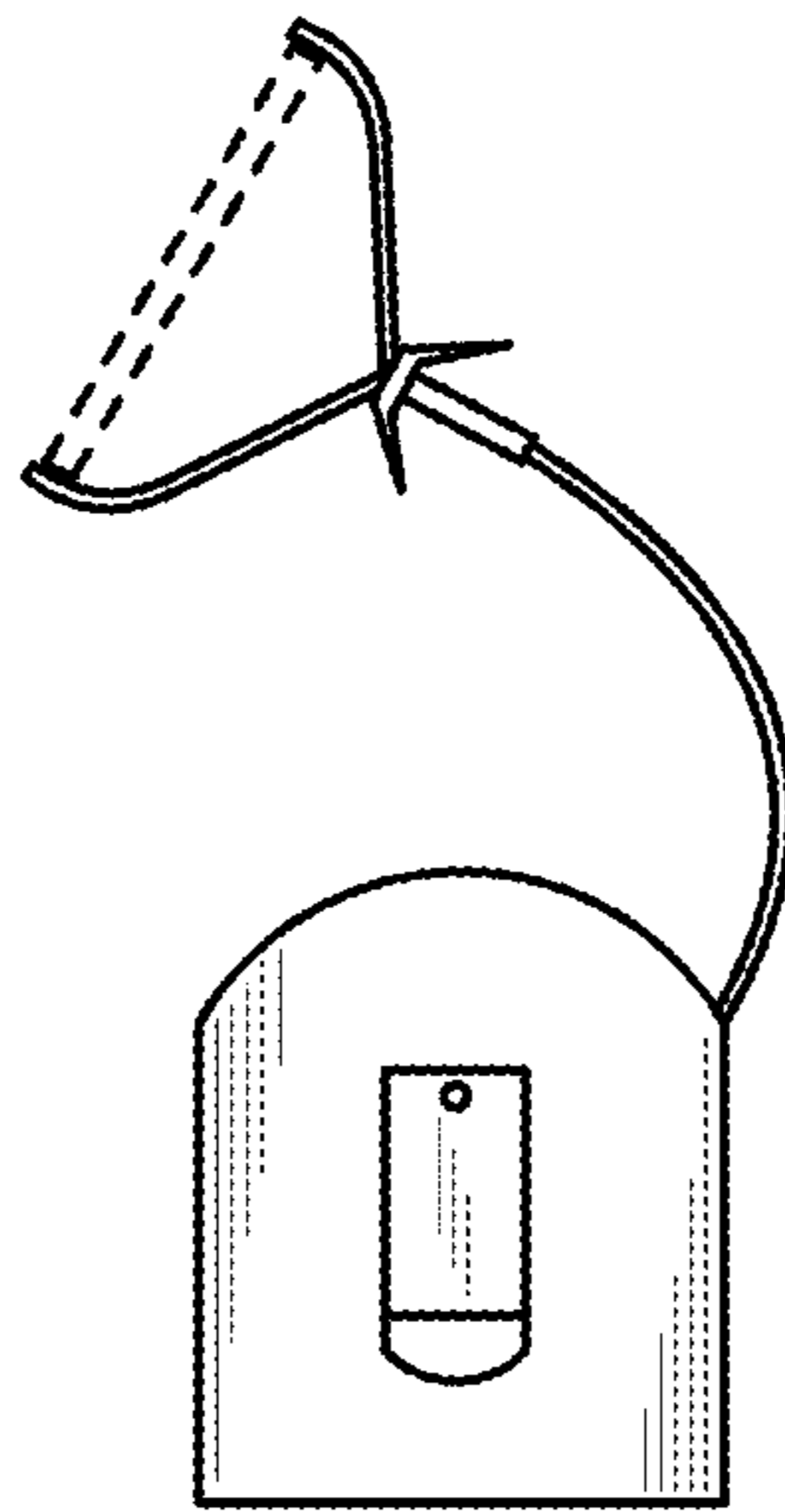

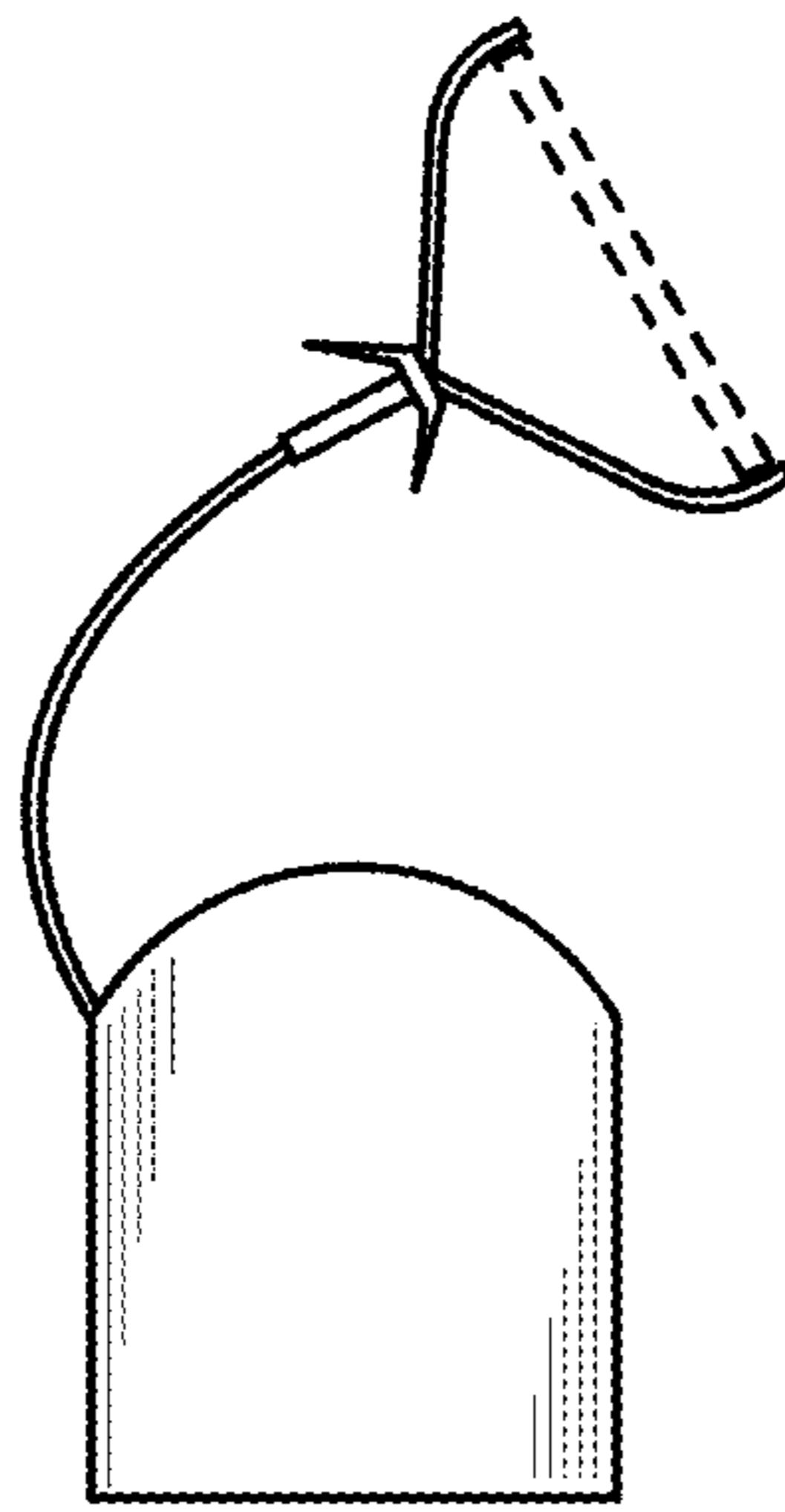

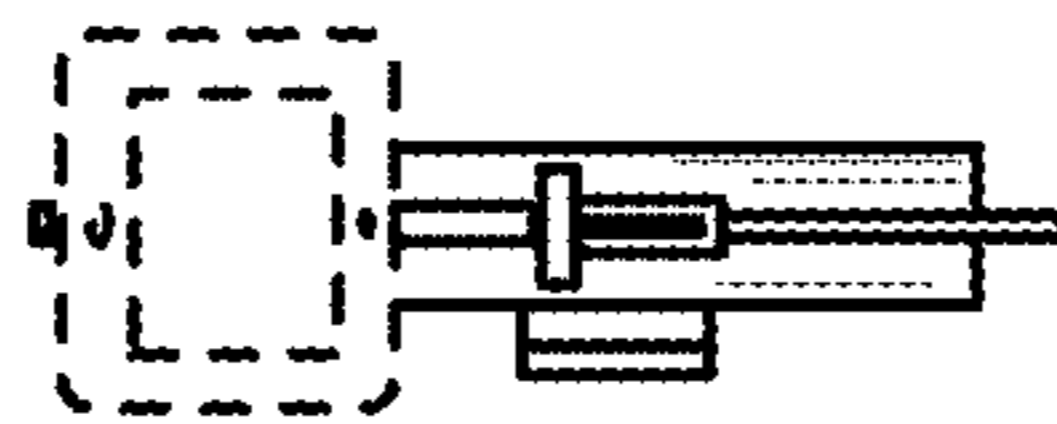

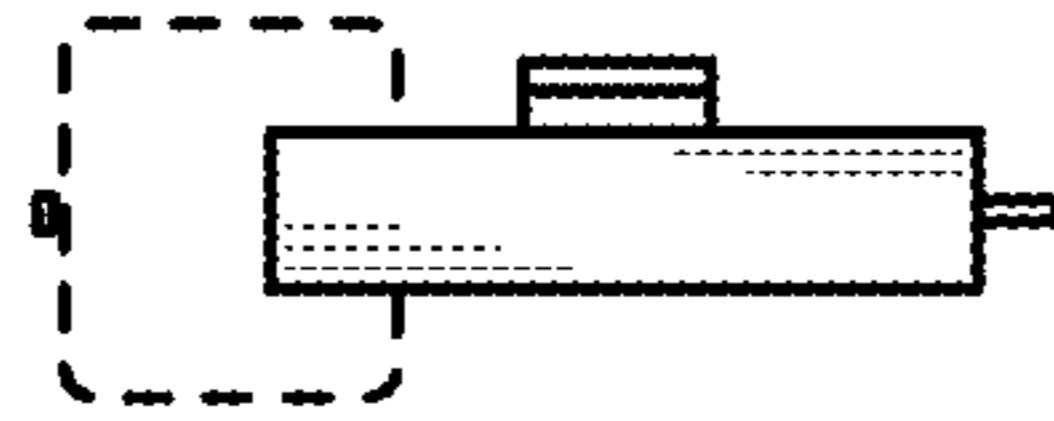

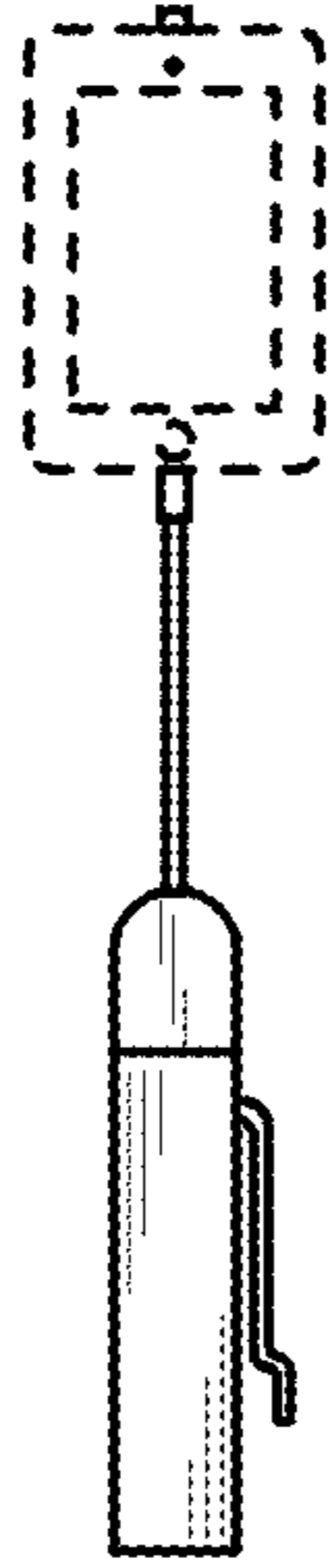

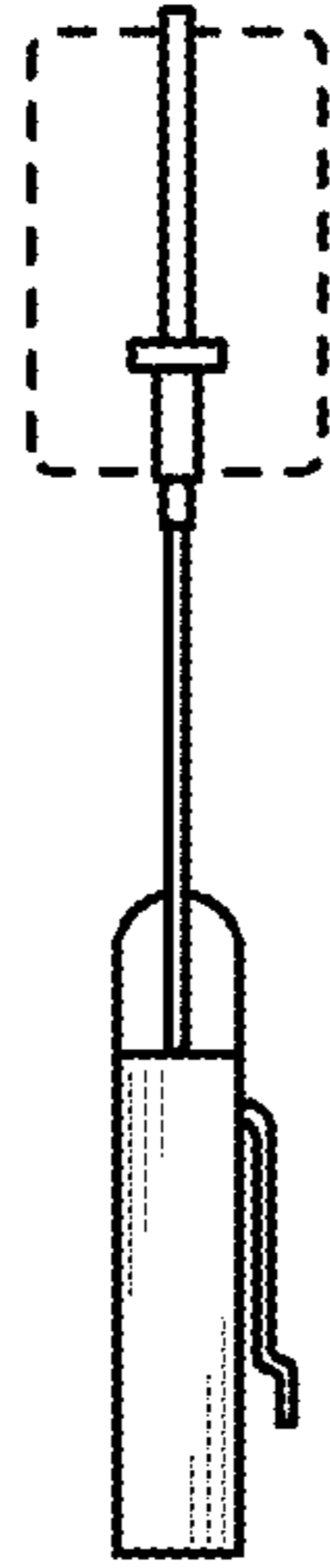
