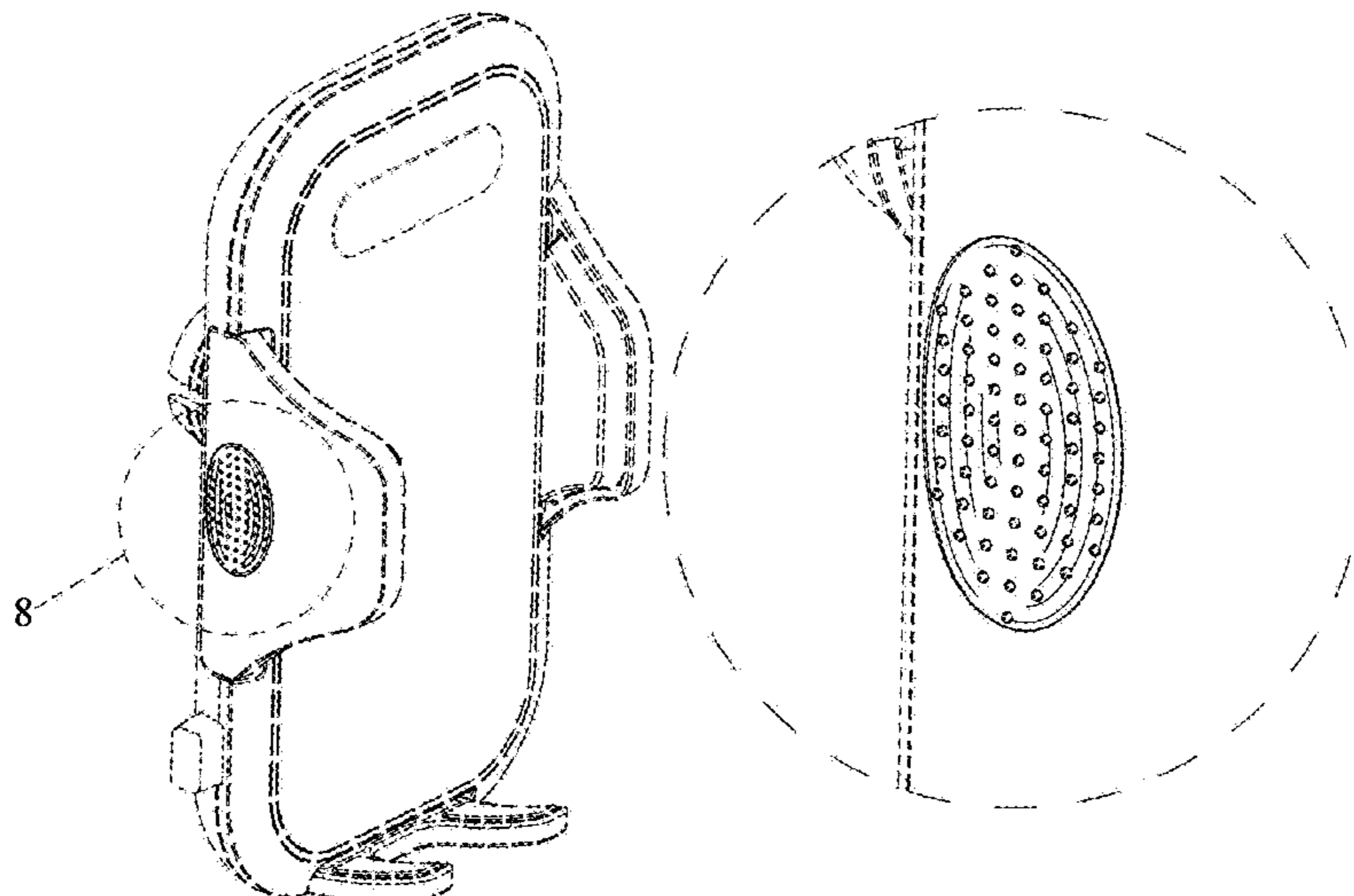
(57) **CLAIM**

I claim the ornamental design for a mobile phone holder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a mobile phone holder showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof;
FIG. 8 is an enlarged detail view of the encircled portion of FIG. 1; and,
FIG. 9 is a perspective view thereof, showing the mobile phone holder in a state of use.
In the drawings, the claimed design is defined by the shaded surfaces adjacent to solid line disclosure; broken lines illustrate portions of the mobile phone holder that form no part of the claimed design.

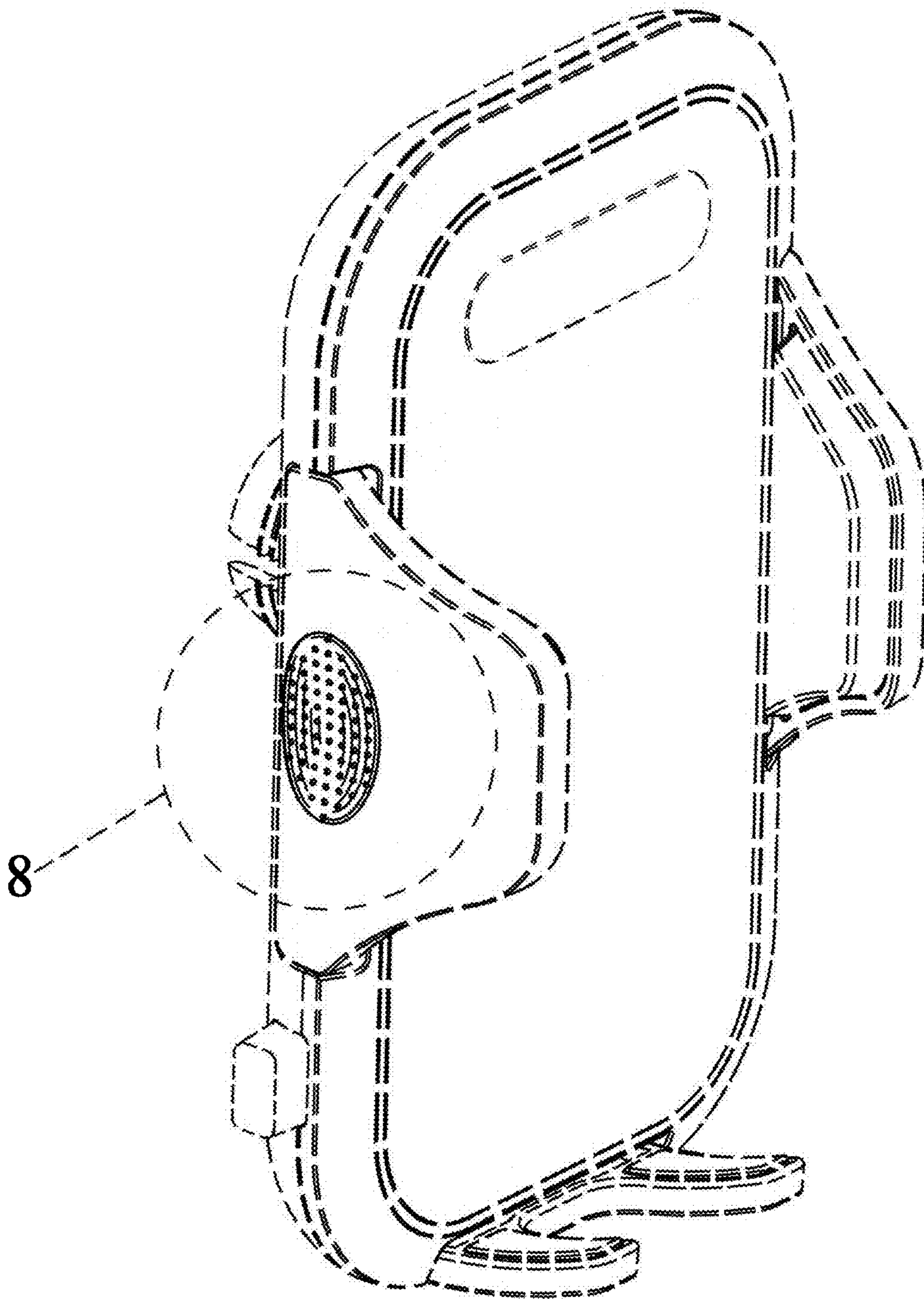

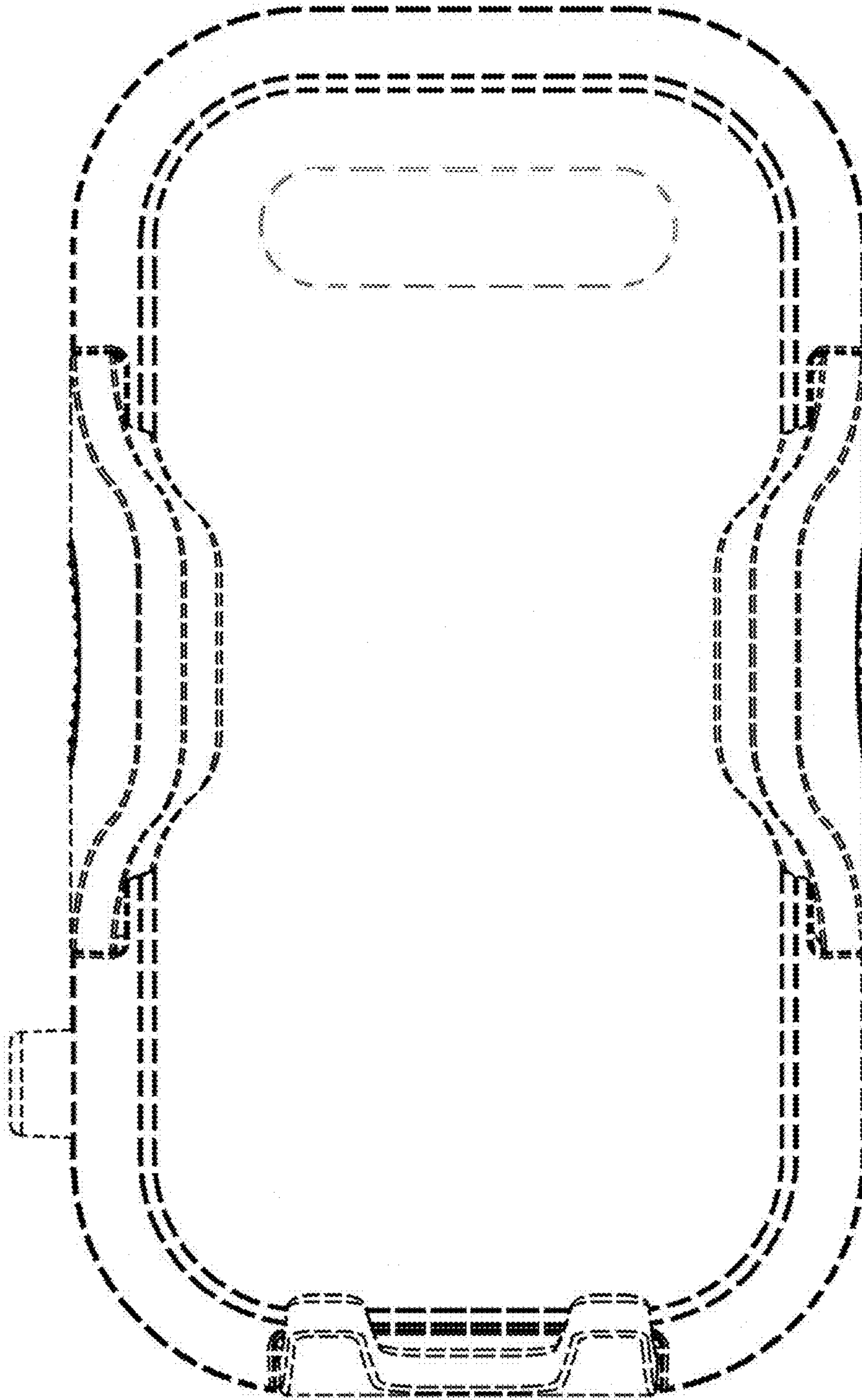

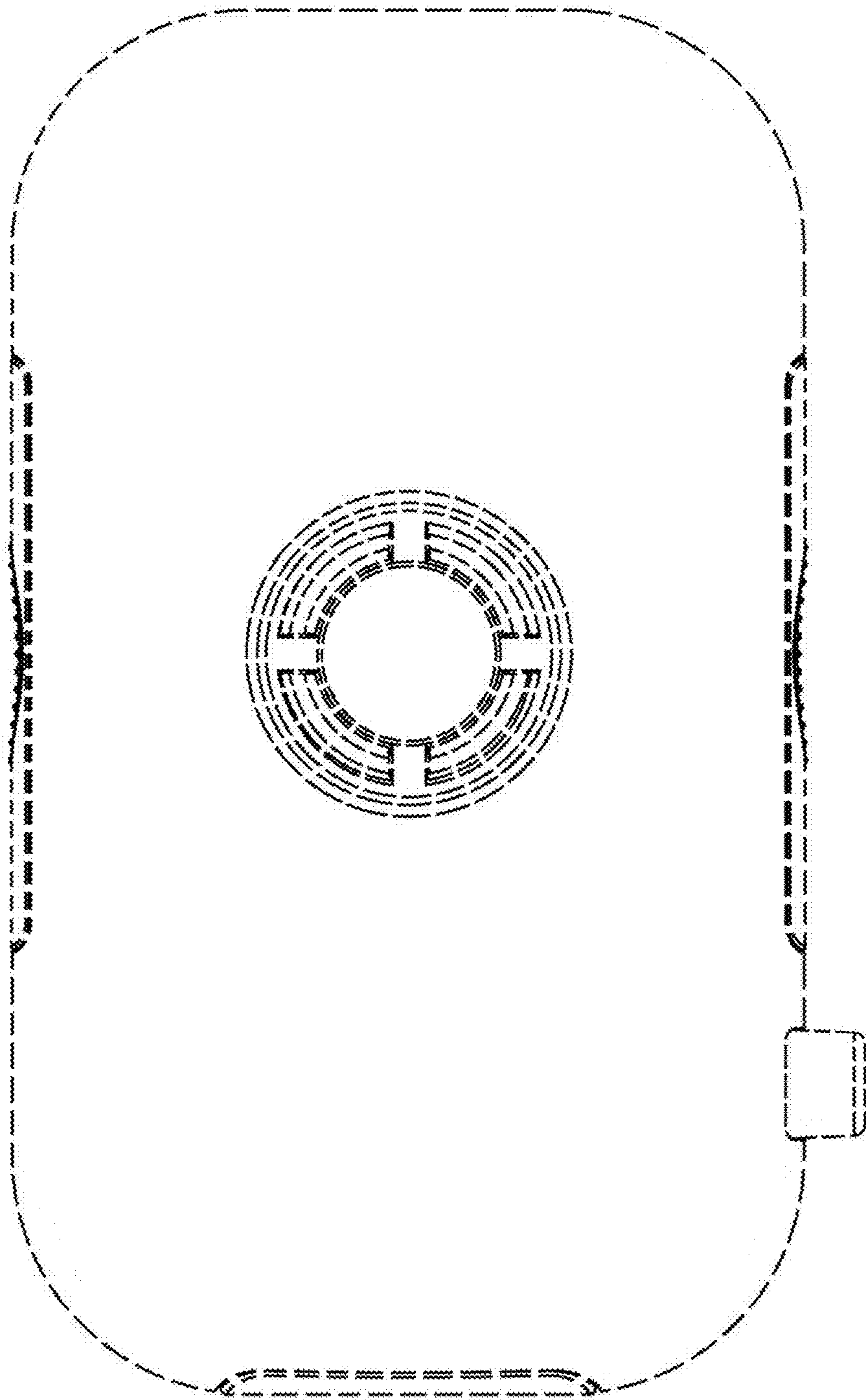

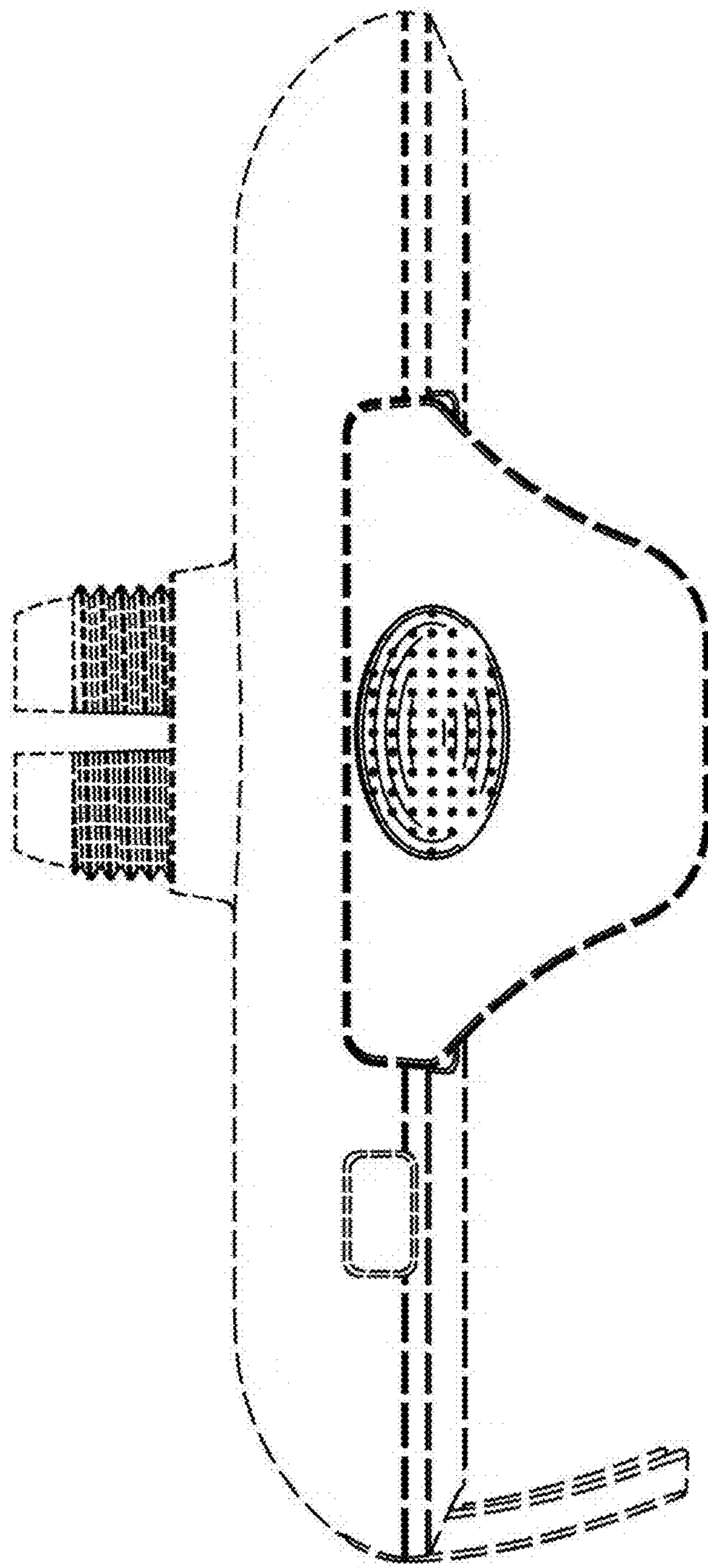

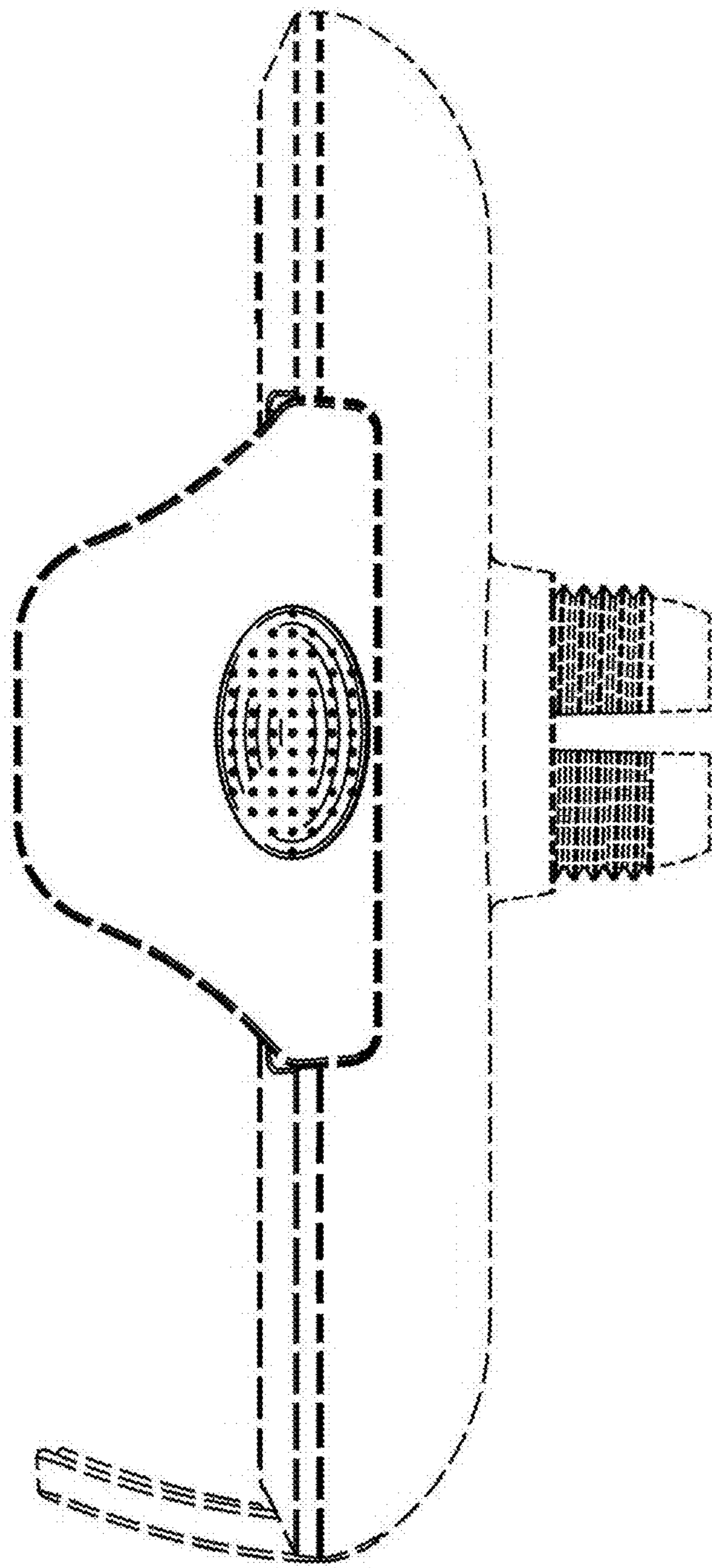

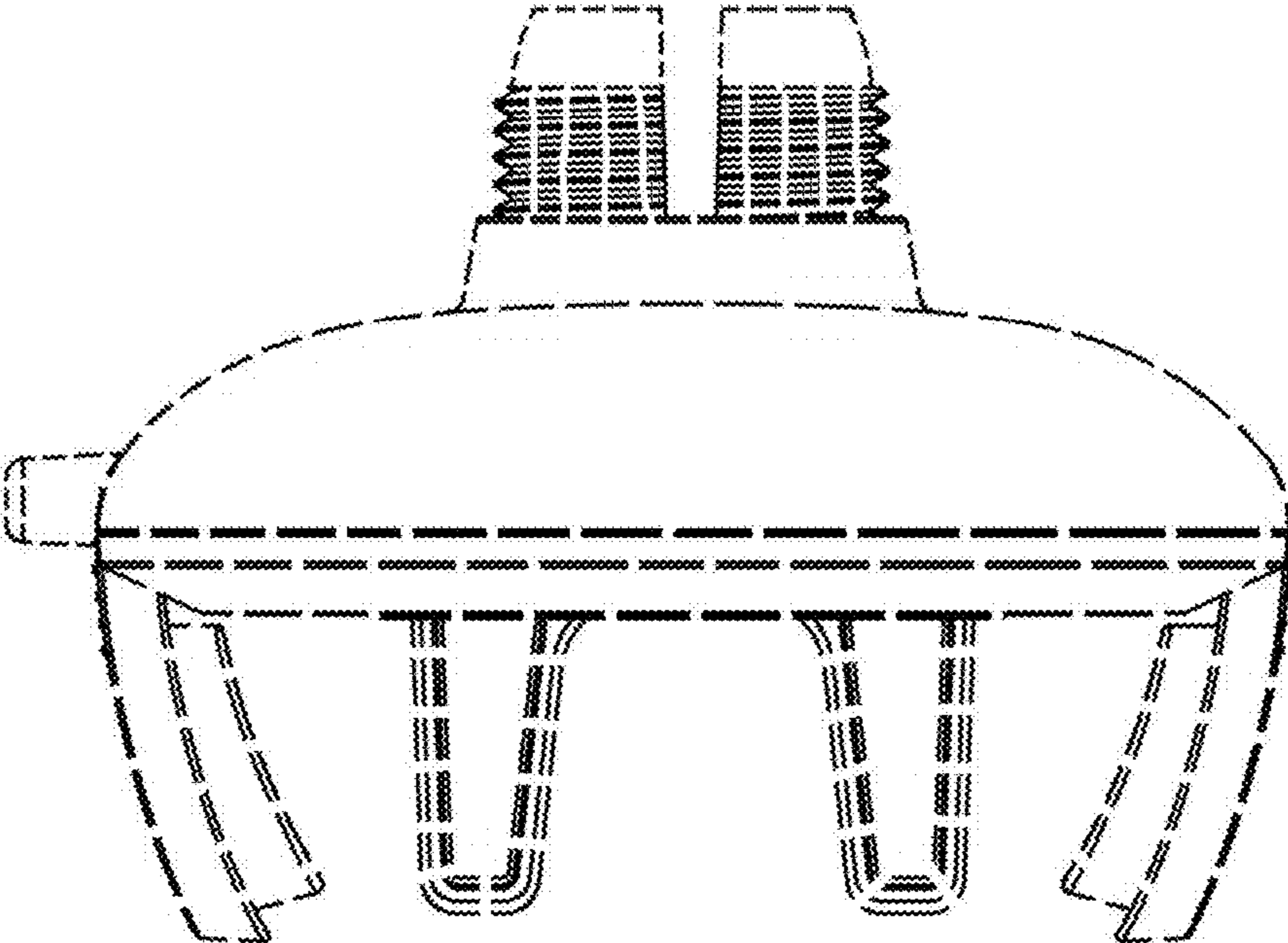

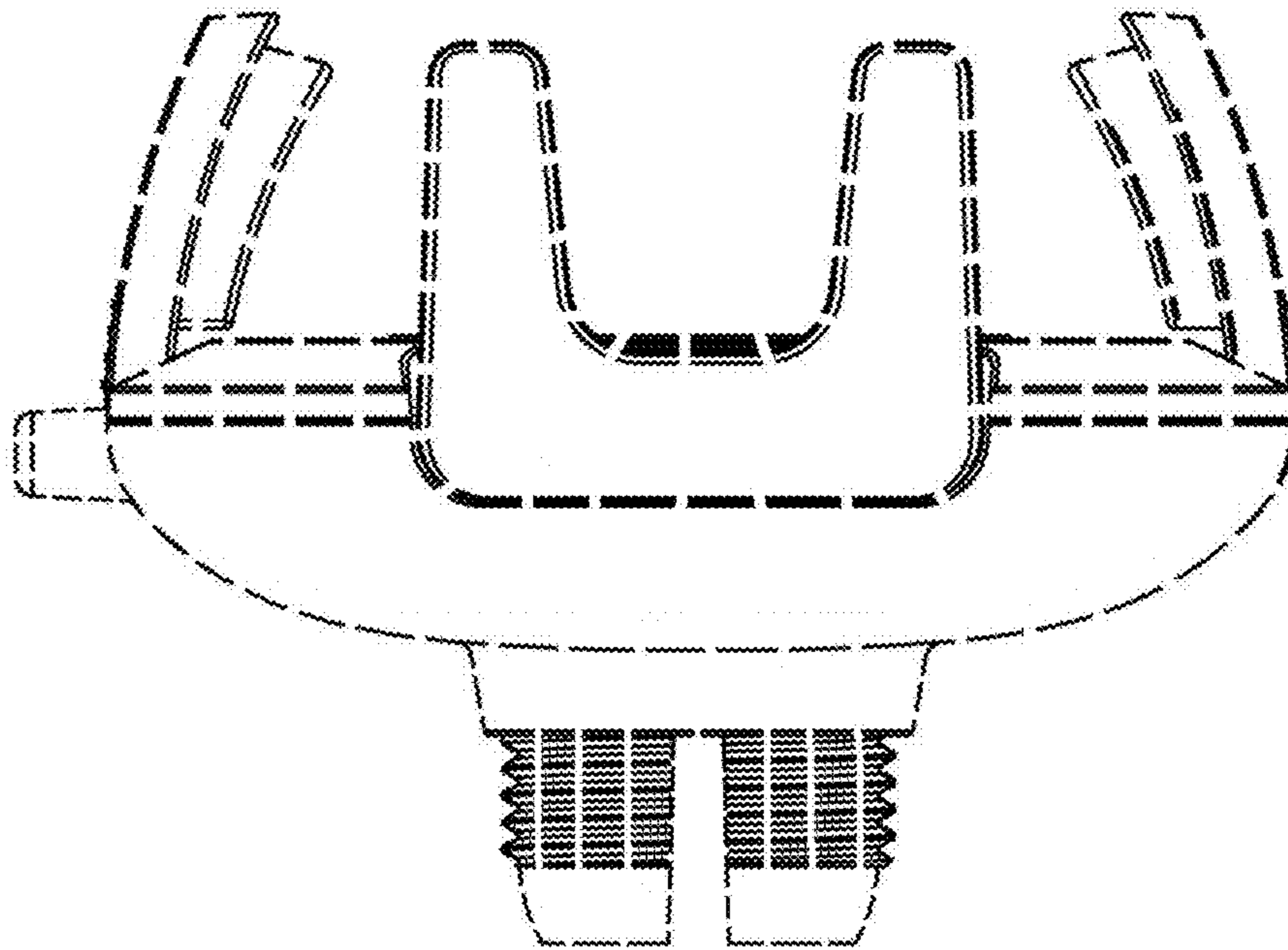

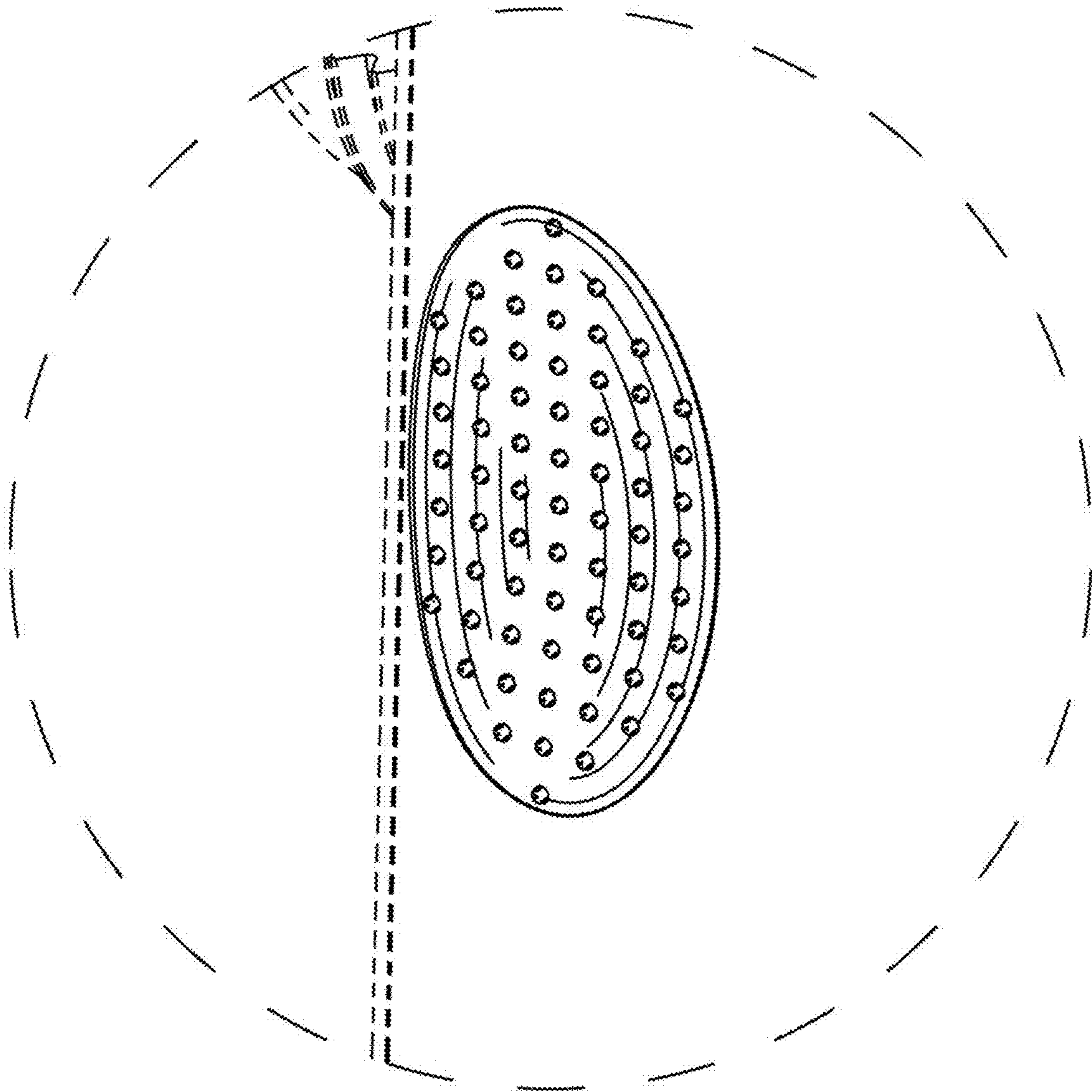

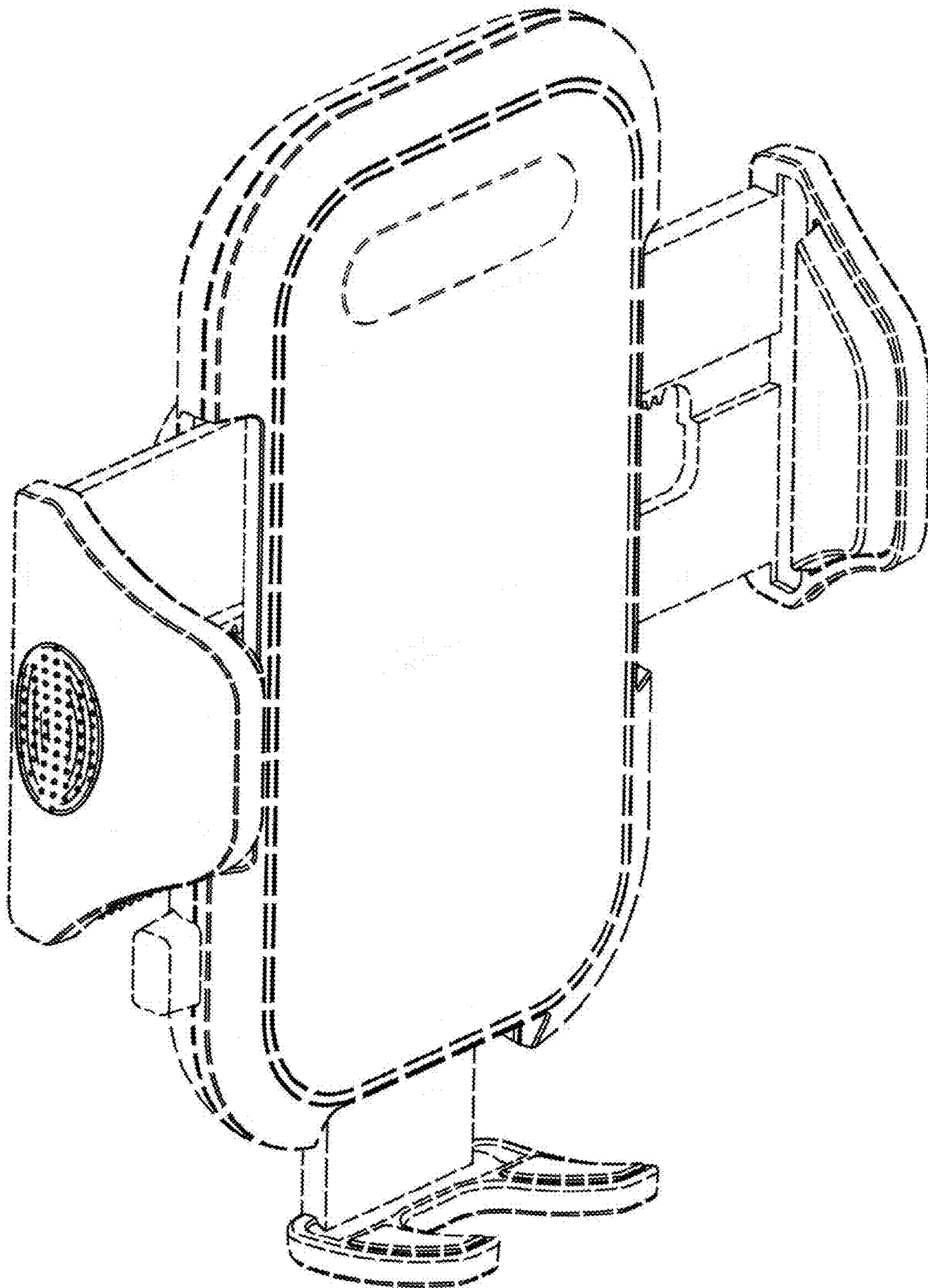
