(57) **CLAIM**

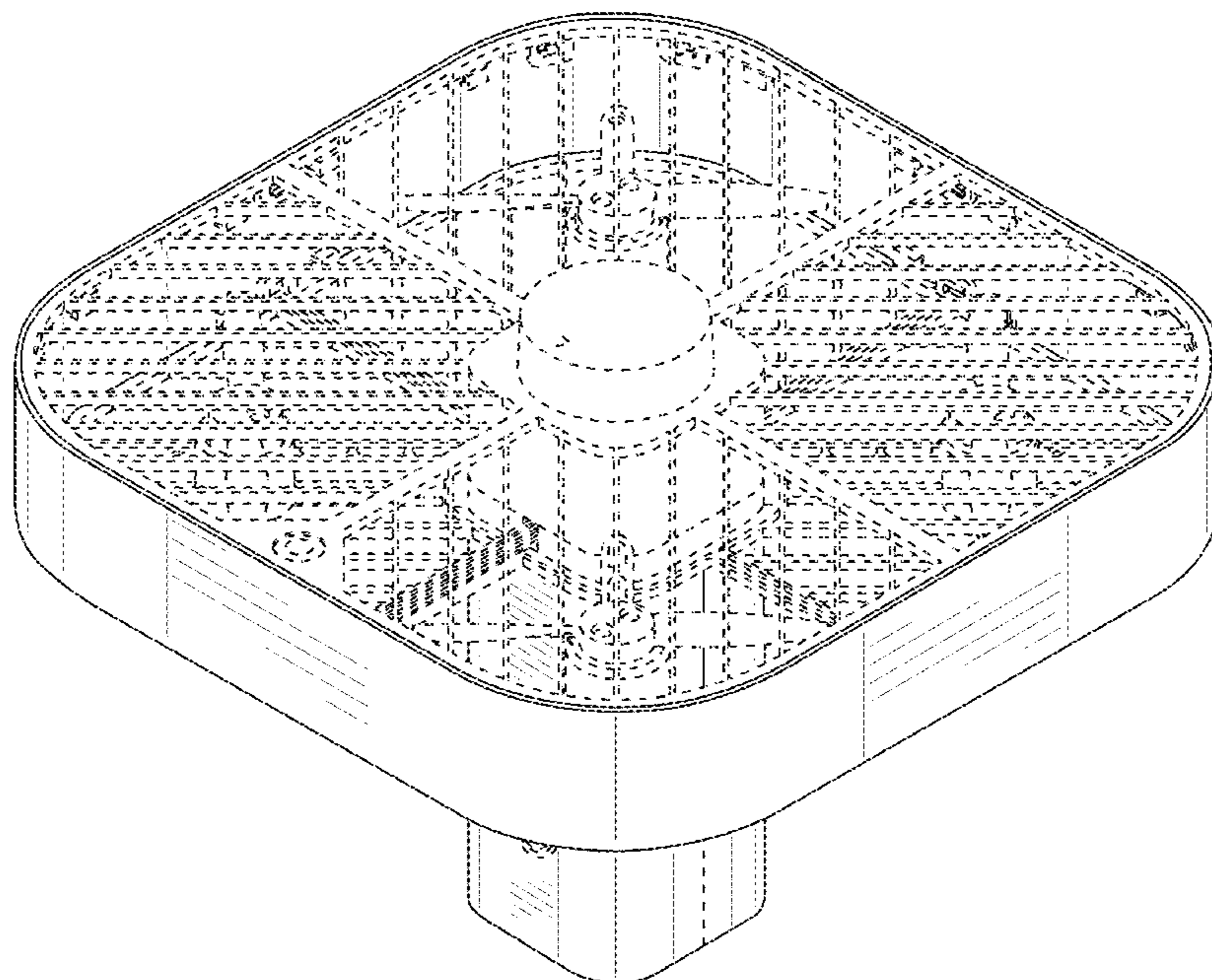
The ornamental design for a security device, as shown and described.

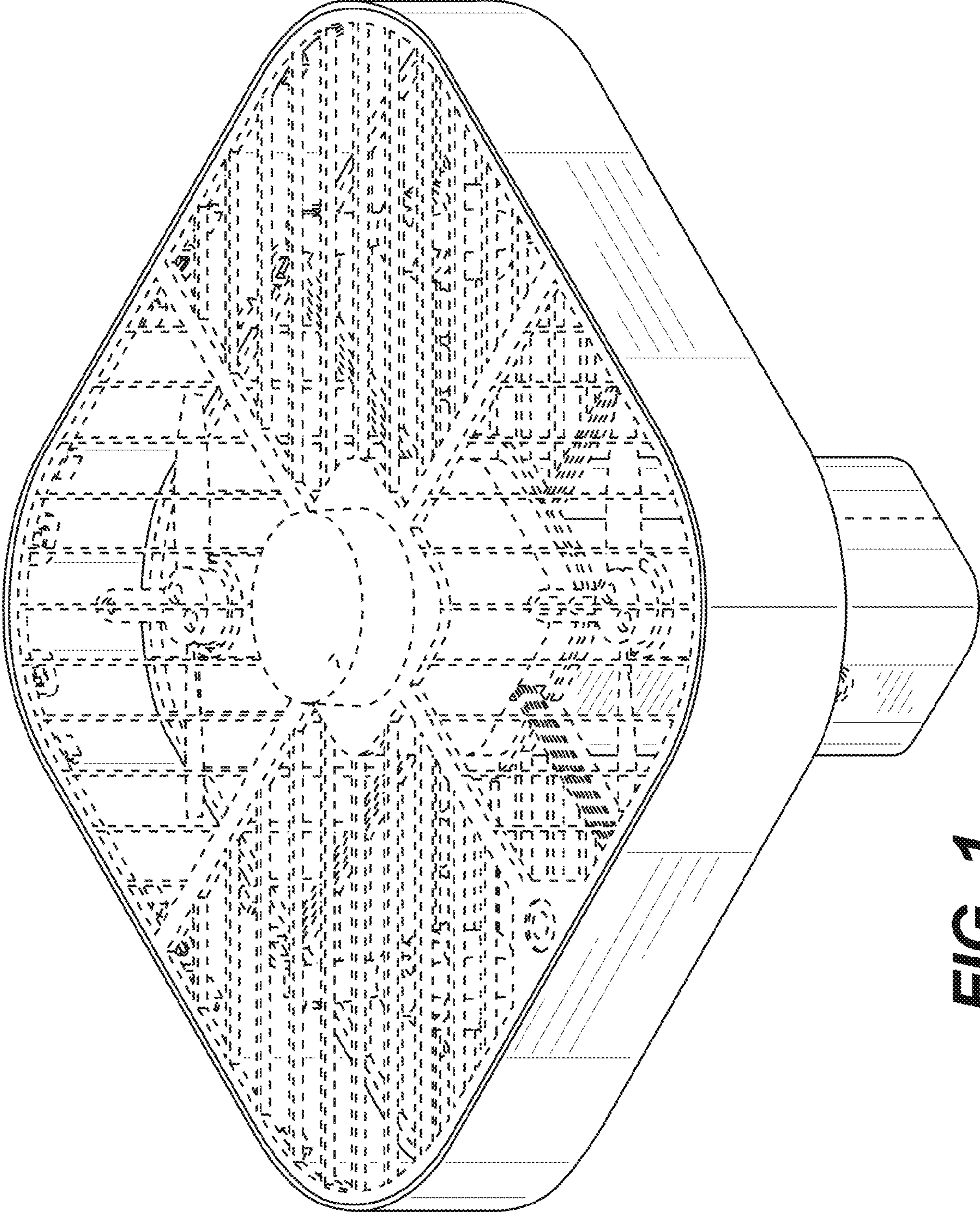

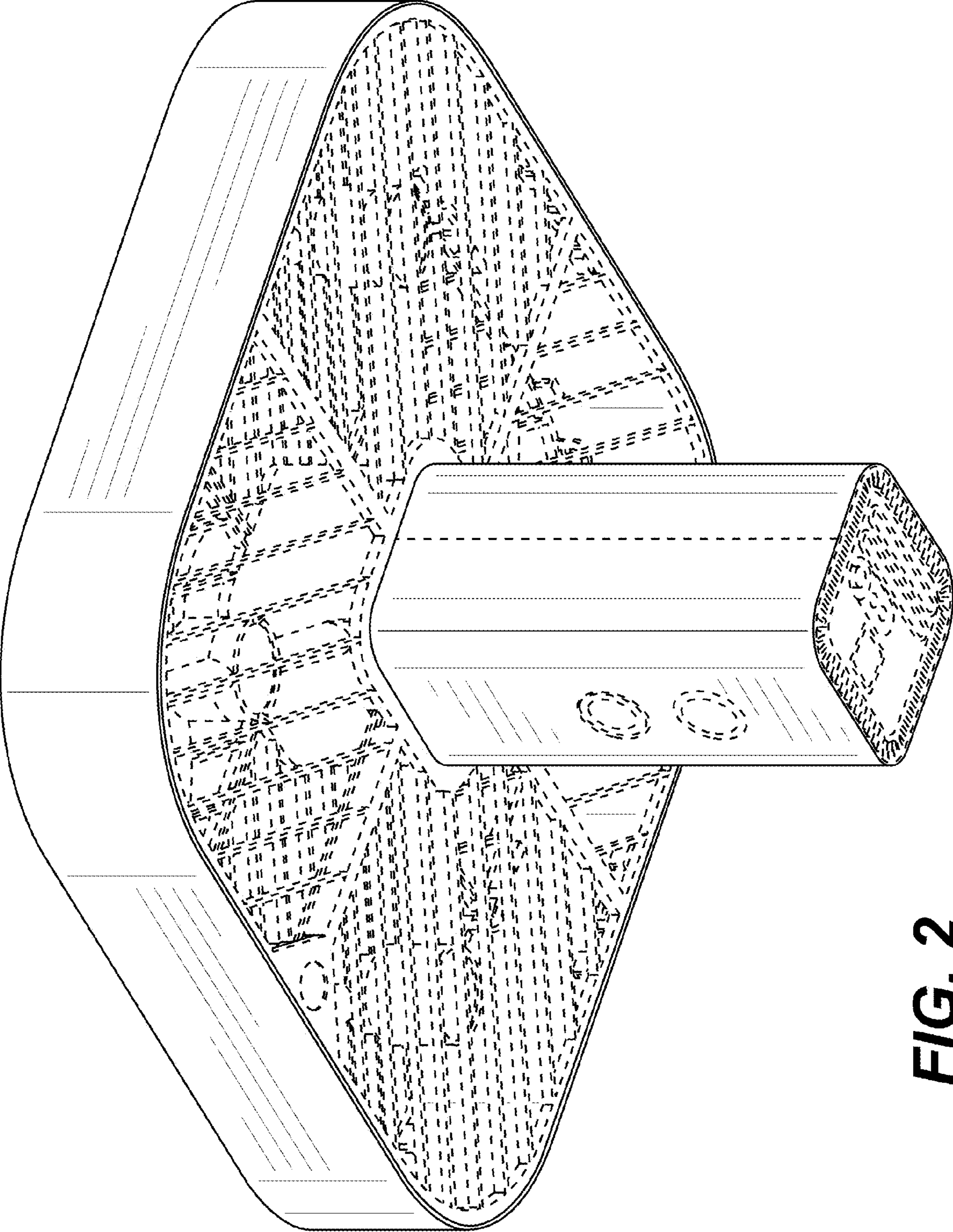

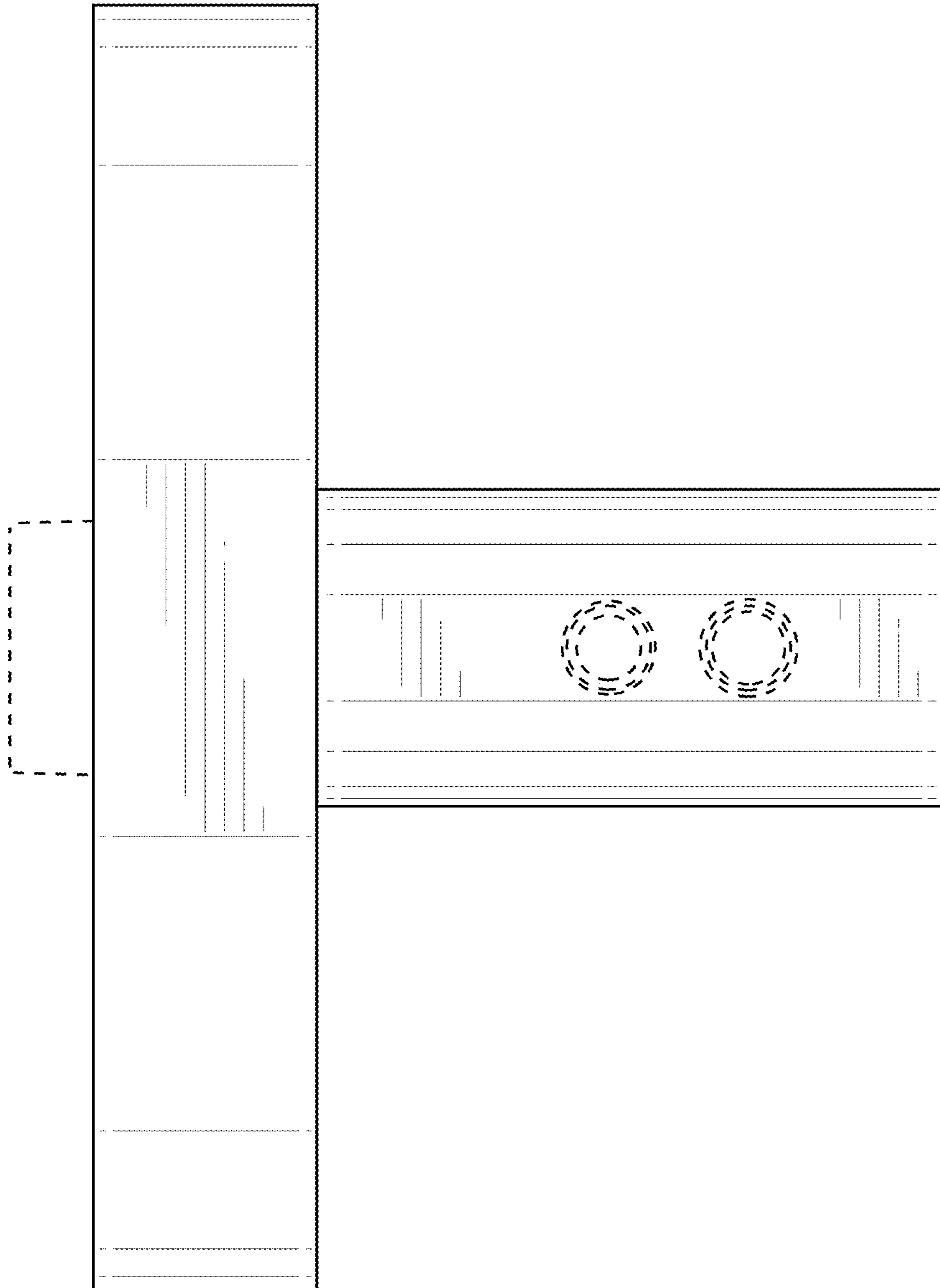

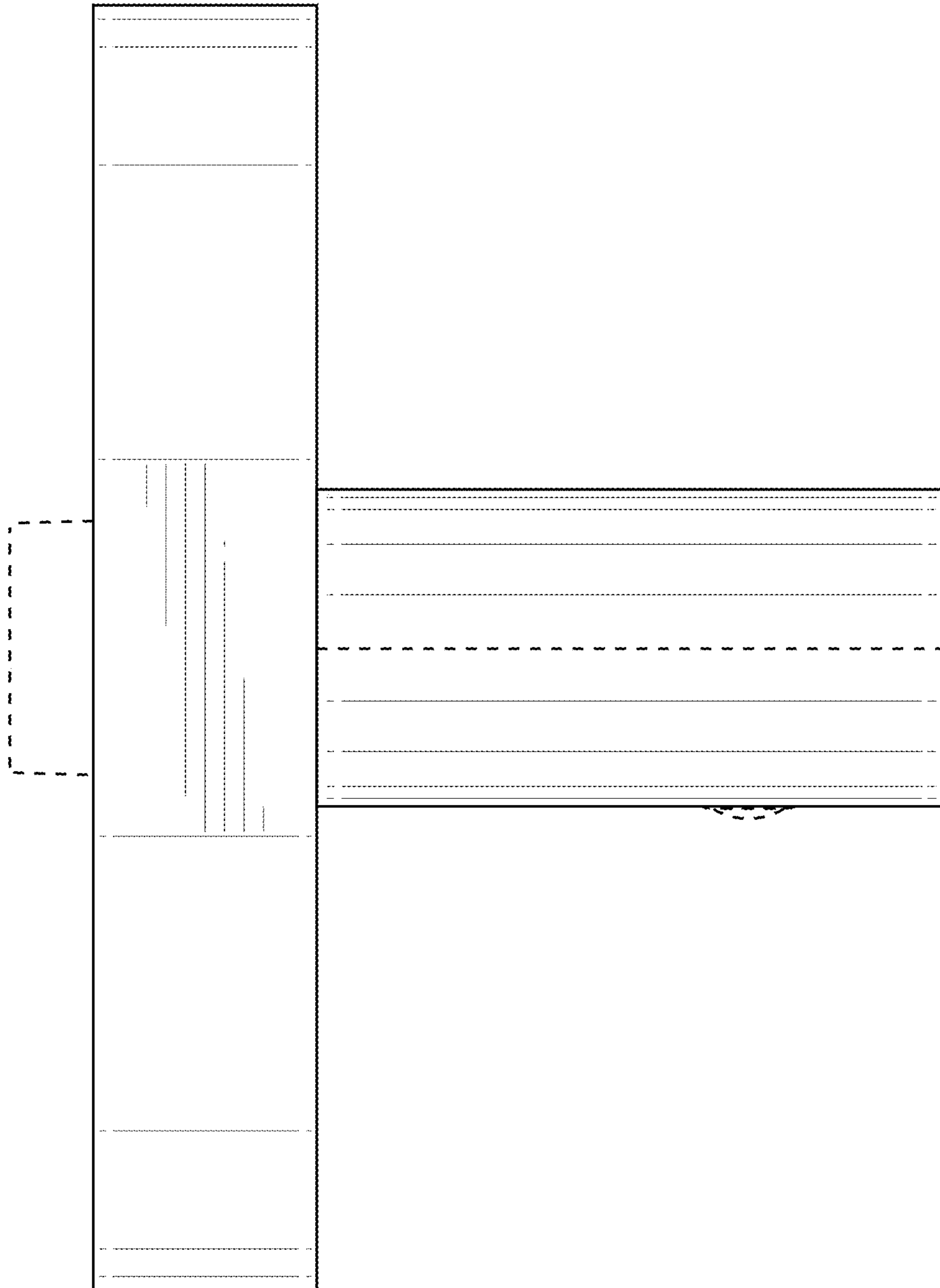

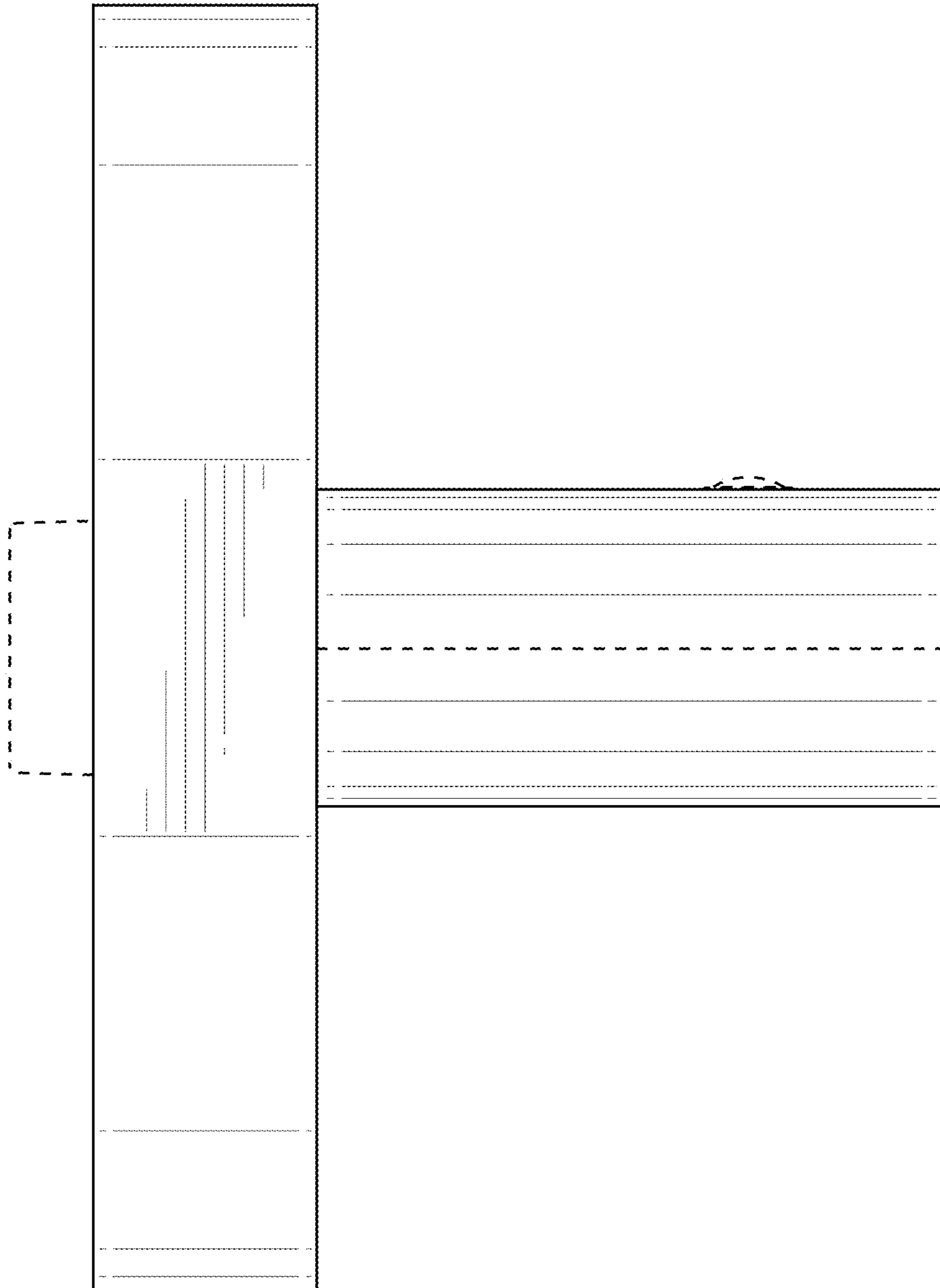

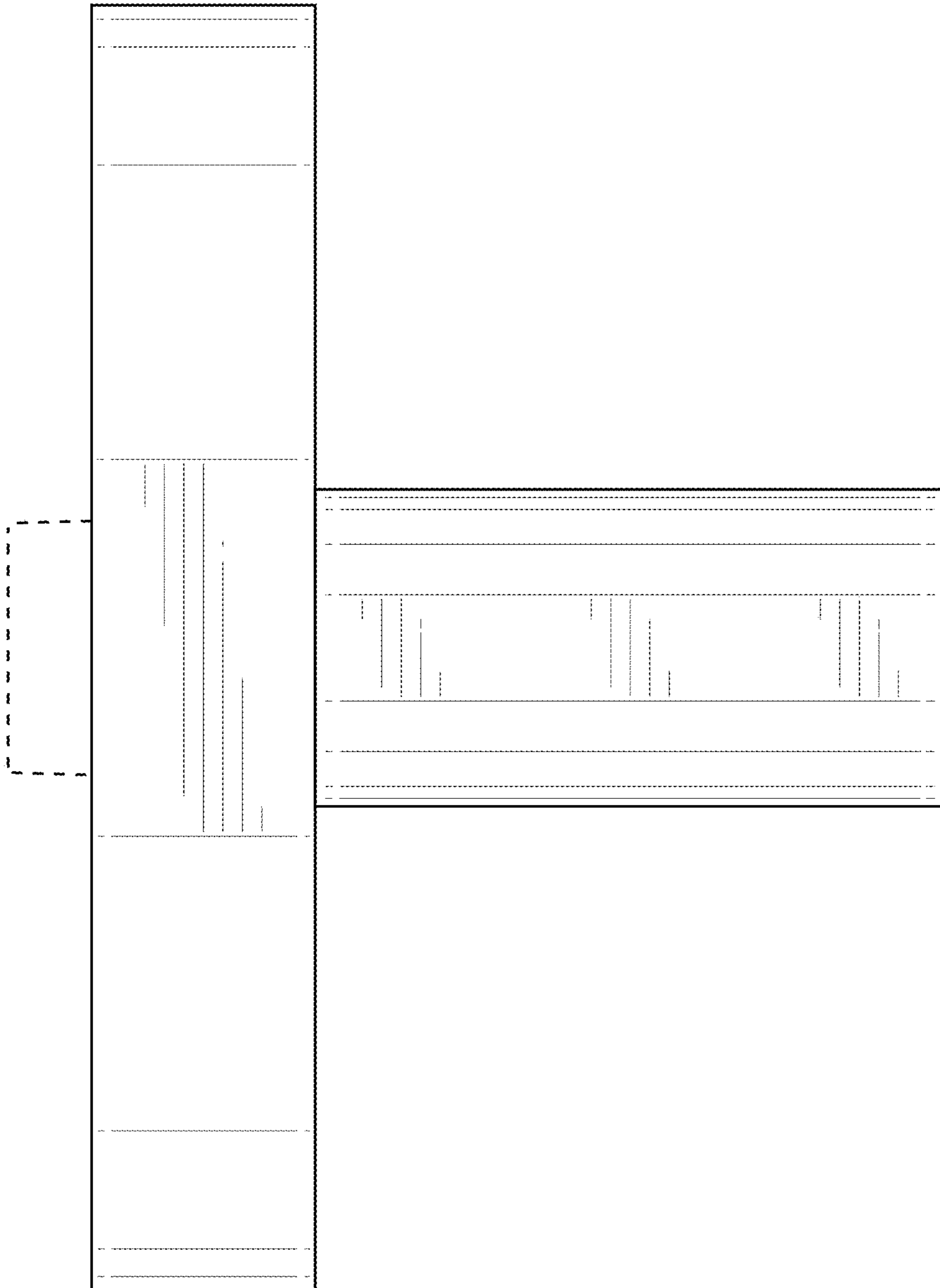

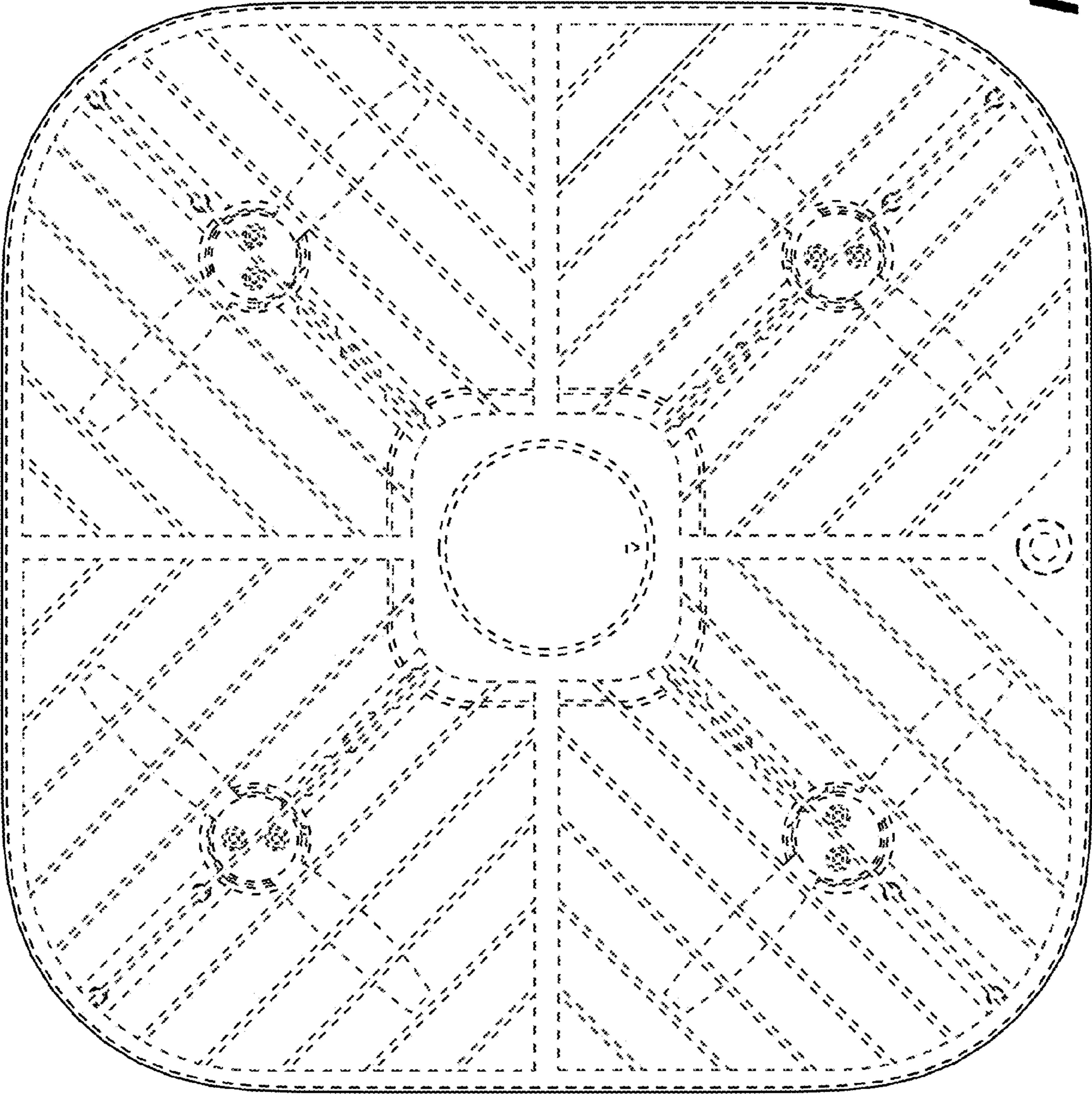

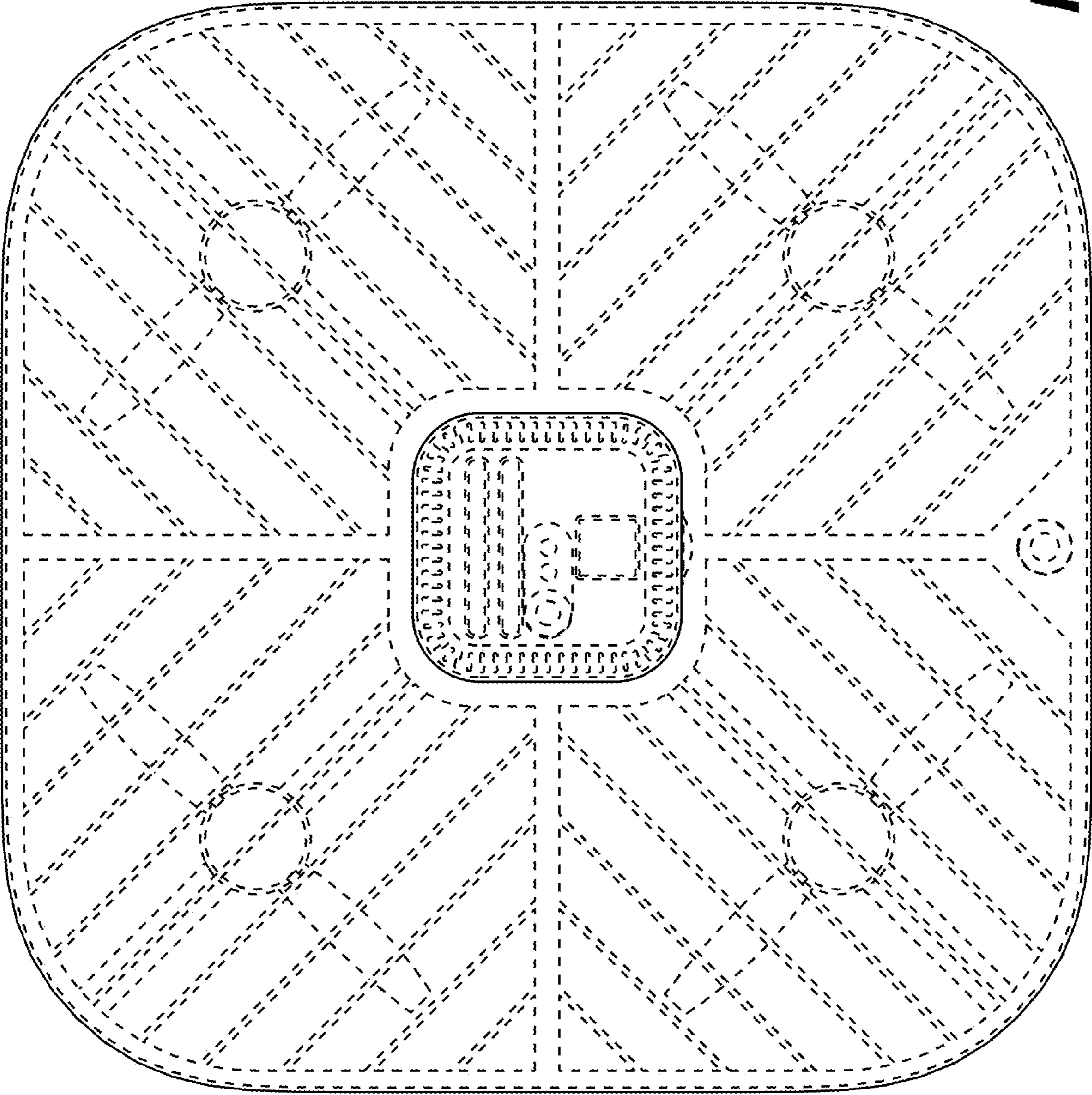
