FIG. 2 is a second embodiment thereof;

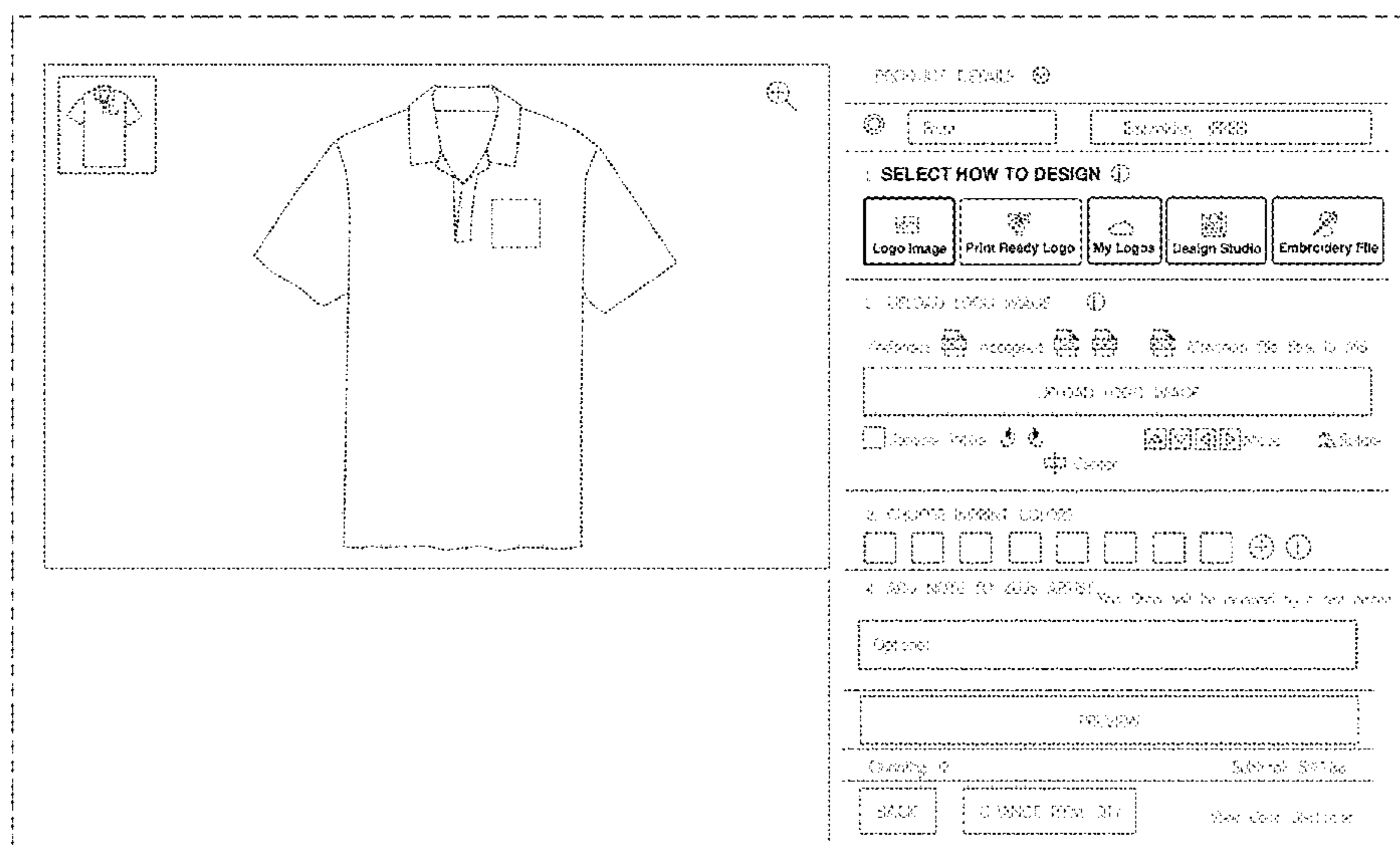
FIG. 3 is a third embodiment thereof;



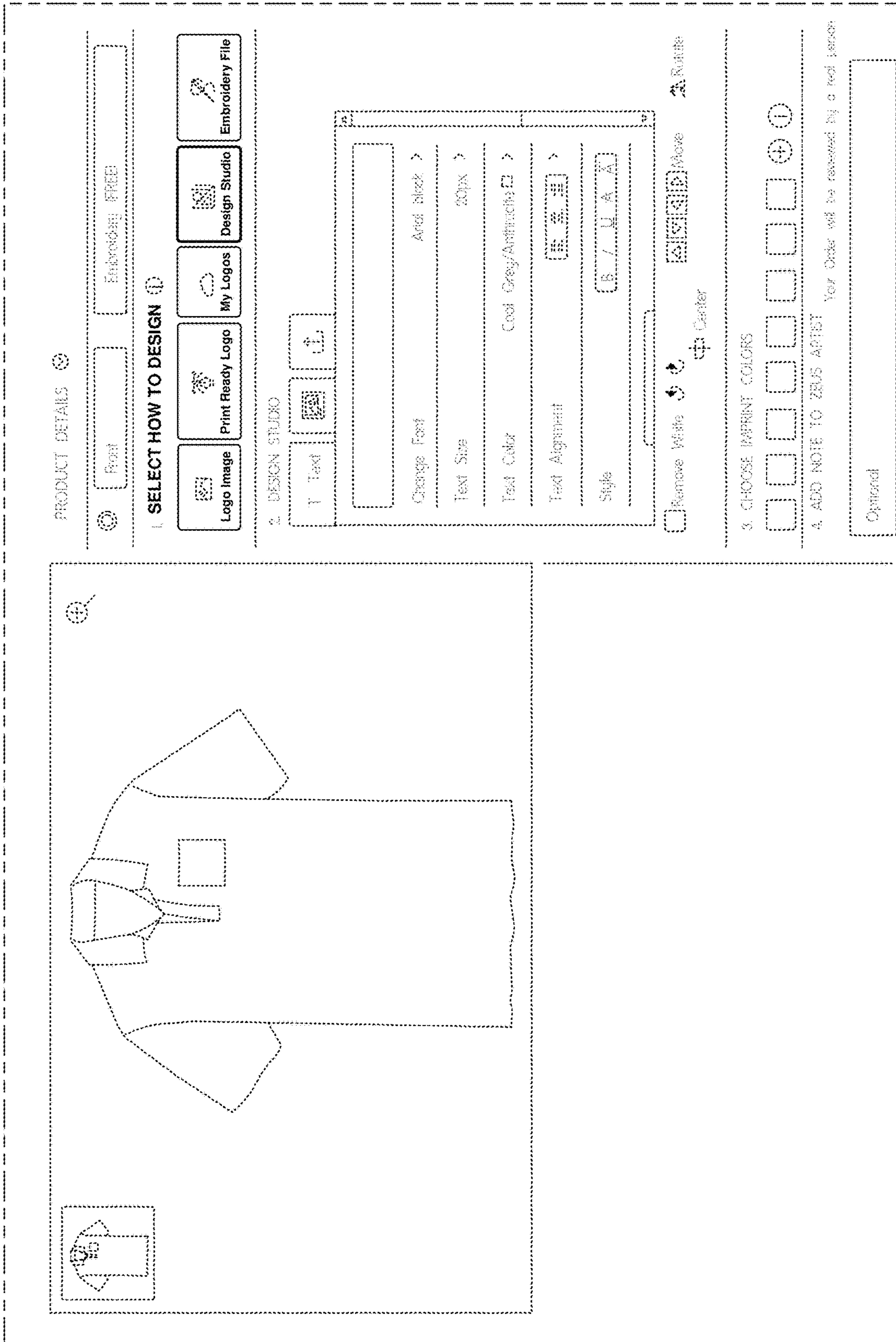
