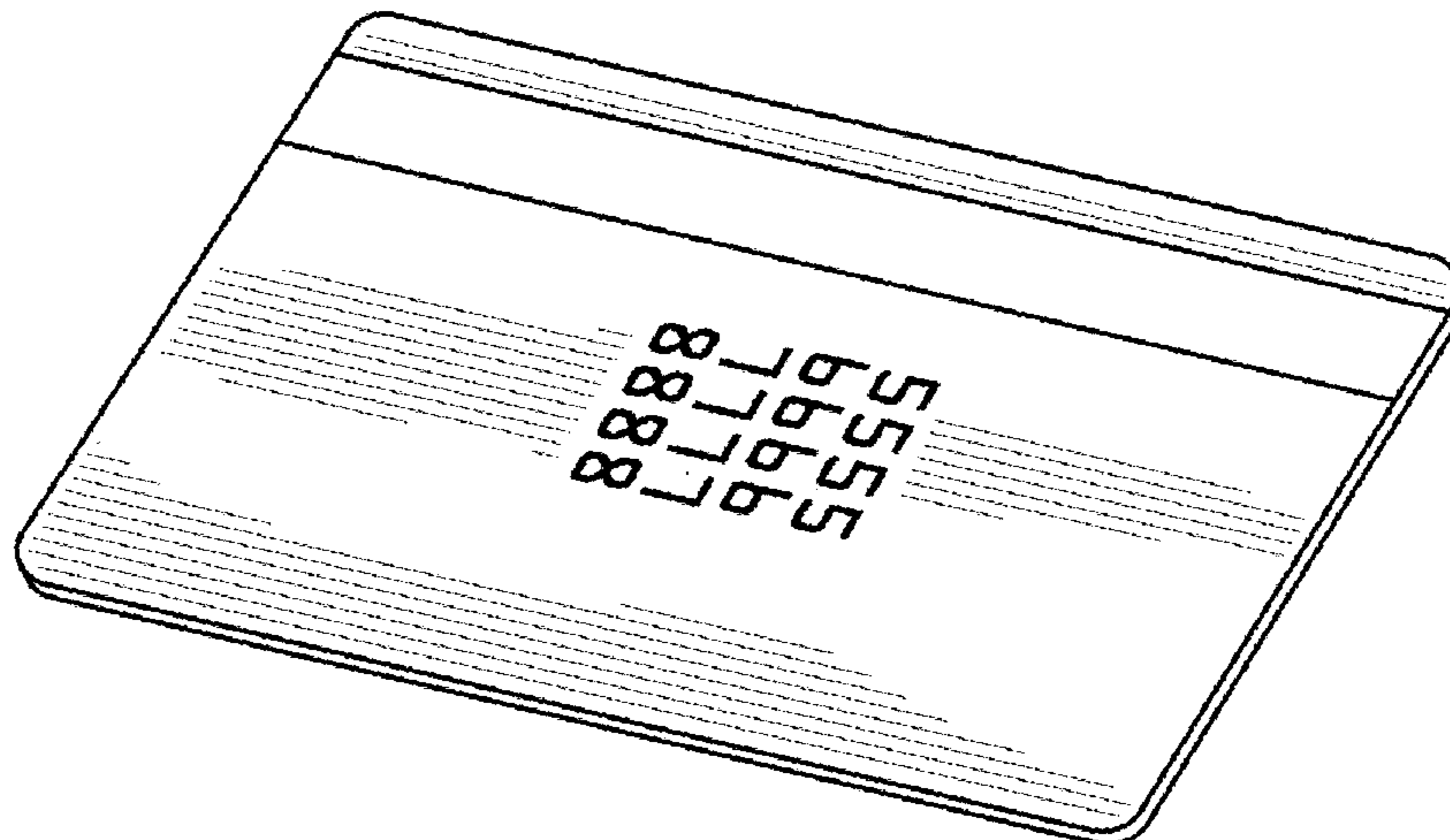
The ornamental design for a transaction card, as shown and described.

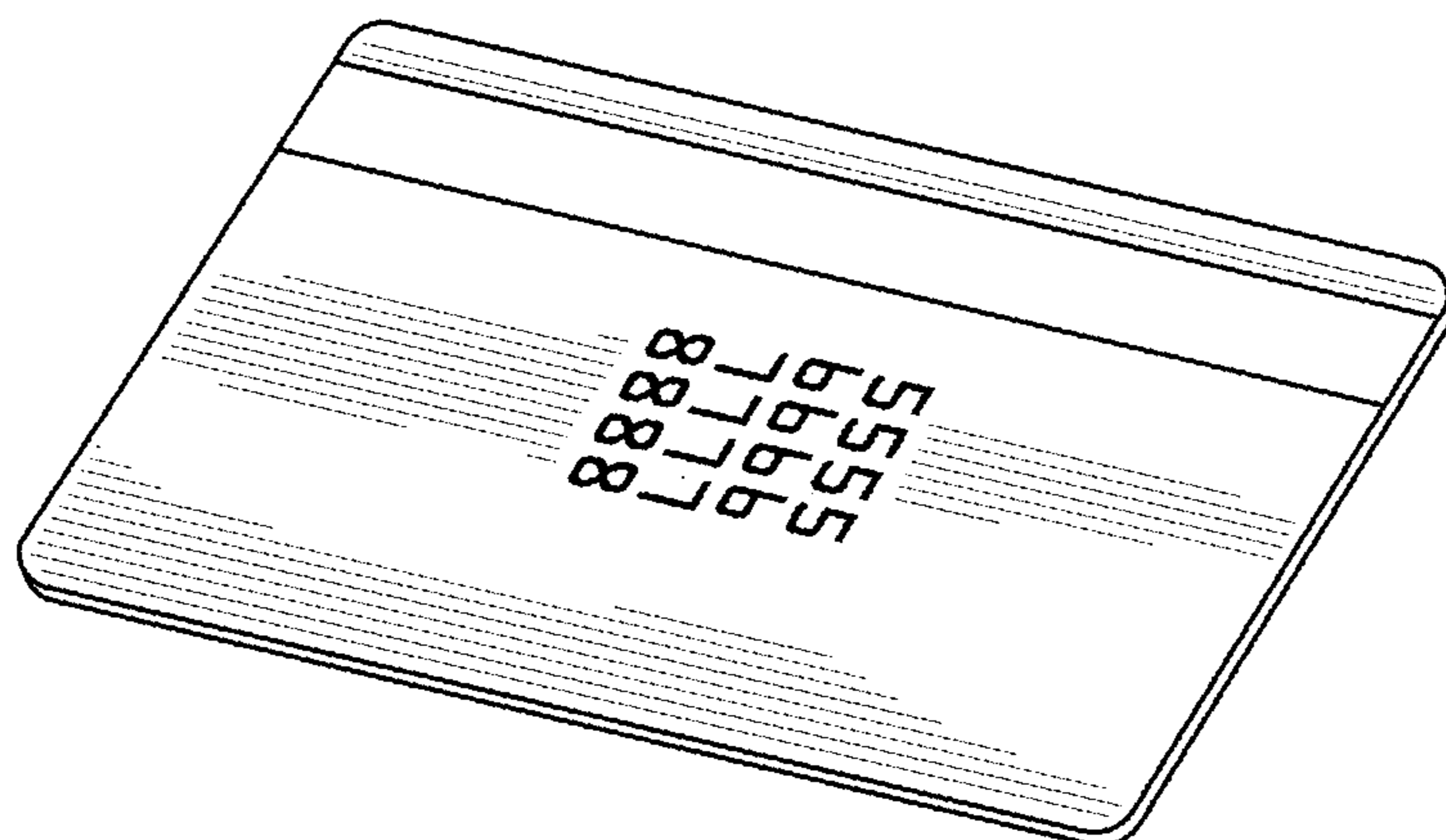

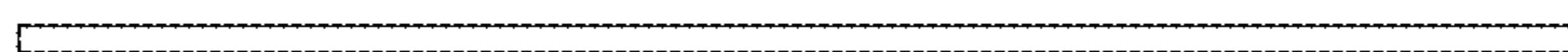

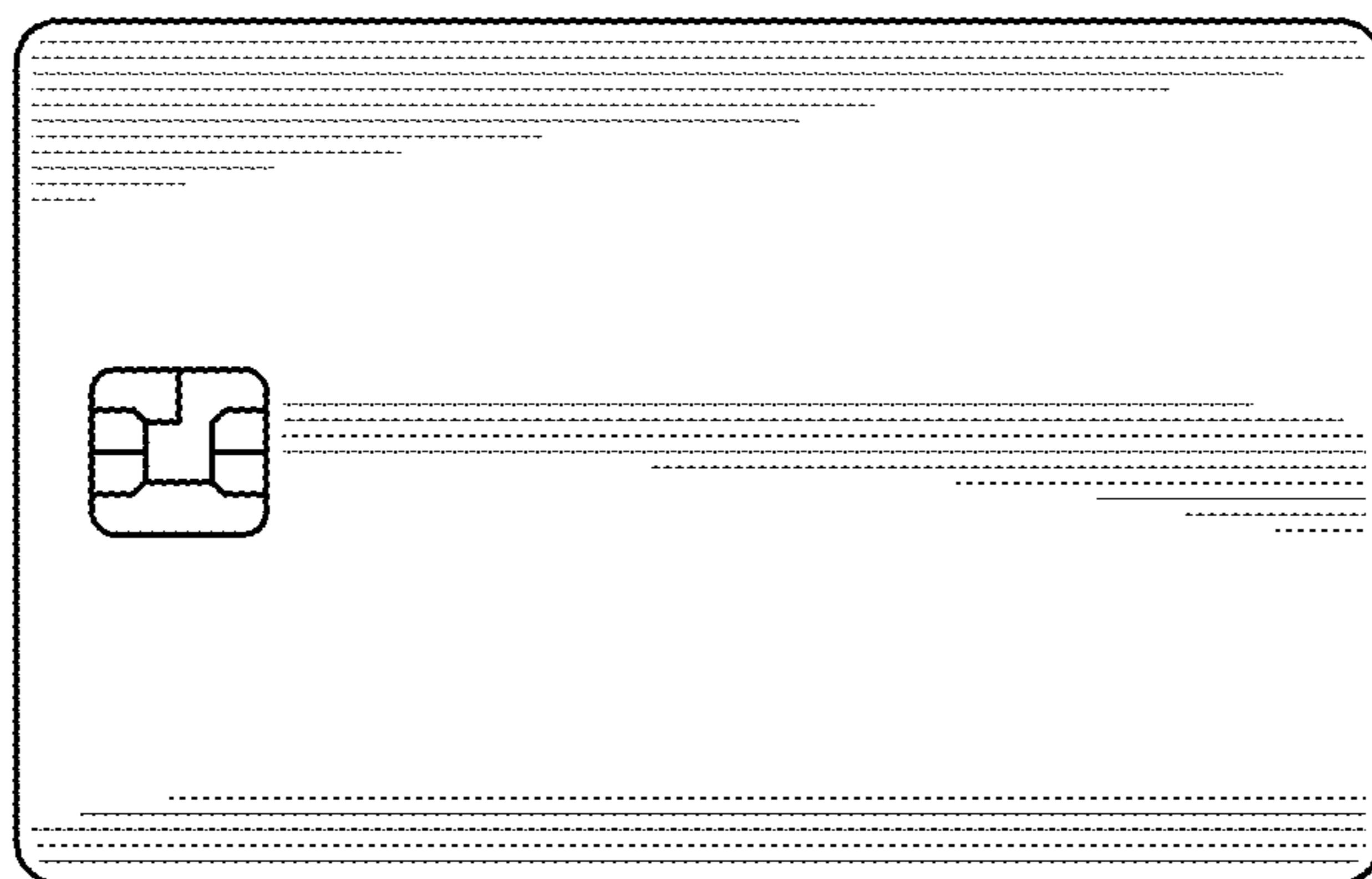

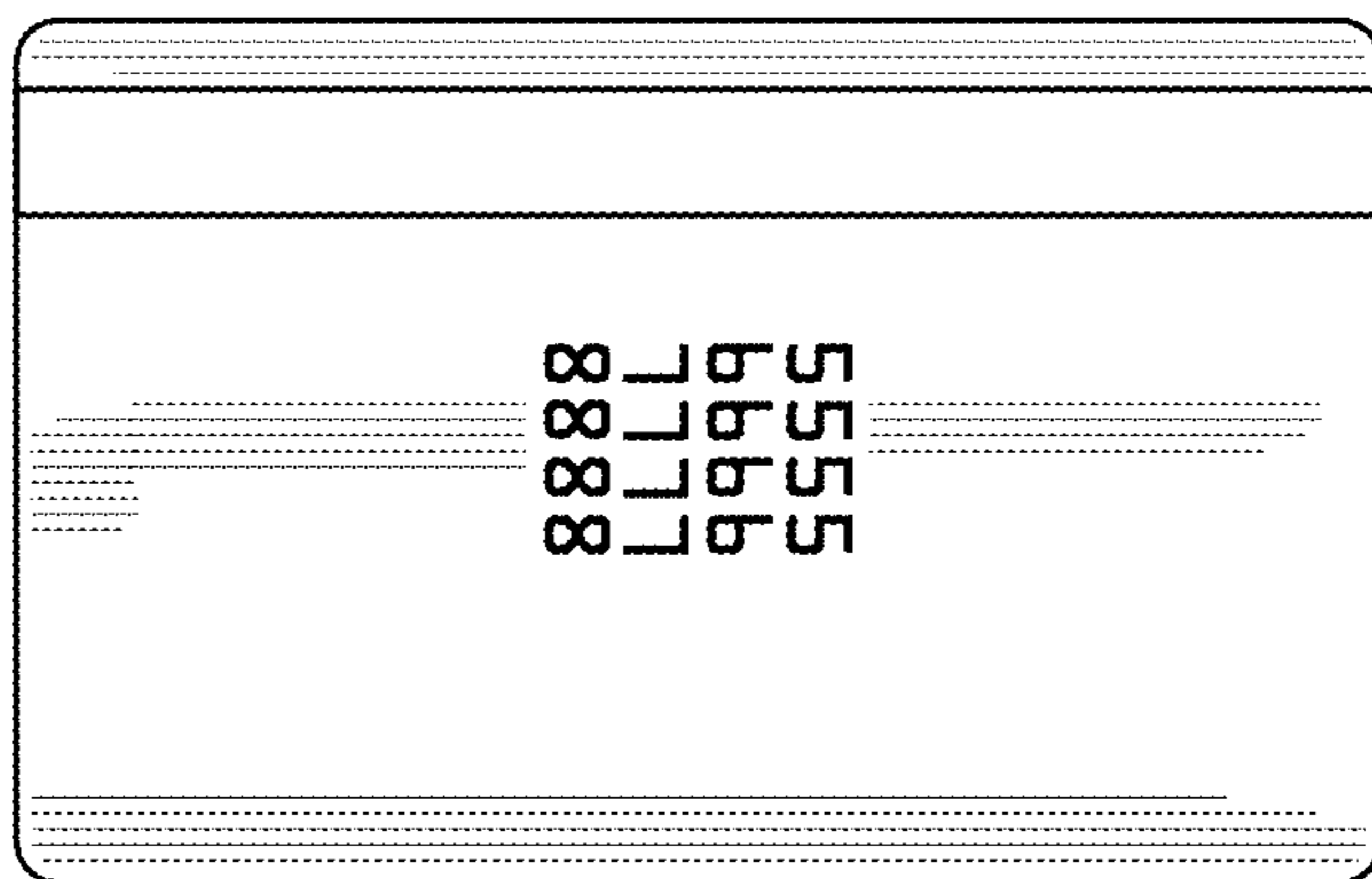

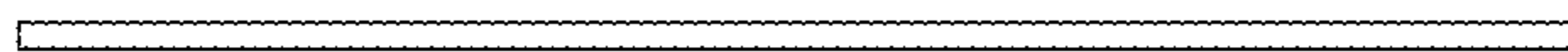
