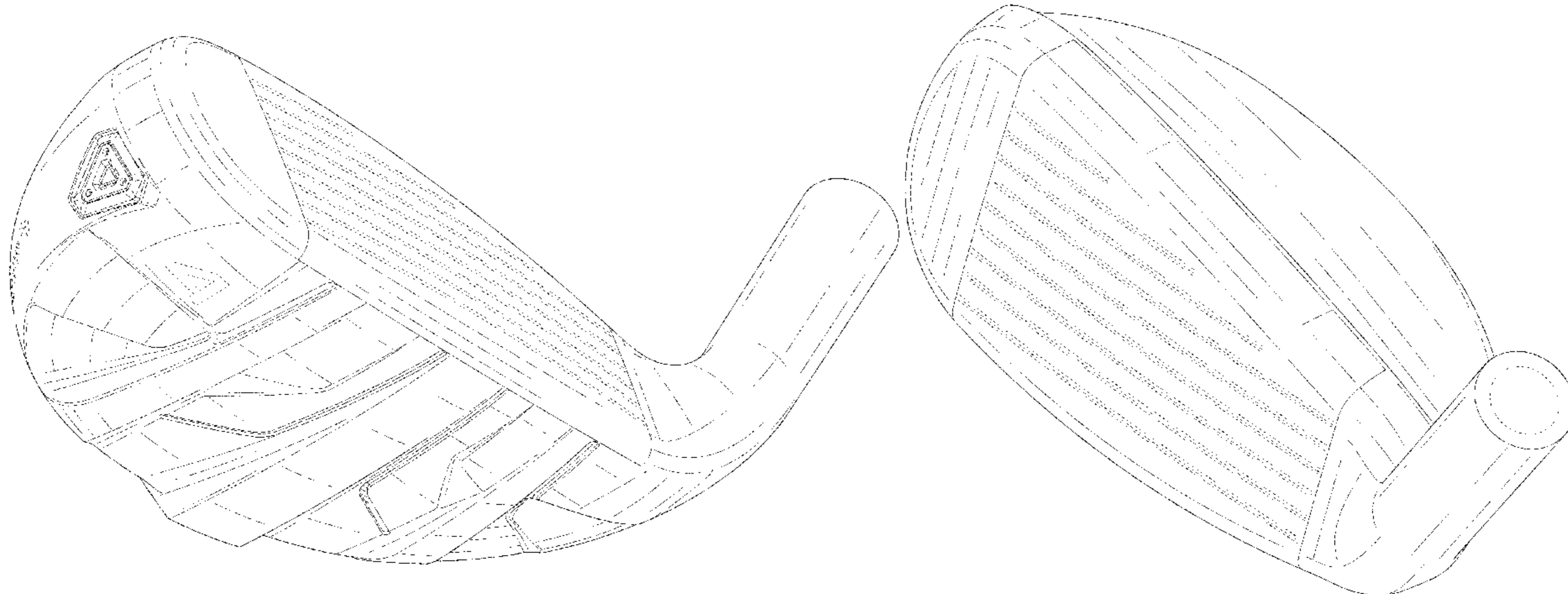
(57) **CLAIM**

The ornamental design for a golf club head, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, toe-side, bottom perspective view of a golf club head, showing the new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a toe-side elevational view thereof;  
FIG. 5 is a heel-side elevational view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof;  
FIG. 8 is a front, heel-side, bottom perspective view thereof;  
FIG. 9 is a front, heel-side, top perspective view thereof;

FIG. 10 is a rear, heel-side, top perspective view thereof.

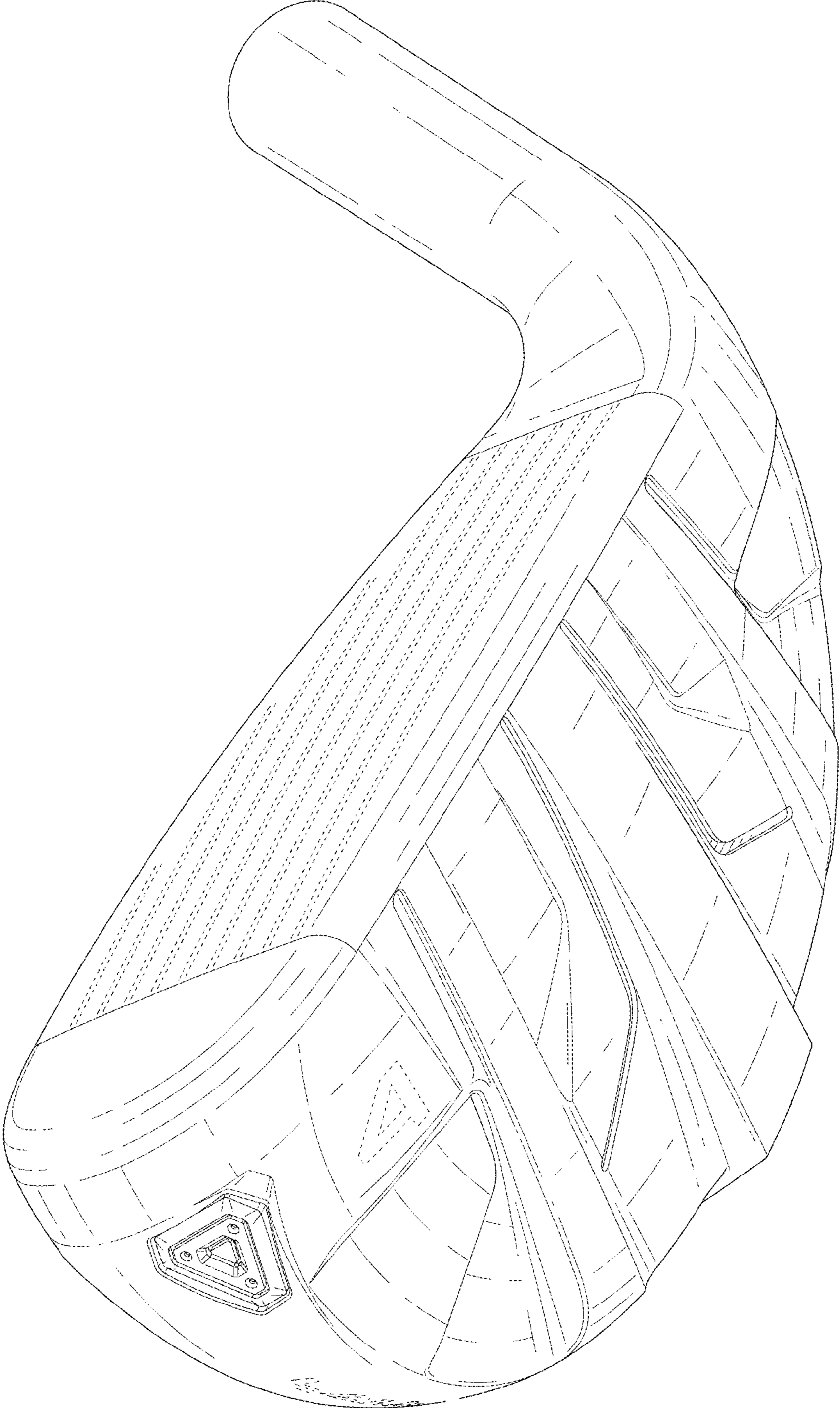

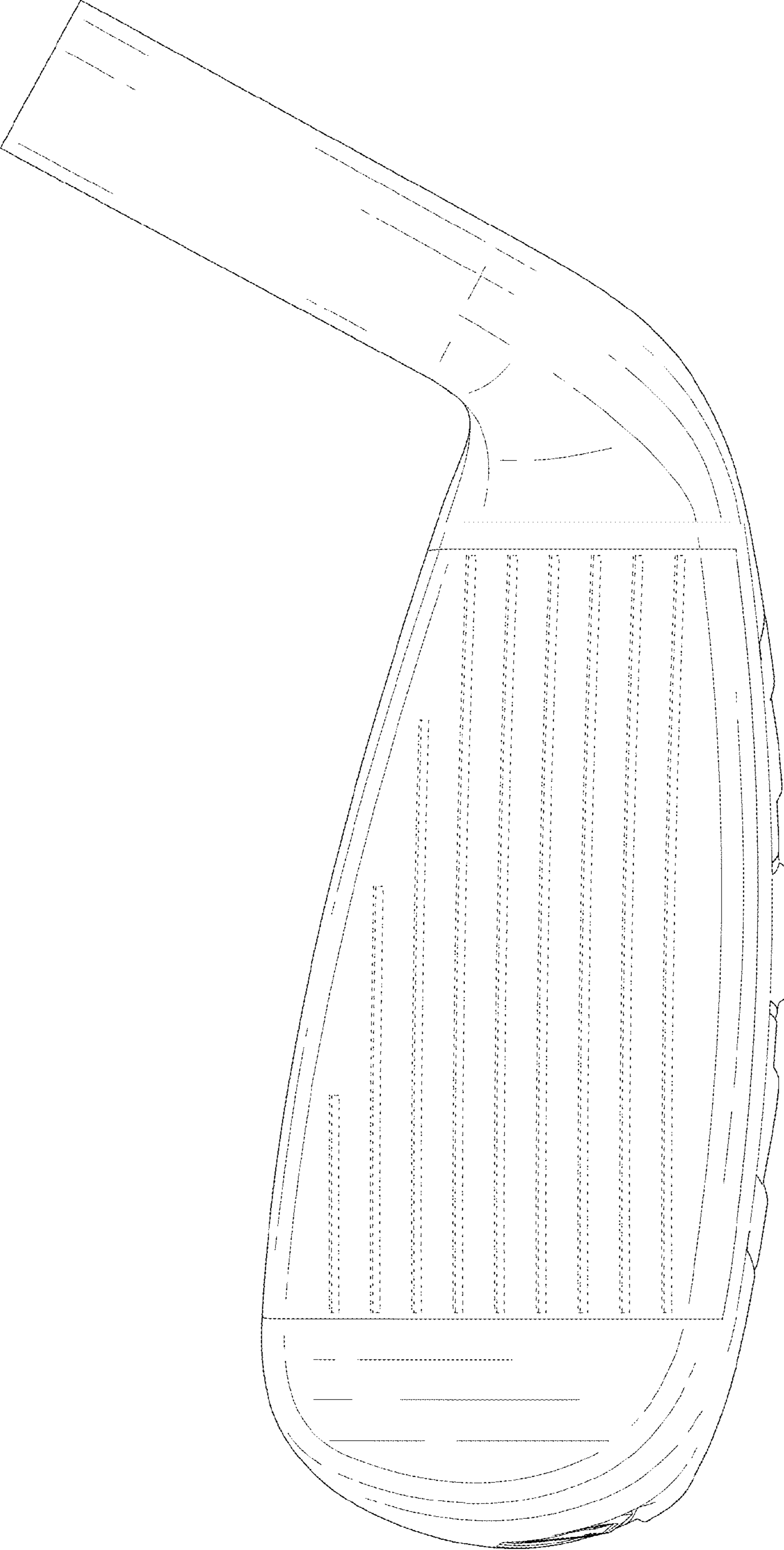

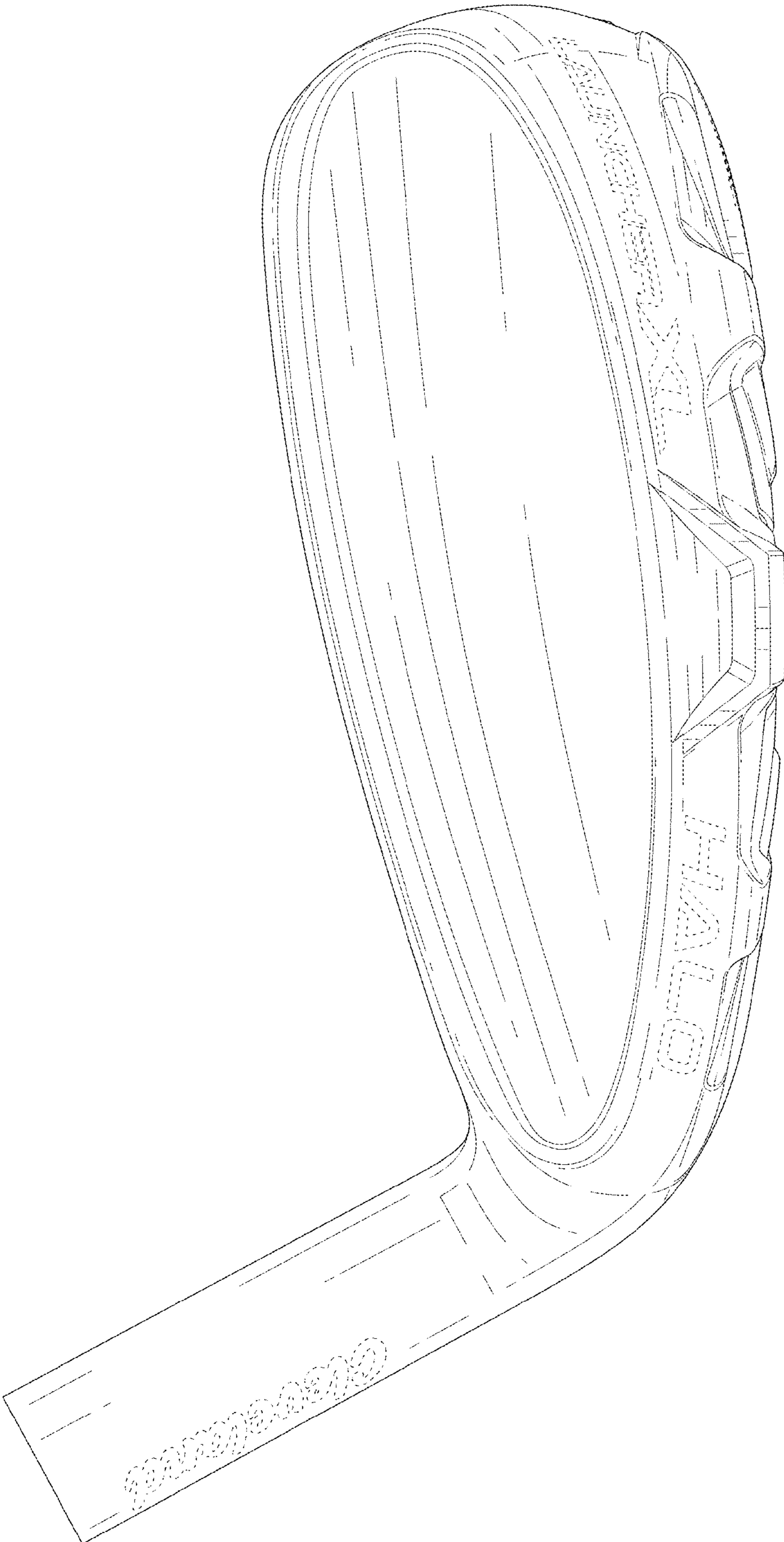

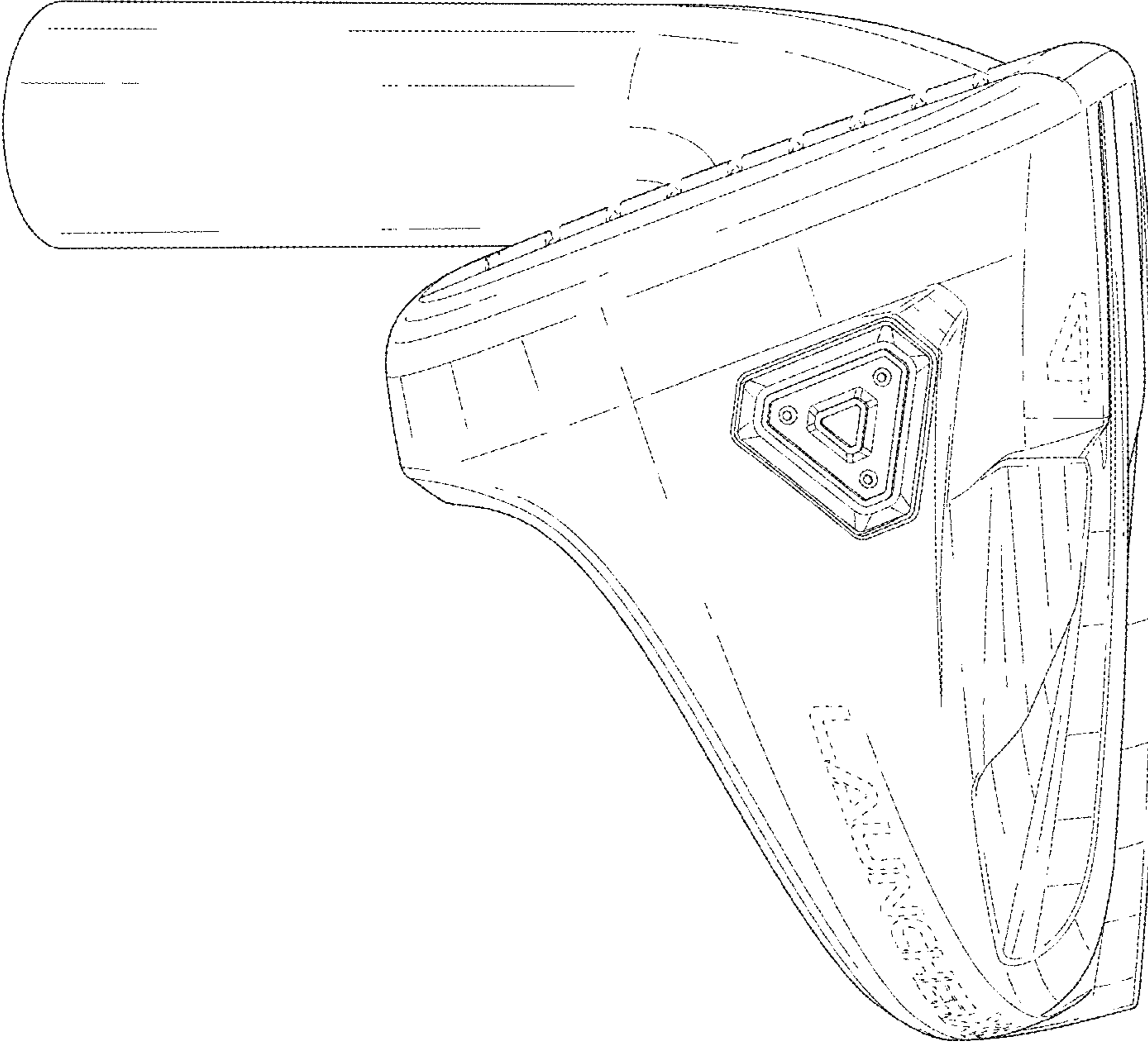

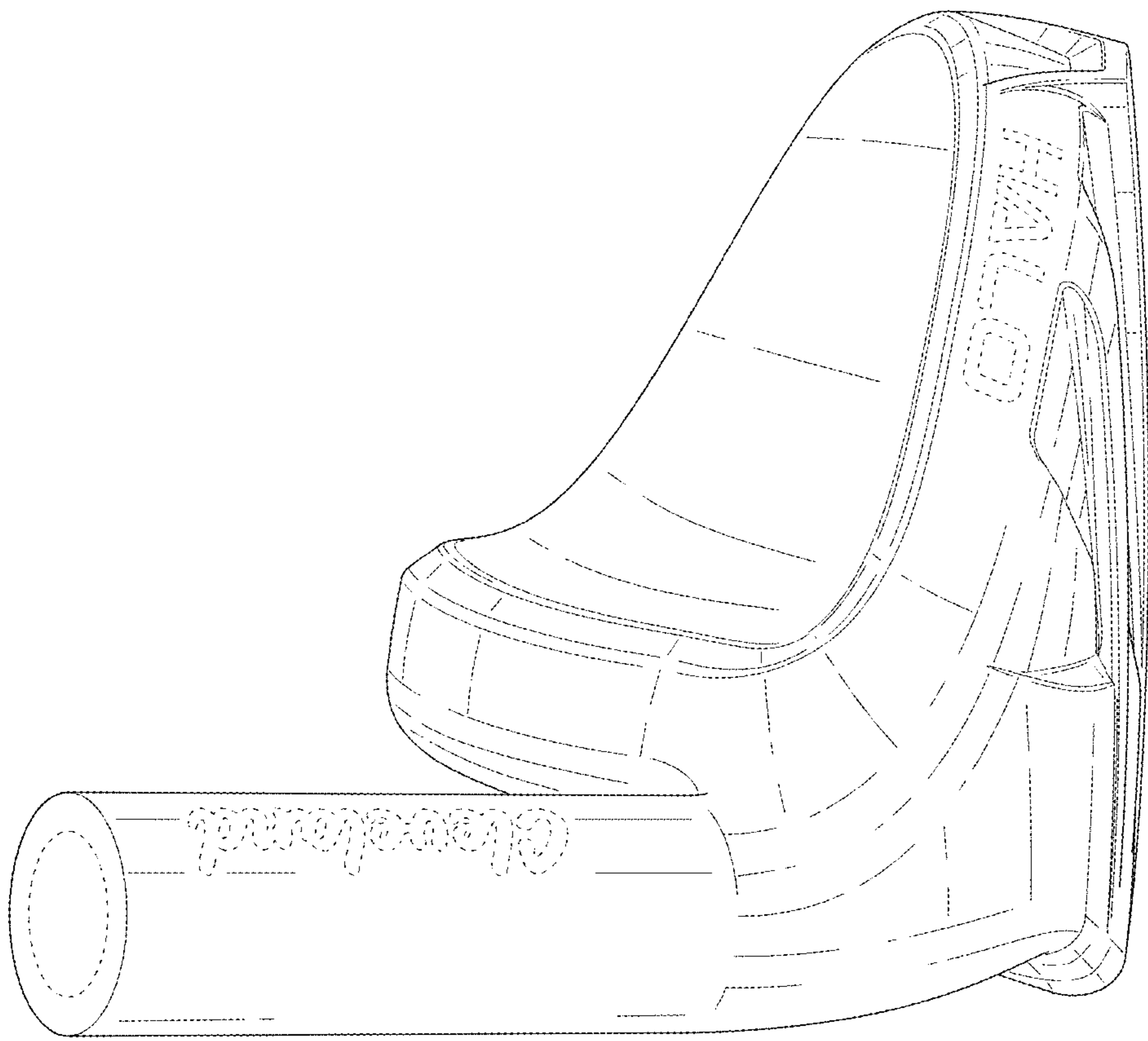

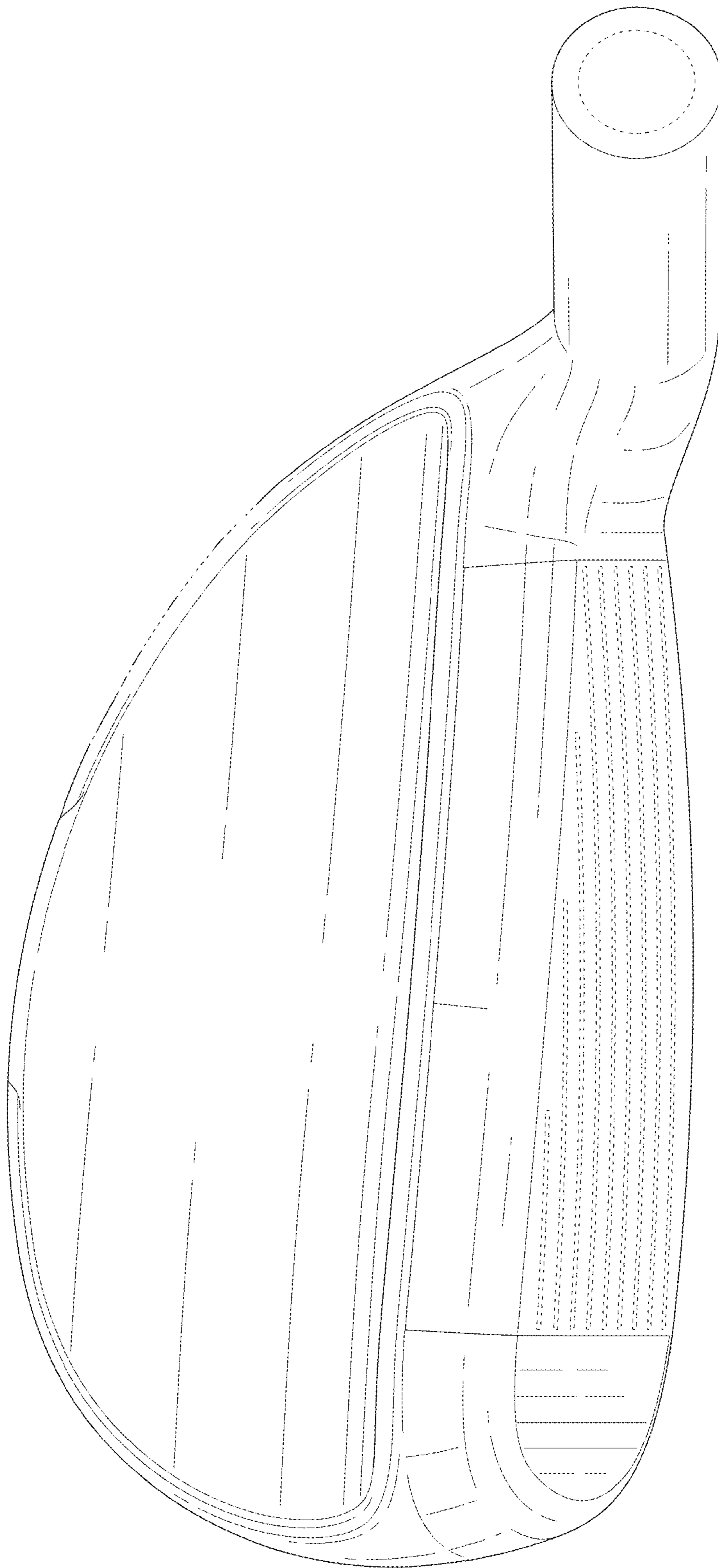

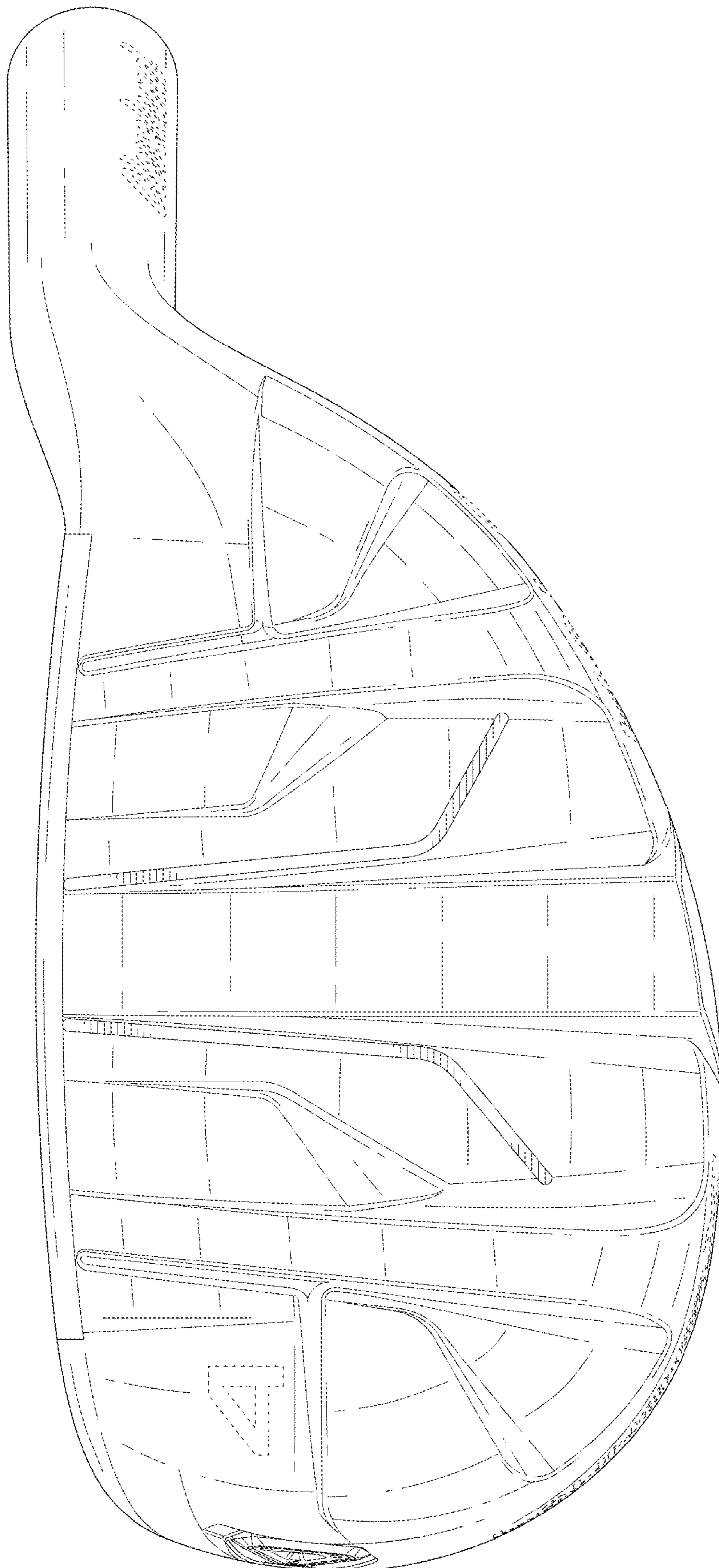

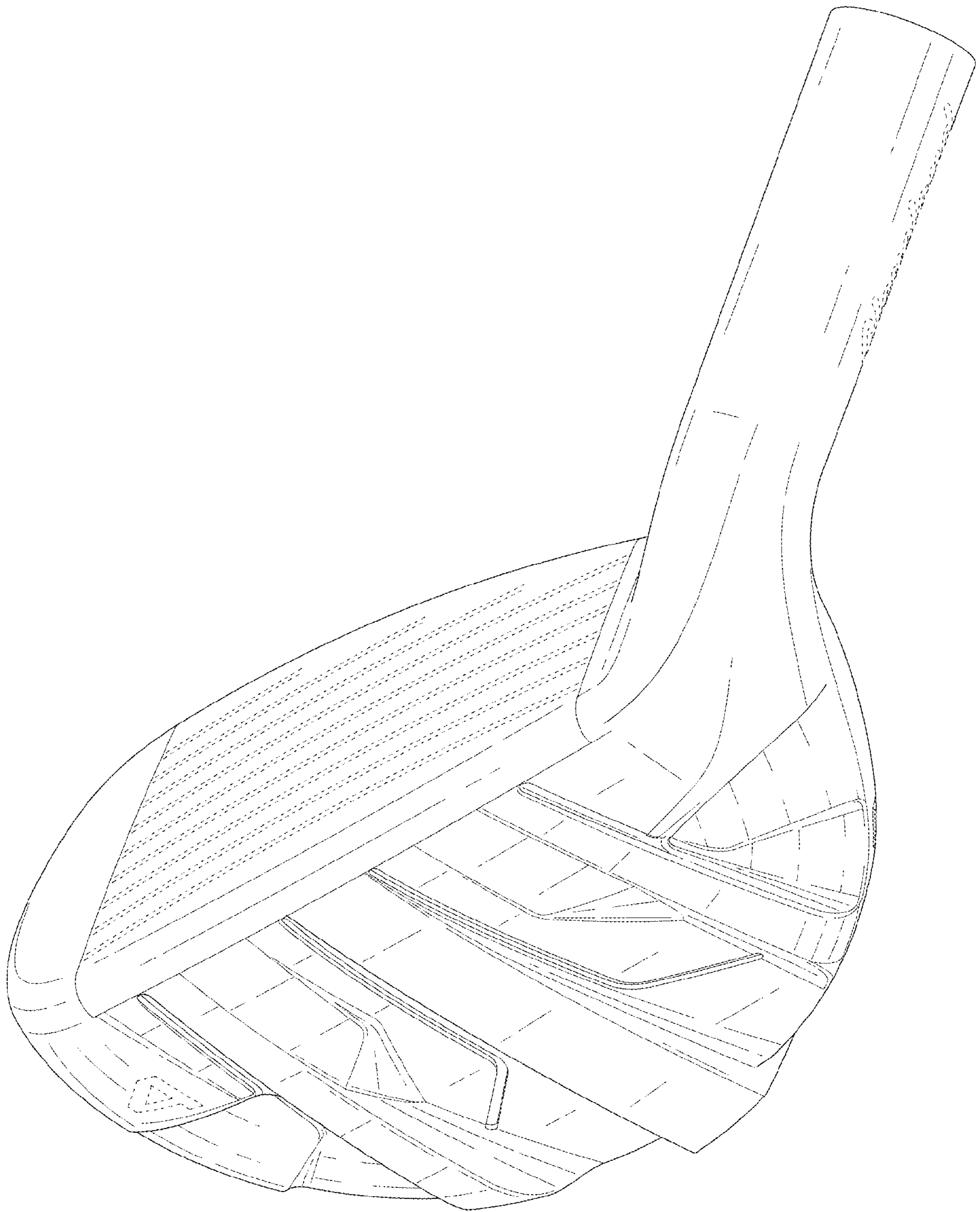

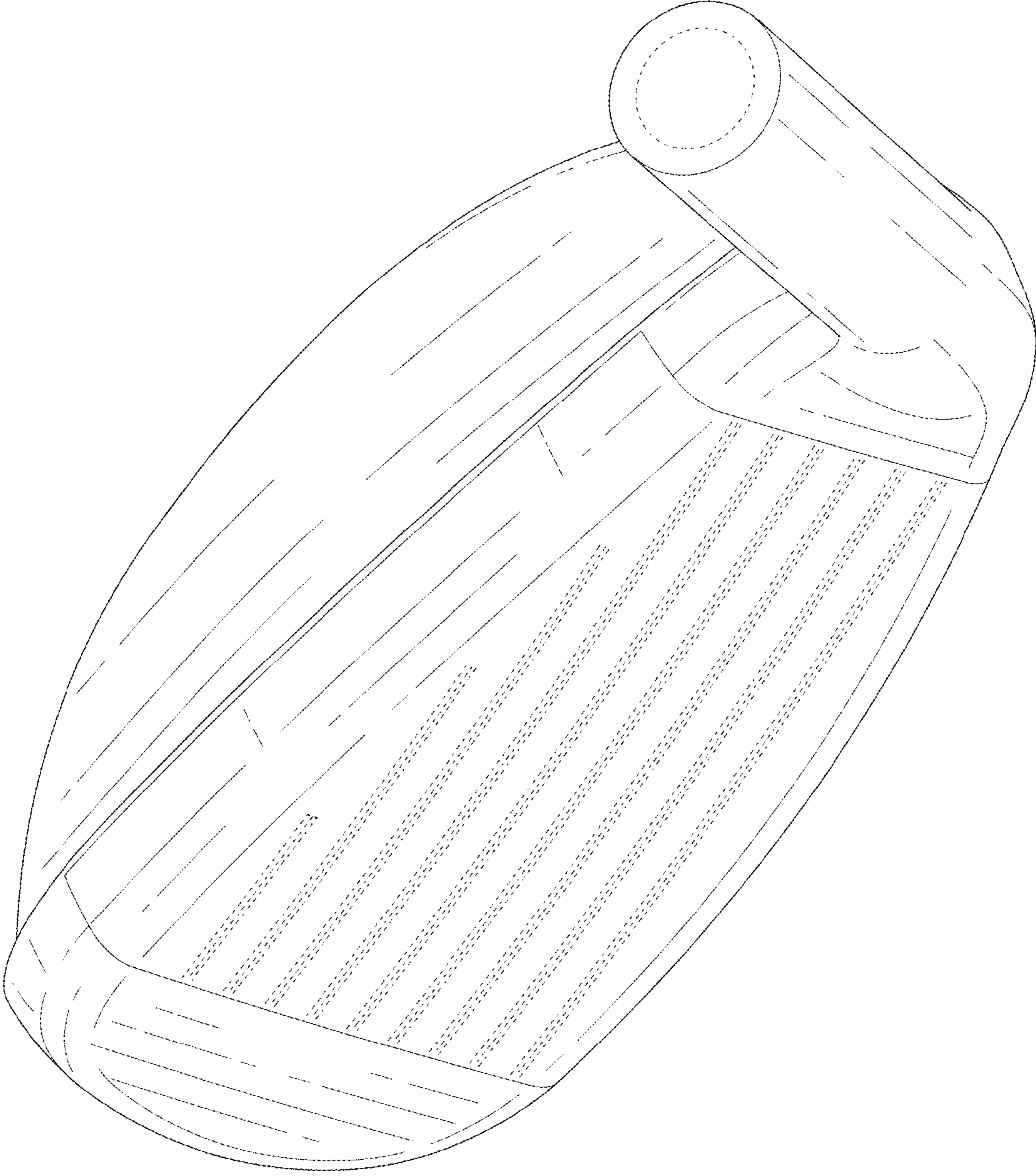

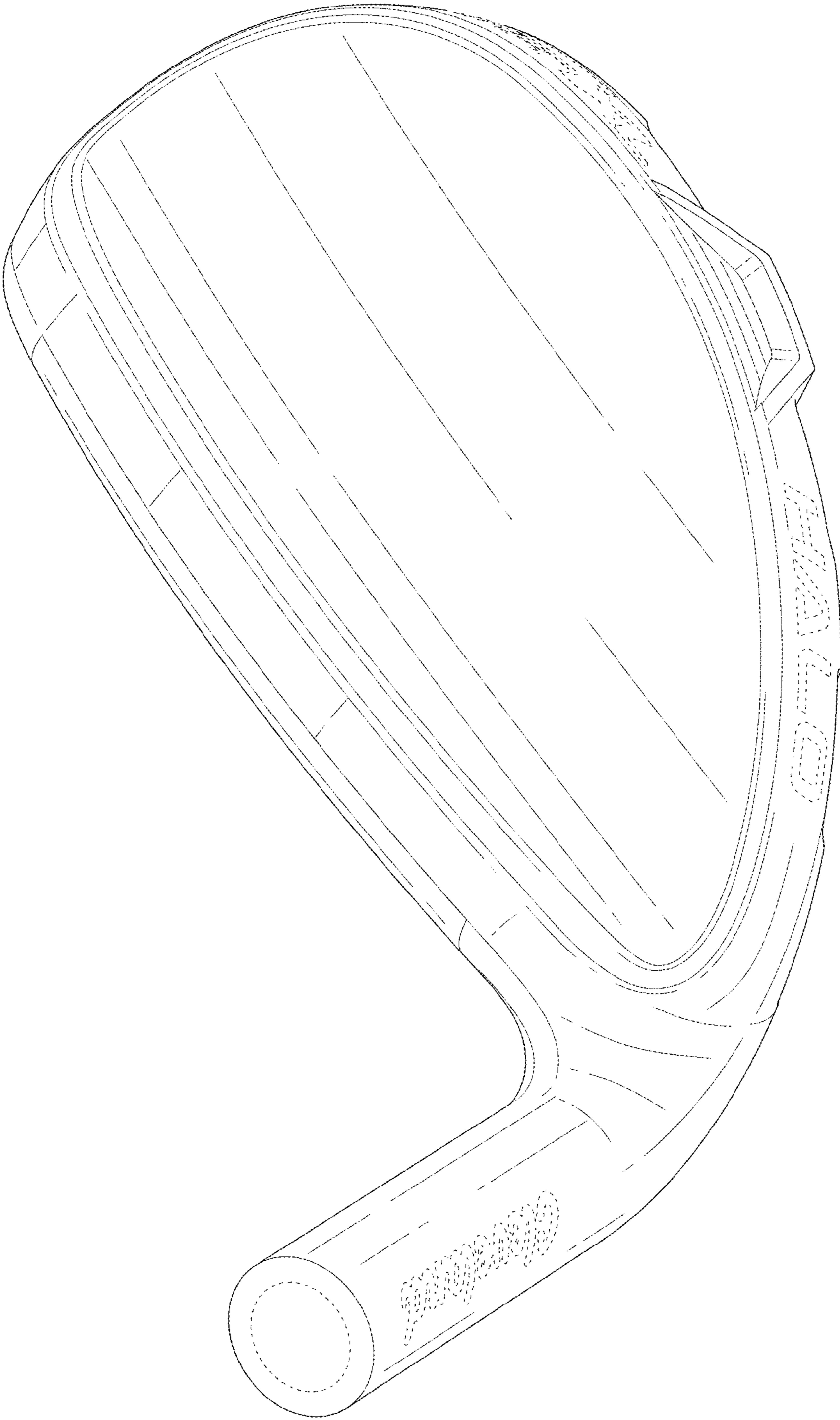
