The ornamental design for a raft, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the raft in accordance with my design.

FIG. 2 is a top plan view of the raft of FIG. 1.

FIG. 3 is a bottom plan view of the raft of FIG. 1.

FIG. 4 is a left-side elevation of the raft of FIG. 2.


FIG. 5 is a right-side elevation of the raft of FIG. 2.
















