 FIG. 8 is an enlarged section of FIG. 1 taken along line 8 of FIG. 1.

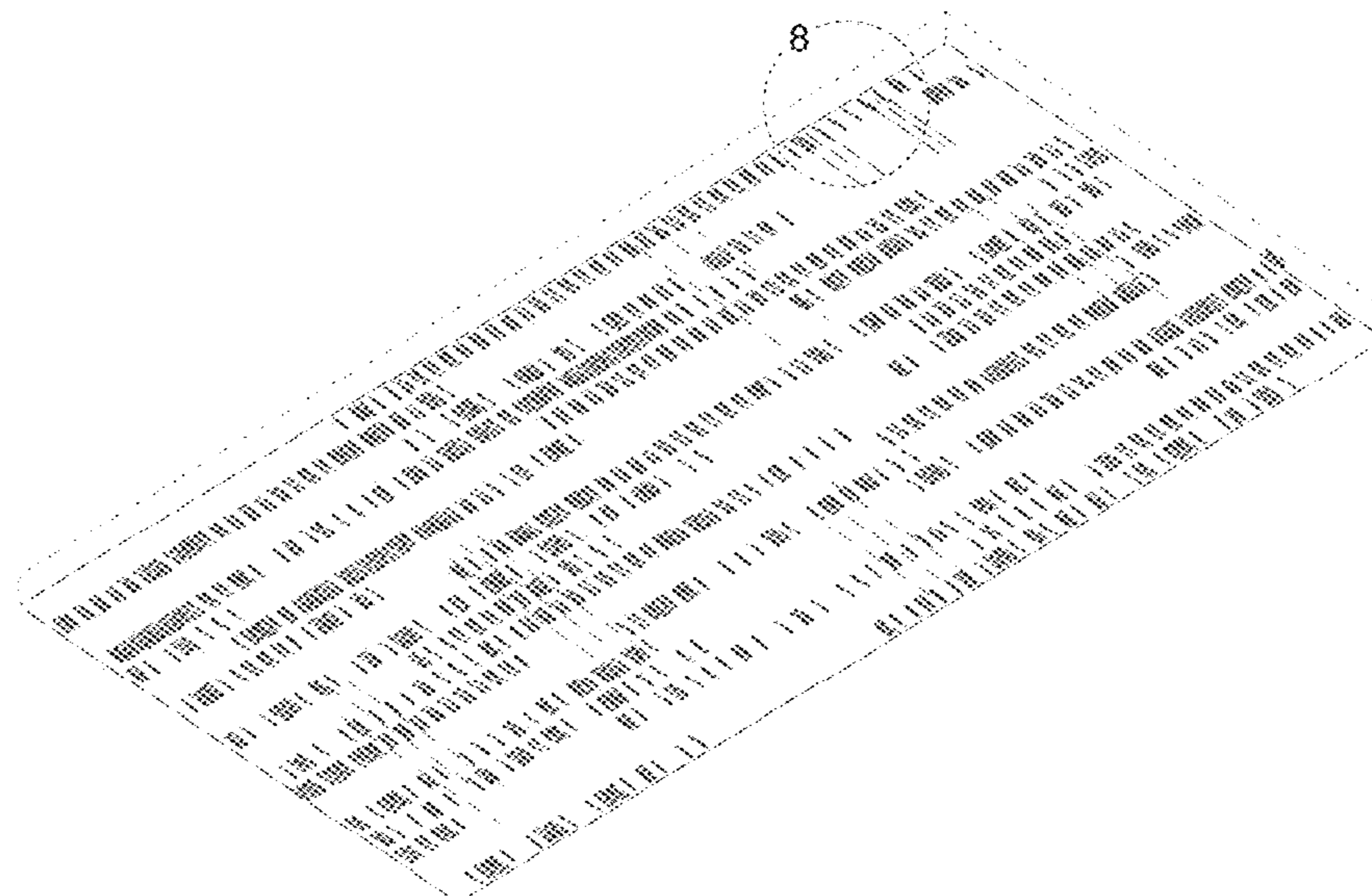
The broken lines in the drawings depict portions of the architectural fixture that form no part of the claimed design.

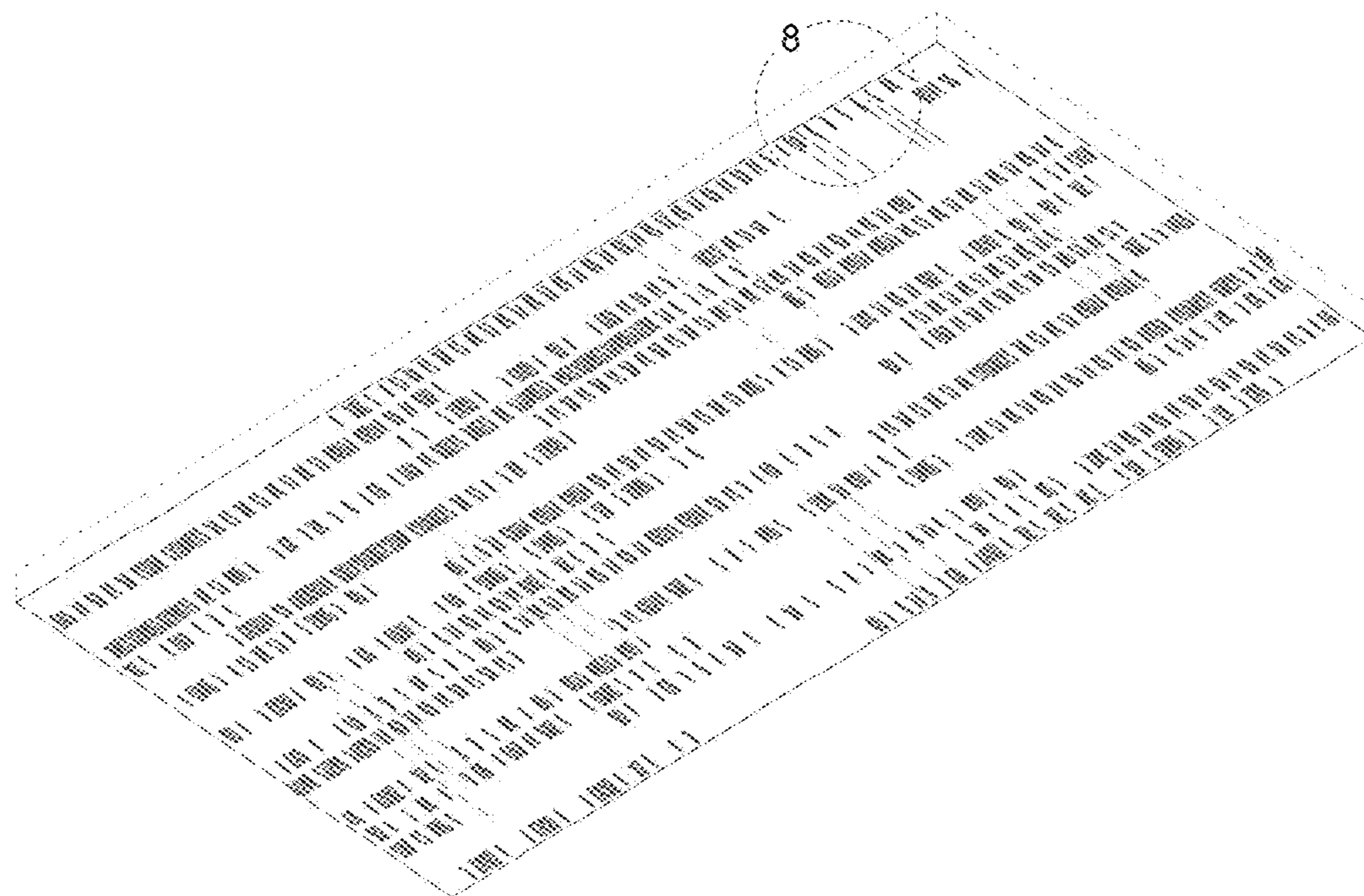

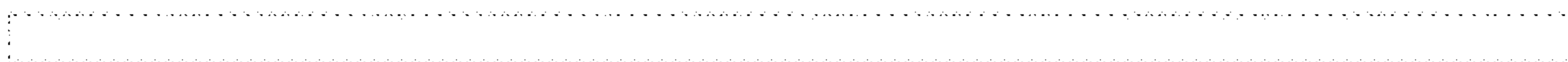

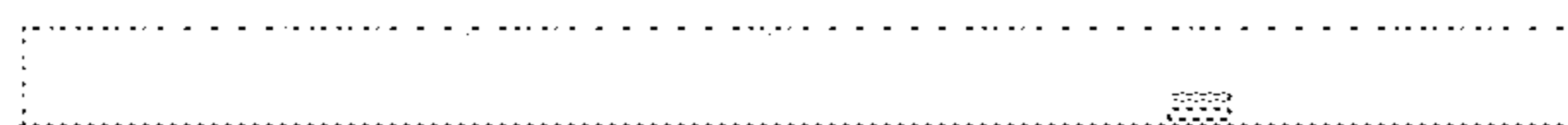
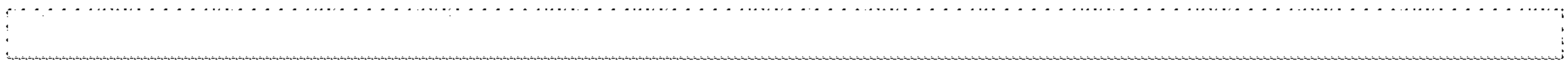
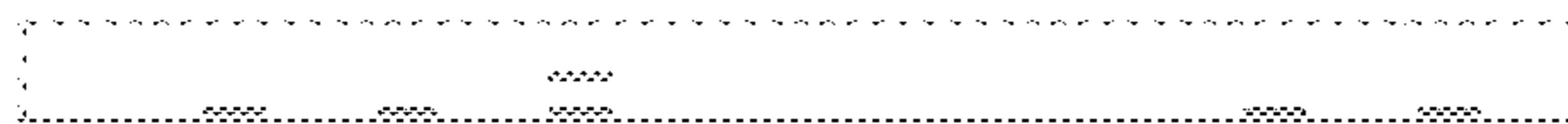

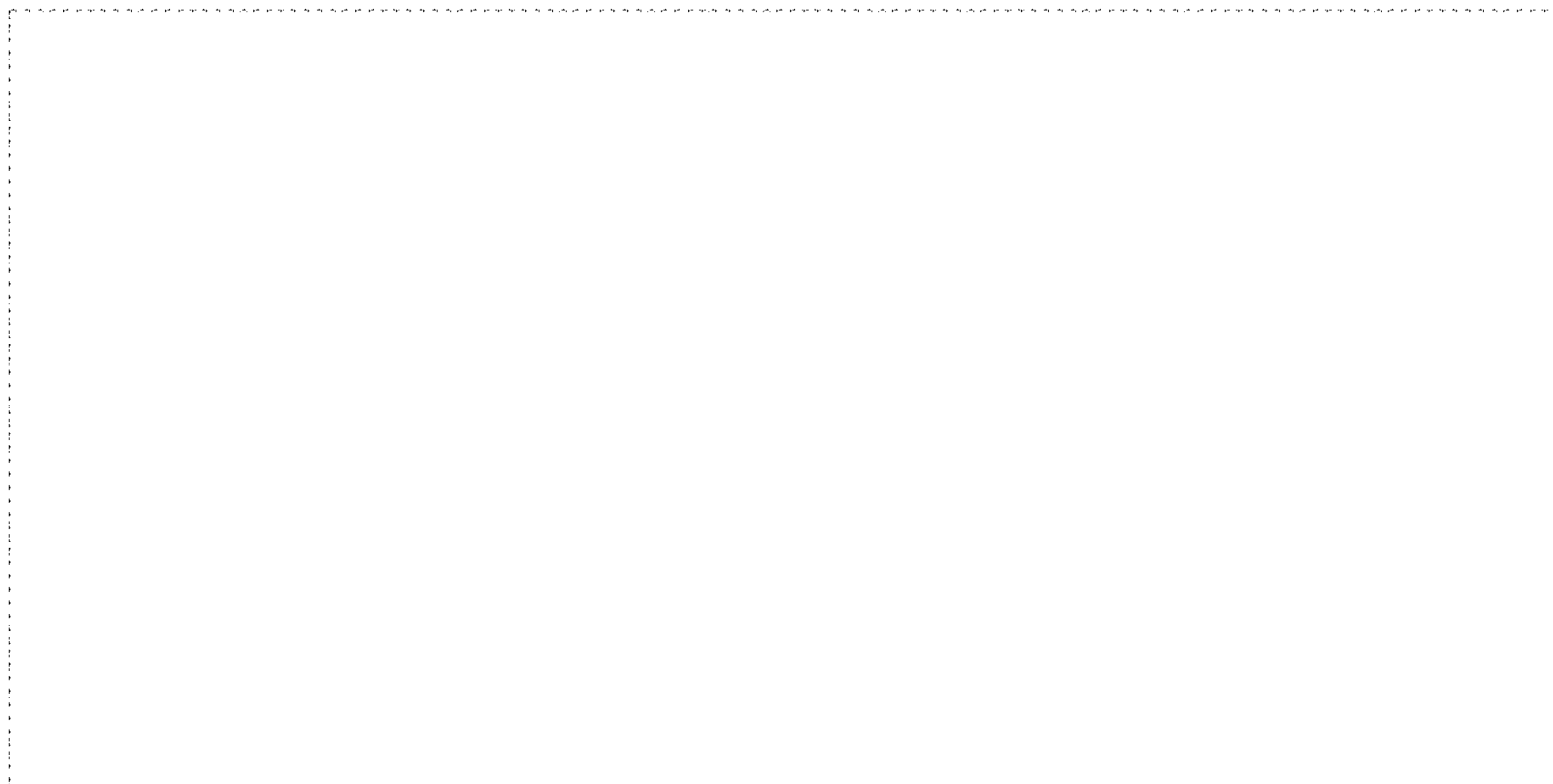

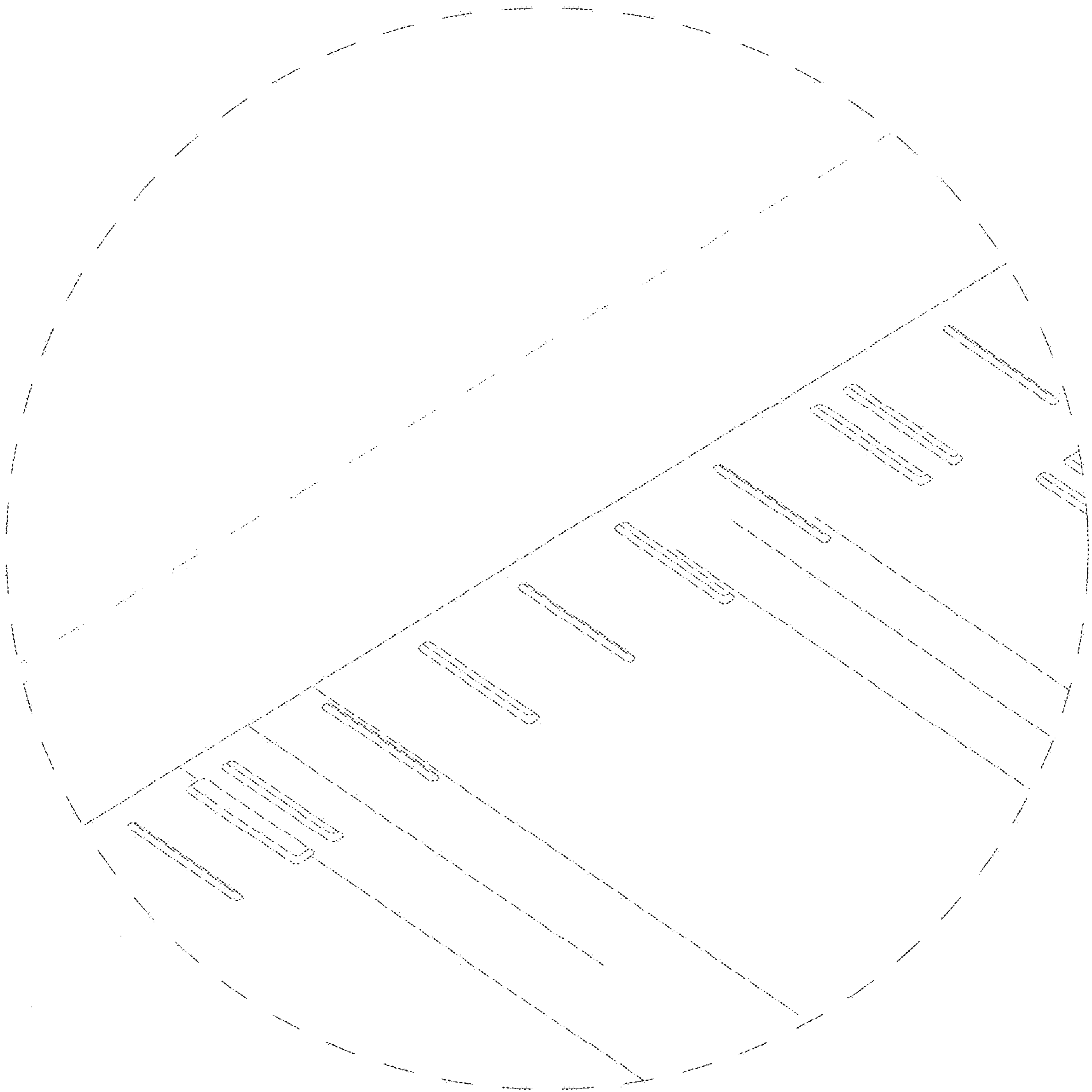
