(57) **CLAIM**

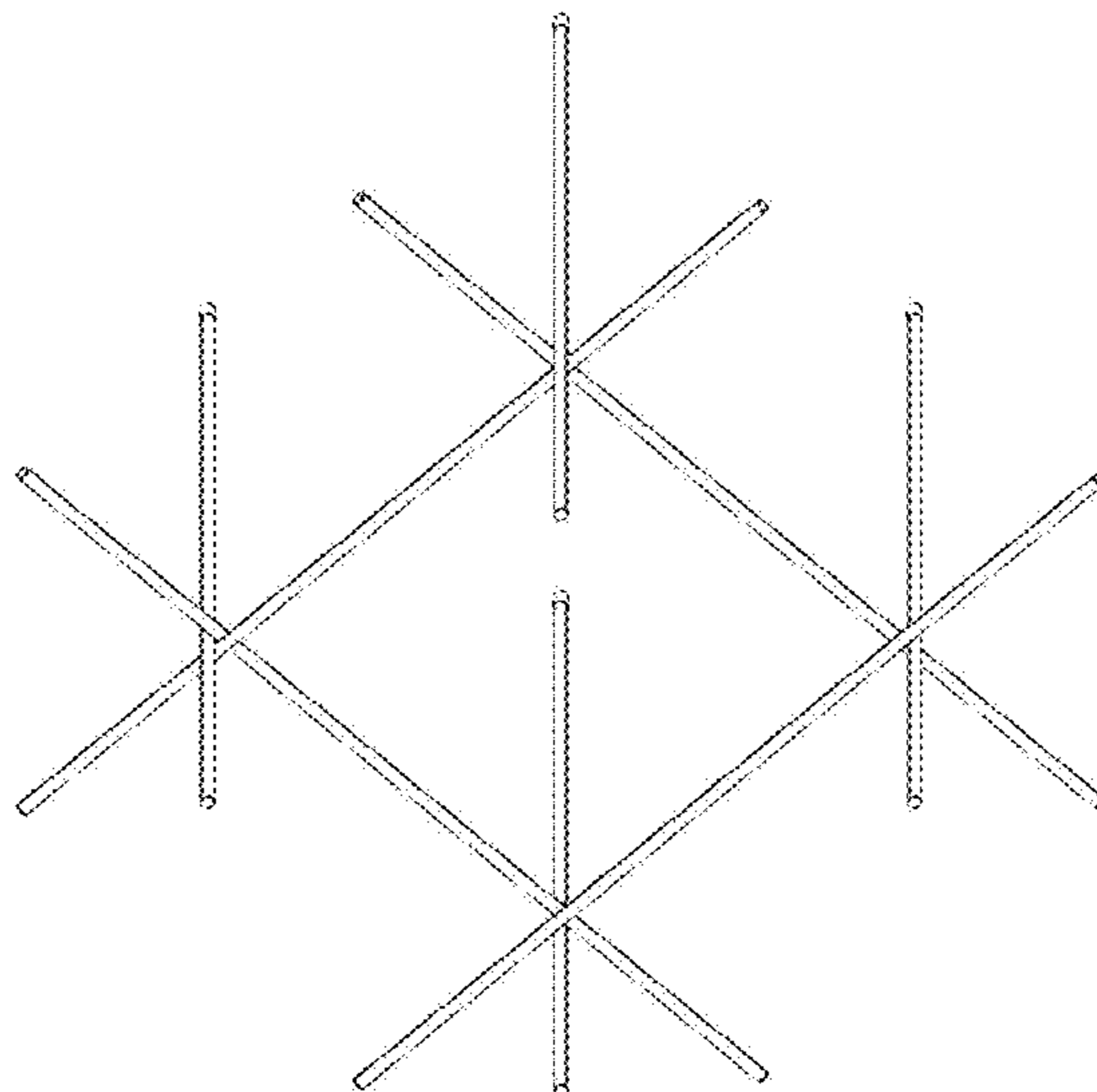
The ornamental design for a ceiling lamp, as shown and described.

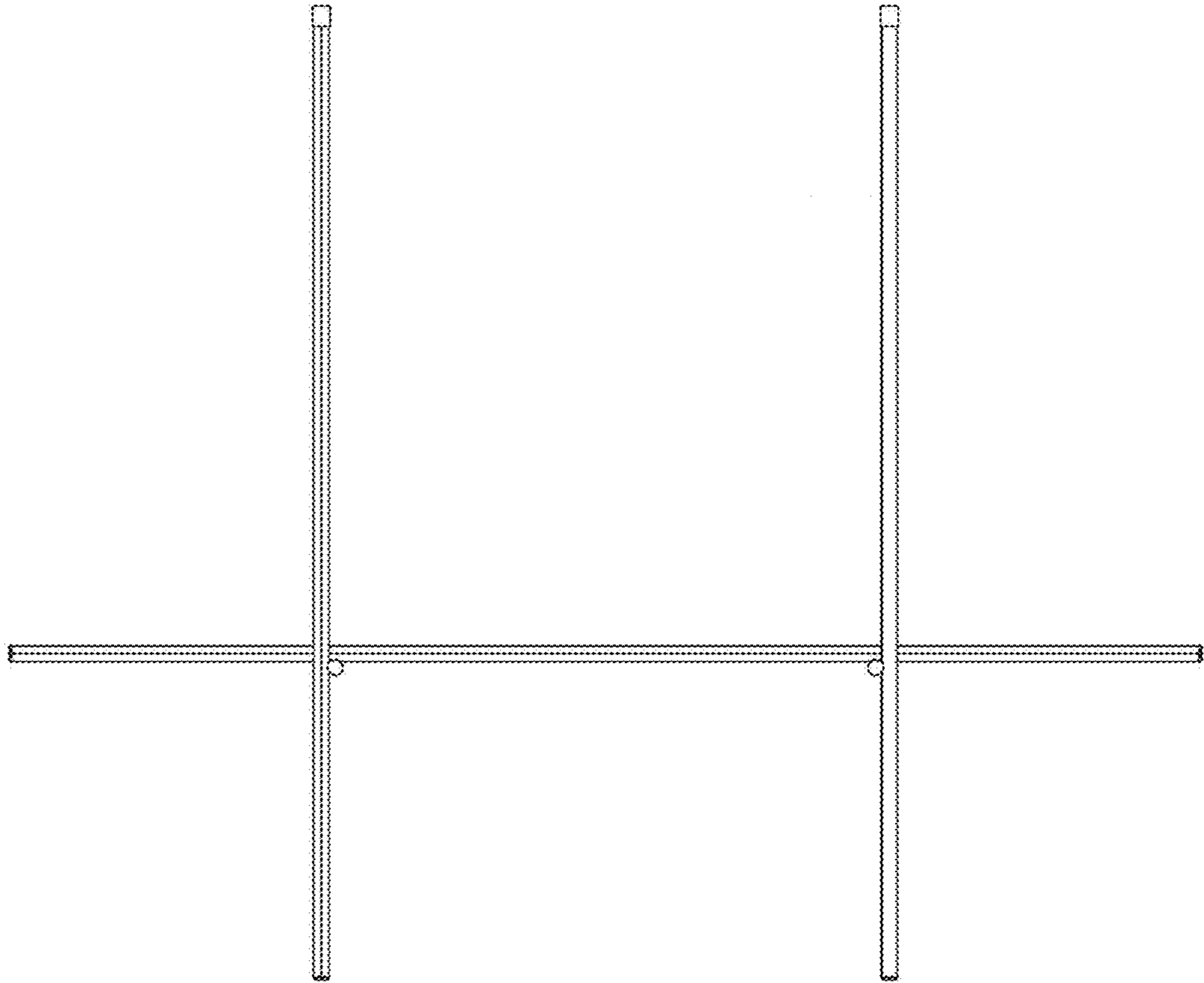

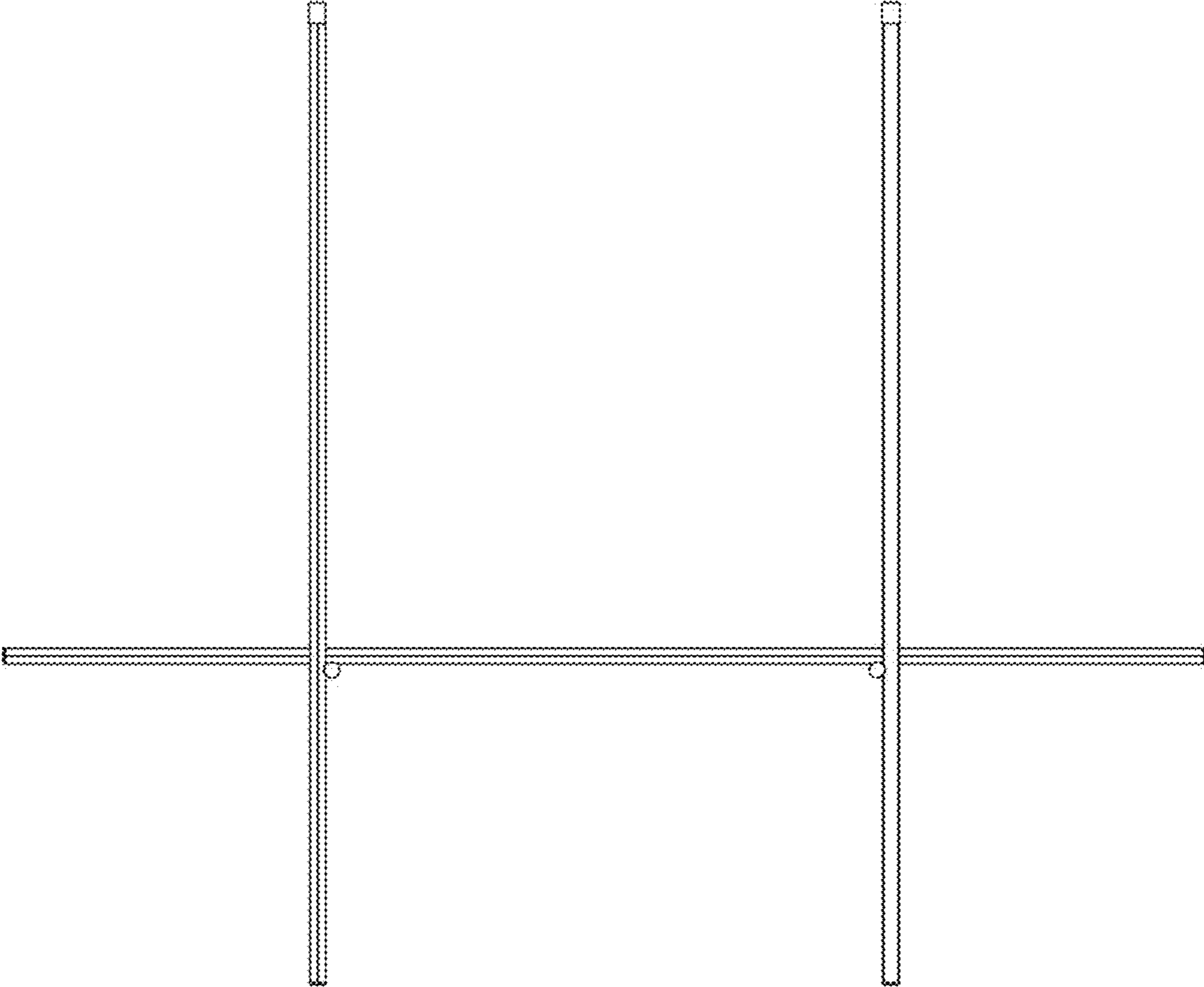

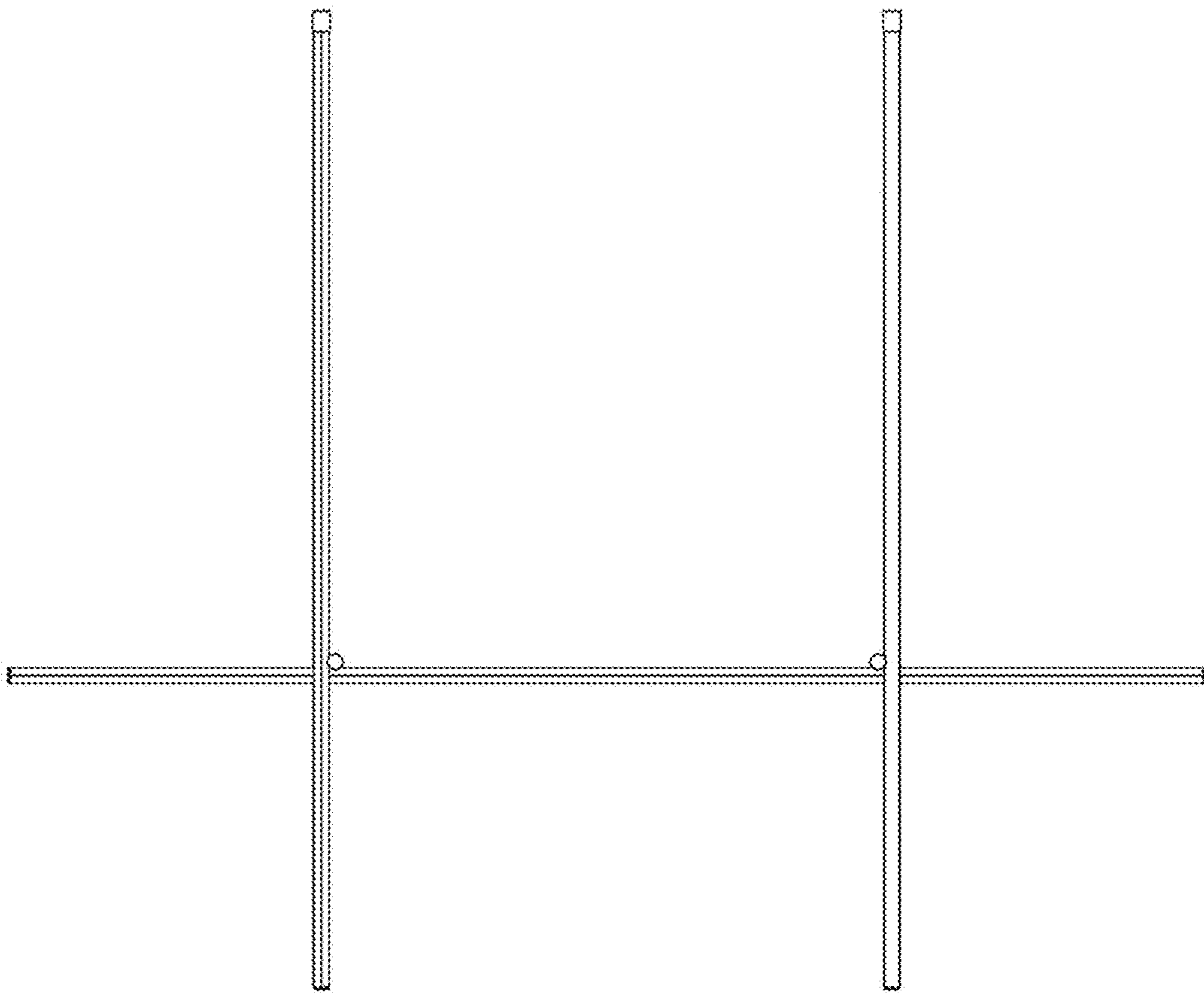

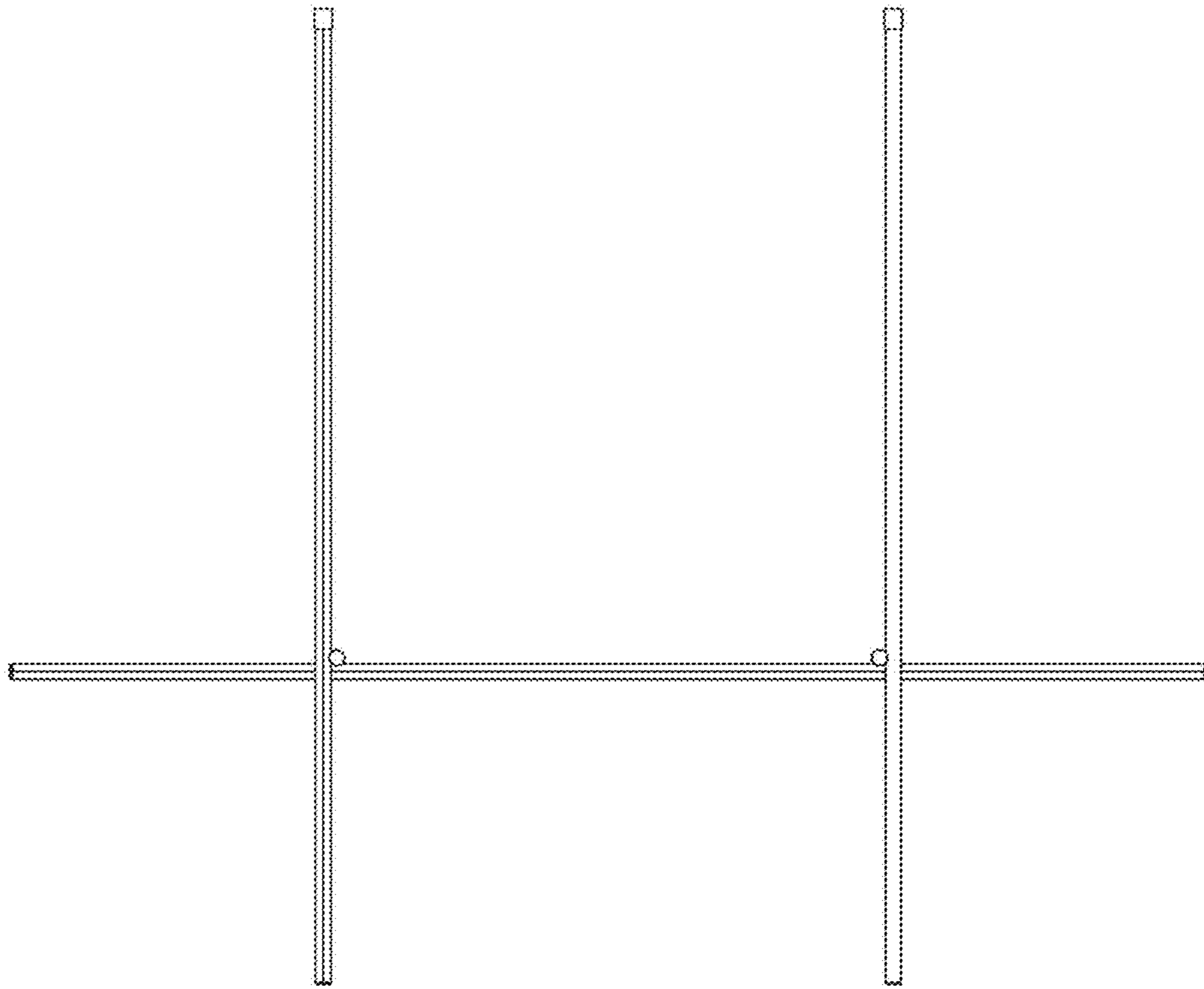

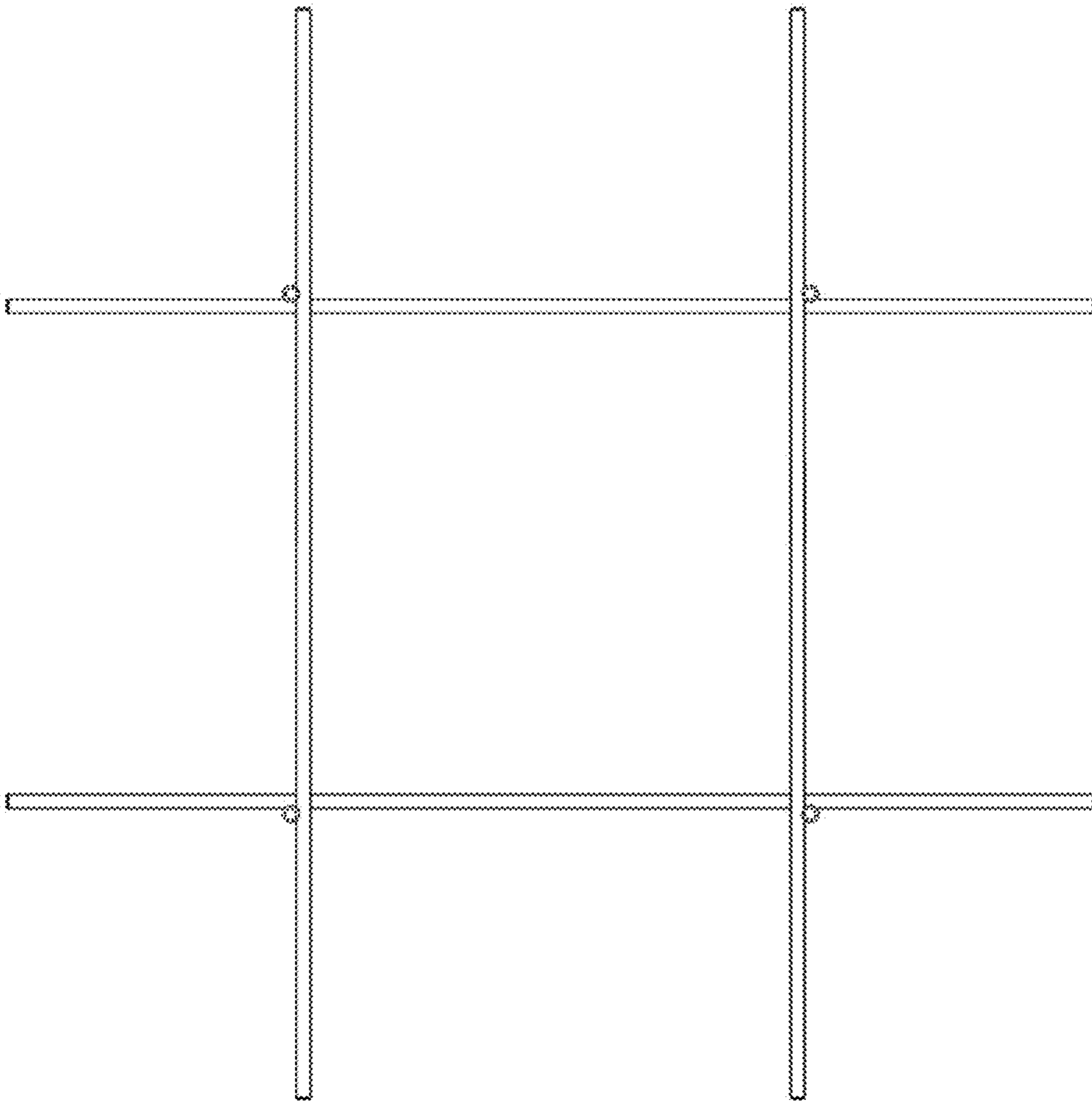
