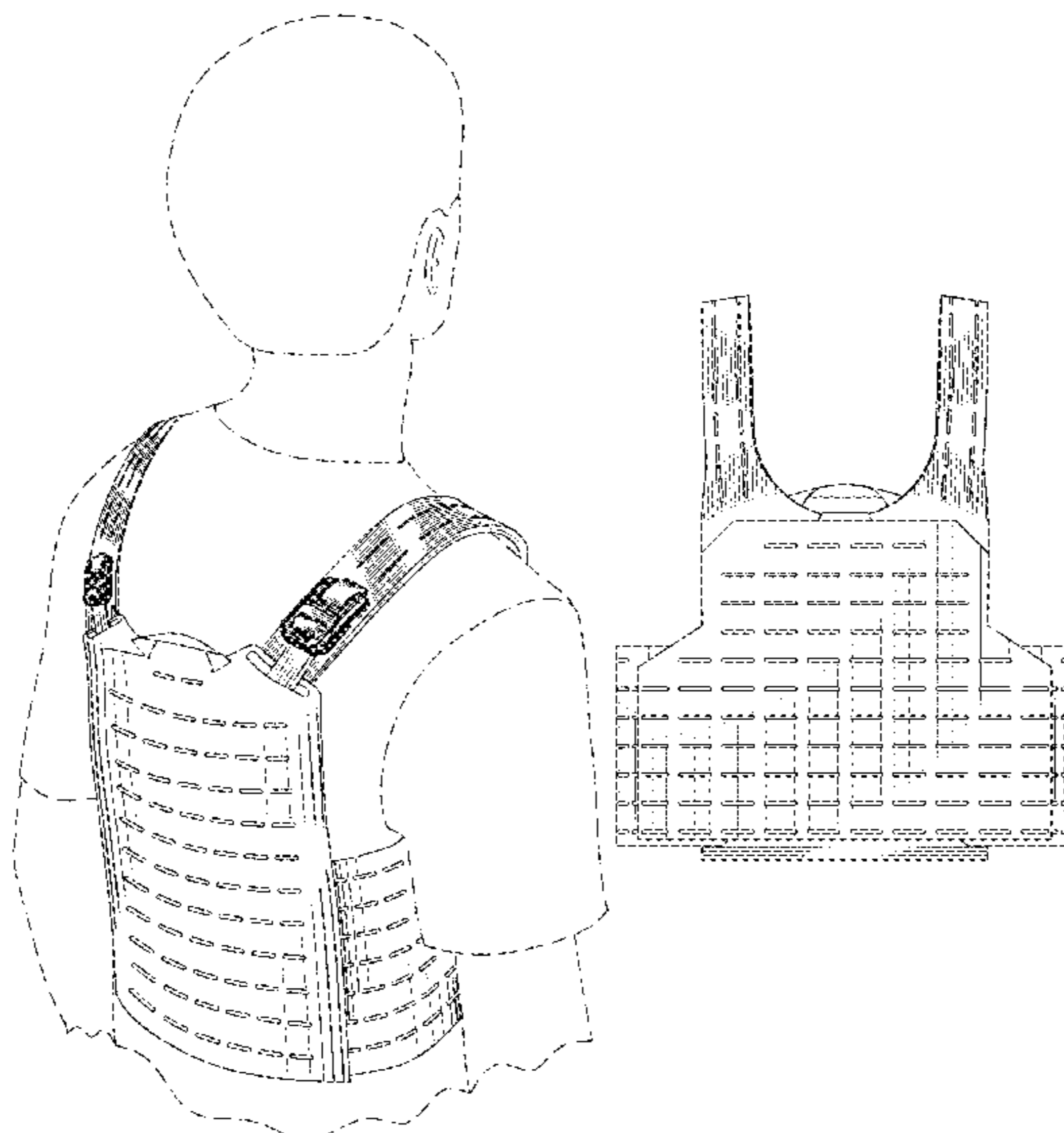
(57) **CLAIM**

The ornamental design for a ballistic carrier garment, as shown and described.

**DESCRIPTION**

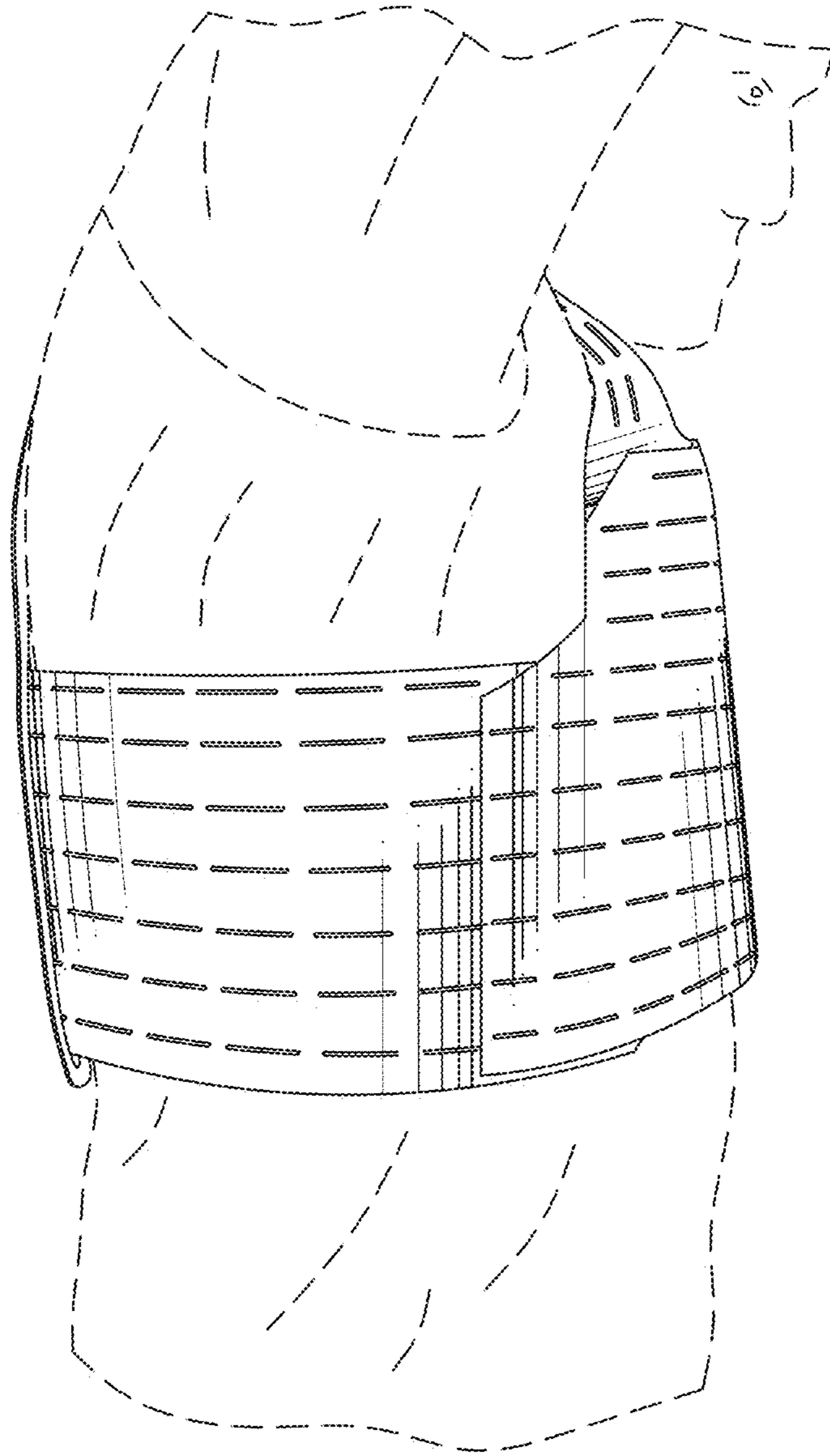

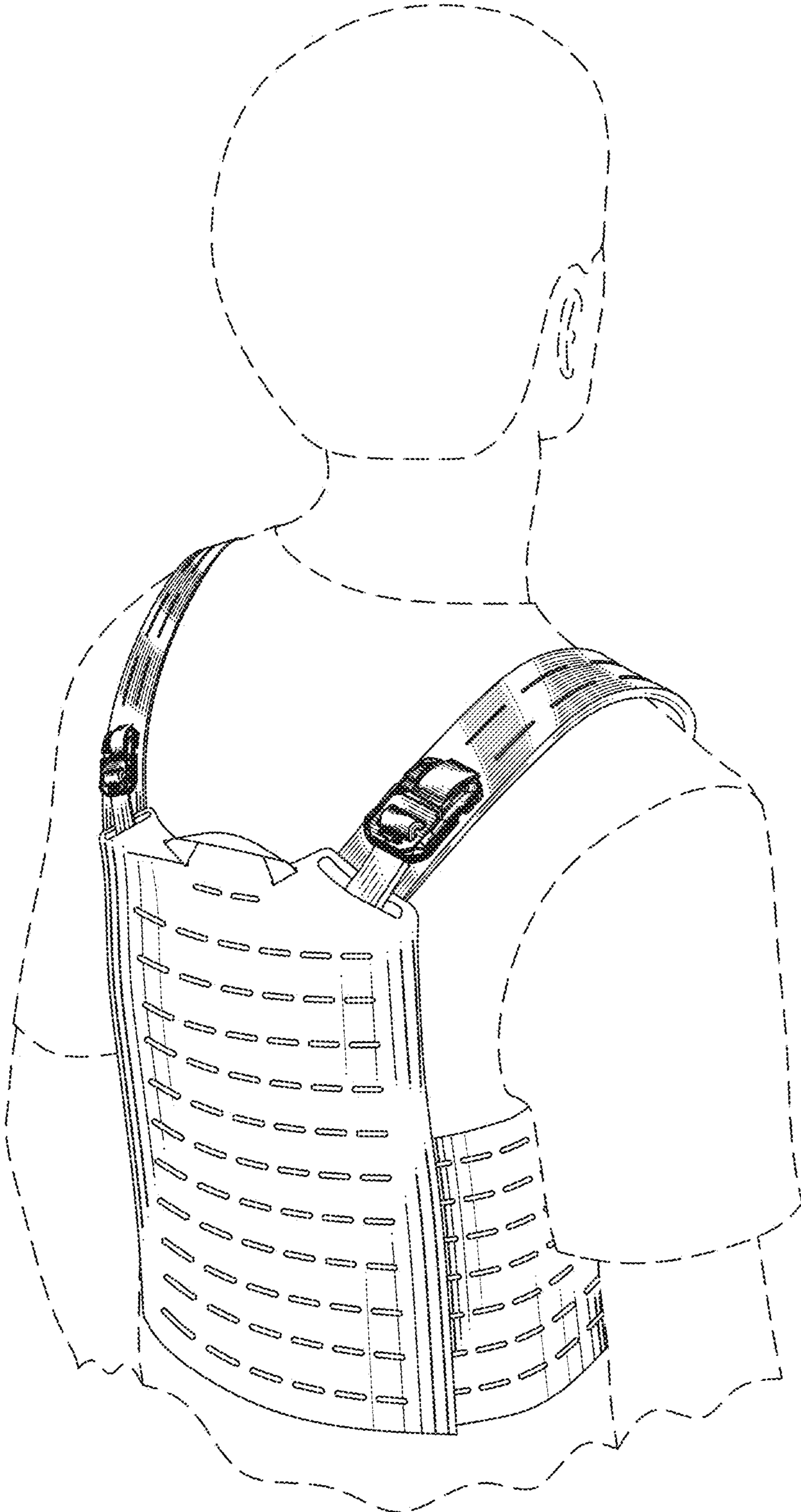

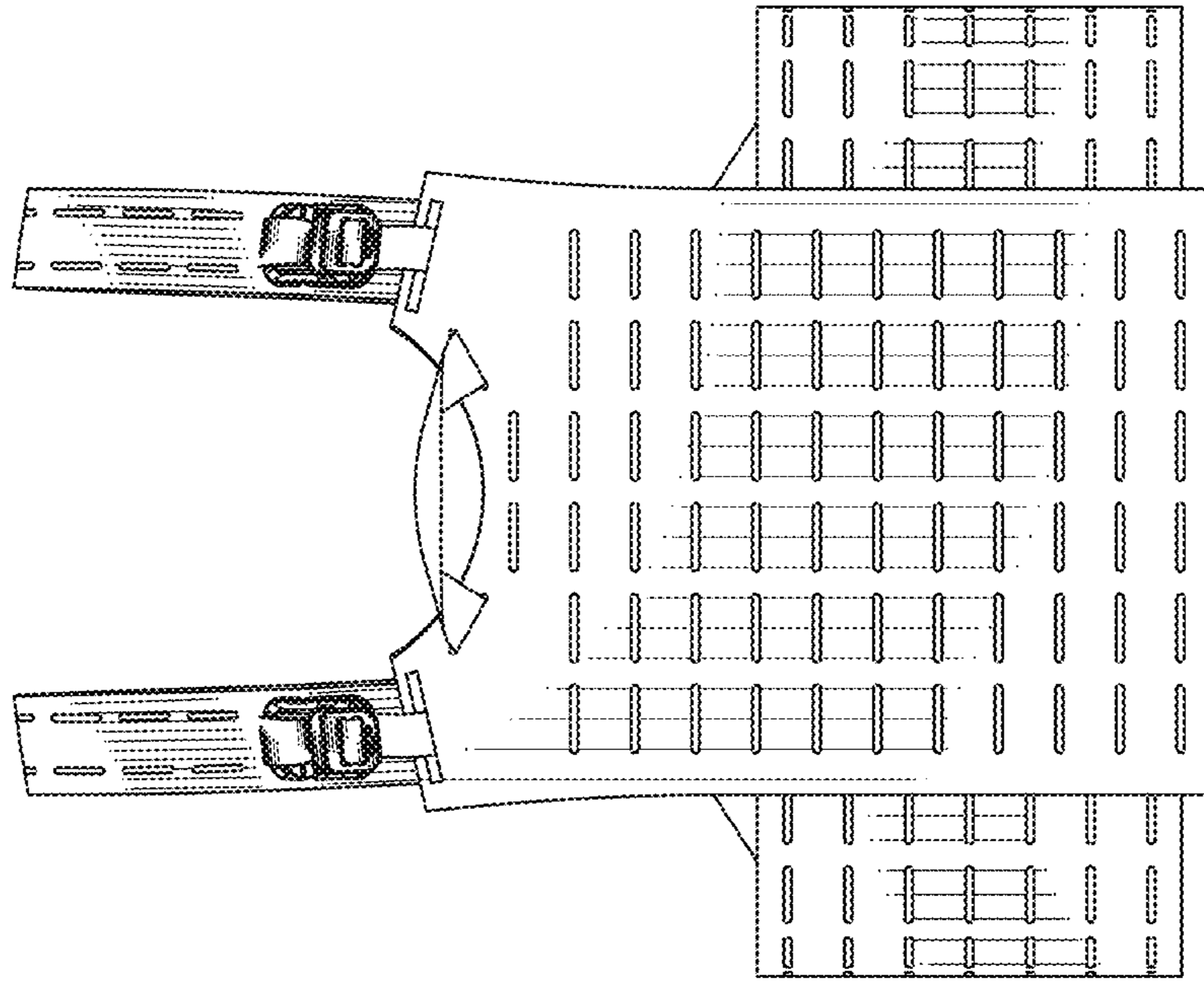

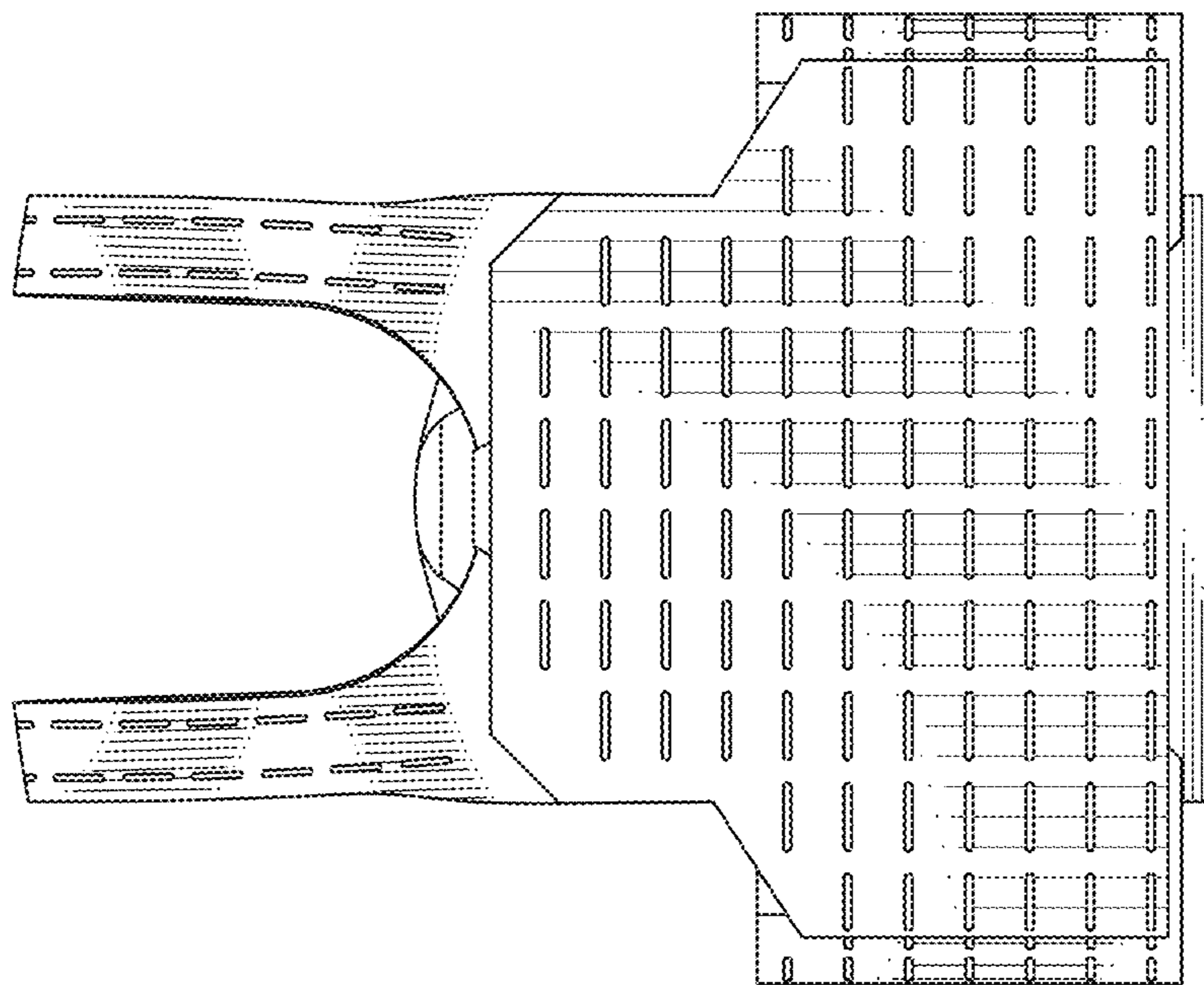

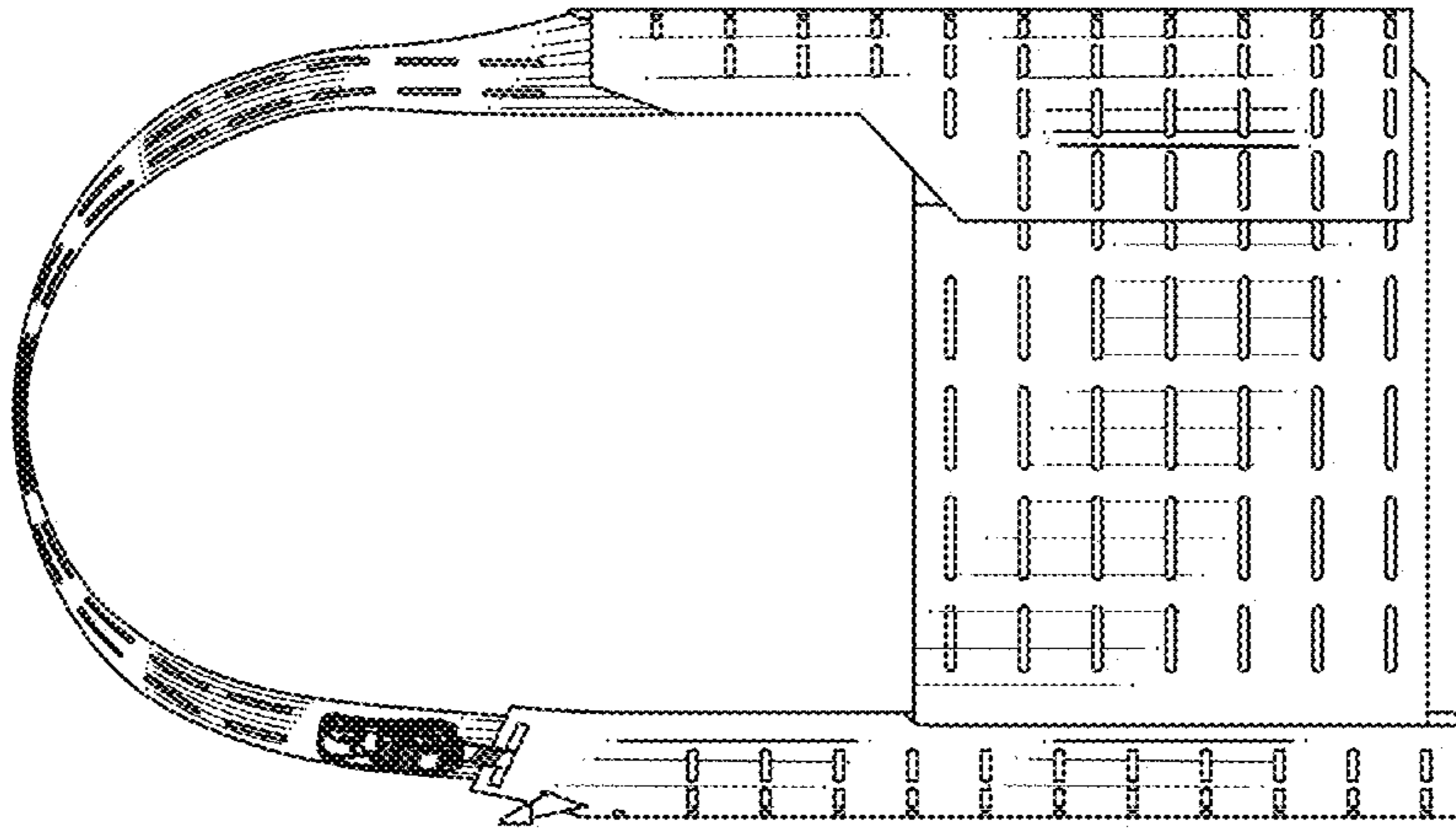

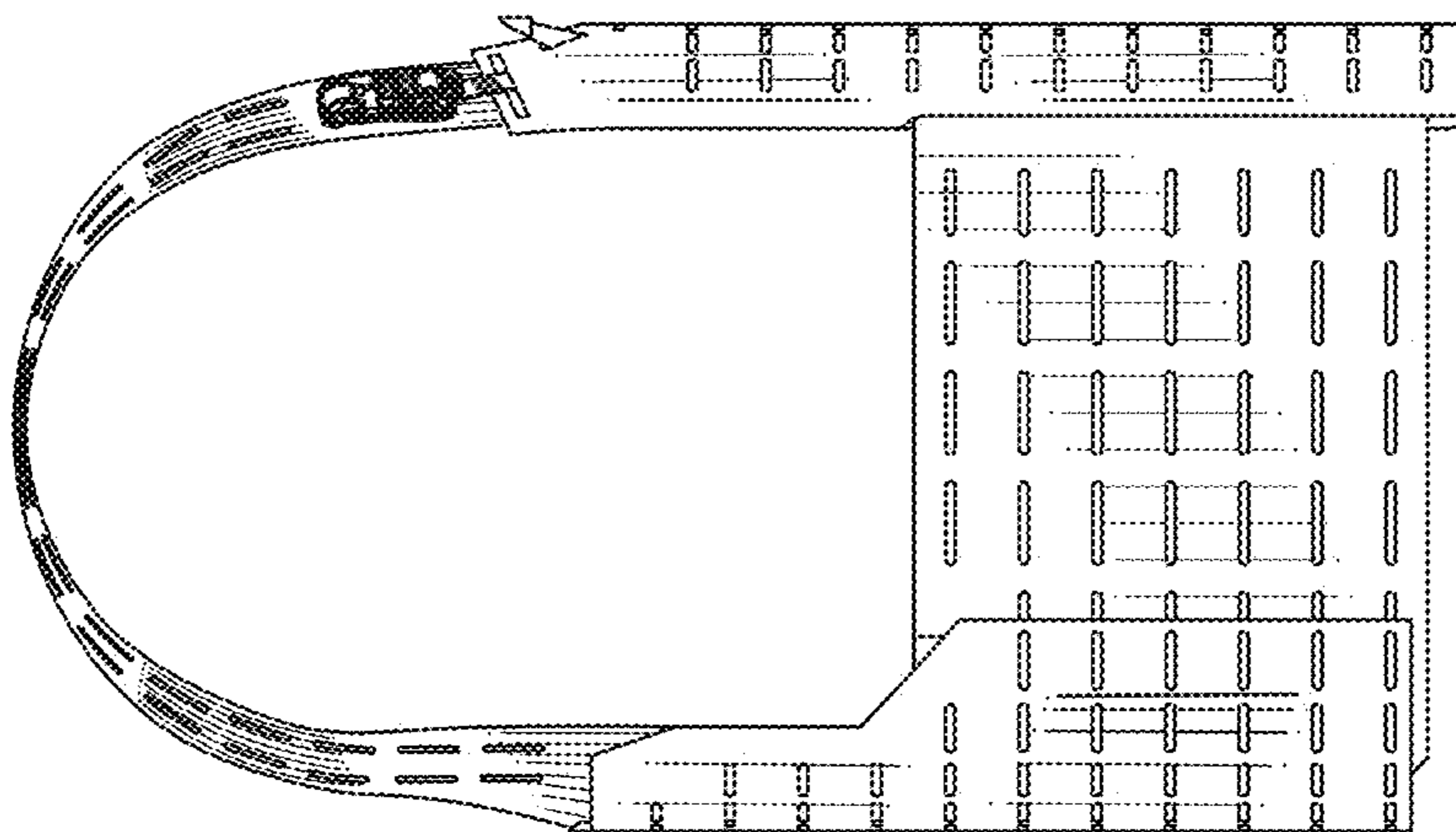

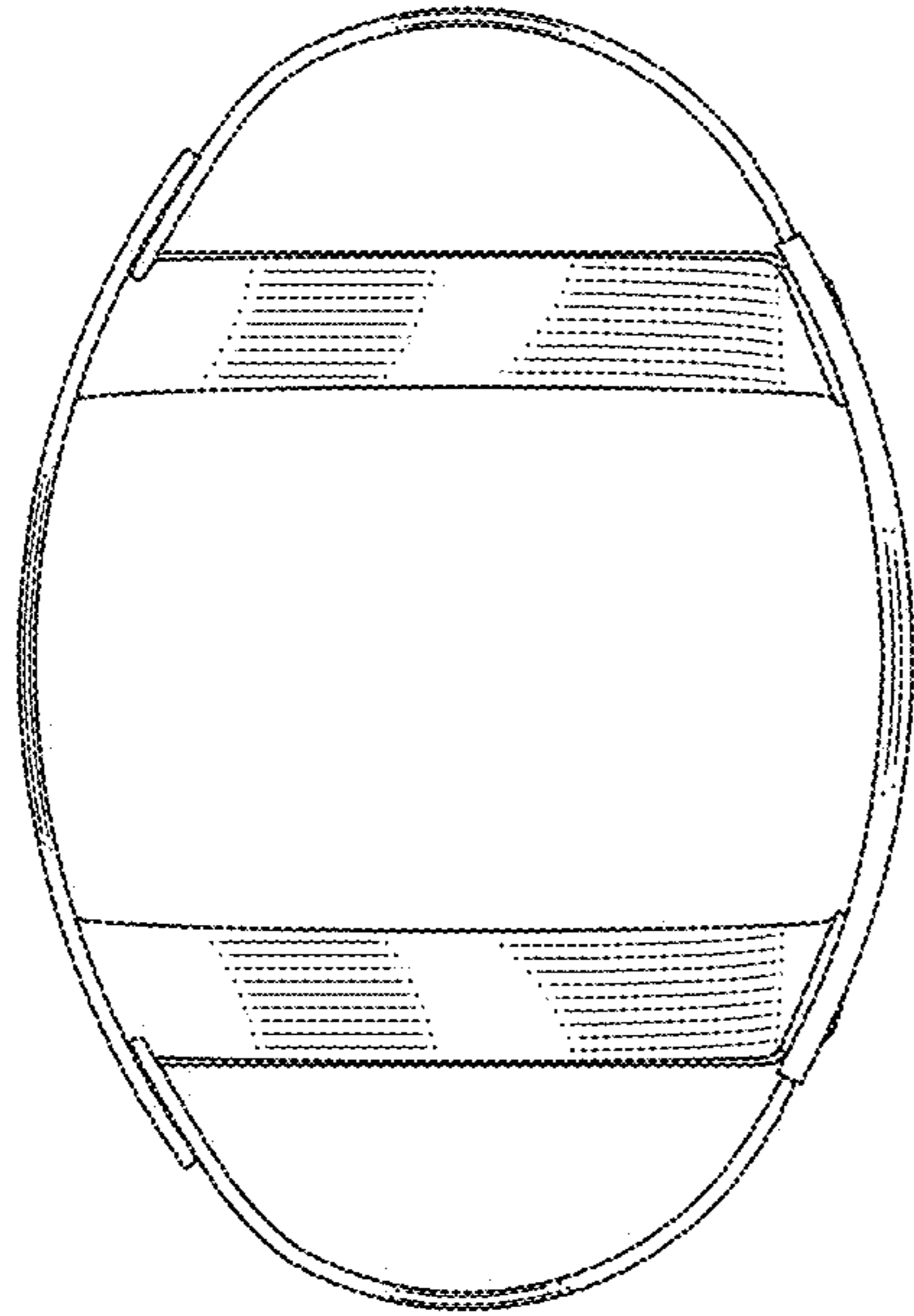

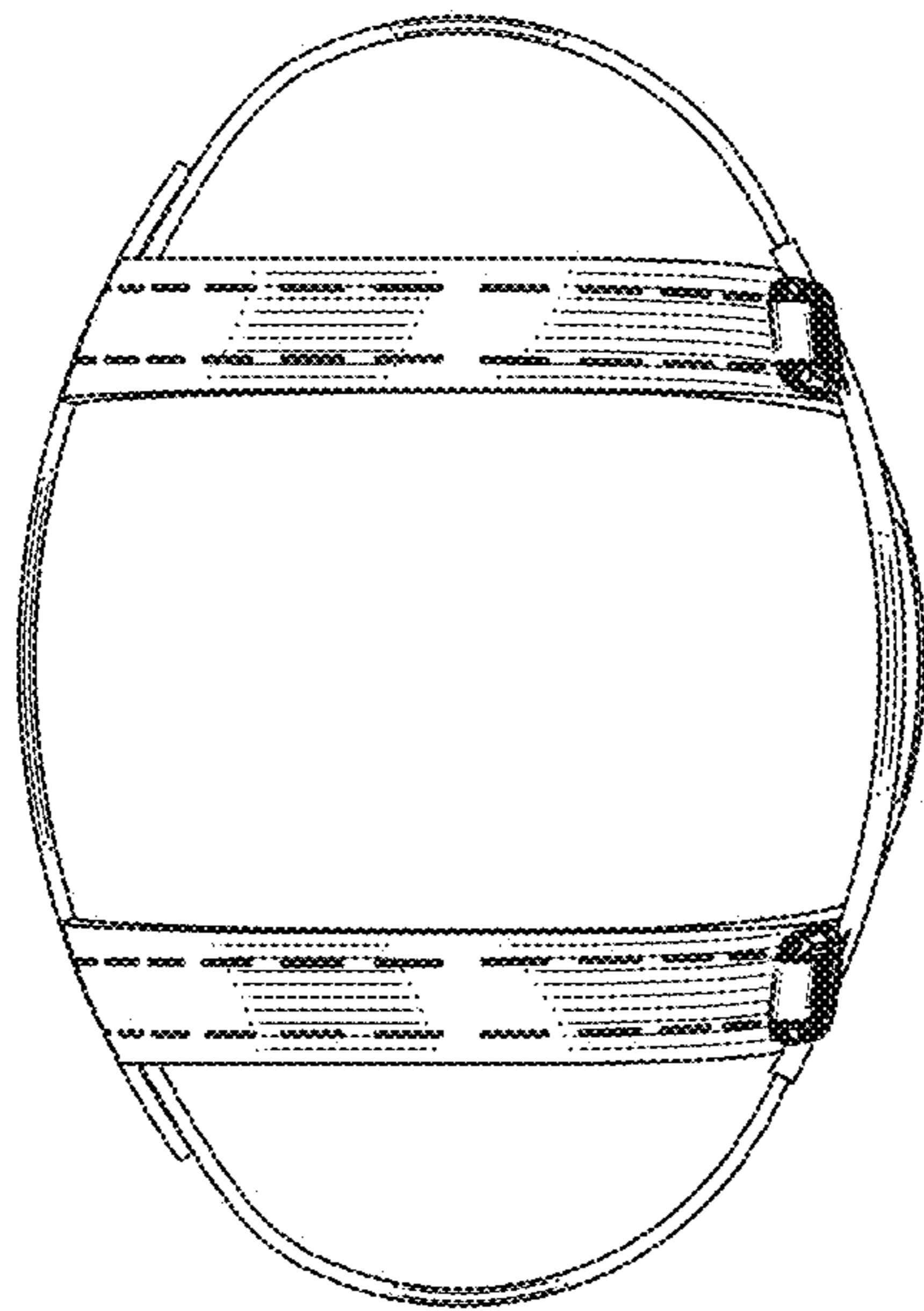
