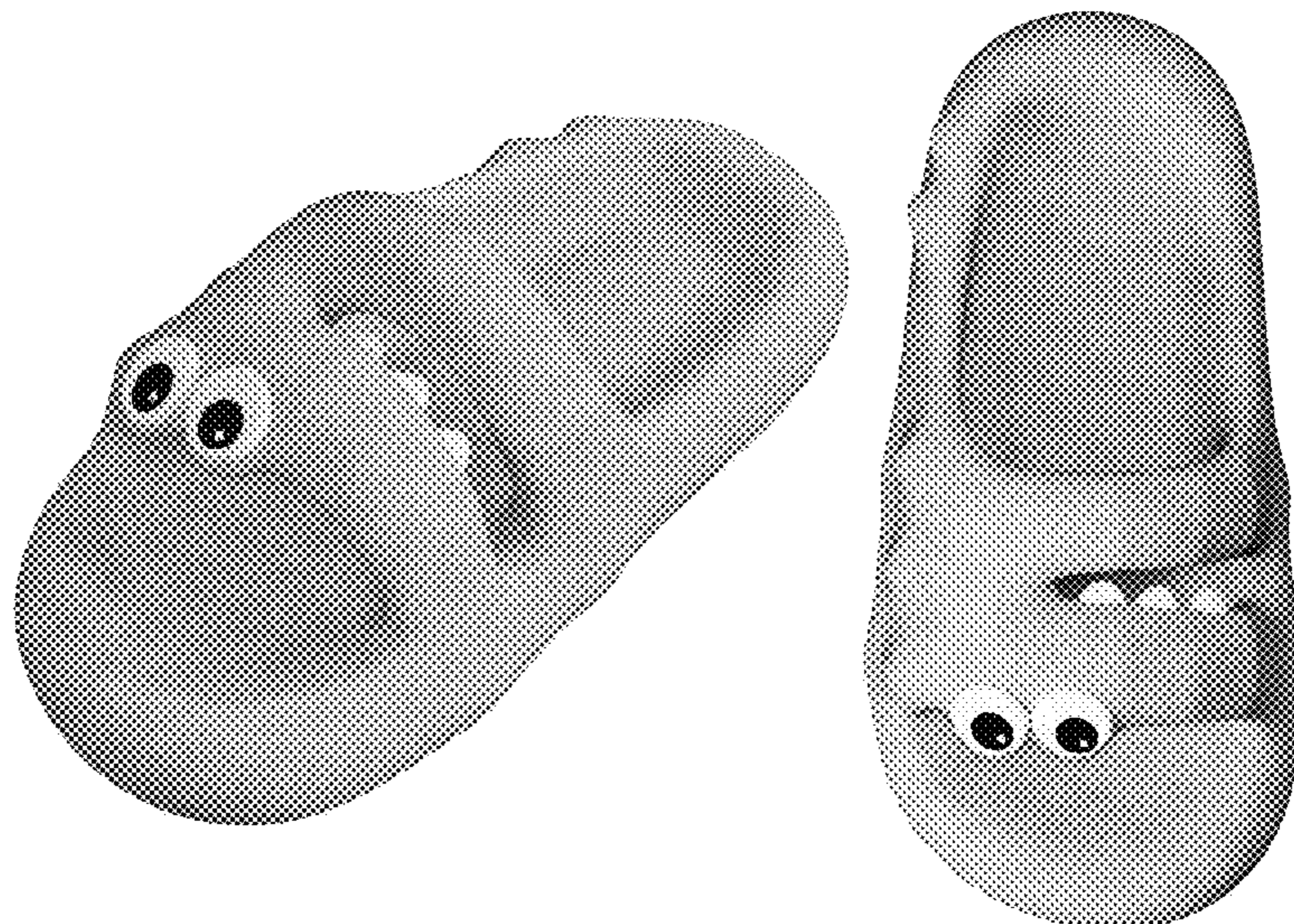
(57) **CLAIM**

The ornamental design for a slipper, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear, left and top perspective view of a slipper for a right foot, showing my design.  
FIG. 2 is a front, right and top perspective view thereof.  
FIG. 3 is a rear, right and top perspective view thereof.  
FIG. 4 is a front, left and top perspective view thereof.  
FIG. 5 is a front elevation view thereof.  
FIG. 6 is a rear elevation view thereof.  
FIG. 7 is a left side elevation view thereof.  
FIG. 8 is a right side elevation view thereof.  
FIG. 9 is a top plan view thereof; and,  
FIG. 10 is a bottom plan view thereof.  
A slipper for a left foot is a mirror image of the slipper for the right foot as shown in FIGS. 1 to 10.

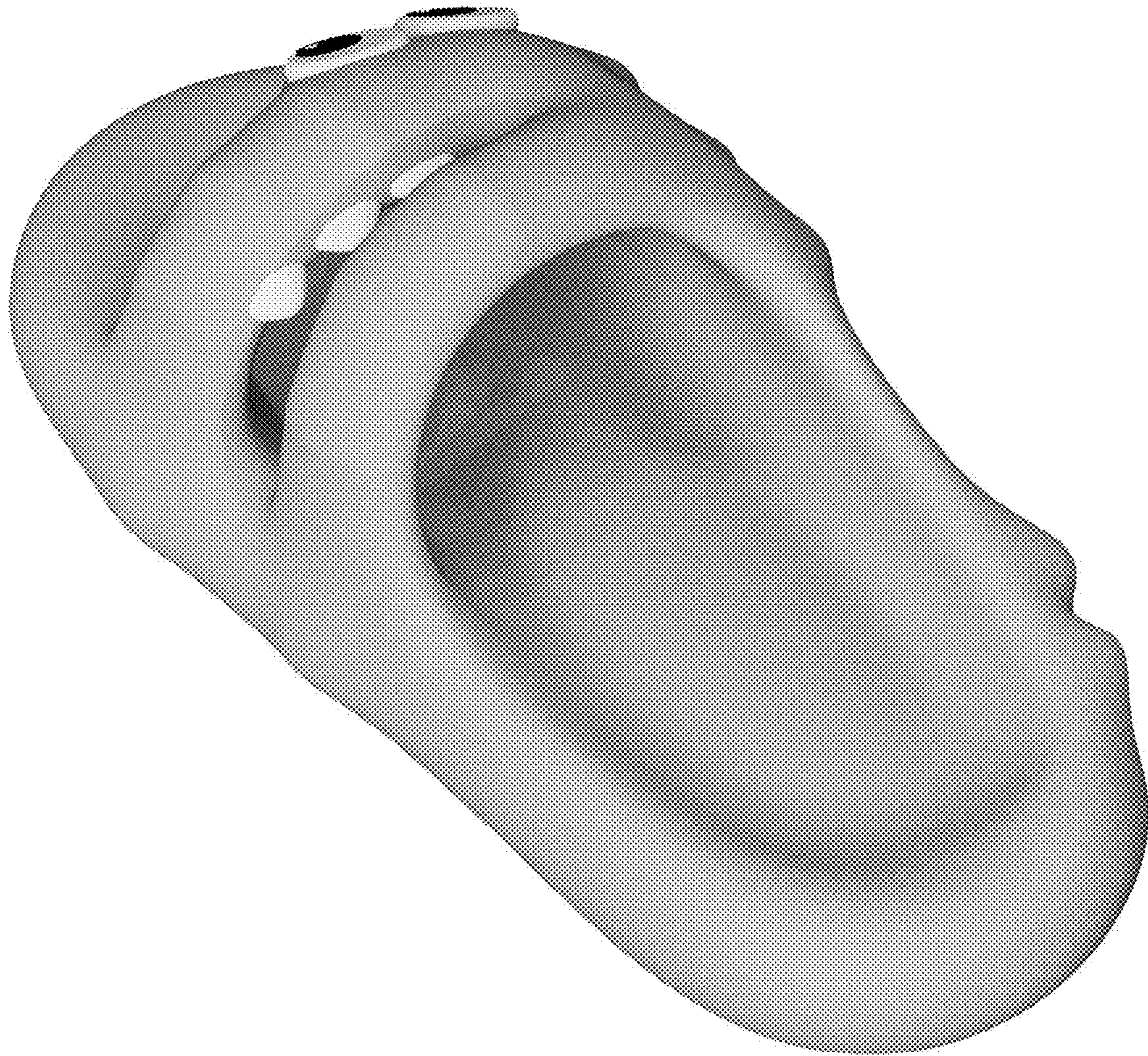

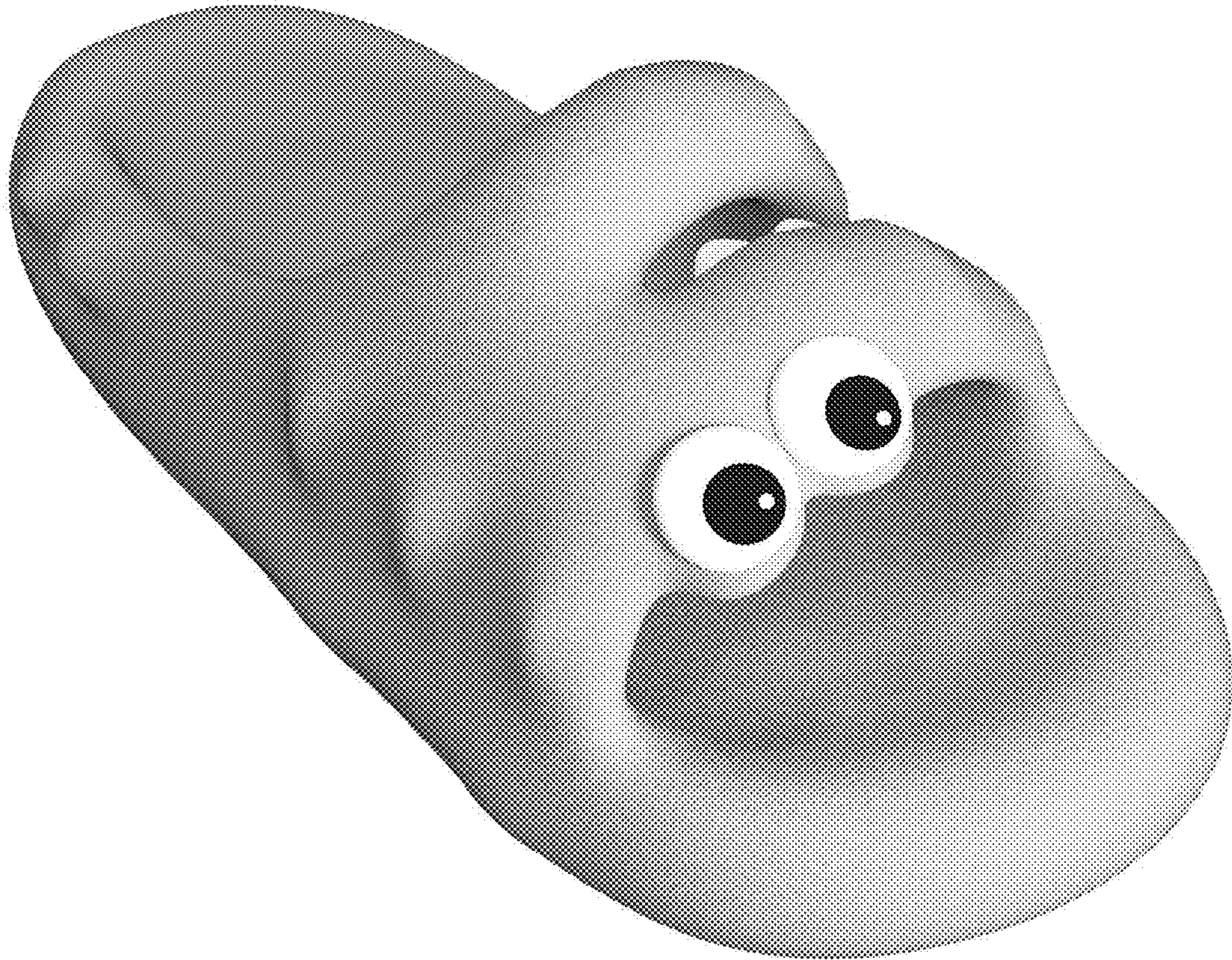

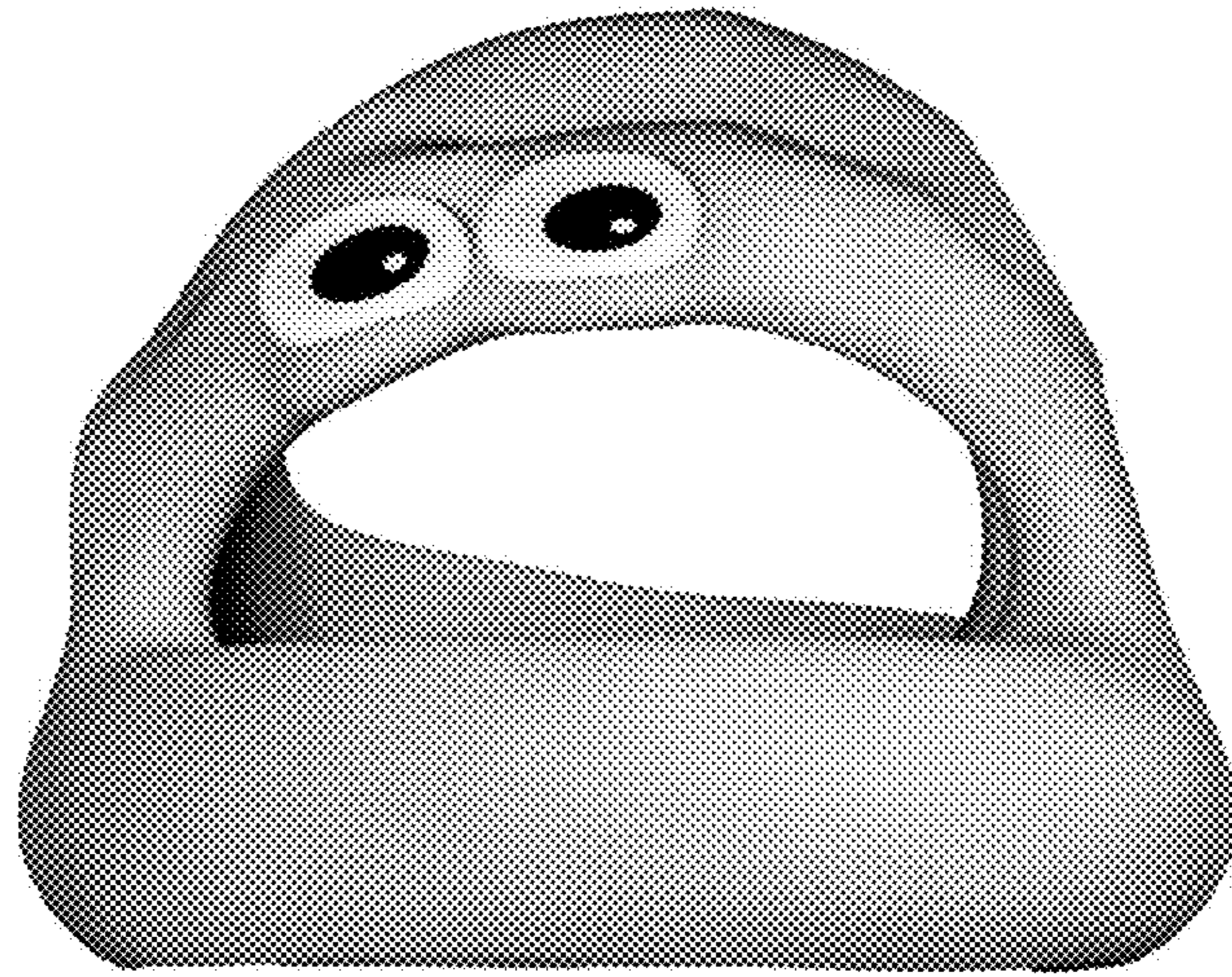

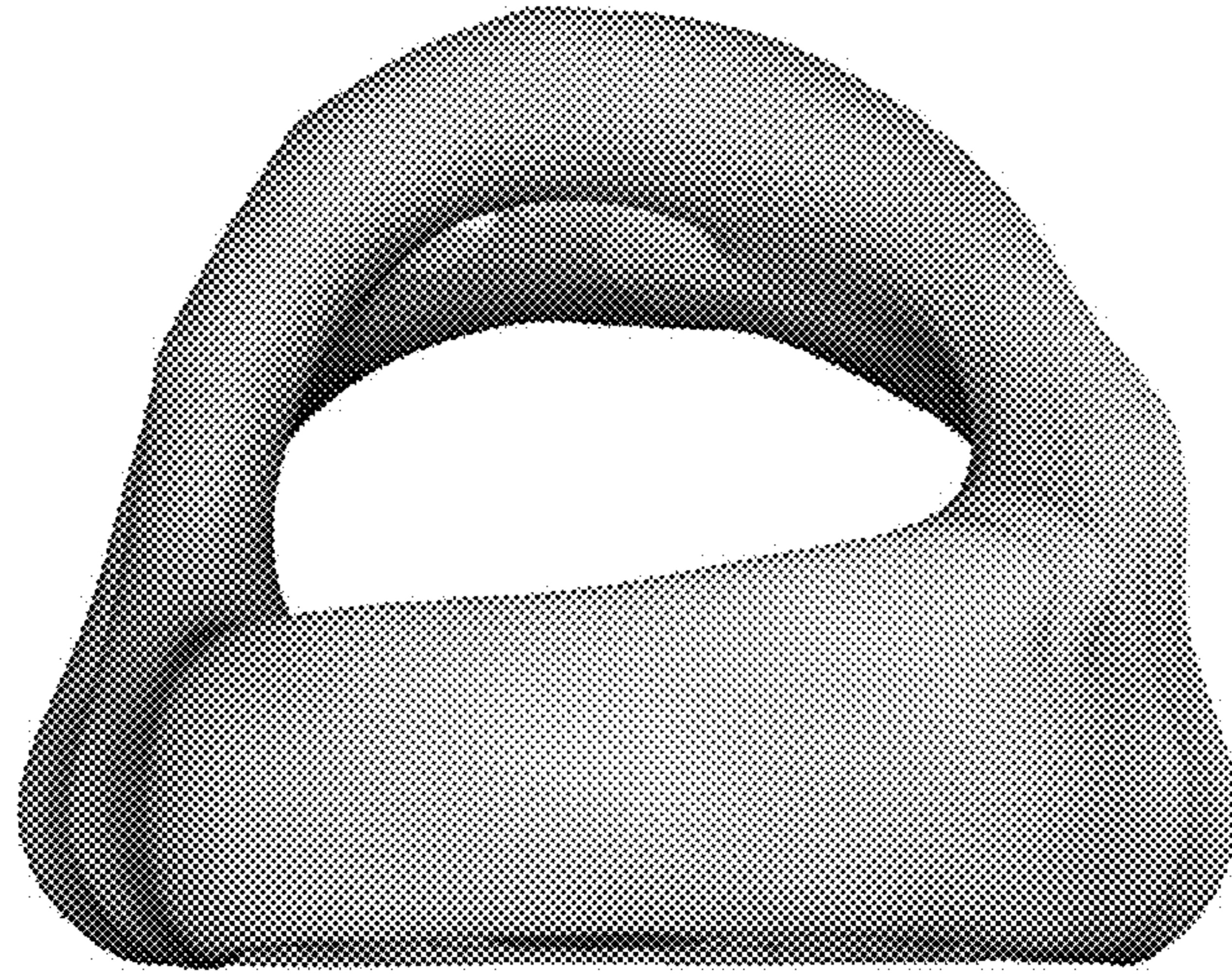

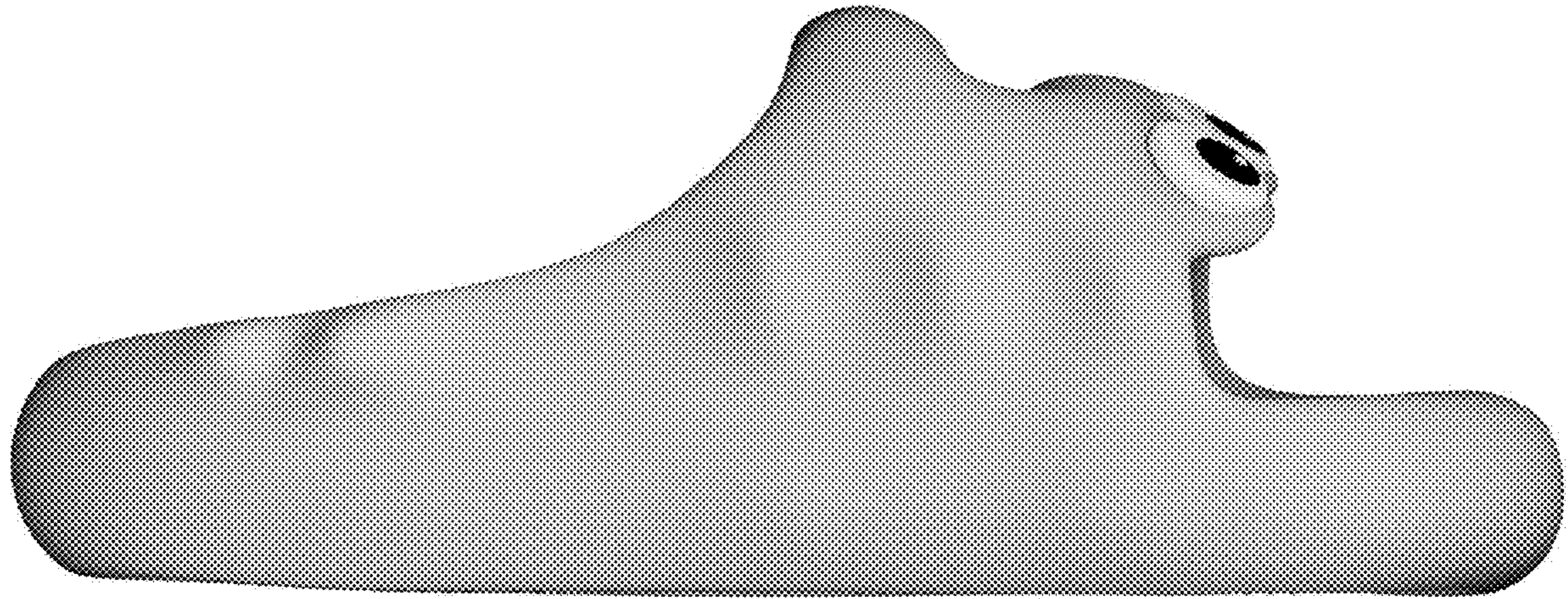

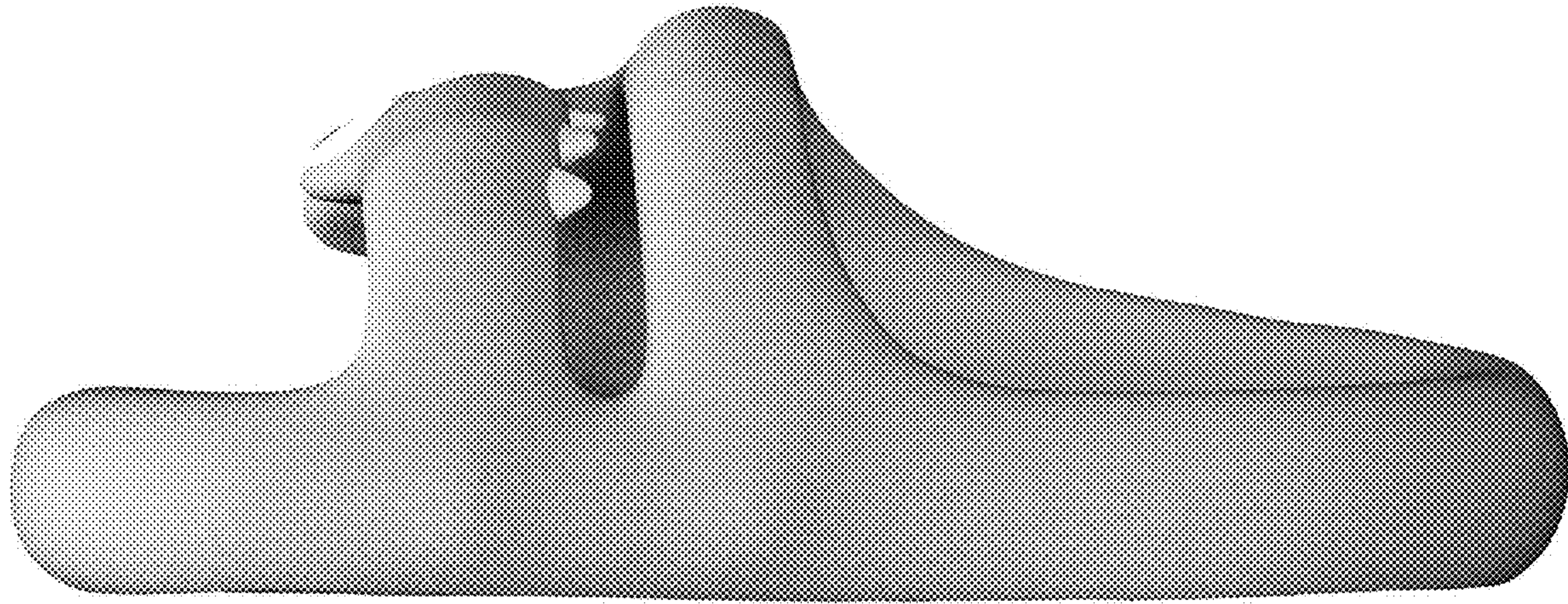

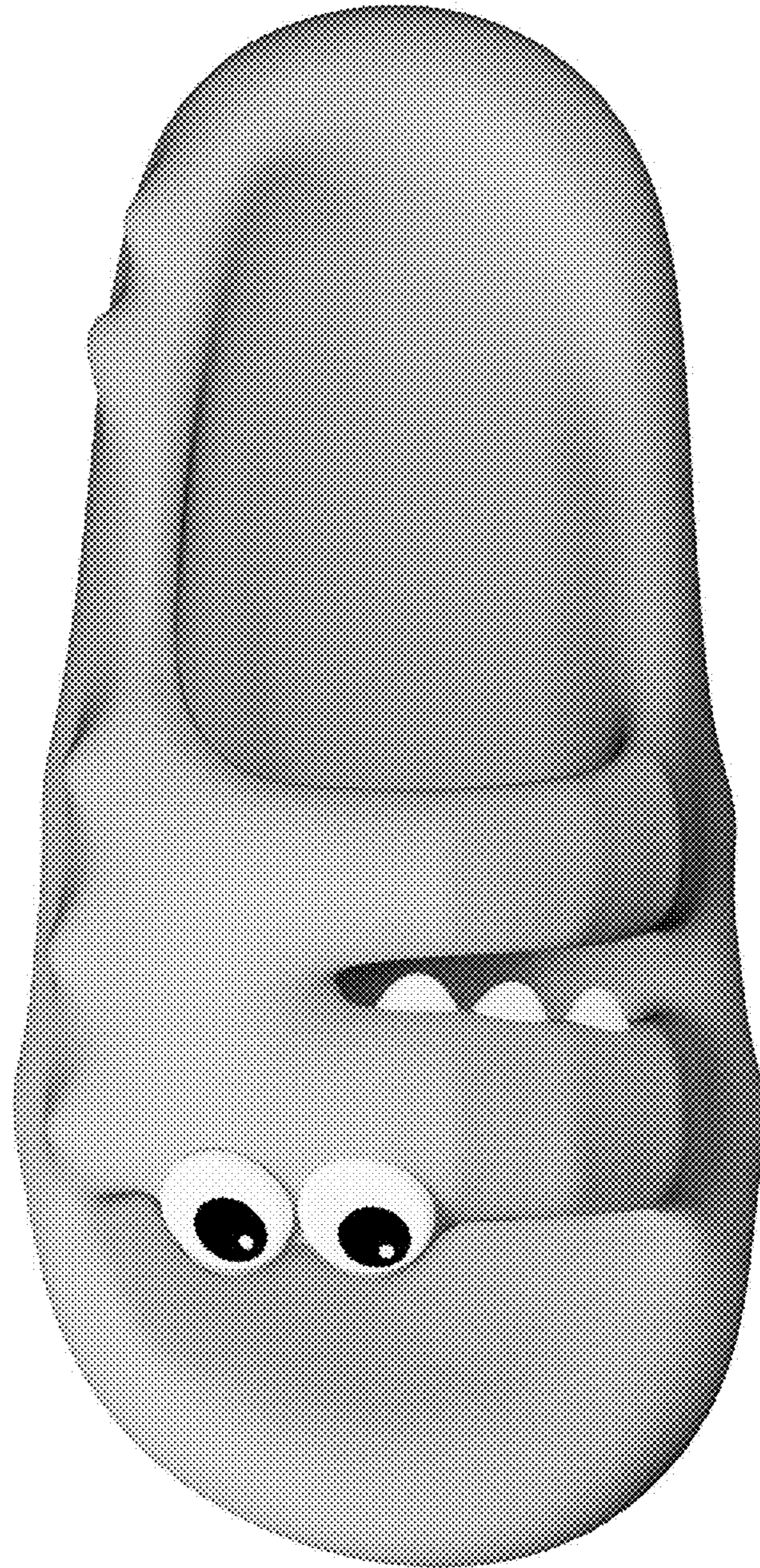

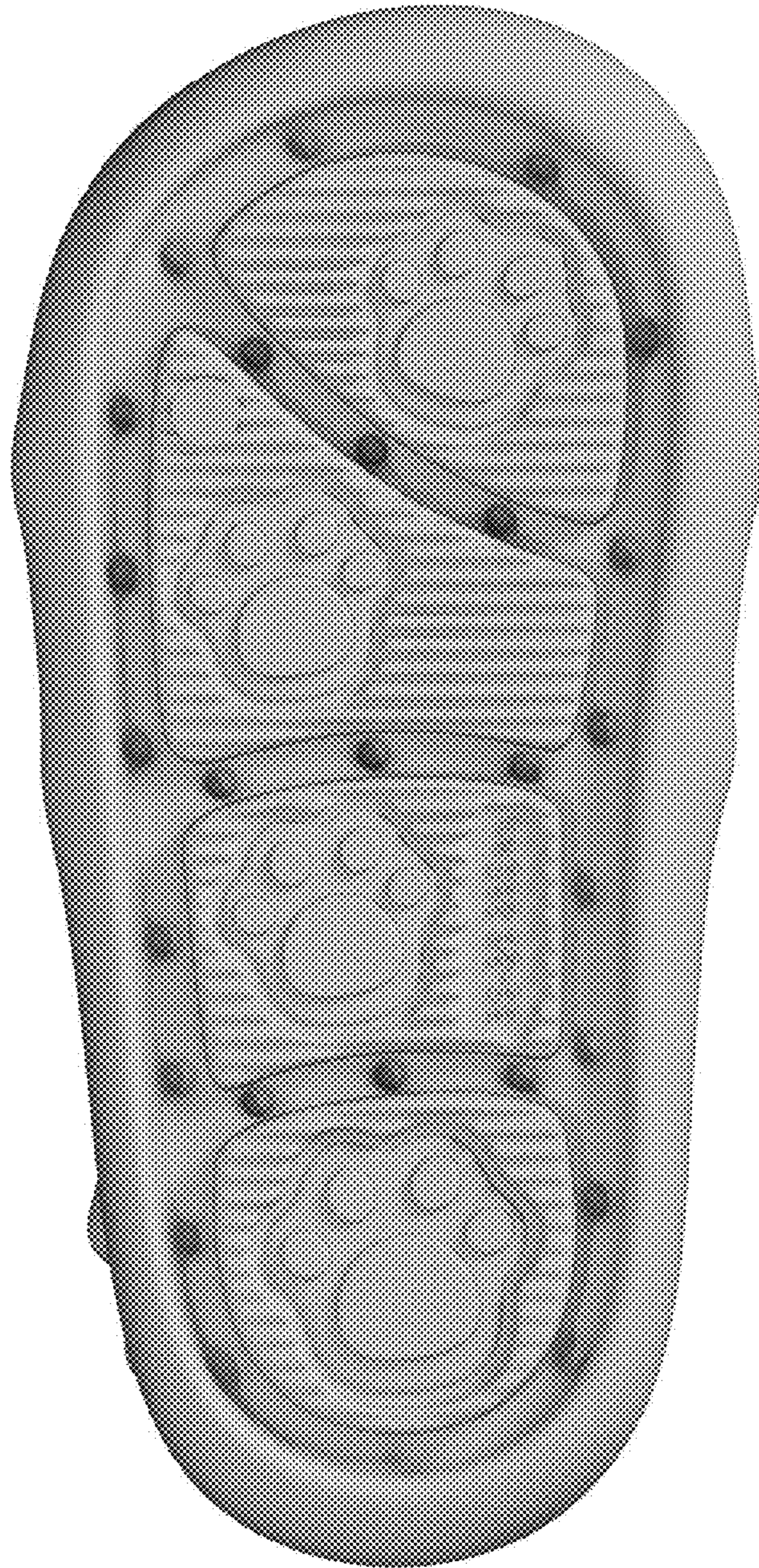
