(57) **CLAIM**

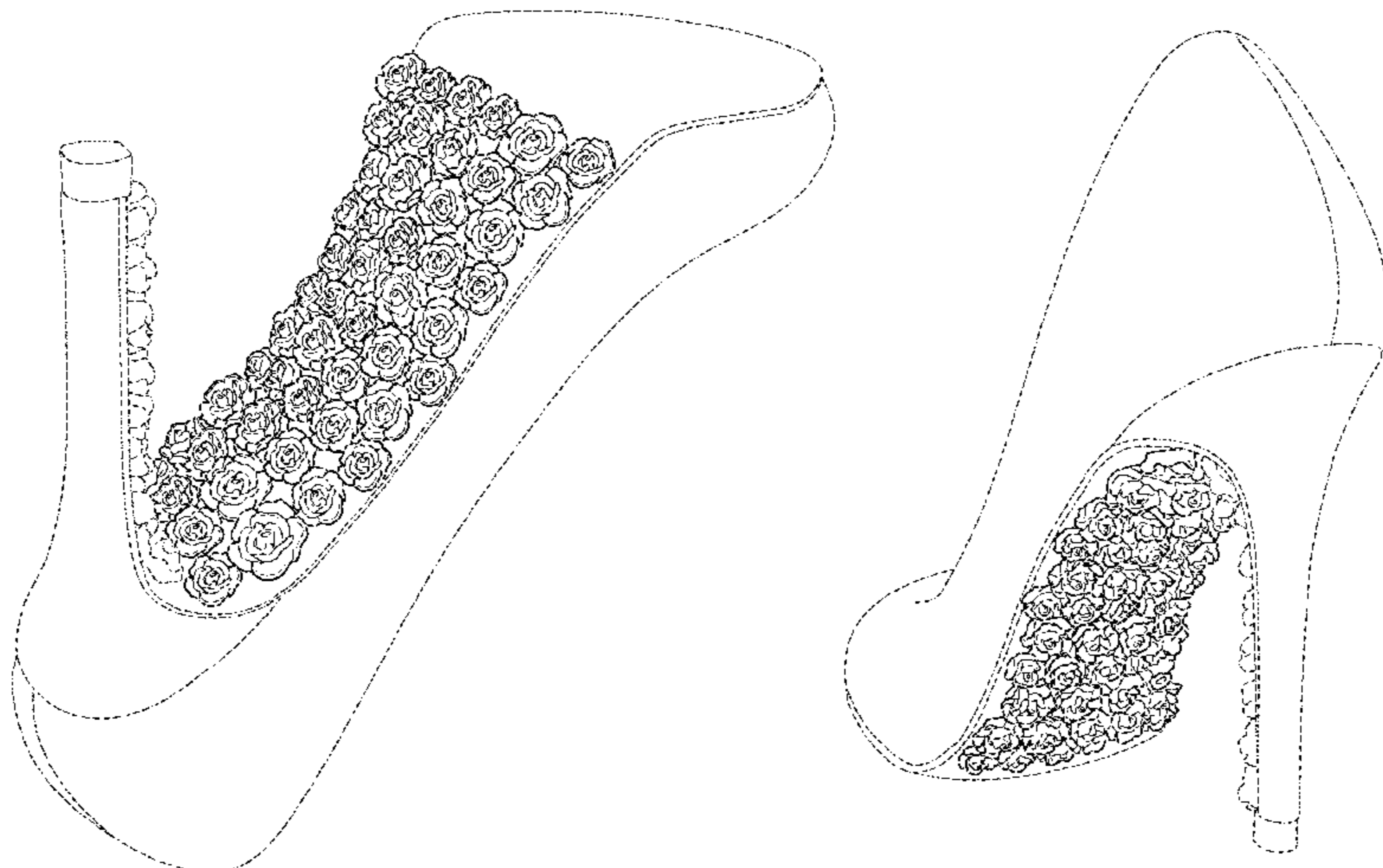
The ornamental design for a shoe sole with flower design, as shown and described.

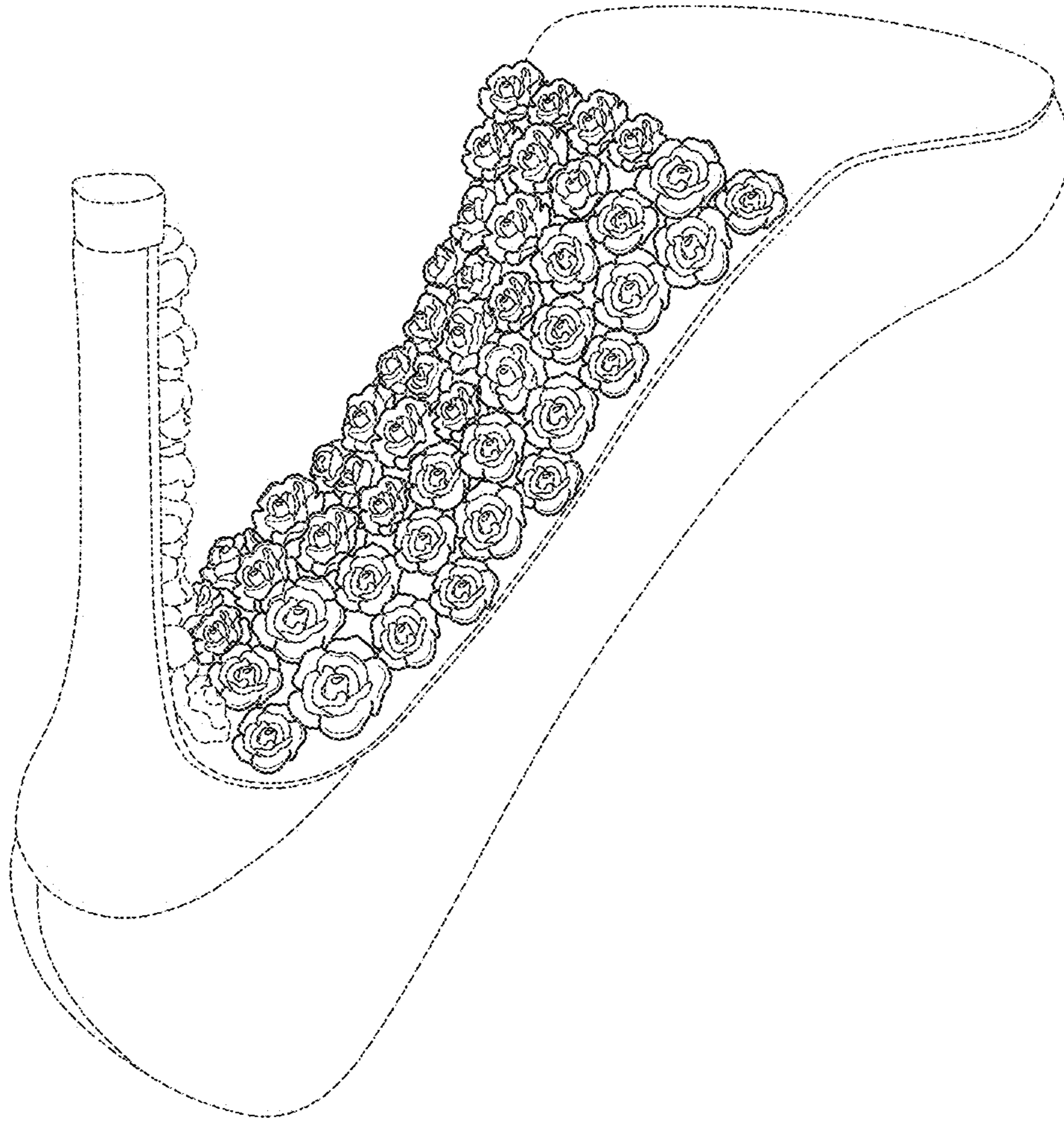

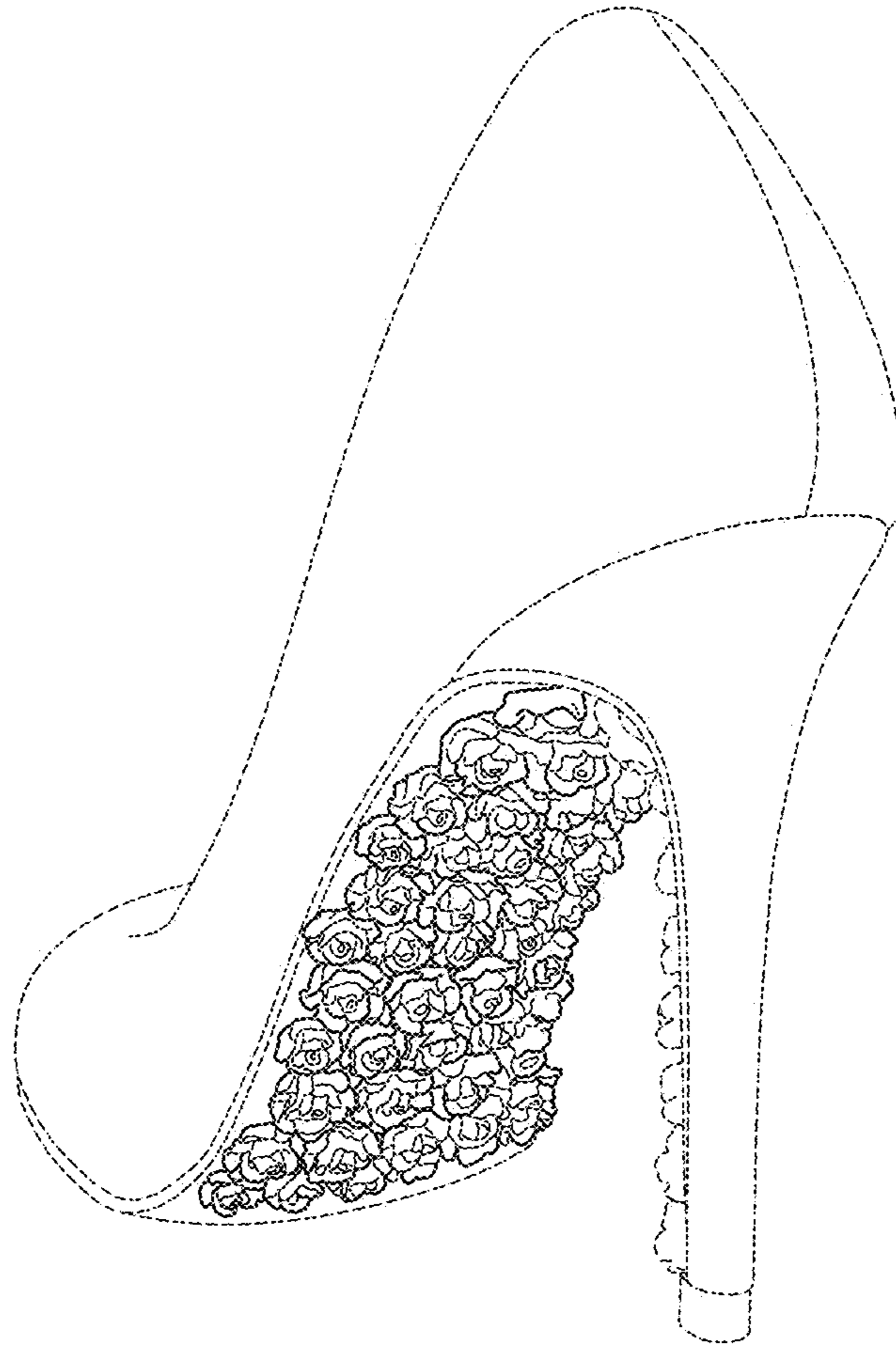

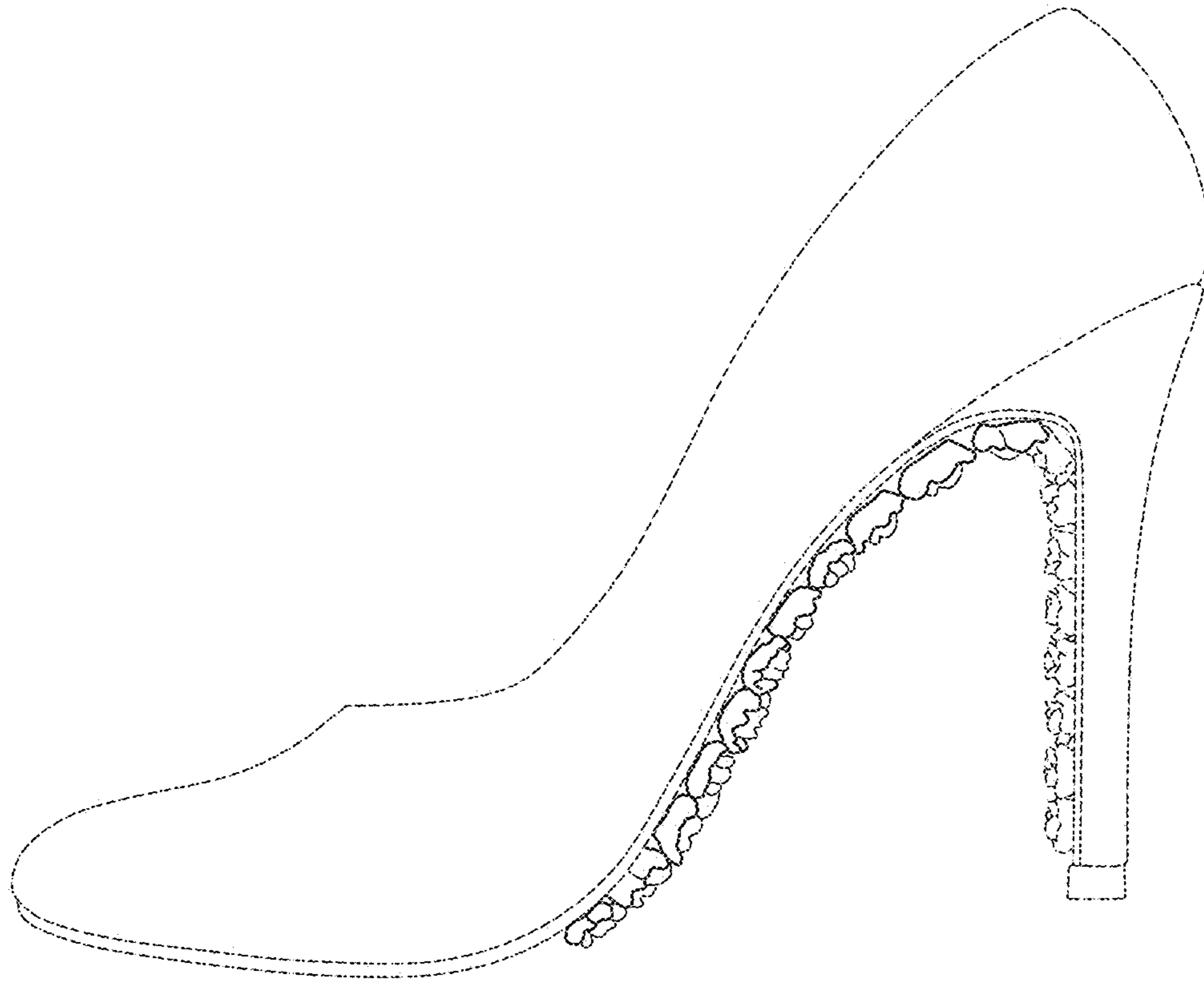

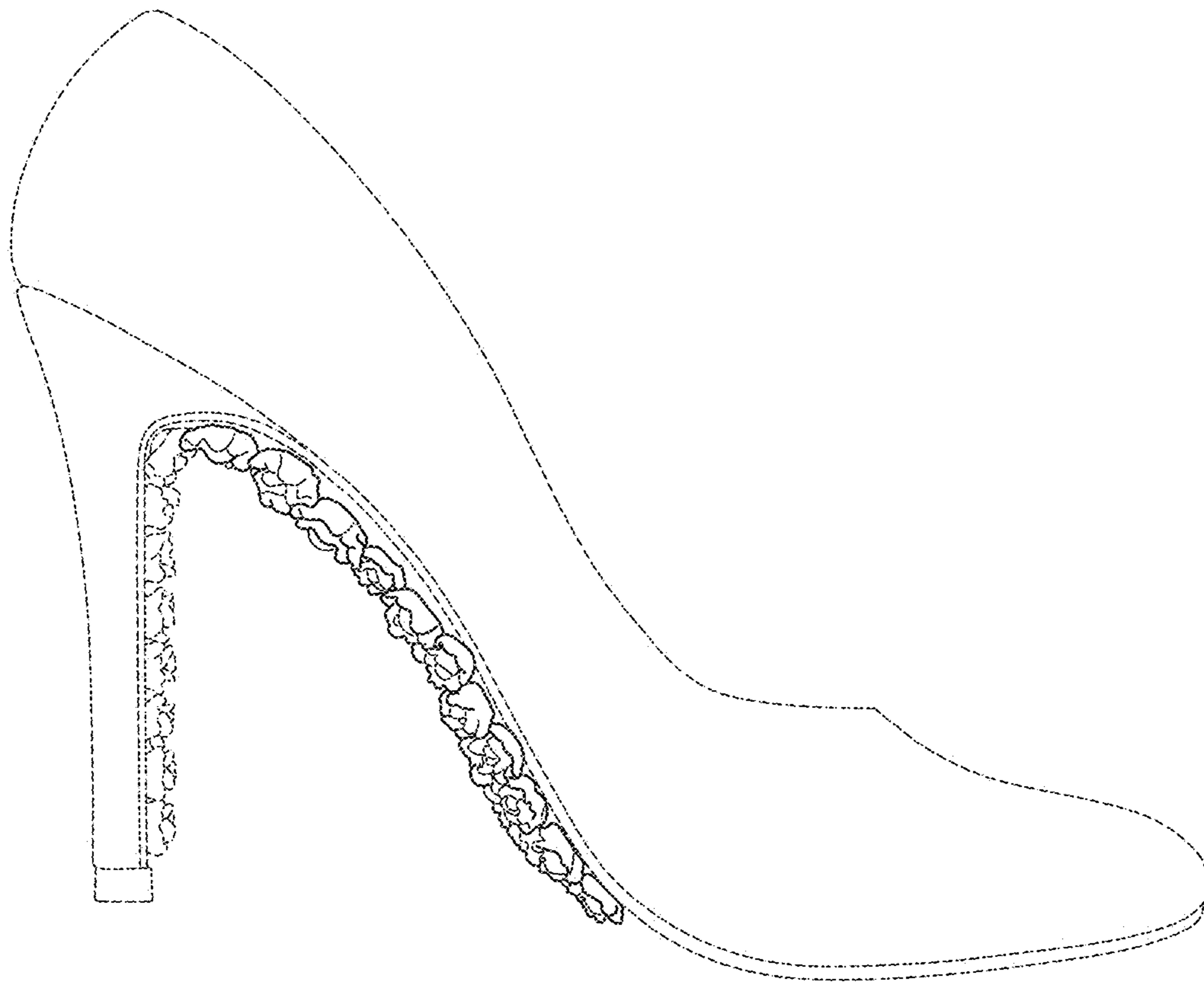

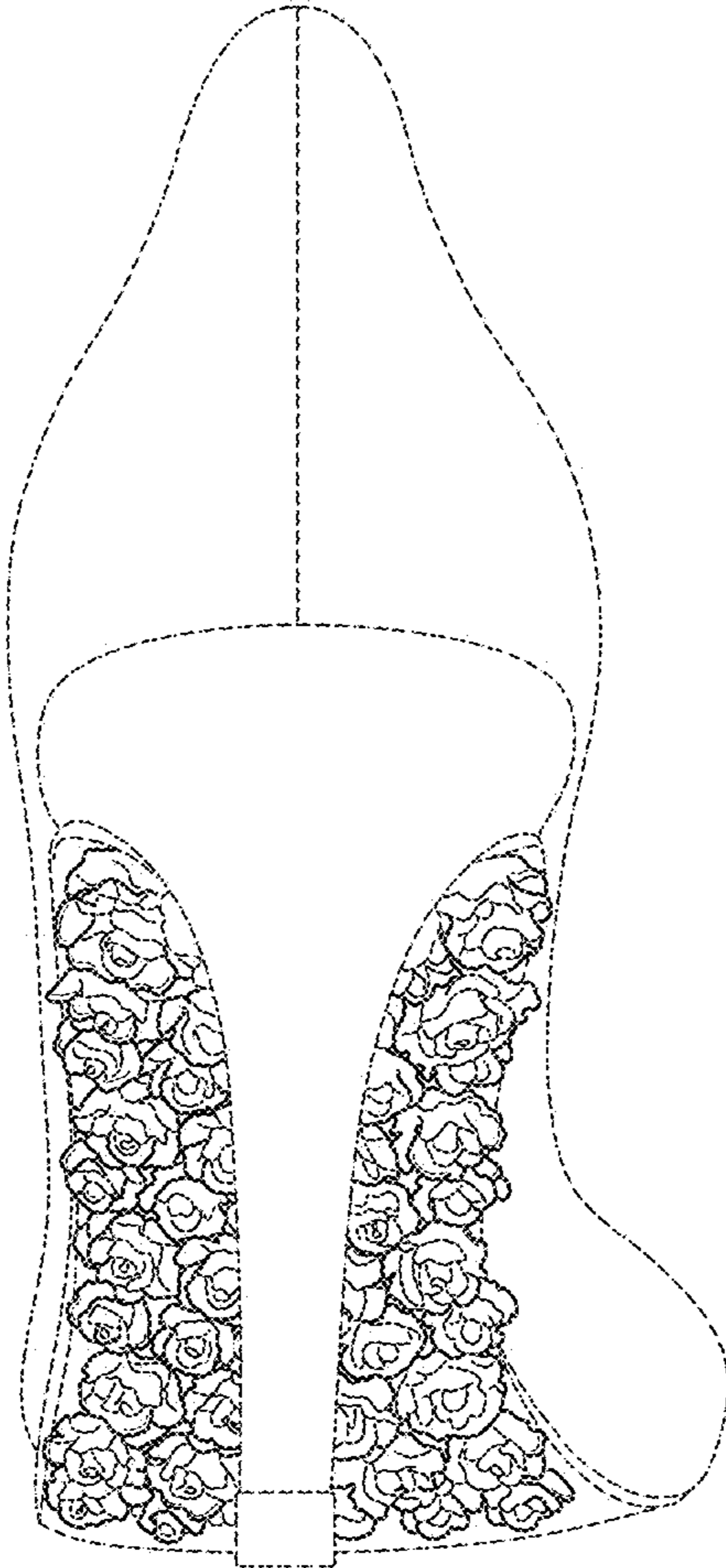

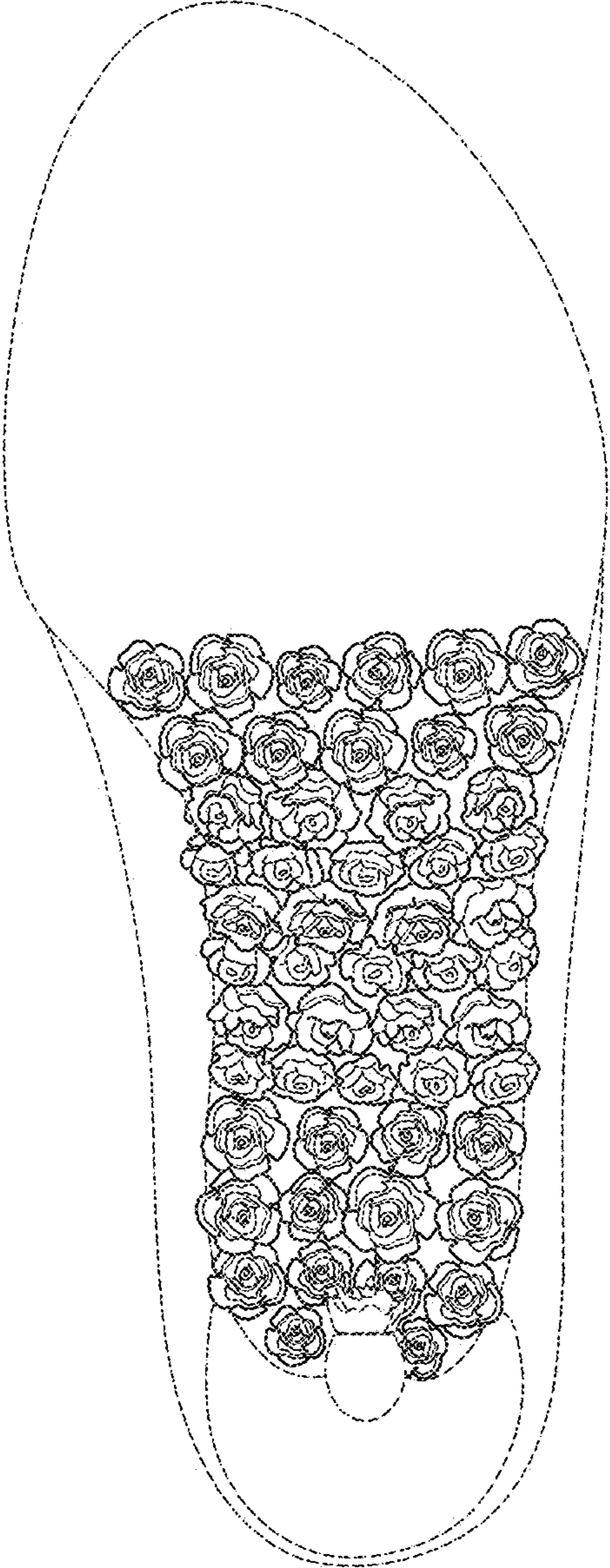

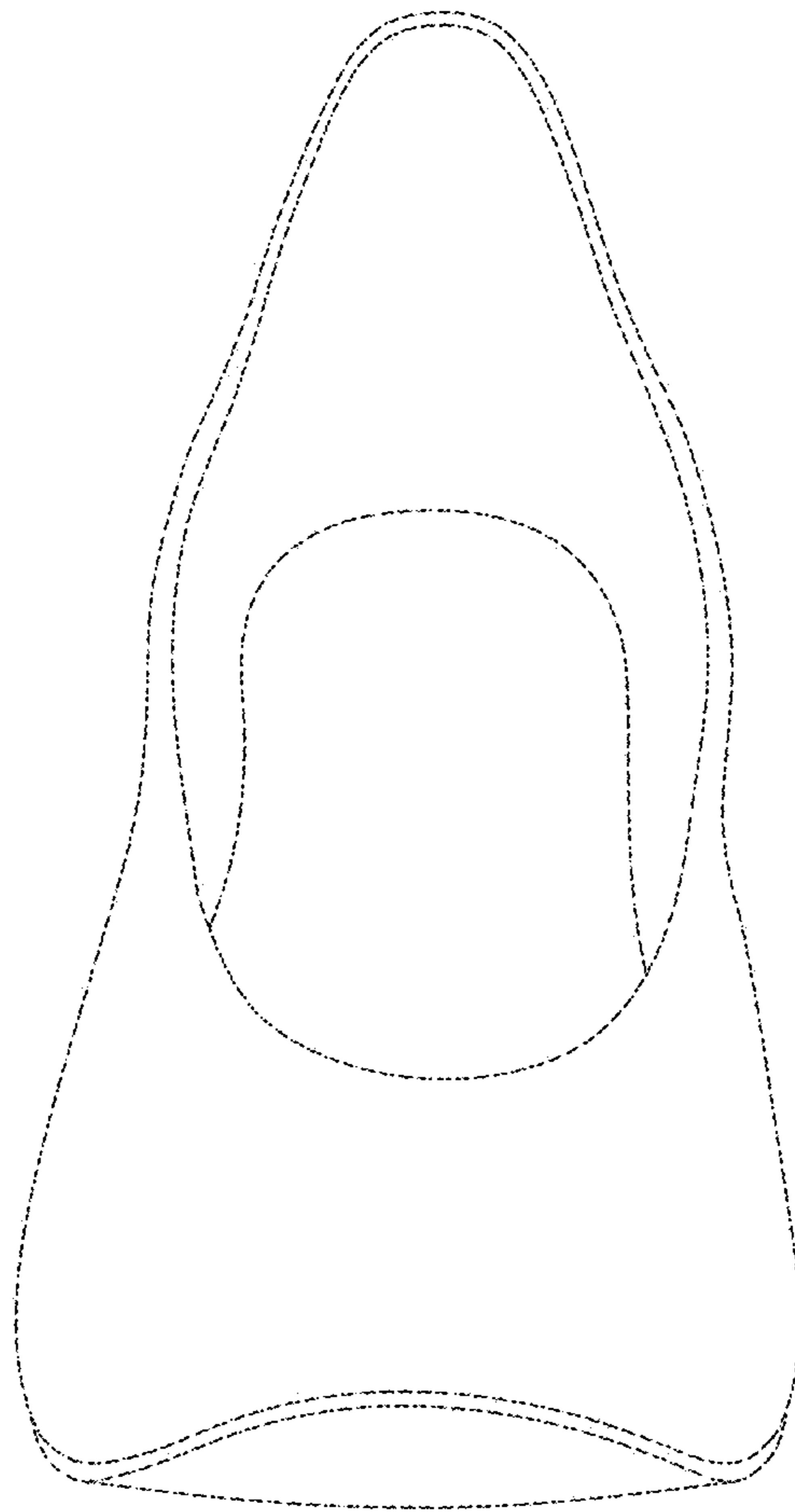

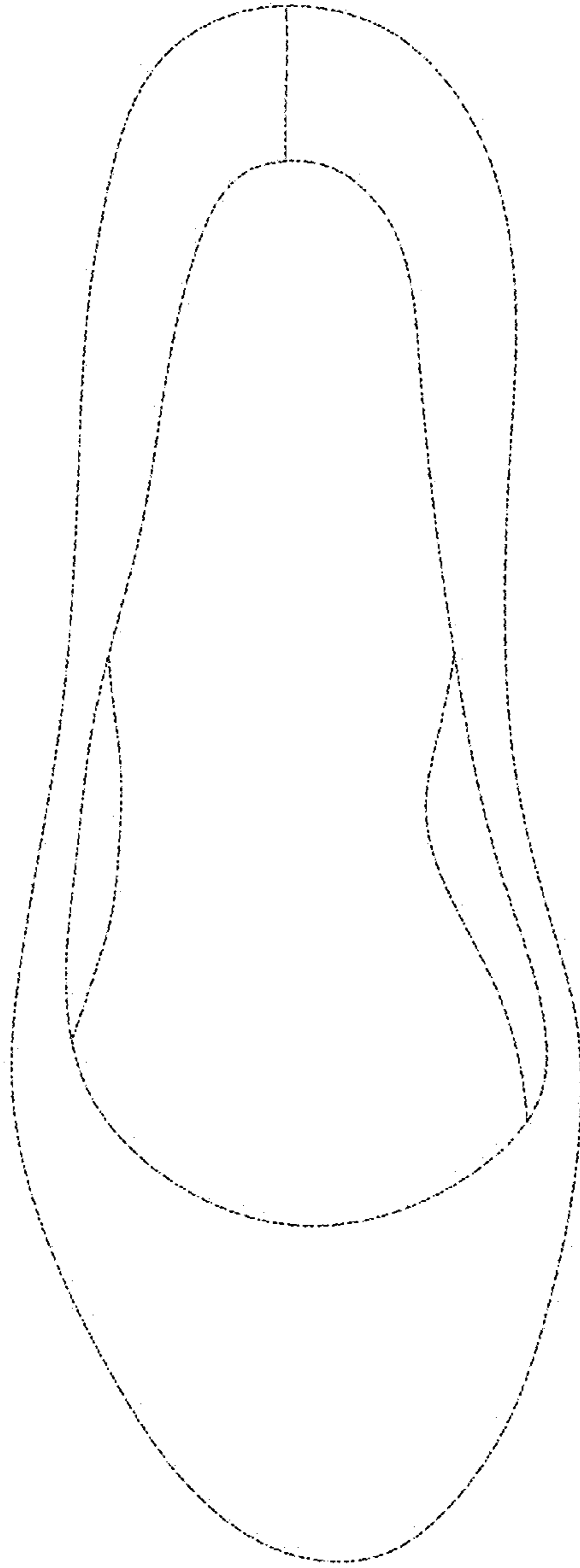
