FIG. 12 is a rear view thereof;

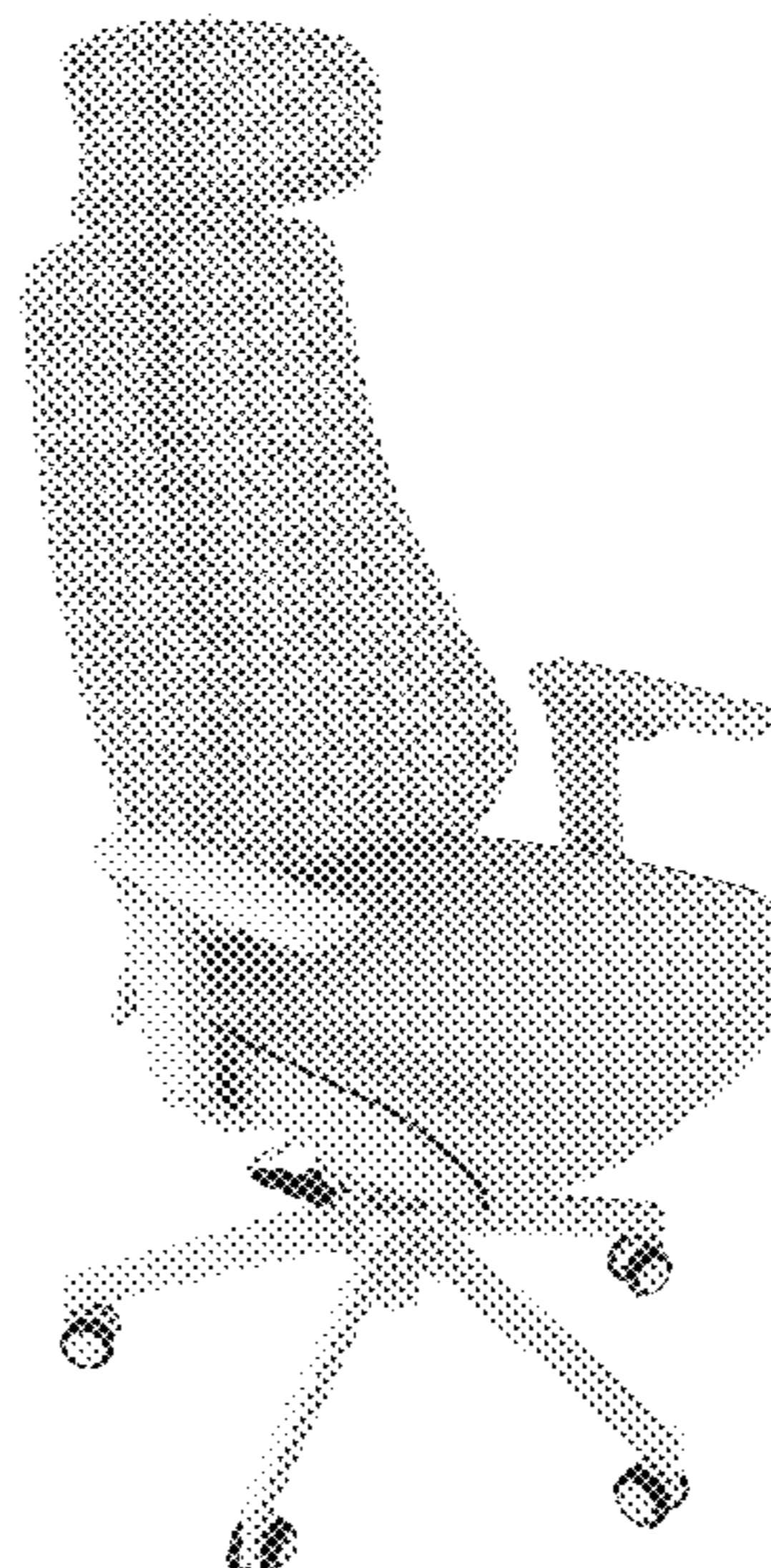
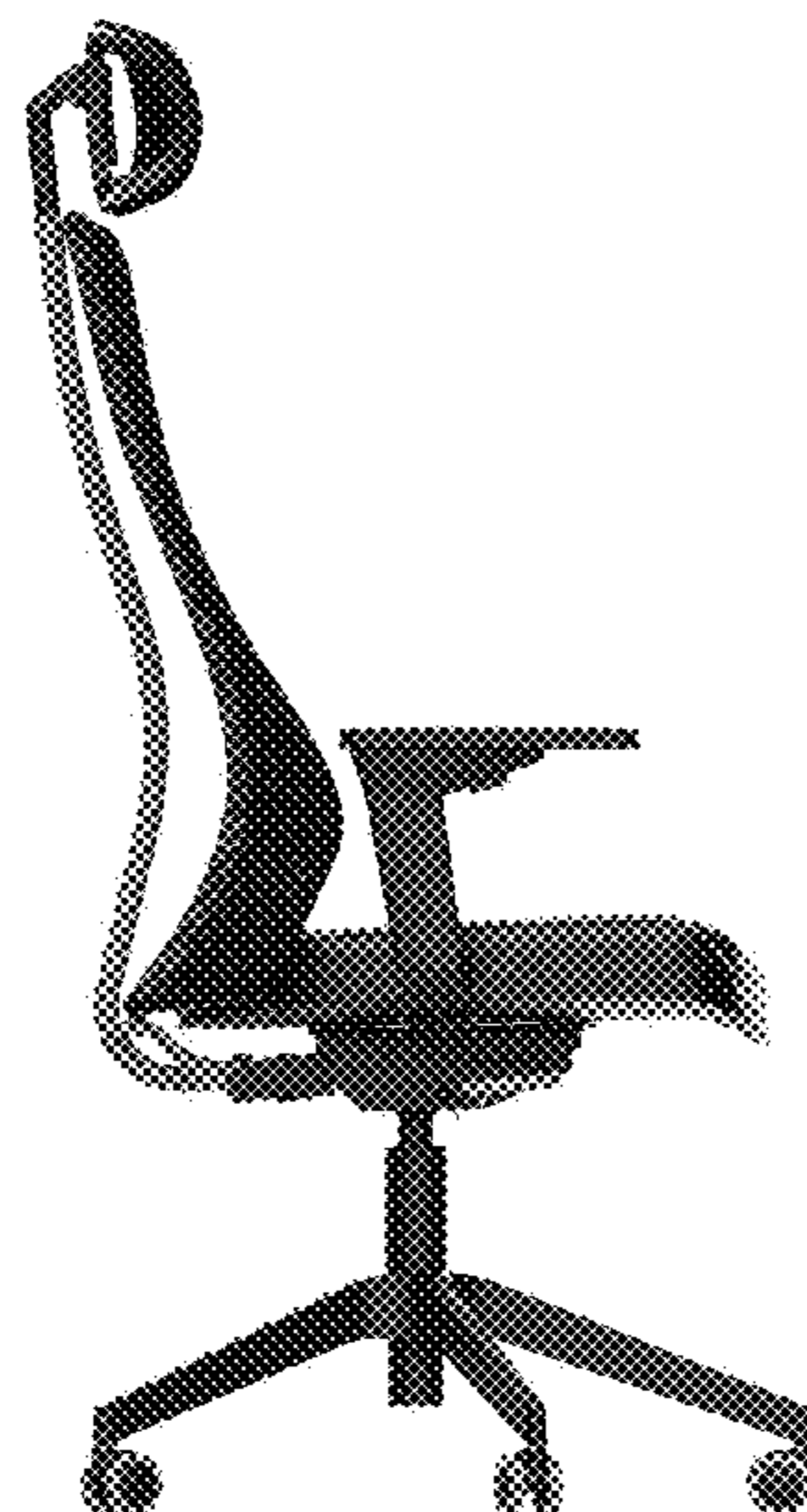
FIG. 13 is a top view thereof;

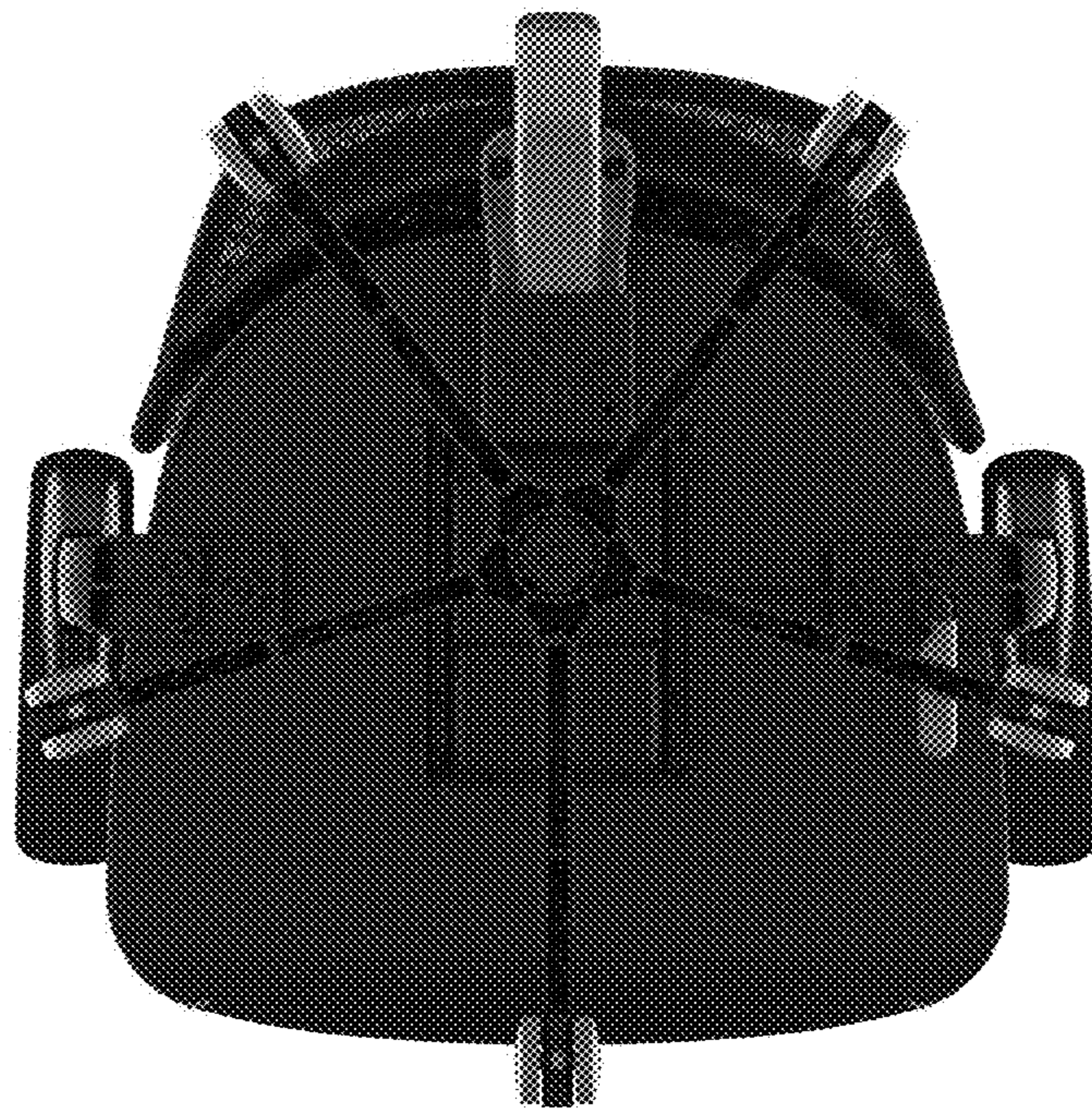

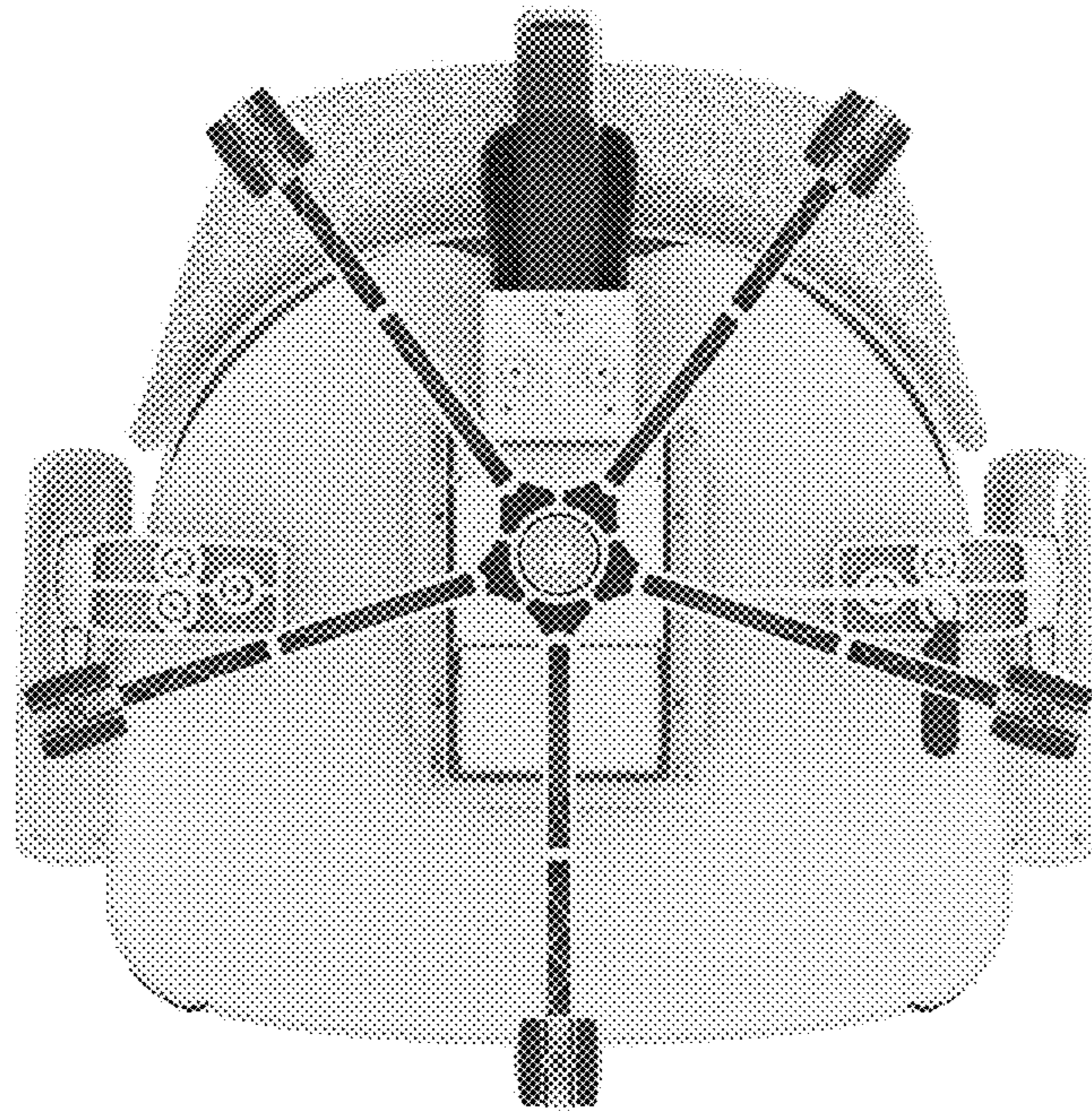
