The dash-dash broken lines in the drawings depict portions of the cooking appliance that form no part of the claimed design.

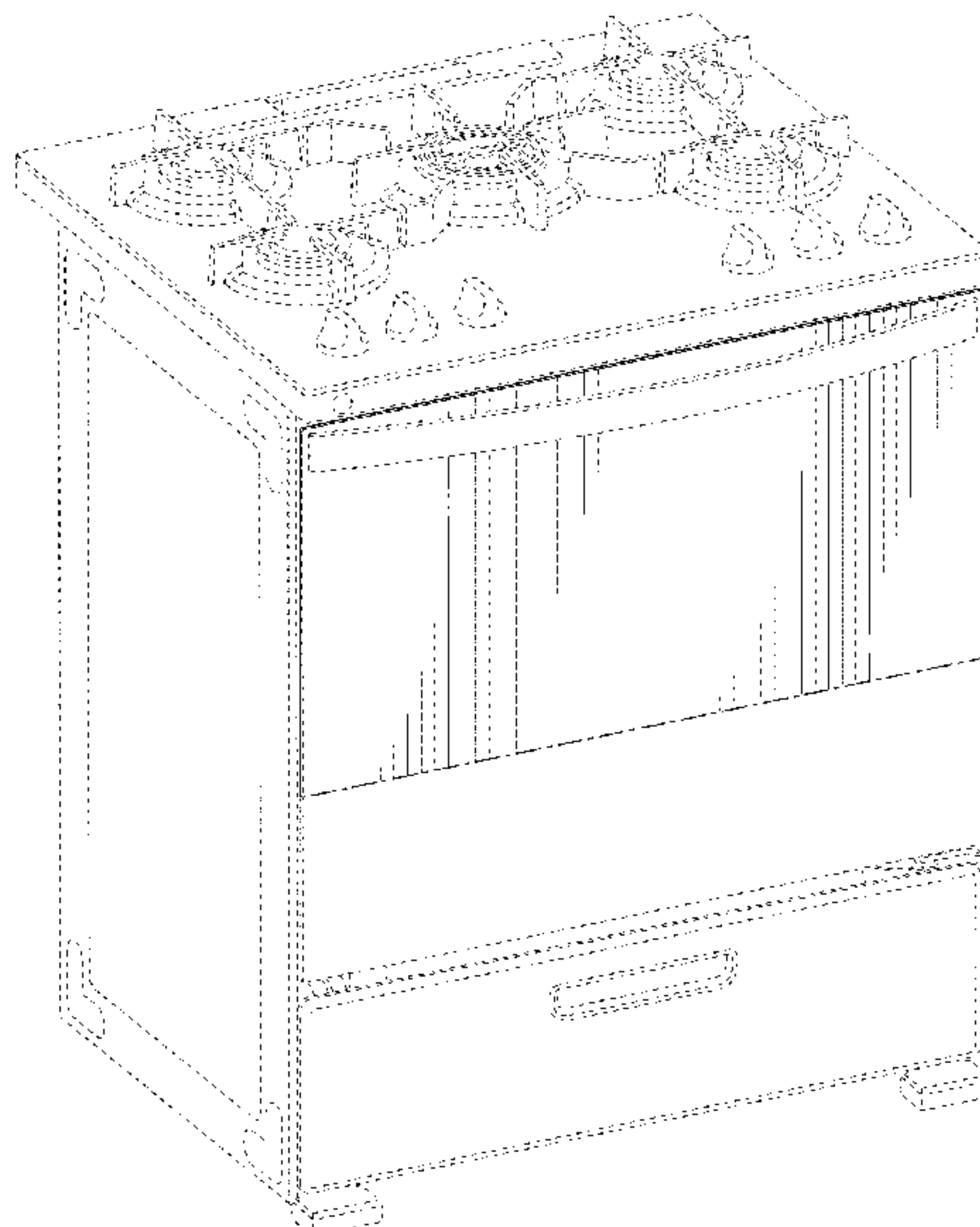
The dash-dot-dash lines adjacent un-shaded areas represent bounds of the claimed design and form no part thereof.

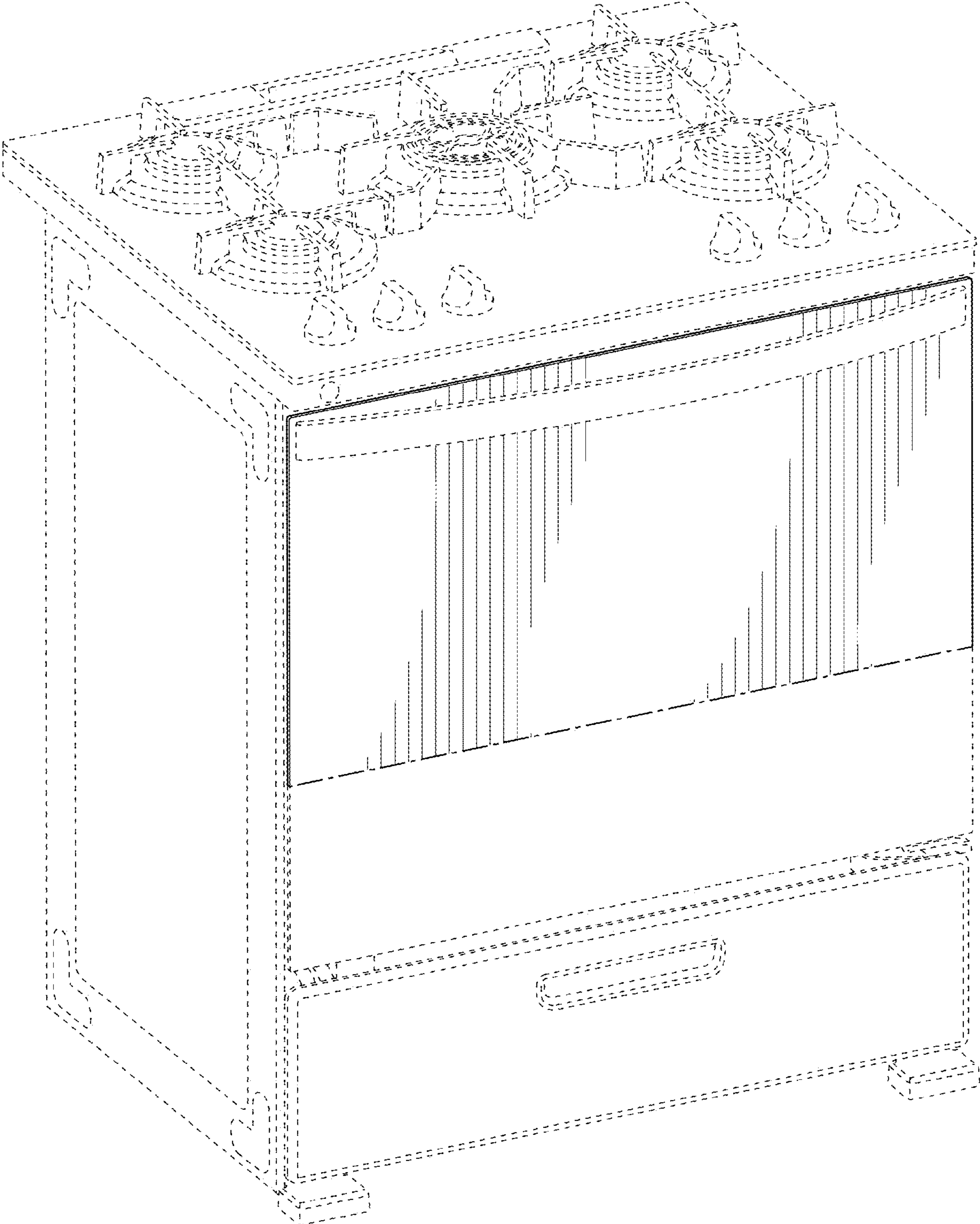

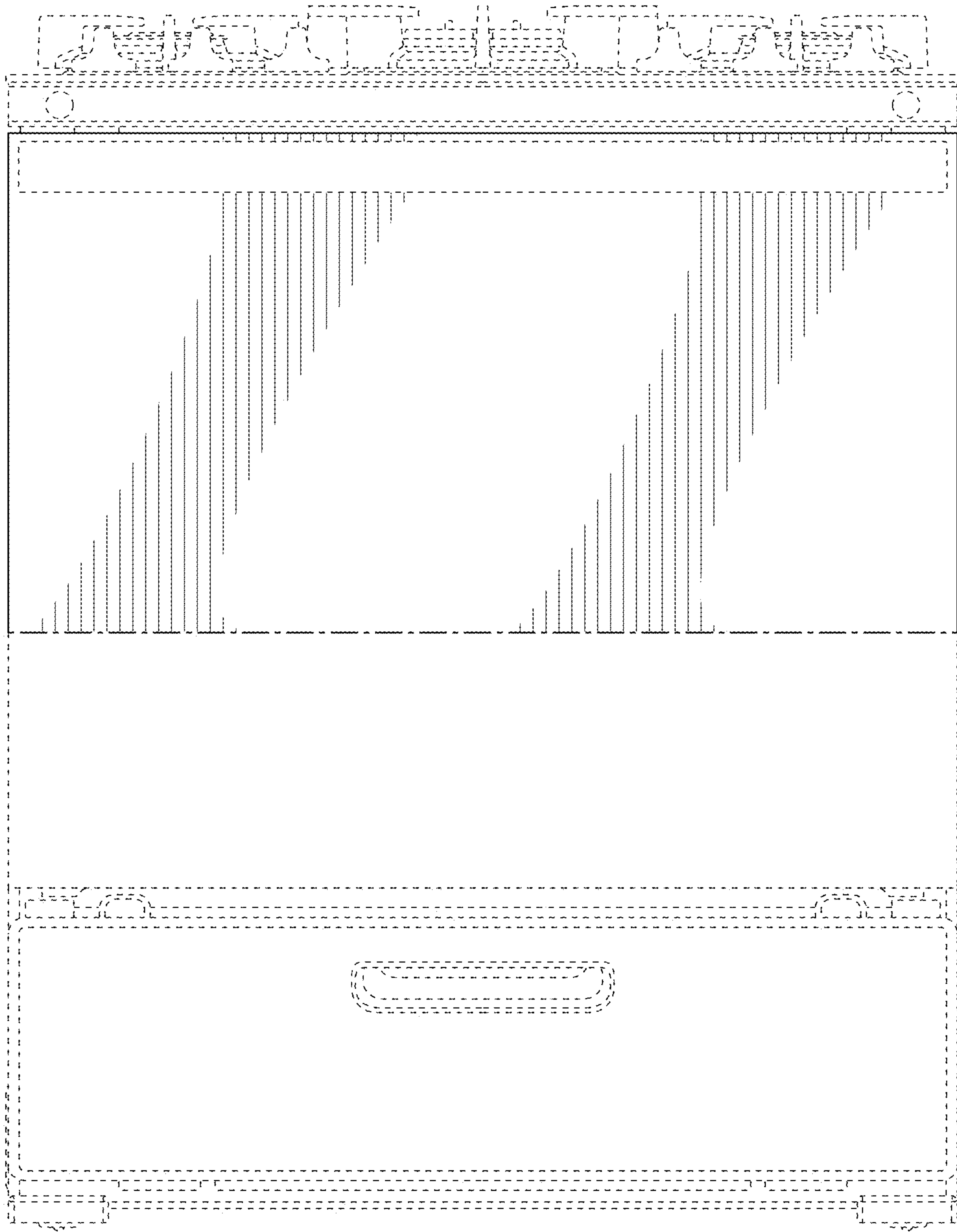

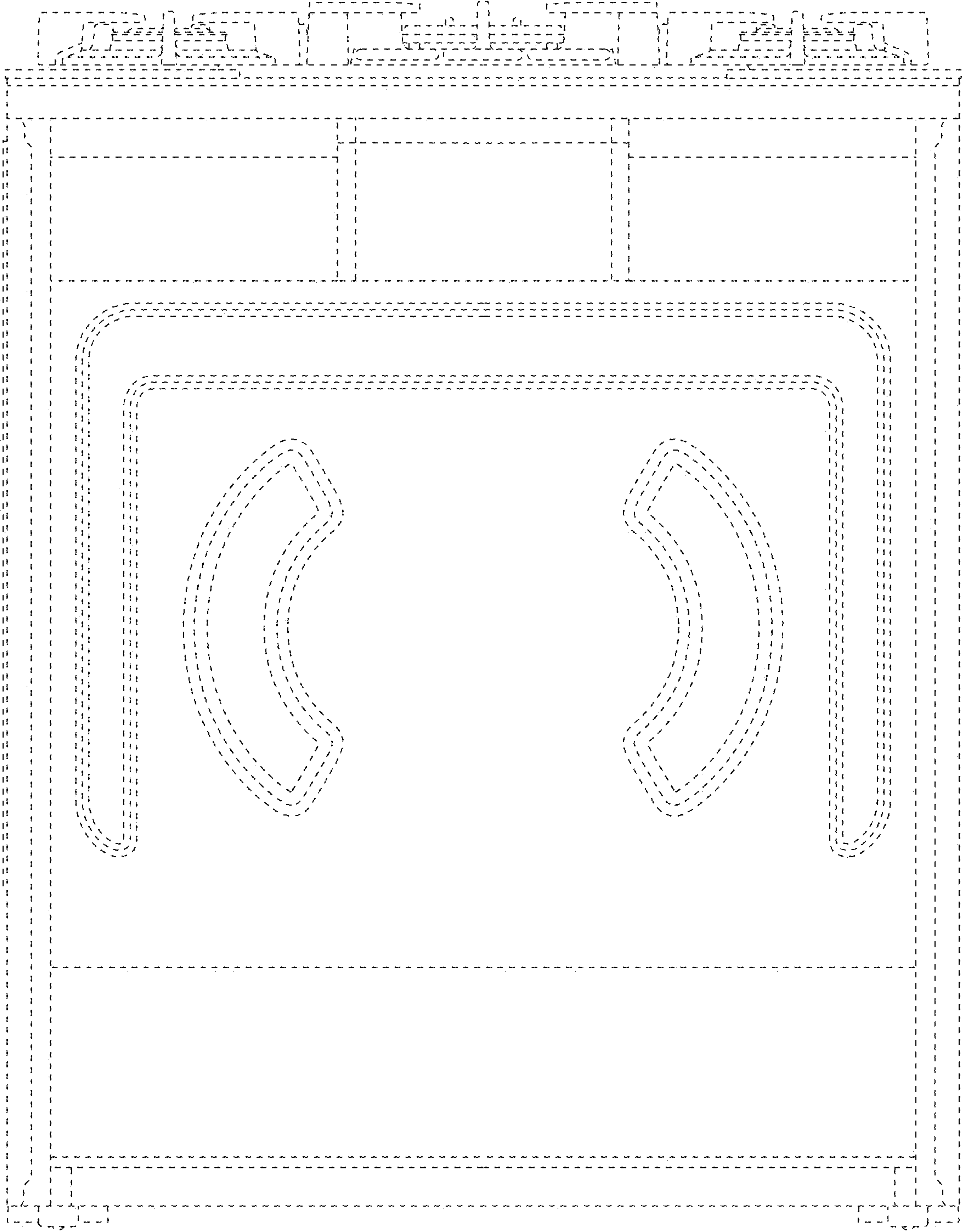

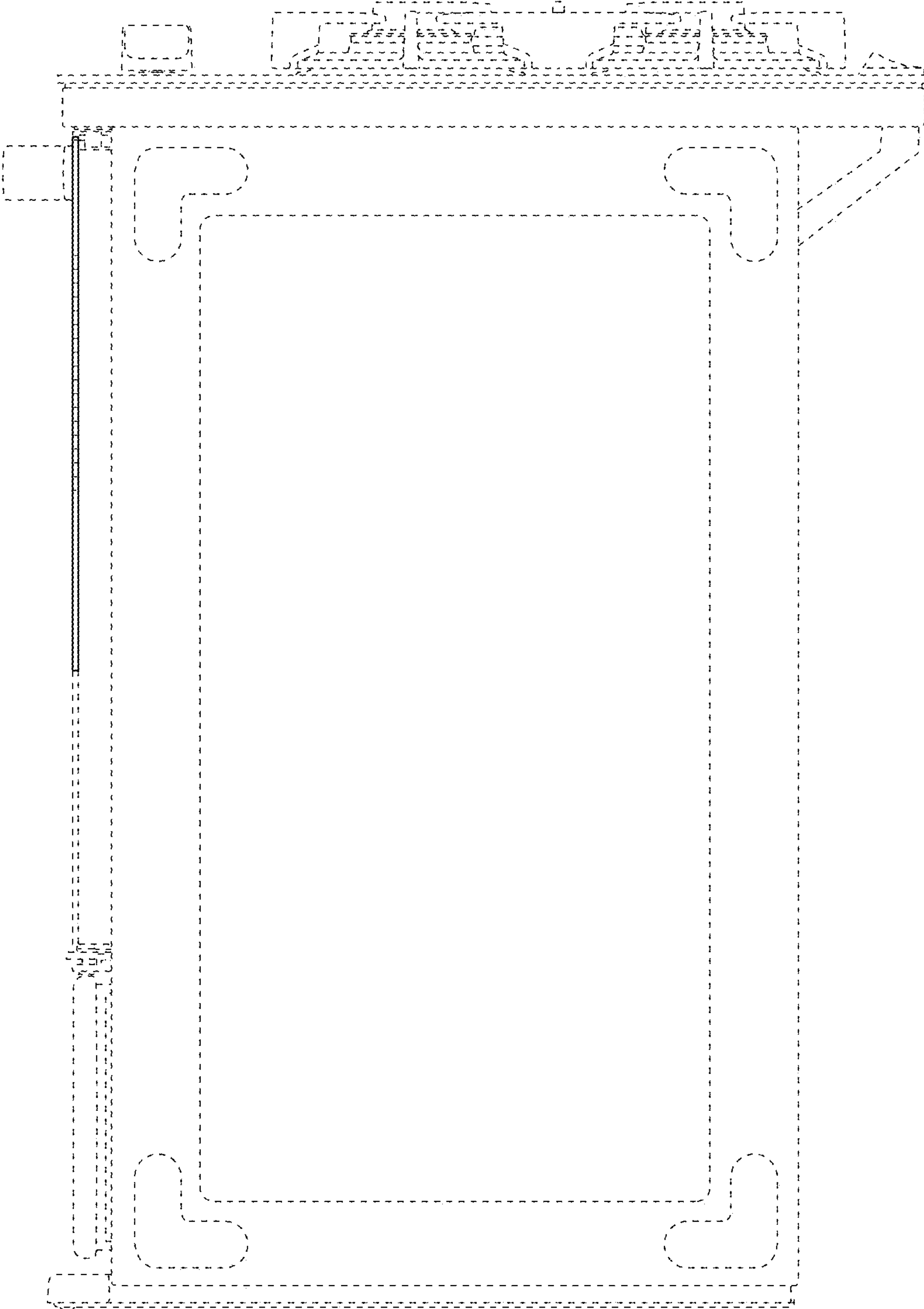

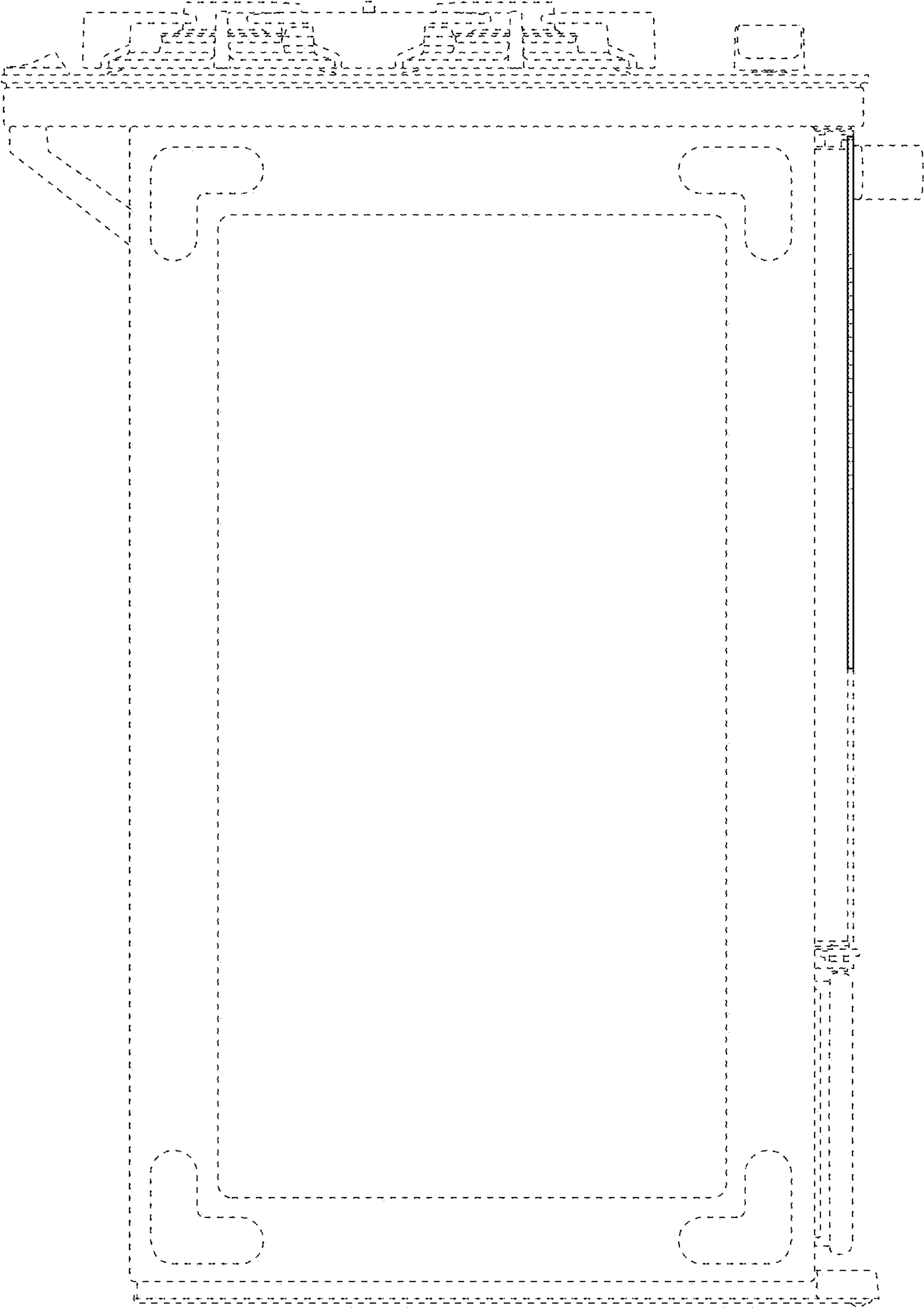

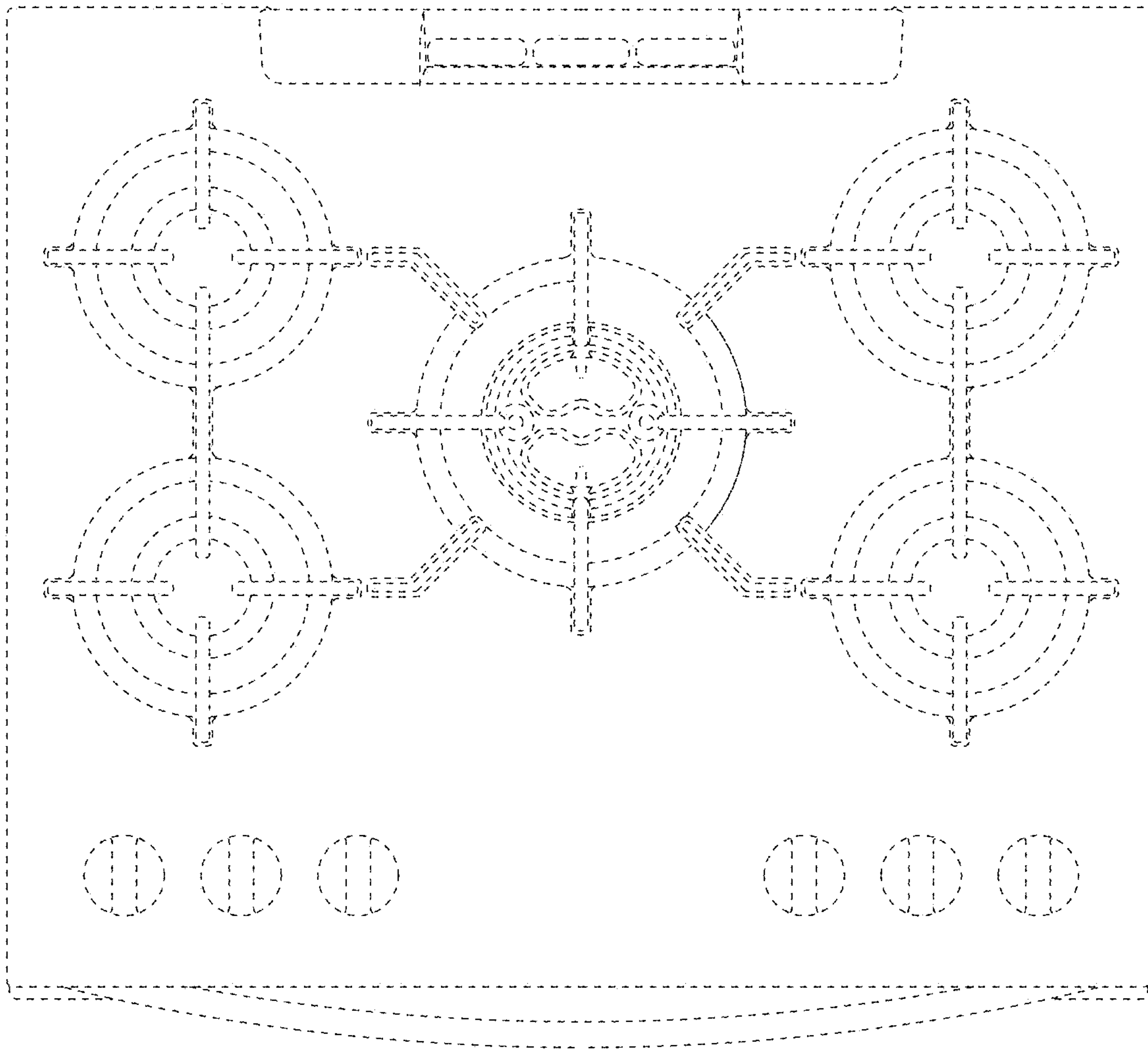

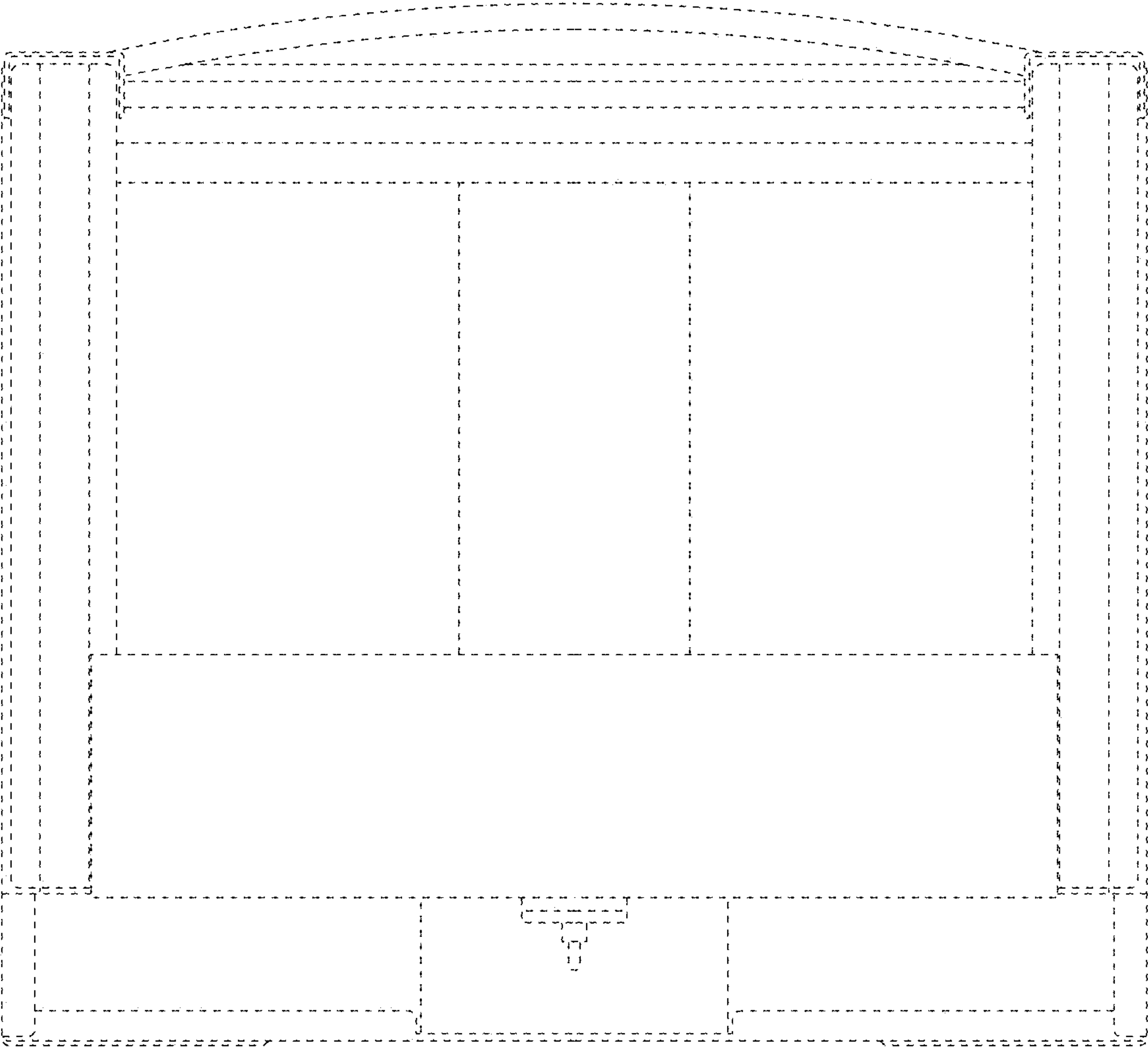

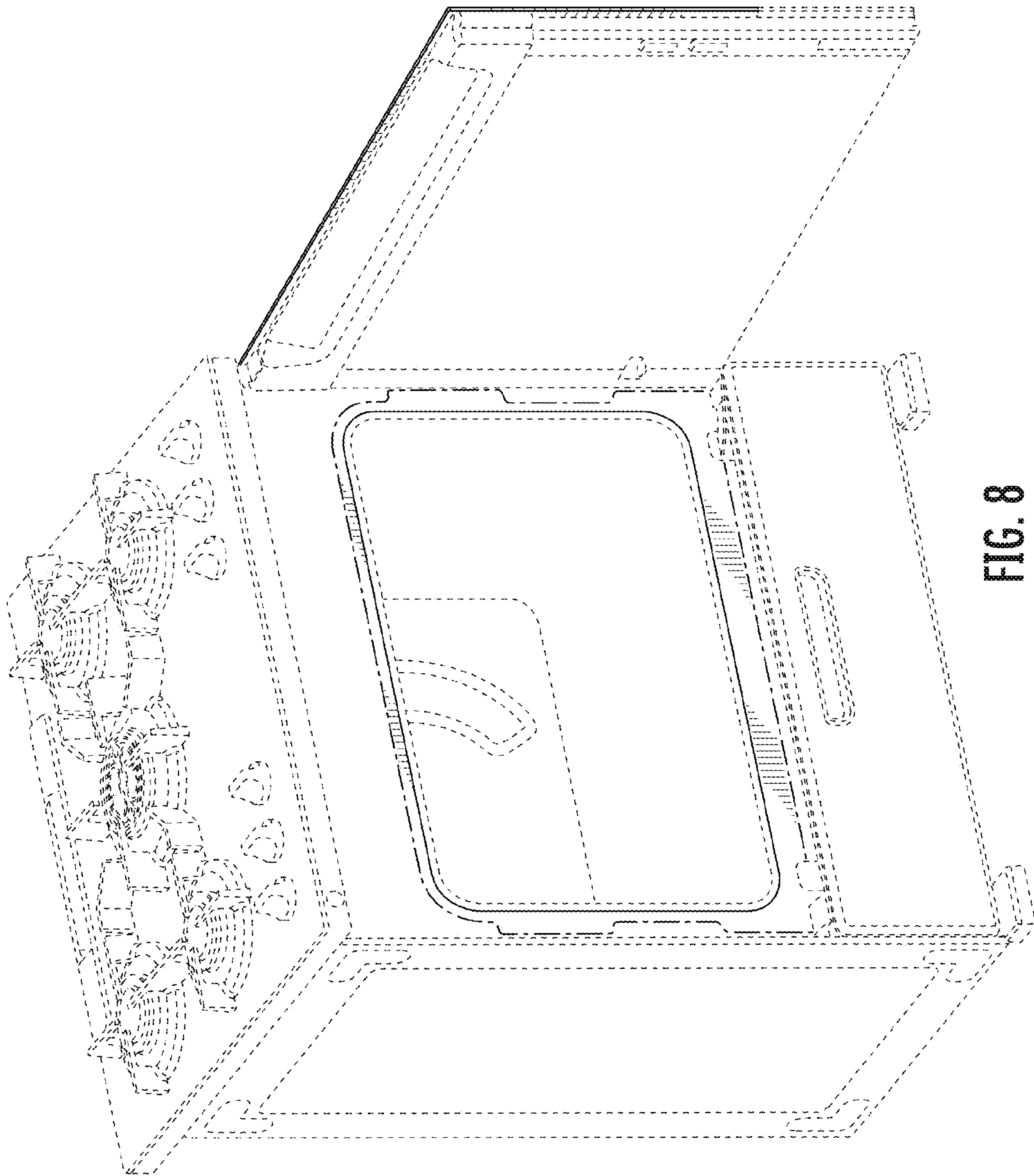

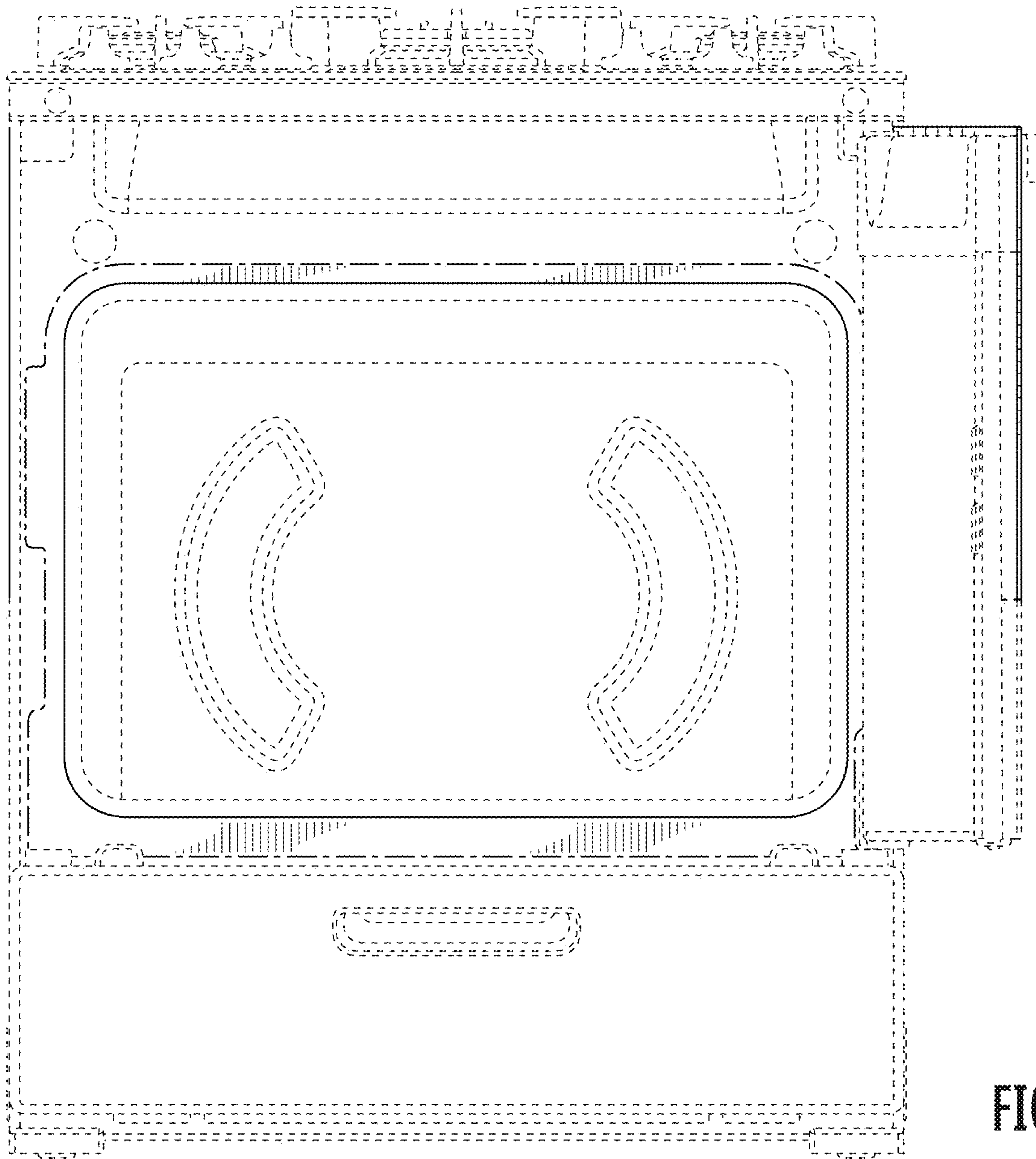

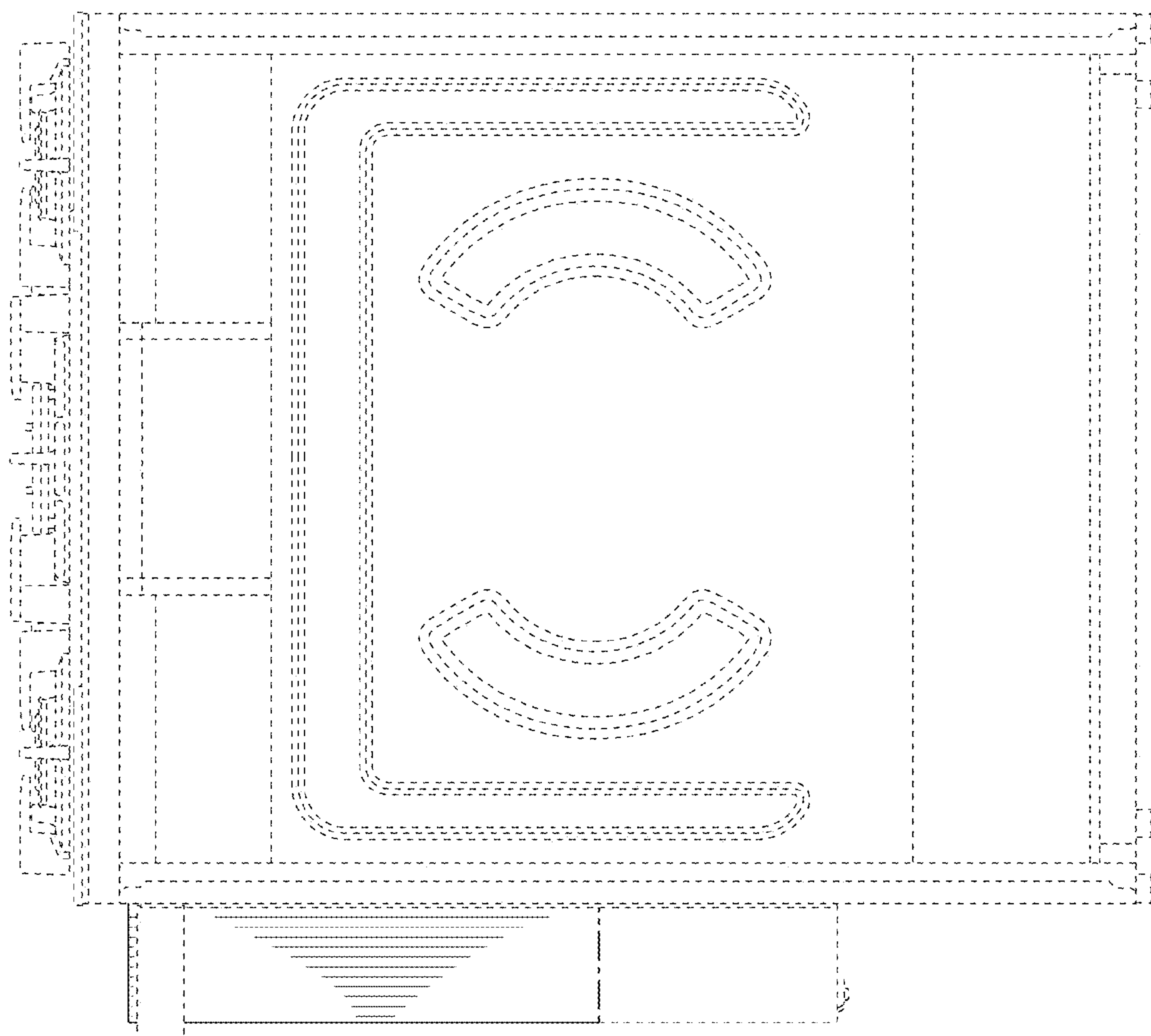

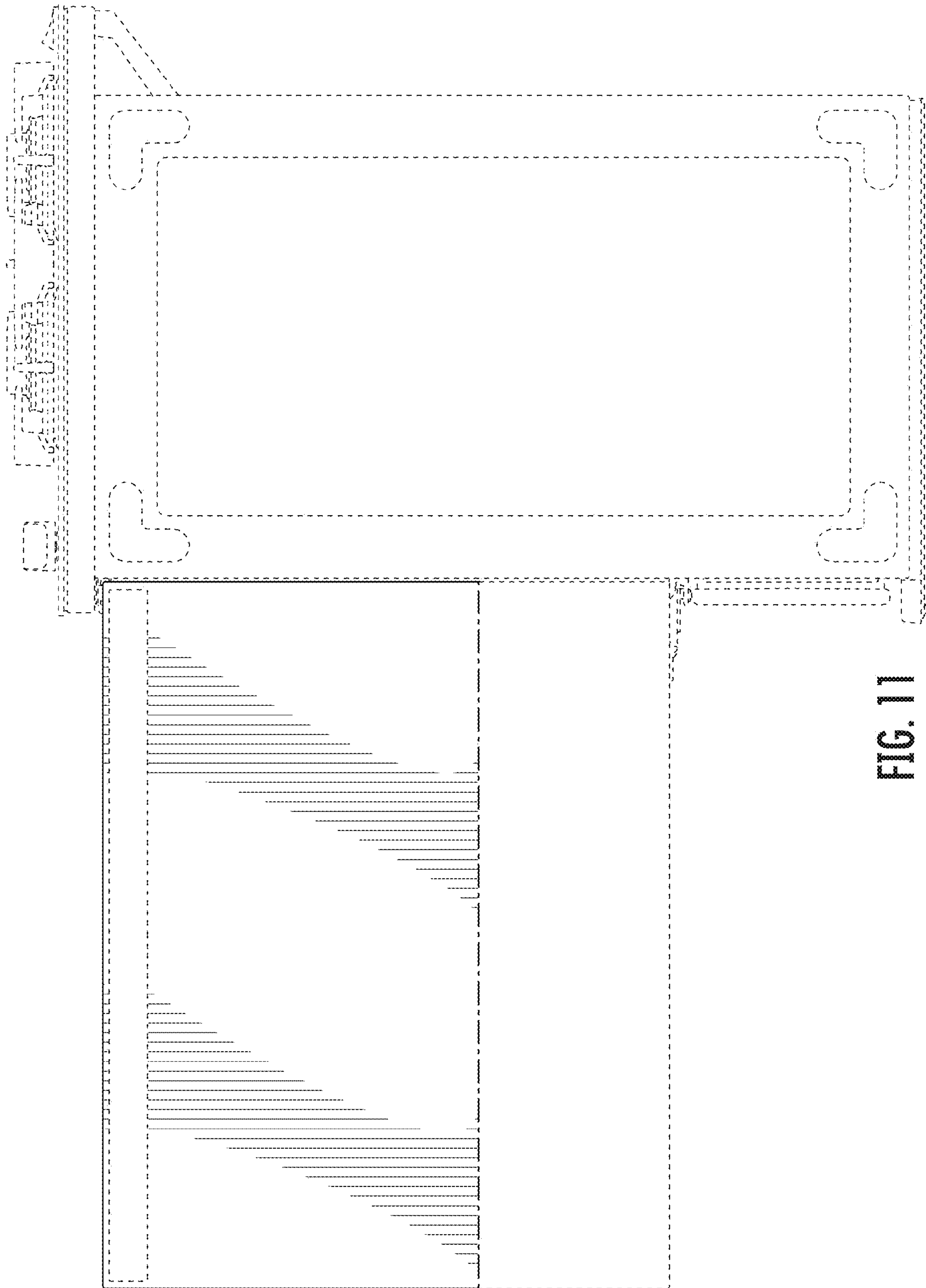

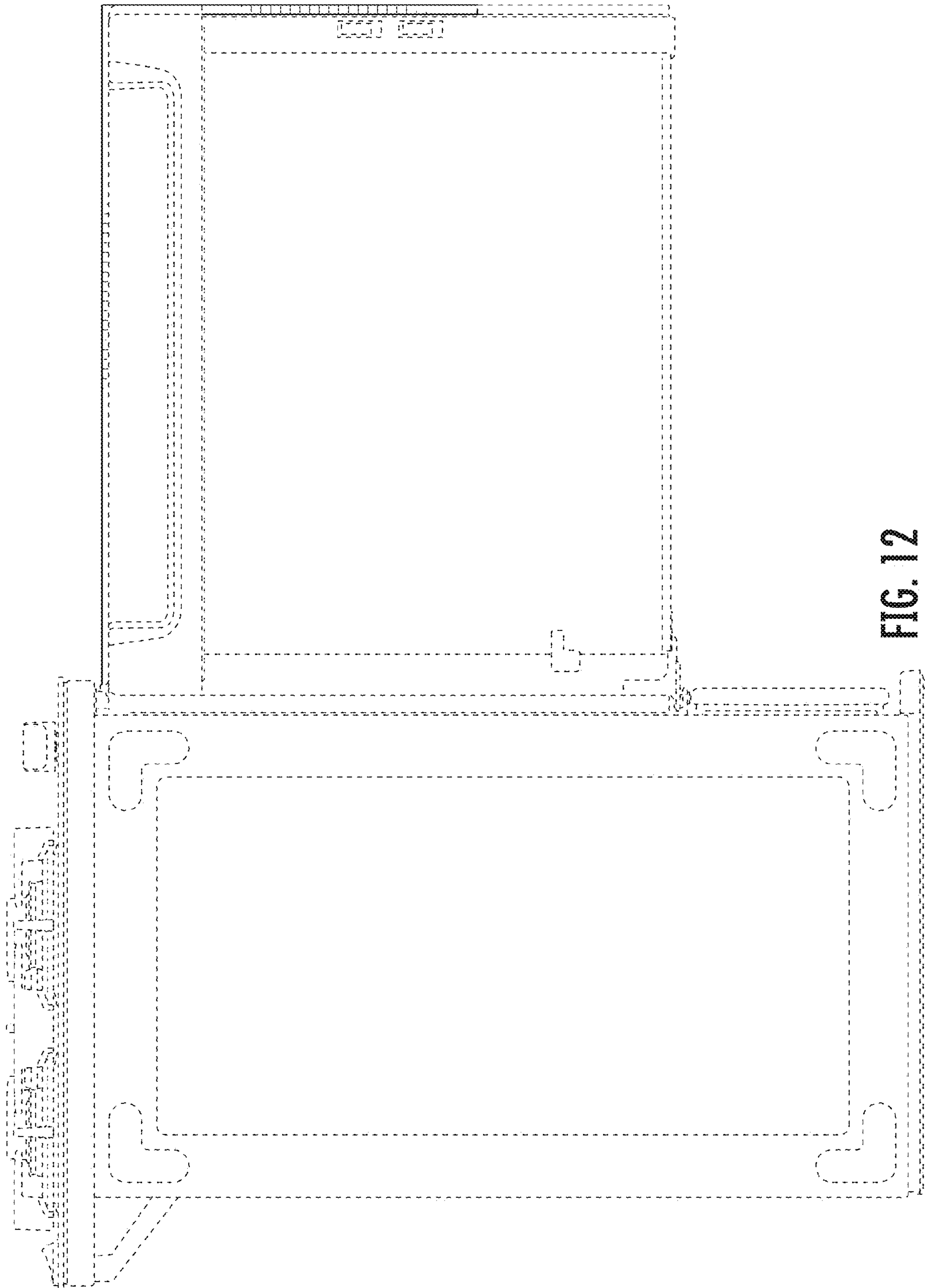

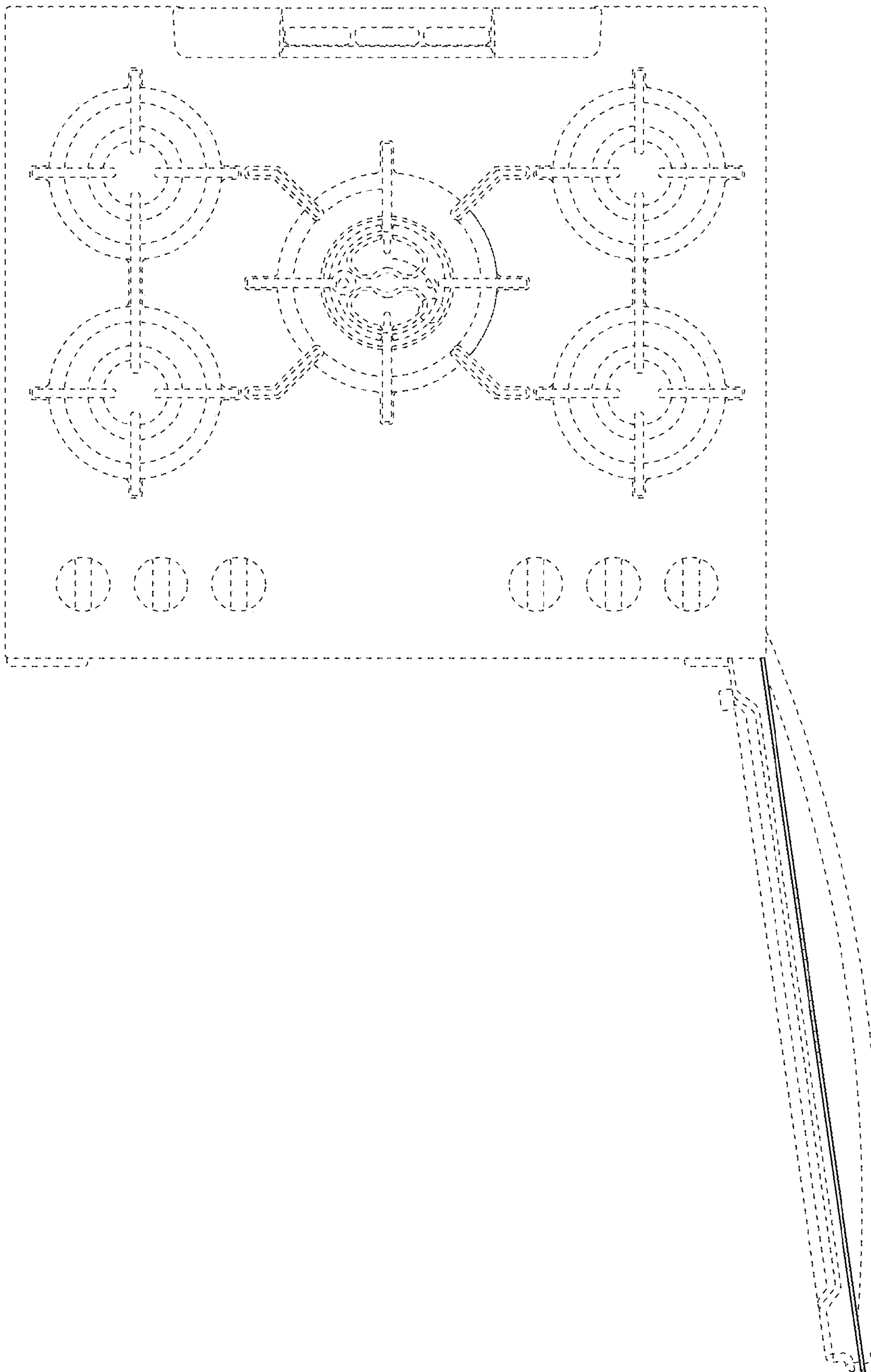

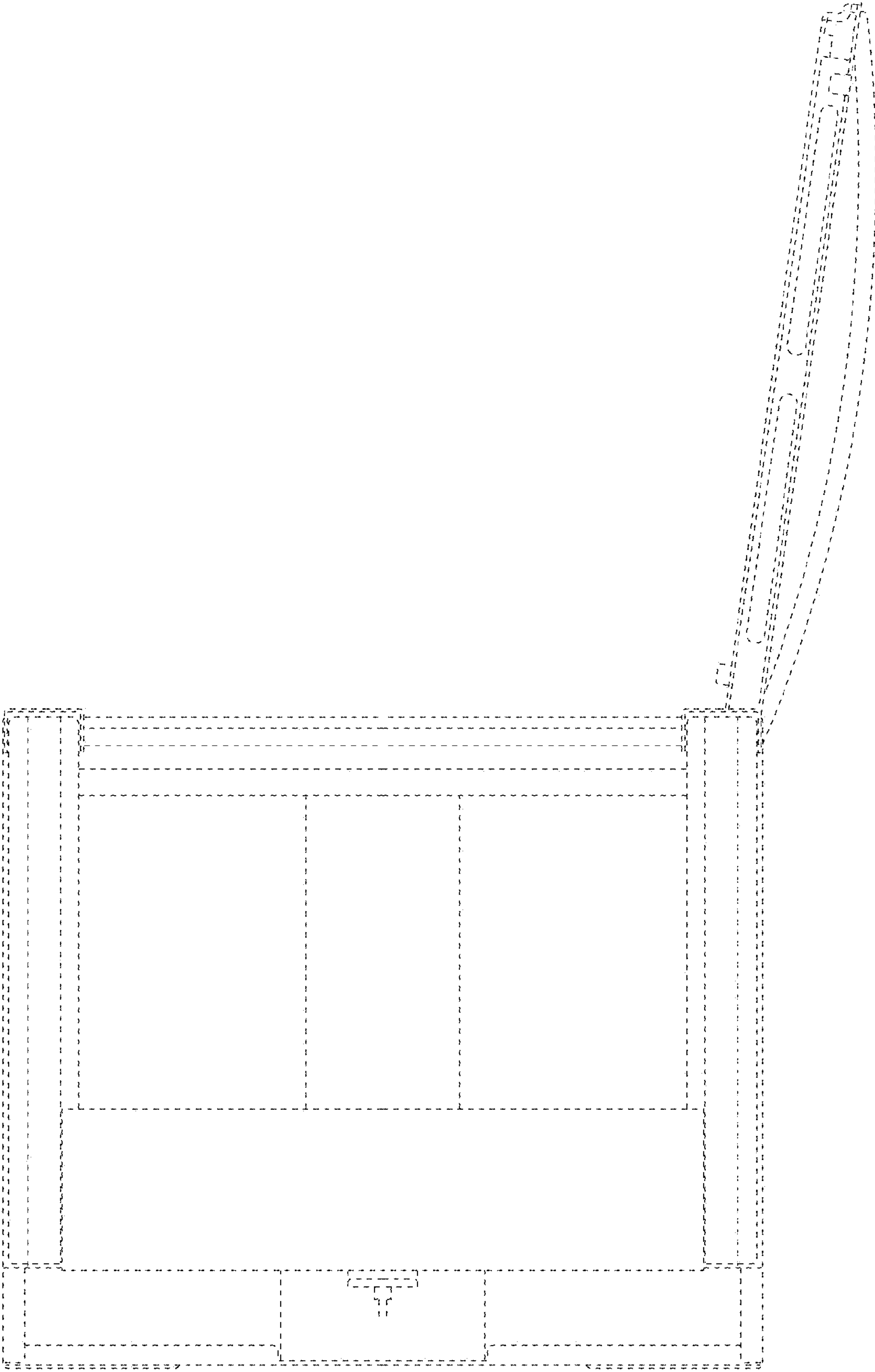
