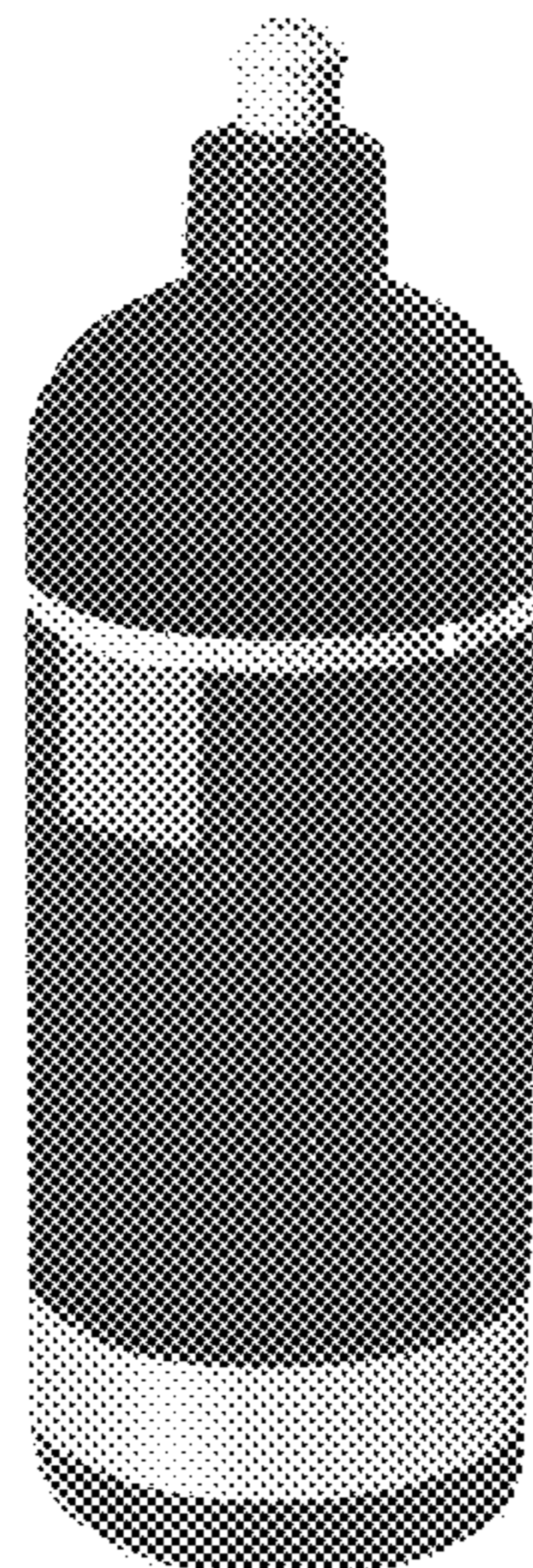
The ornamental design for a bottle for polishing compound,

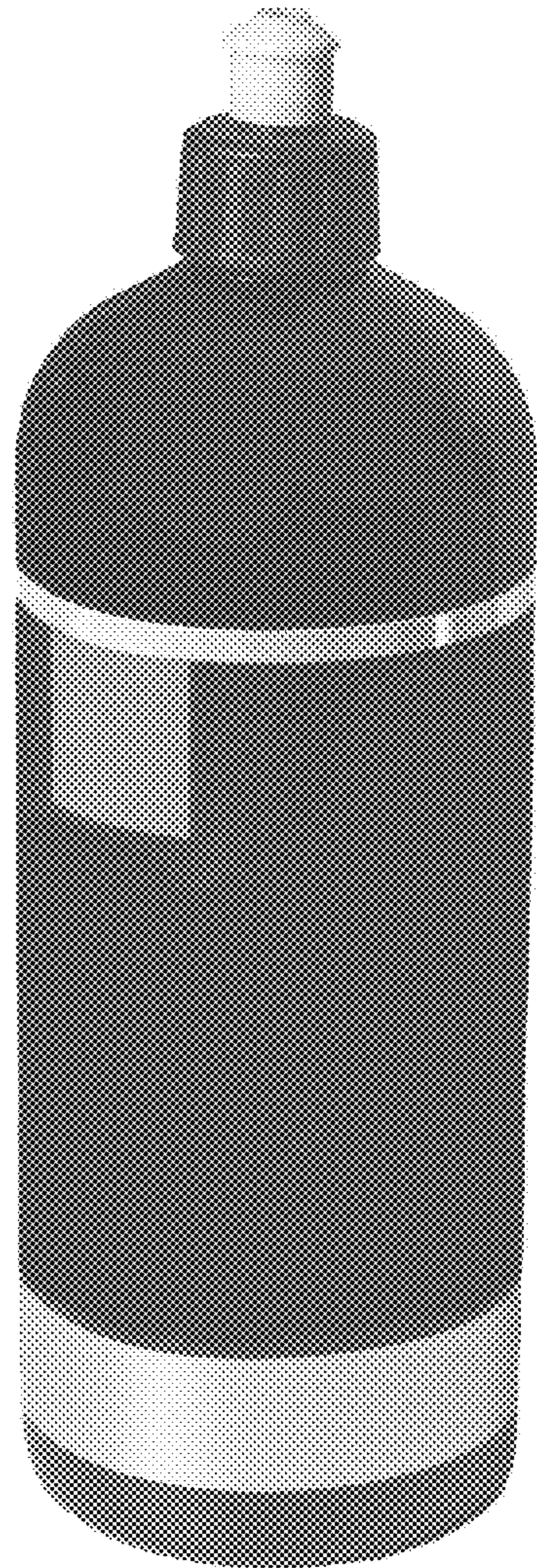

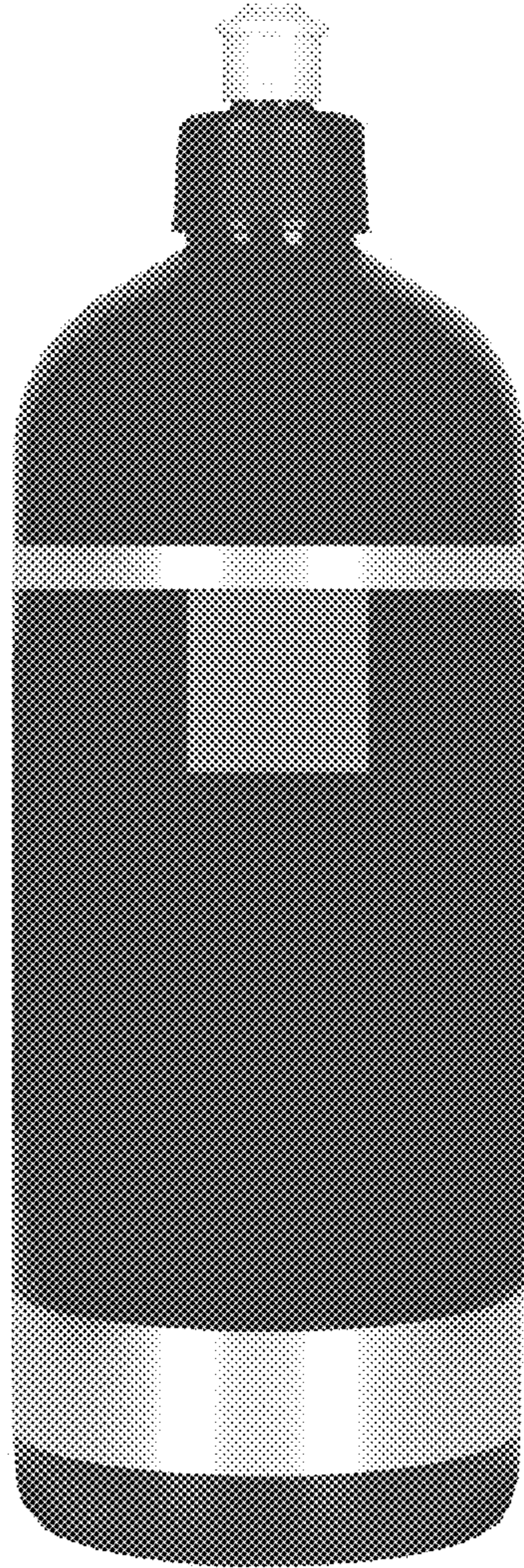

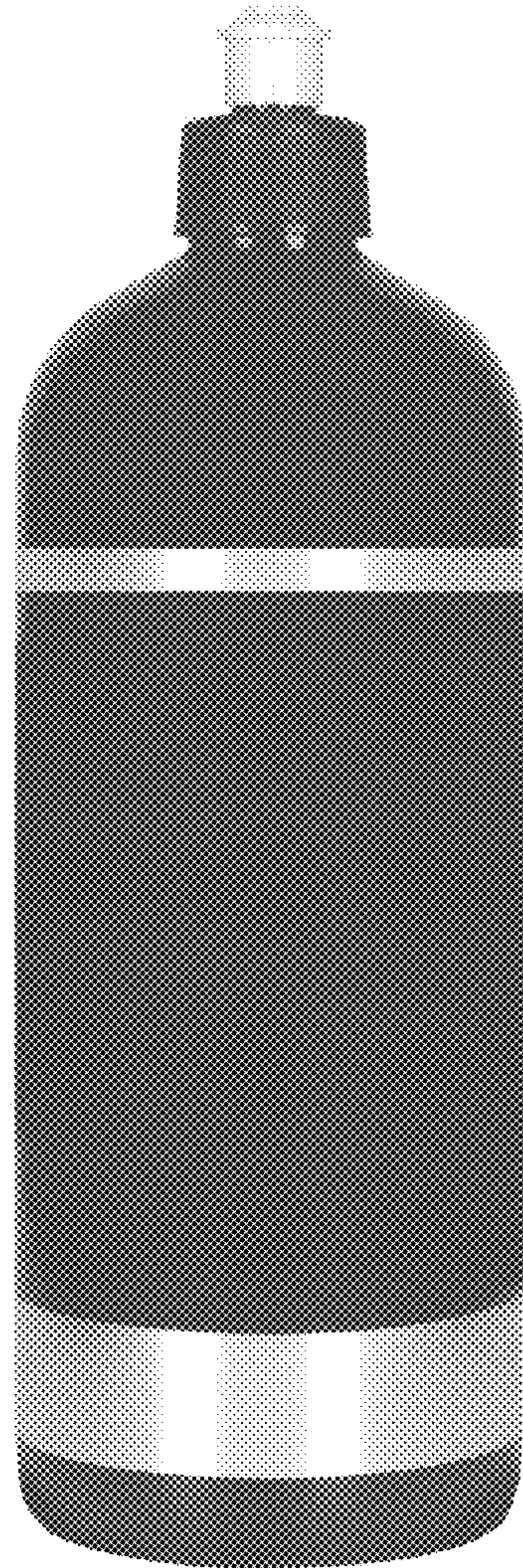

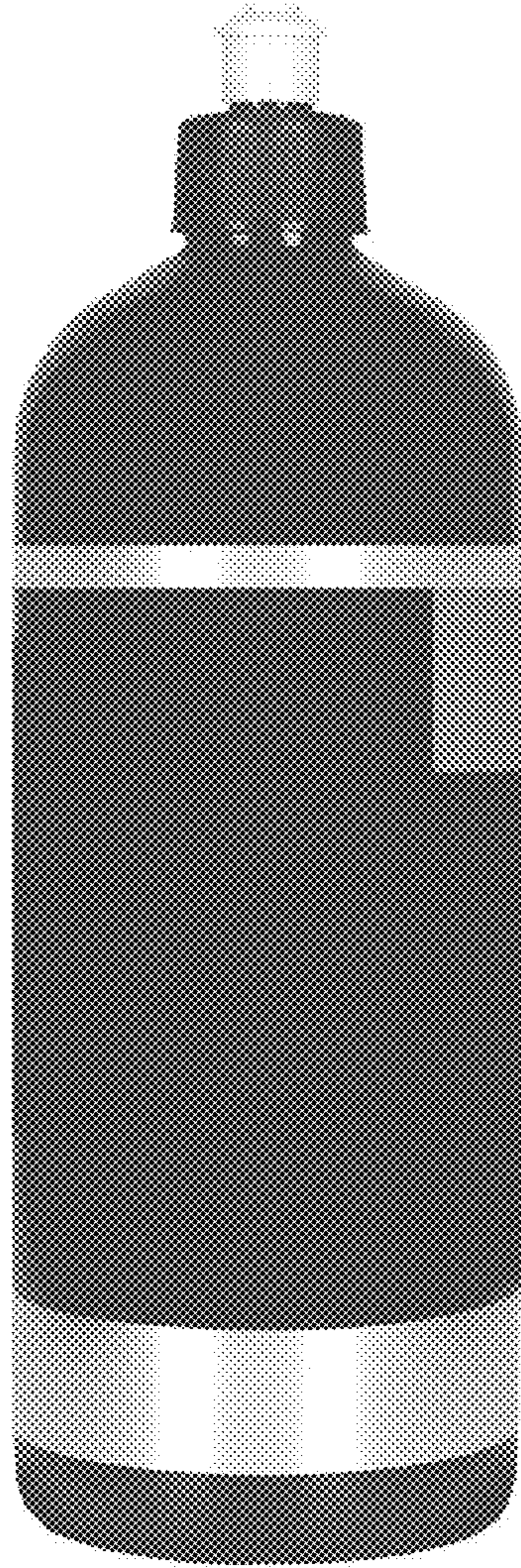

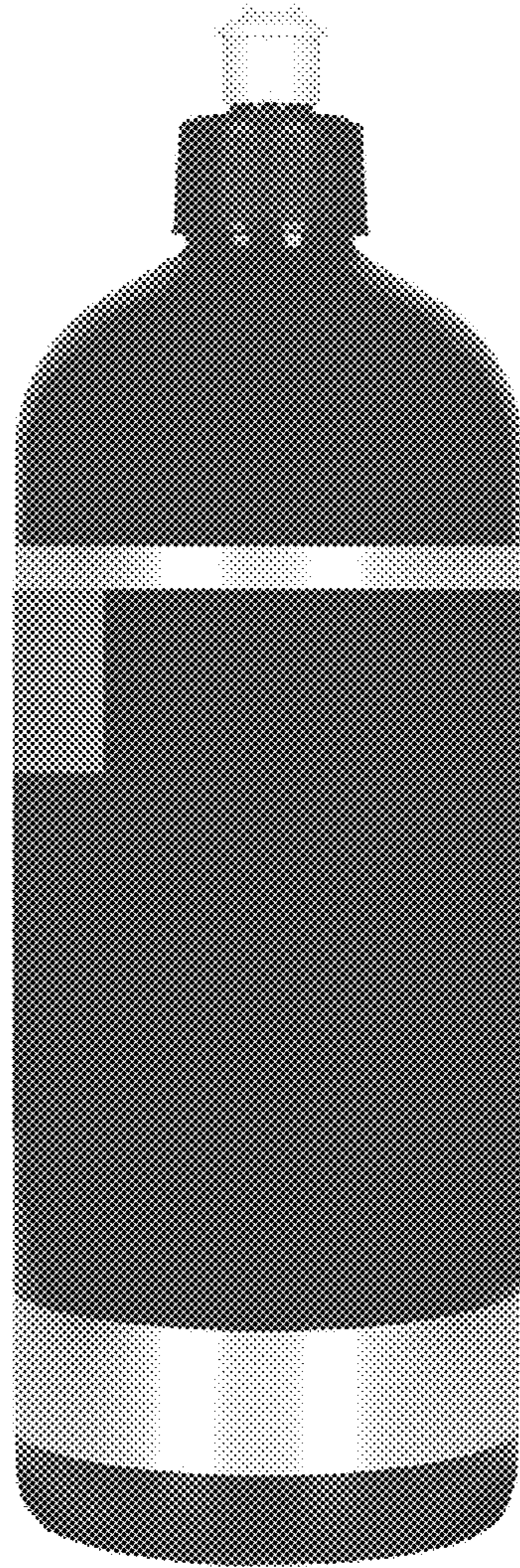

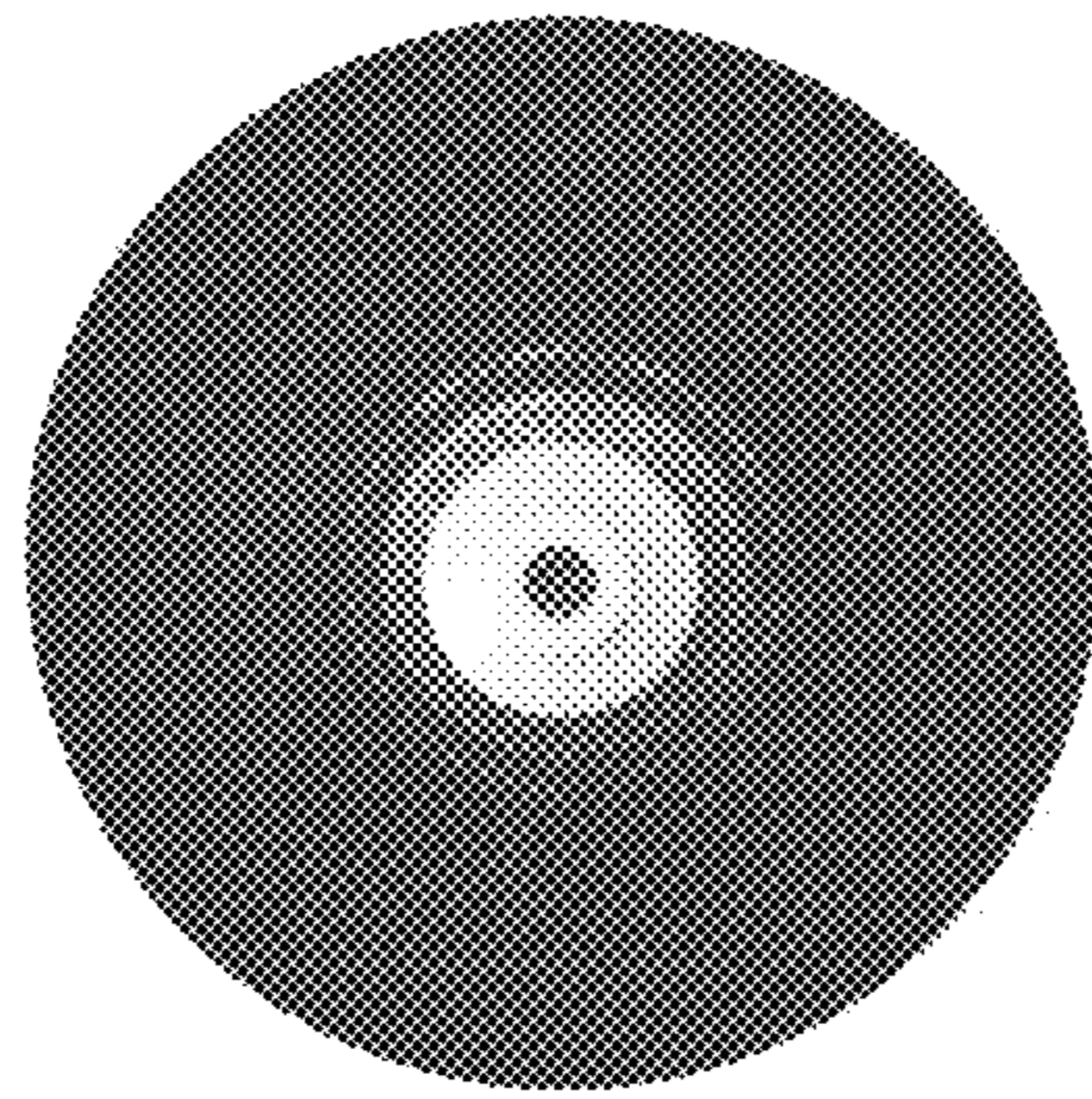

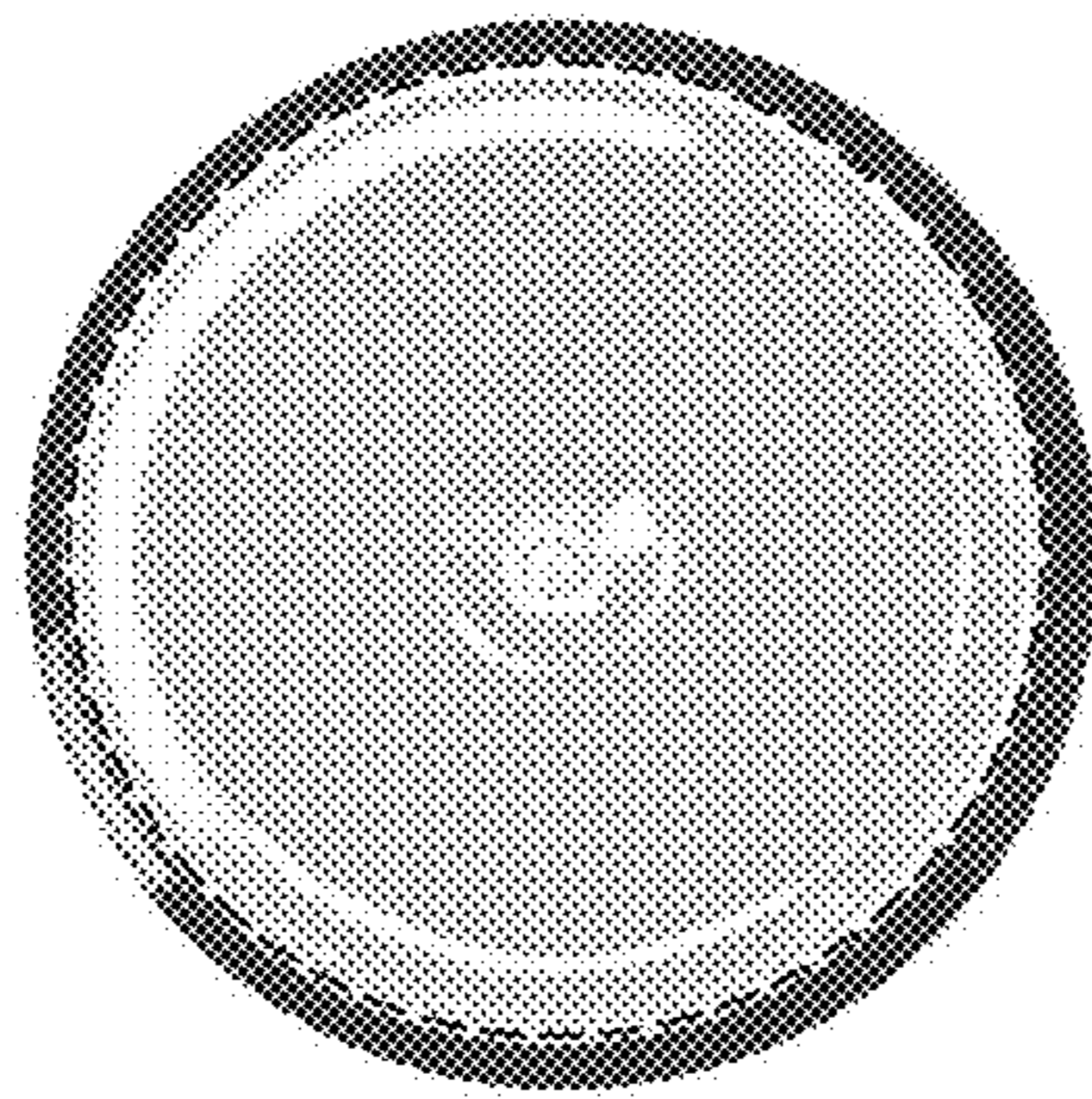
