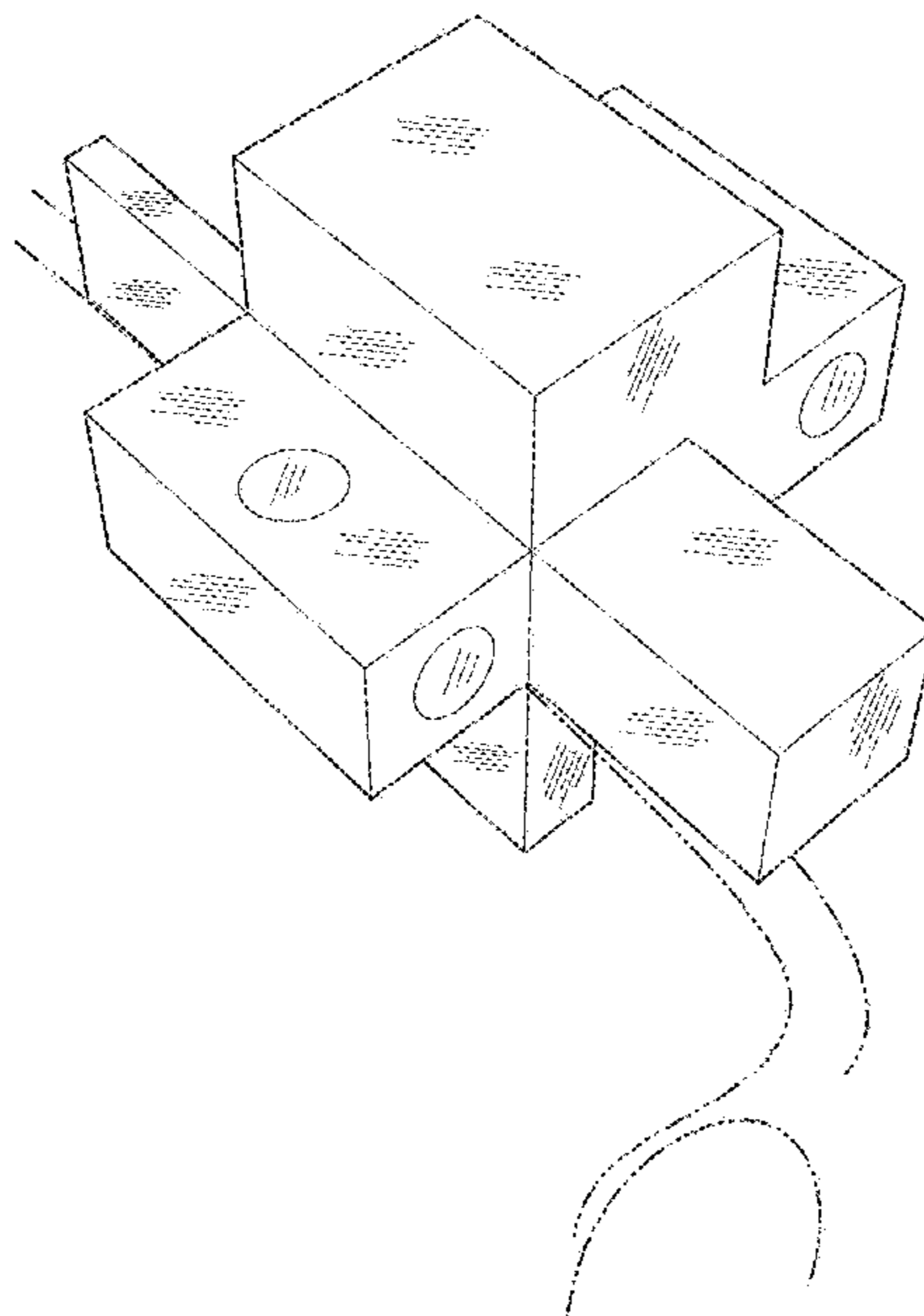

DESCRIPTION

FIG. 1 is a top, left perspective view of a gap gauge arranged between panels of an automobile, showing my new design; FIG. 2 is a left, side perspective view of the gap gauge of FIG. 1 removed from between the panels of an automobile; FIG. 3 is a right, side perspective view of the gap gauge of FIG. 2; FIG. 4 is a front elevational view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a left side elevational view thereof; FIG. 7 is a right side elevational view thereof; FIG. 8 is a top plan view thereof; and, FIG. 9 is a bottom plan view thereof. The broken line showing of the panels of an automobile in FIG. 1 forms no part of the claimed design.

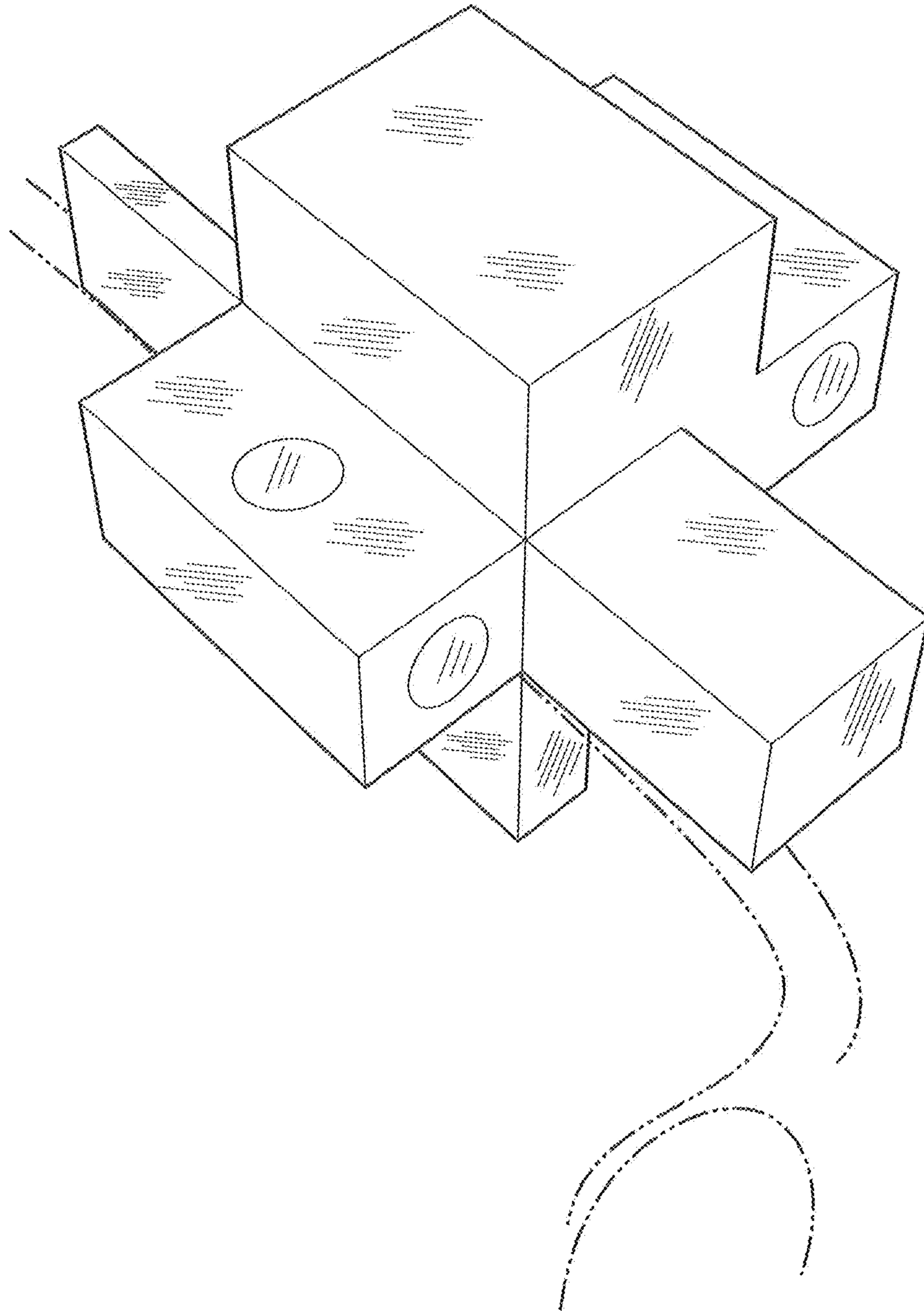

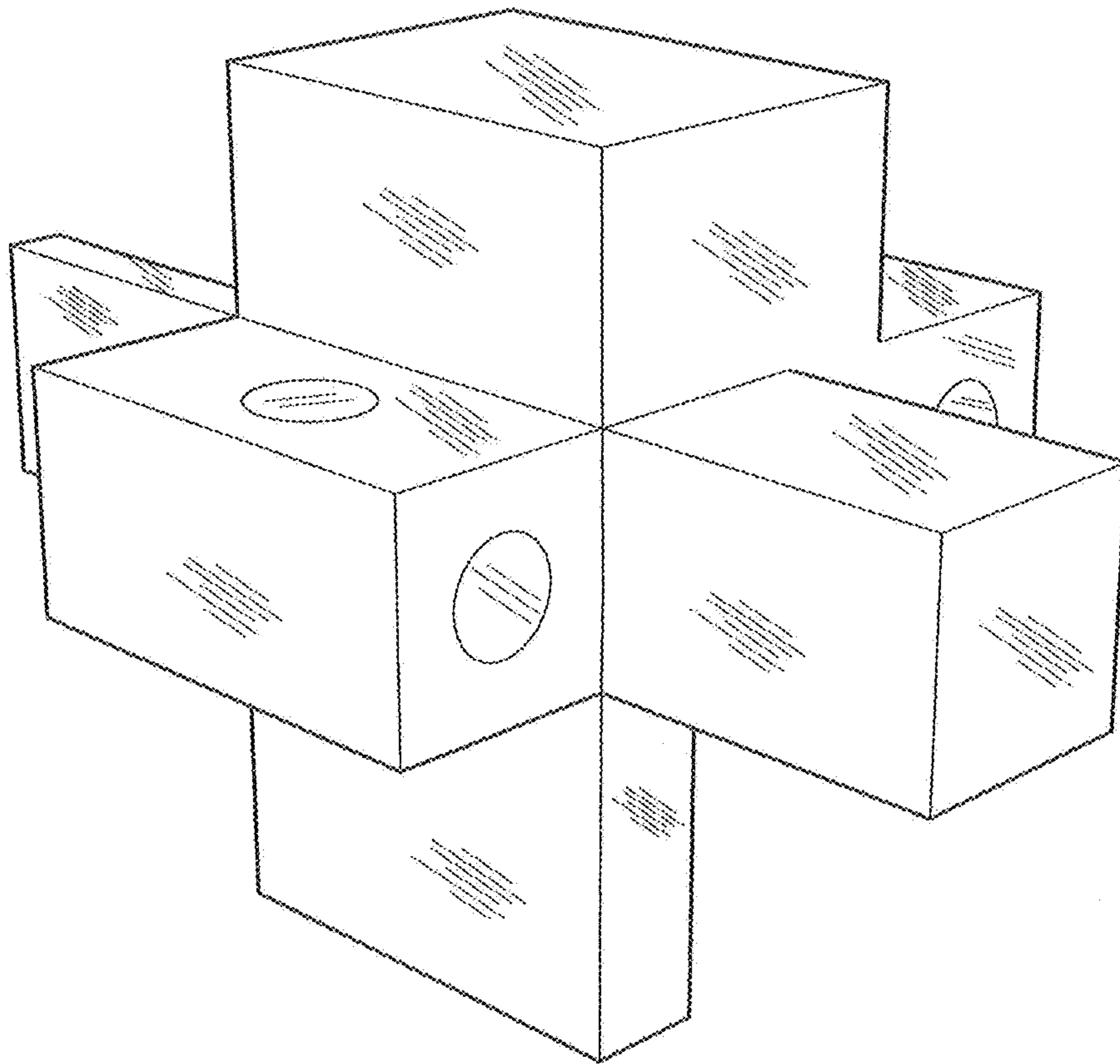

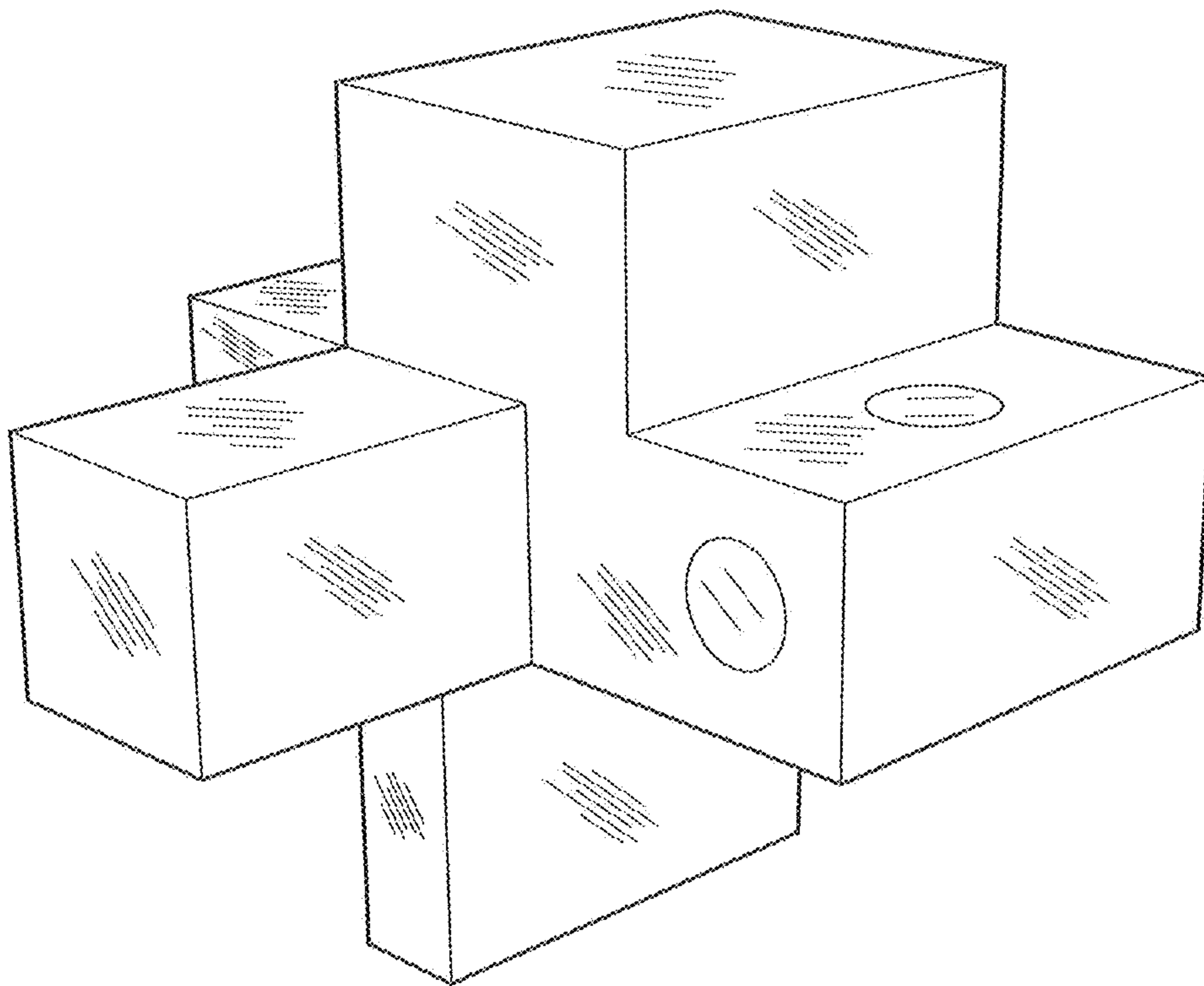

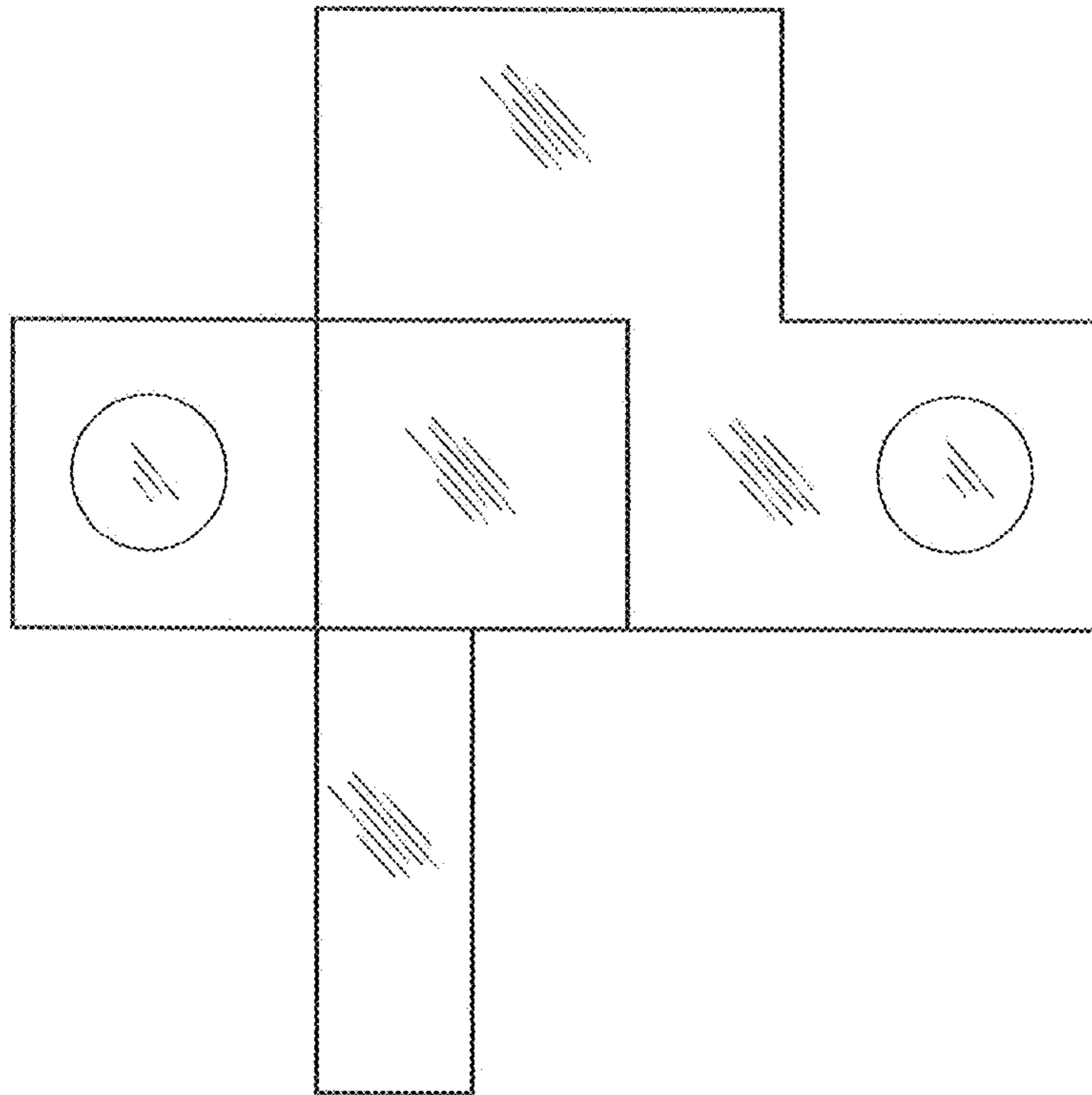

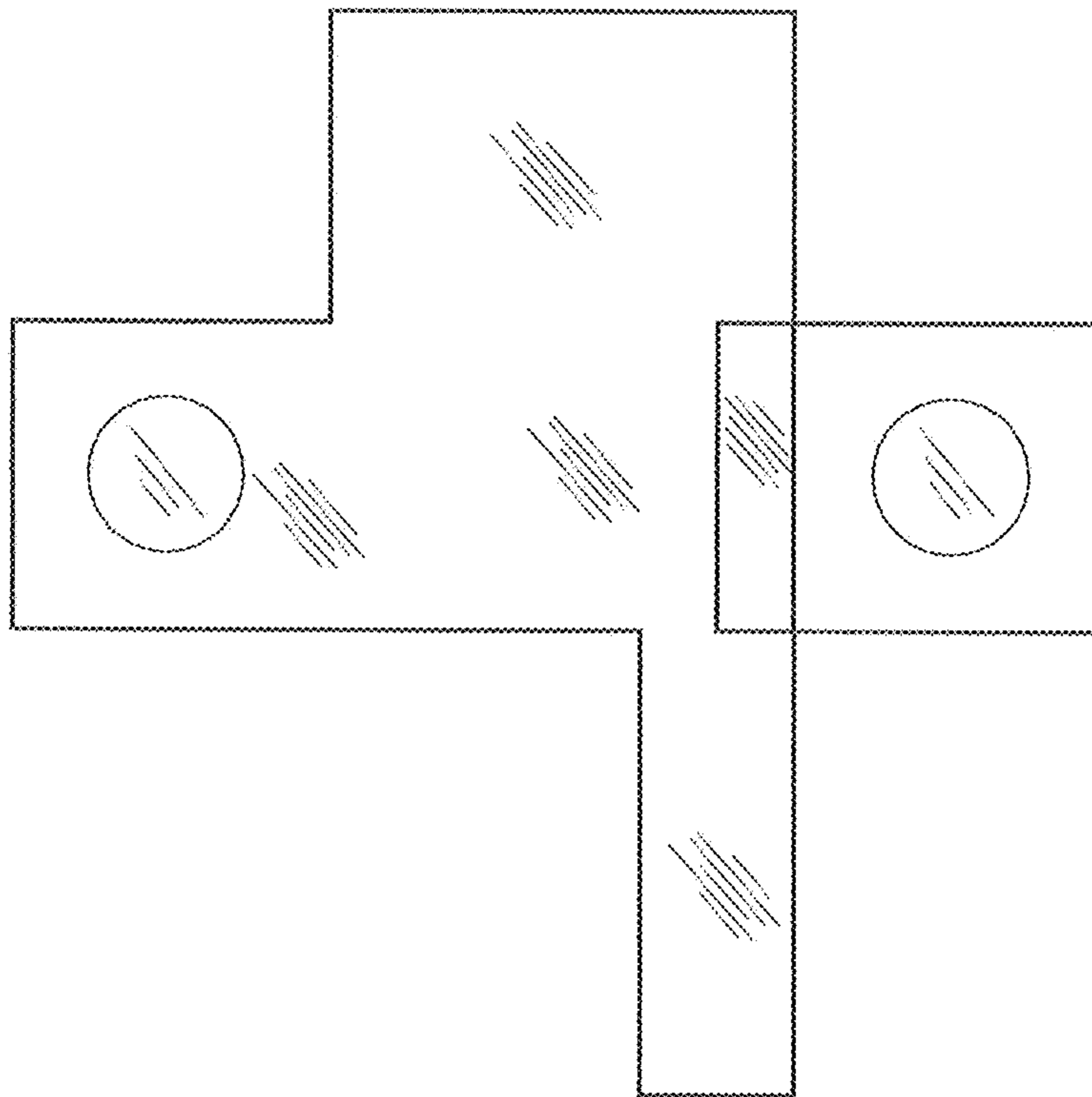

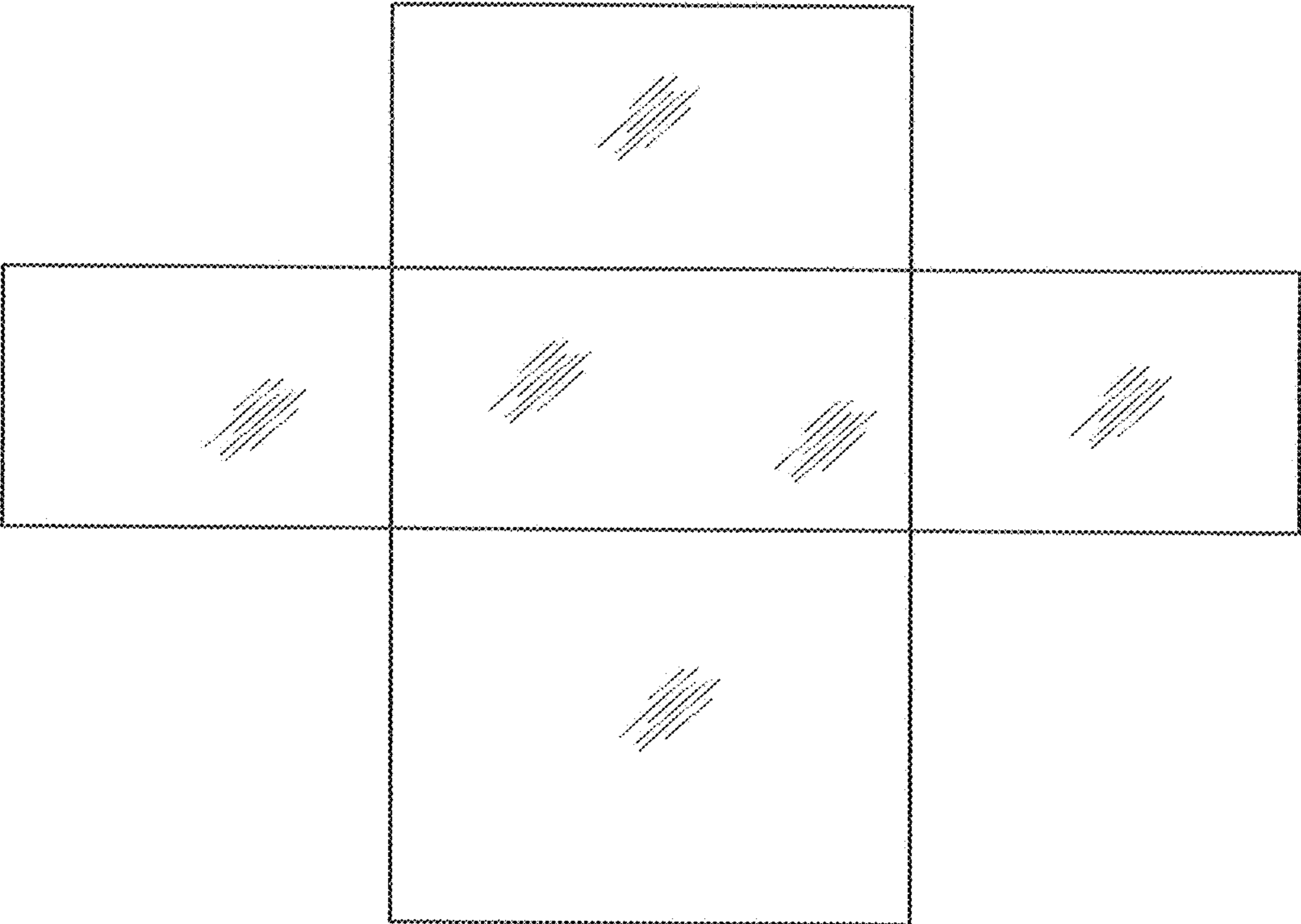

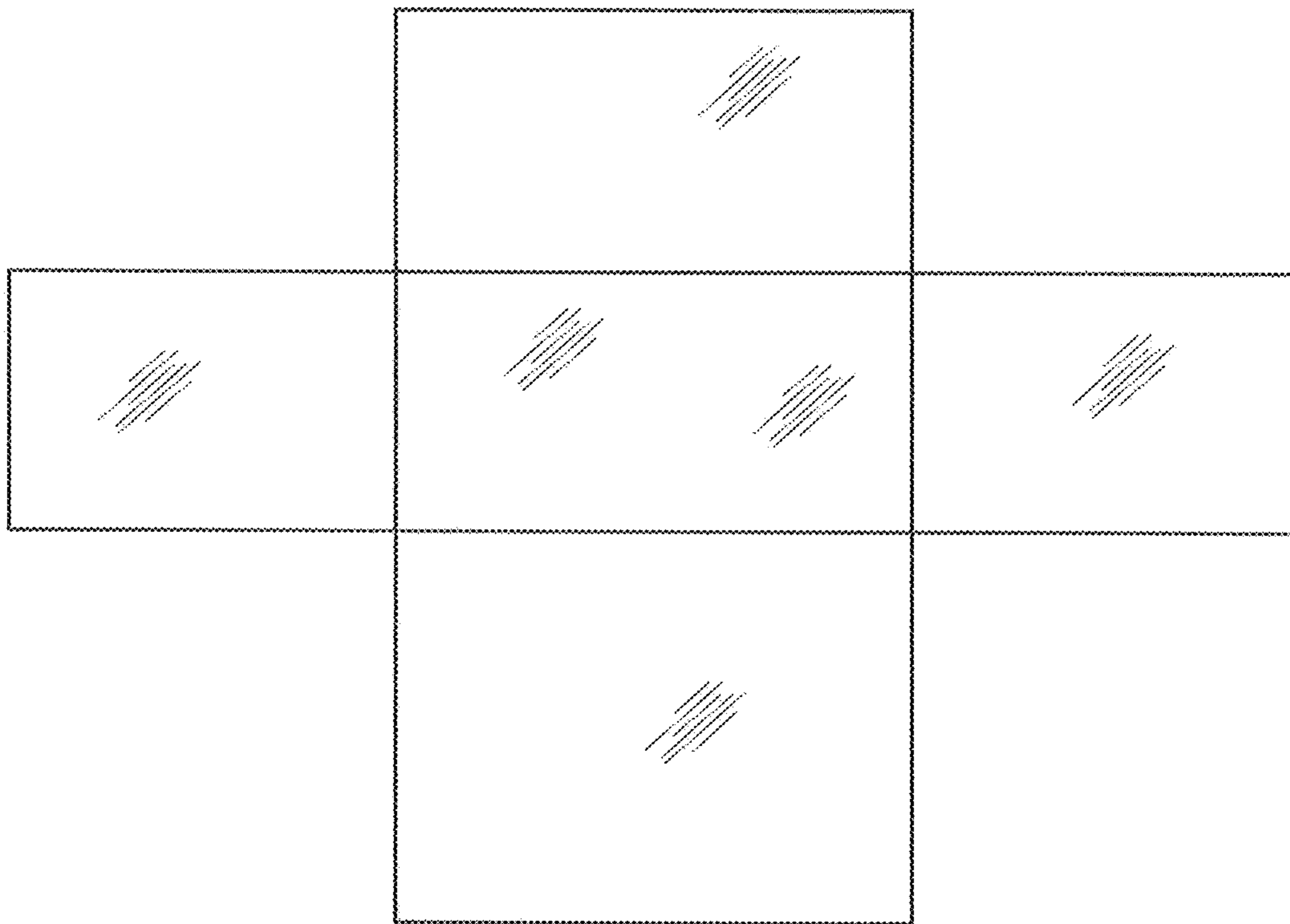

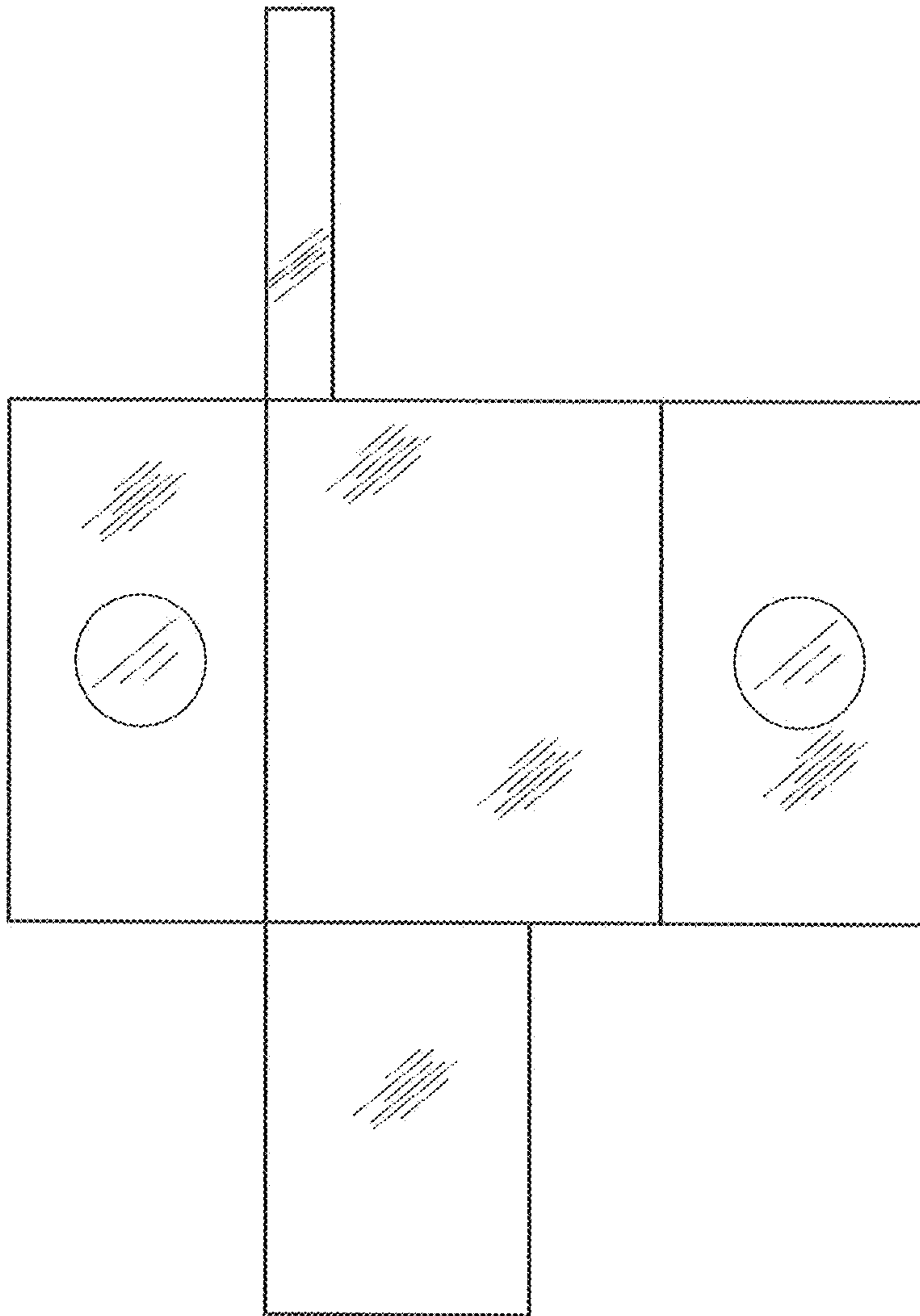

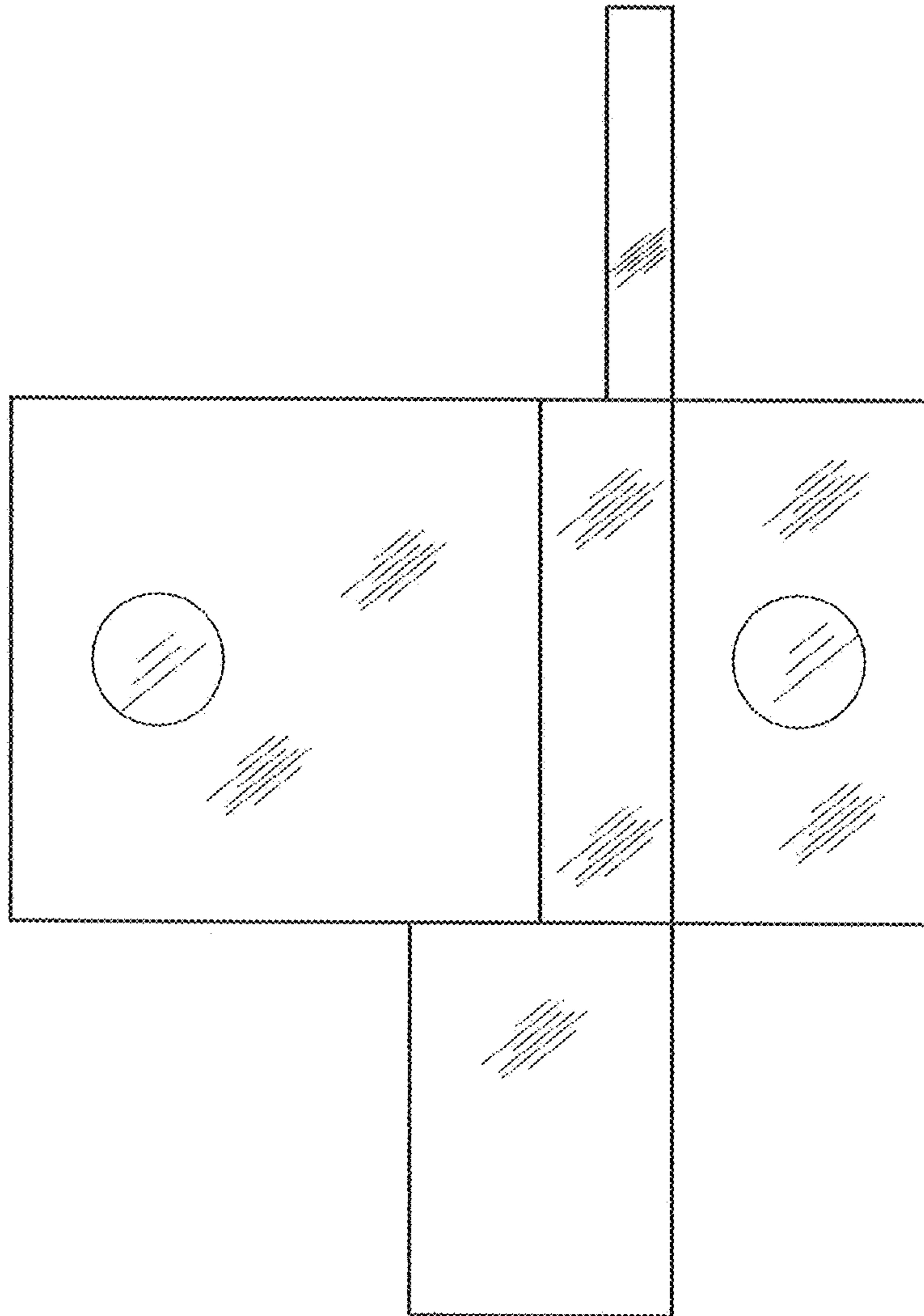
