1.2 is a front elevation view thereof;

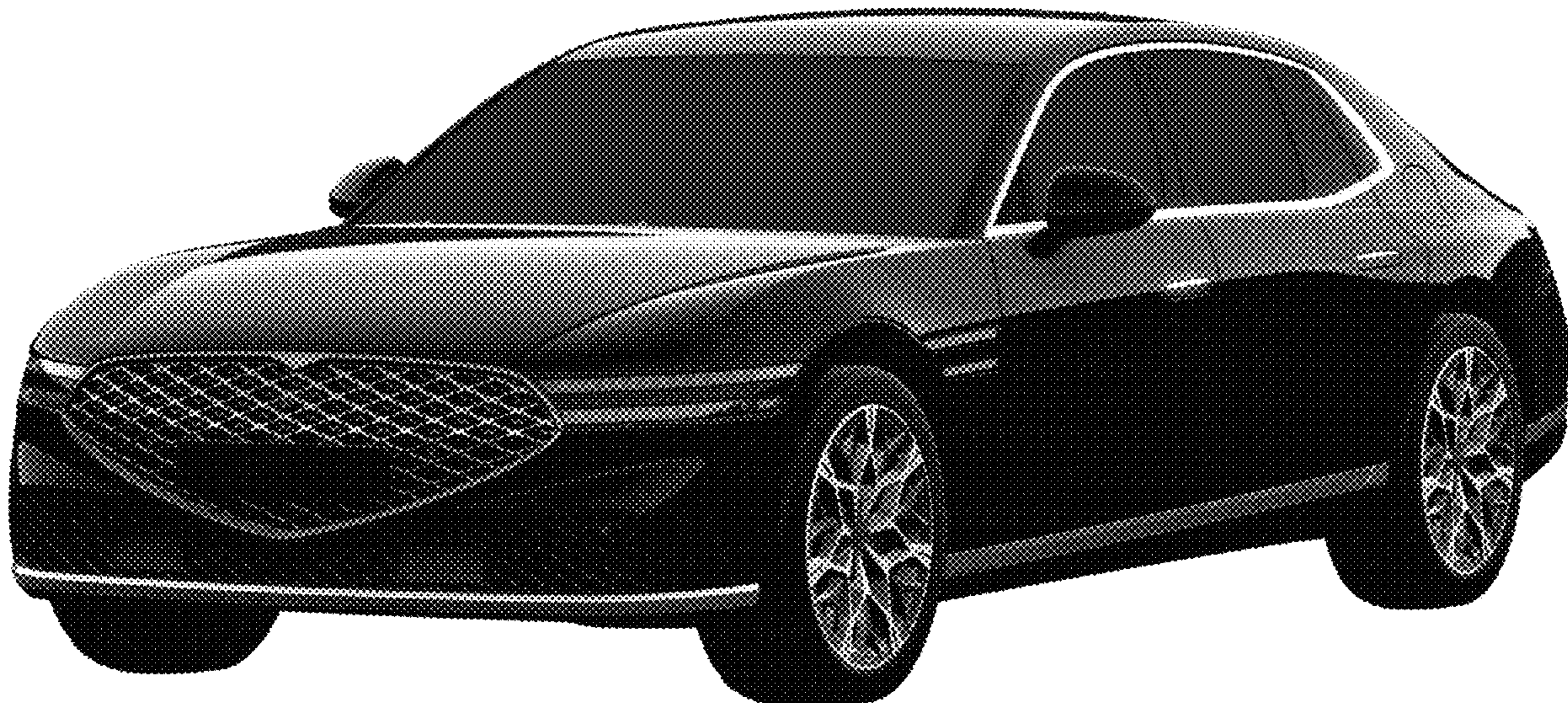
1.3 is a rear elevation view thereof;

1.4 is a right side elevation view thereof;

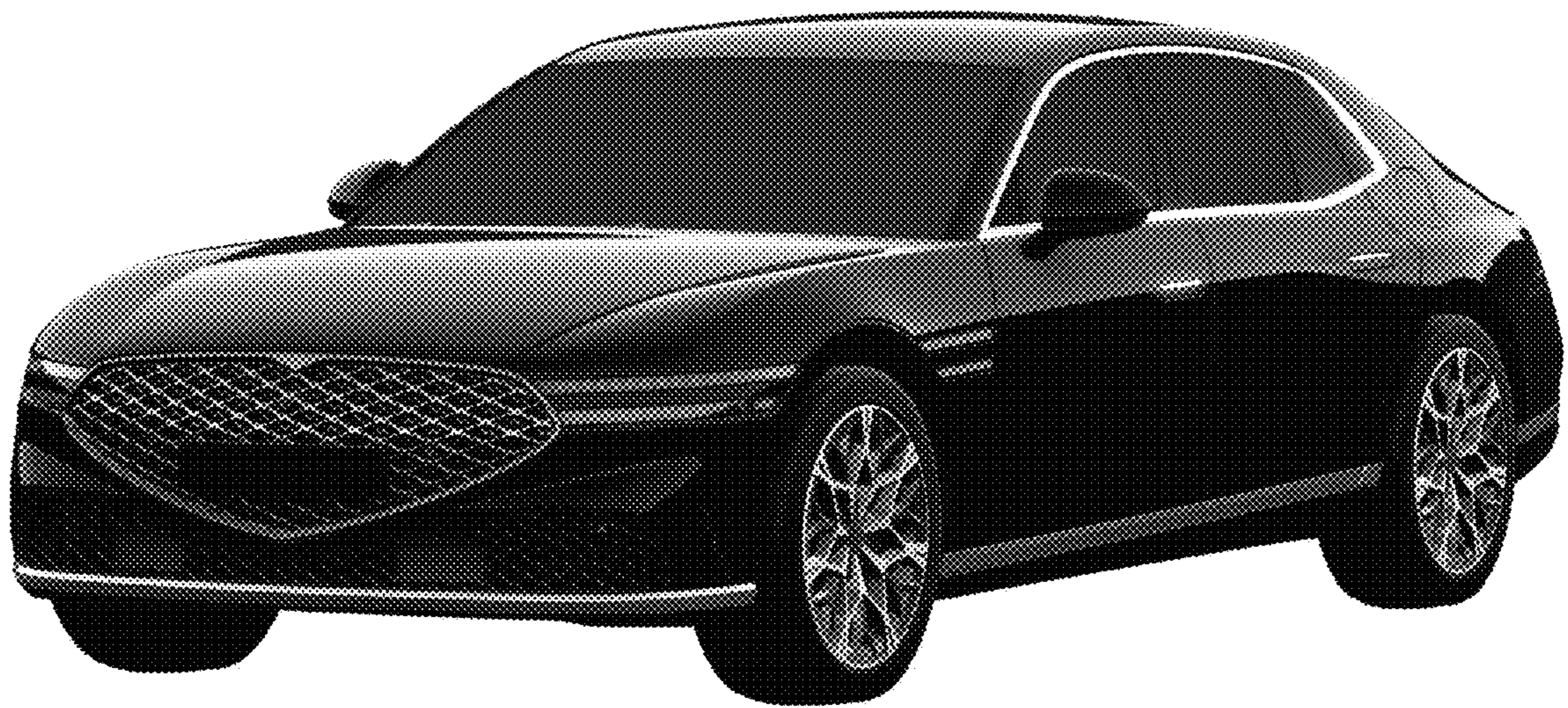
1.5 is a left side elevation view thereof;

1.6 is a top plan view thereof.

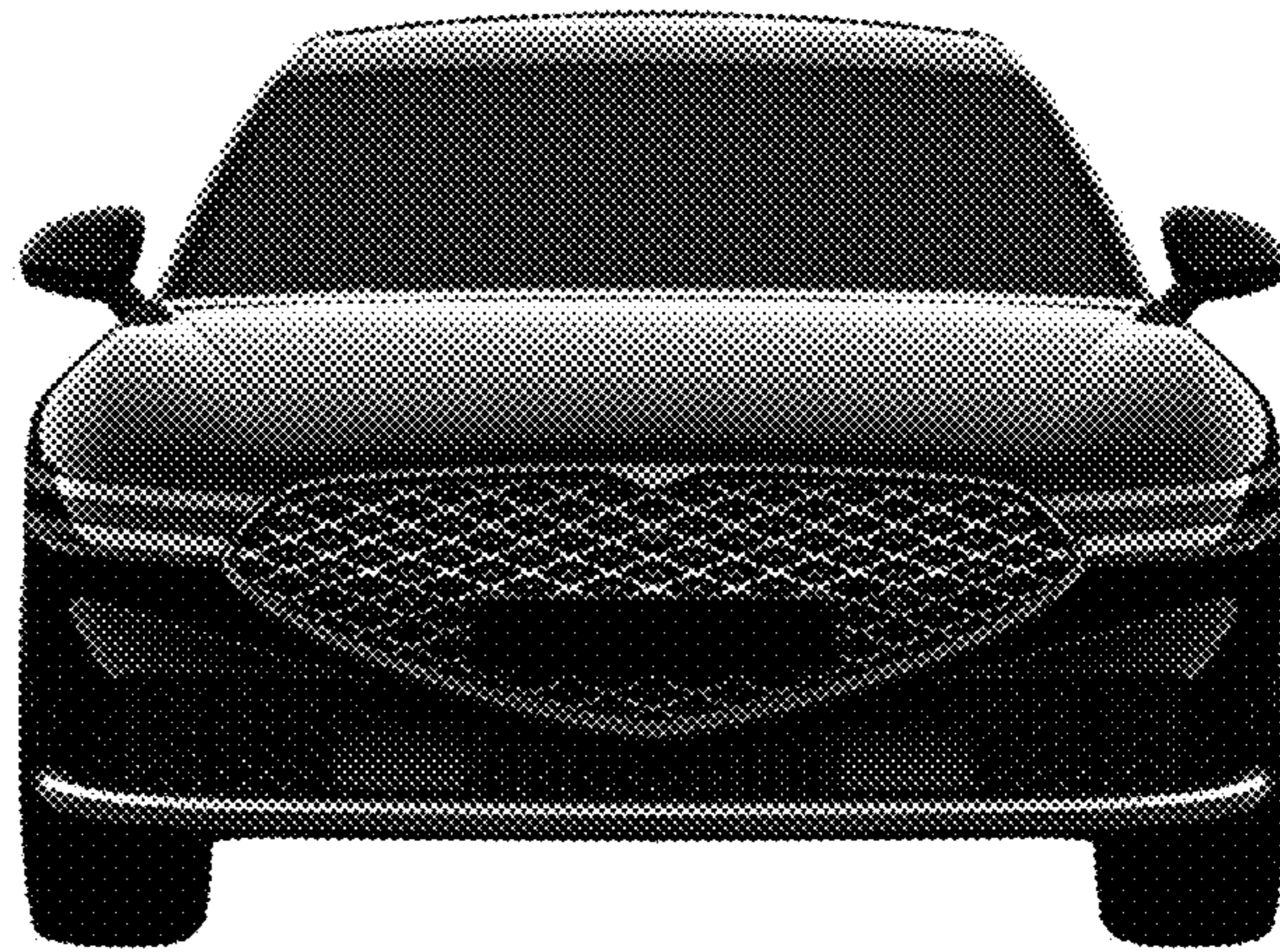

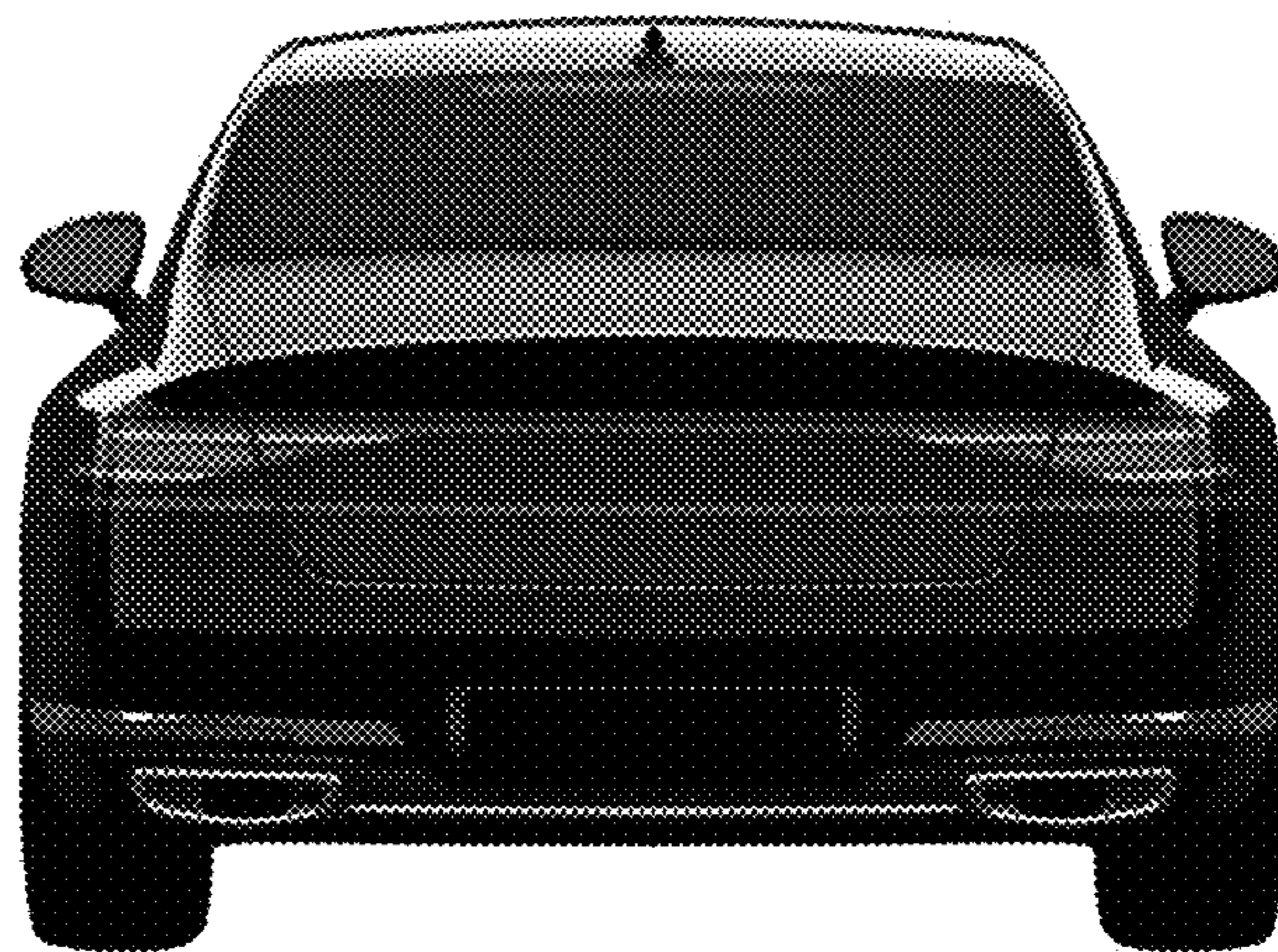
