The ornamental design for a vehicle front upper bumper cover, as shown and described.

FIG. 4 is a top plan view thereof;

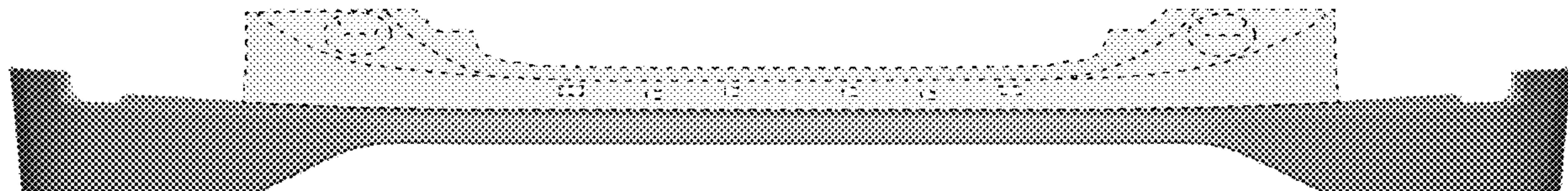
FIG. 5 is a bottom plan view thereof;

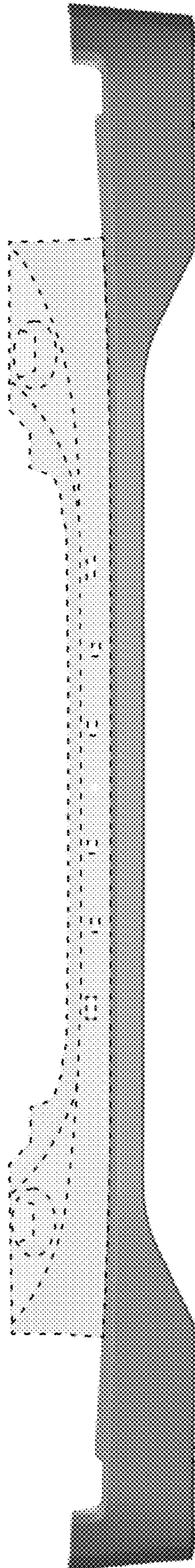

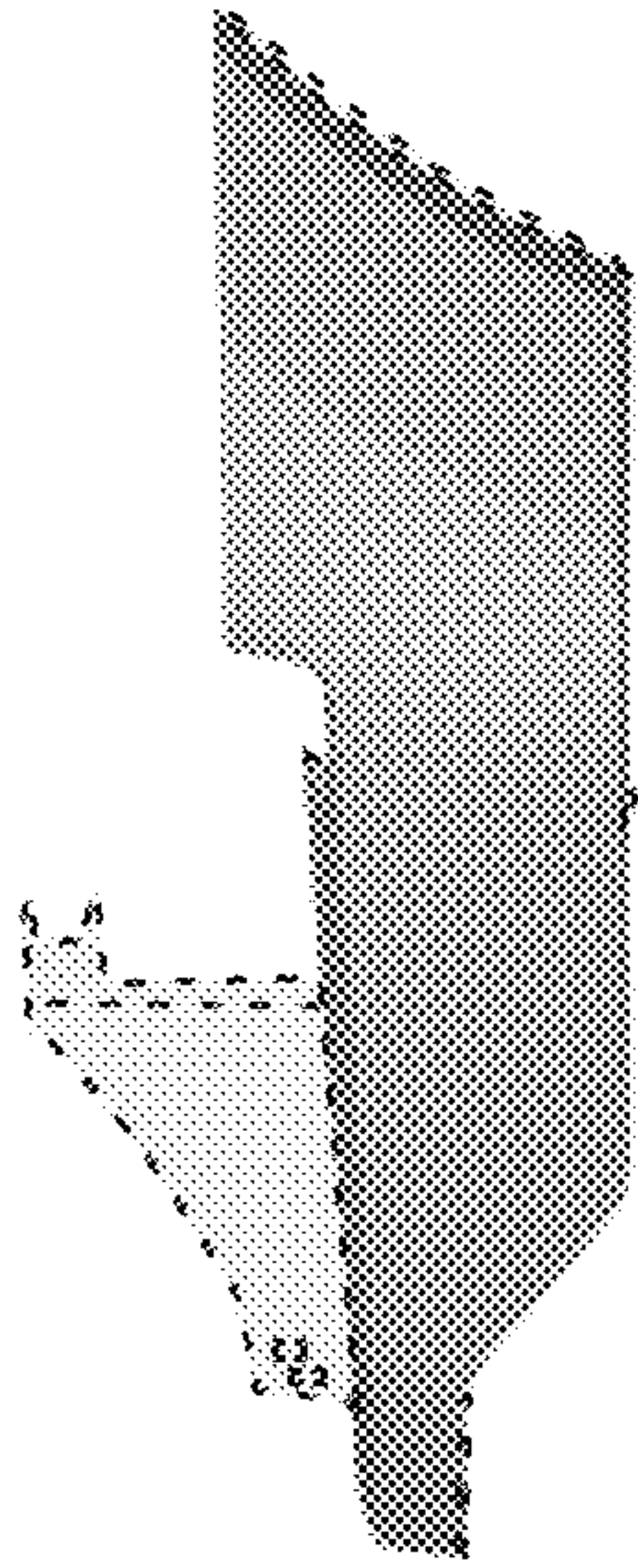

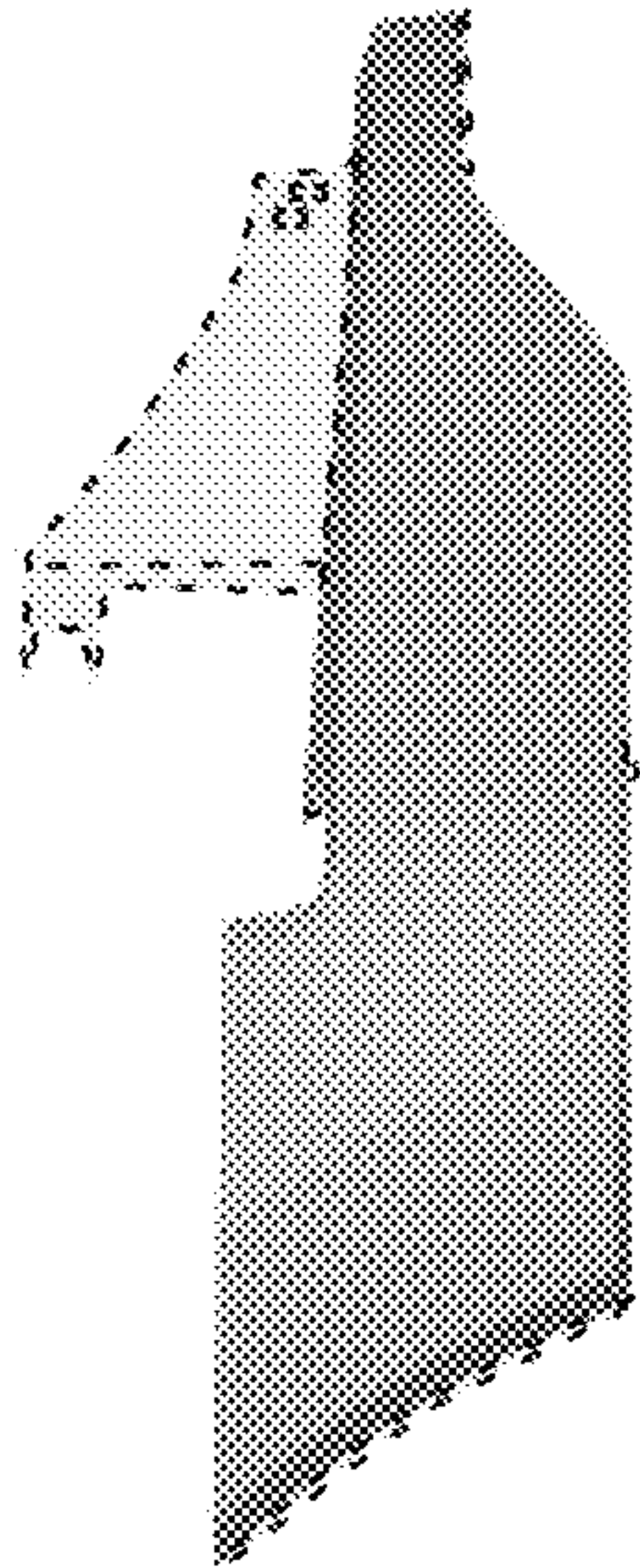

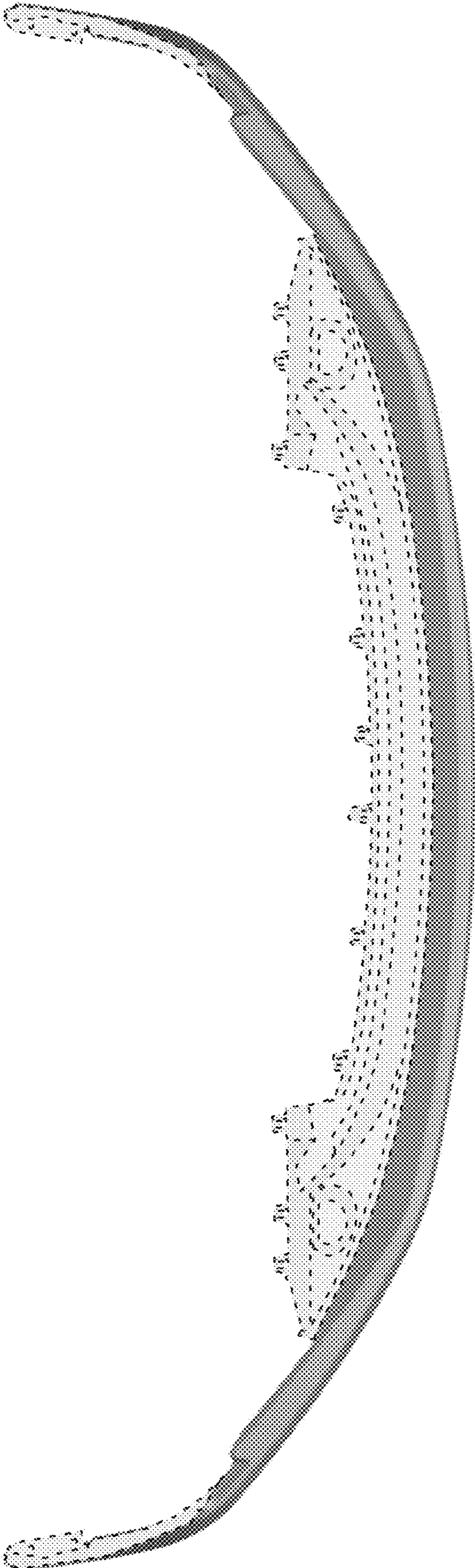

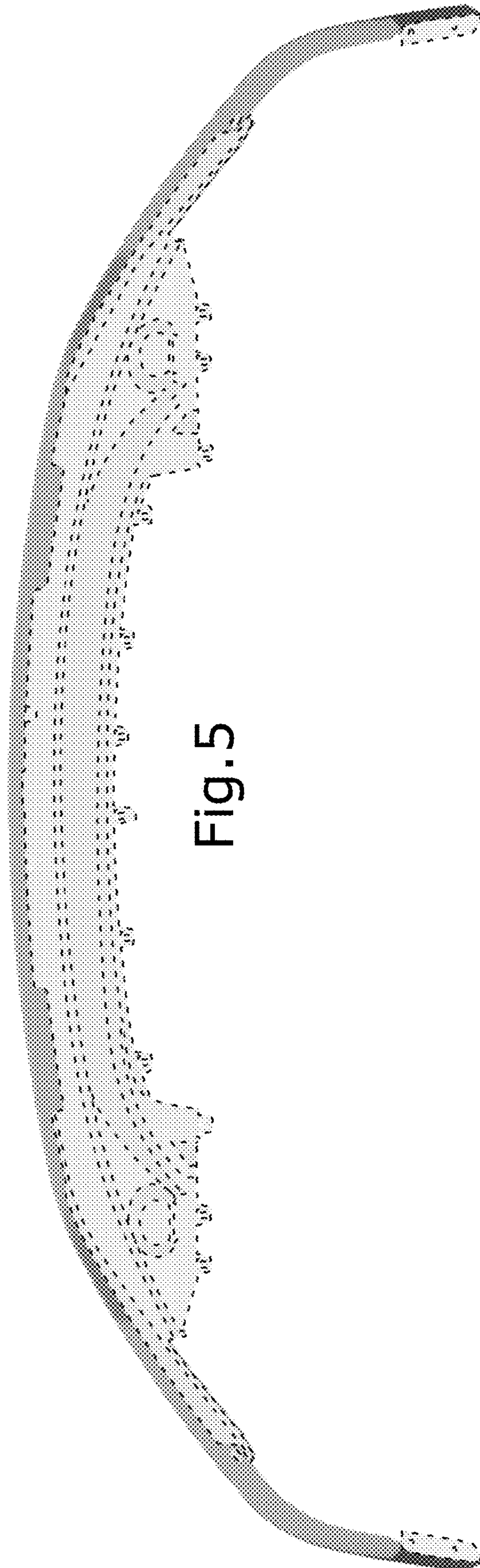

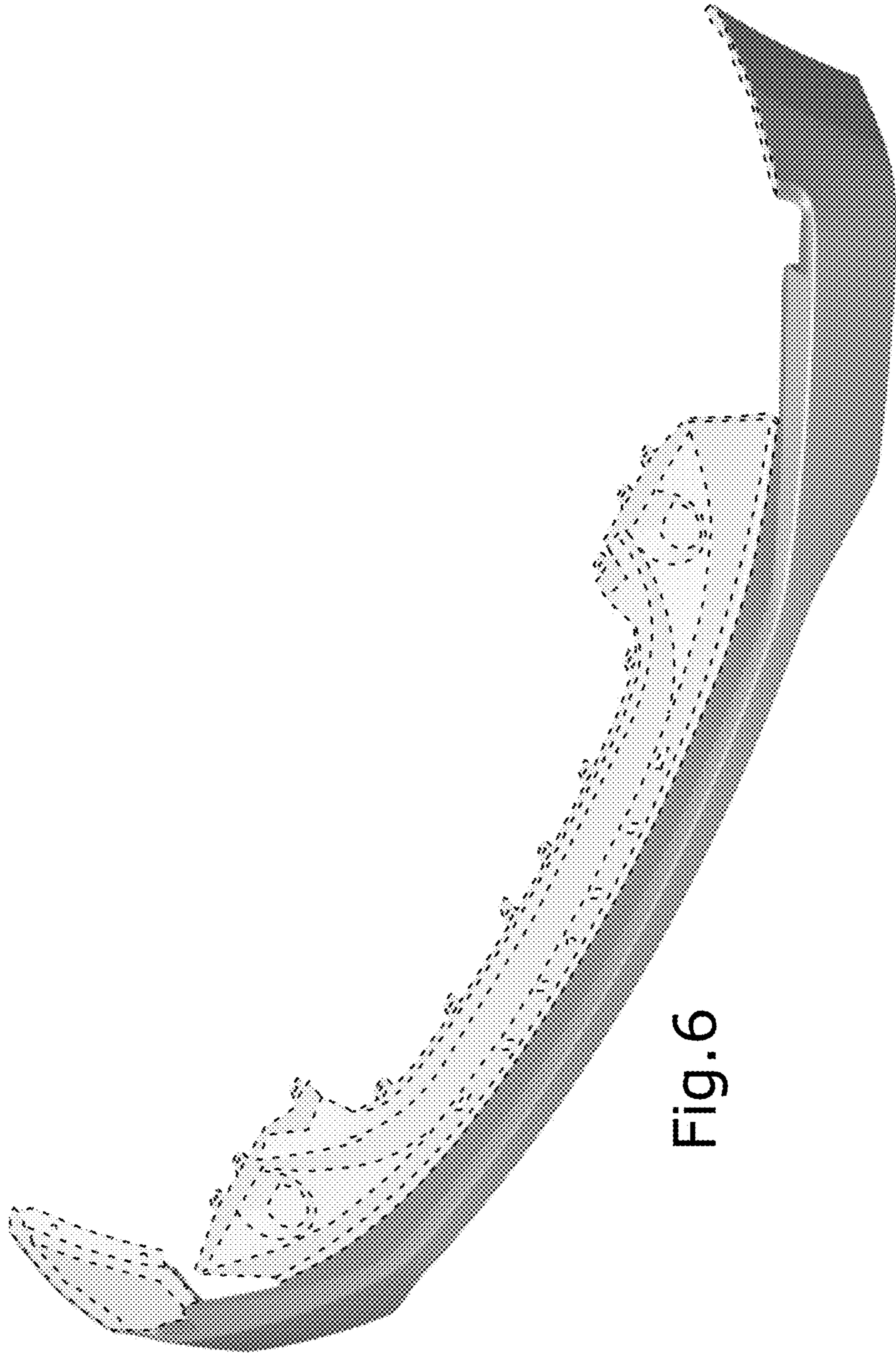

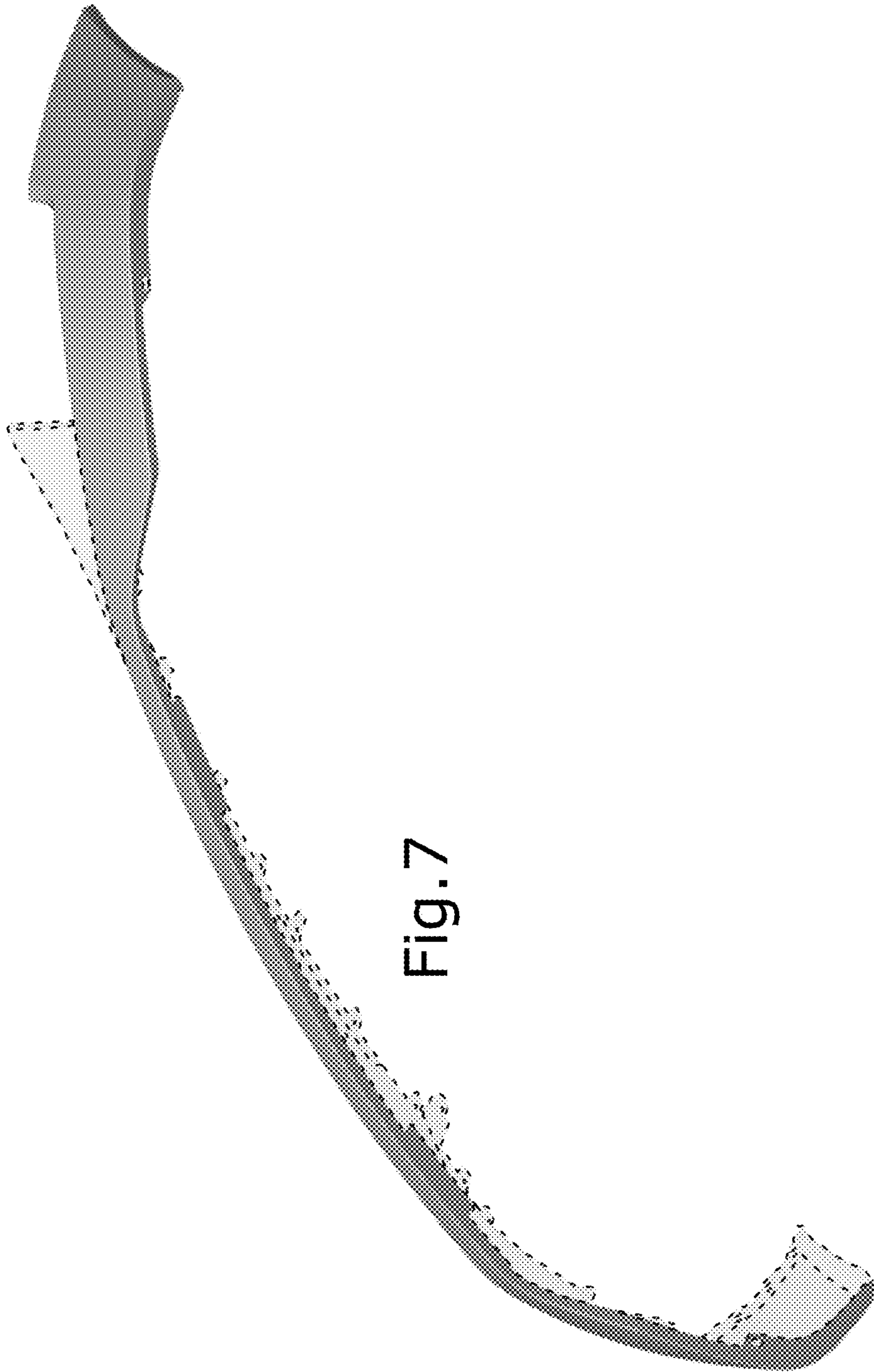
