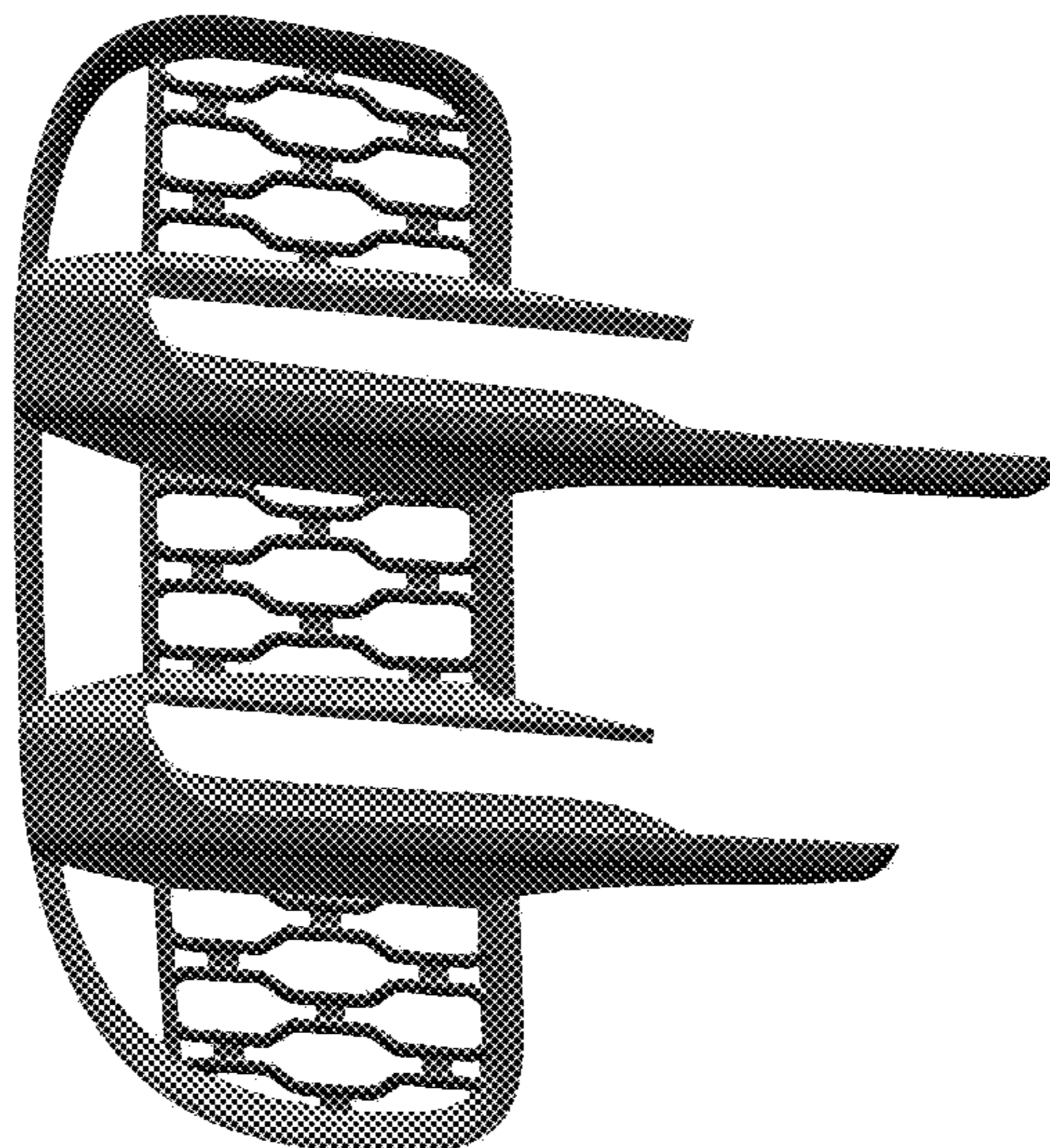
FIG. 1 is a front left elevated perspective view of a vehicle side grille;

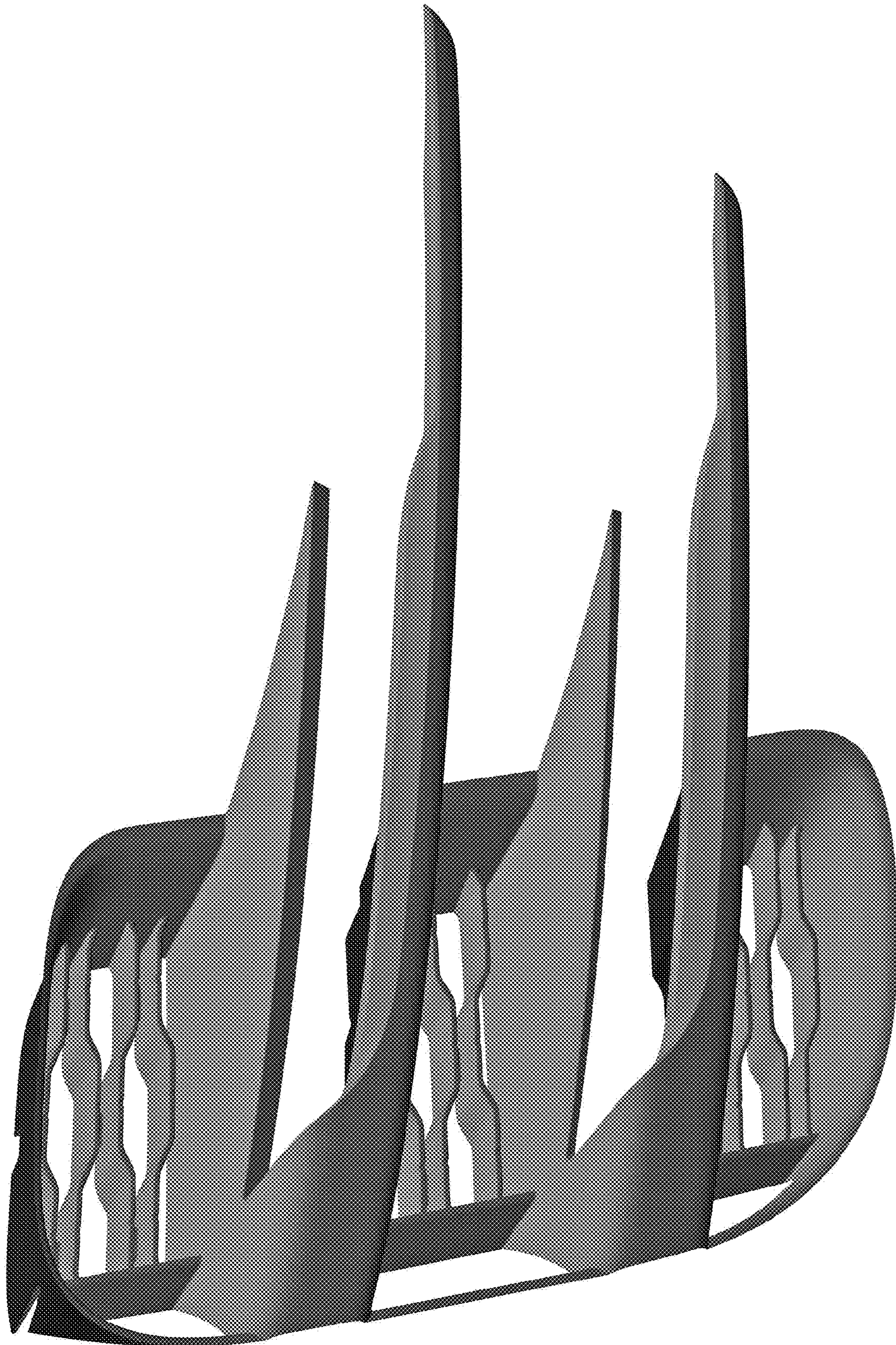

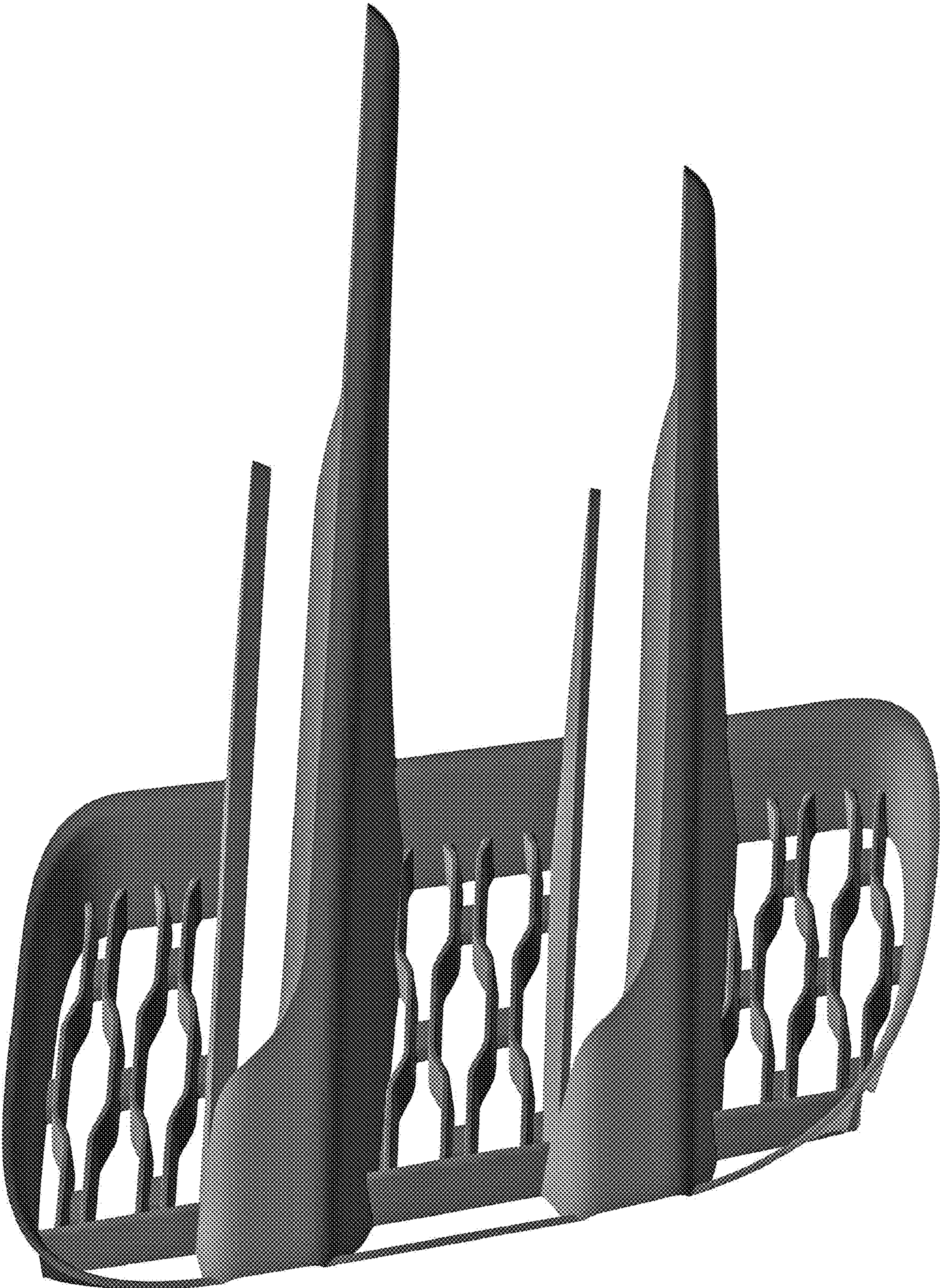

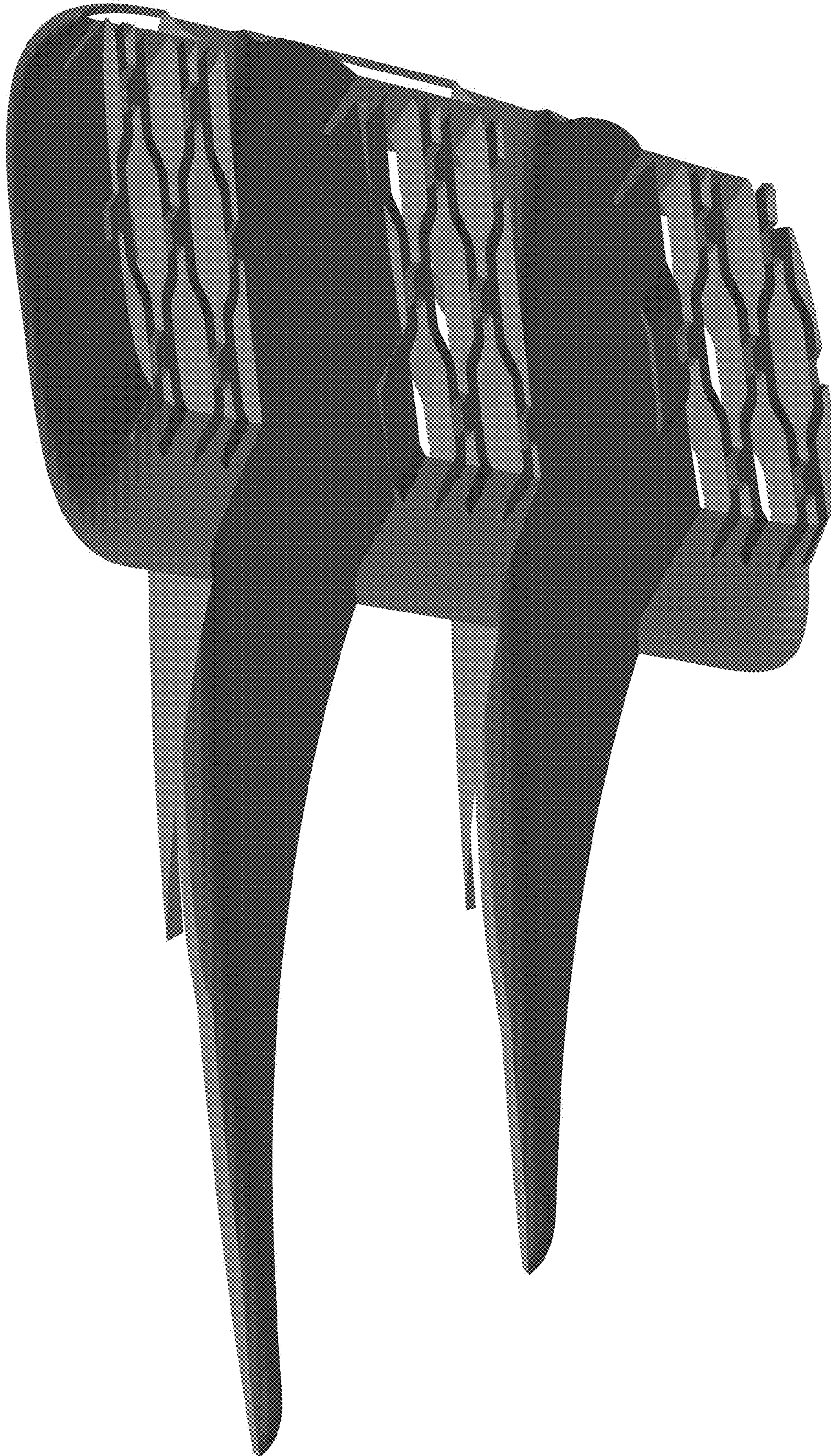

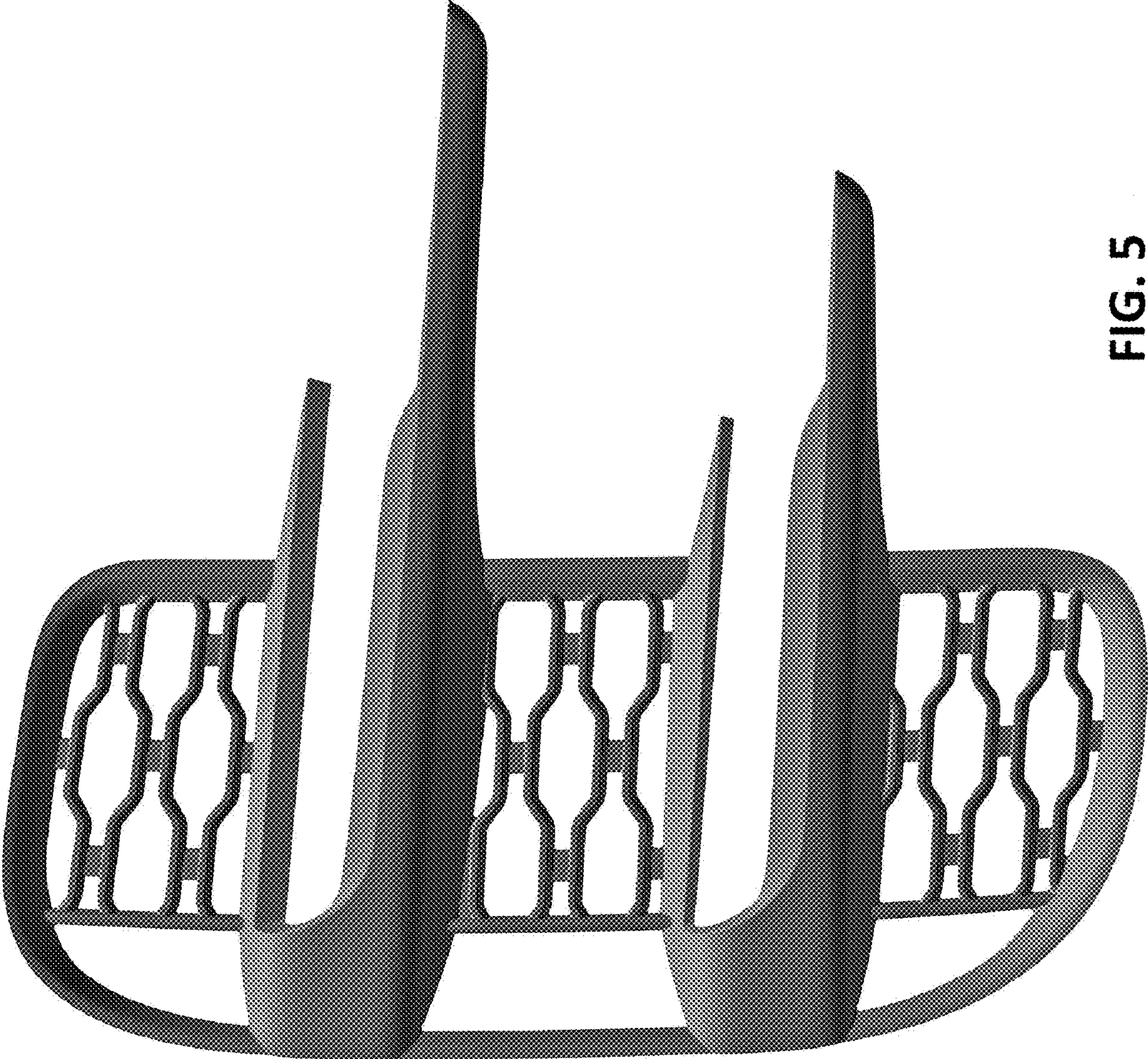

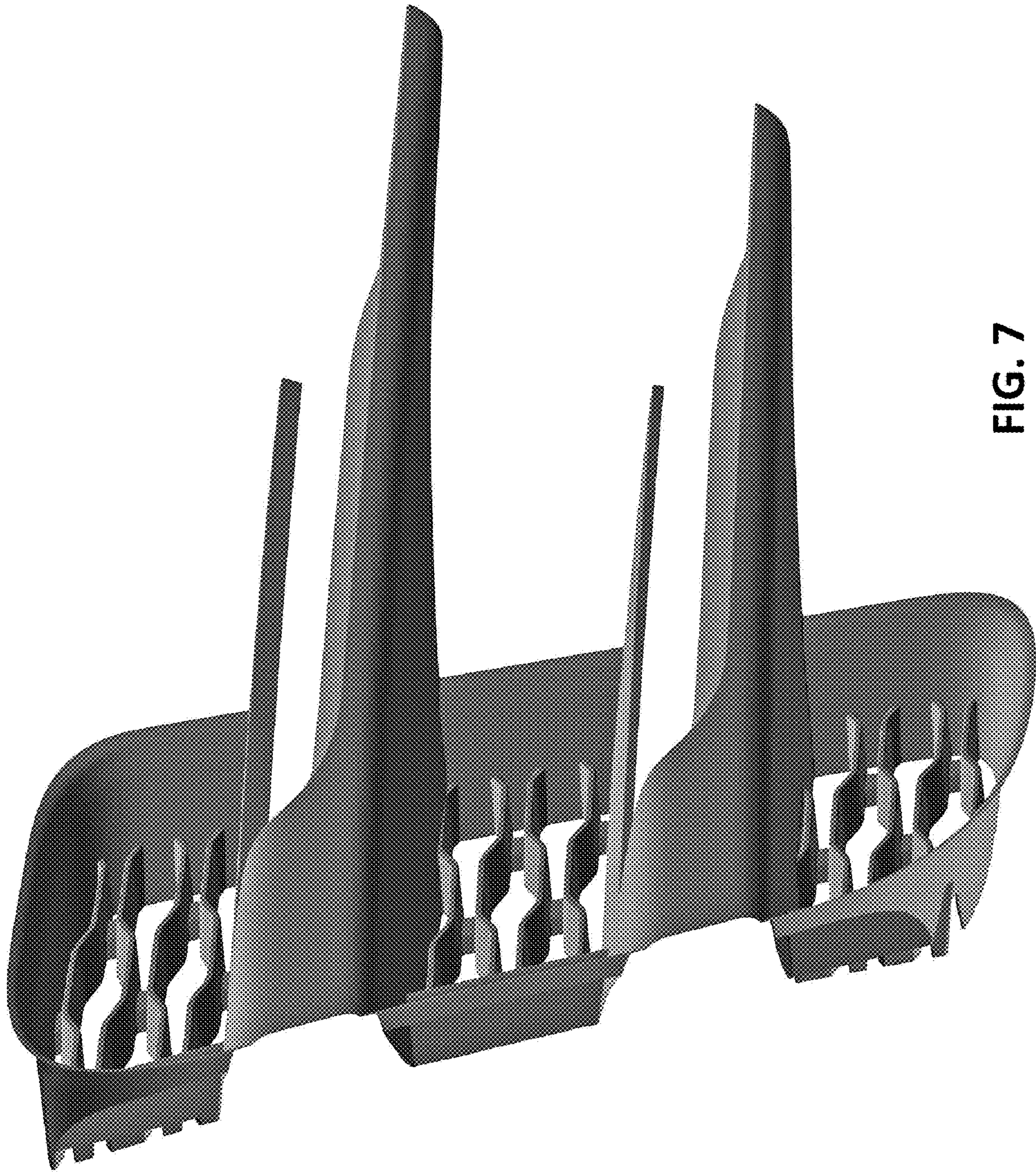

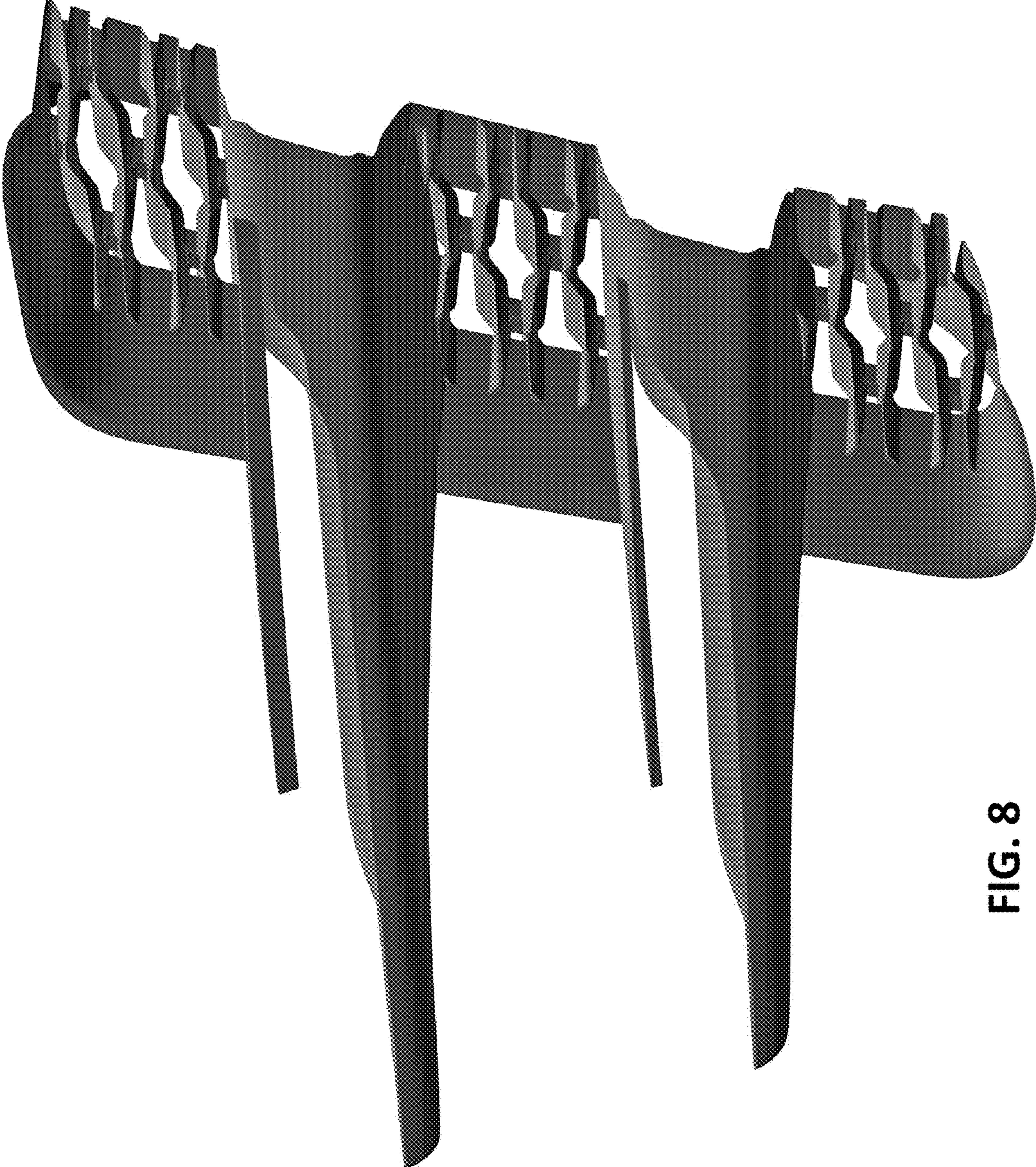

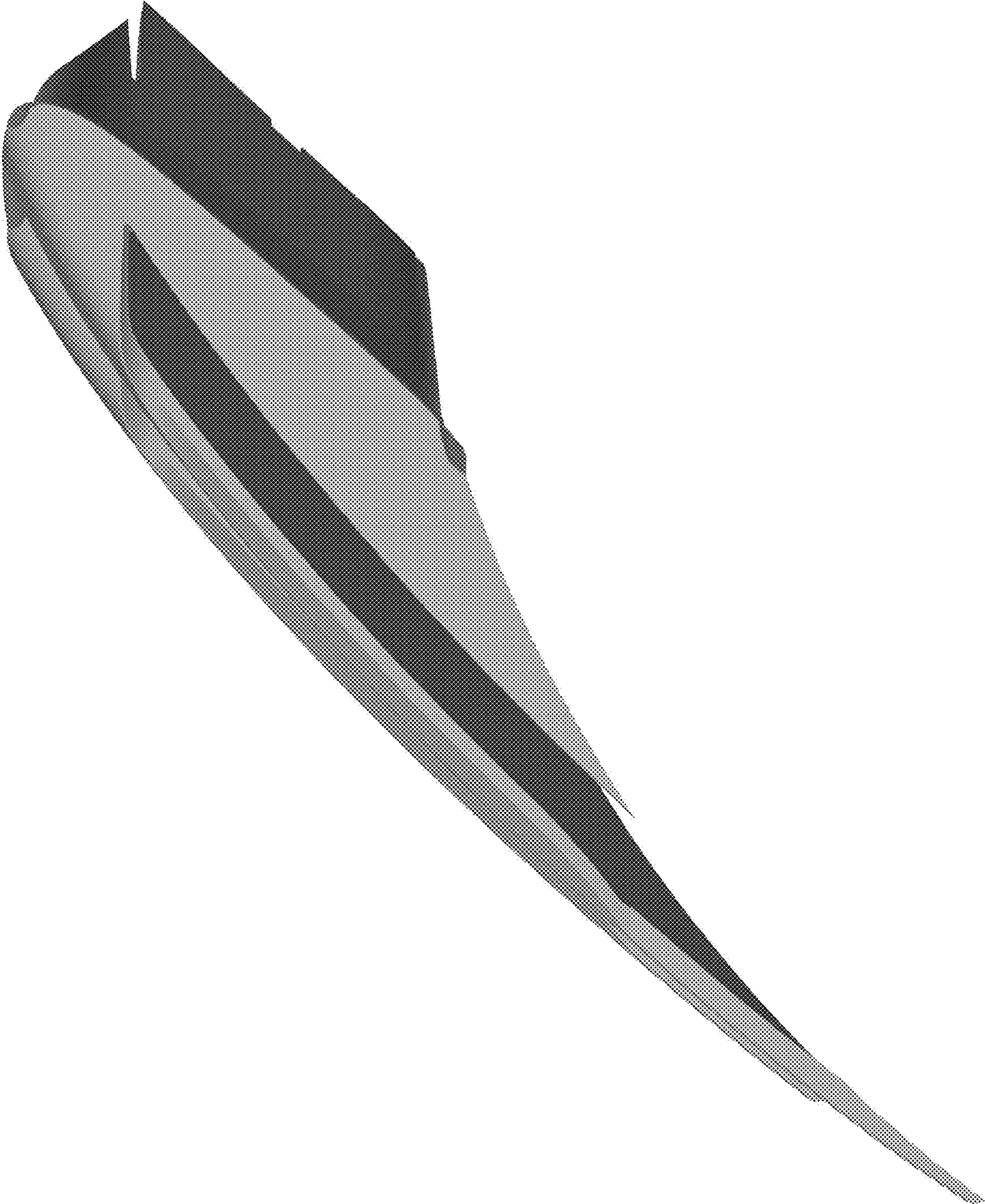

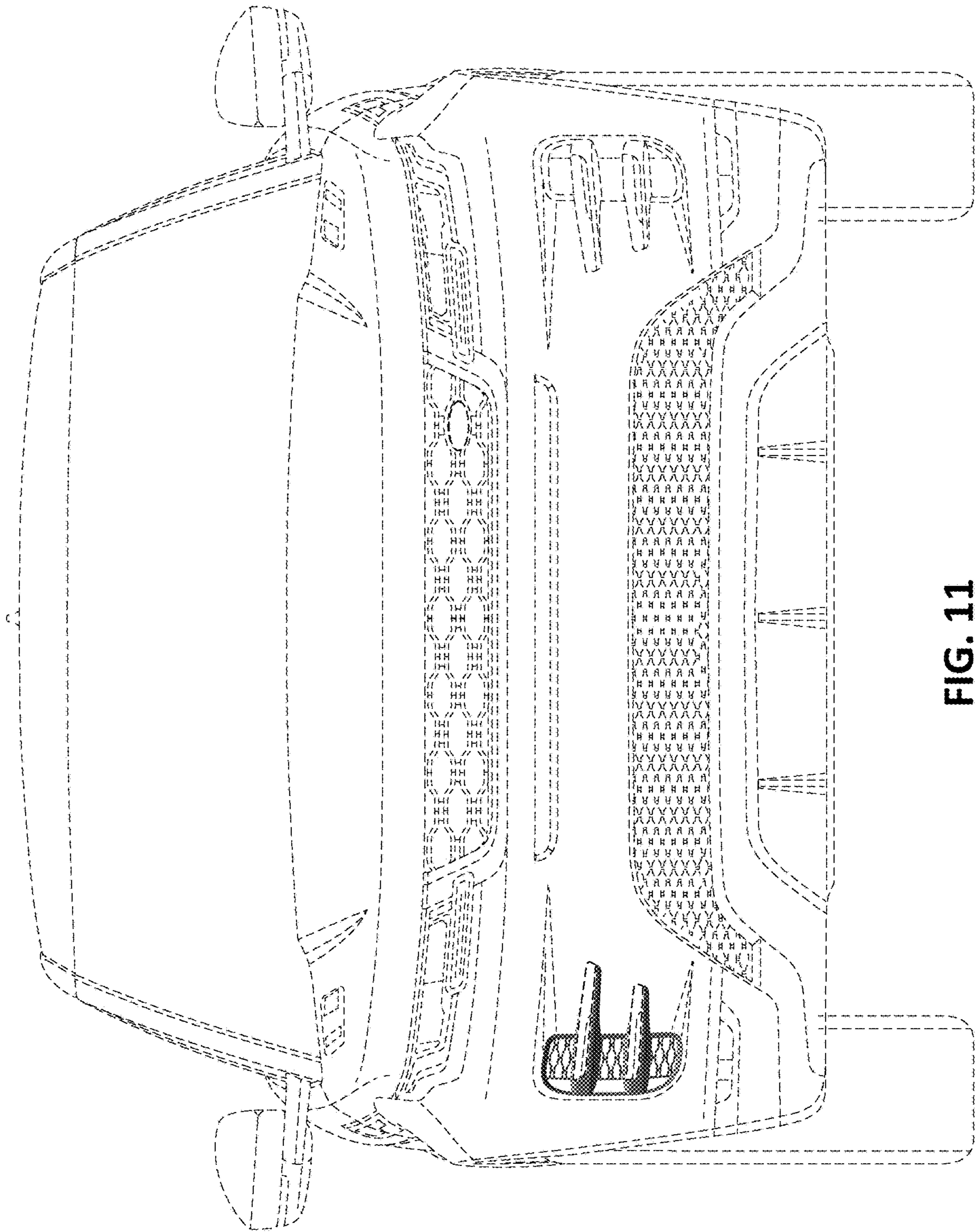
