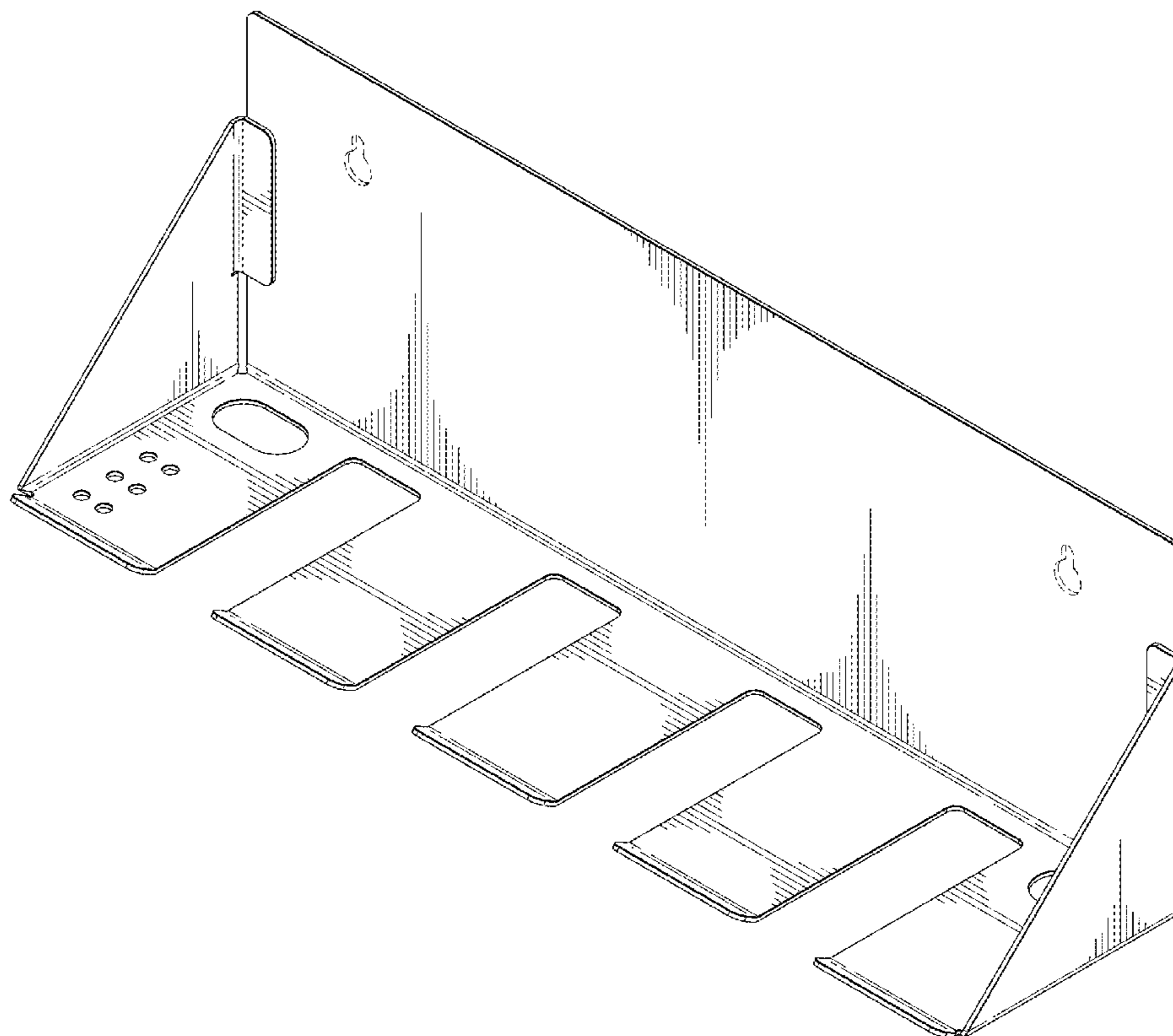
(57) **CLAIM**

The ornamental design for a battery charging station, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top, right, perspective view of a battery charging station showing the new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is a bottom, rear, left, perspective view thereof. The broken lines shown represent the portions of the battery charging station that form no part of the claimed design.

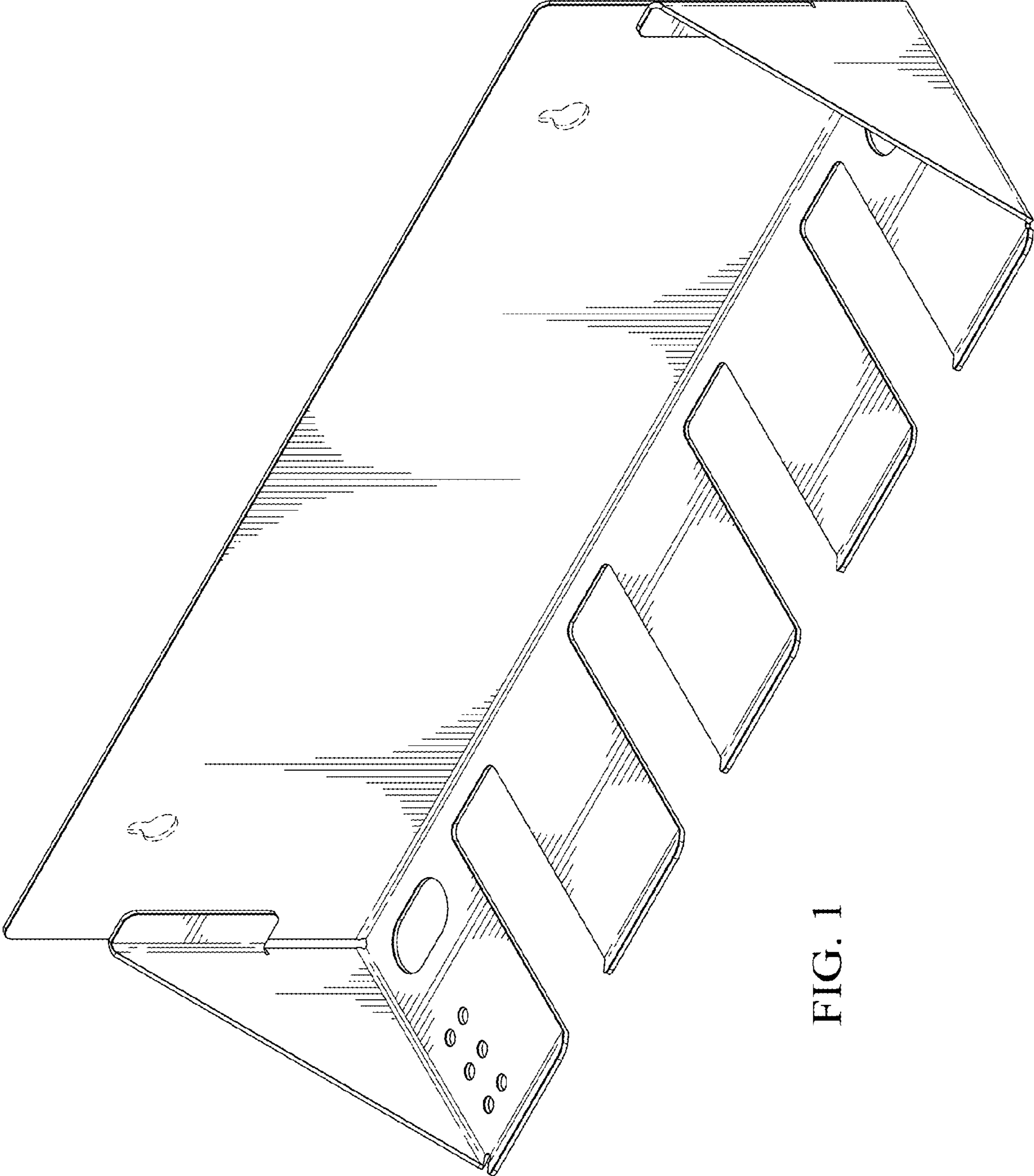

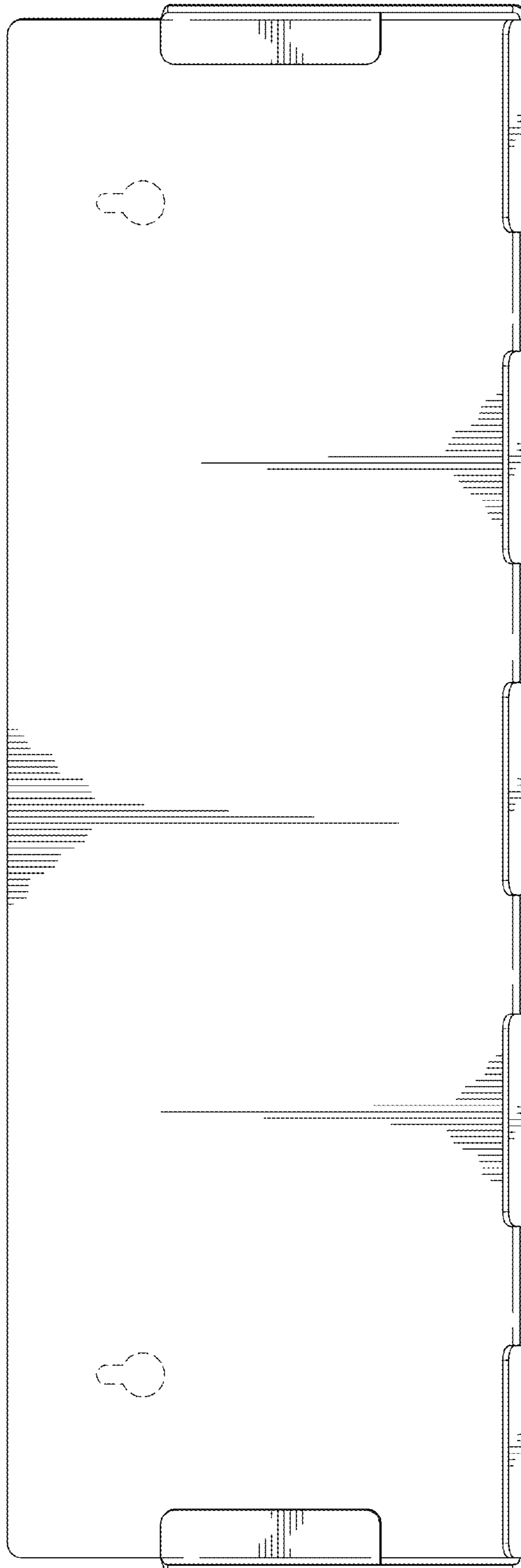

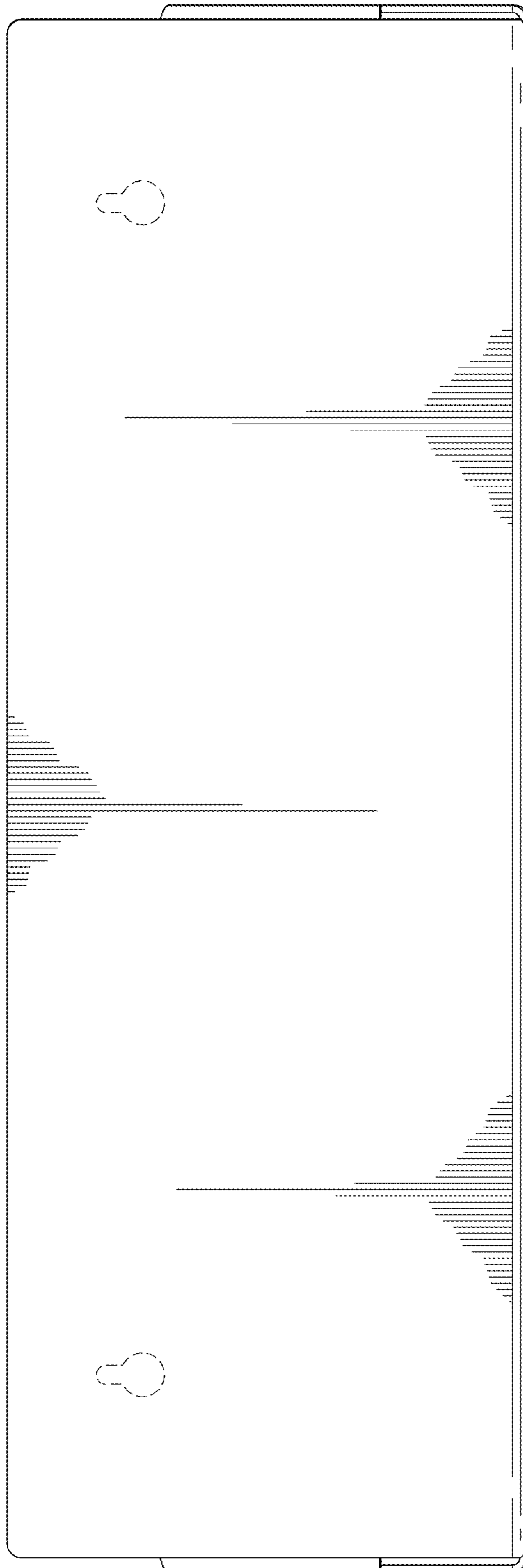

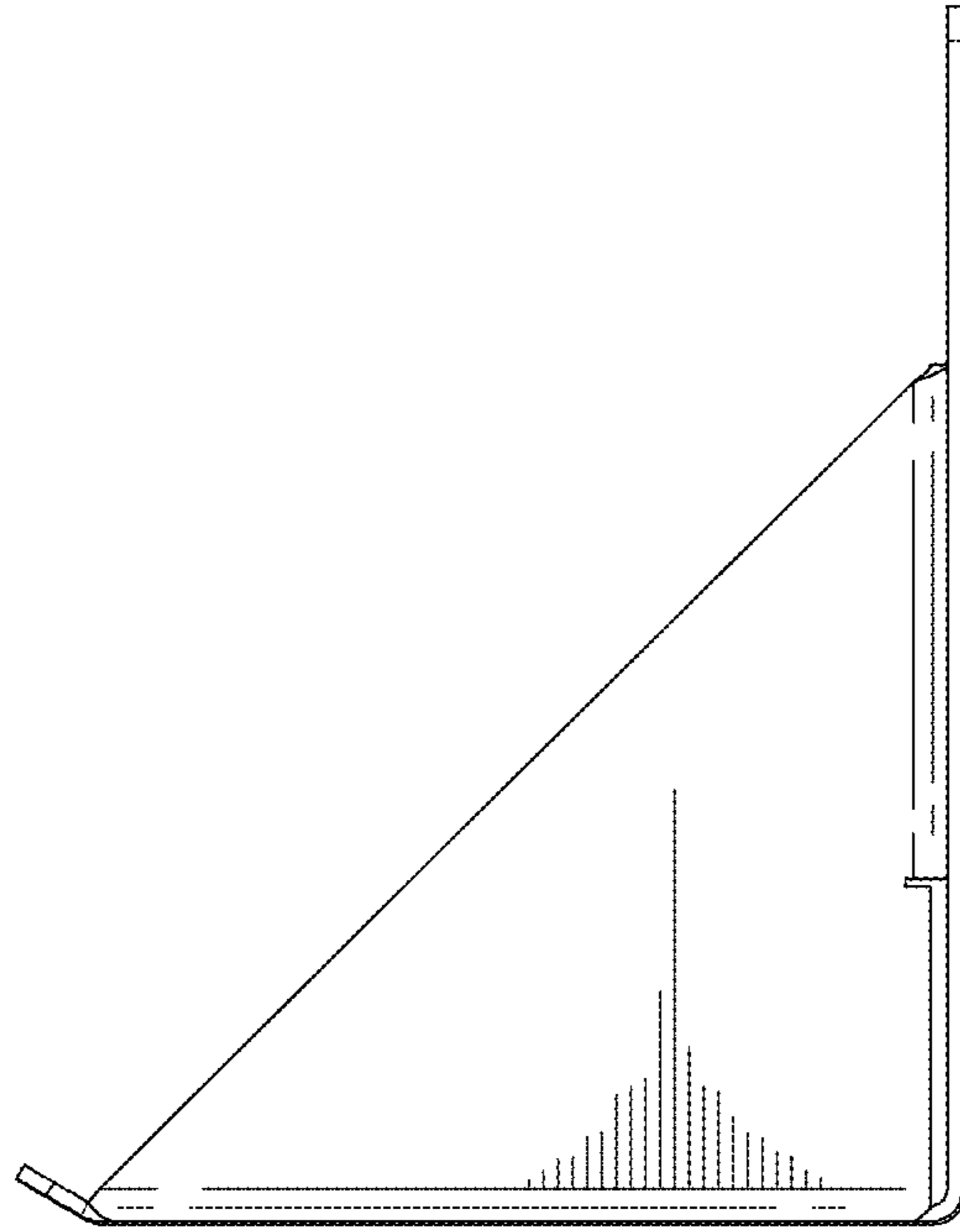

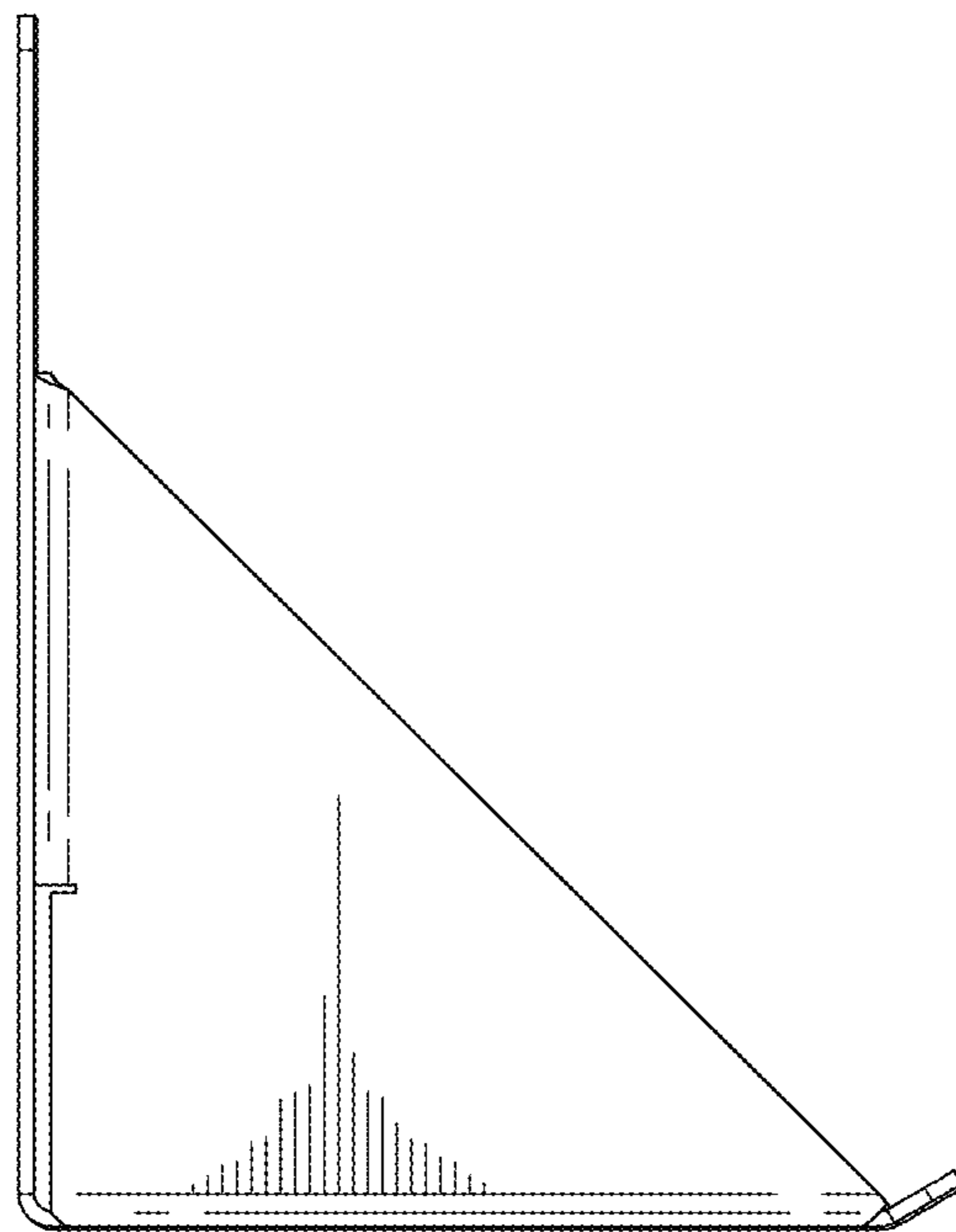

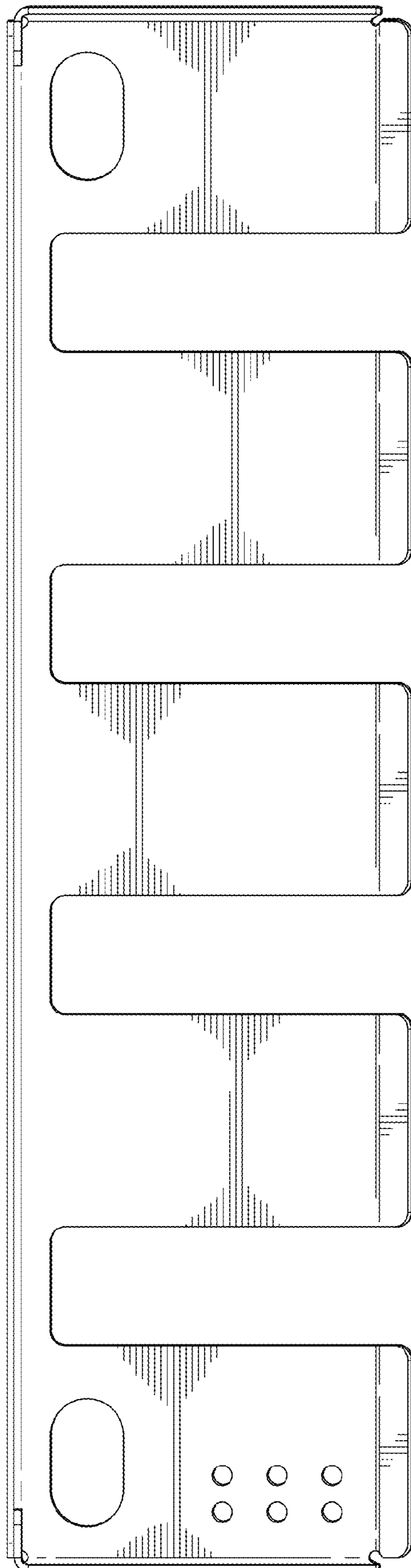

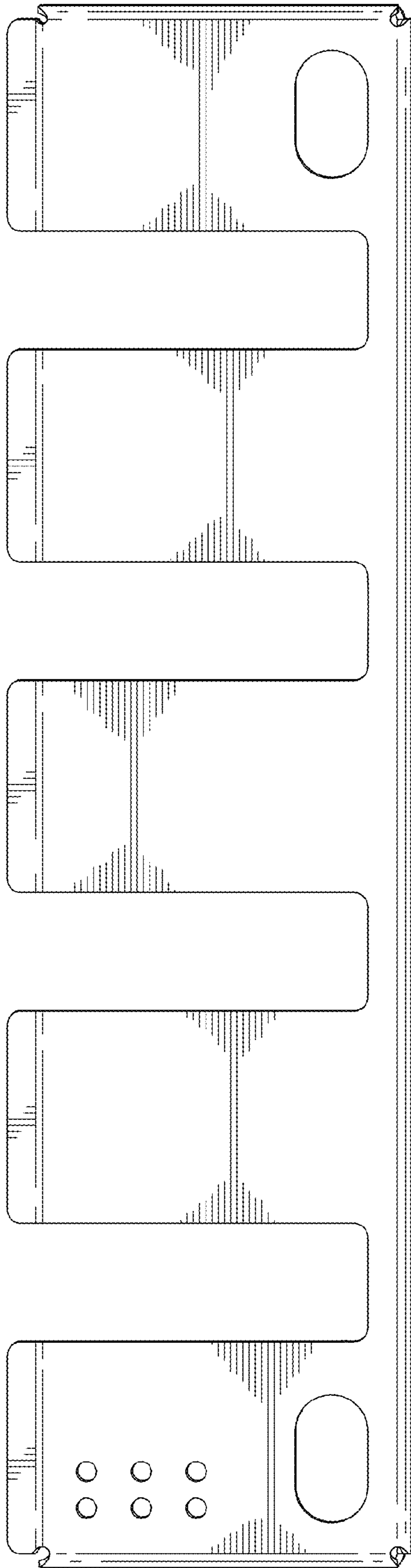

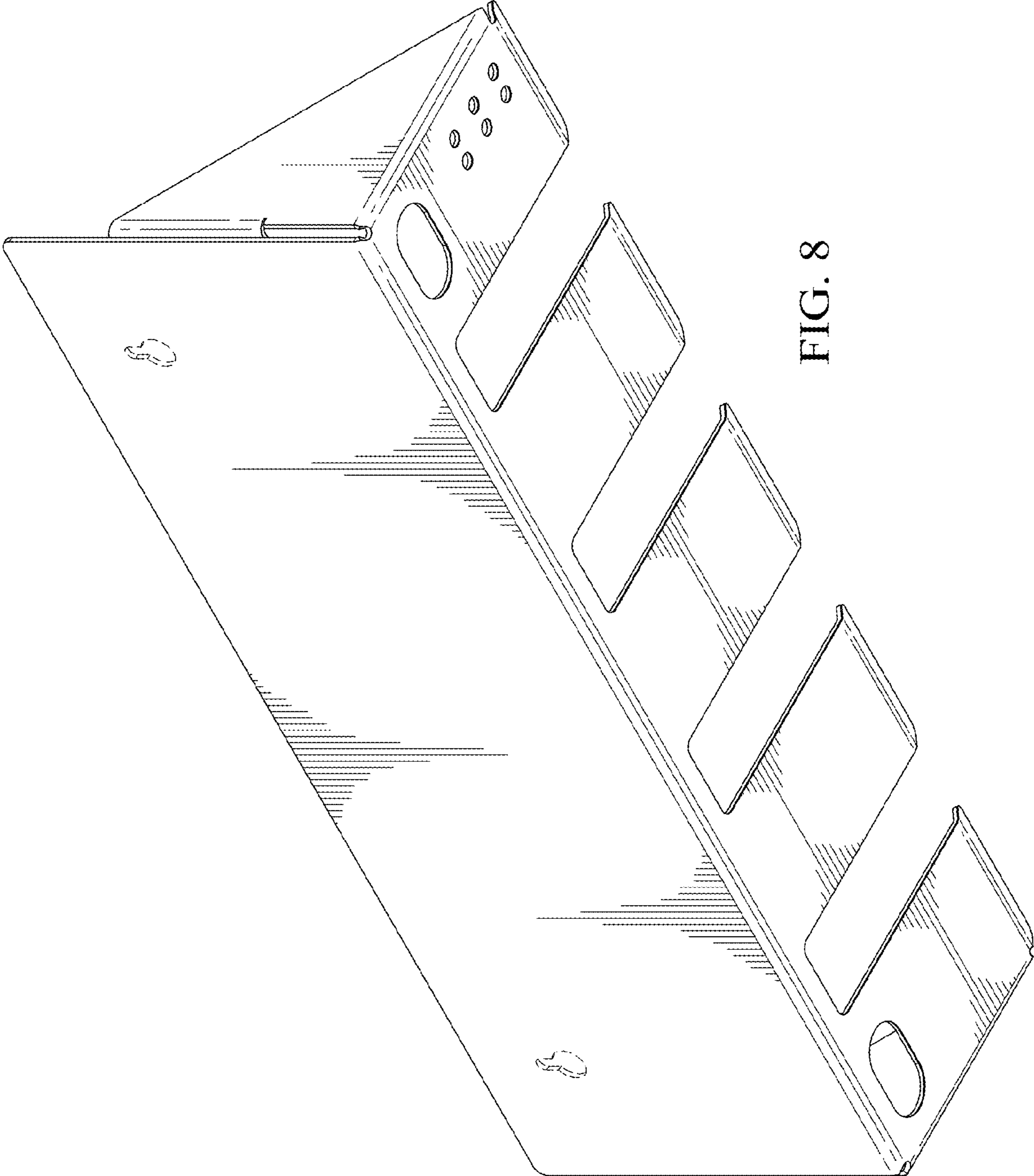
