FIG. 1 is a front view of a display screen or a portion thereof with a graphical user interface;

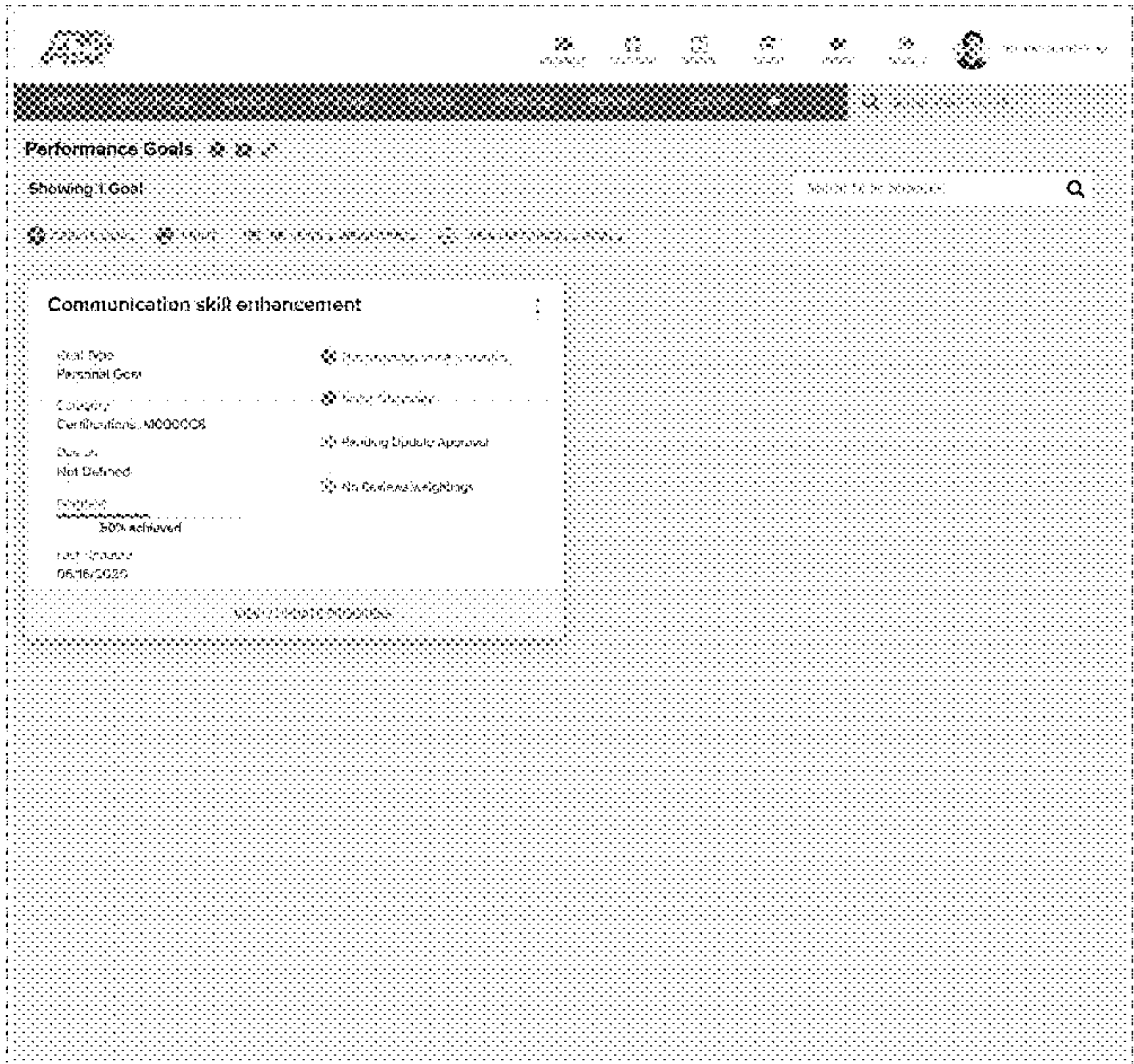
FIG. 2 is a front view of a second embodiment of a display screen or a portion thereof with a graphical user interface;

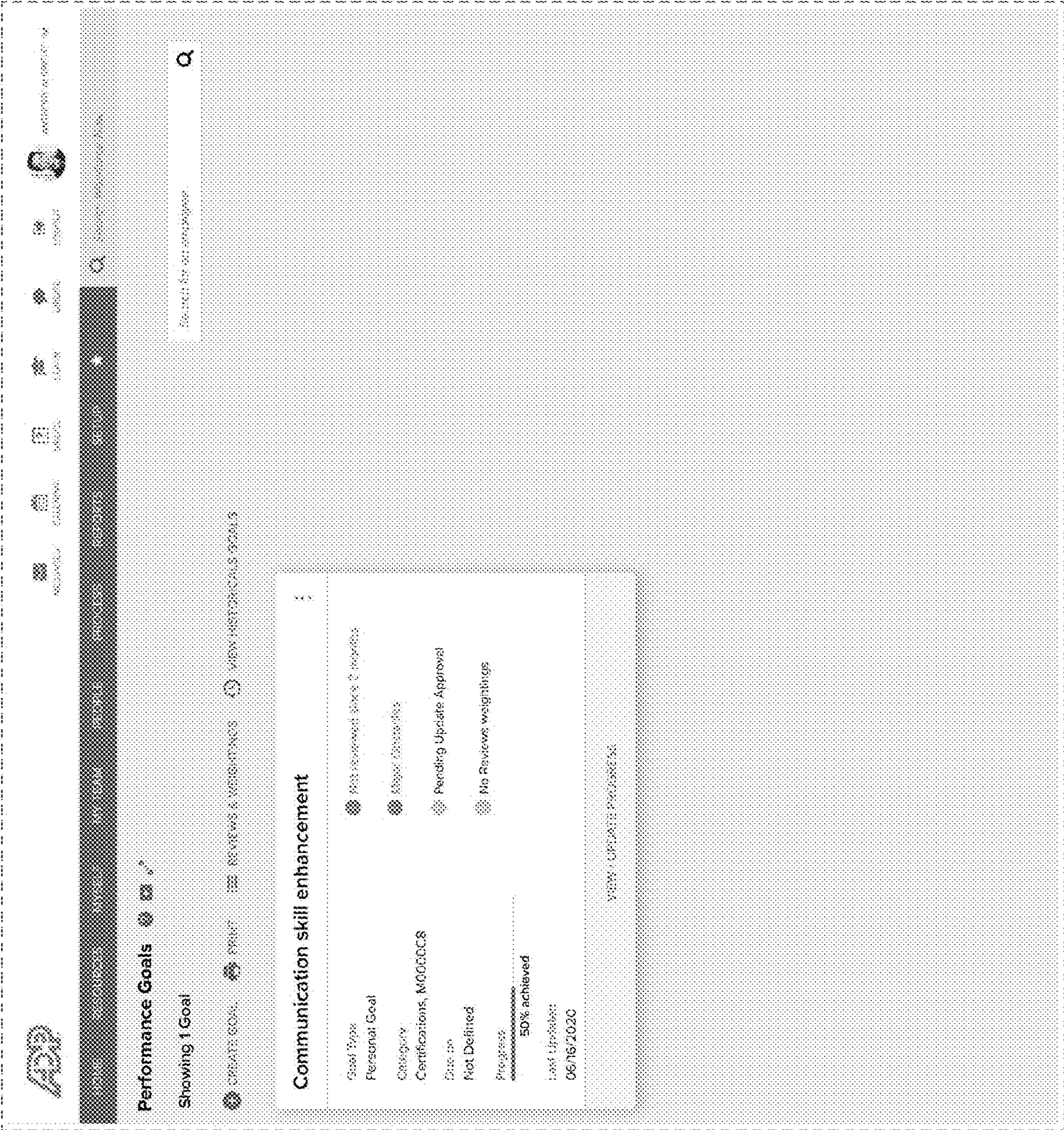
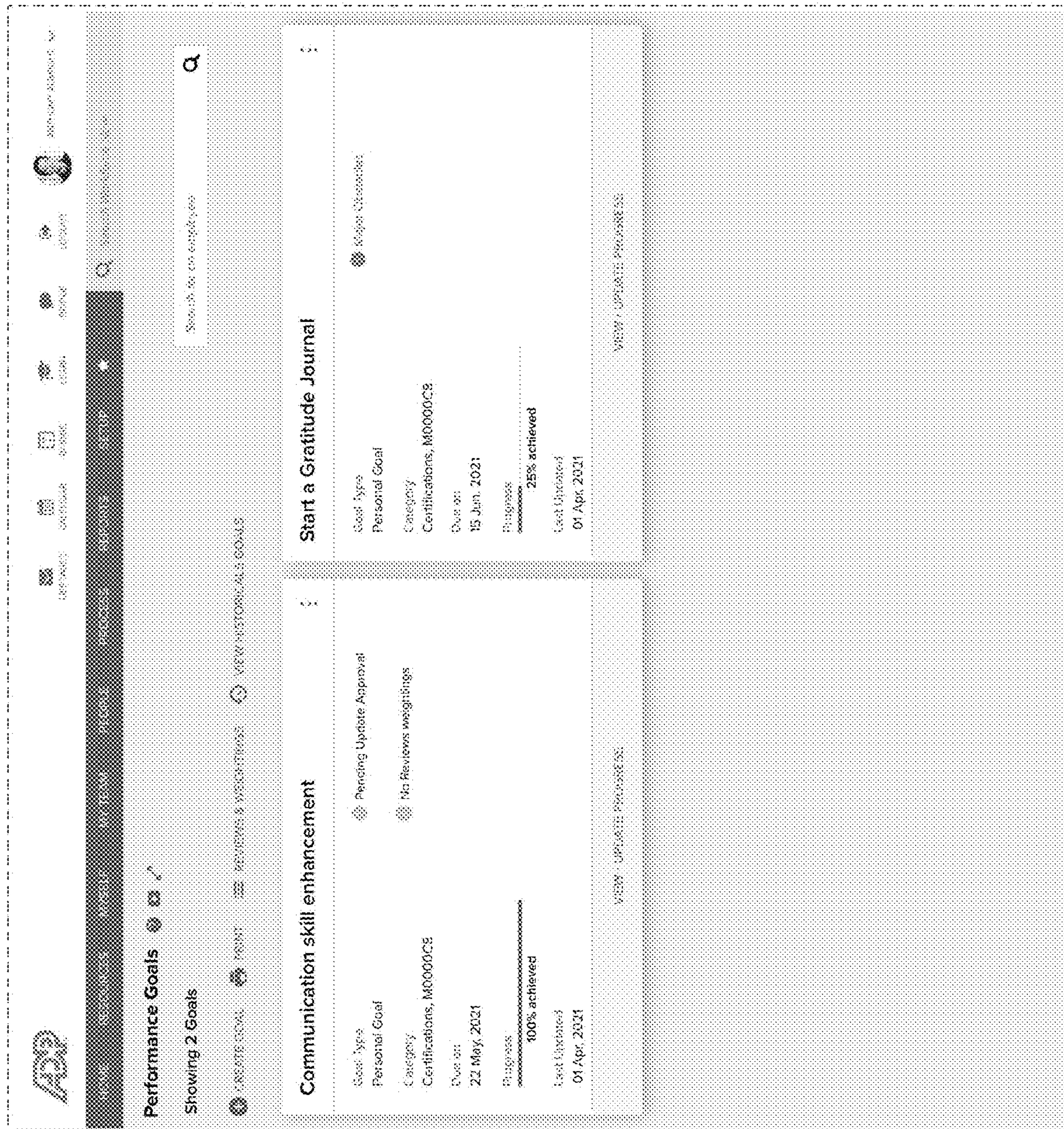

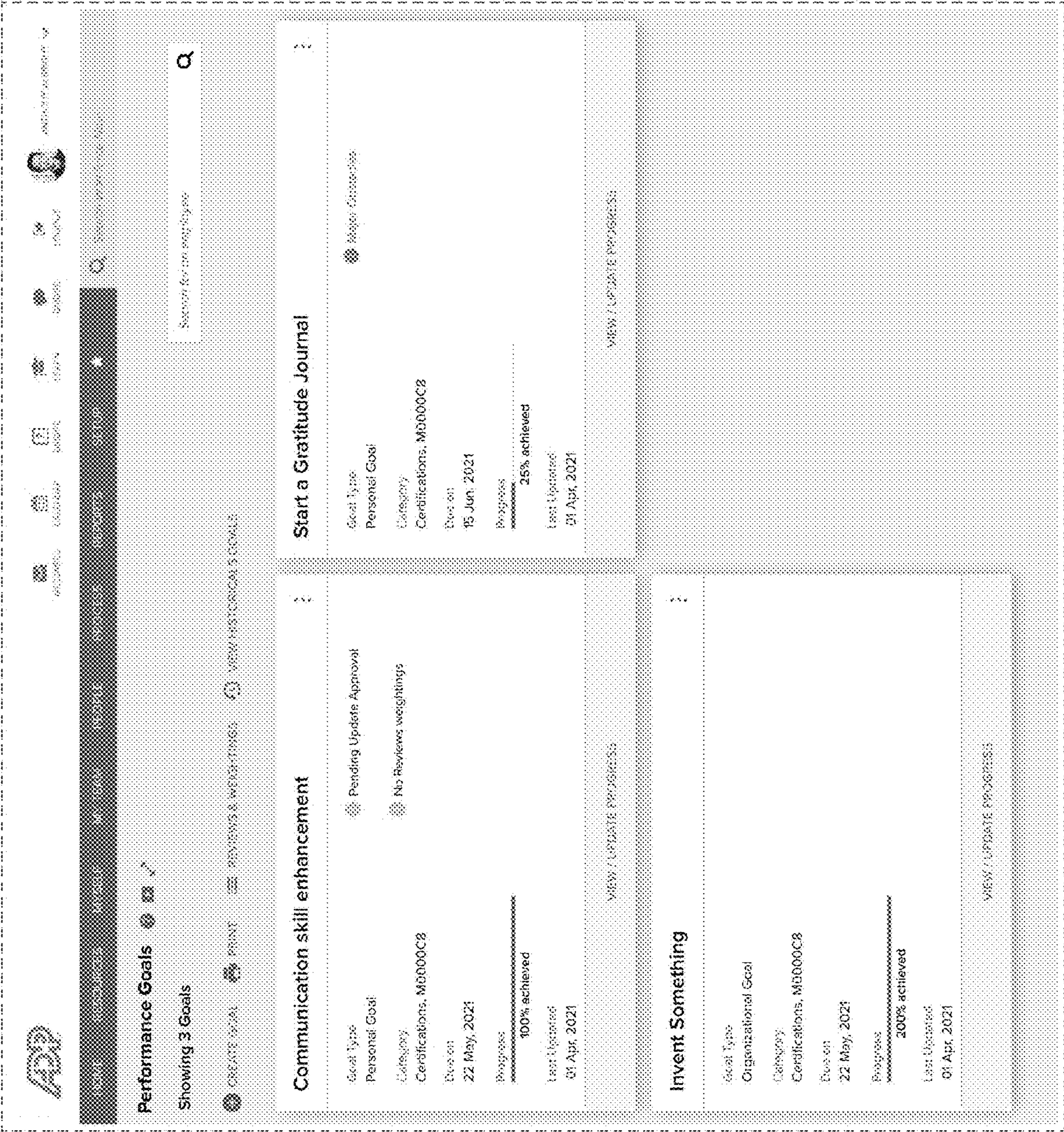

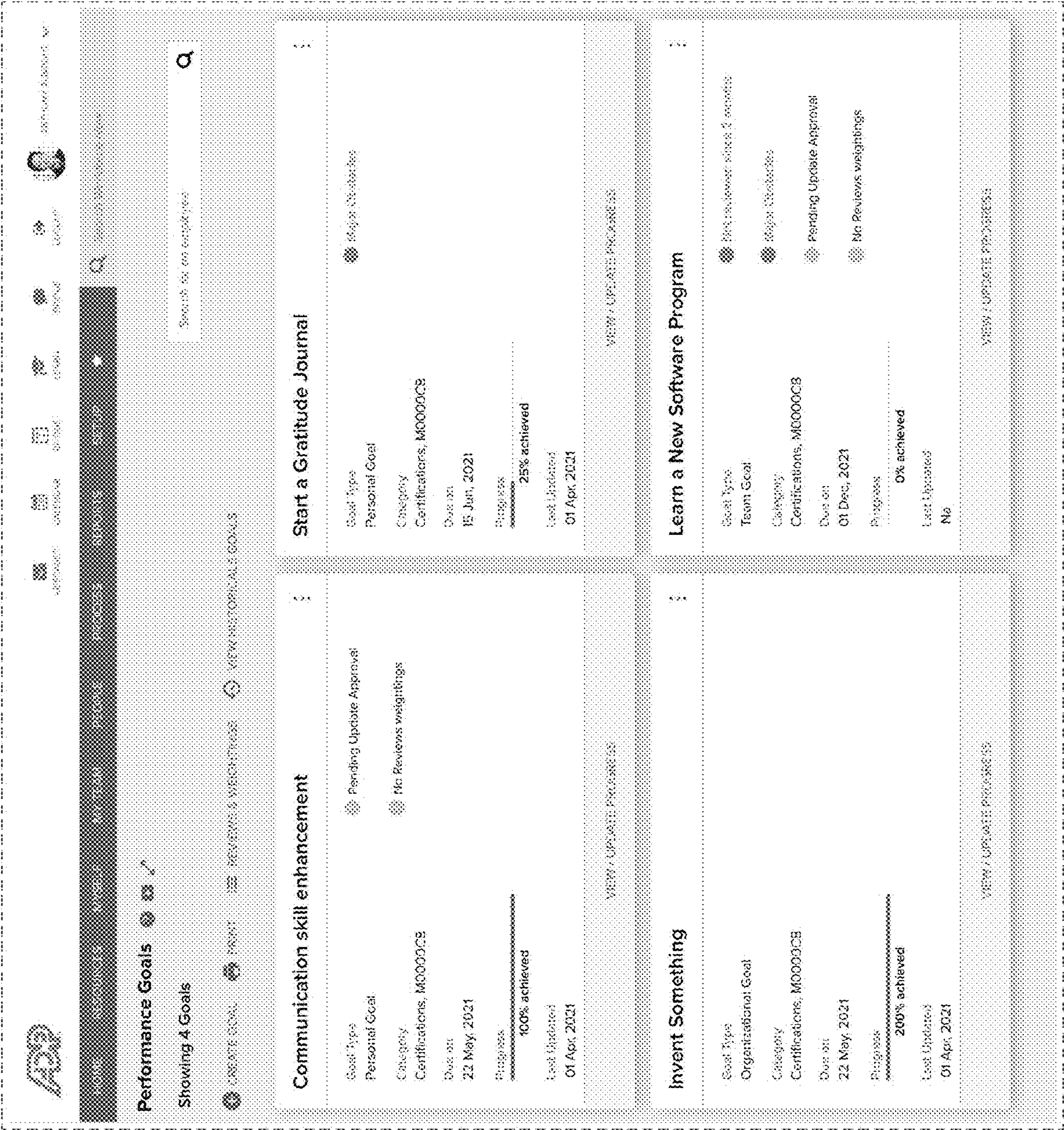
