FIG. 8 is a front view of an eighth embodiment of a display screen or a portion thereof with a graphical user interface;

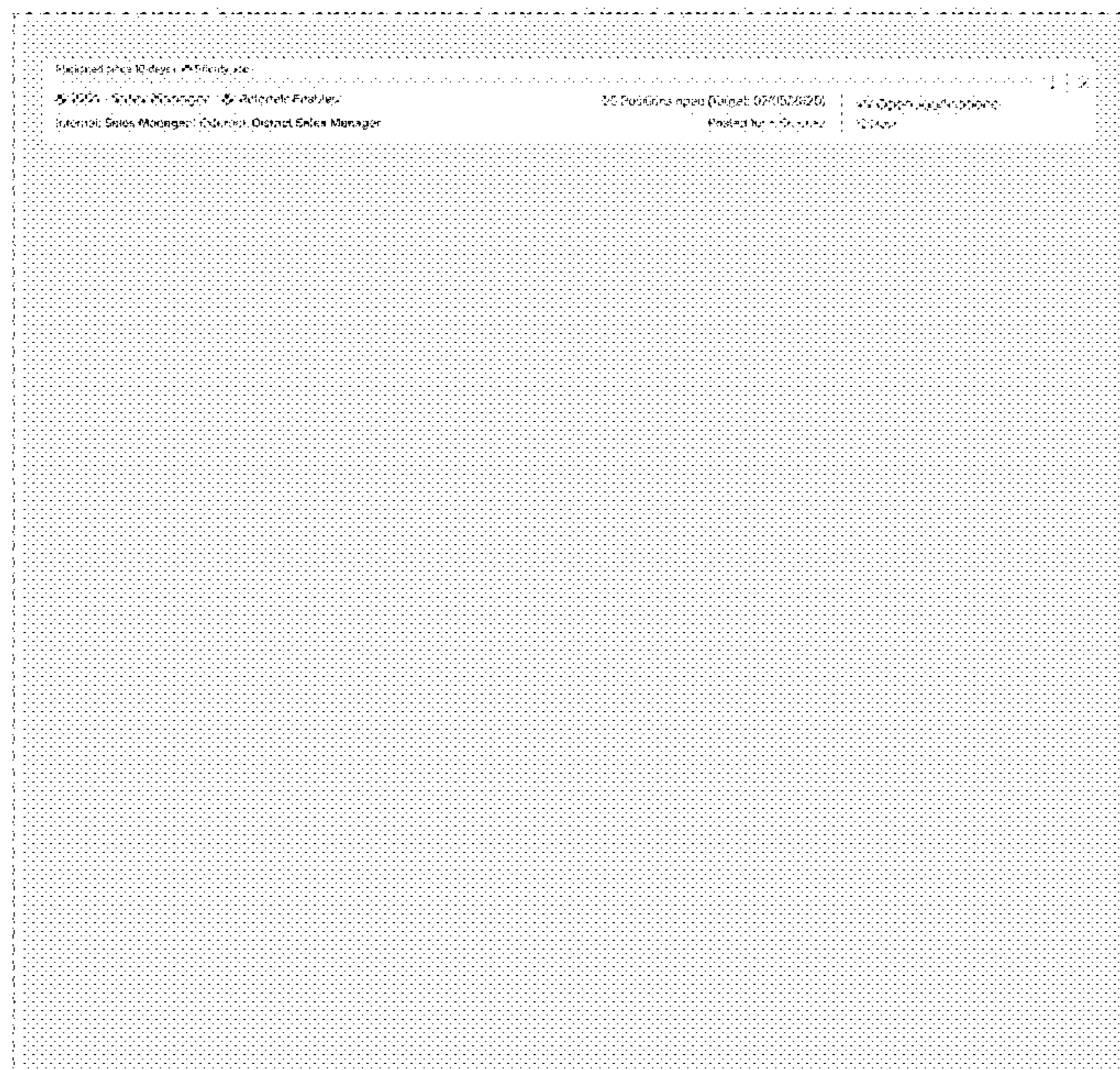
FIG. 9 is a front view of a ninth embodiment of a display screen or a portion thereof with a graphical user interface;

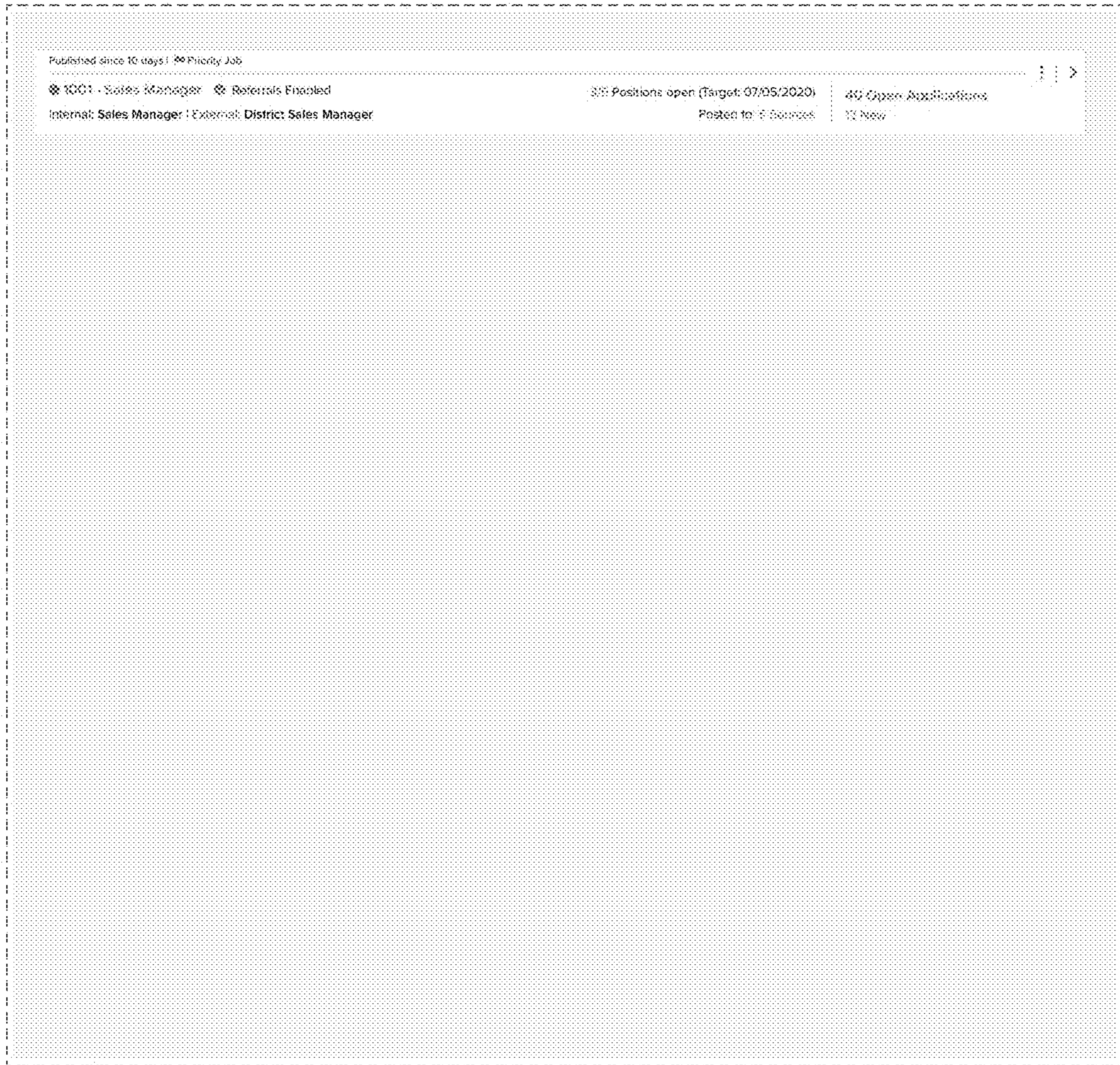

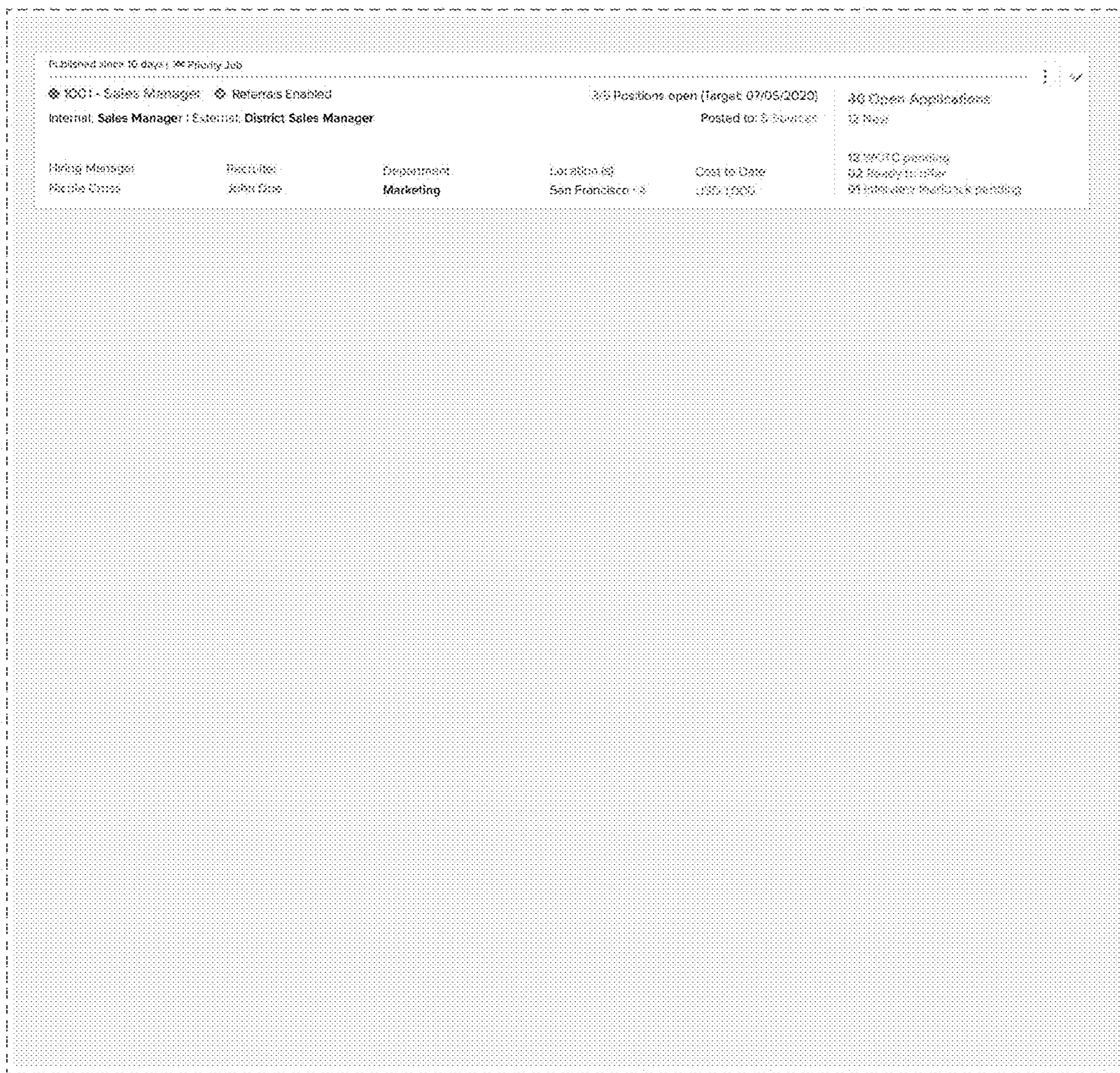

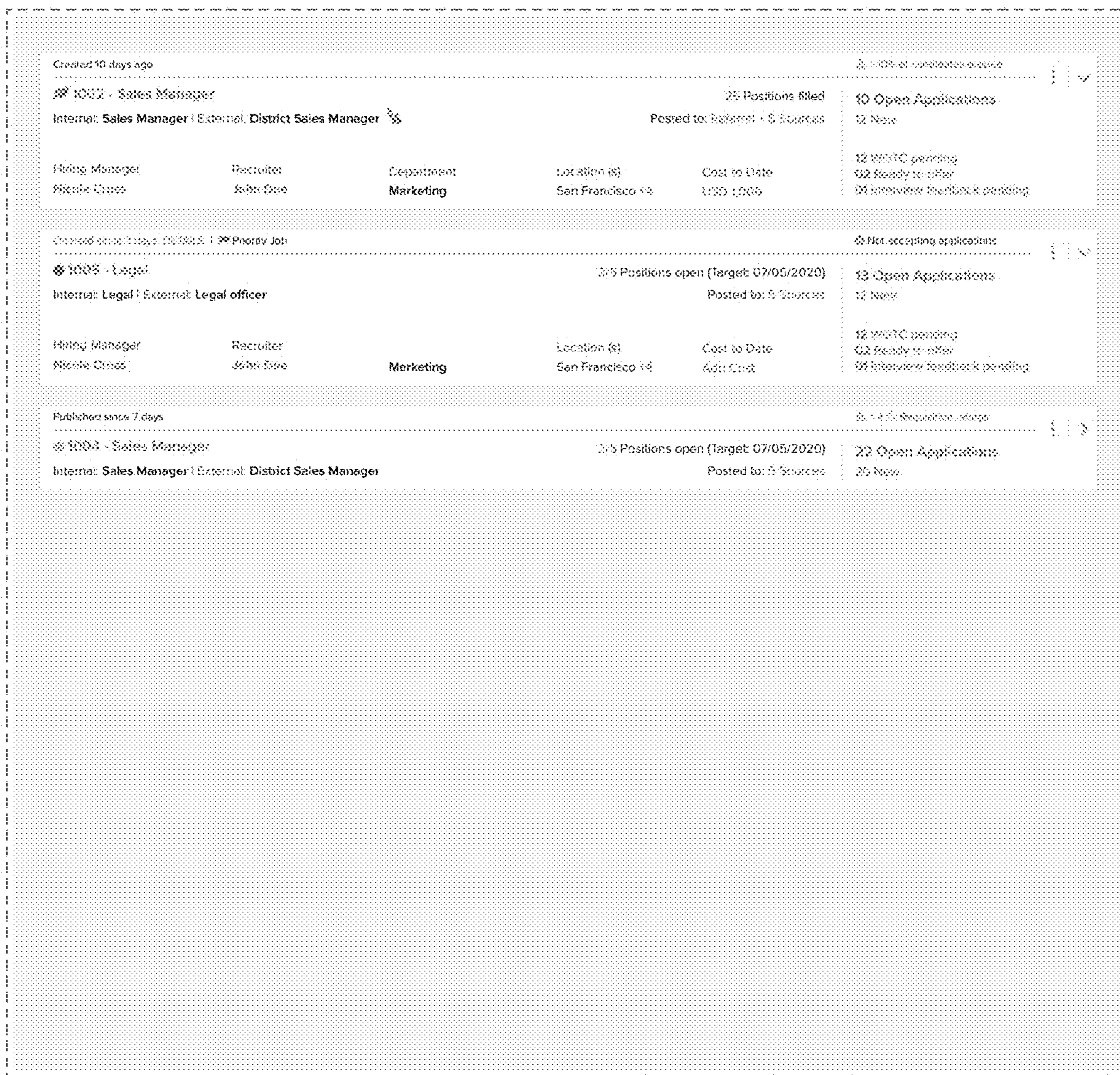

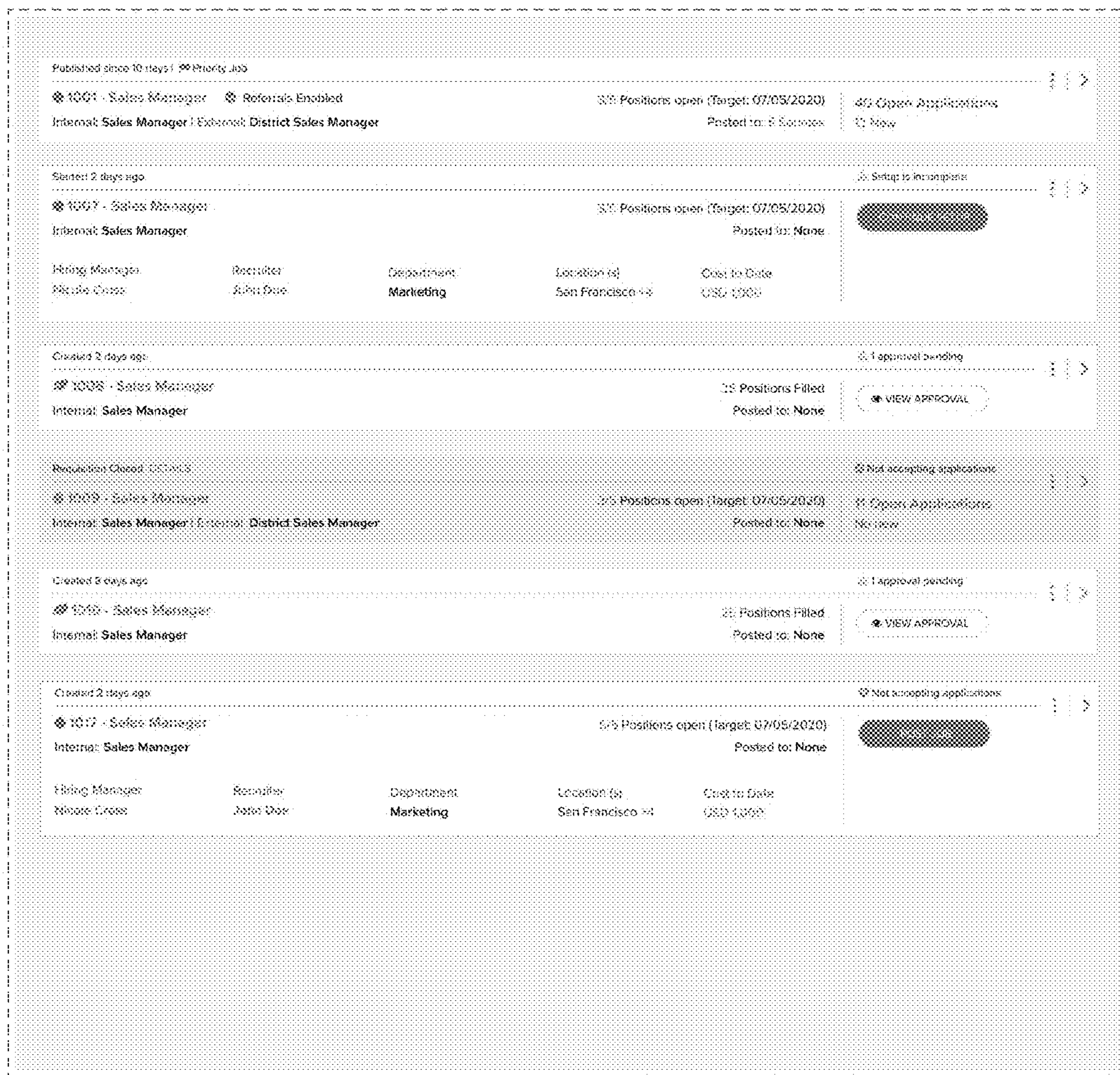
