The appearance of the image sequentially transitions between images shown in FIGS. 1 through 5. The process or period in which one image changes to another forms no part of the claimed design.

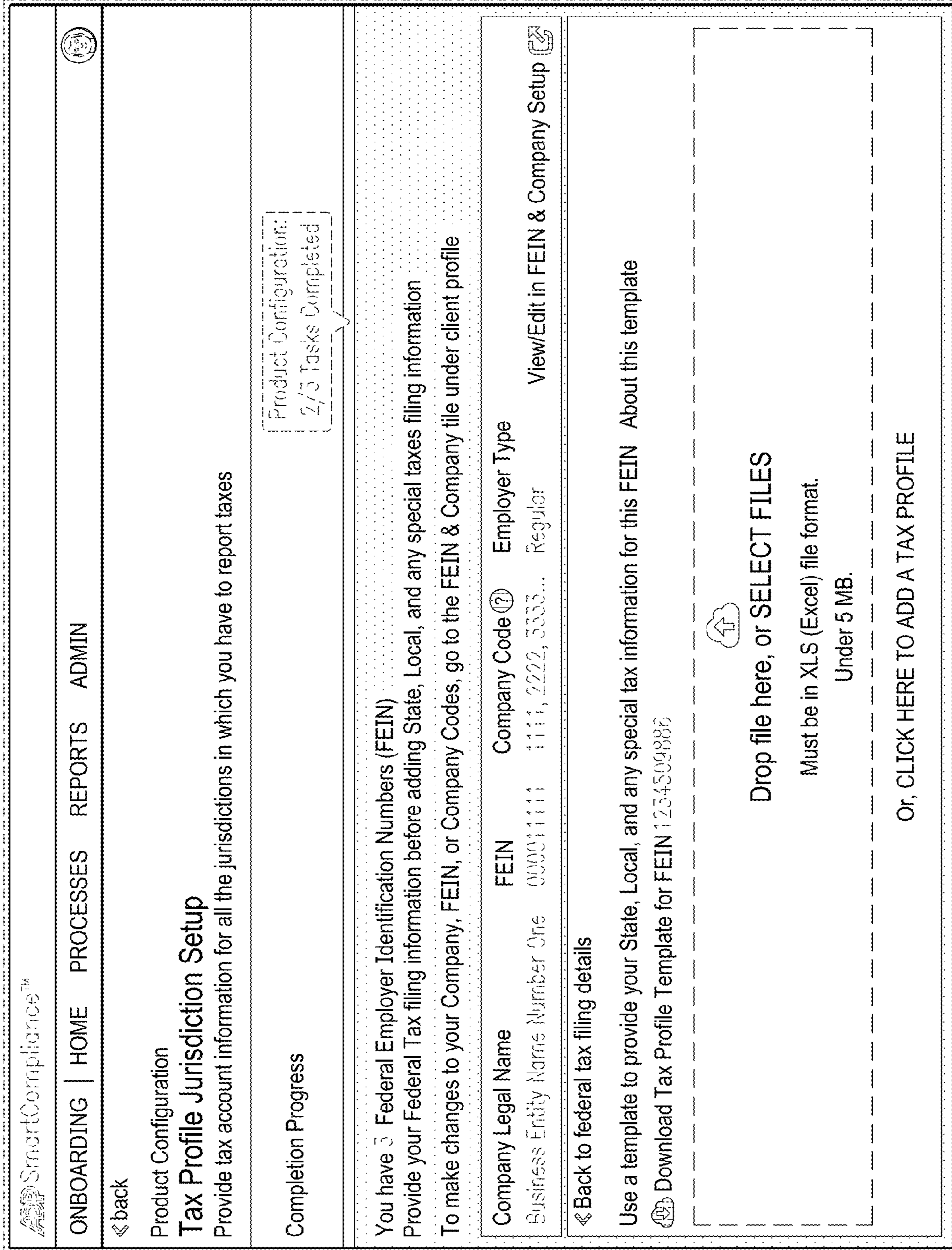
