(57) **CLAIM**

The ornamental design for a display screen or portion thereof with a set of mahjong game tile icons, as shown and described.

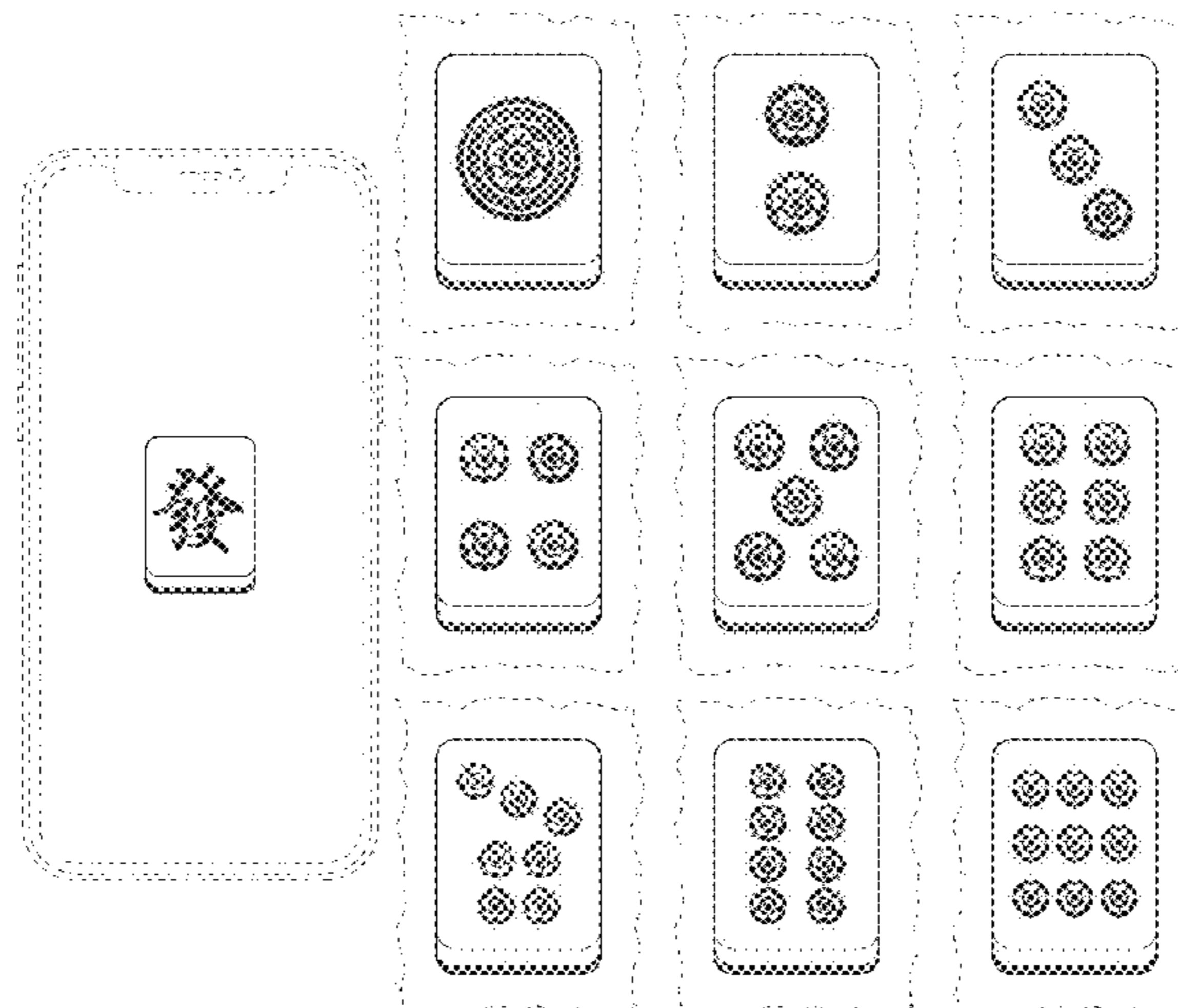


FIG. 11 is another group of mahjong game tile icons from the second embodiment, each depicted on a display screen or portion thereof;

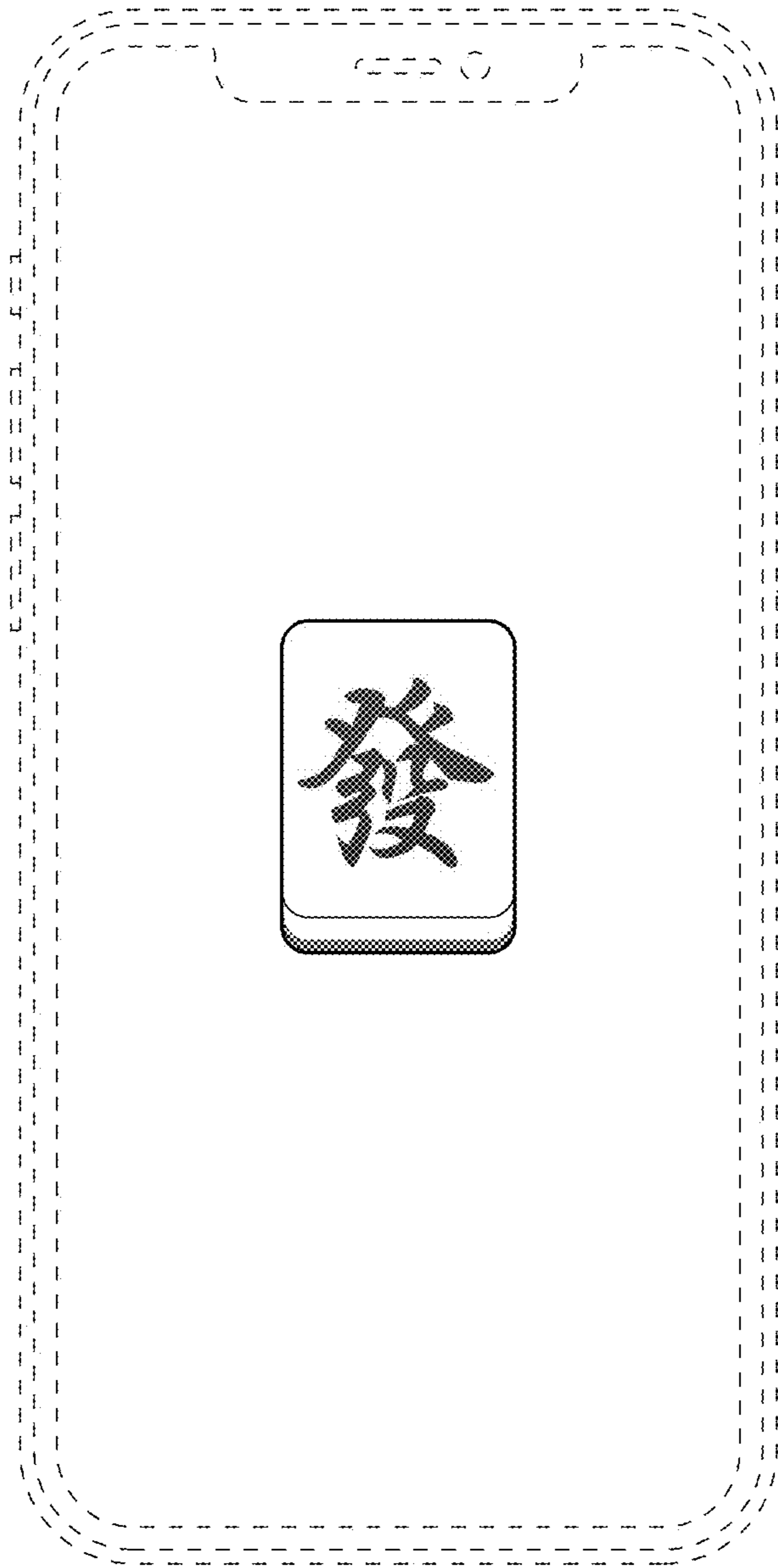

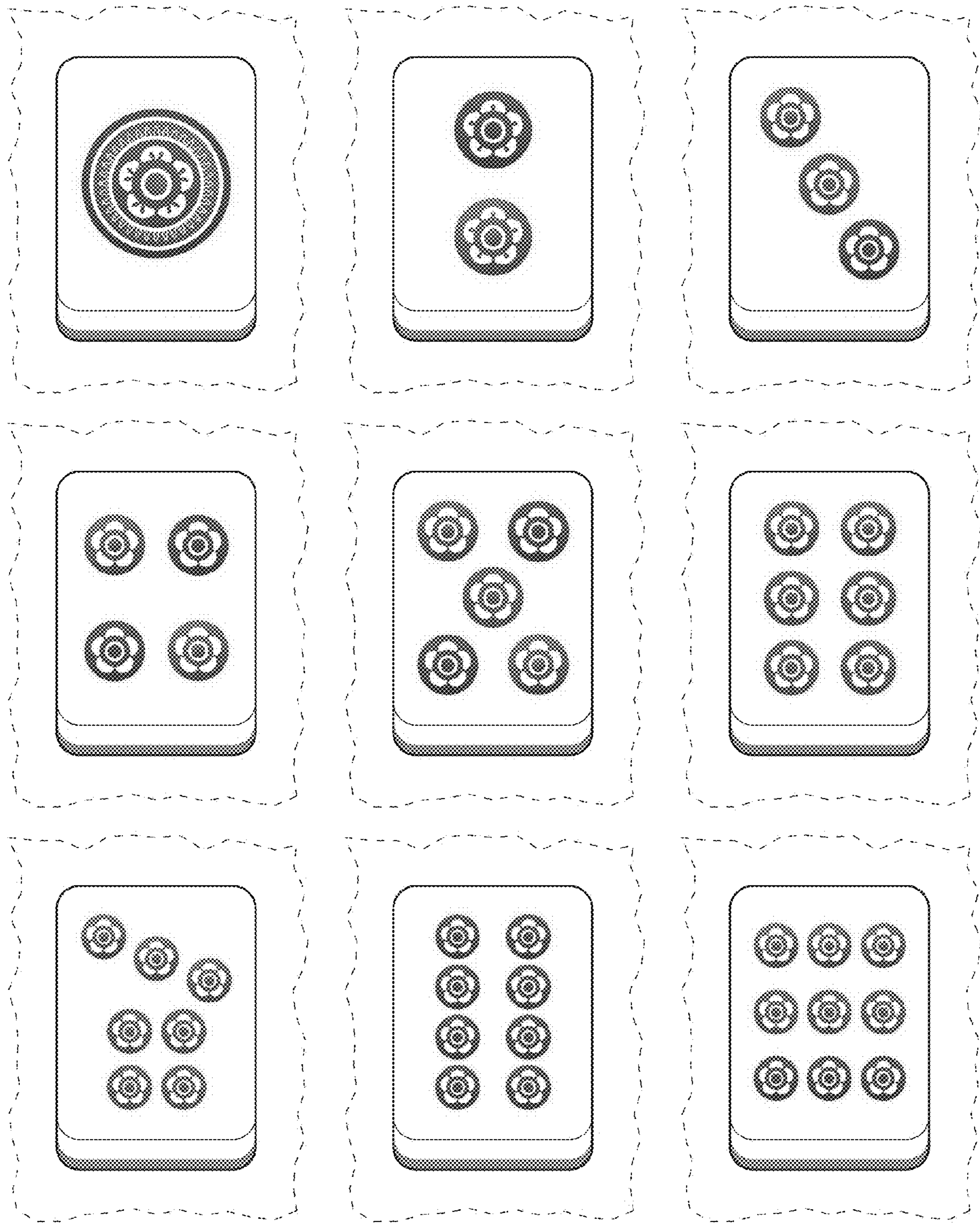

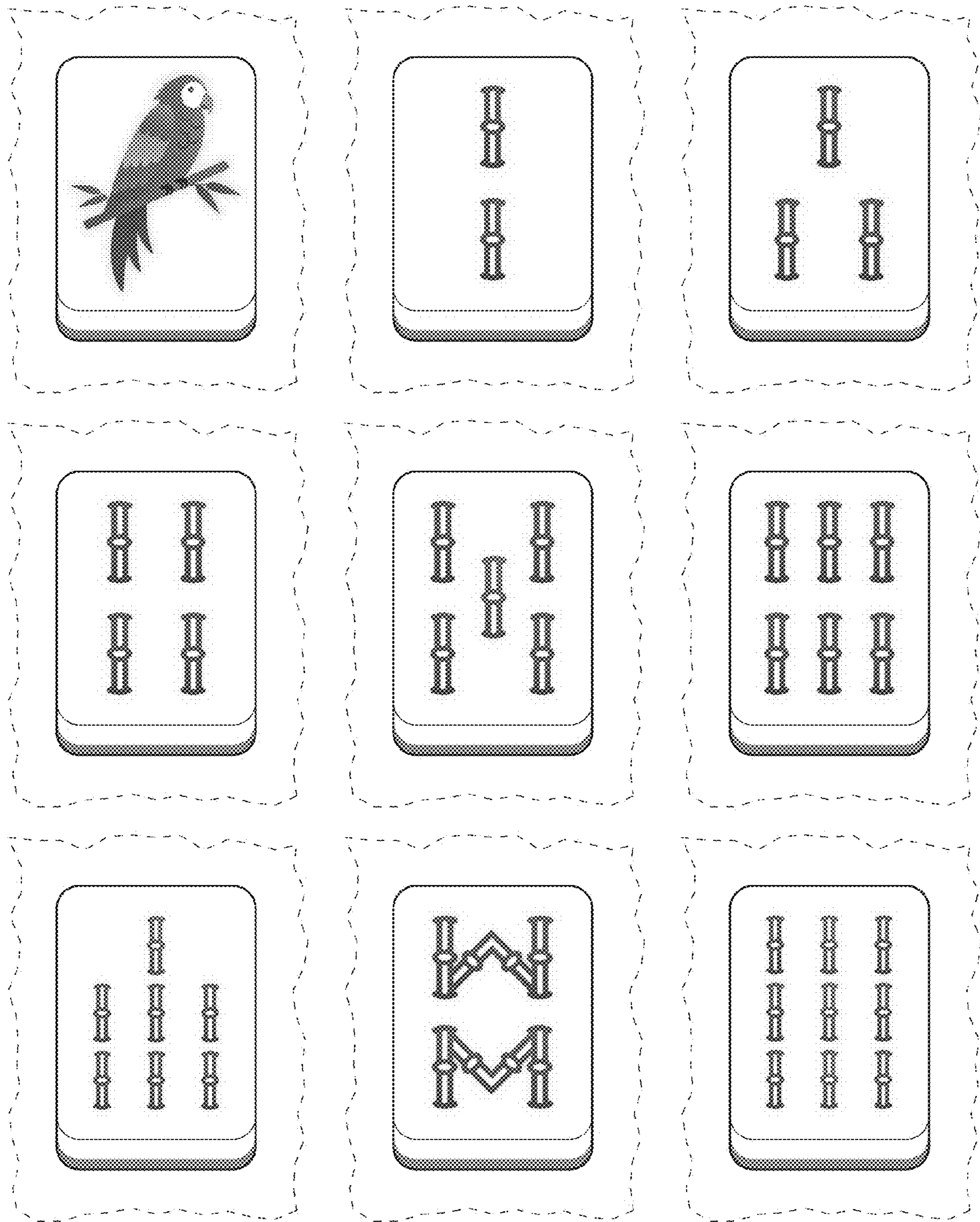

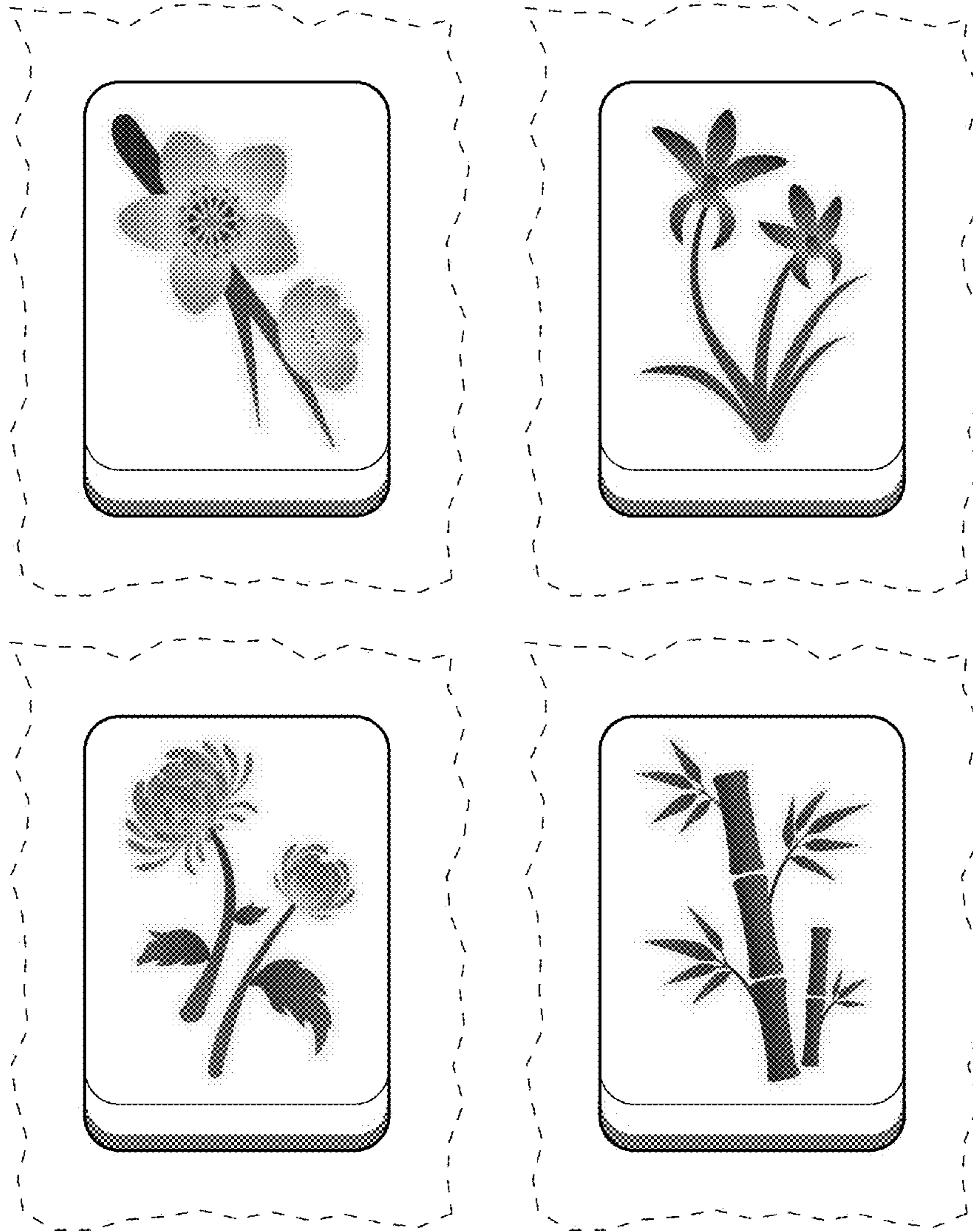

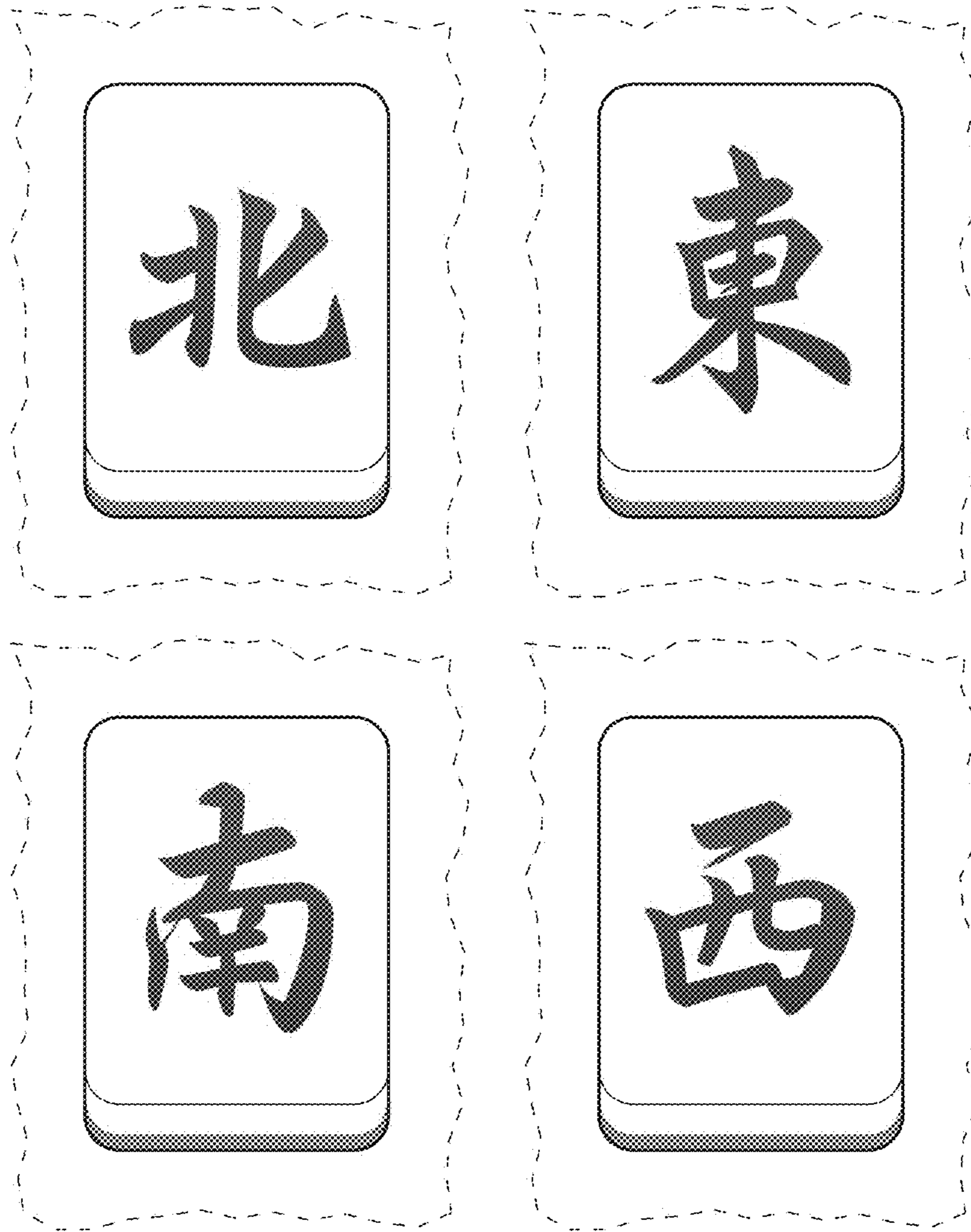
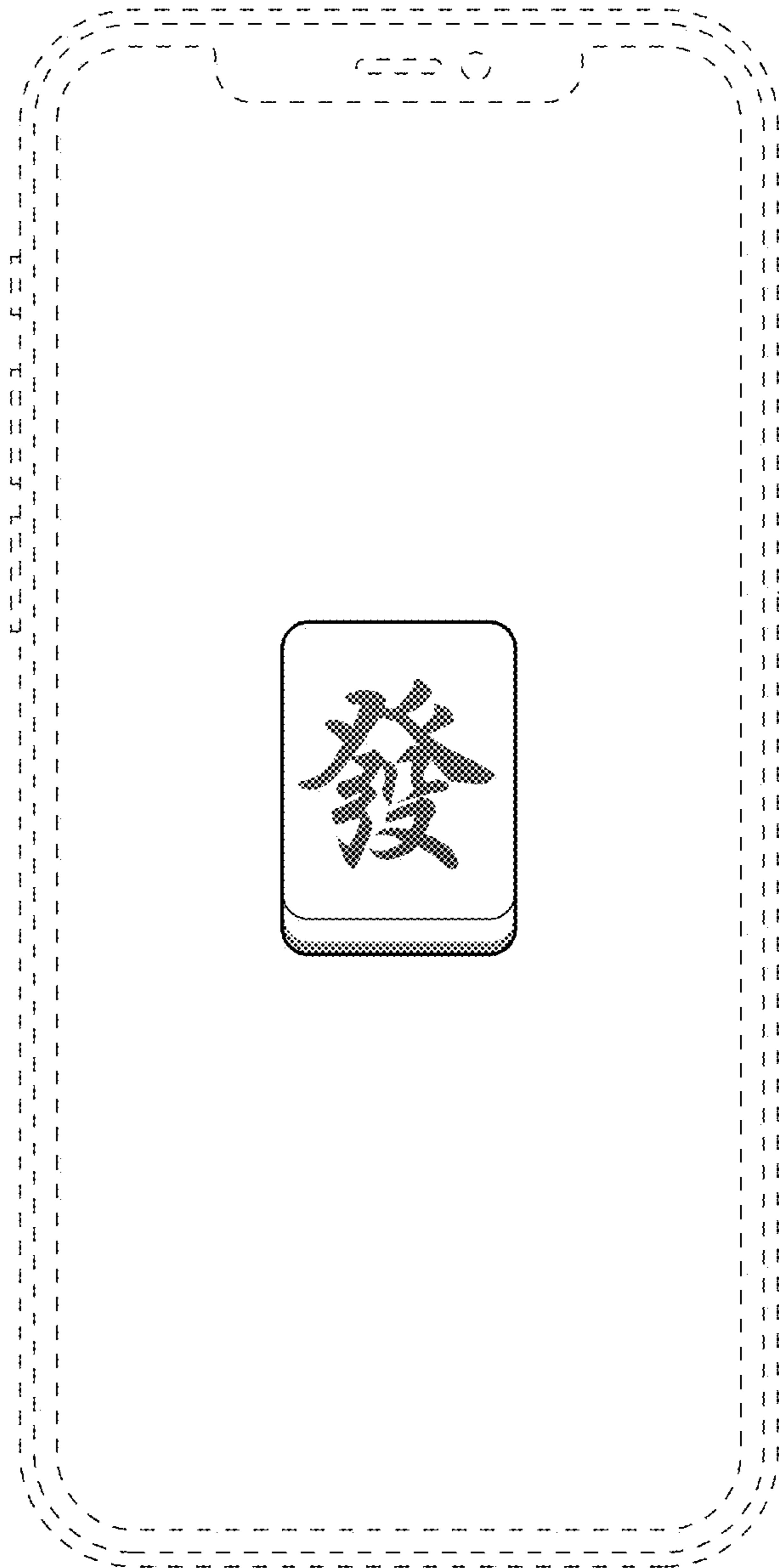
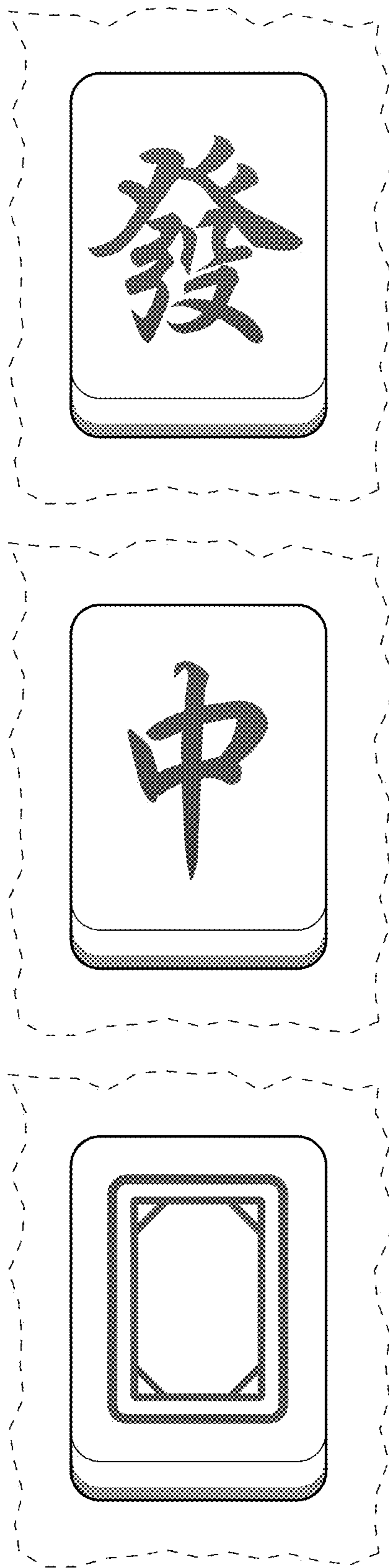

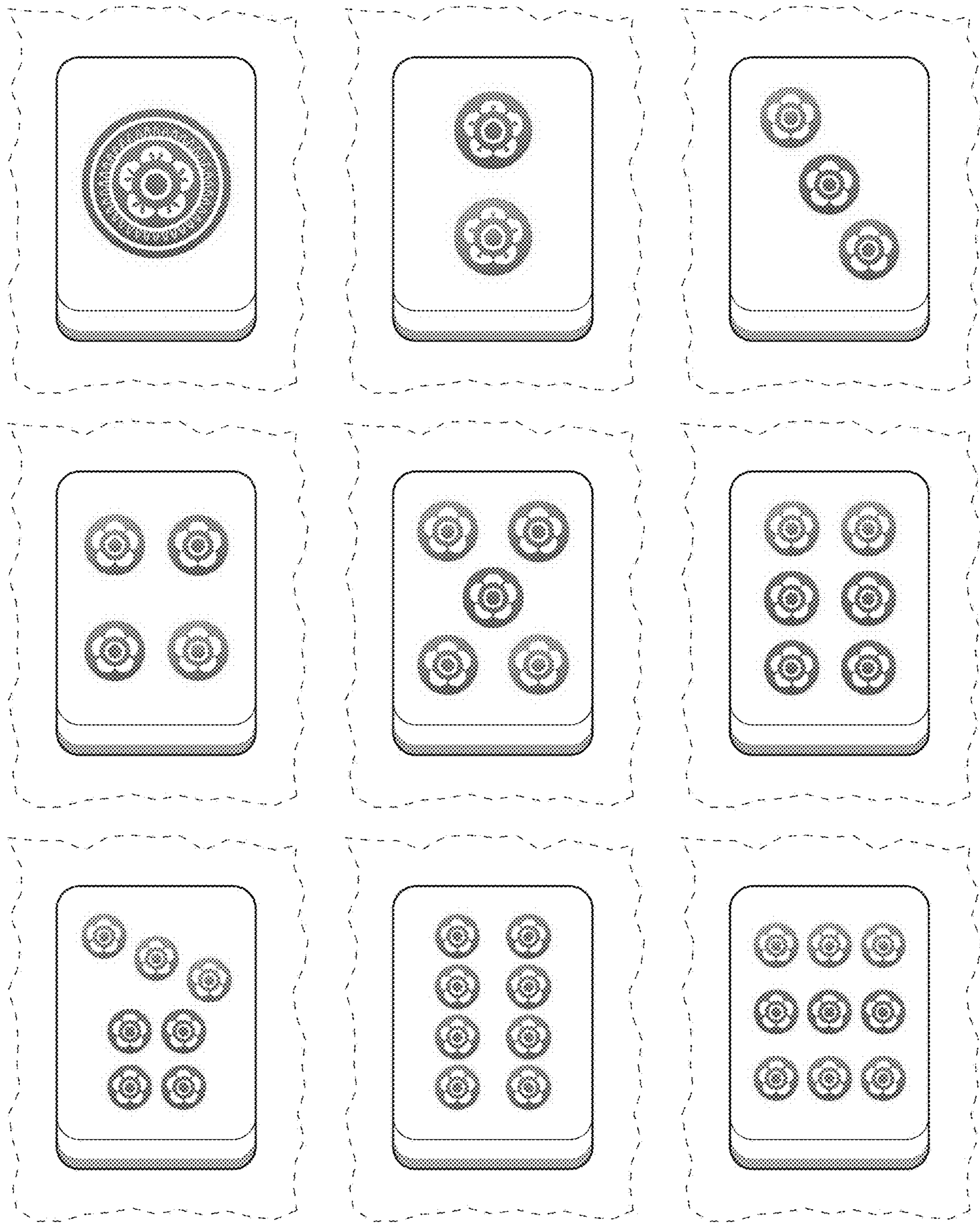

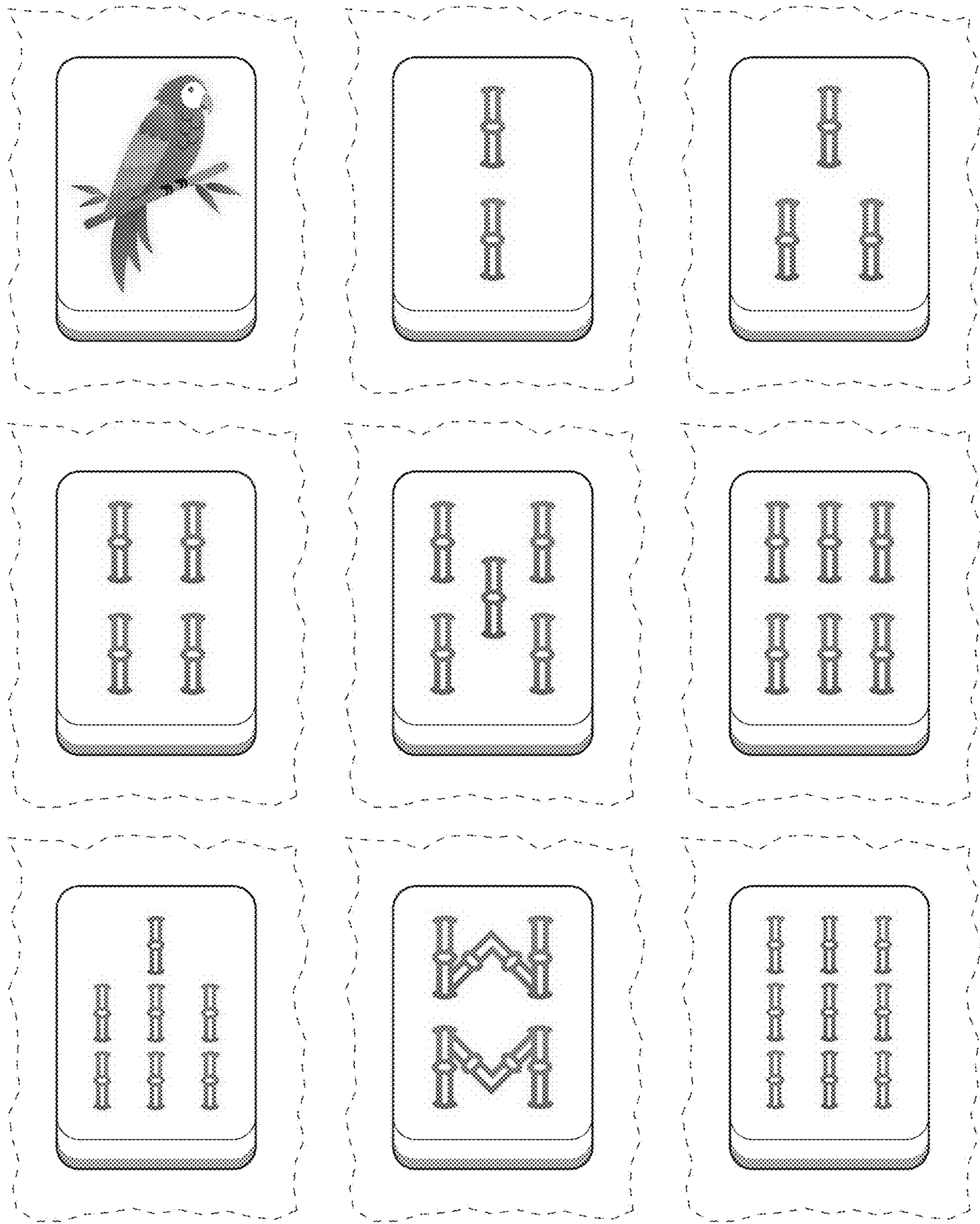
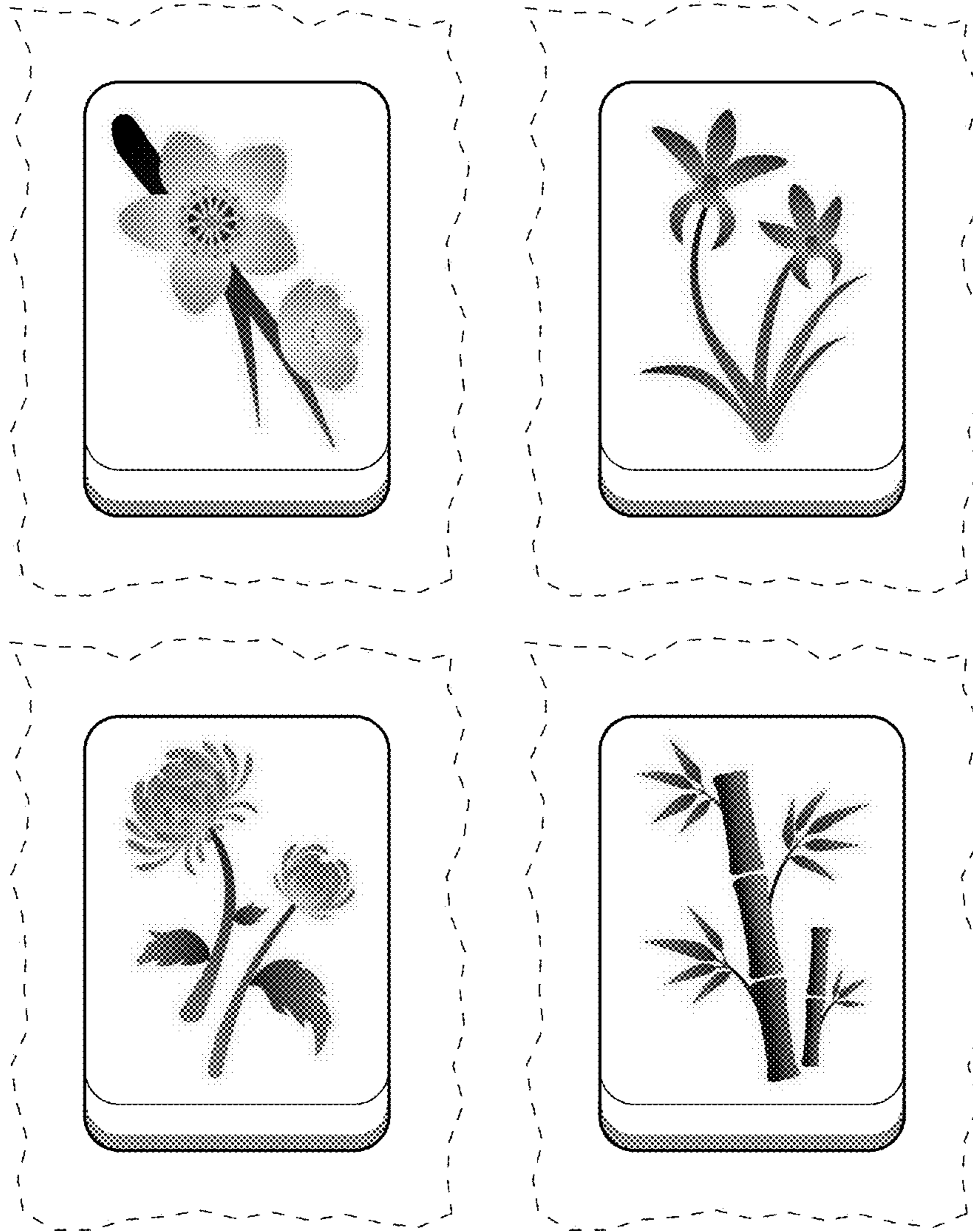

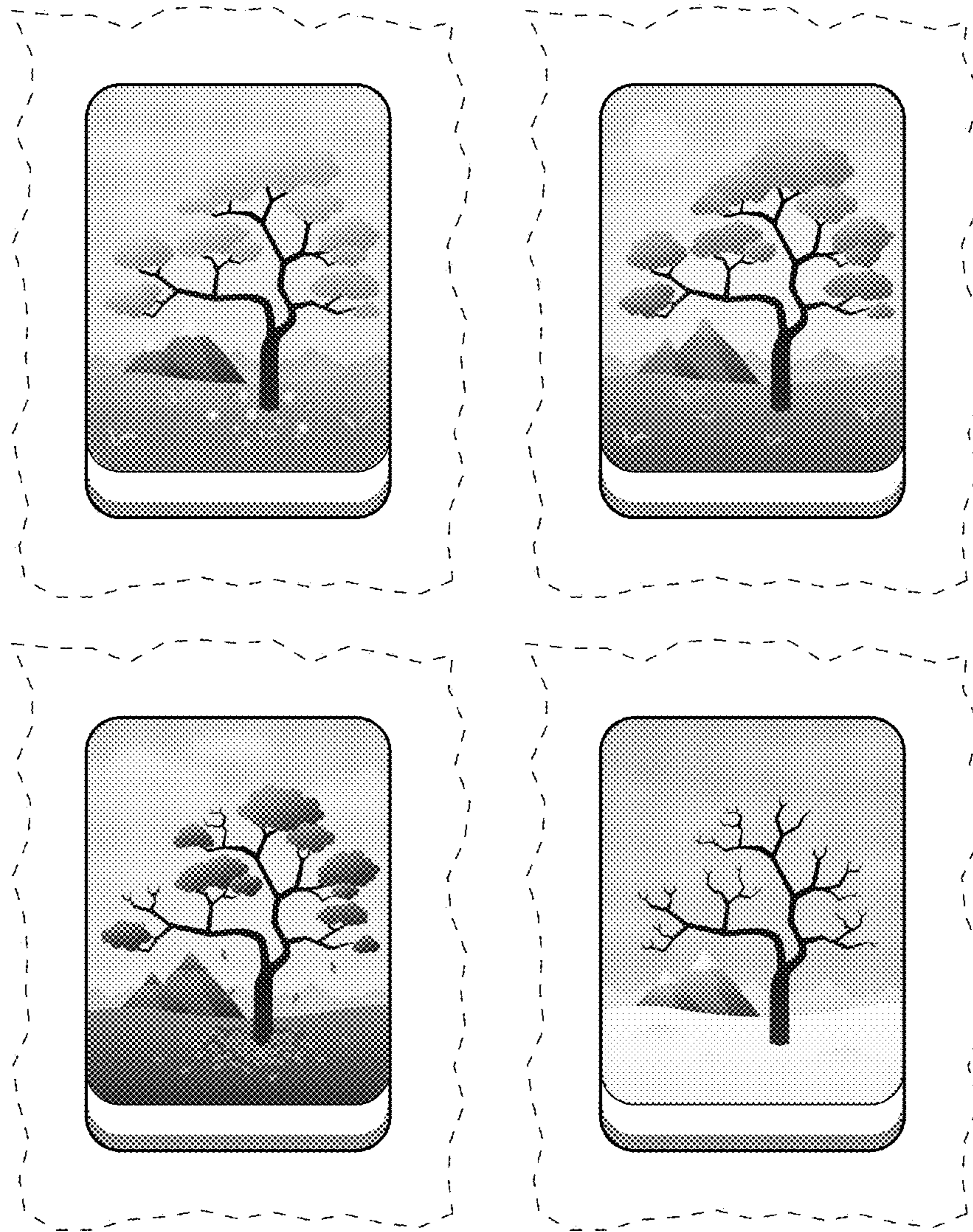

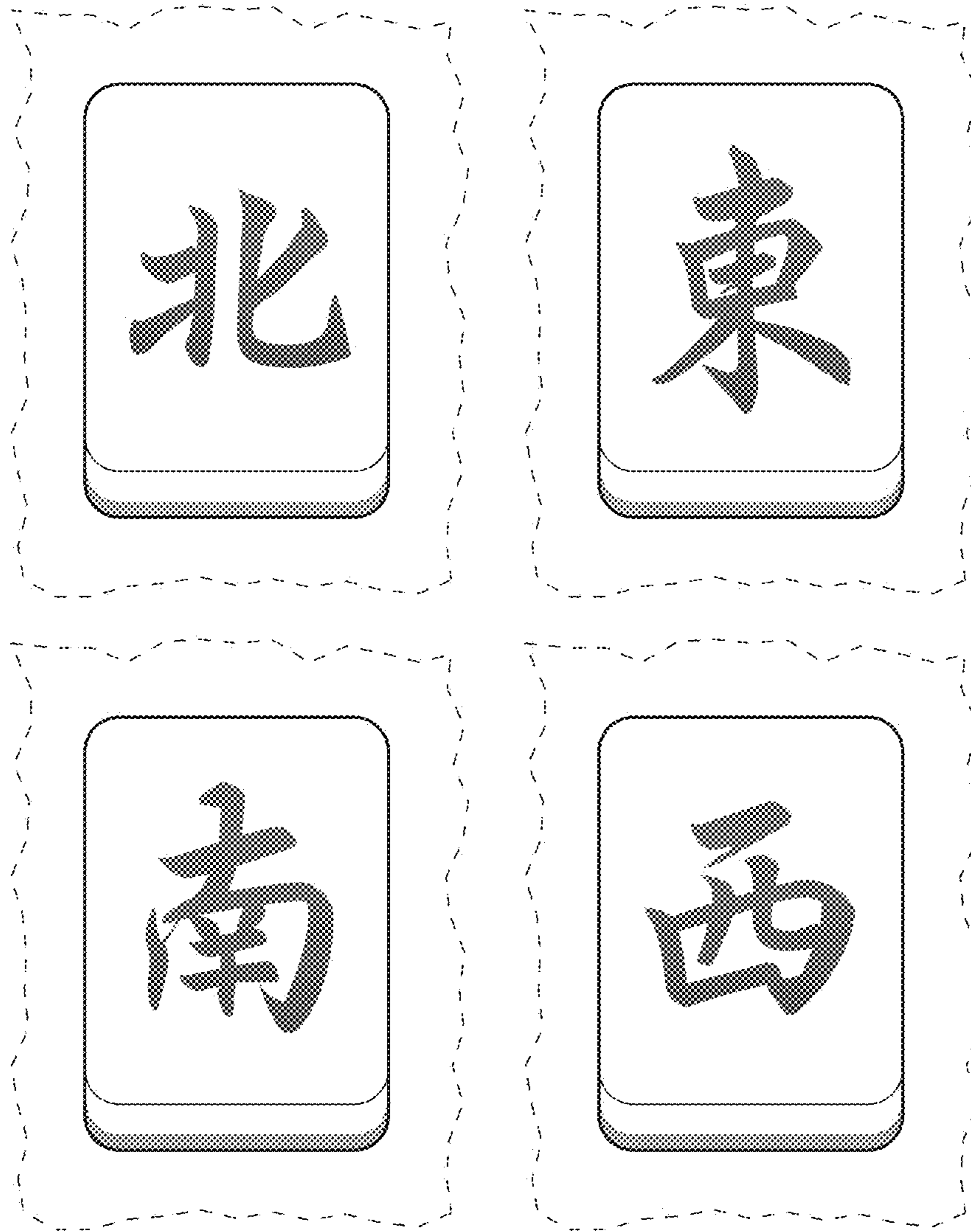
