DESCRIPTION

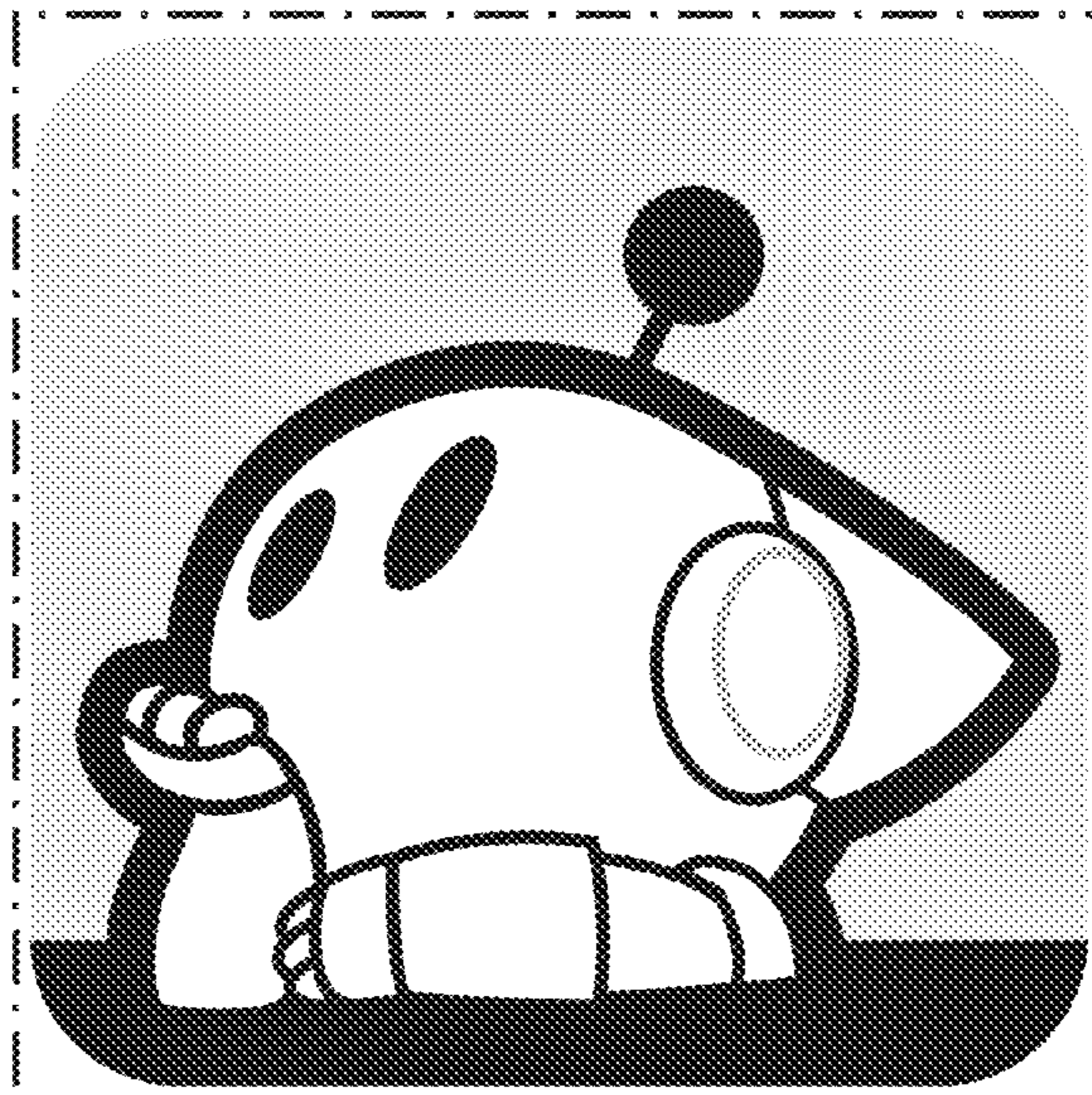
FIG. 1 is a front view of the display screen or portion thereof with icon, the icon is shown separately for clarity of illustration, and on an enlarged scale; and,

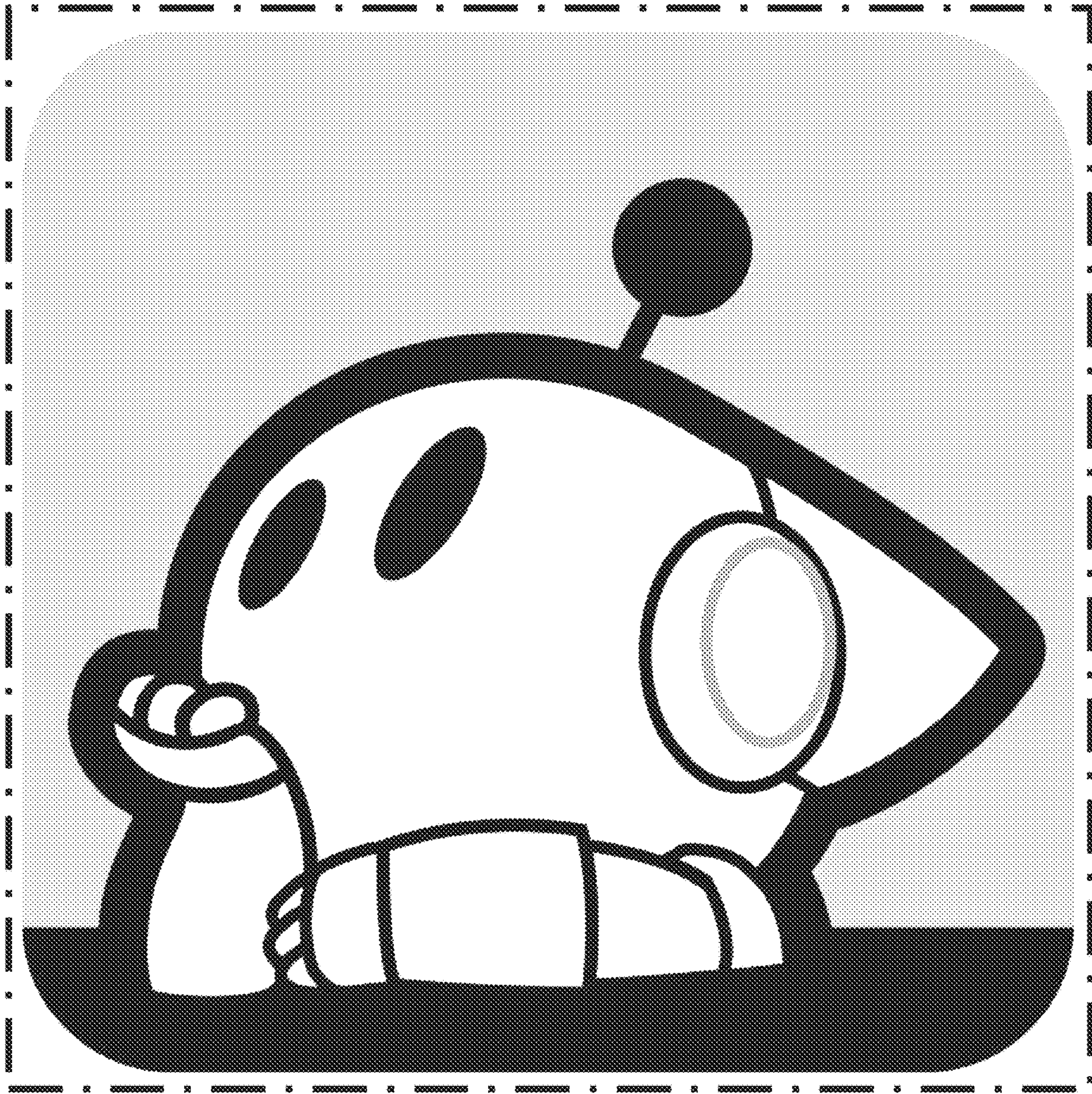

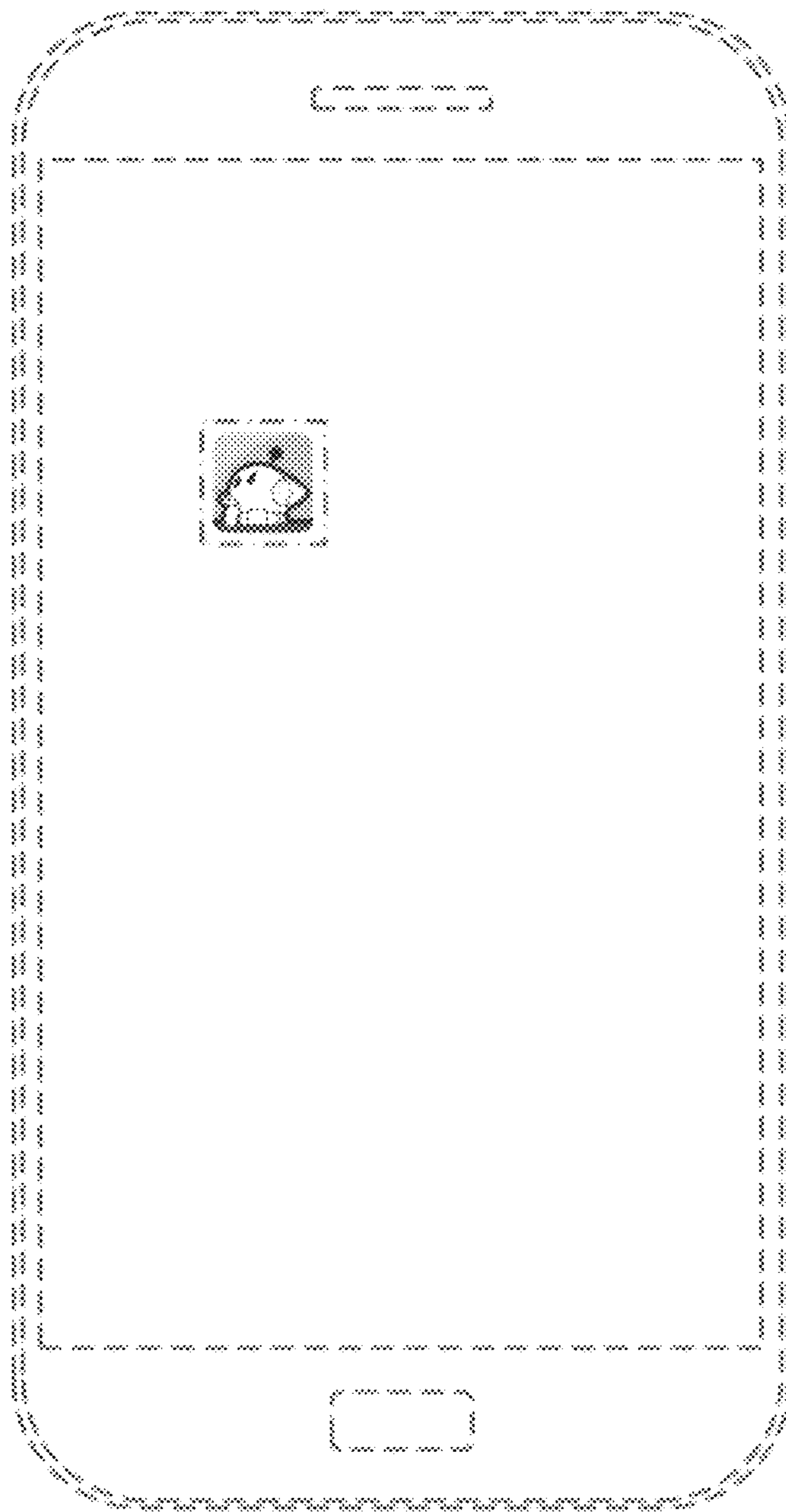
