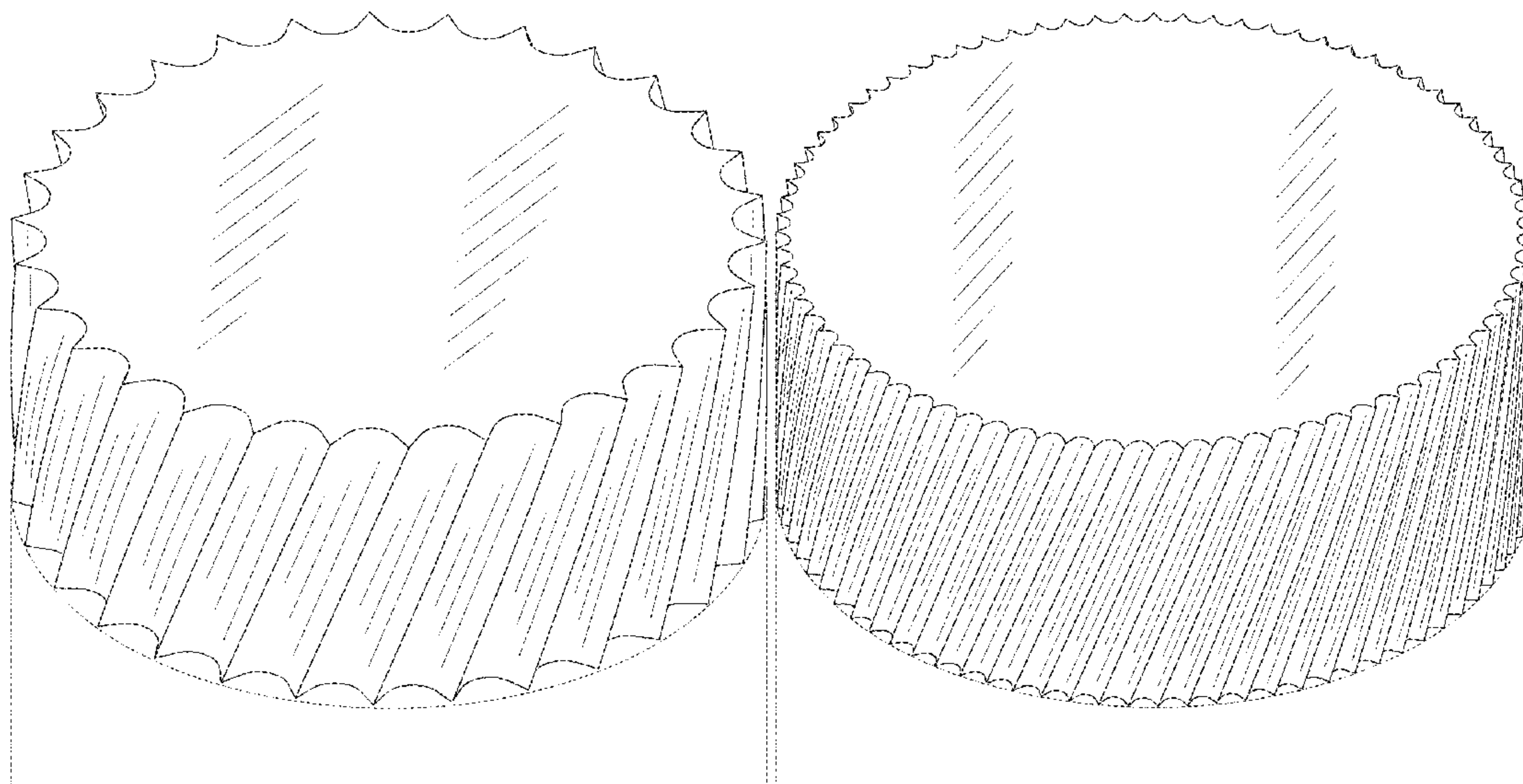
(57) **CLAIM**

The ornamental design for a cutting tool, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a cutting tool in accordance with Embodiment 1 of the present design; FIG. 2 is a rear view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a top view thereof; FIG. 6 is a bottom view thereof; FIG. 7 is a perspective view thereof; FIG. 8 is an enlarged perspective view of 8-8 portion of FIG. 7; FIG. 9 is a front view of a cutting tool in accordance with Embodiment 2 of the present design; FIG. 10 is a rear view thereof; FIG. 11 is a right side view thereof; FIG. 12 is a left side view thereof; FIG. 13 is a top view thereof; FIG. 14 is a bottom view thereof; FIG. 15 is a perspective view thereof; FIG. 16 is an enlarged perspective view of 16-16 portion of FIG. 15; FIG. 17 is a front view of a cutting tool in accordance with Embodiment 3 of the present design; FIG. 18 is a rear view thereof; FIG. 19 is a right side view thereof; FIG. 20 is a left side view thereof; FIG. 21 is a top view thereof; FIG. 22 is a bottom view thereof; FIG. 23 is a perspective view thereof; and, FIG. 24 is an enlarged perspective view of 24-24 portion of FIG. 23. 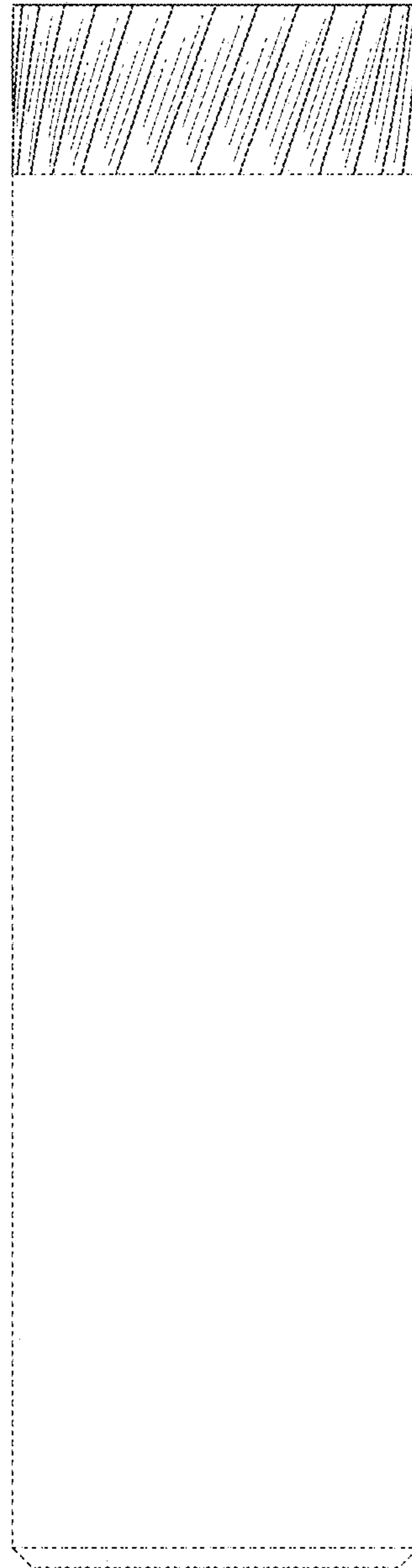

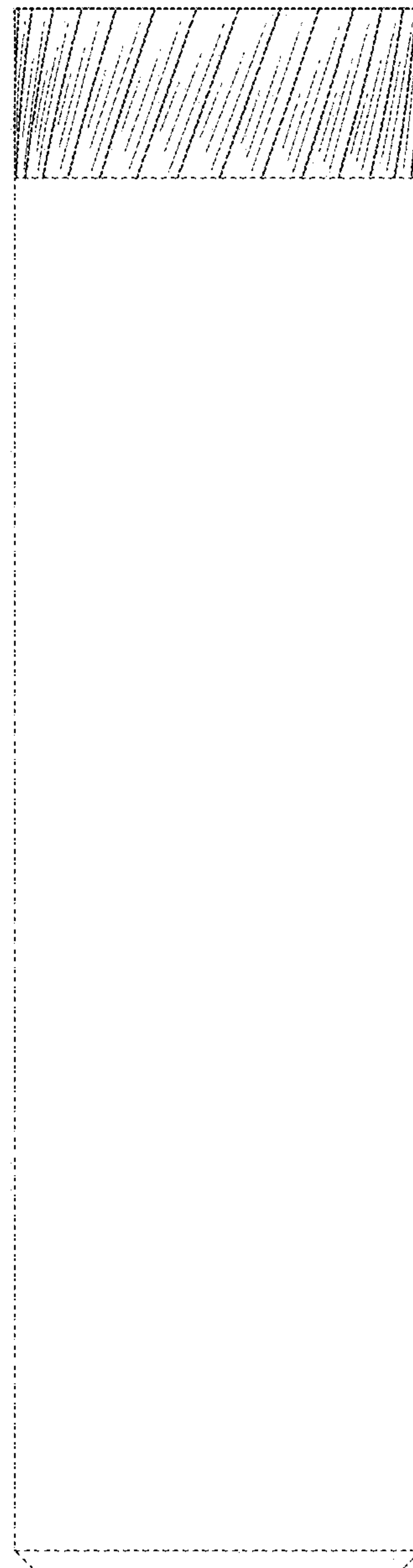

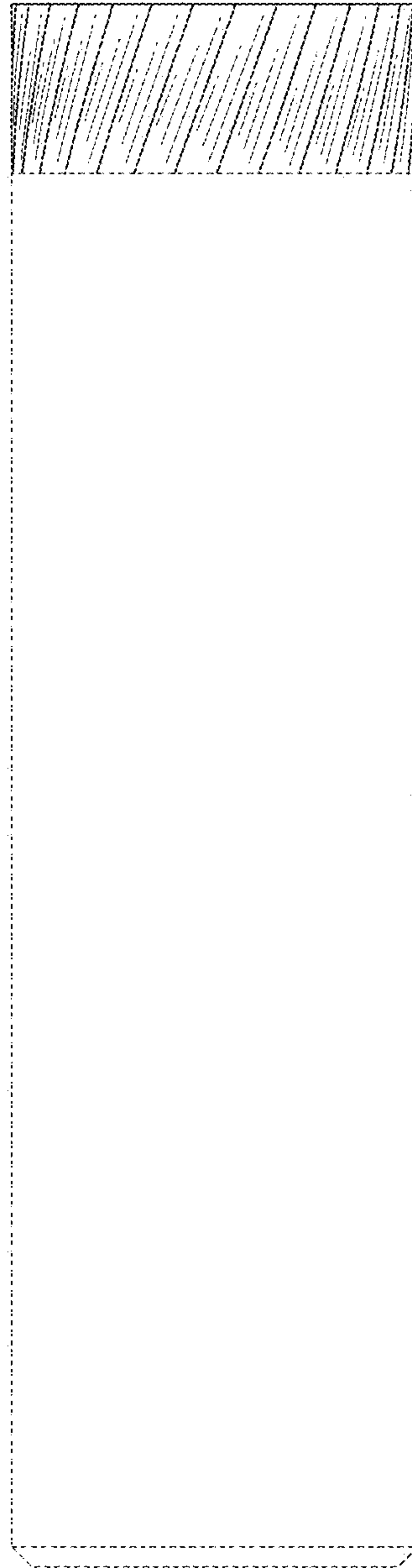

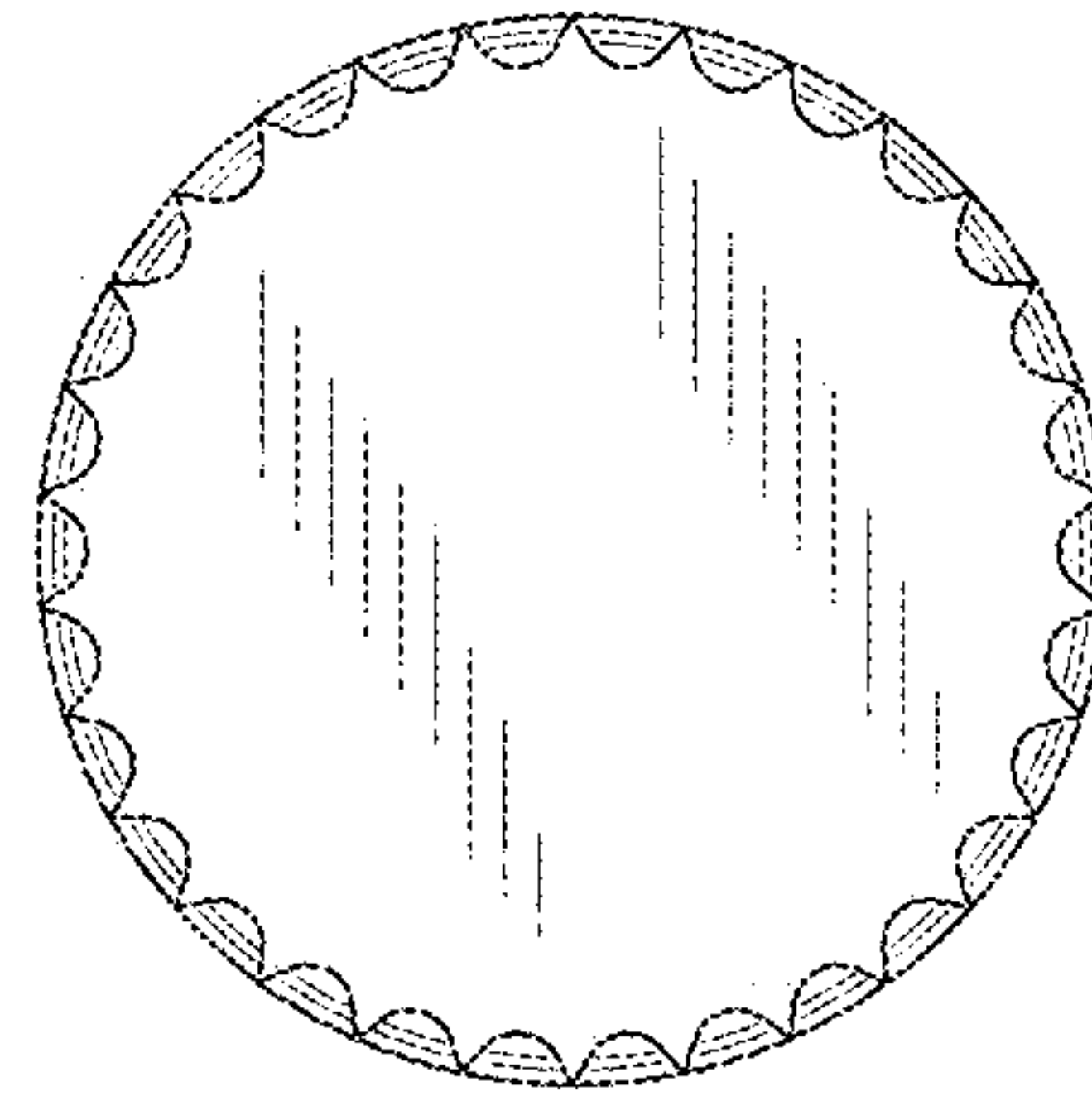

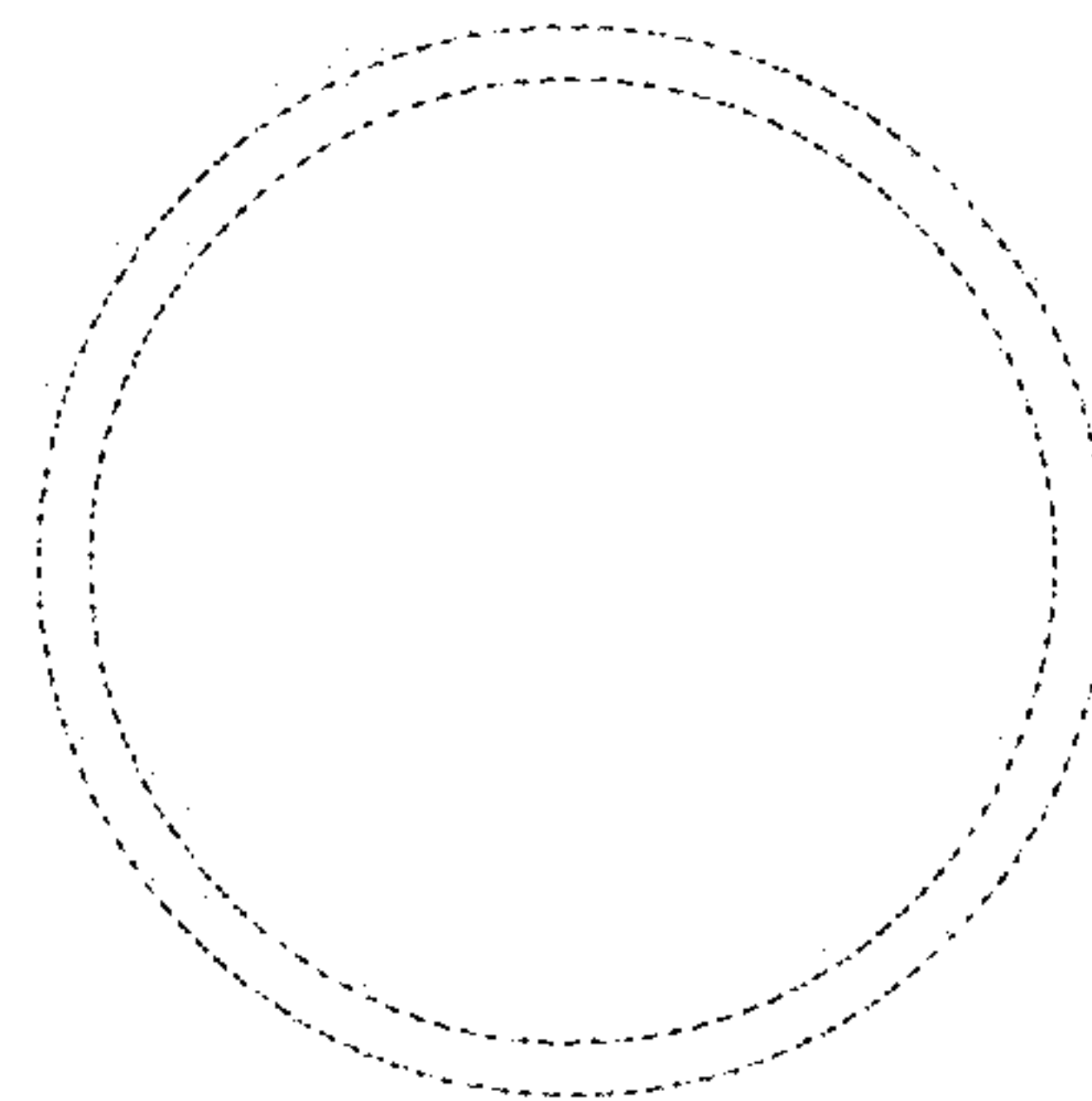

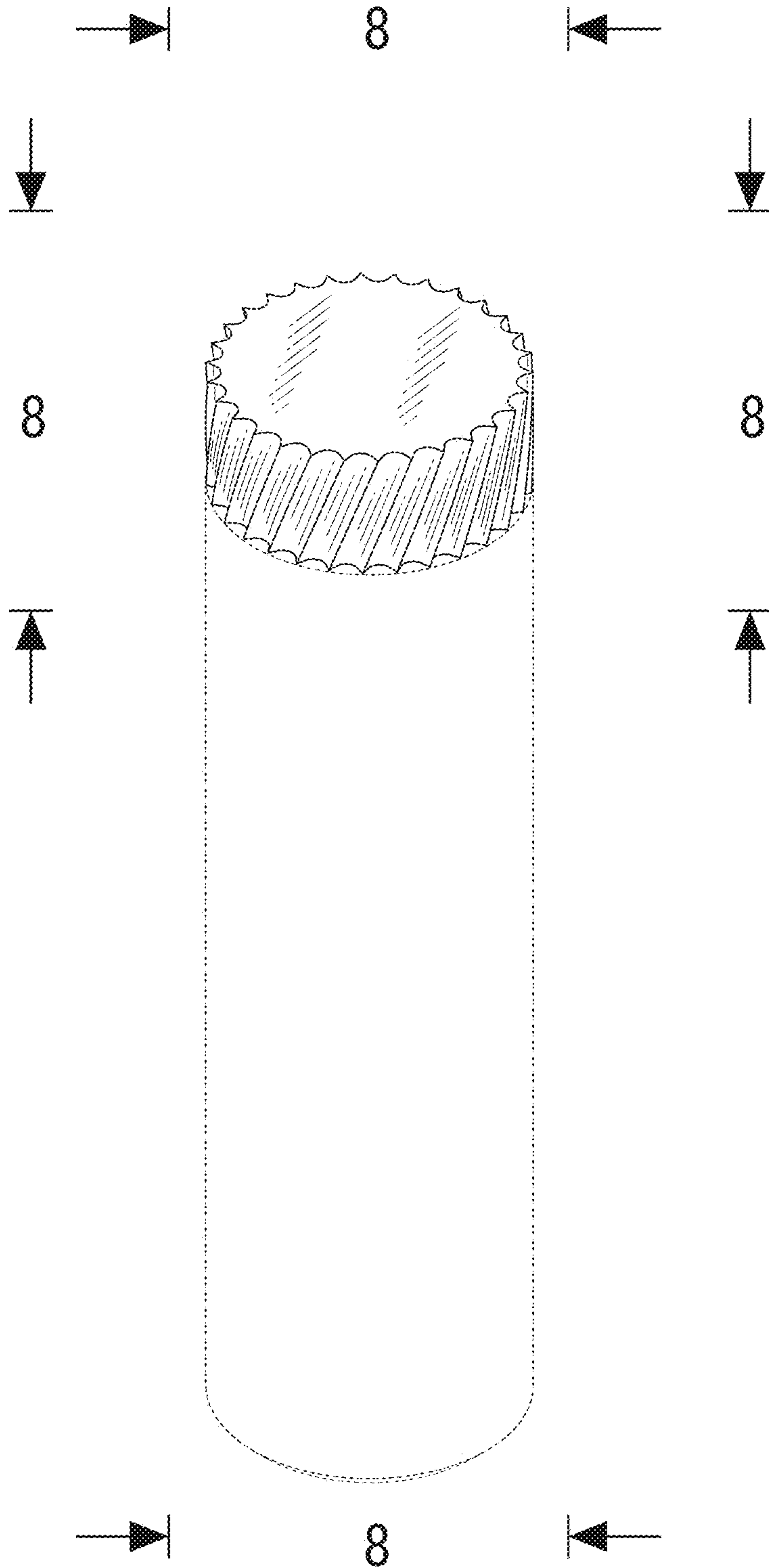

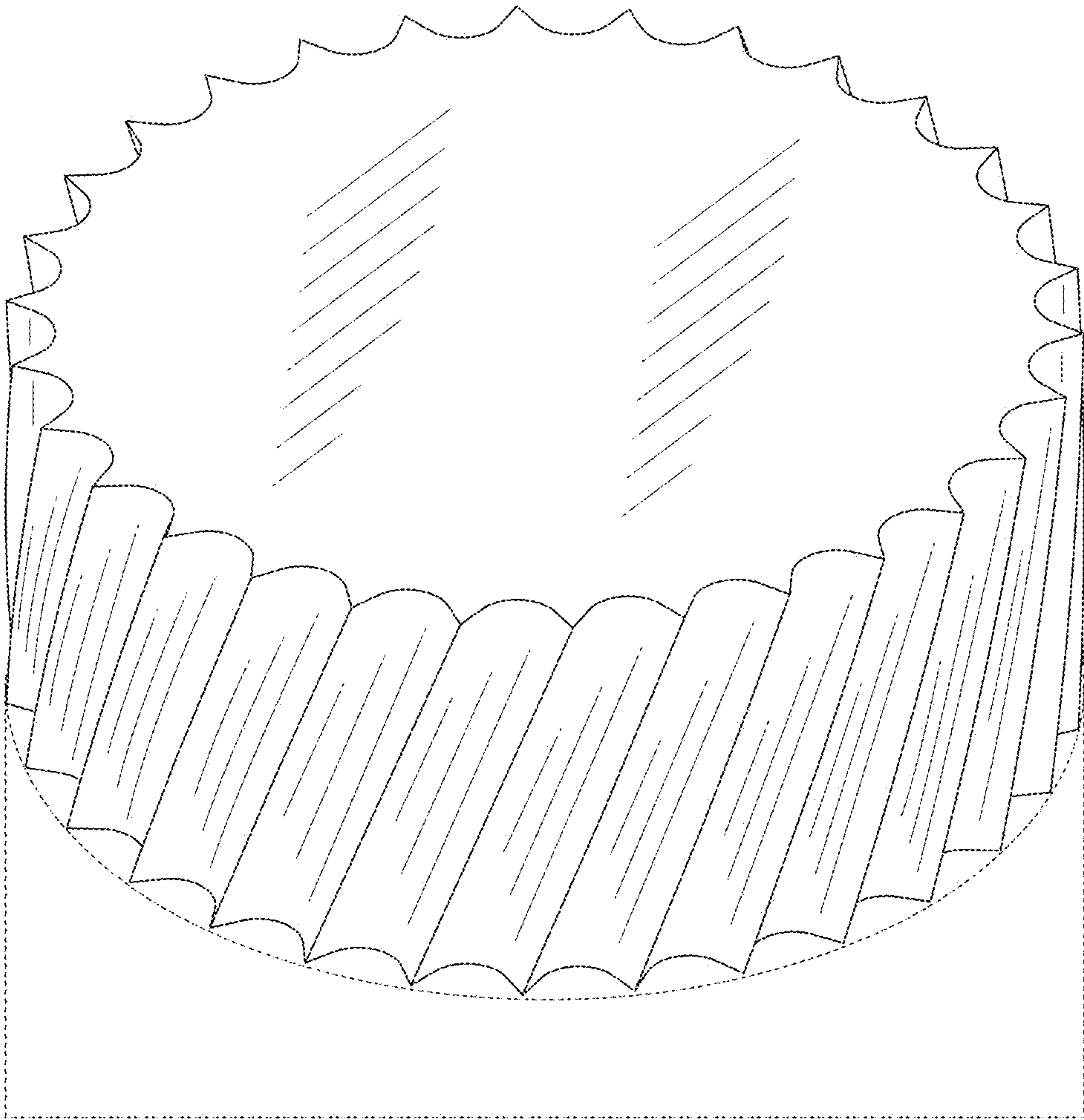

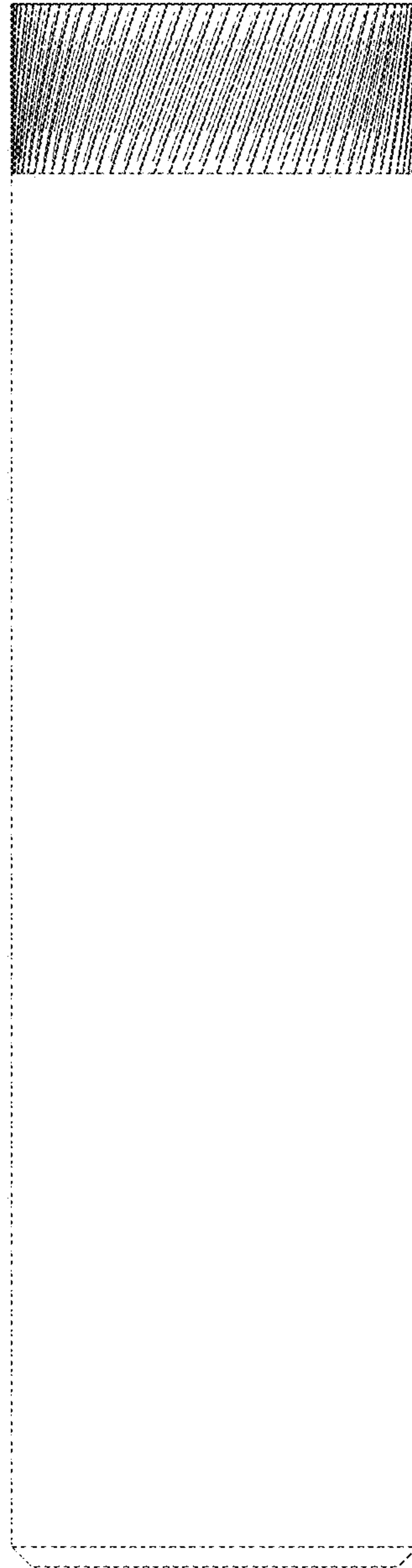

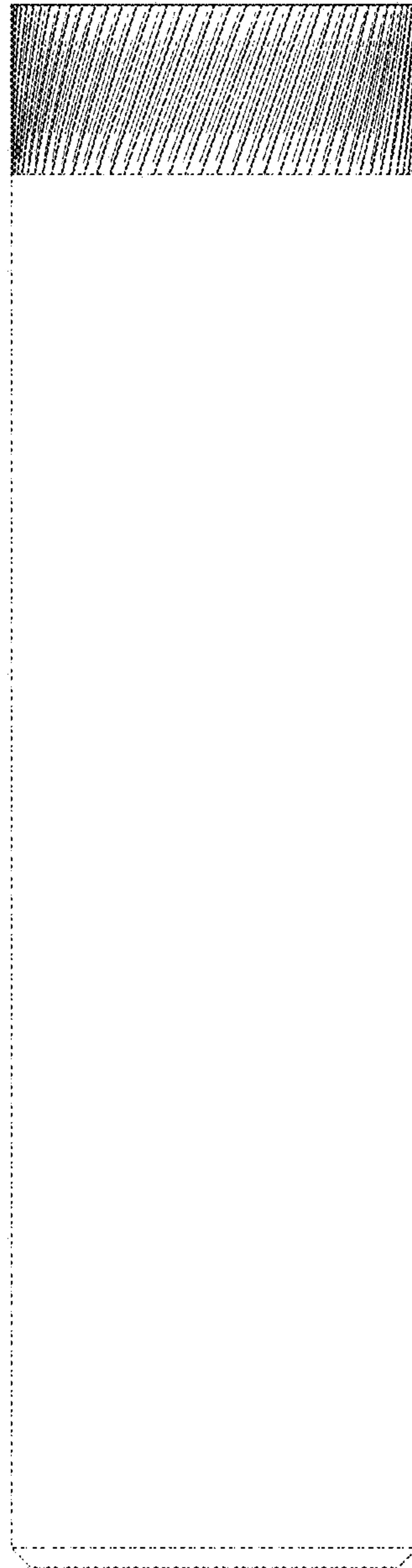

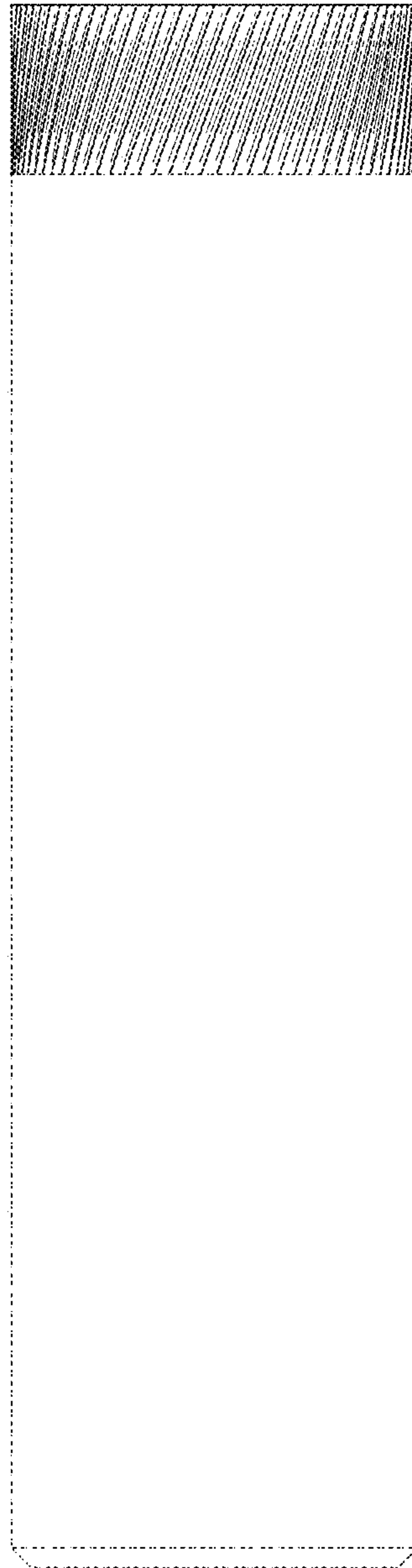

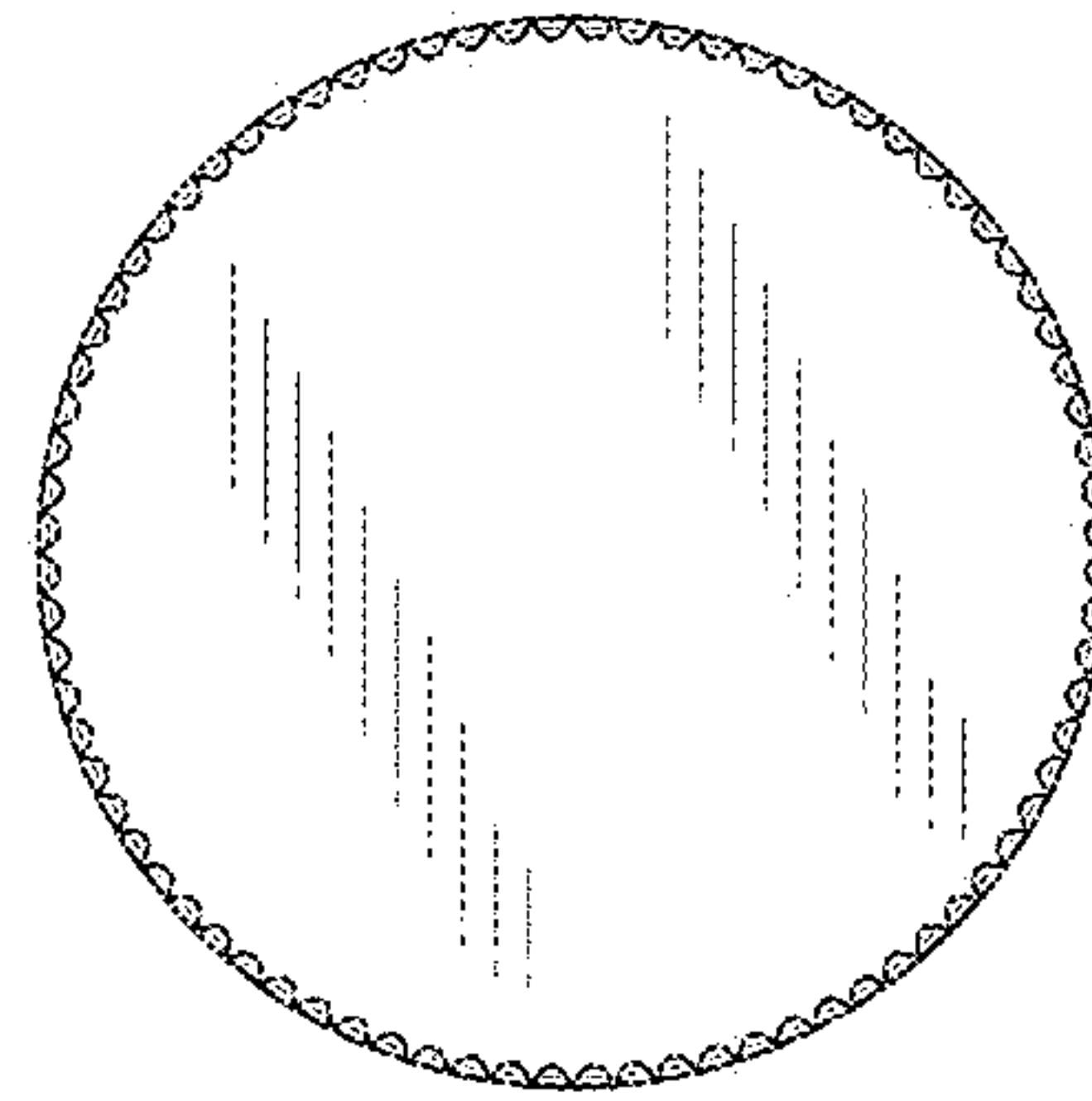

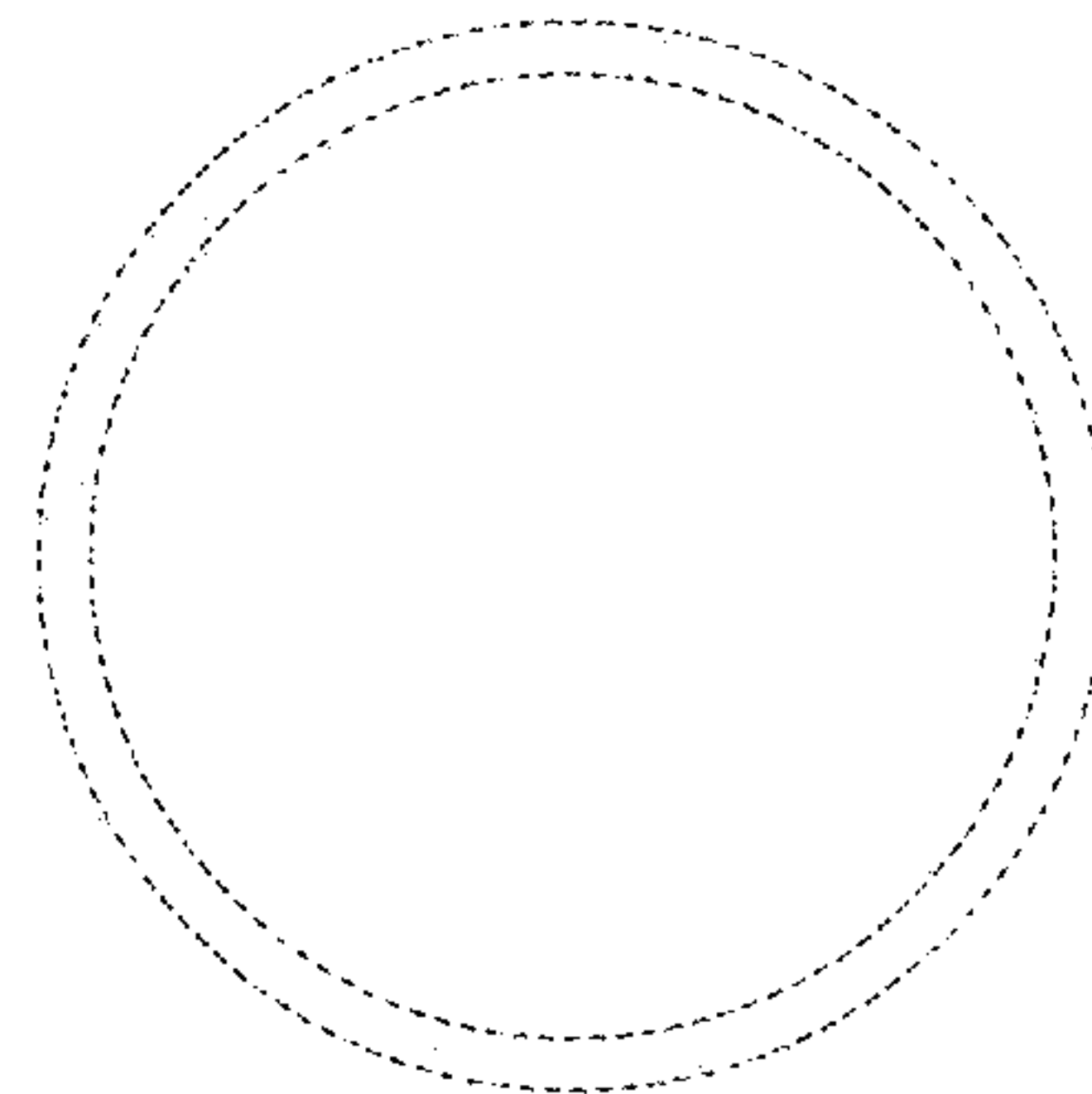

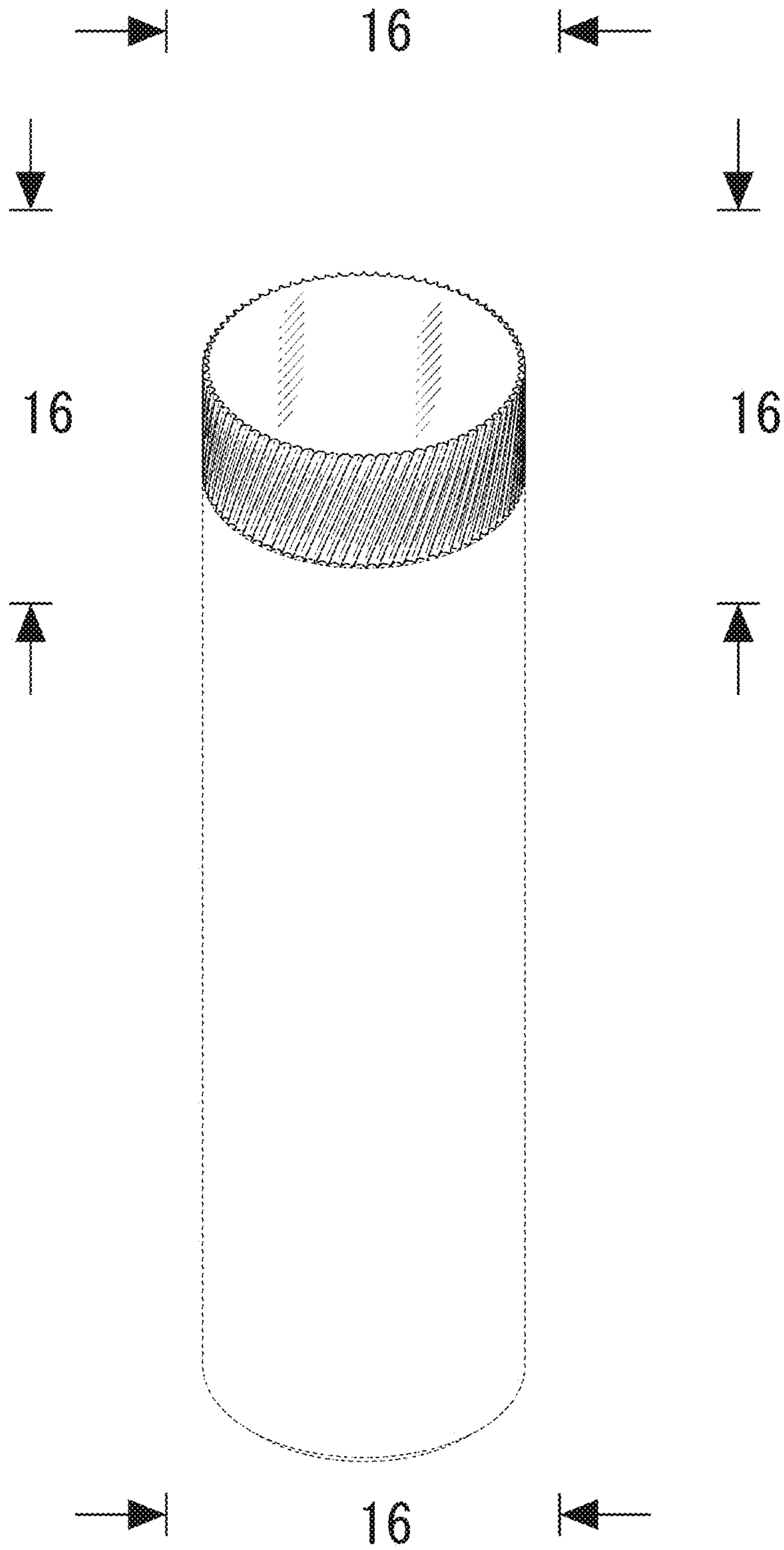

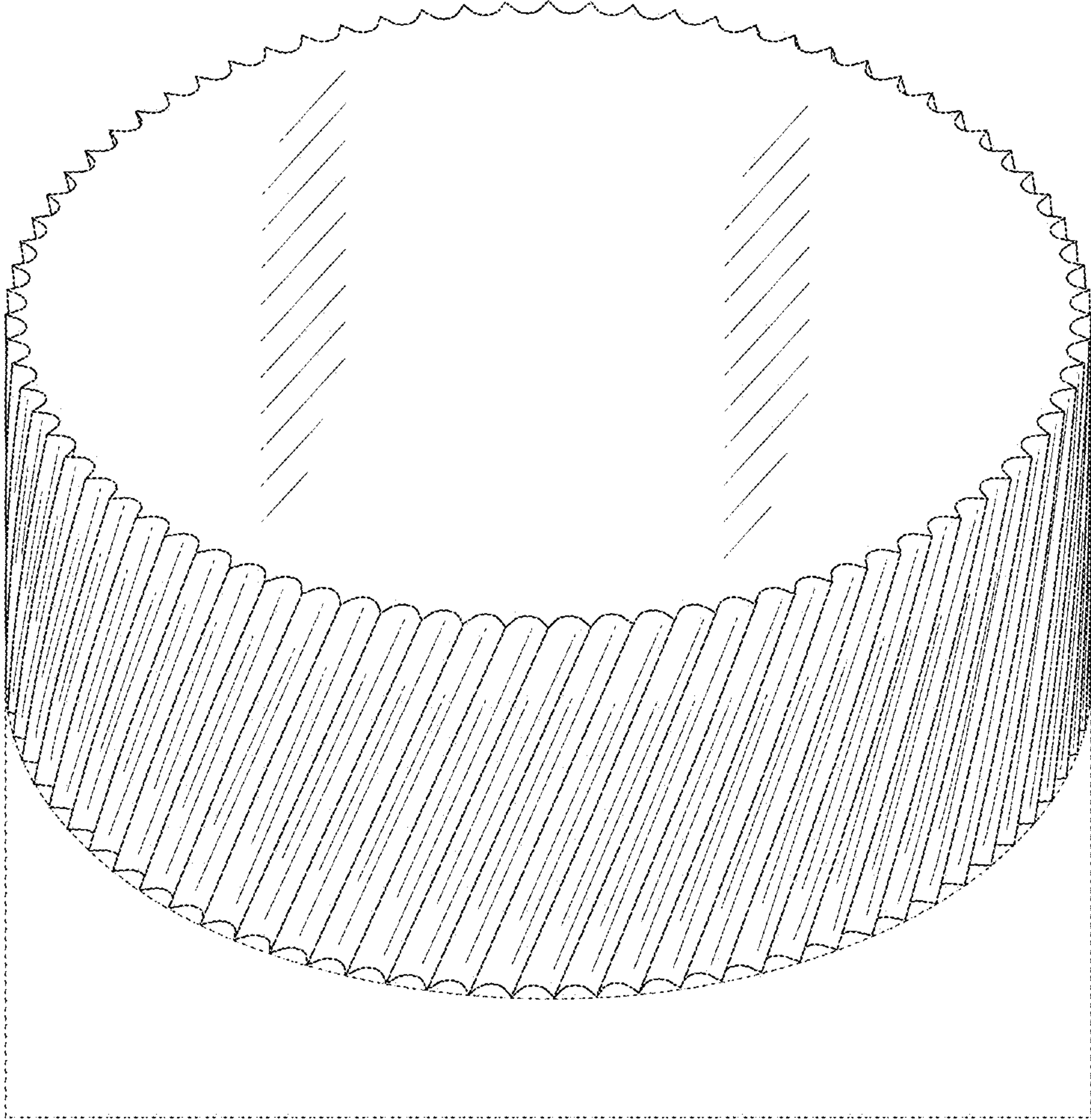

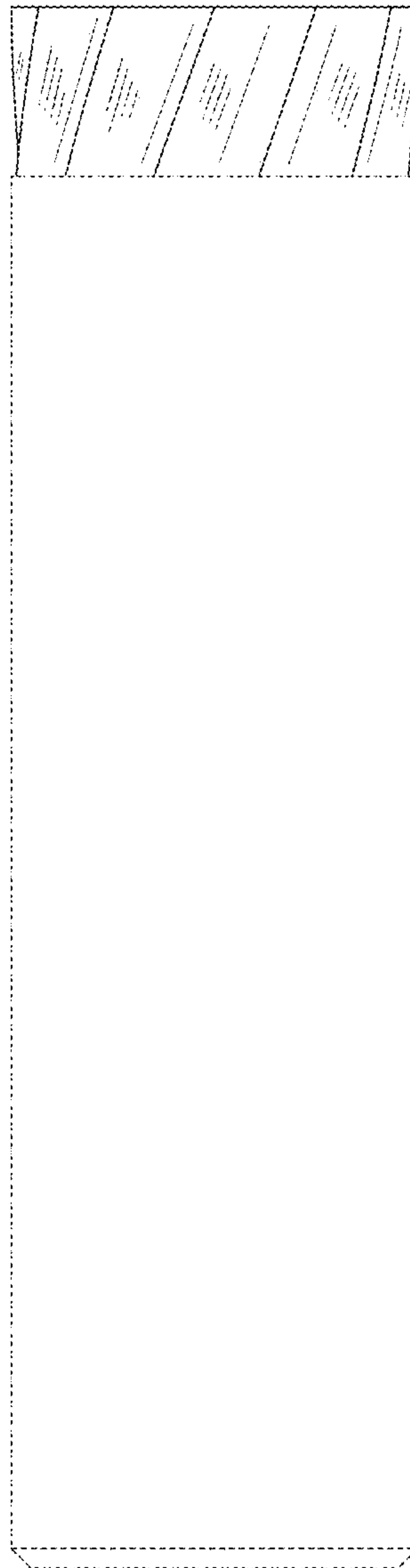

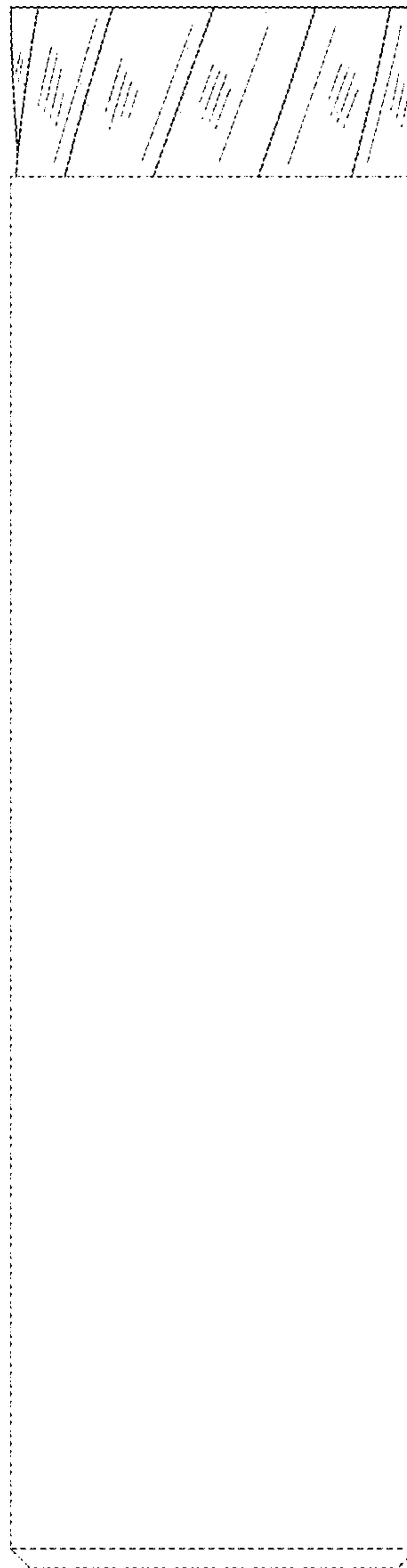

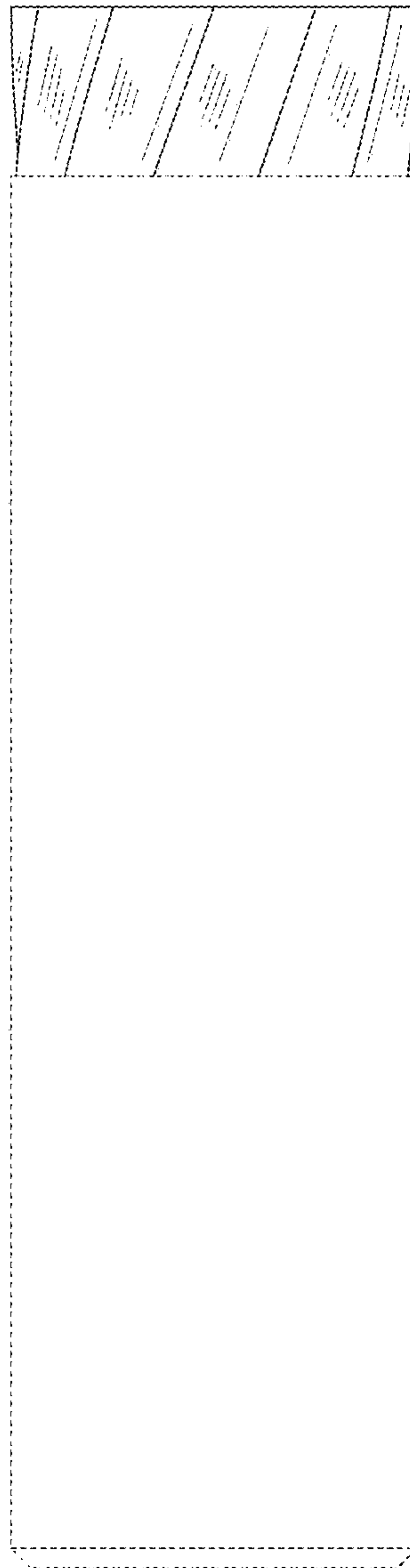

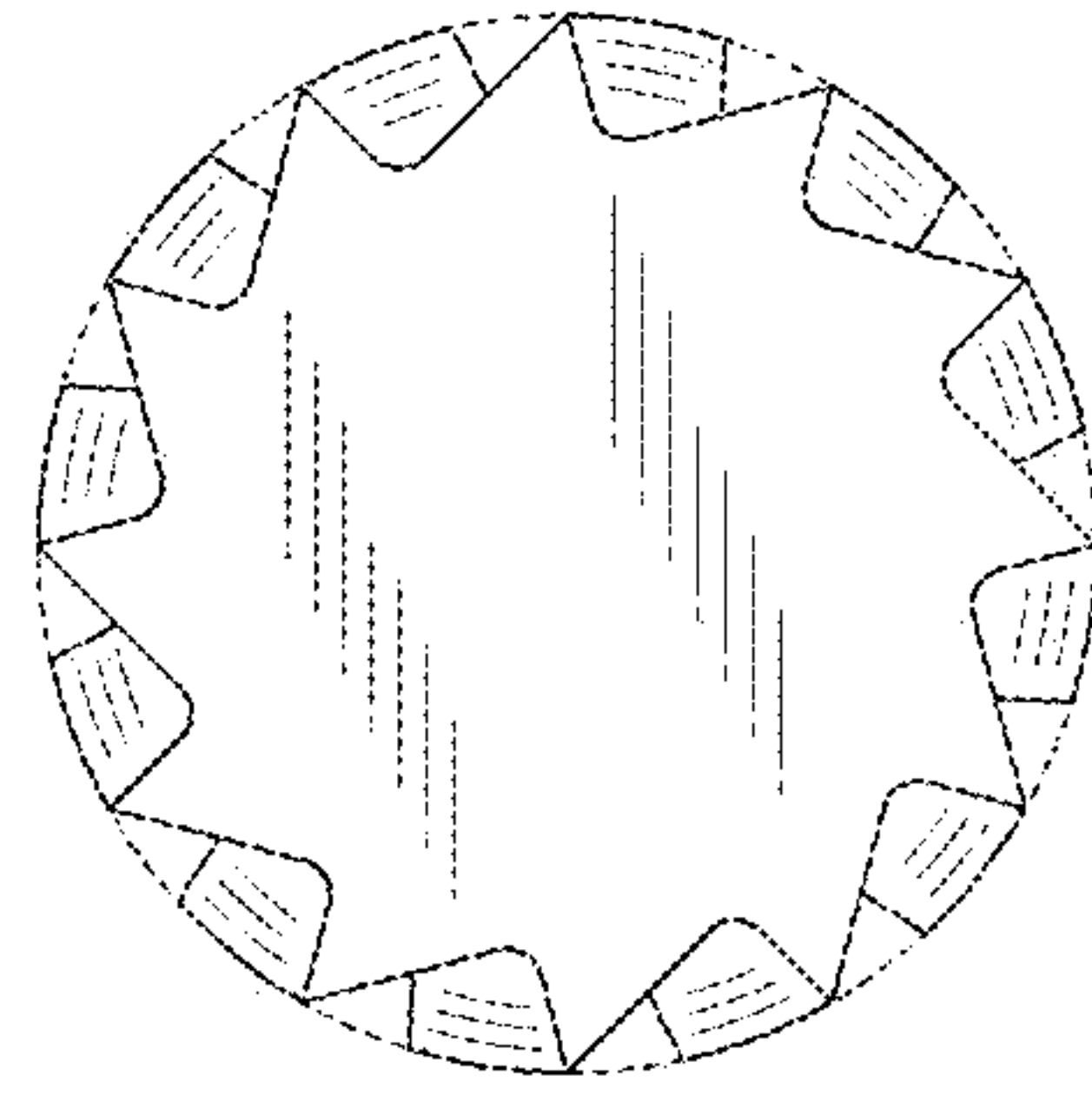

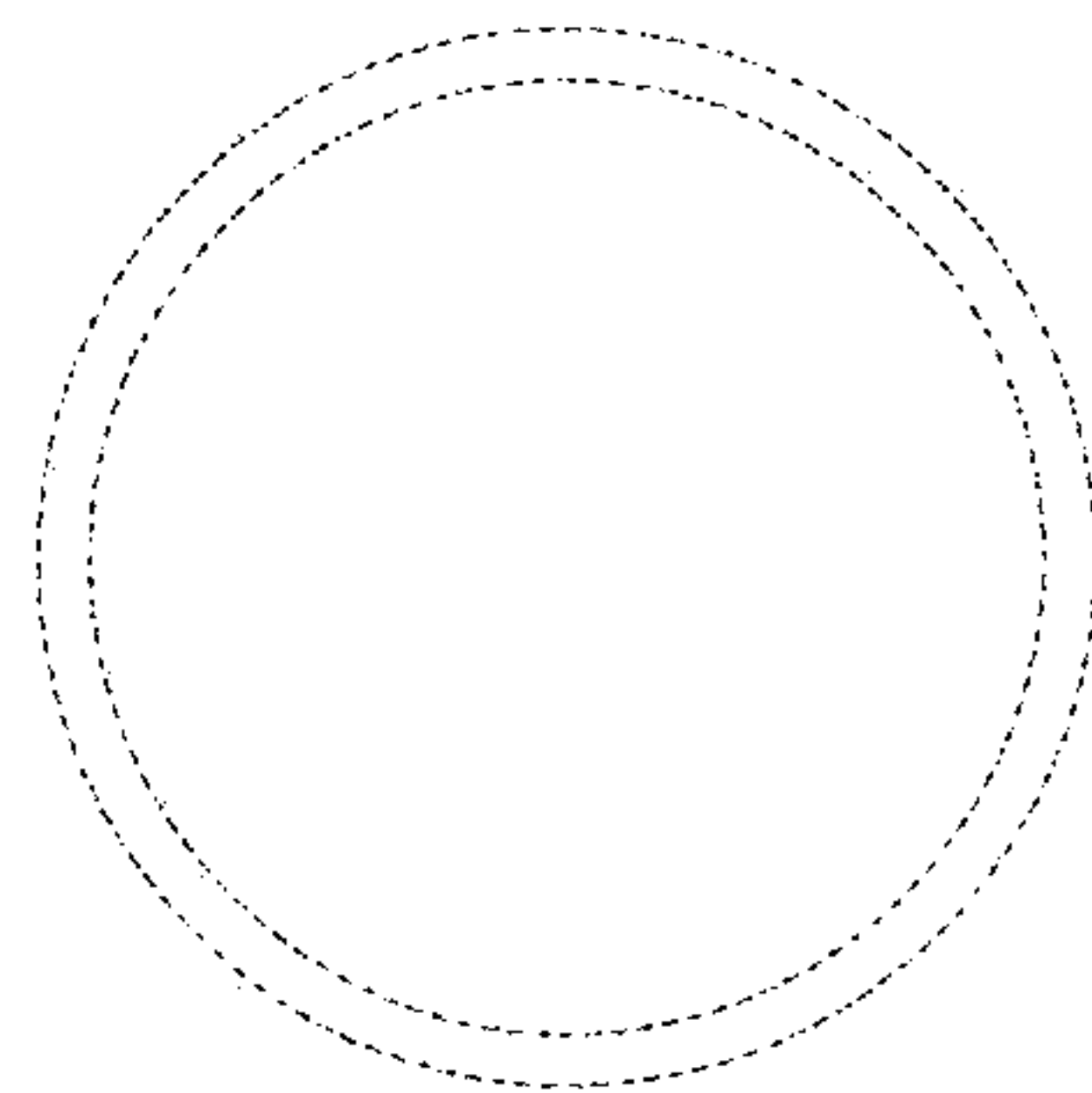

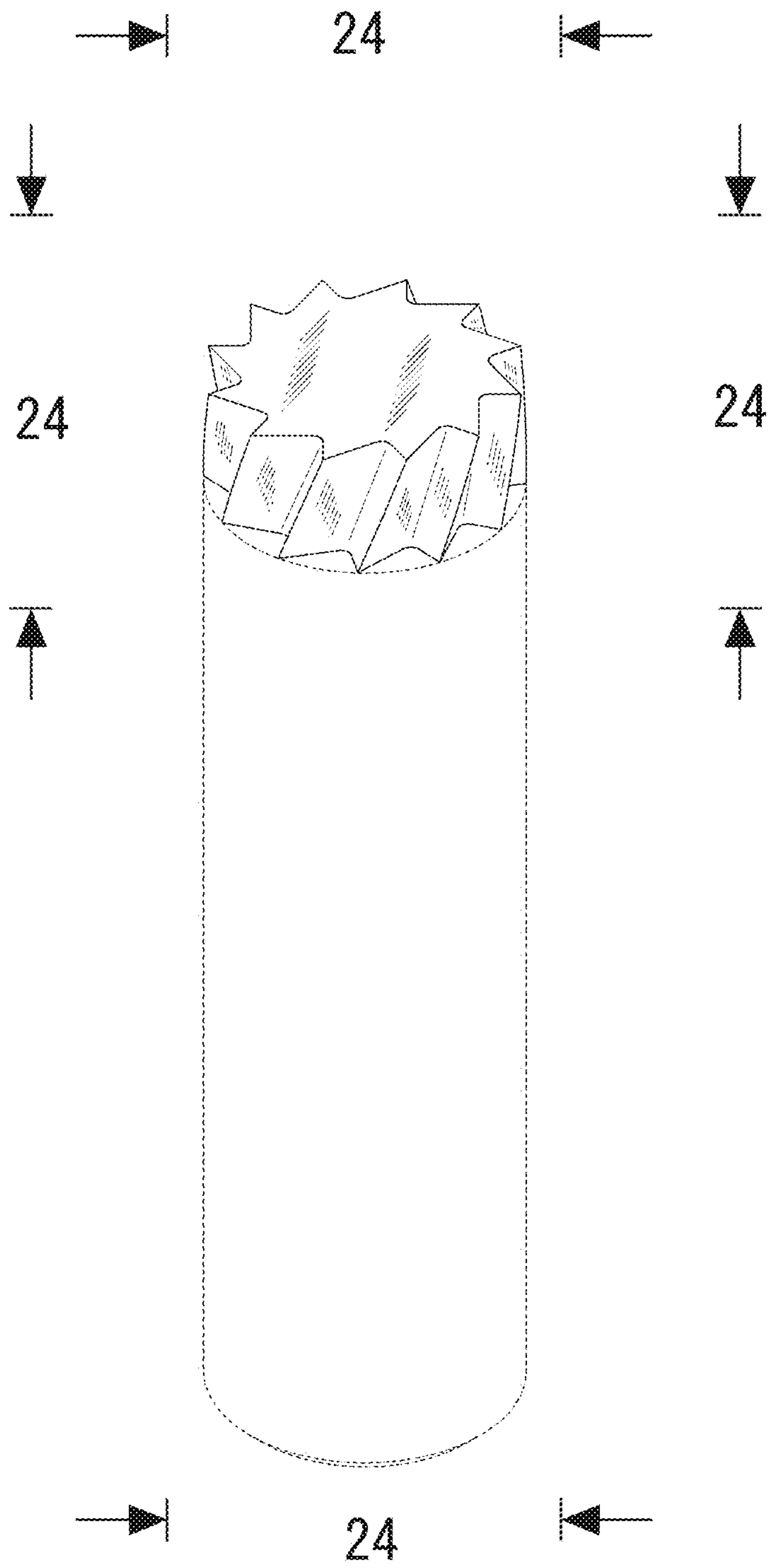
