What is claimed is the educational card set, as shown and described.

**DESCRIPTION**

FIG. 1 shows a front view of a first of the cards, having one heart;  
FIG. 2 shows a front view of a second of the cards, having two hearts;  
FIG. 3 shows a front view of a third of the cards, having three hearts;  
FIG. 4 shows a front view of a fourth of the cards, having four hearts;  
FIG. 5 shows a front view of a fifth of the cards, having five hearts;

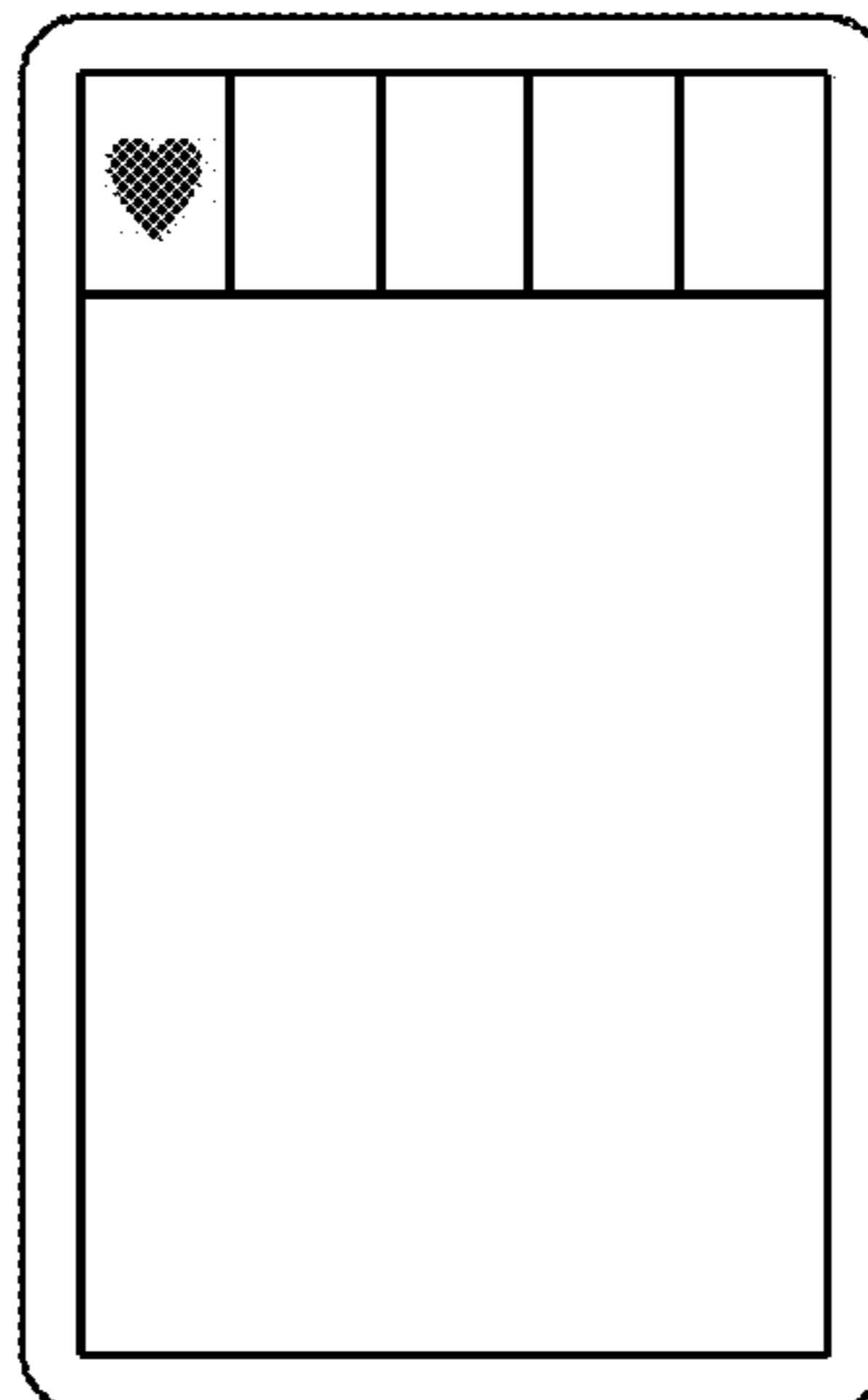


FIG. 6 shows a front view of a sixth of the cards, having six hearts;

FIG. 7 shows a front view of a seventh of the cards, having seven hearts;

FIG. 8 shows a front view of a eighth of the cards, having eight hearts;

FIG. 10 shows a front view of a tenth of the cards, having ten hearts;

FIG. 11 shows a front view of a eleventh of the cards, having eleven hearts;

FIG. 13 shows a front view of a thirteenth of the cards, having thirteen hearts;

FIG. 19 shows a front view of a nineteenth of the cards, having six spades;

FIG. 20 shows a front view of a twentieth of the cards, having seven spades;

FIG. 21 shows a front view of a twenty first of the cards, having eight spades;

FIG. 22 shows a front view of a twenty second of the cards, having nine spades;

FIG. 23 shows a front view of a twenty third of the cards, having ten spades;

FIG. 24 shows a front view of a twenty fourth of the cards, having eleven spades;

FIG. 25 shows a front view of a twenty fifth of the cards, having twelve spades;

FIG. 30 shows a front view of a thirtieth of the cards, having four diamonds;

FIG. 31 shows a front view of a thirty first of the cards, having five diamonds;

FIG. 32 shows a front view of a thirty second of the cards, having six diamonds;

FIG. 33 shows a front view of a thirty third of the cards, having seven diamonds;

FIG. 34 shows a front view of a thirty fourth of the cards, having eight diamonds;

FIG. 35 shows a front view of a thirty fifth of the cards, having nine diamonds;

FIG. 36 shows a front view of a thirty sixth of the cards, having ten diamonds;

FIG. 37 shows a front view of a thirty seventh of the cards, having eleven diamonds;

FIG. 38 shows a front view of a thirty eighth of the cards, having twelve diamonds;

FIG. 39 shows a front view of a thirty ninth of the cards, having thirteen diamonds;

FIGS. 40-52 are a fourth sub-set of the fifty two cards, wherein:

FIG. 40 shows a front view of a fortieth of the cards, having one club;

FIG. 41 shows a front view of a forty first of the cards, having two clubs;

FIG. 42 shows a front view of a forty second of the cards, having three clubs;

FIG. 43 shows a front view of a forty third of the cards, having four clubs;

FIG. 44 shows a front view of a forty fourth of the cards, having five clubs;

FIG. 45 shows a front view of a forty fifth of the cards, having six clubs;

FIG. 46 shows a front view of a forty sixth of the cards, having seven clubs;

FIG. 47 shows a front view of a forty seventh of the cards, having eight clubs;

FIG. 48 shows a front view of a forty eighth of the cards, having nine clubs;

FIG. 49 shows a front view of a forty ninth of the cards, having ten clubs;

FIG. 50 shows a front view of a fiftieth of the cards, having eleven clubs;

FIG. 51 shows a front view of a fifty first of the cards, having twelve clubs;

FIG. 52 shows a front view of a fifty second of the cards, having thirteen clubs;

FIG. 53 is a rear view of the card shown in FIG. 1, wherein the perimeter is shown in broken lines as the rear view is not claimed in the present design, and wherein the rear views of each of the cards shown in FIGS. 2 through 52 are the same as that shown in FIG. 53;

FIG. 54 is a bottom end view of the card shown in FIG. 1 from the bottom end of FIG. 1, wherein the rear, left and right edge portions shown in FIG. 54 are shown in broken lines and not claimed in the present design in which only the front sides of each of the fifty two cards are claimed in the present design, and wherein the bottom end views of each of the cards shown in FIGS. 2 through 52 are the same as that shown in FIG. 54, and wherein the top end views of each of the cards shown in FIGS. 1 through 52 are a mirror image of the view shown in FIG. 54; and,

FIG. 55 is a left side view of the card shown in FIG. 1 from the left side of FIG. 1, wherein rear, top and bottom edge portions shown in FIG. 55 are shown in broken lines and not claimed in the present design in which only the front faces of each of the fifty two cards are claimed in the present design, and wherein the left side views of each of the cards shown in FIGS. 2 through 52 are the same as that shown in FIG. 55, and wherein the right side views of each of the cards shown in FIGS. 1 through 52 are a mirror image of the view shown in FIG. 55.

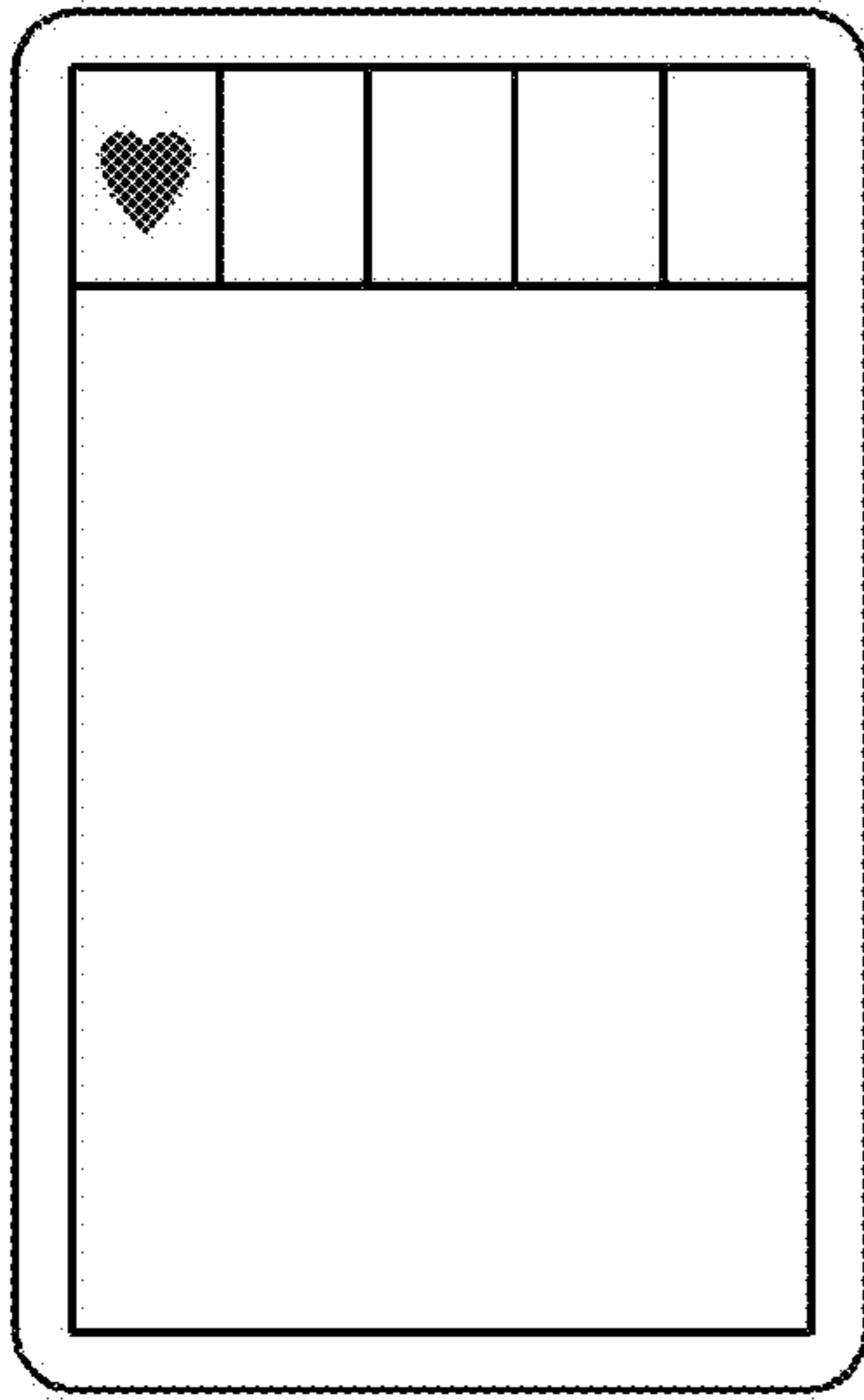

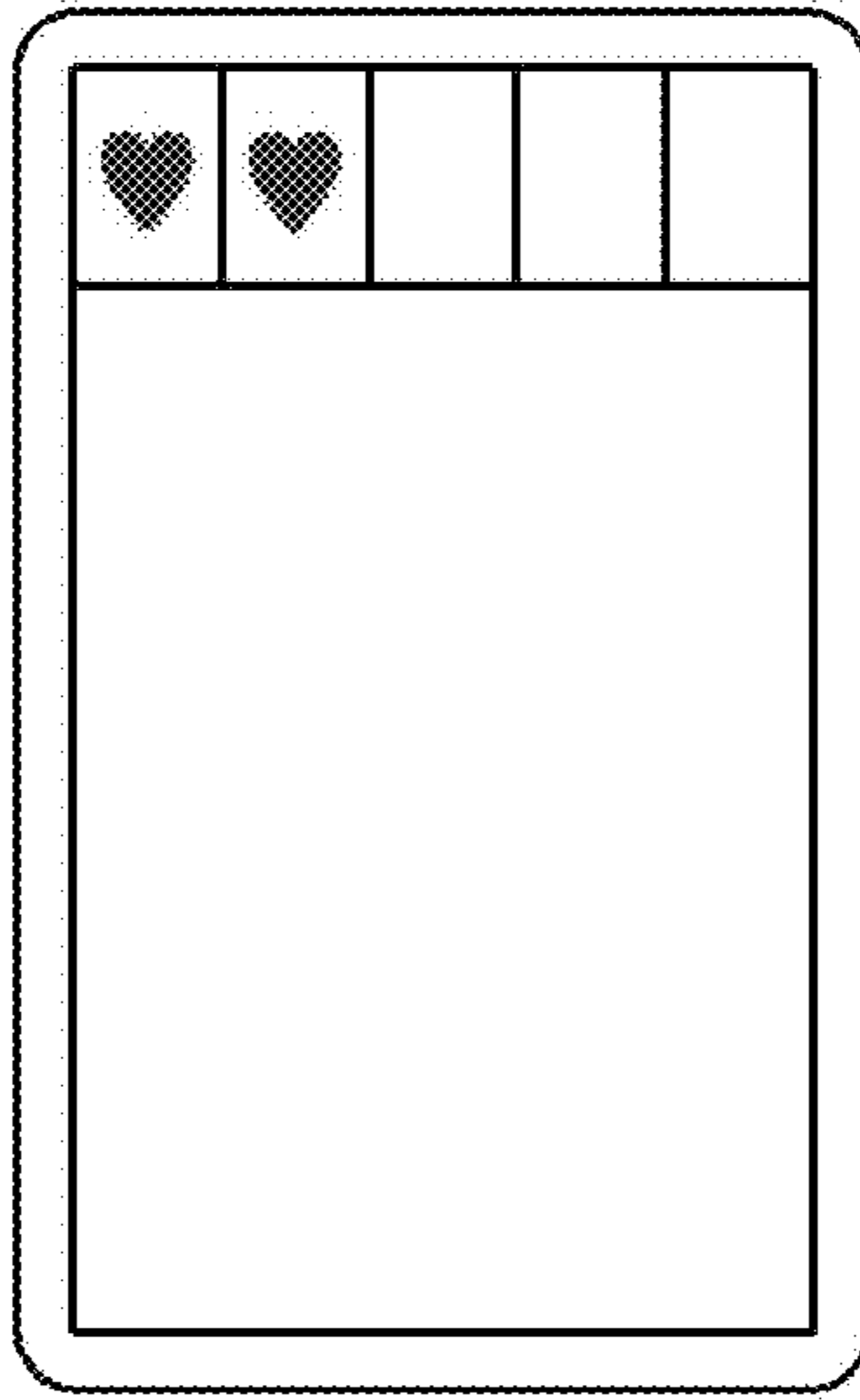

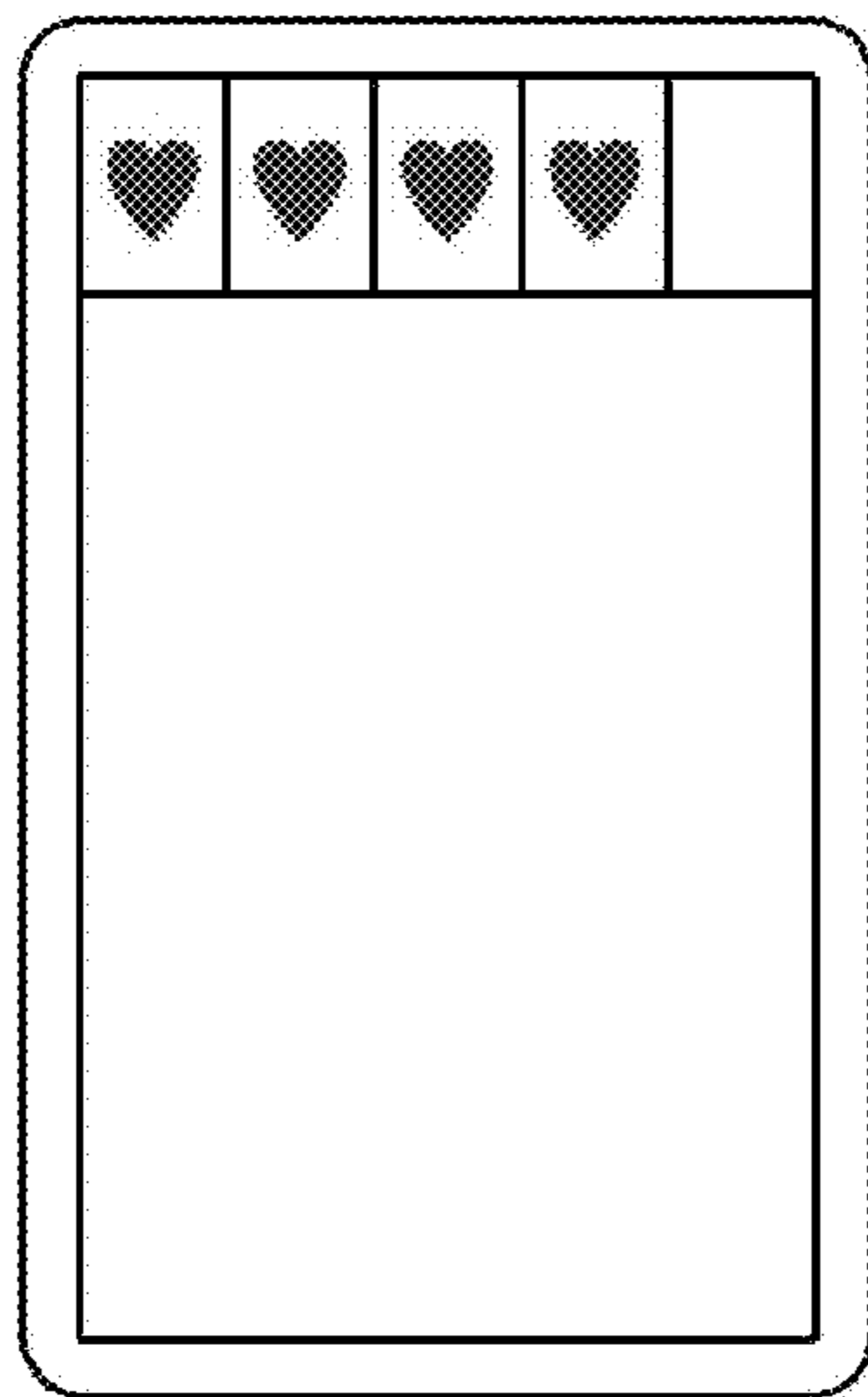
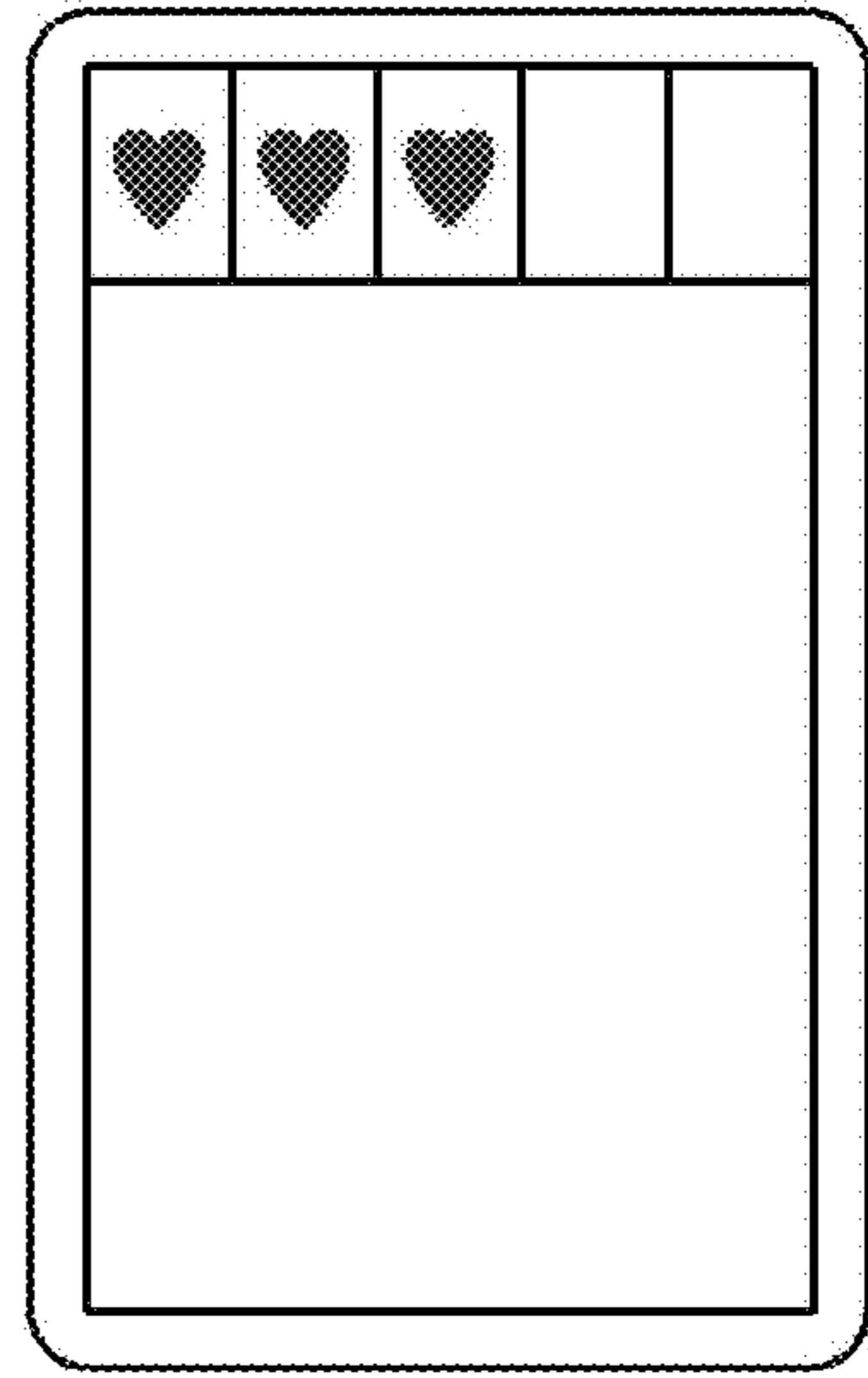

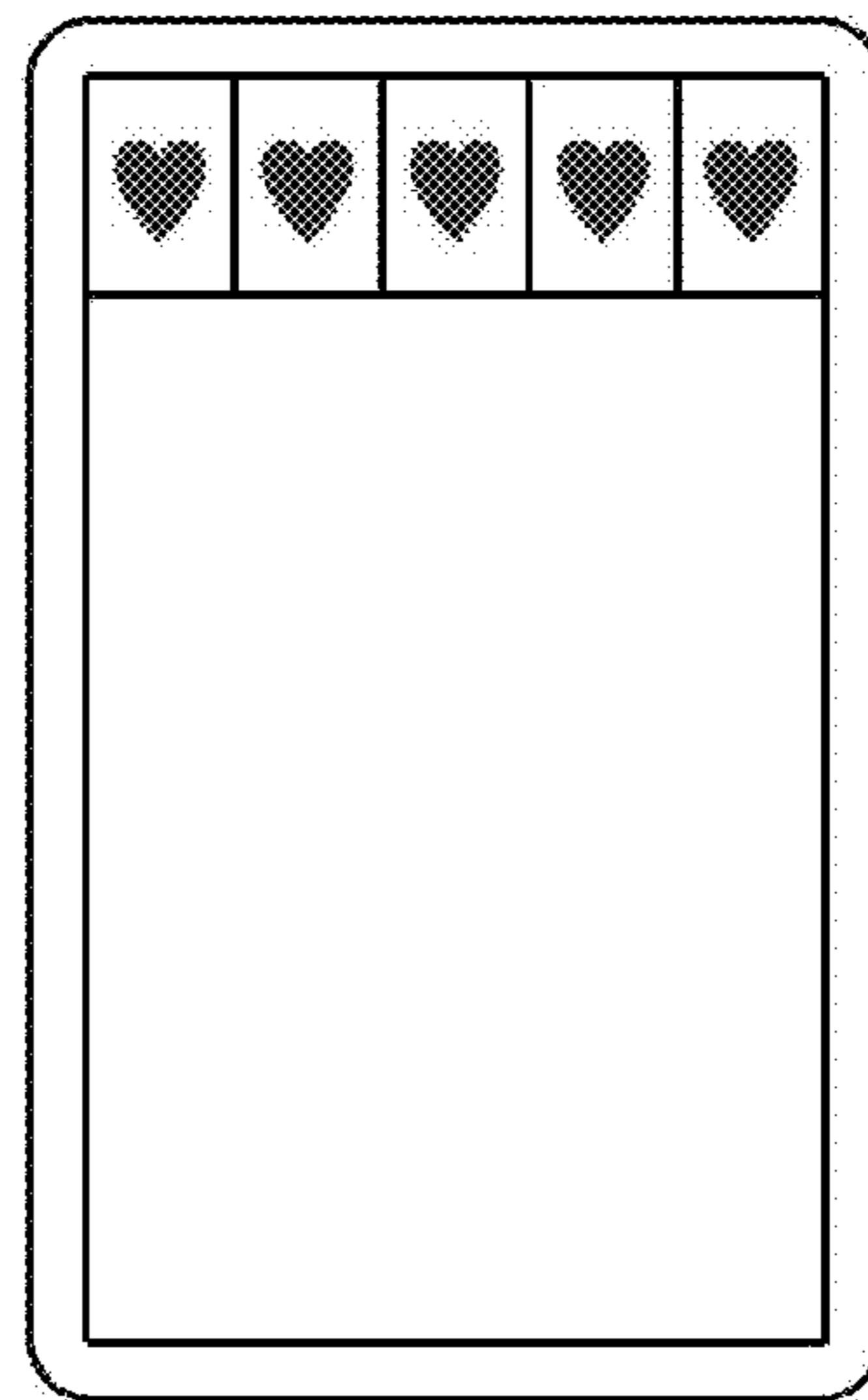

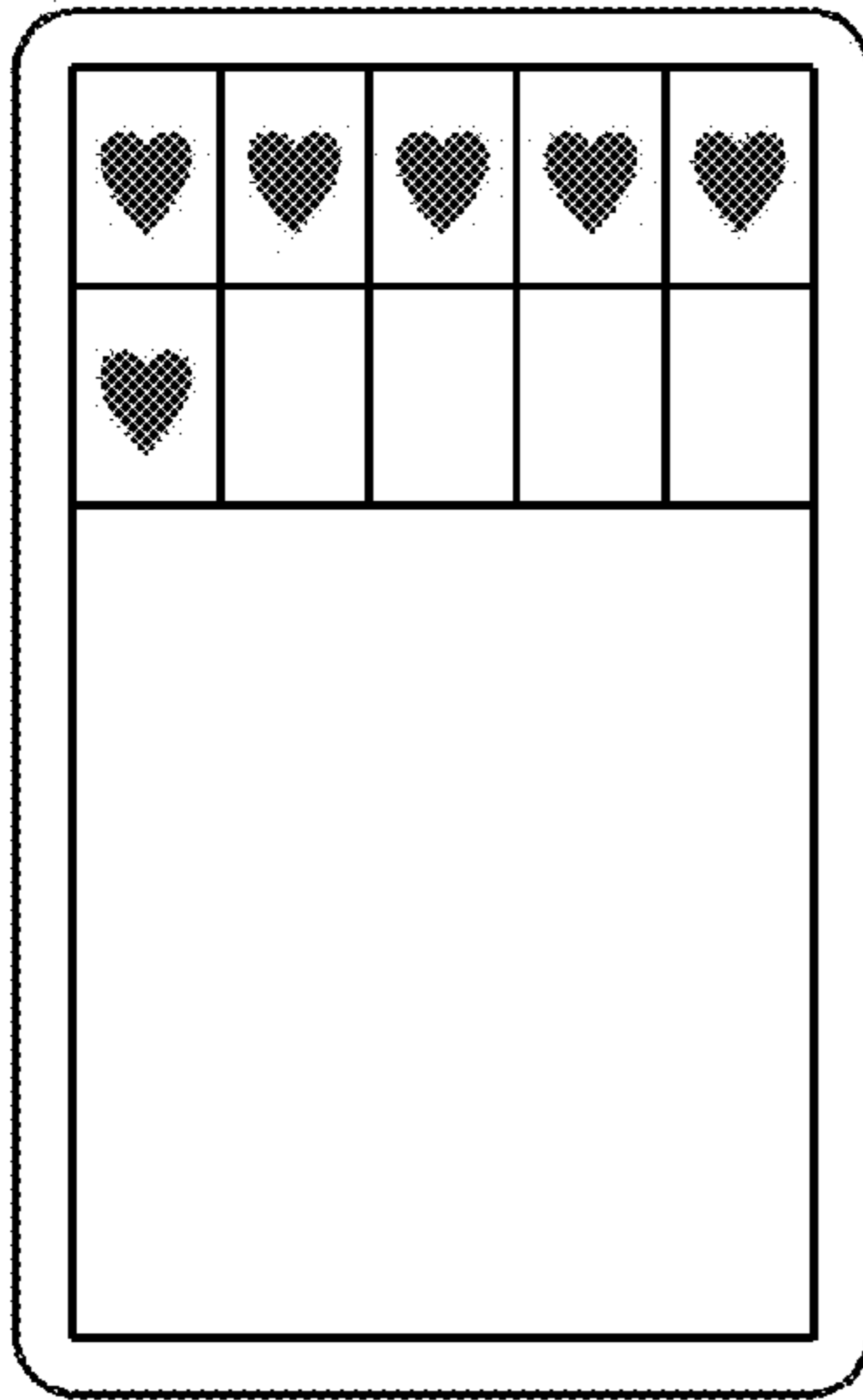

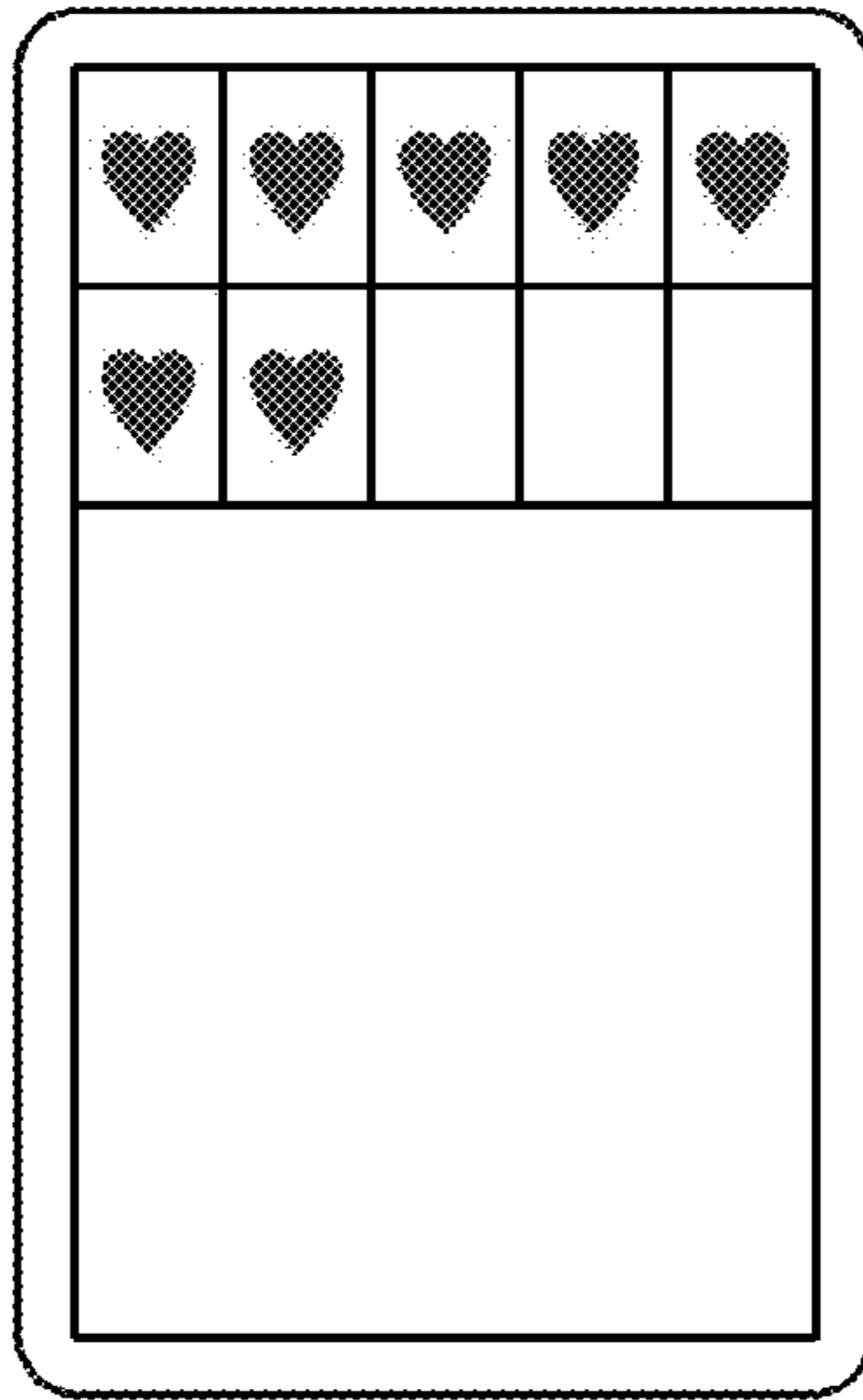

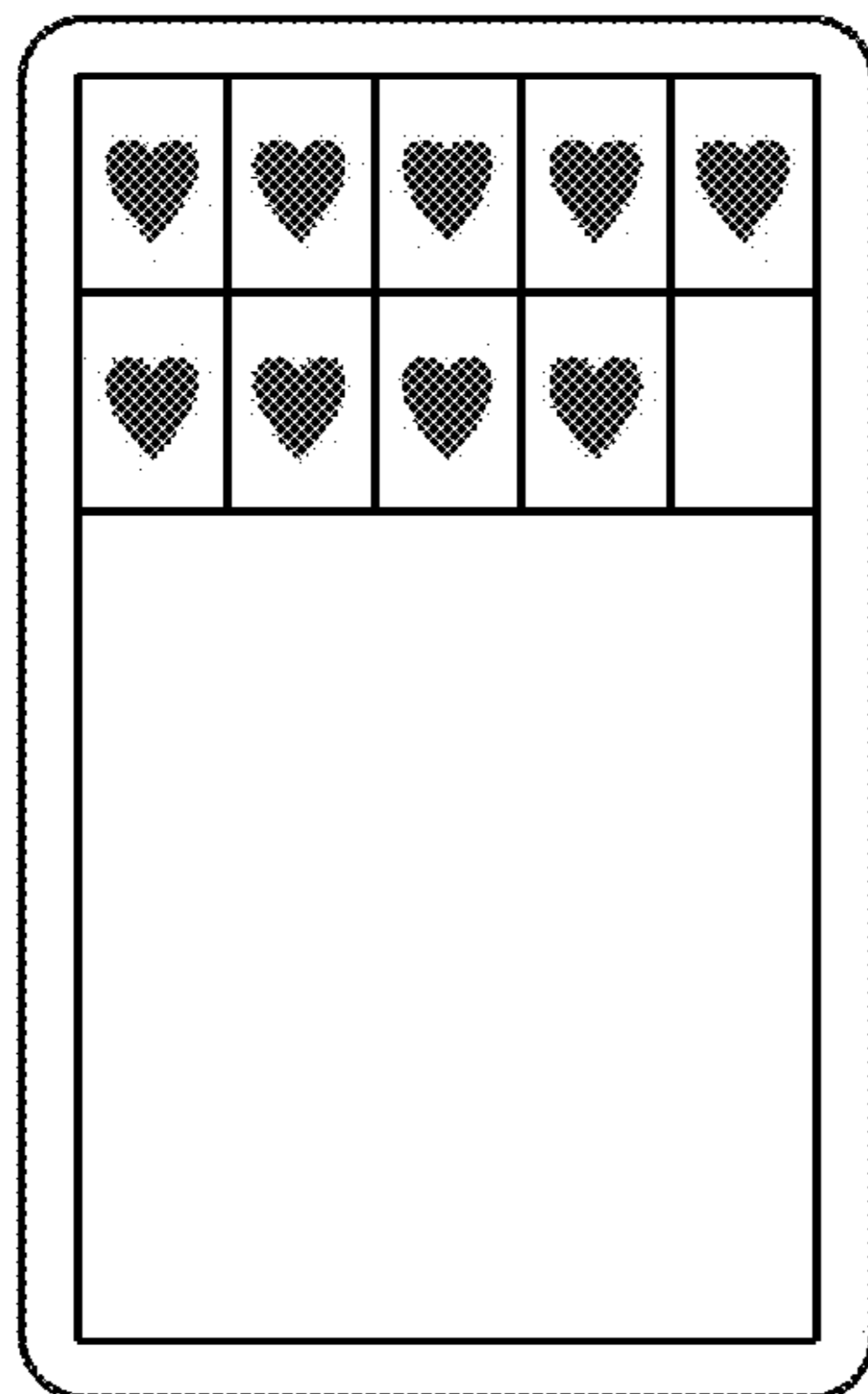
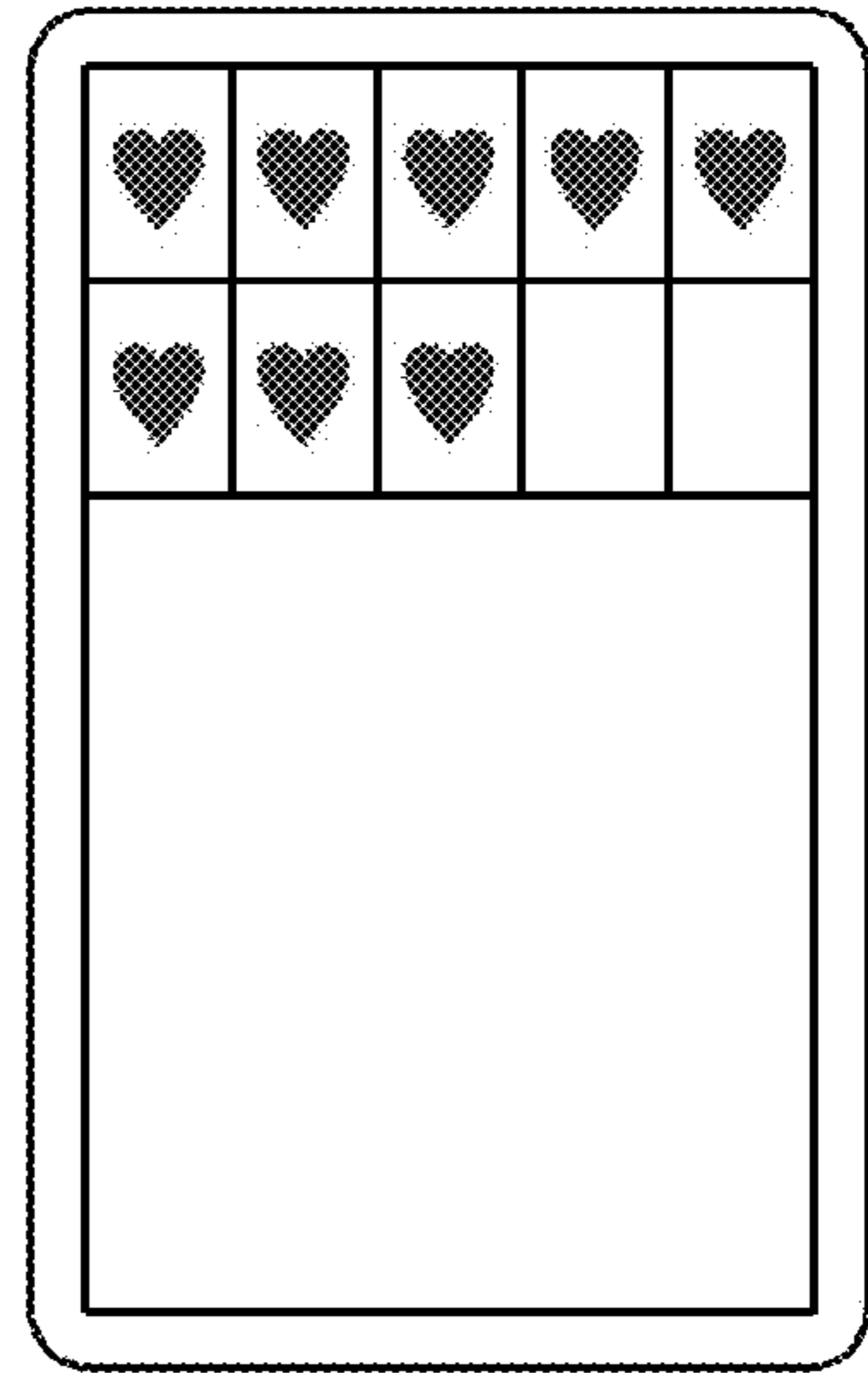

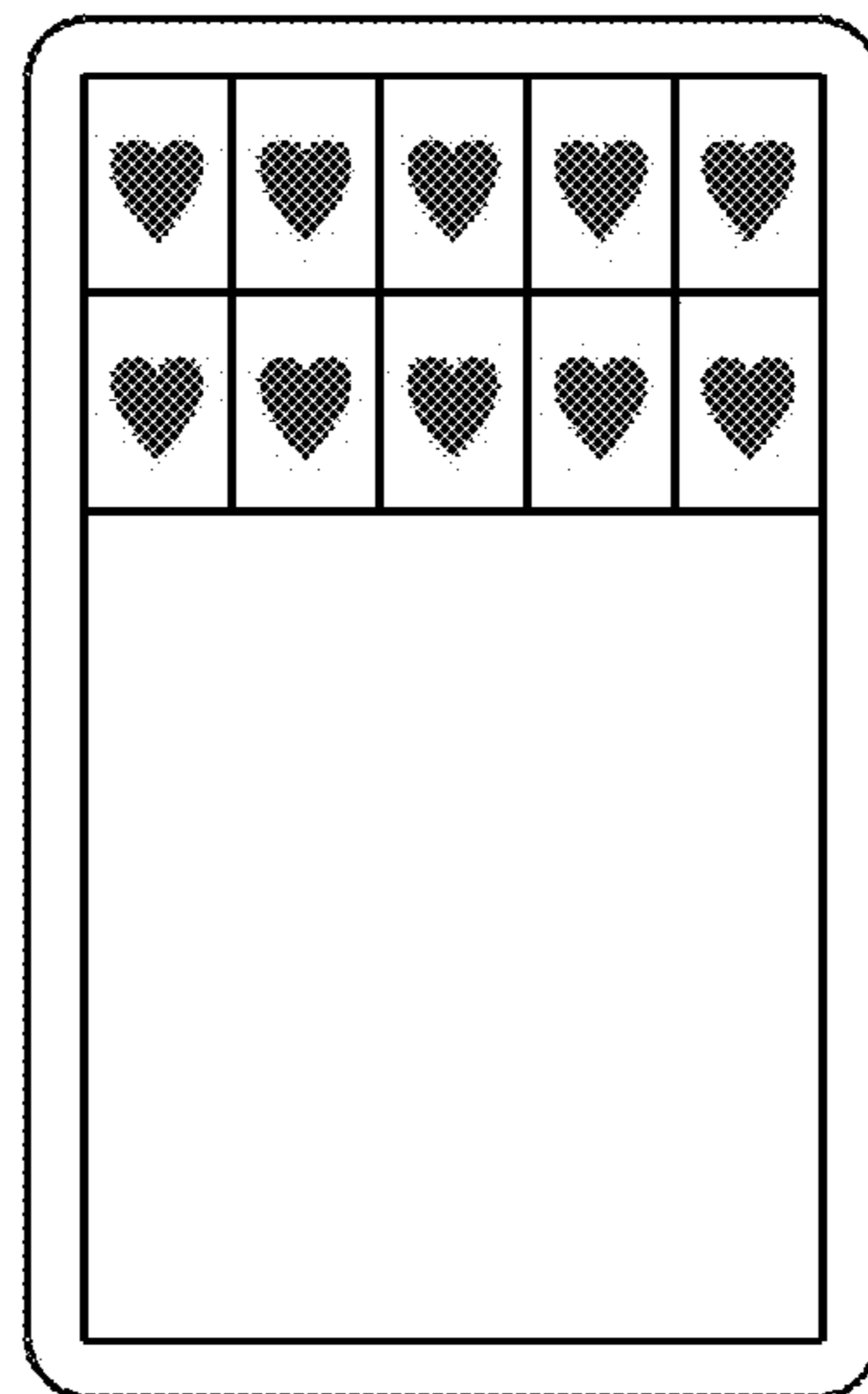

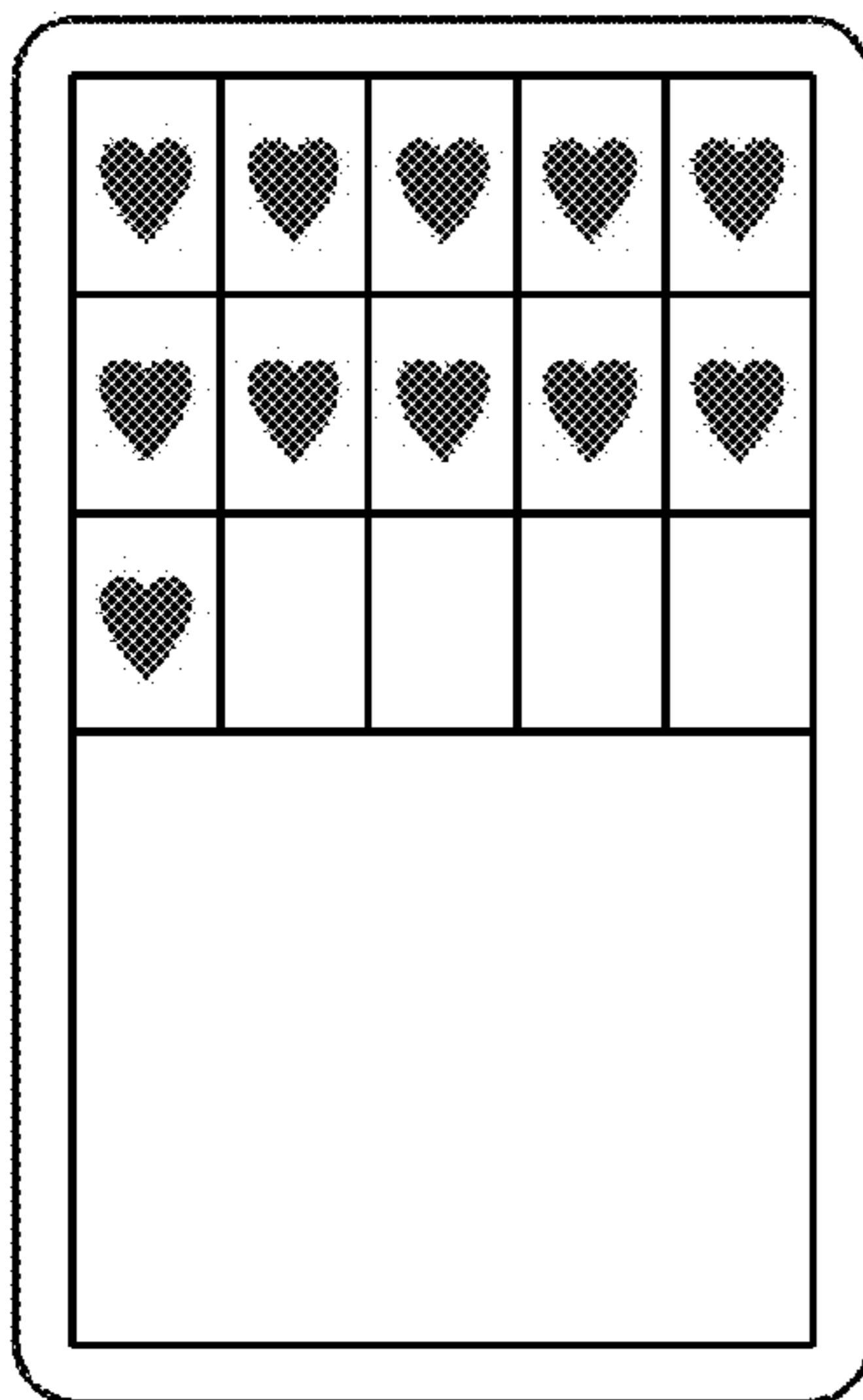

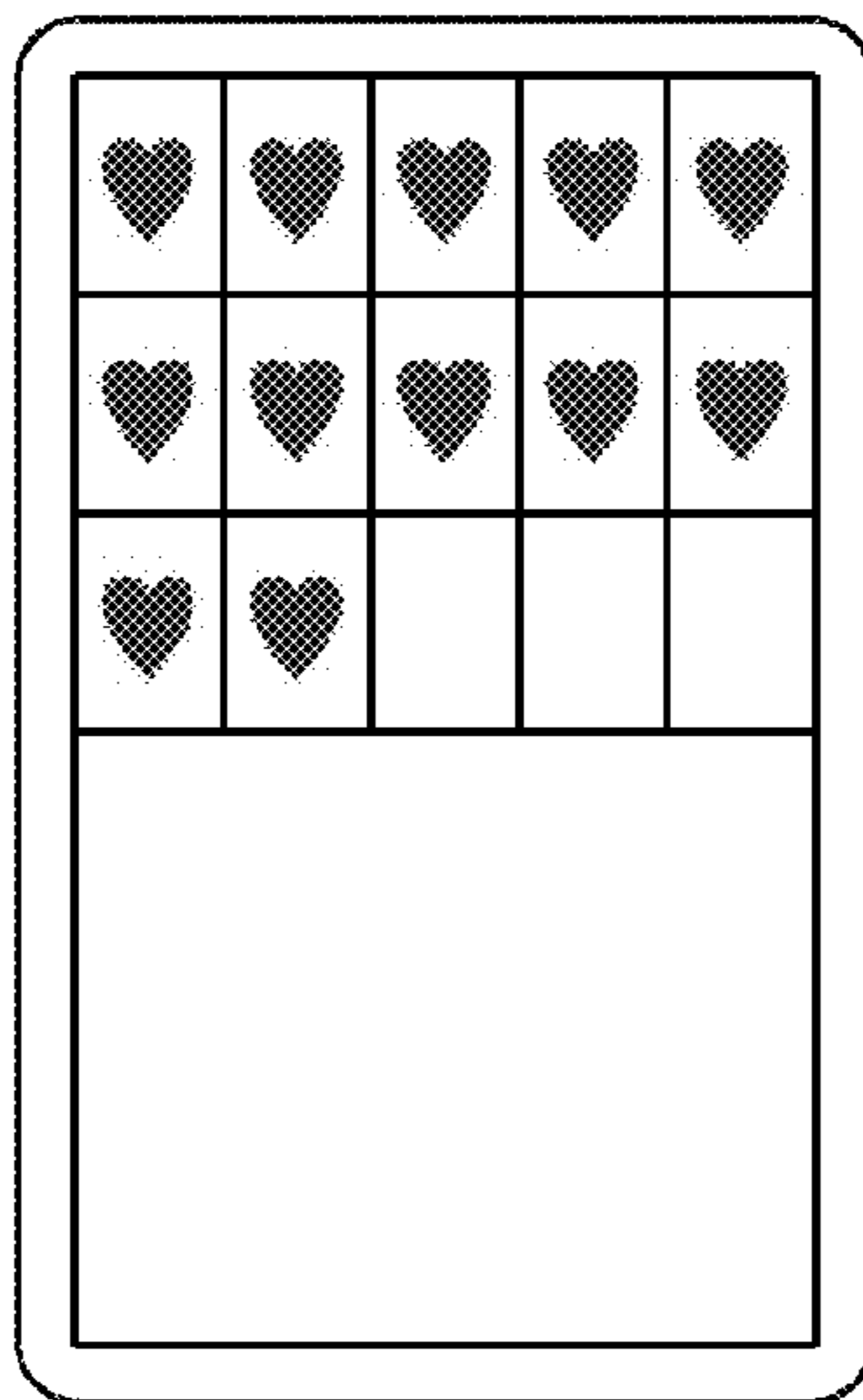

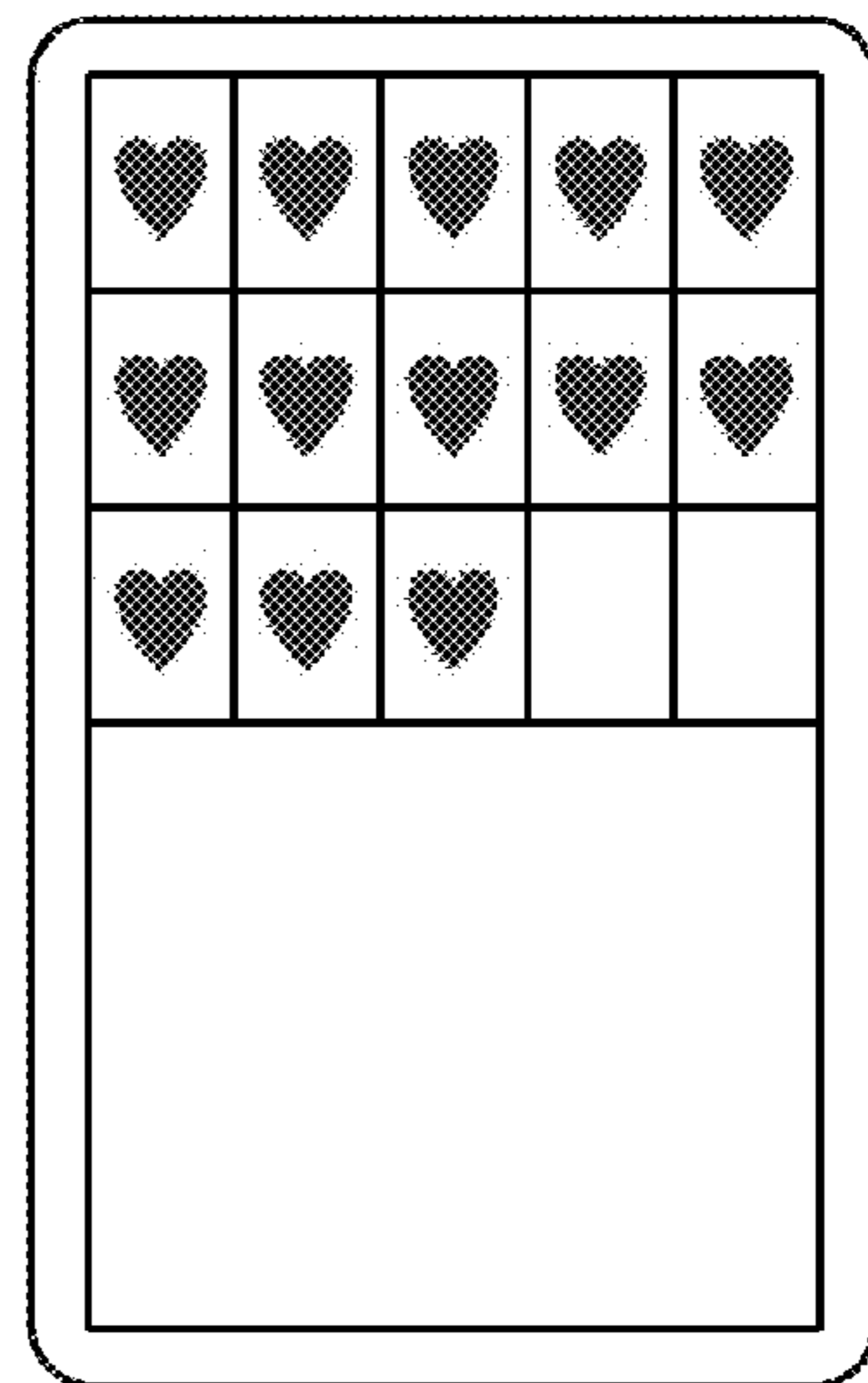

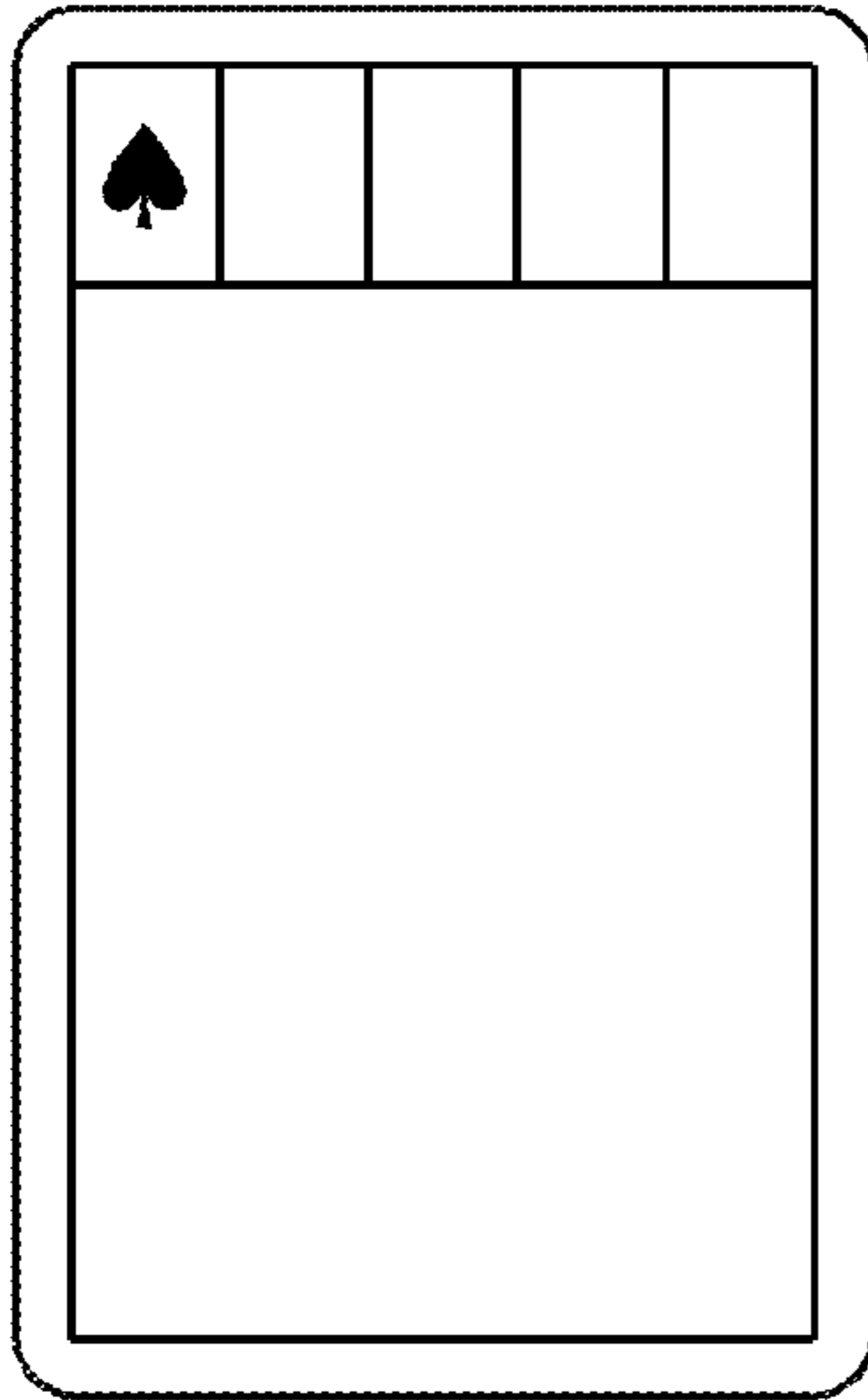

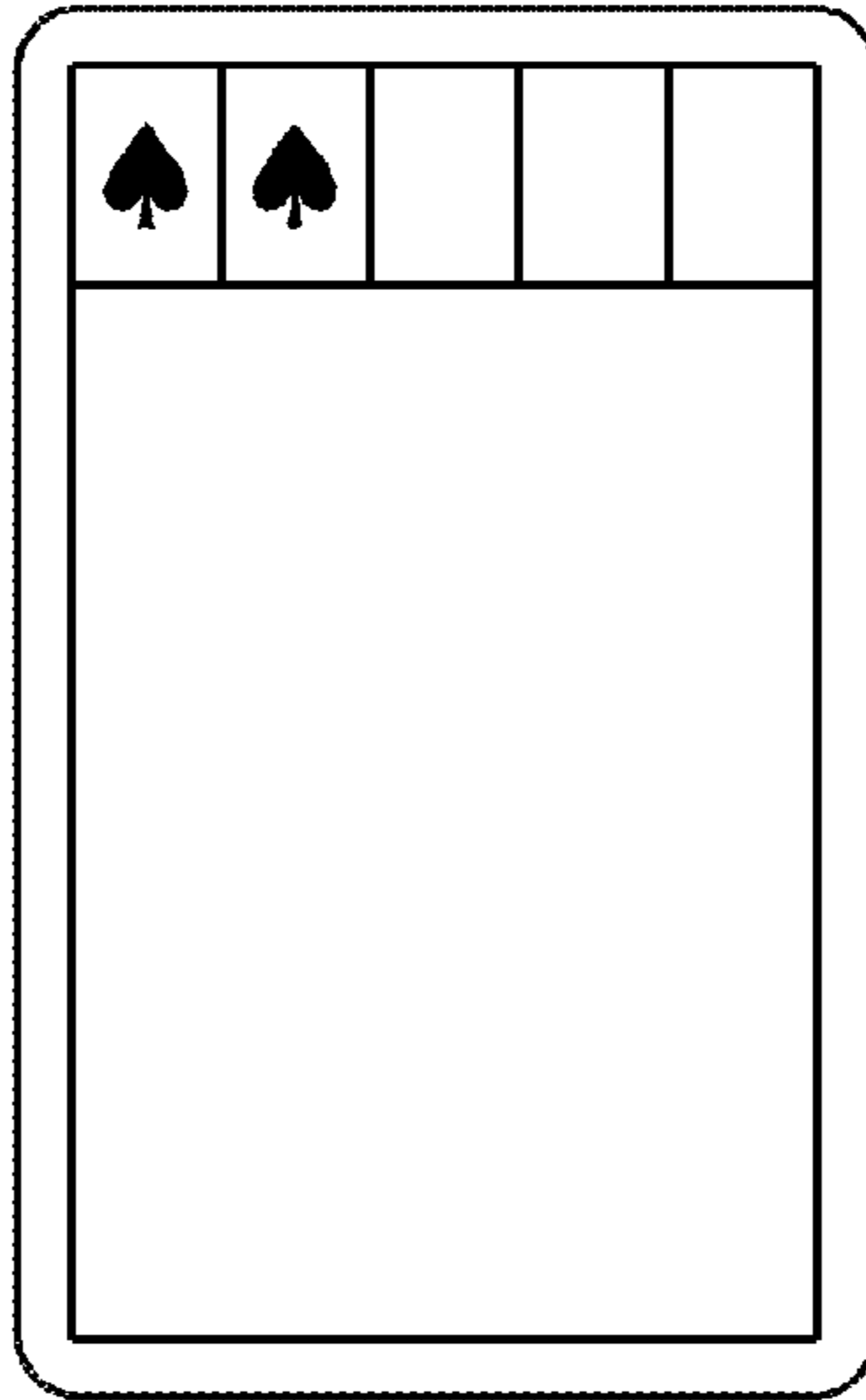

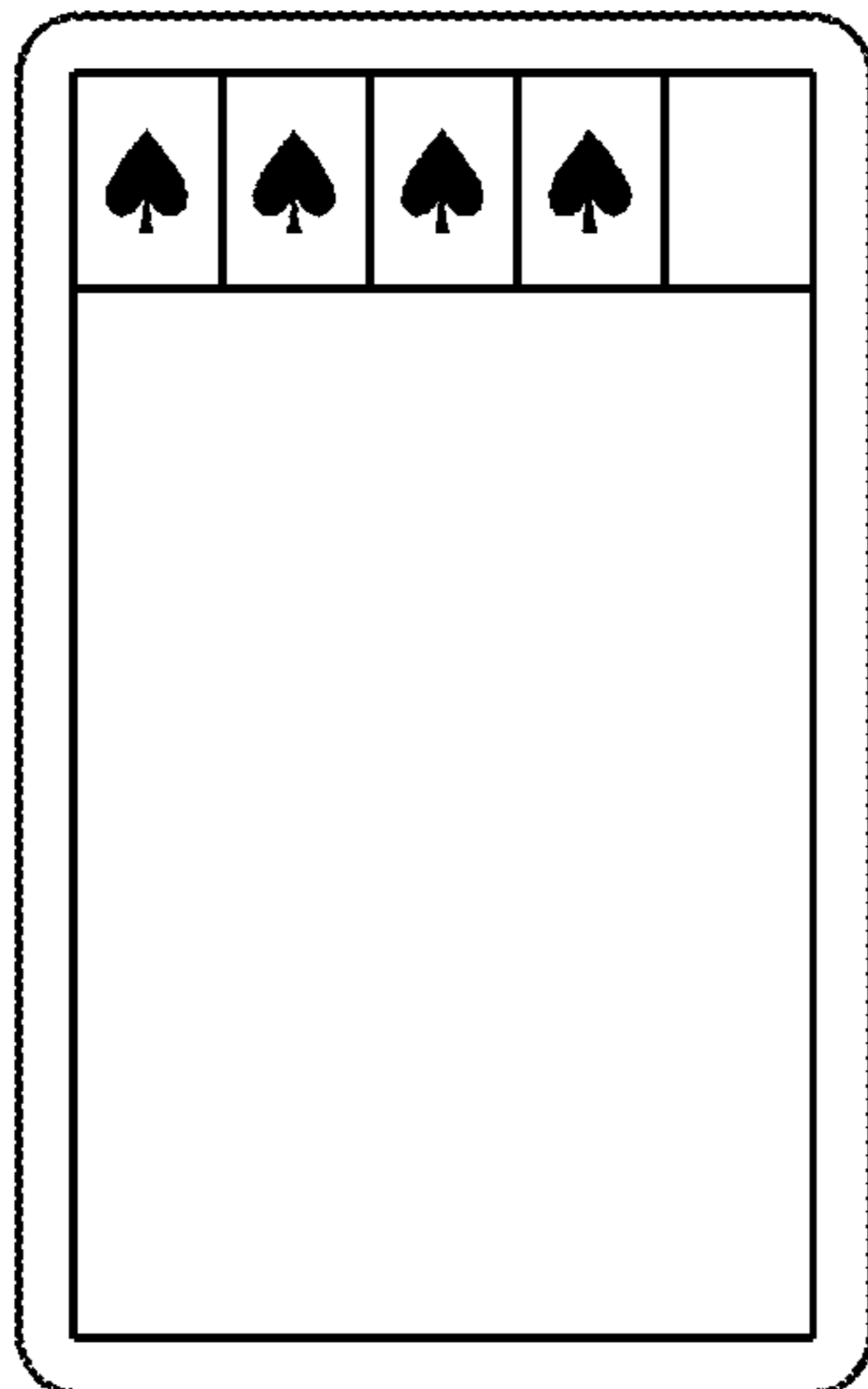
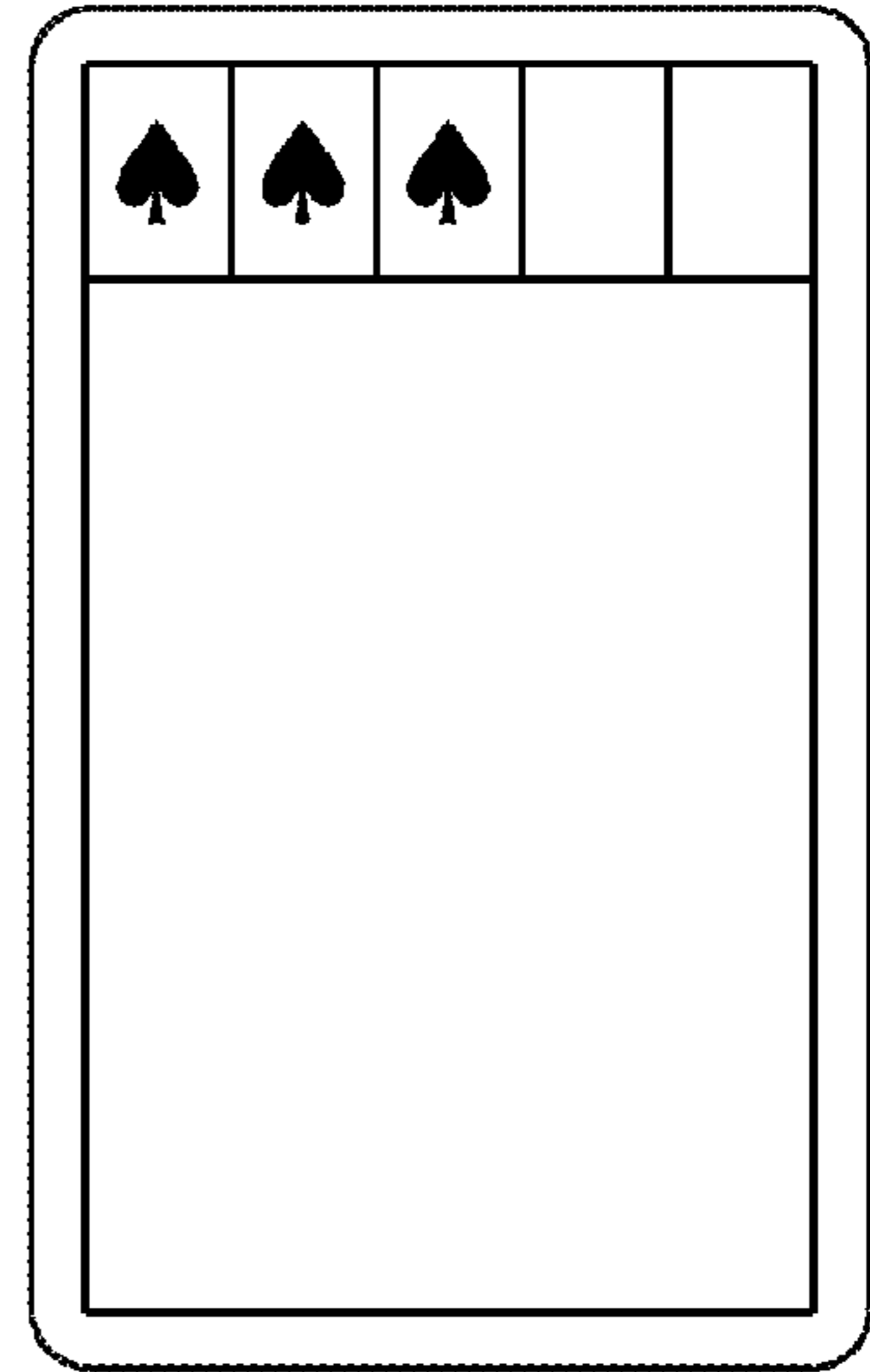

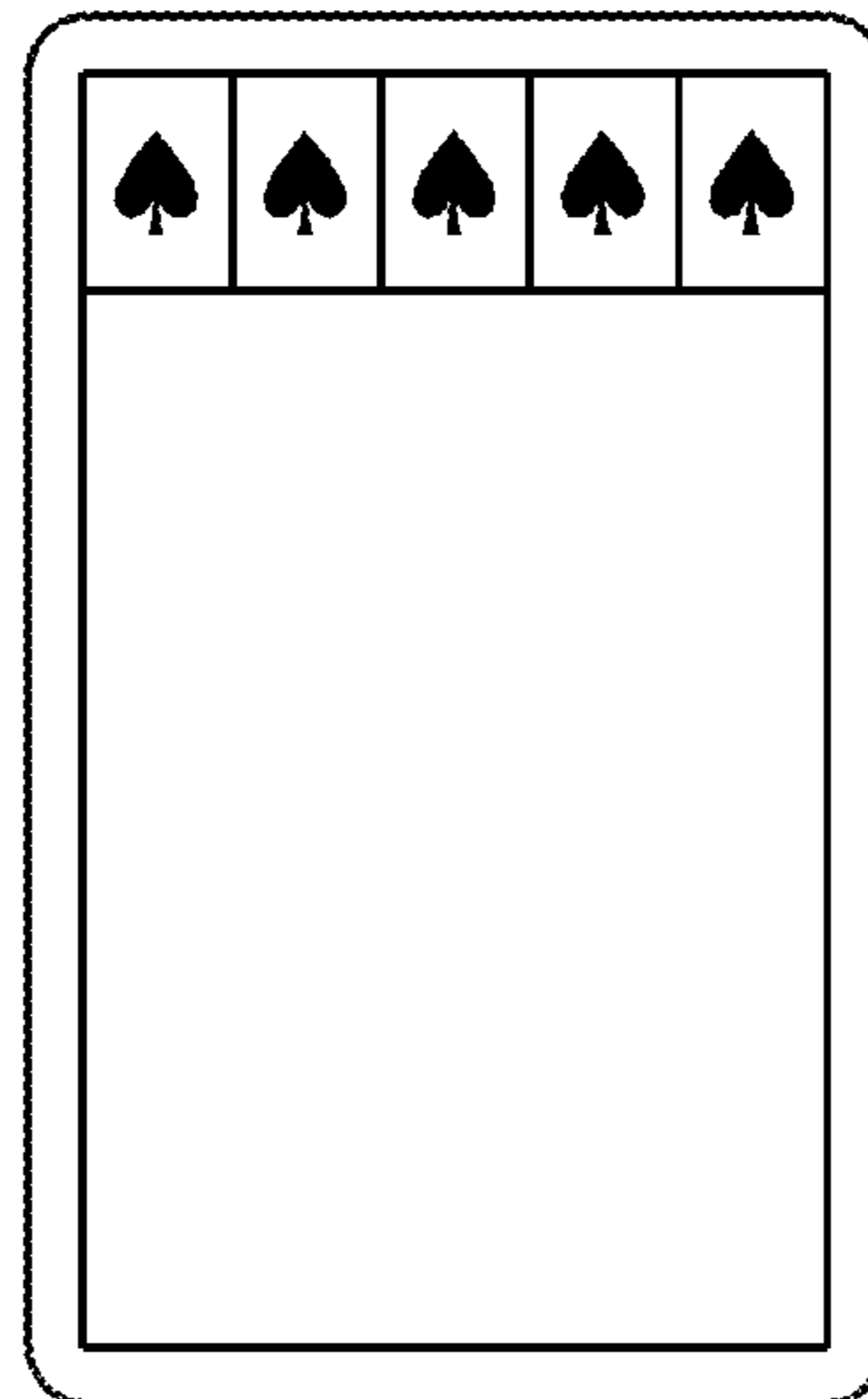

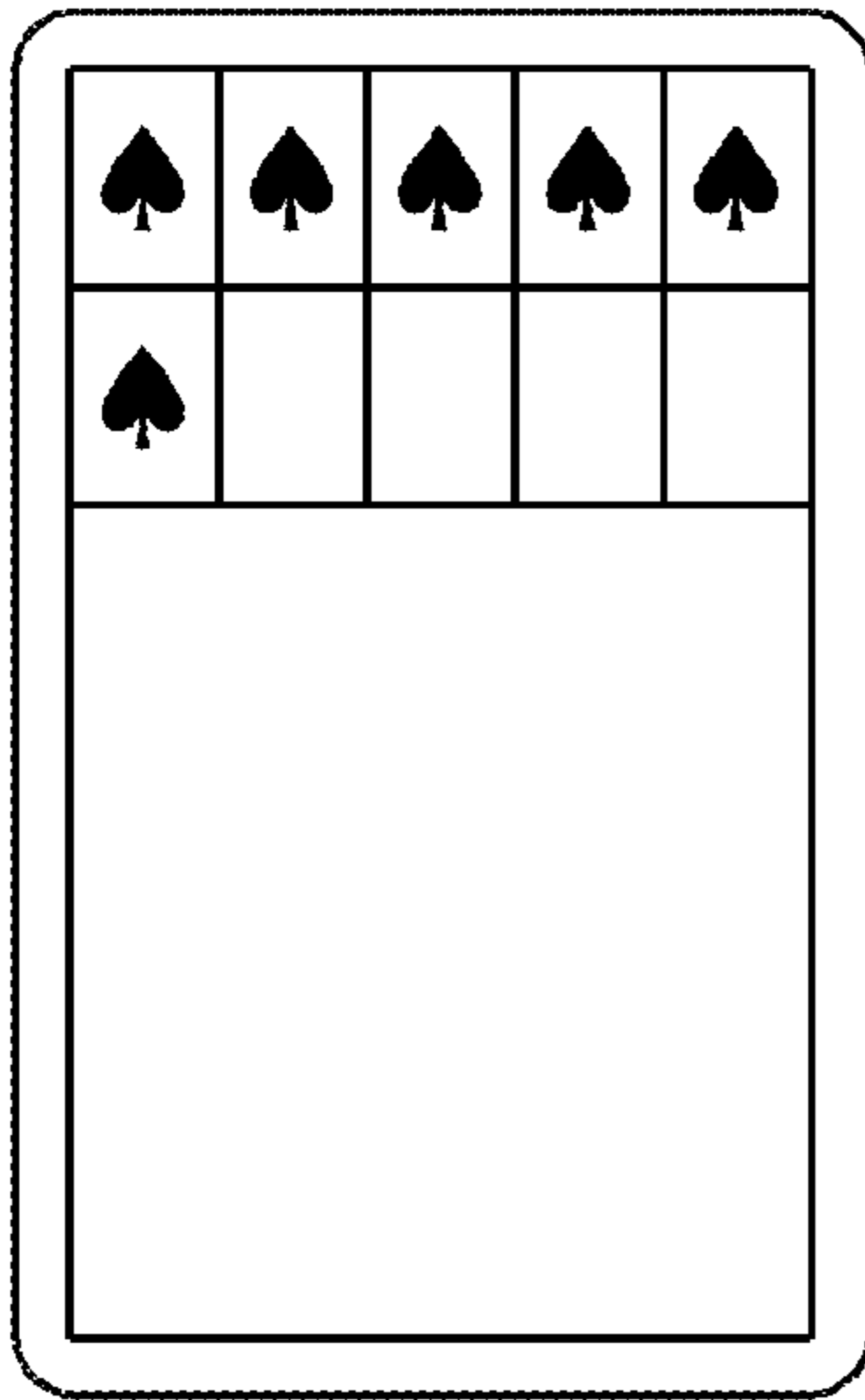

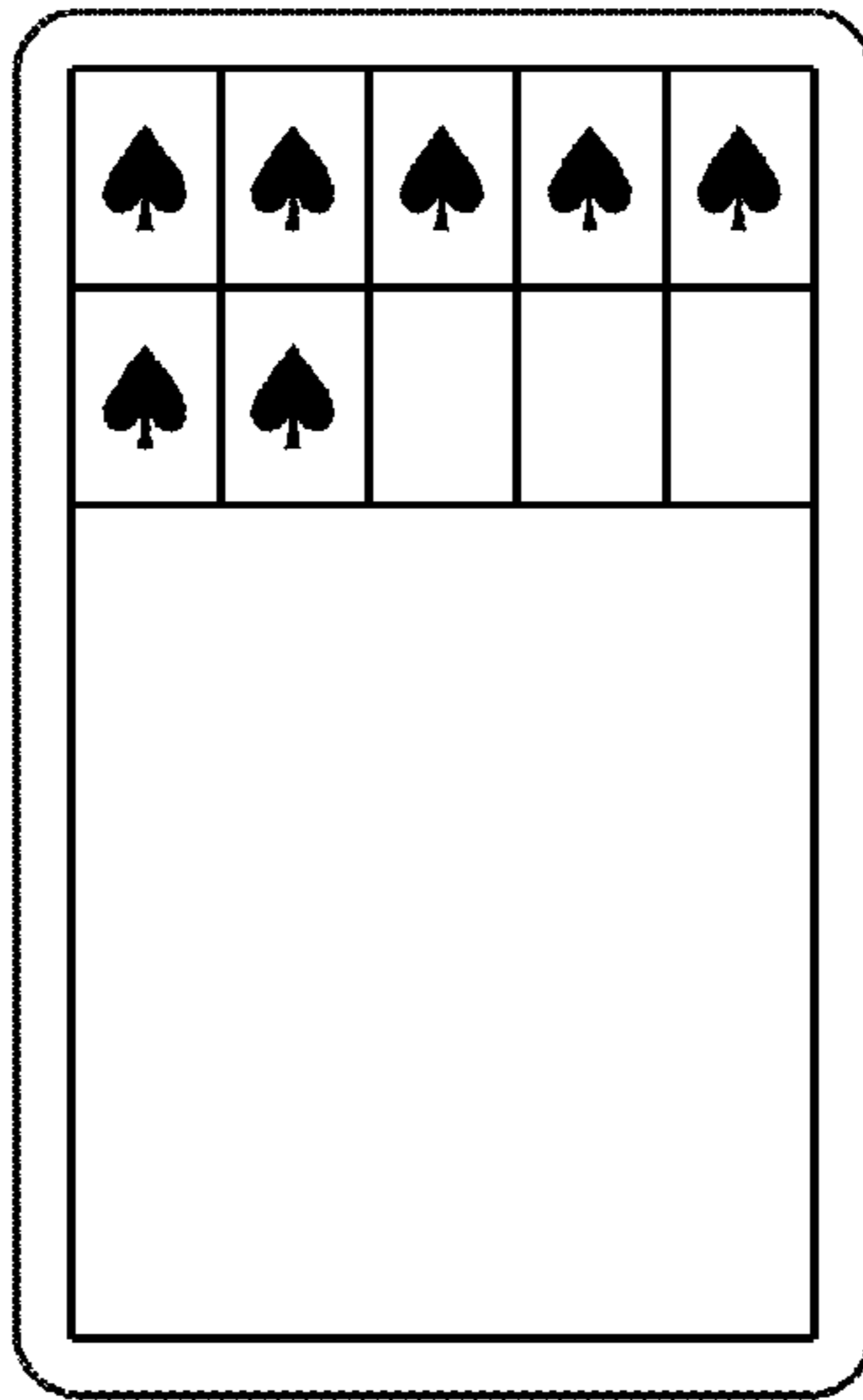

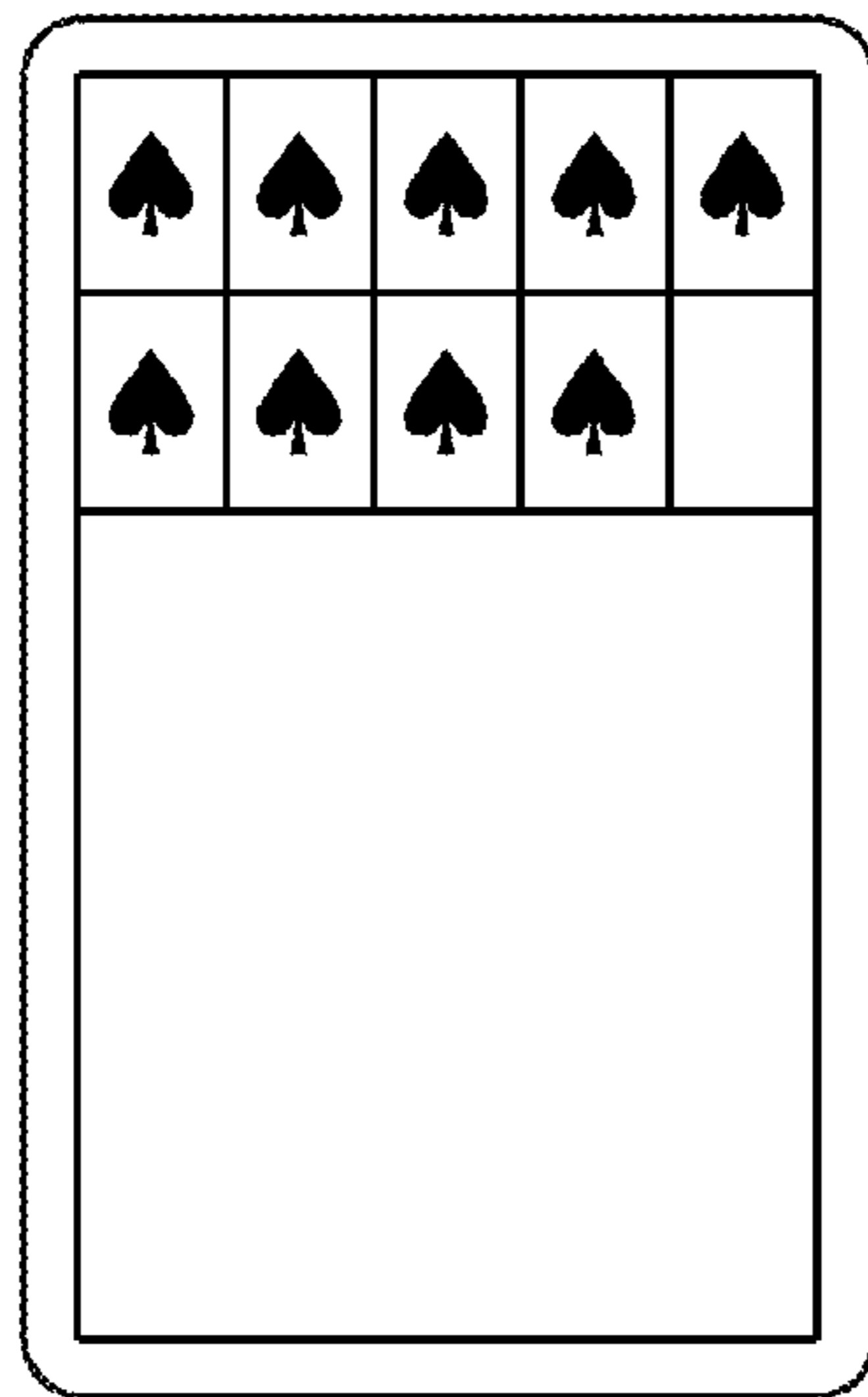
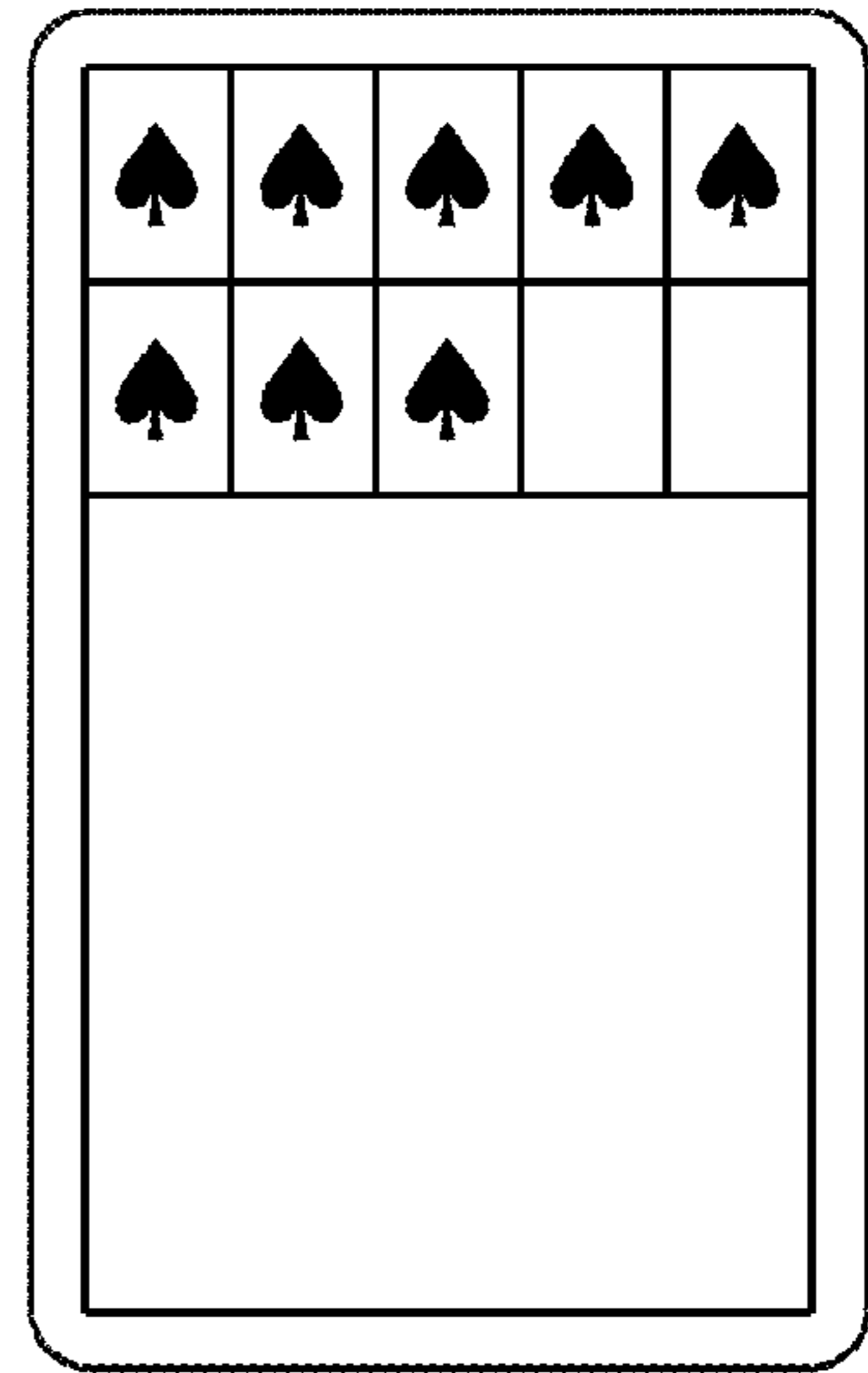

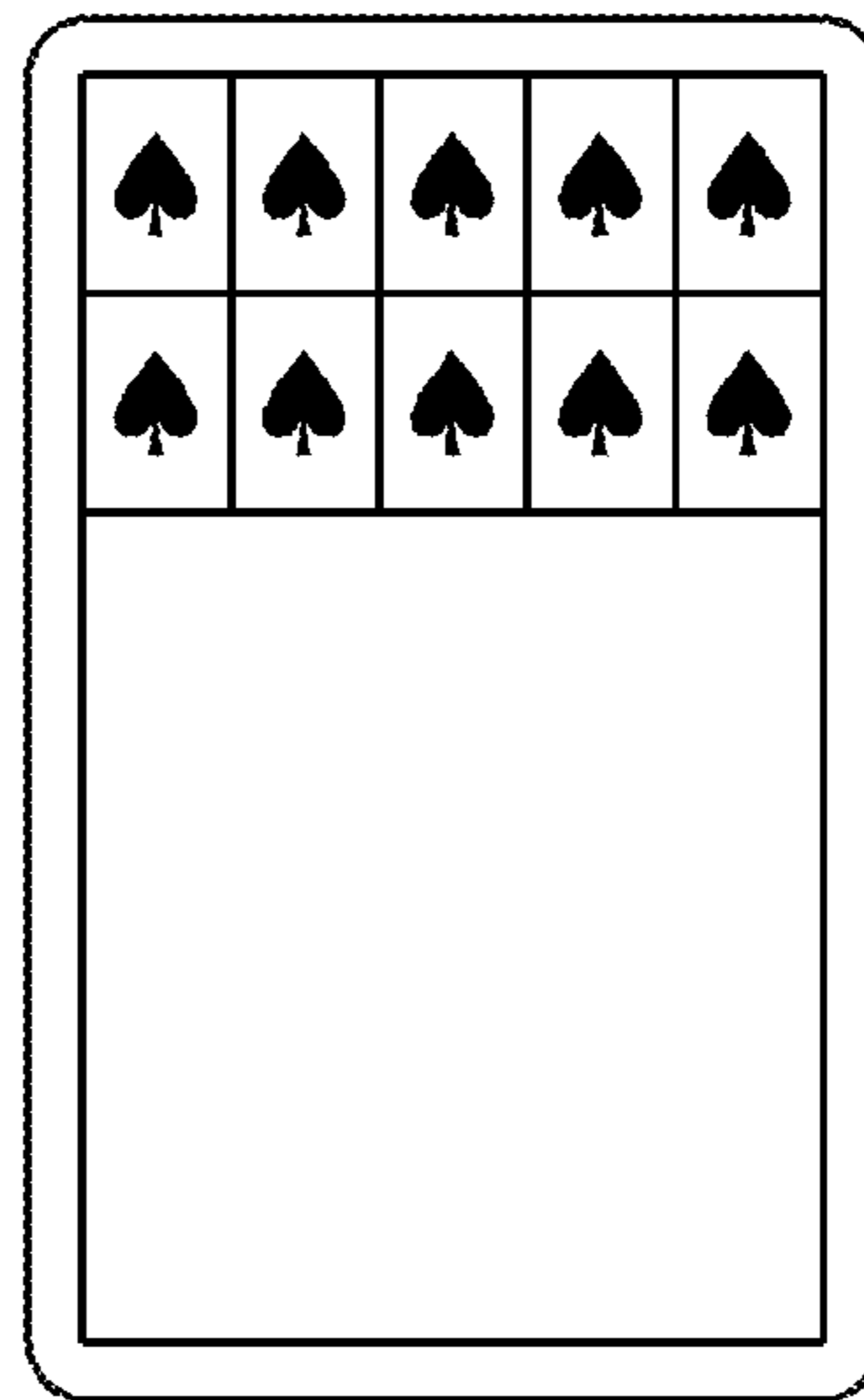

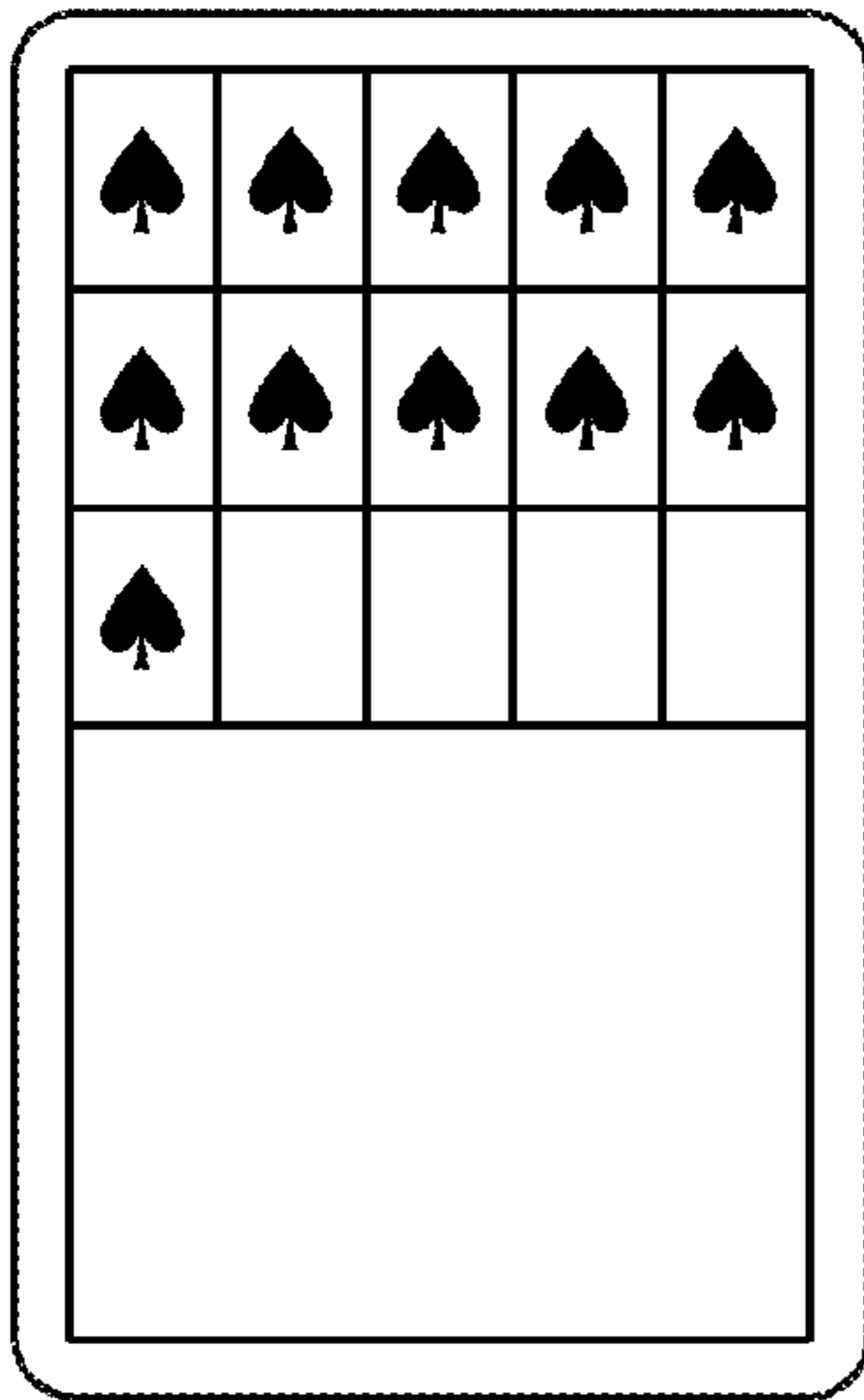

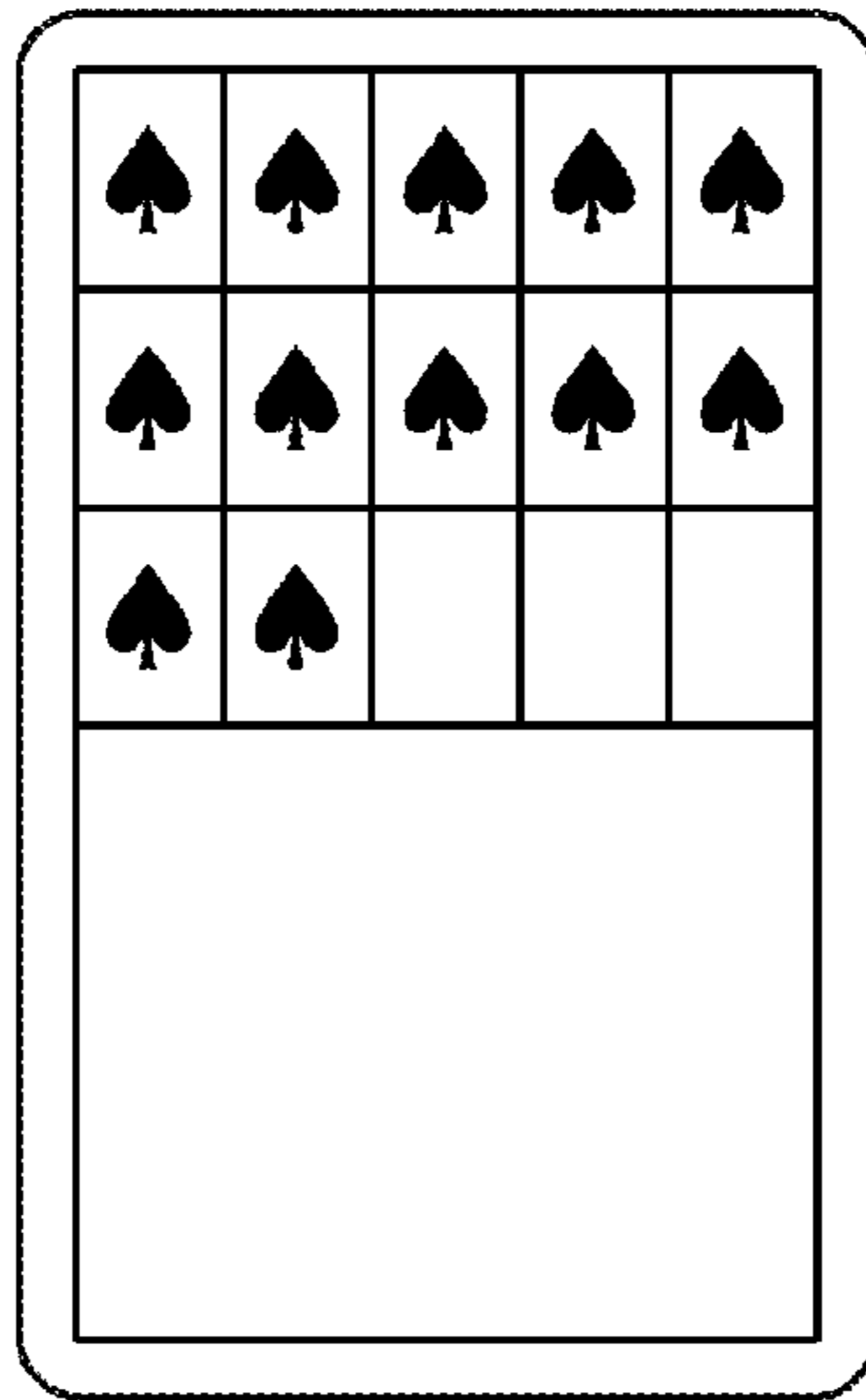

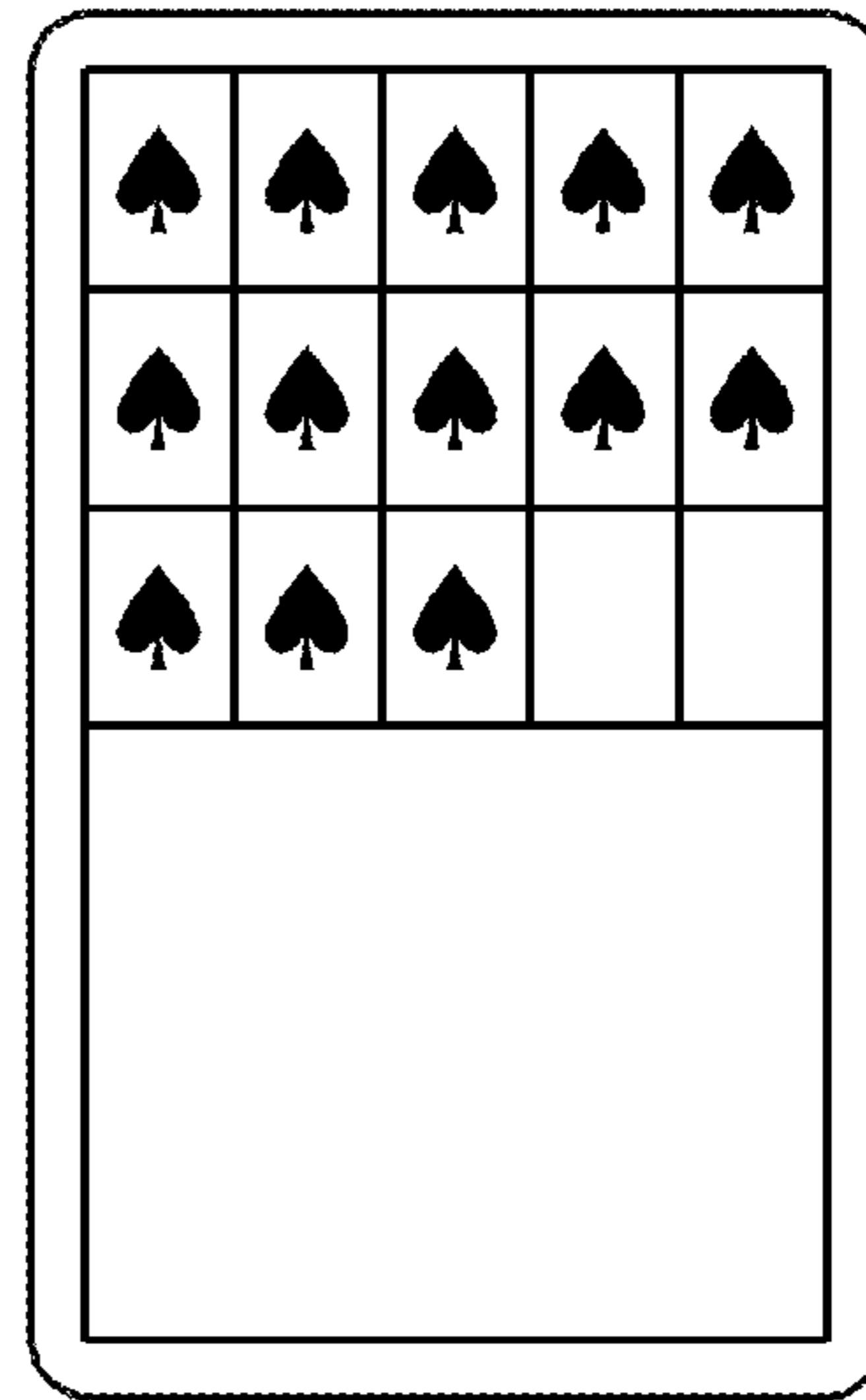

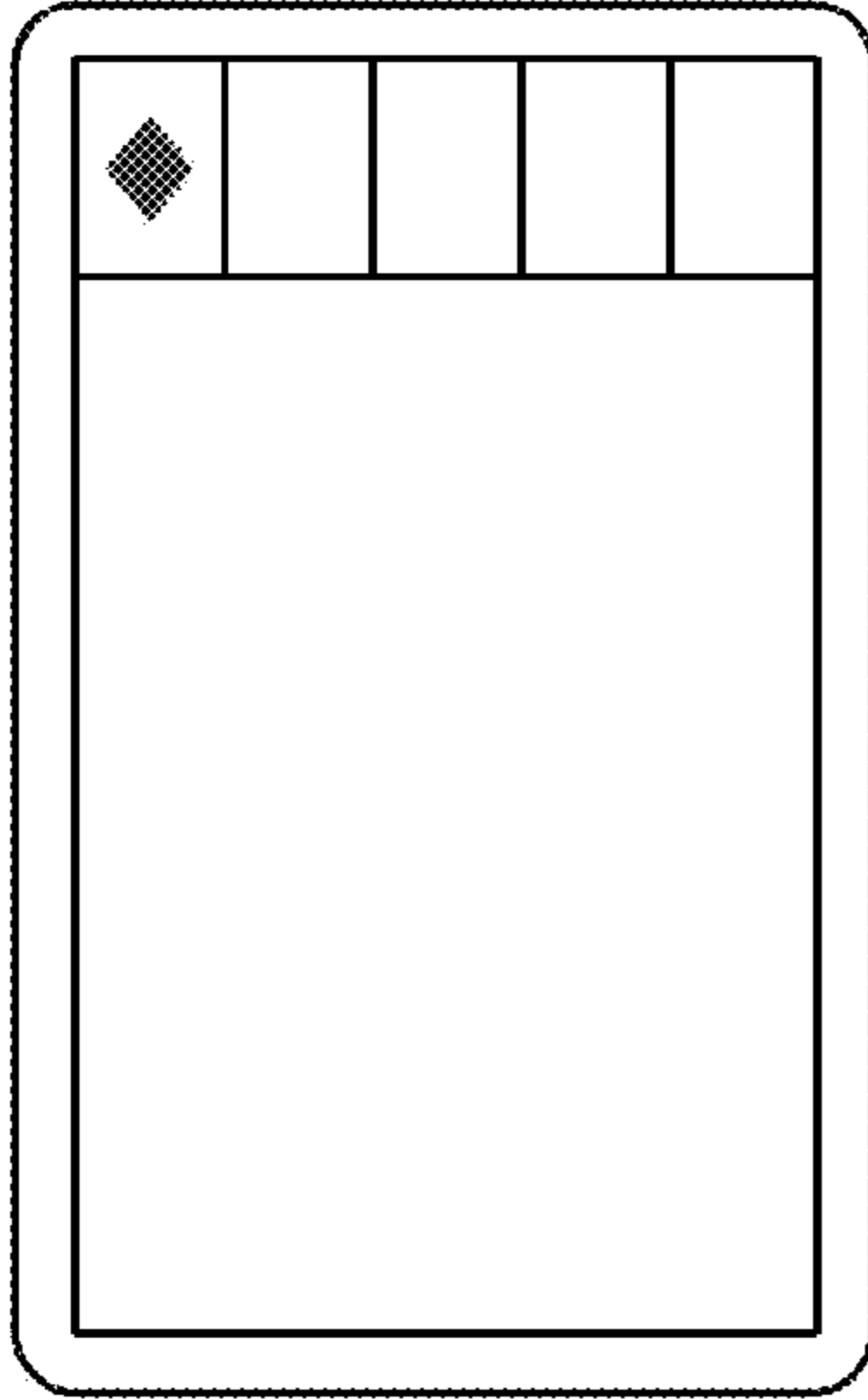

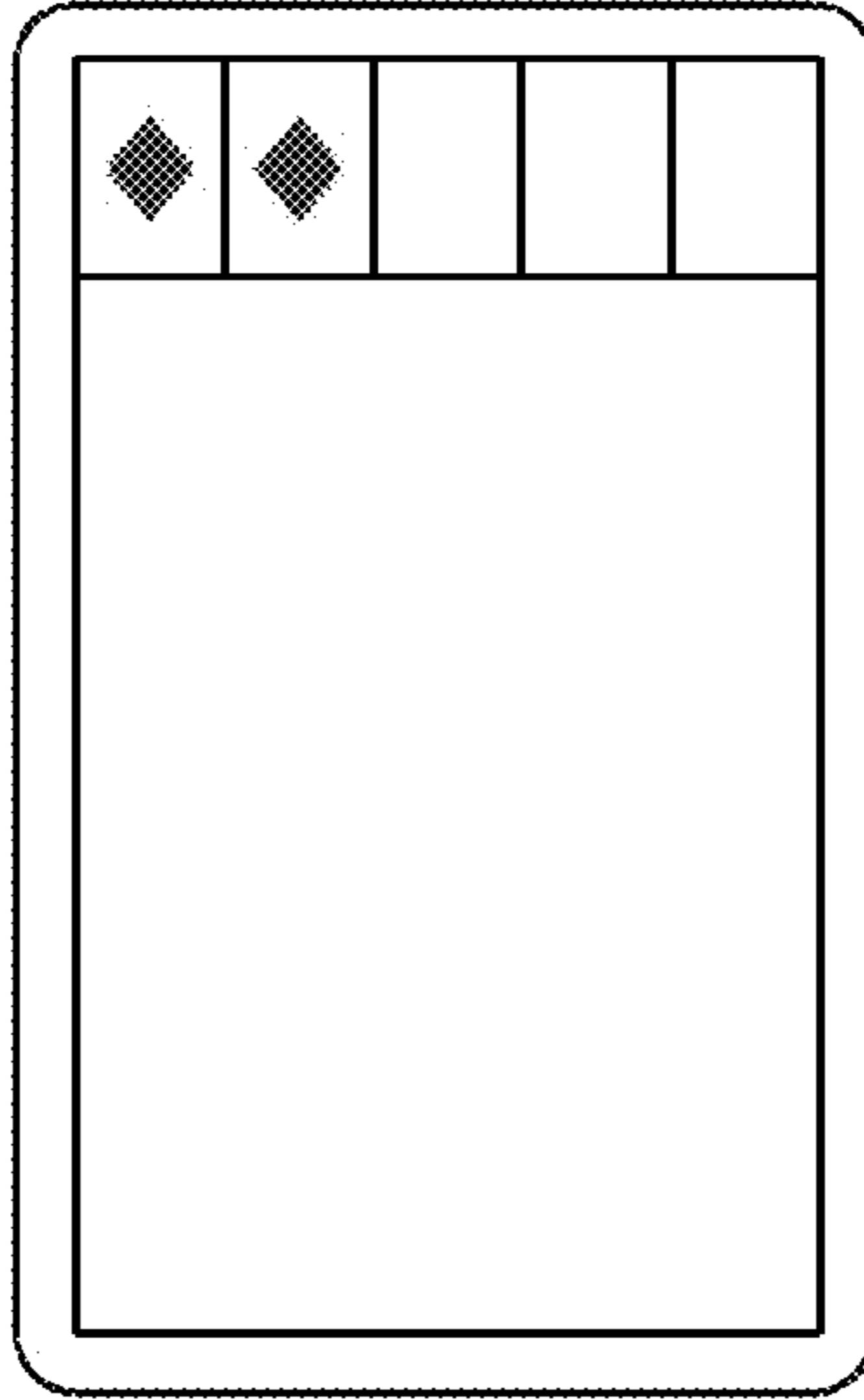

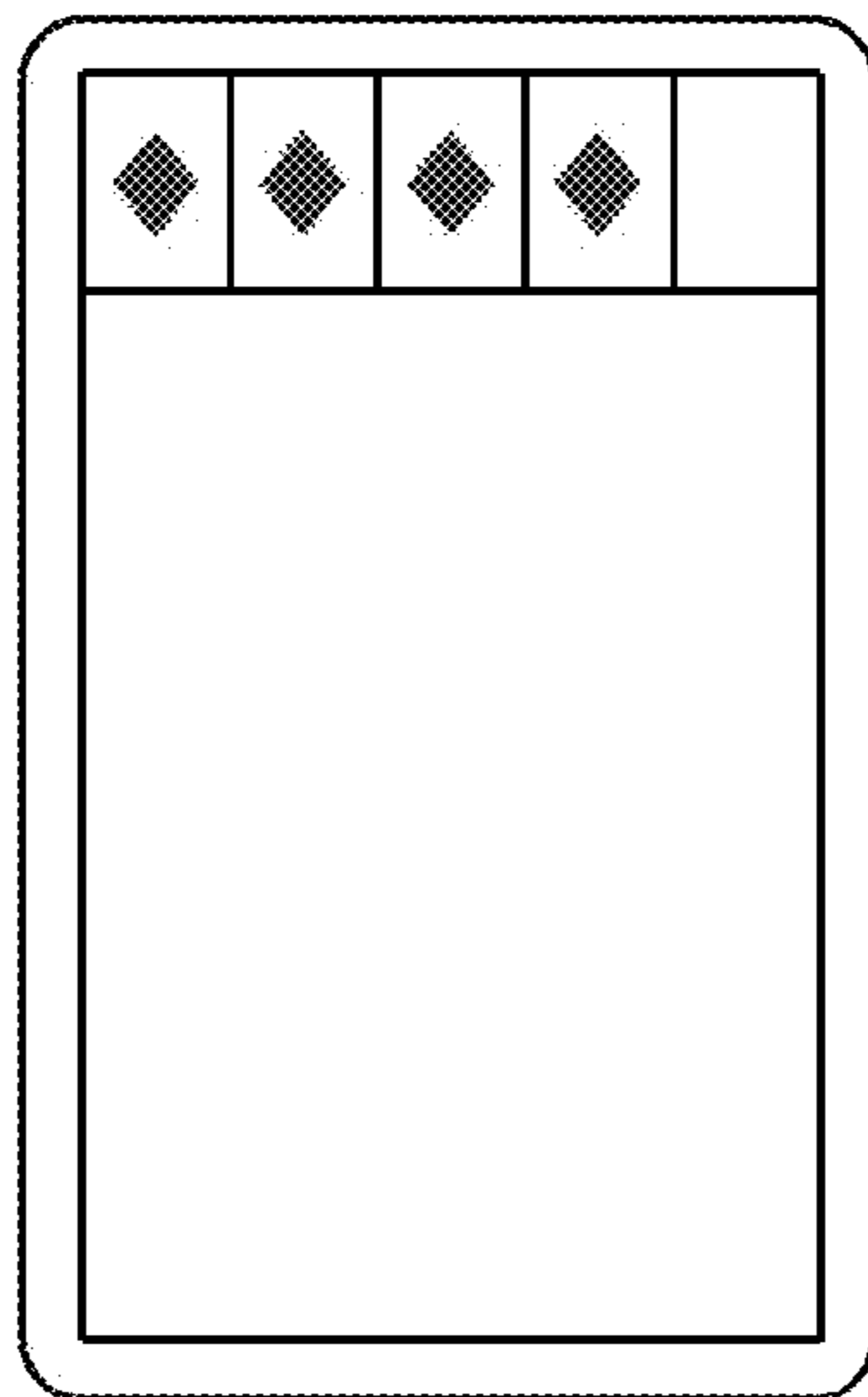
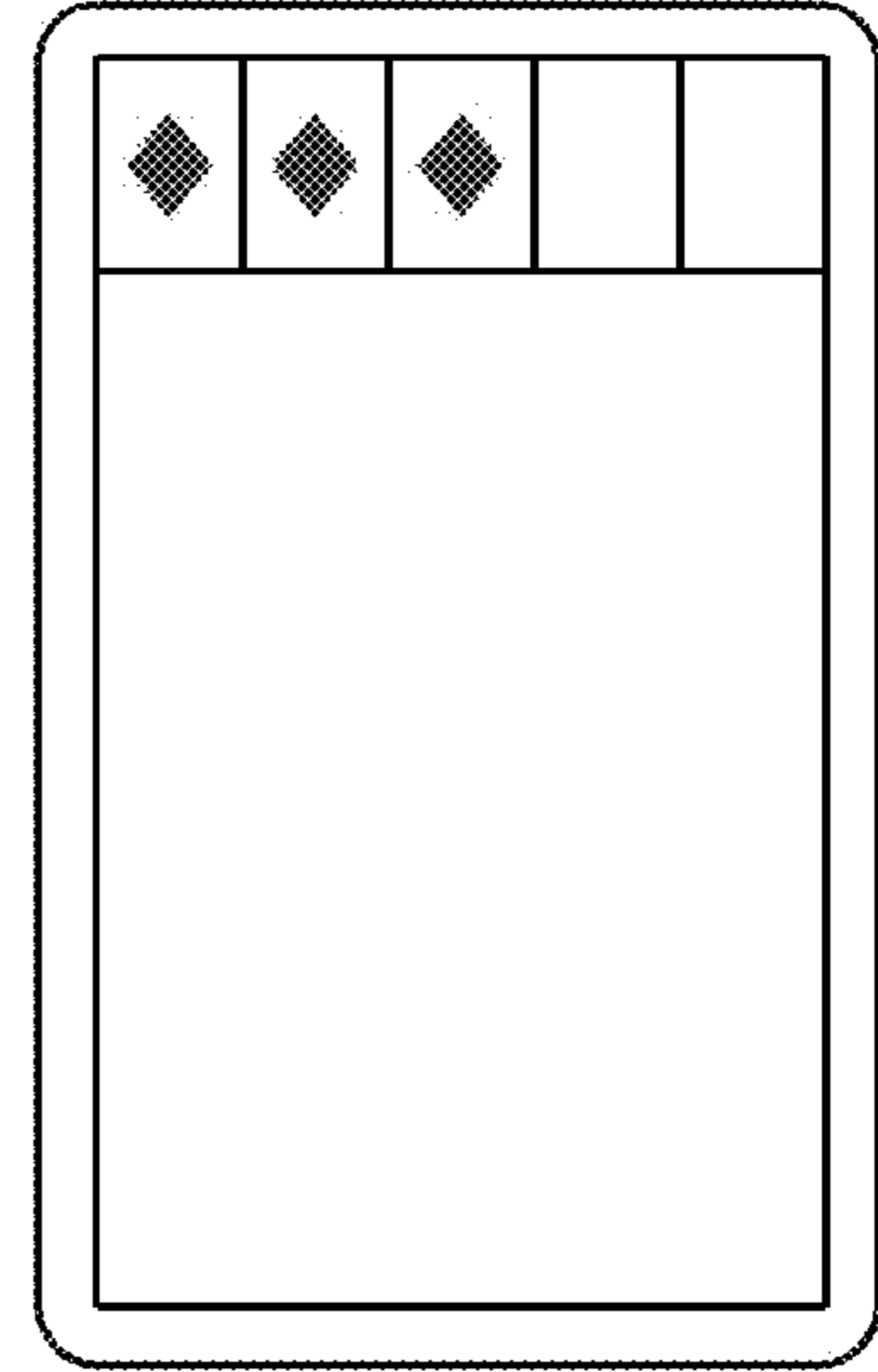

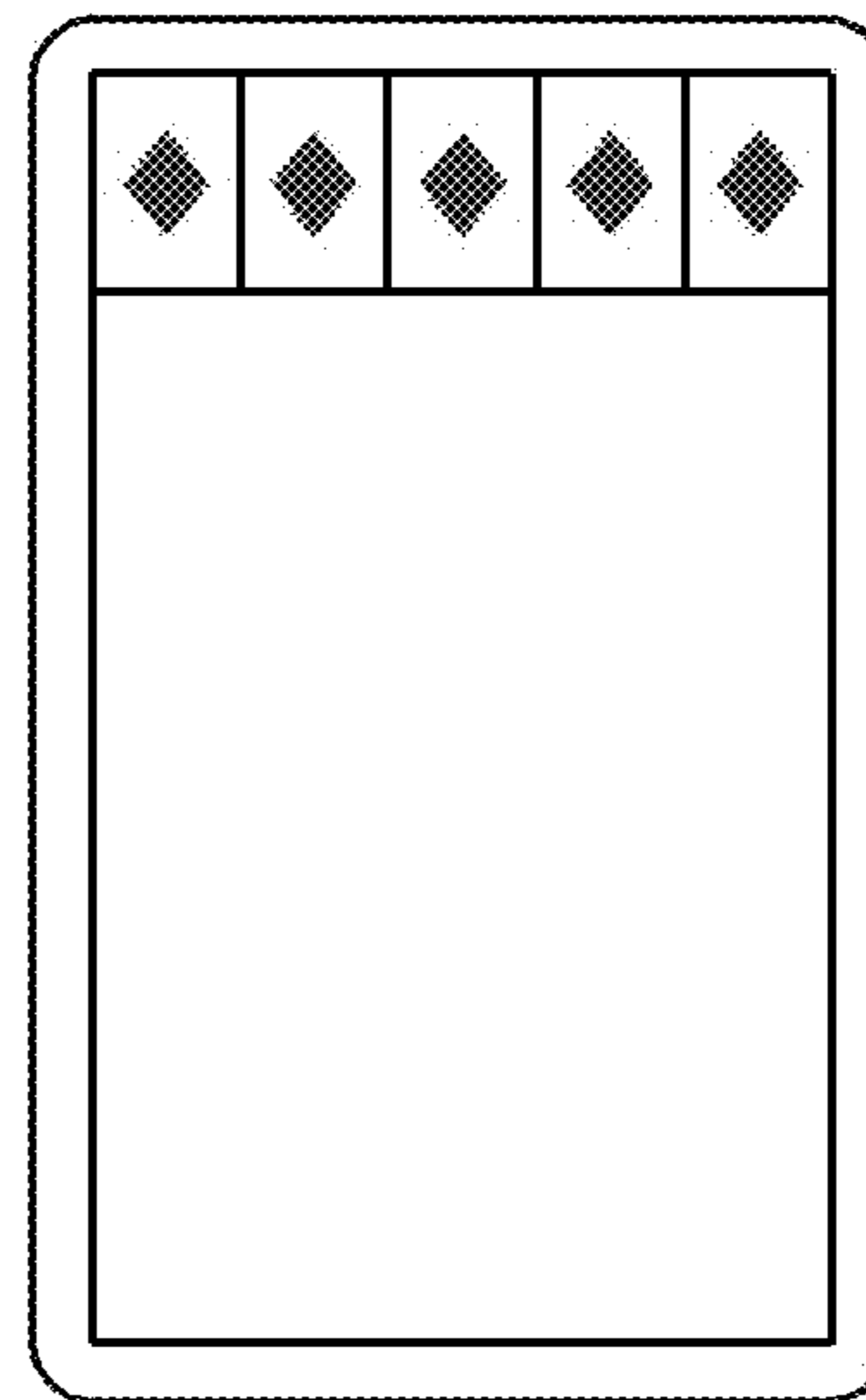

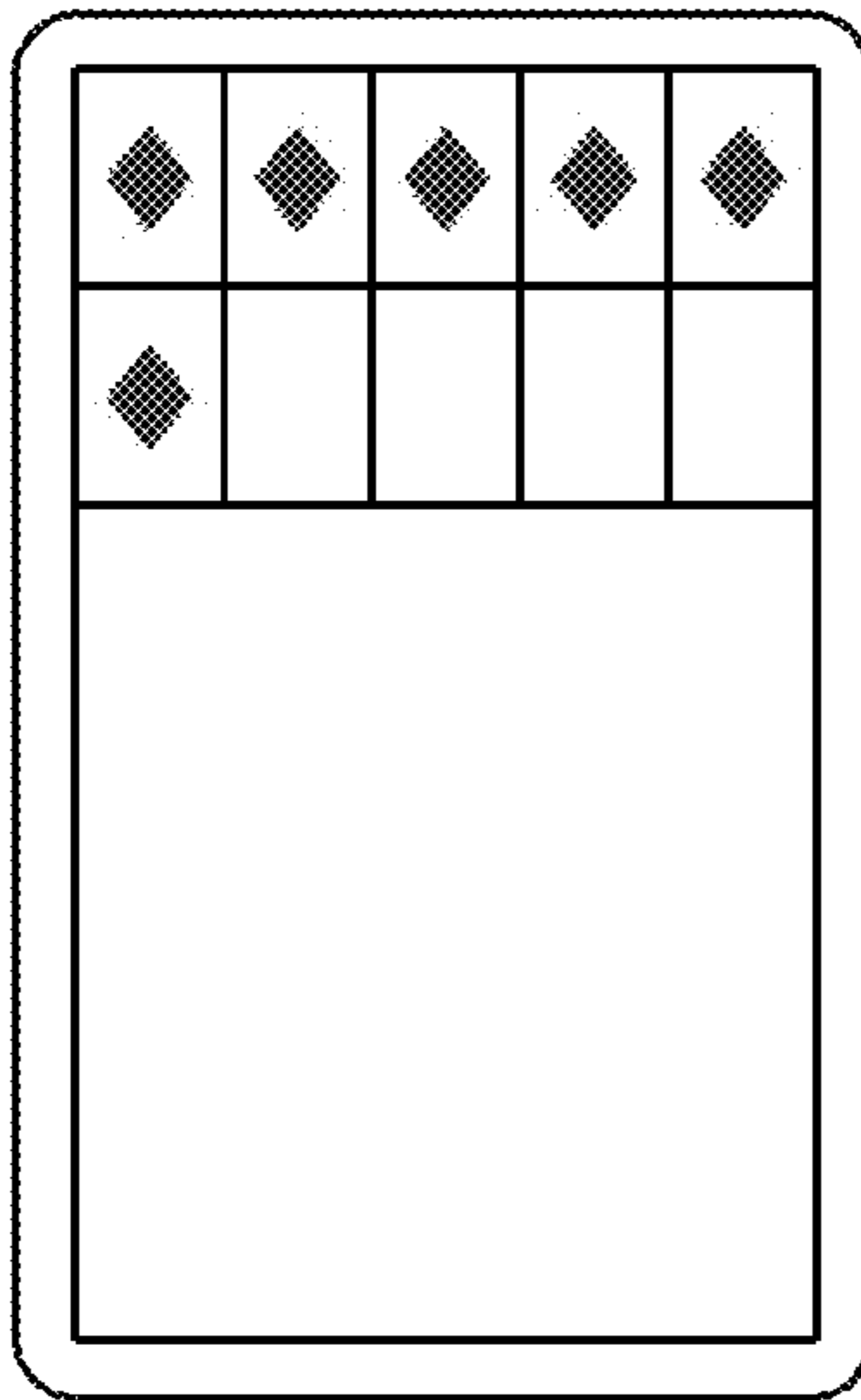

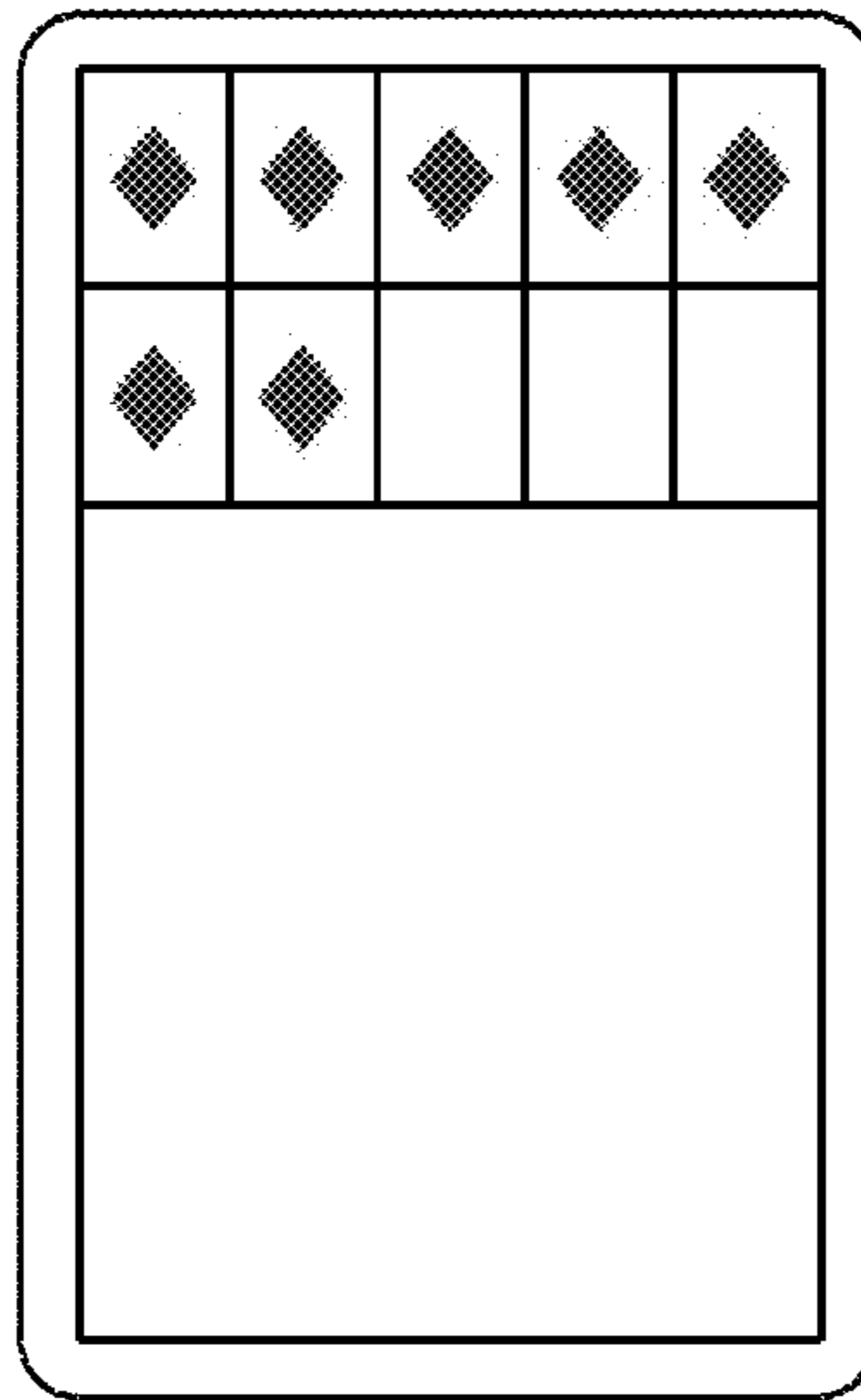

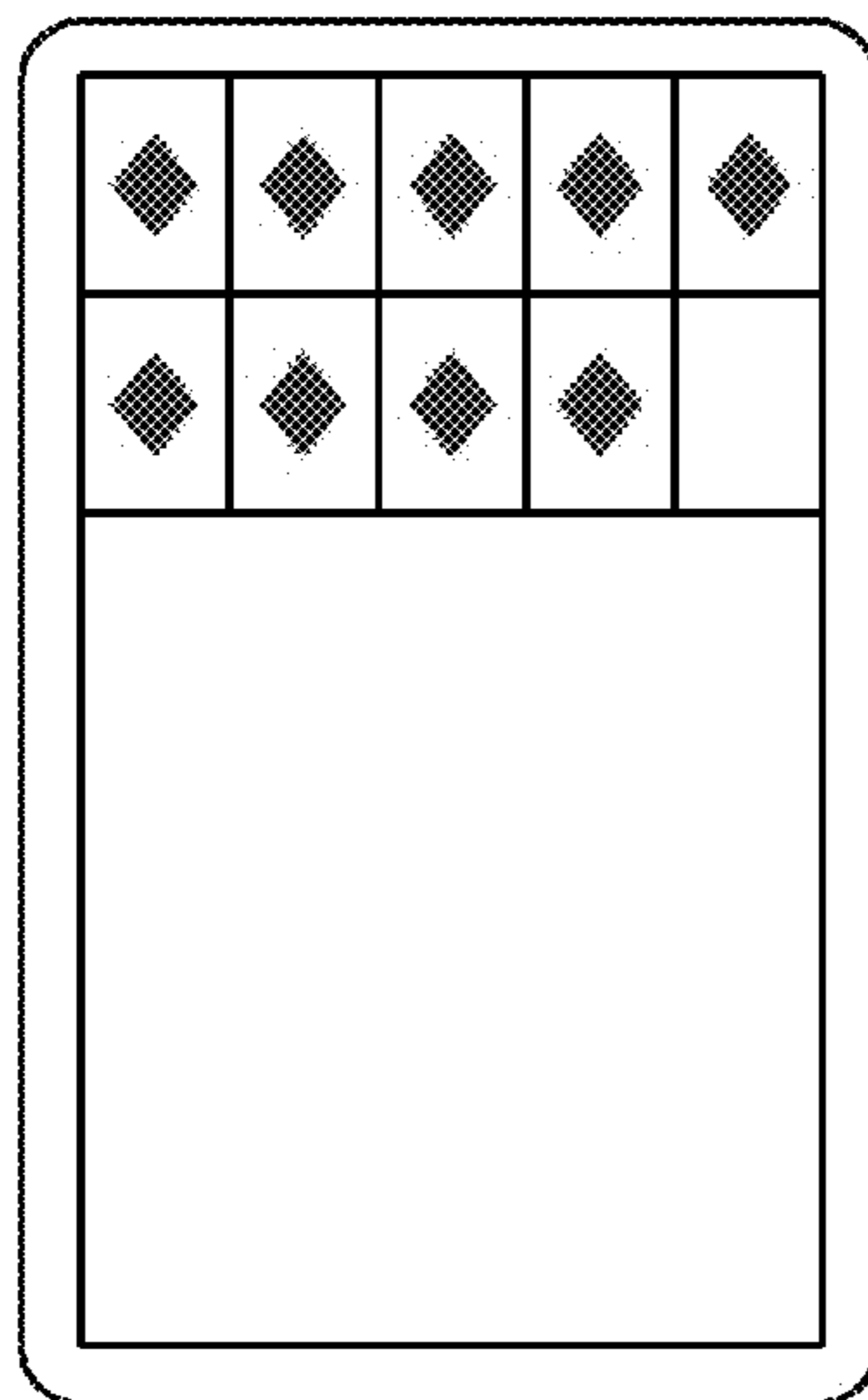
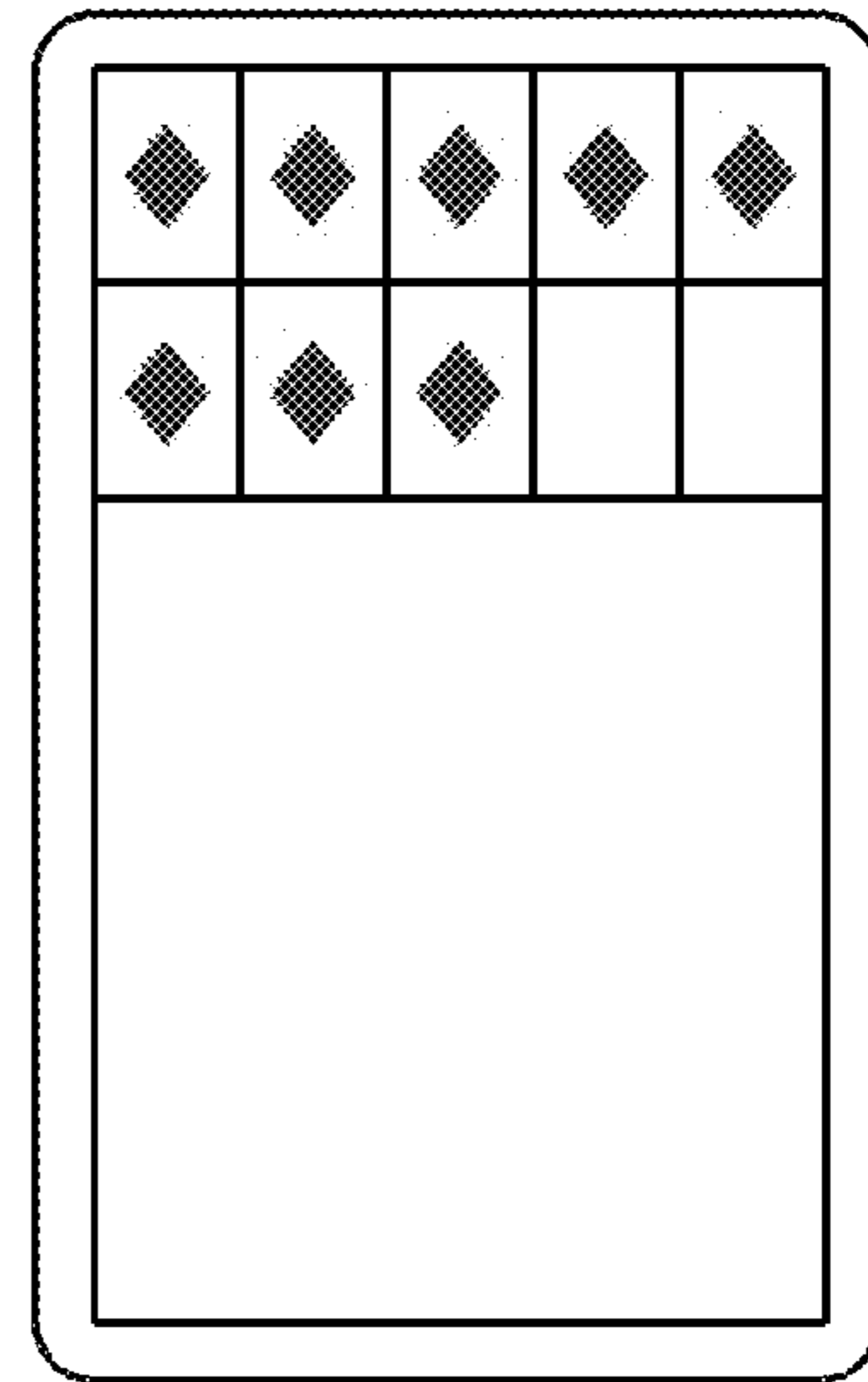

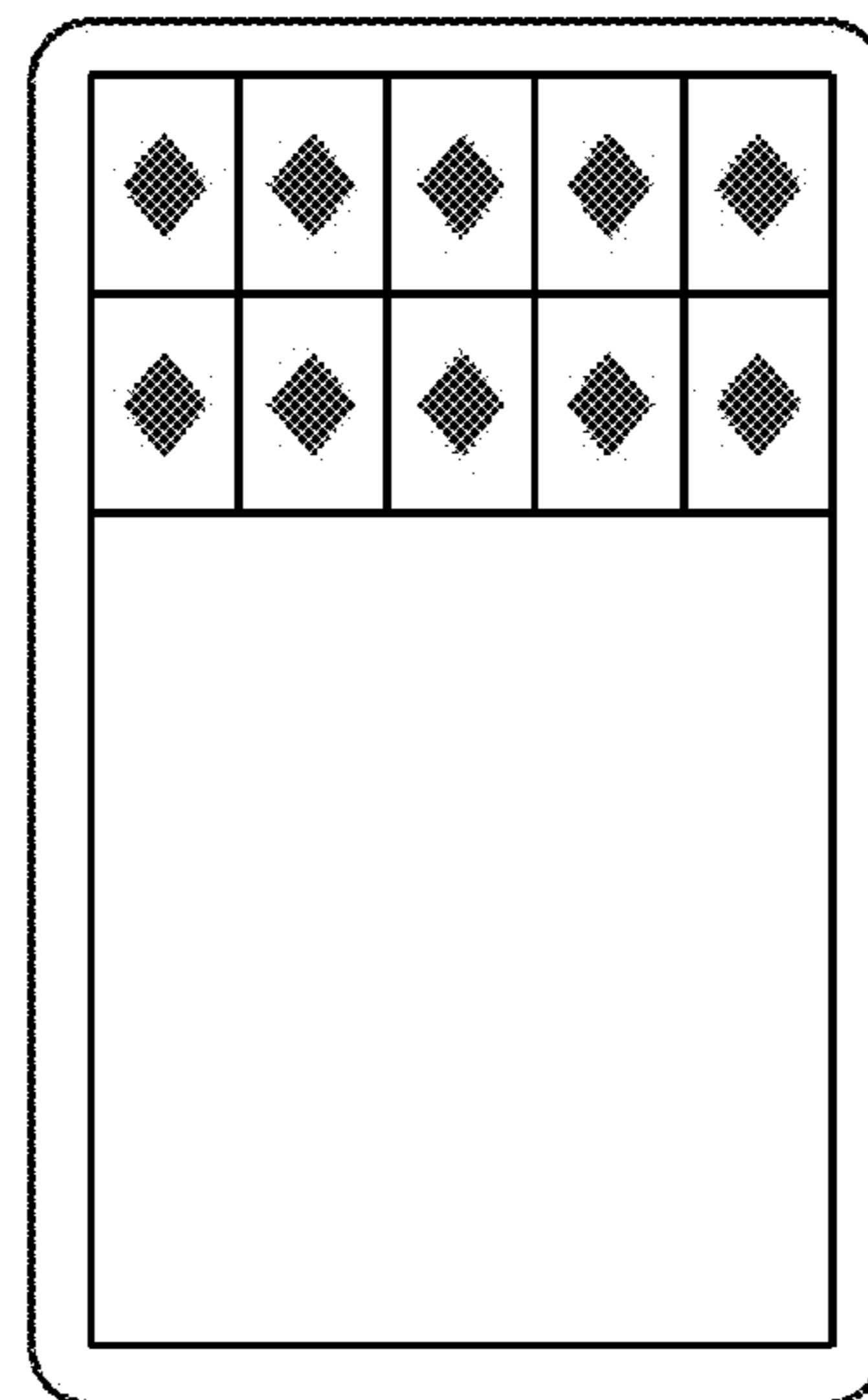

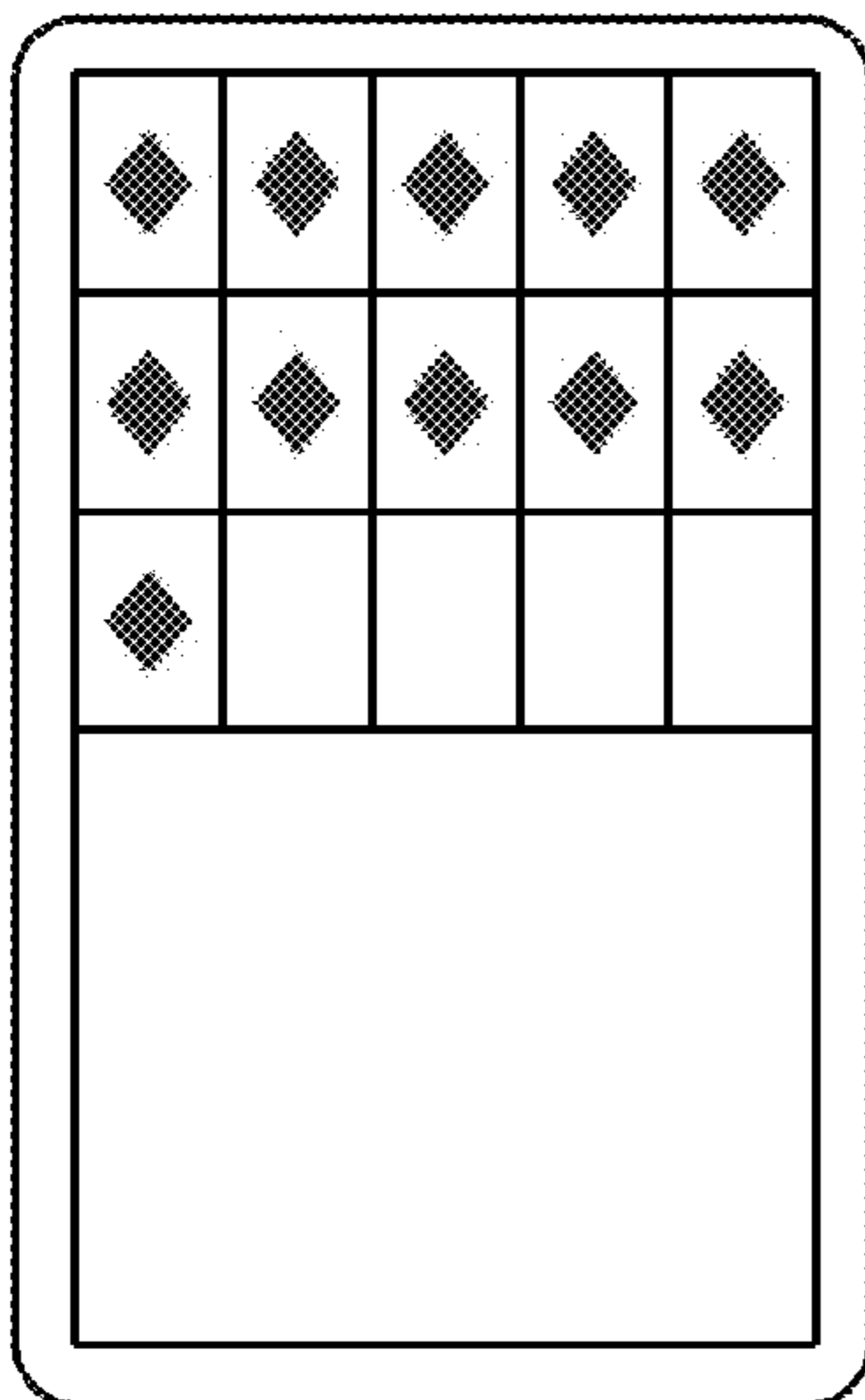

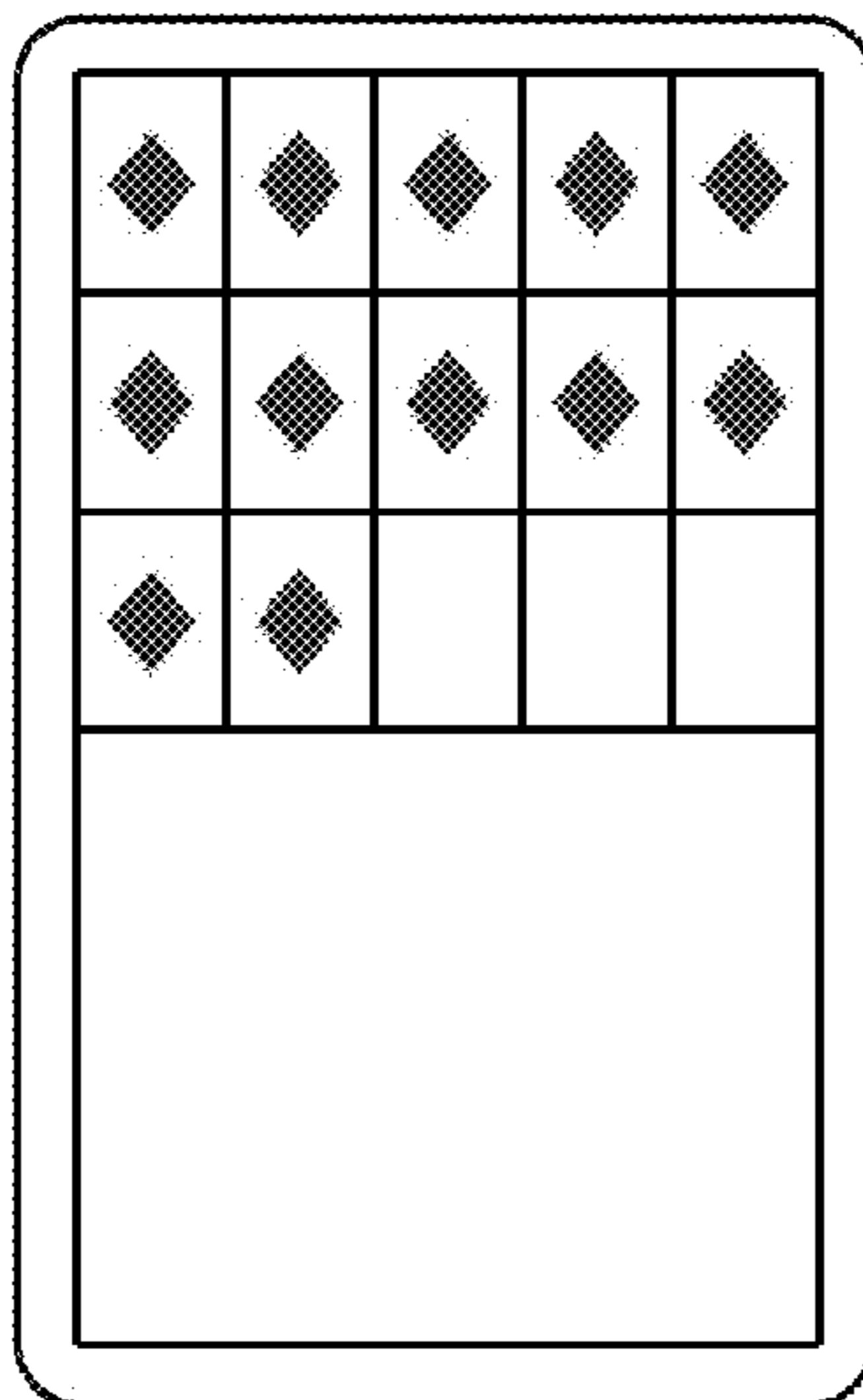

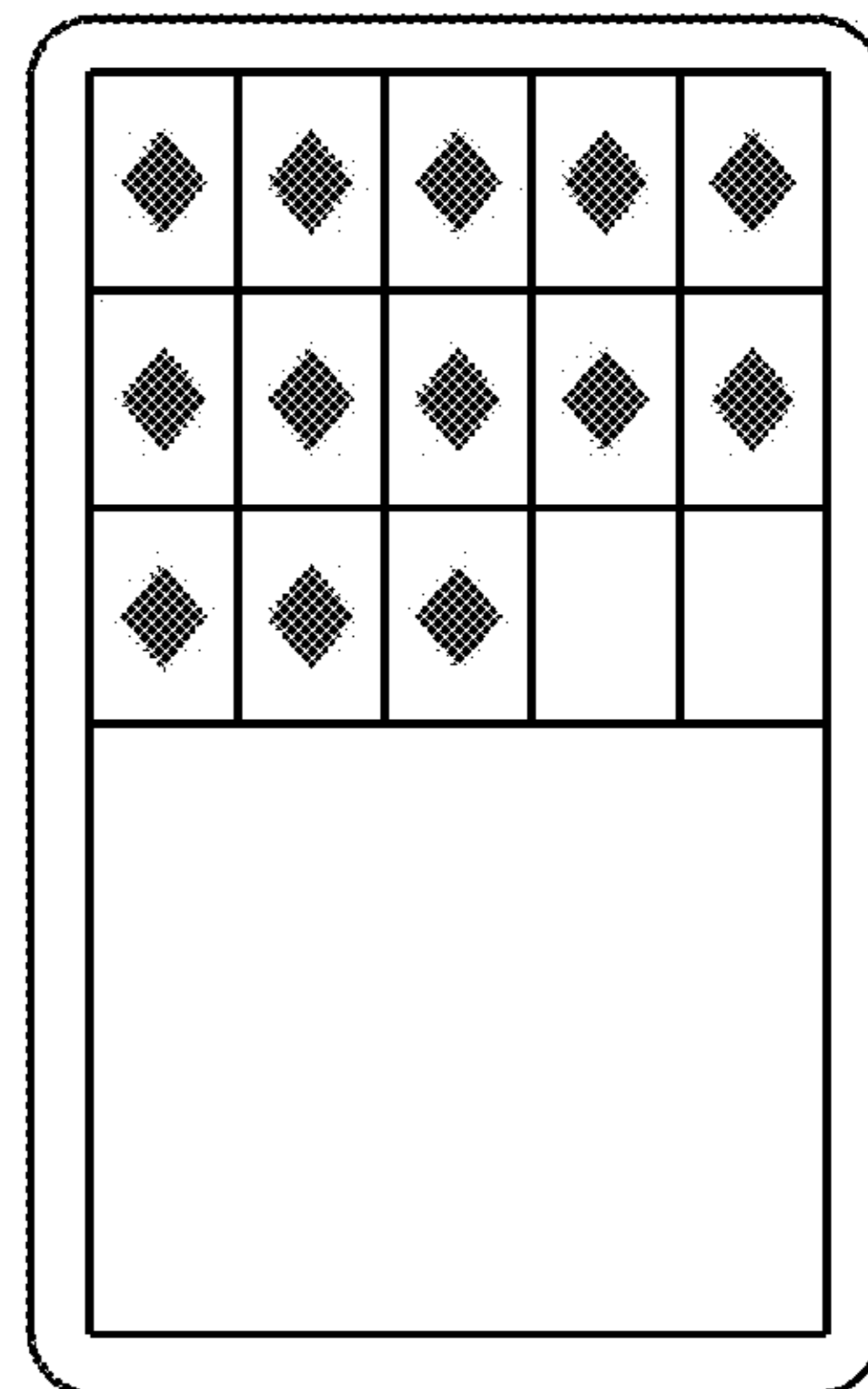

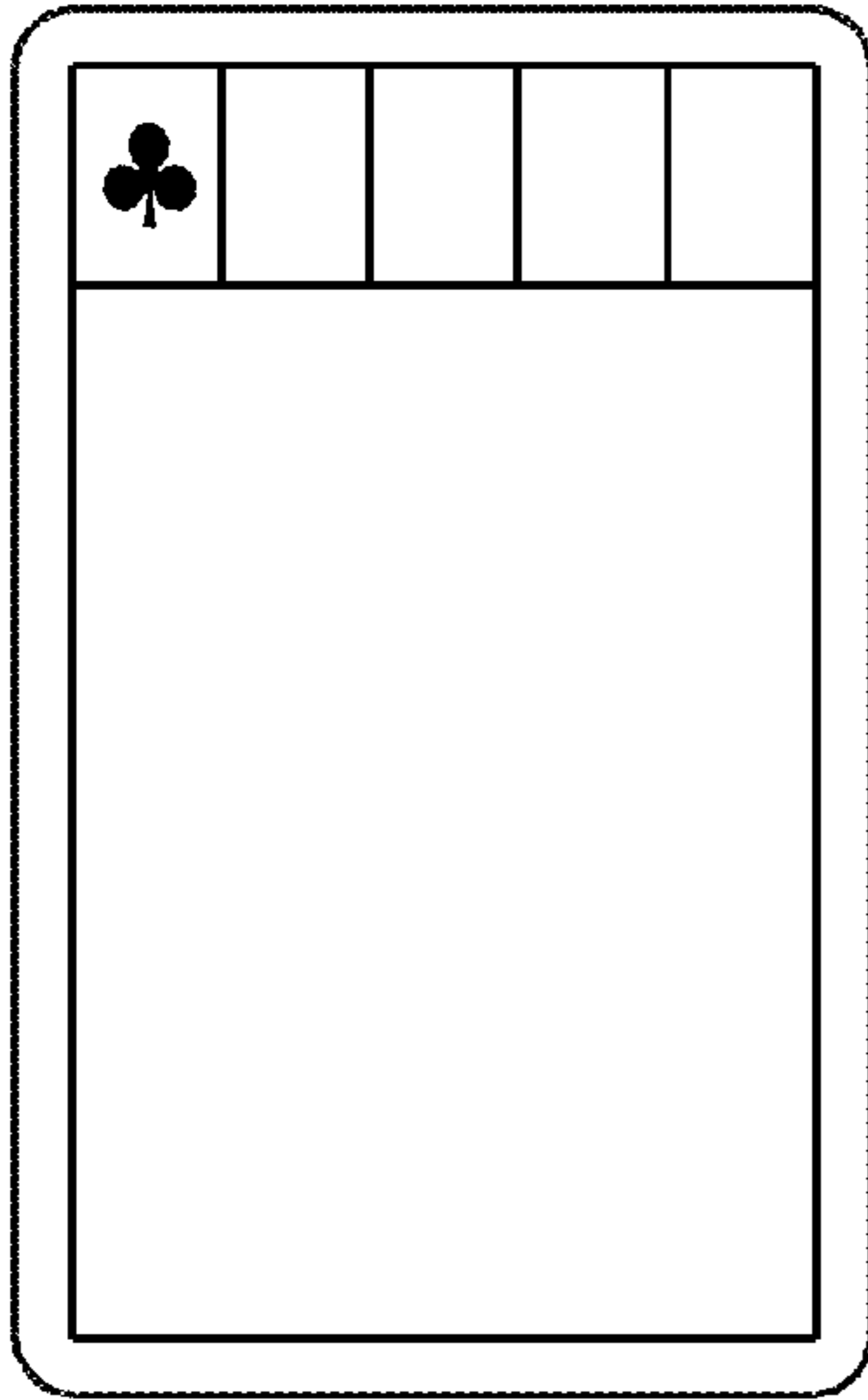

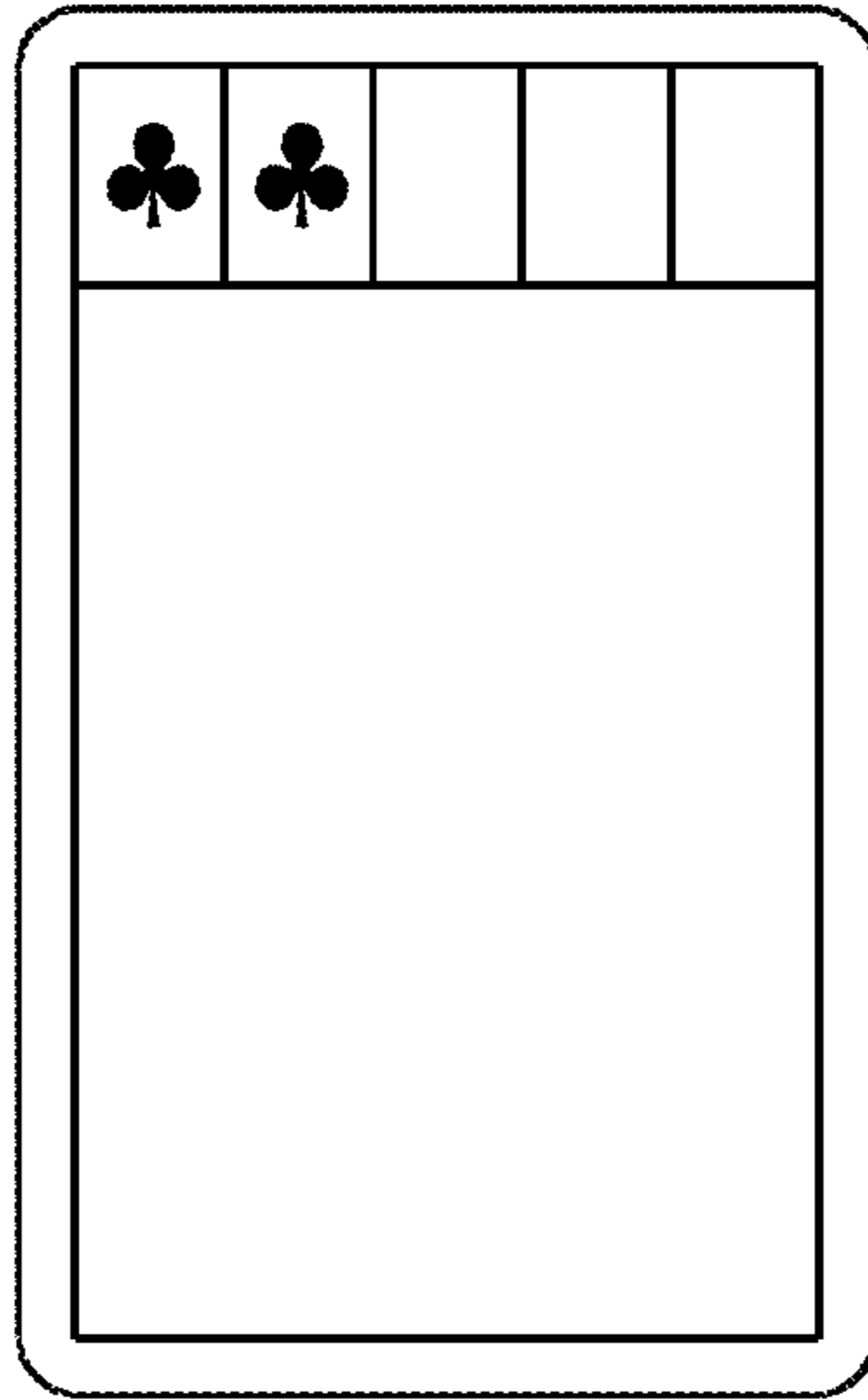

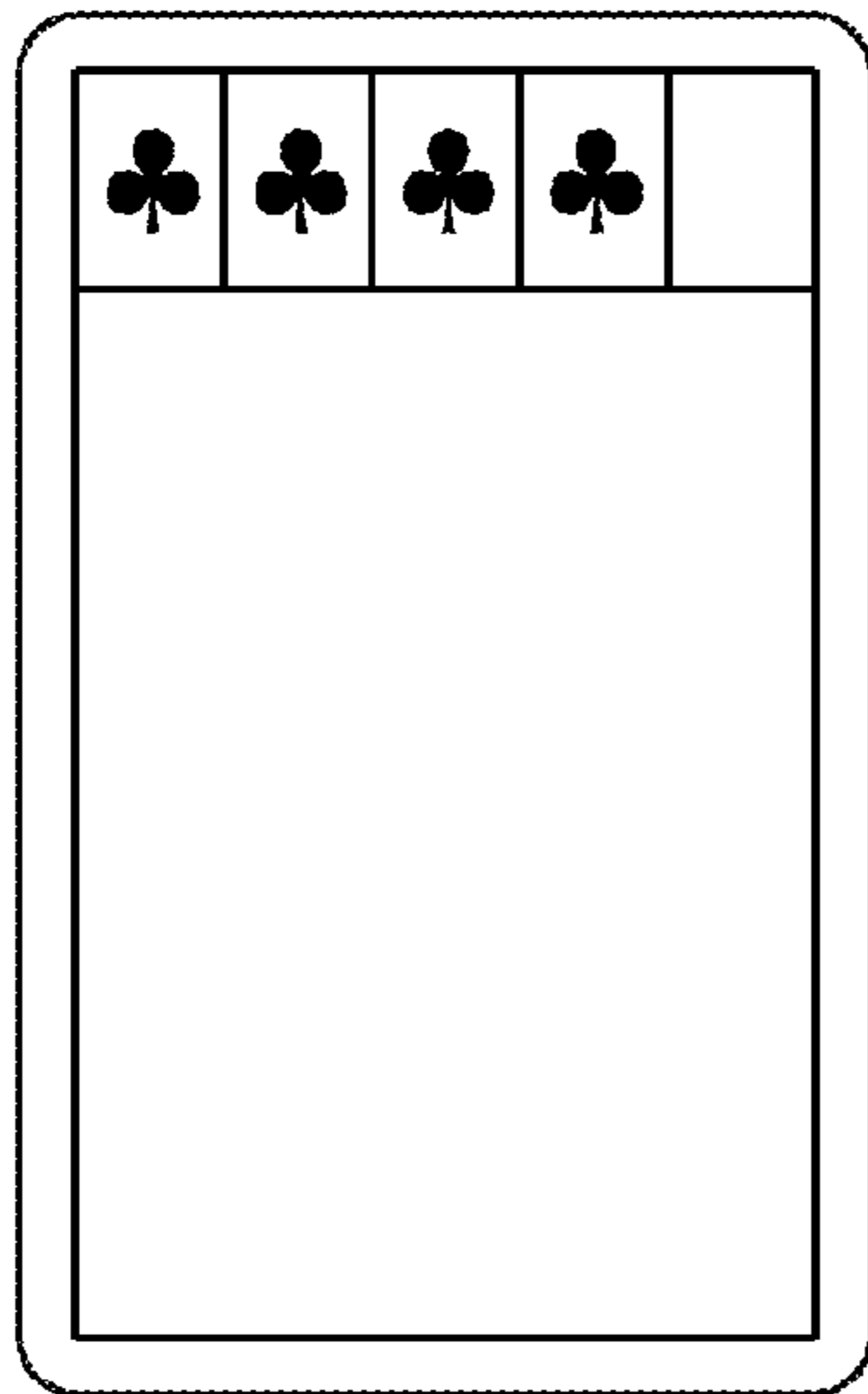
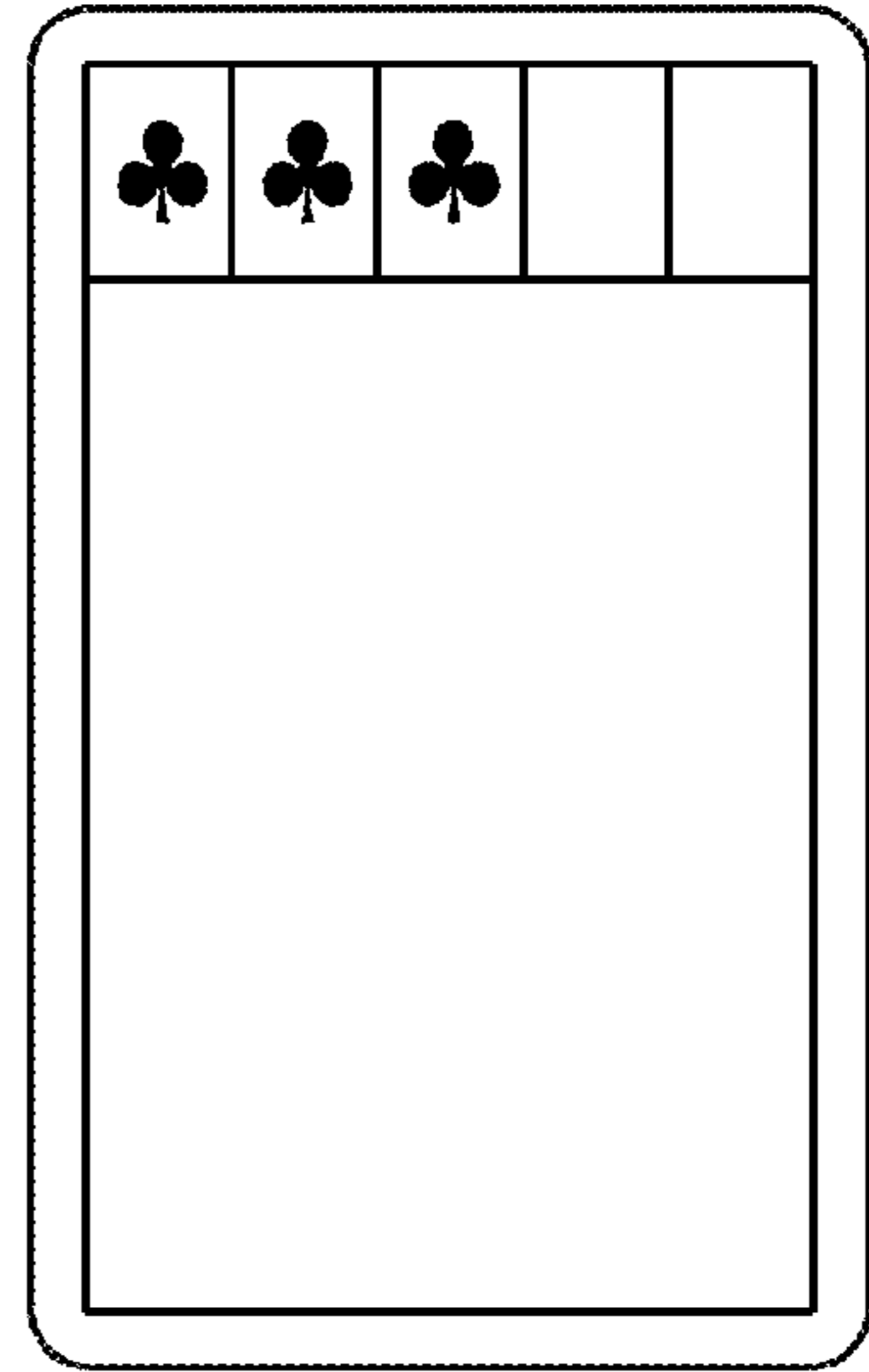

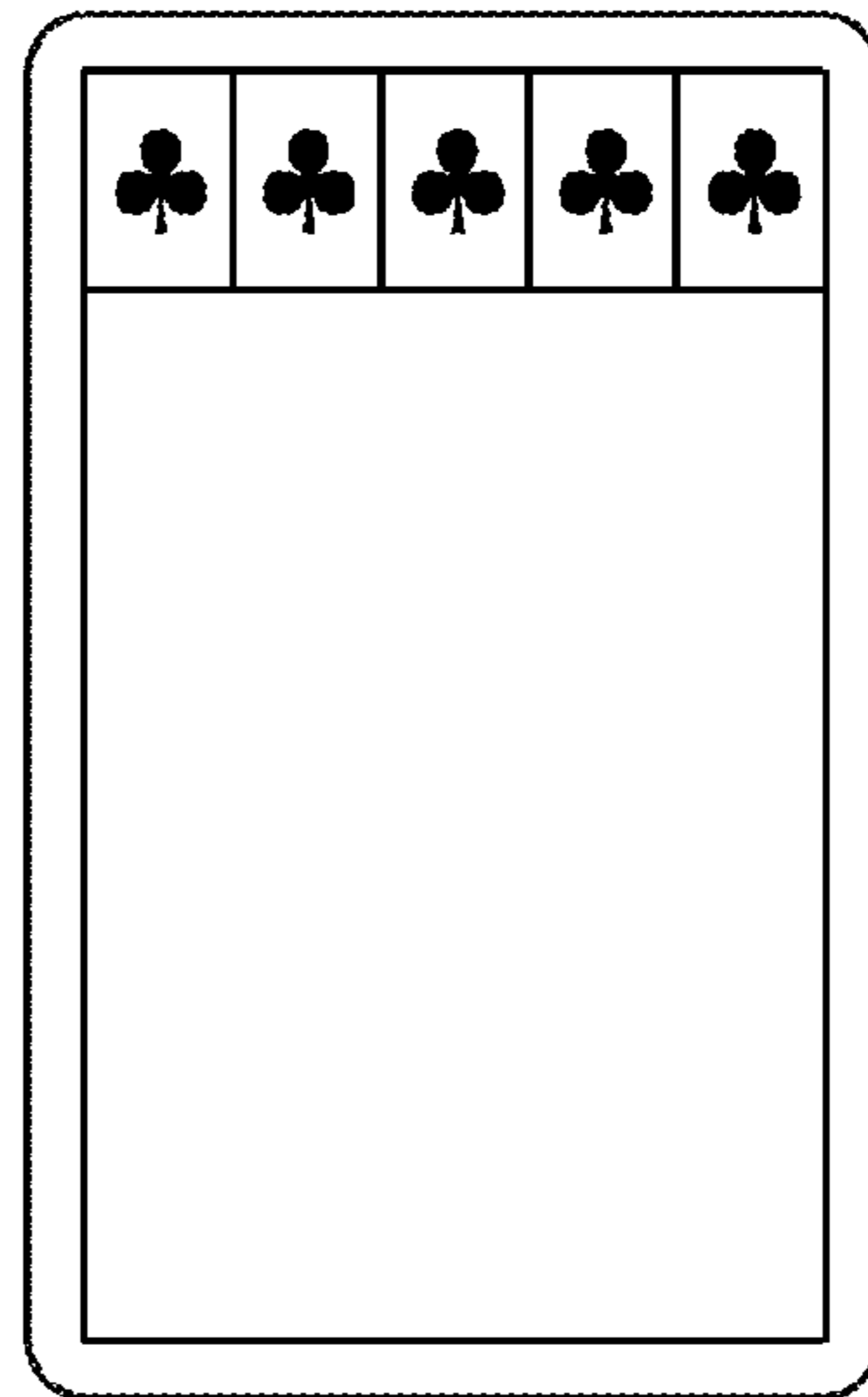

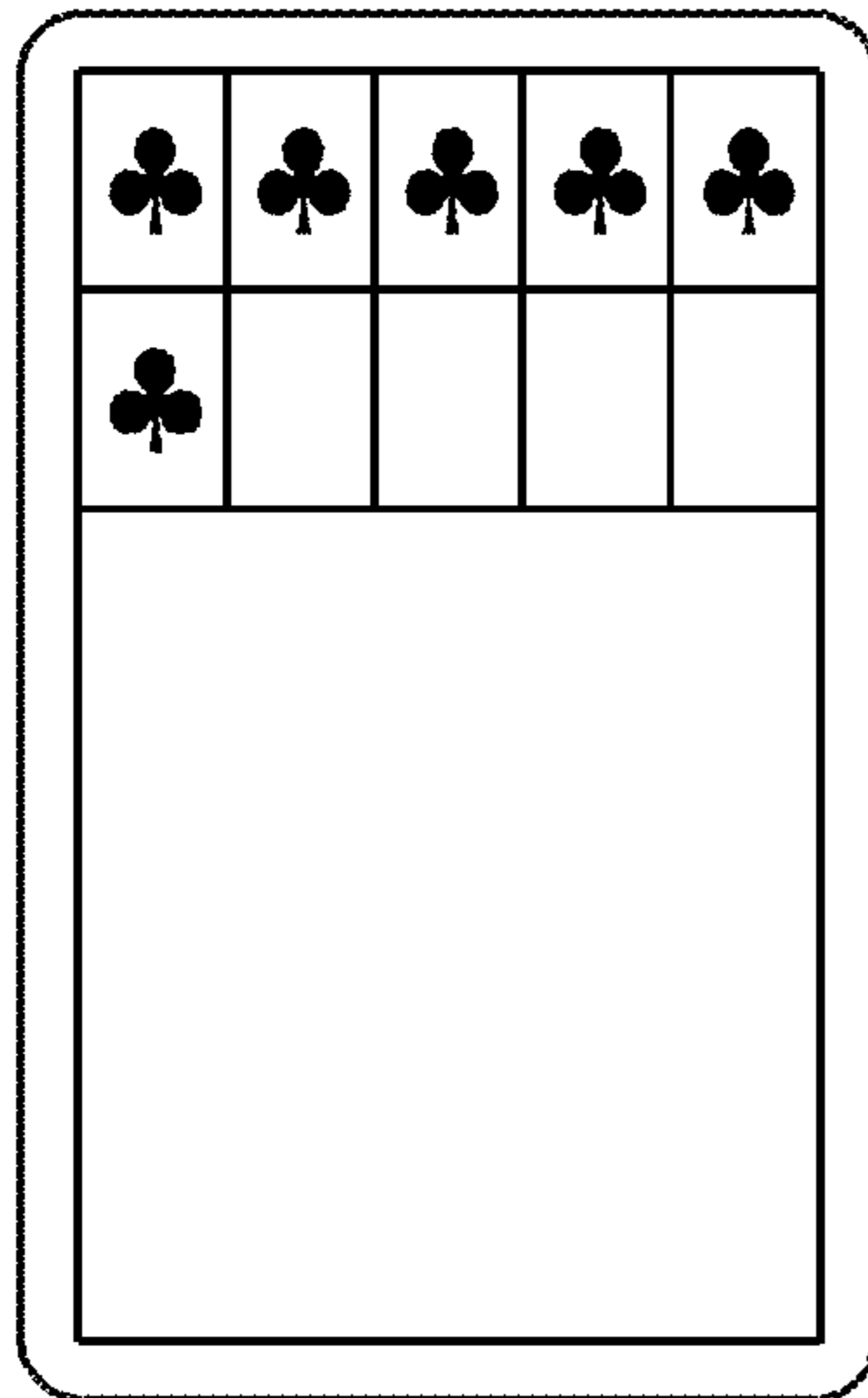

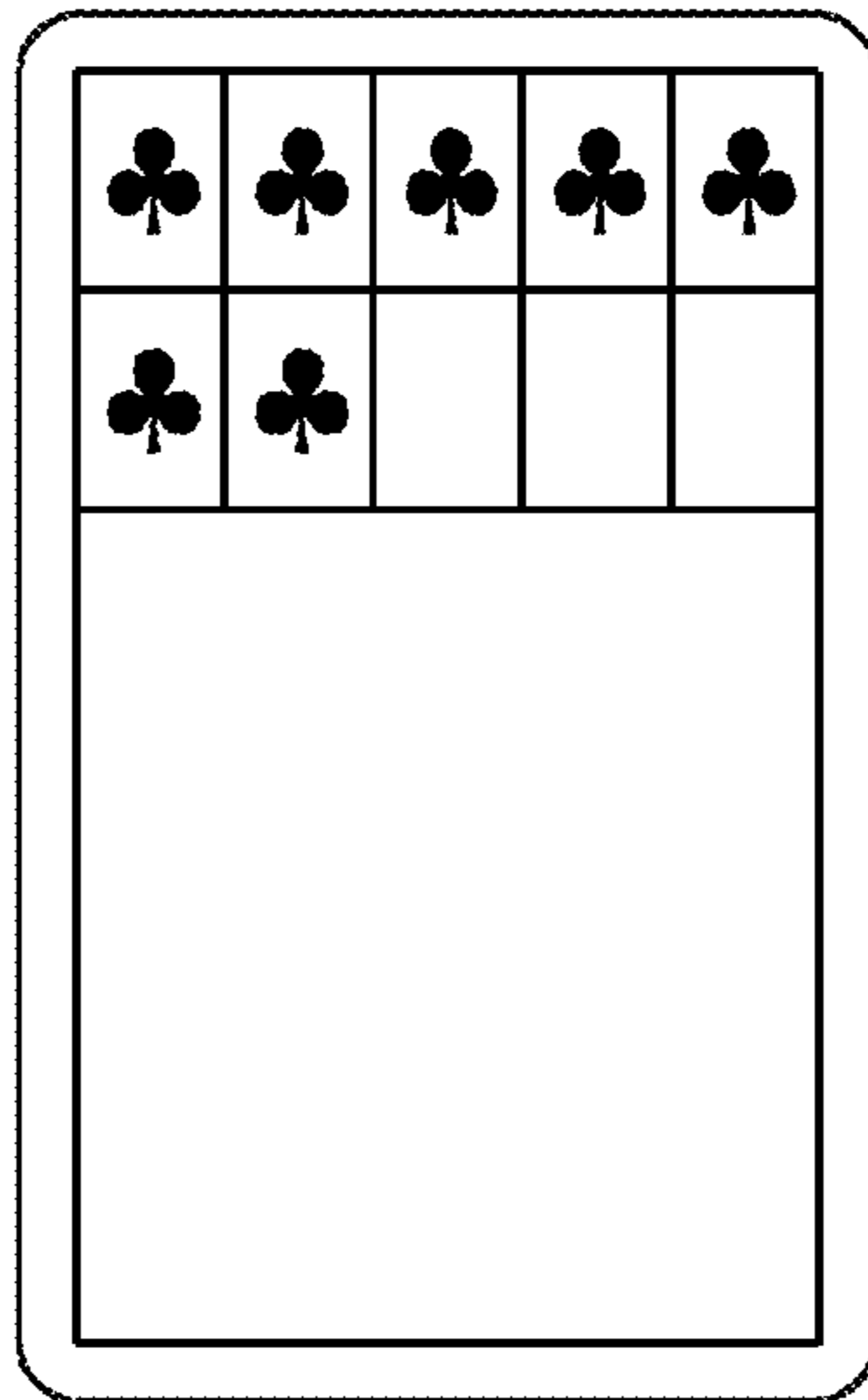

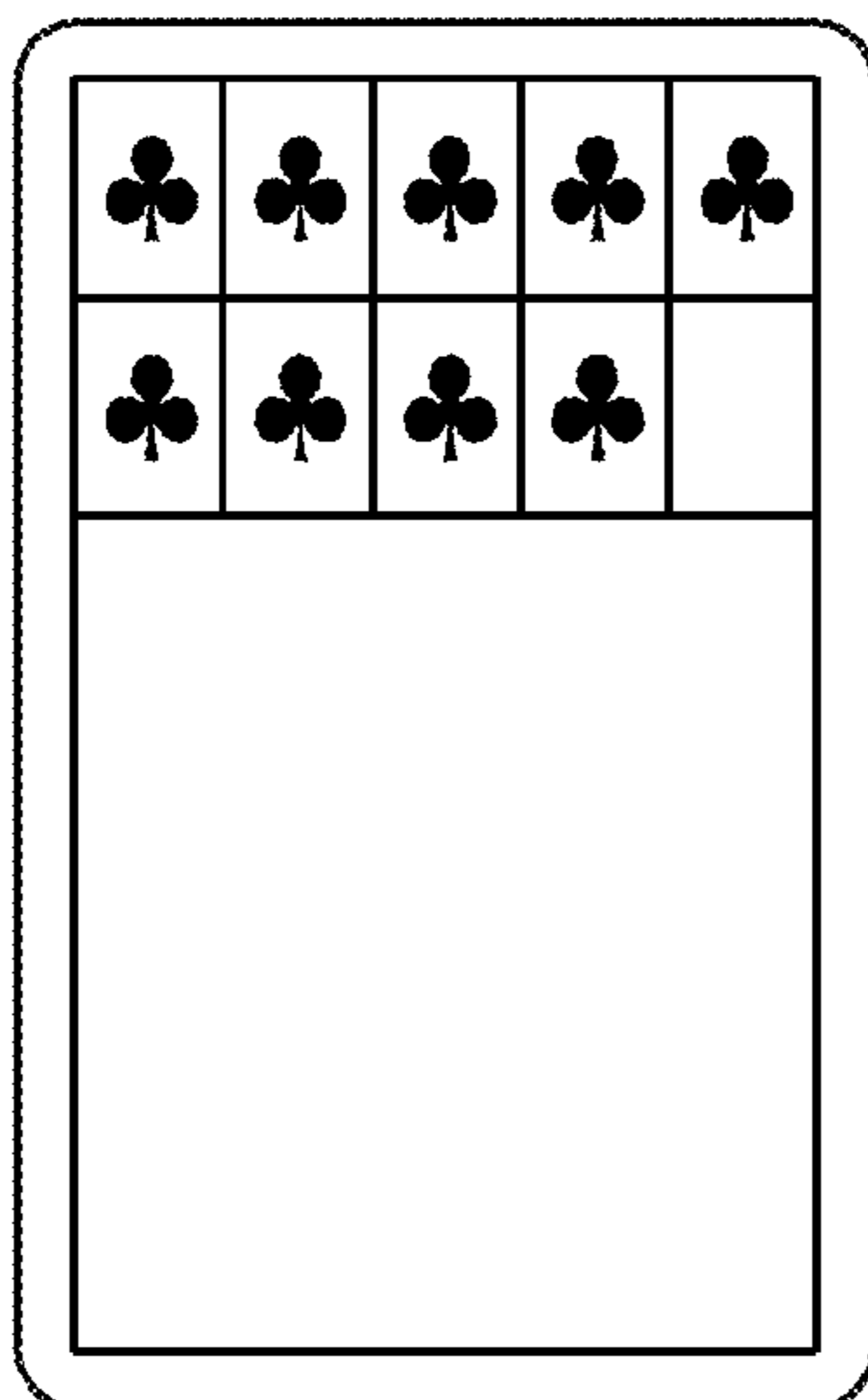
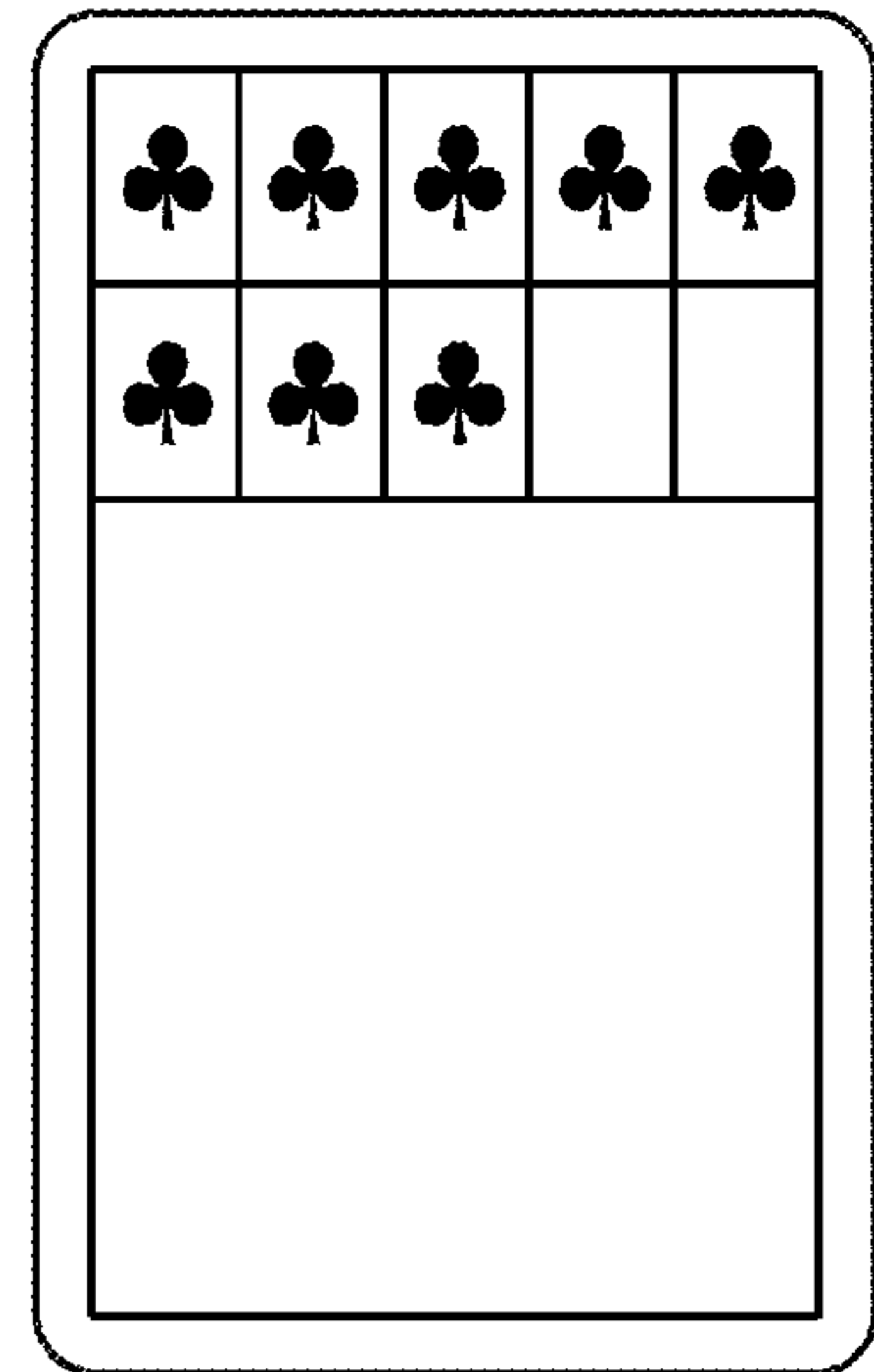

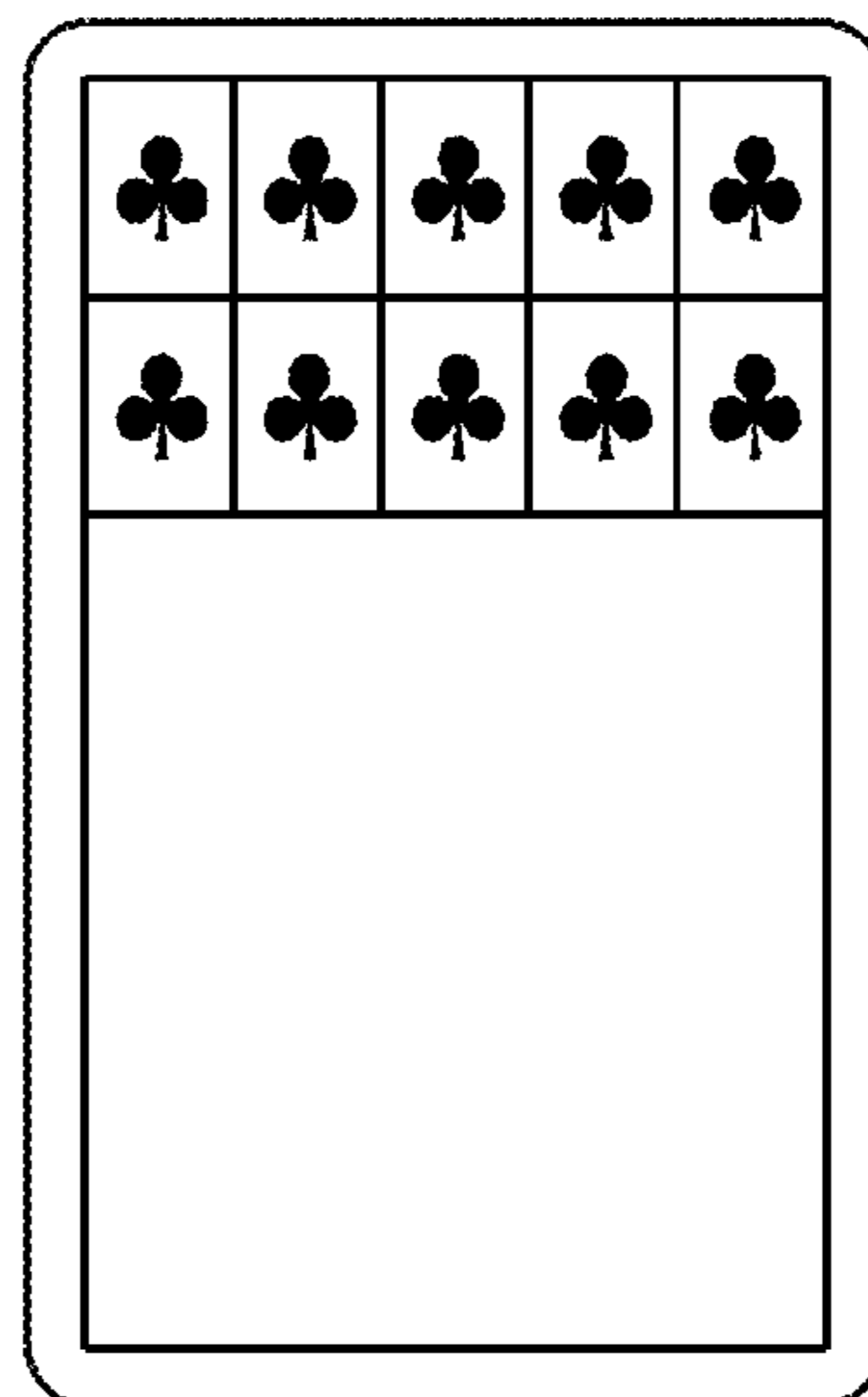

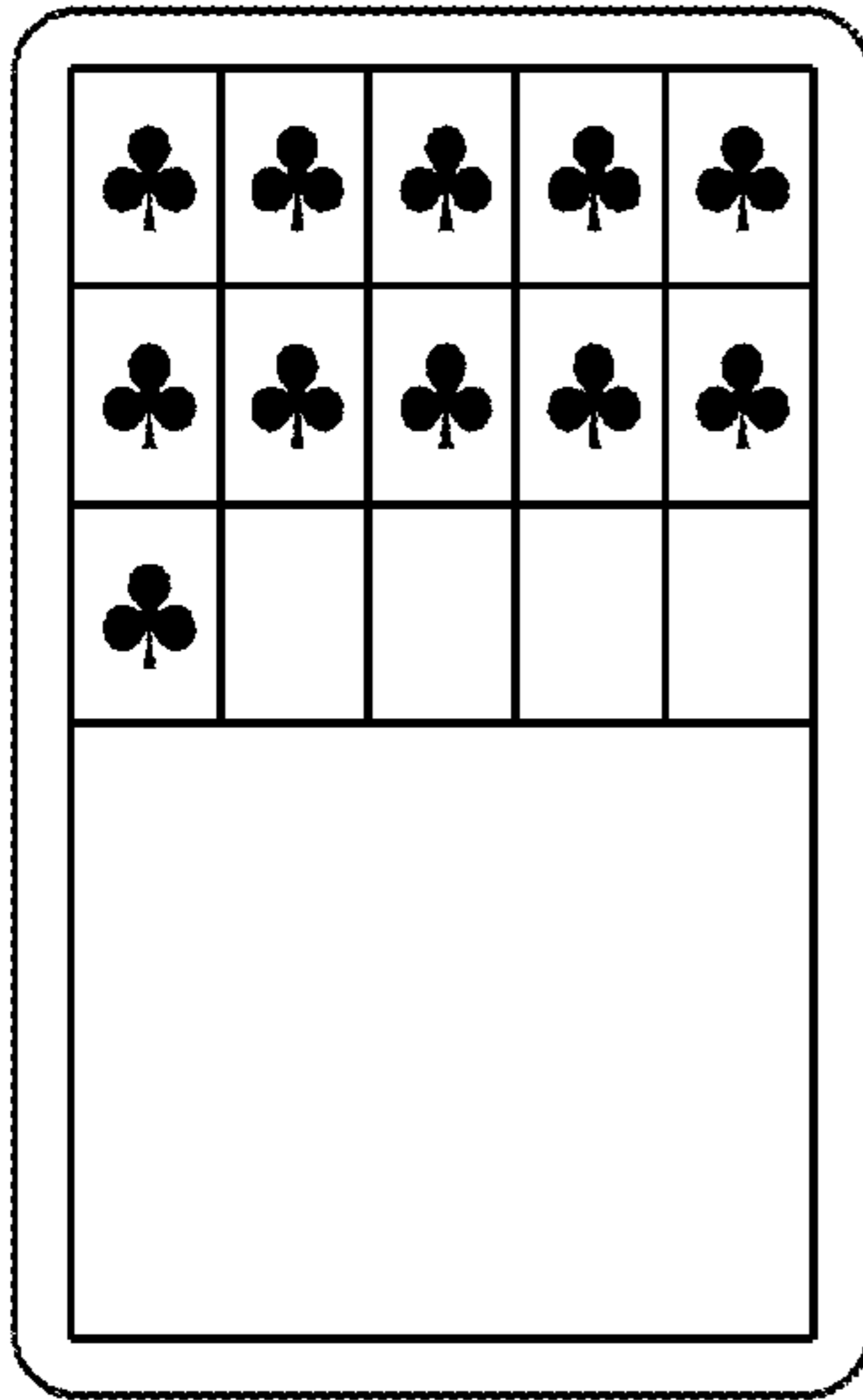

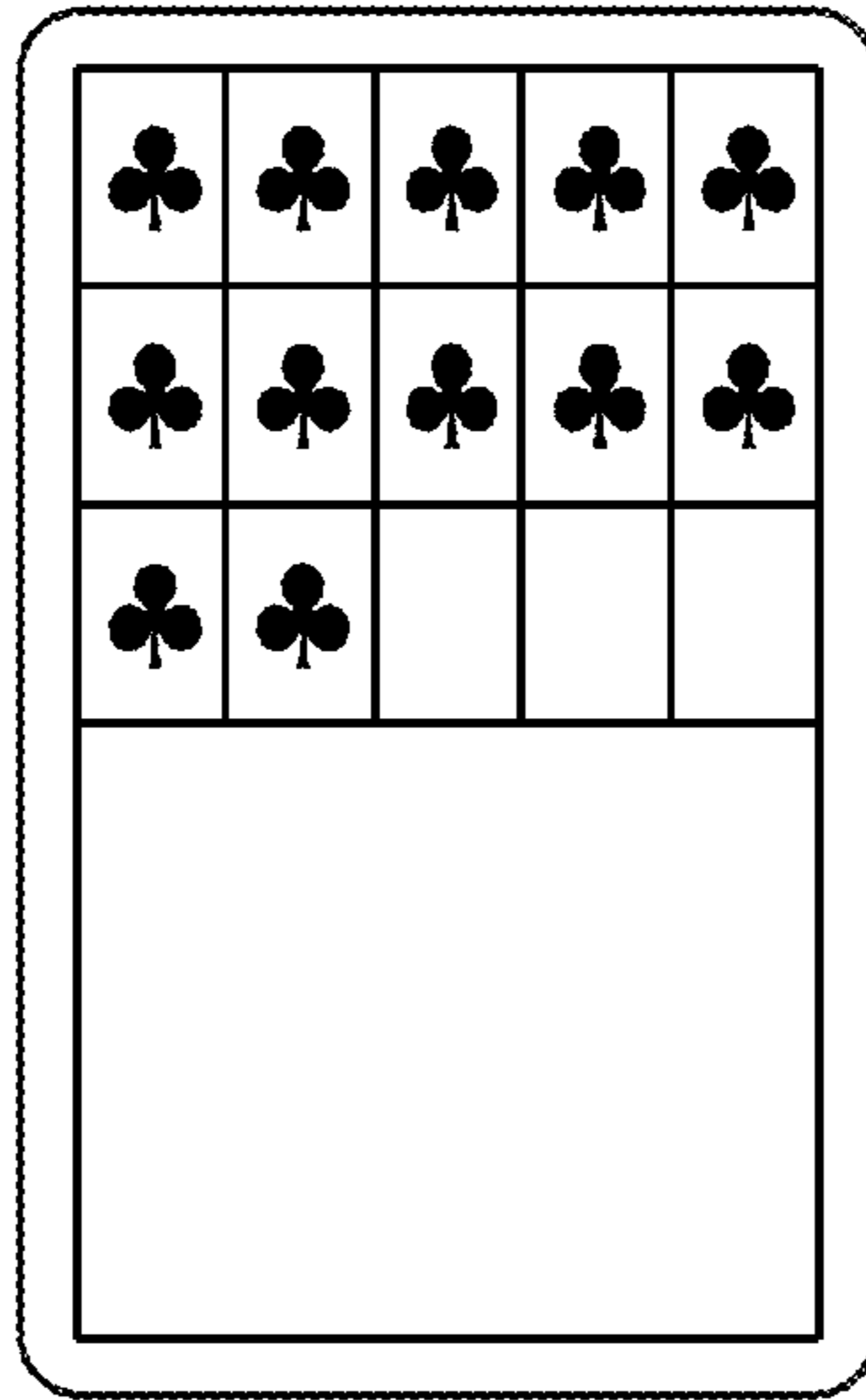

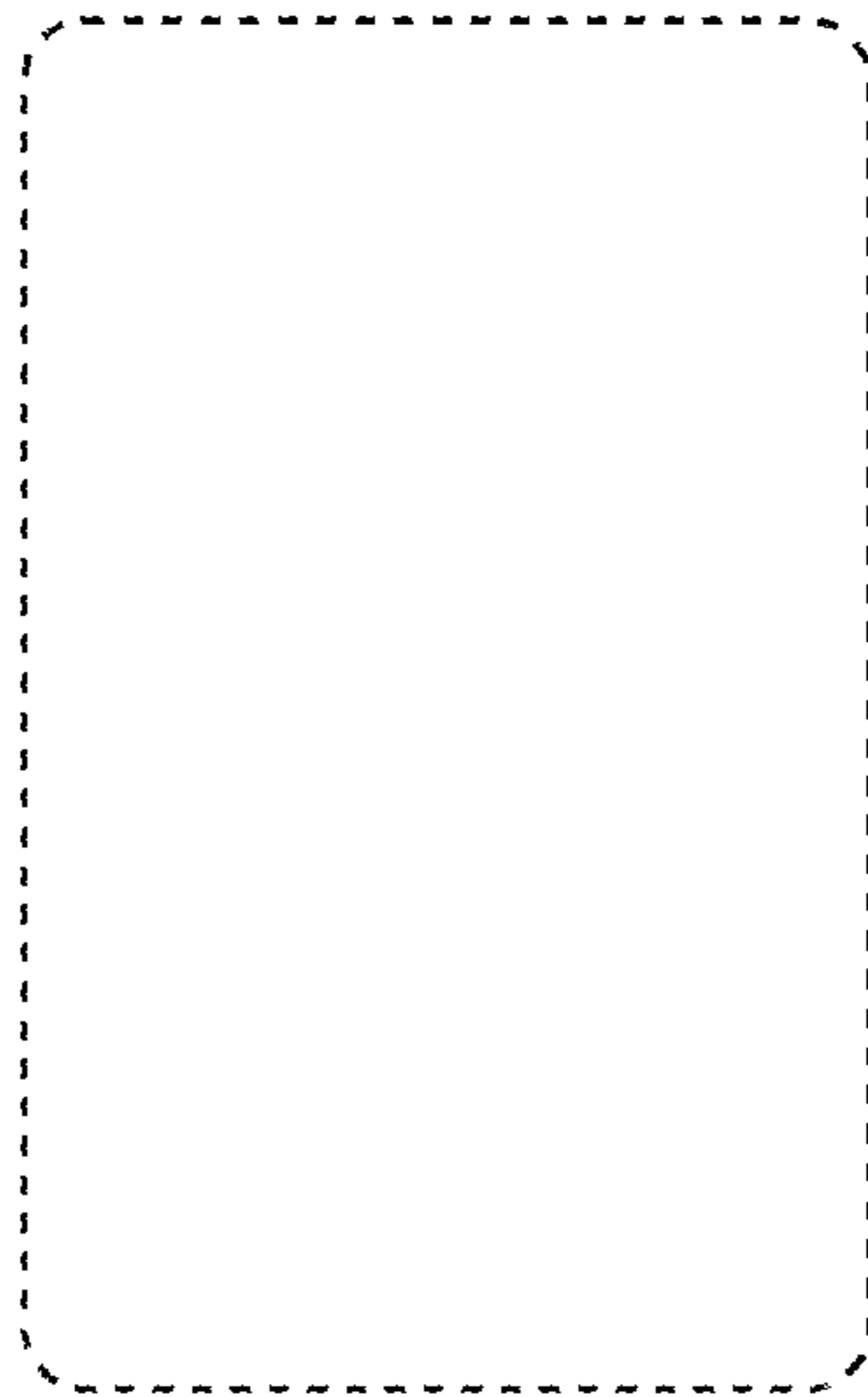
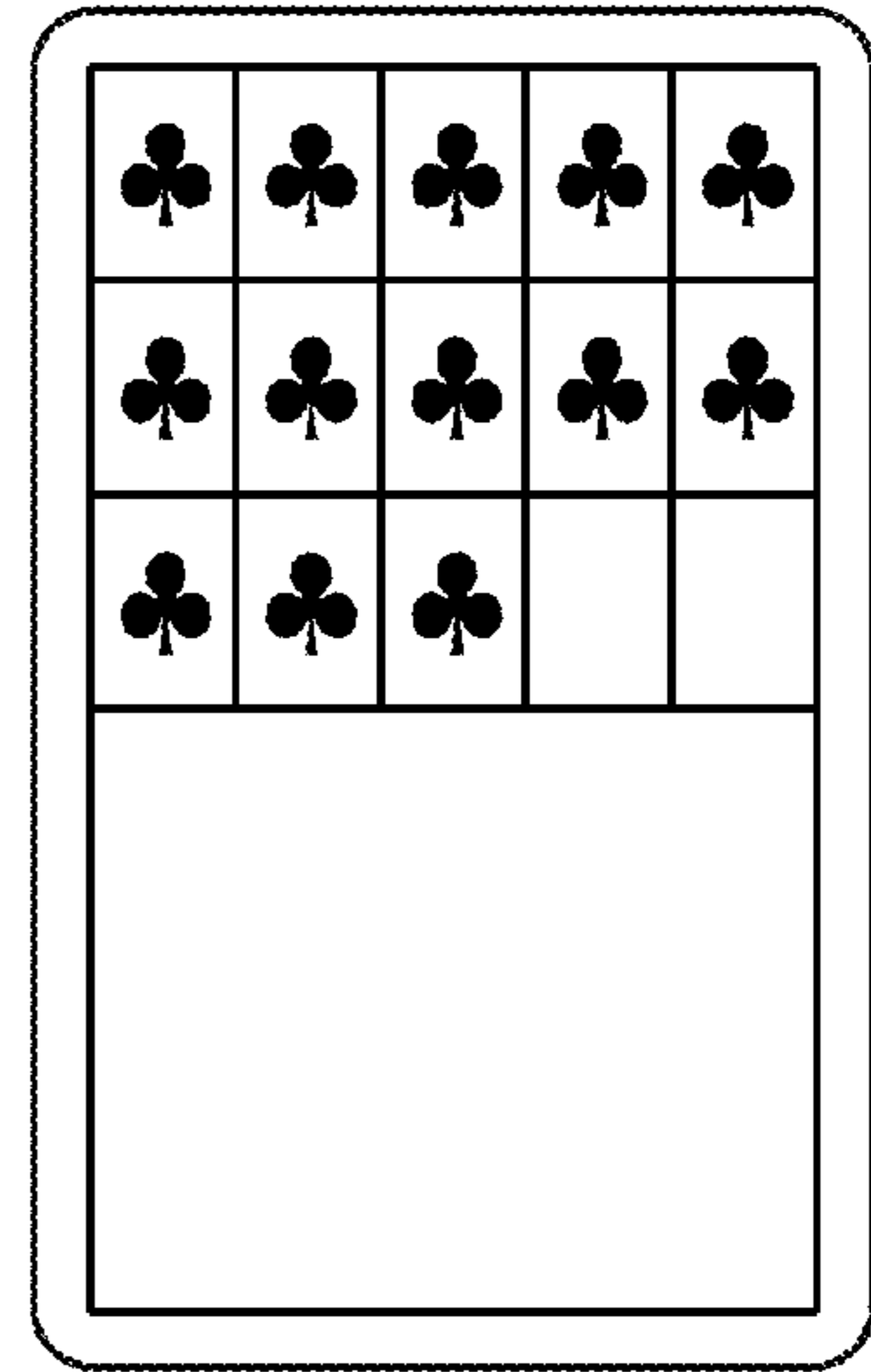
