The ornamental design for a label, as shown and described.

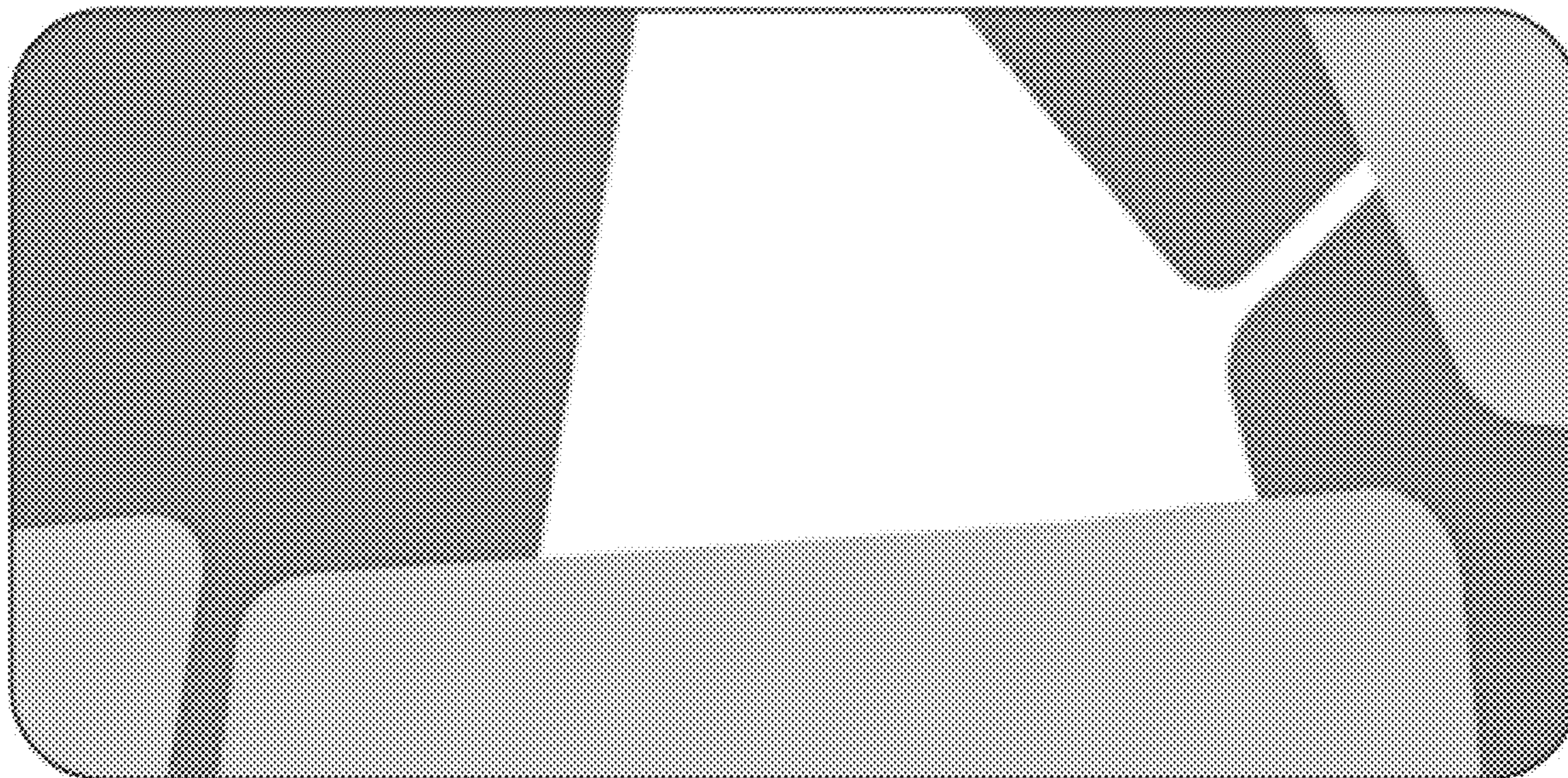
DESCRIPTION

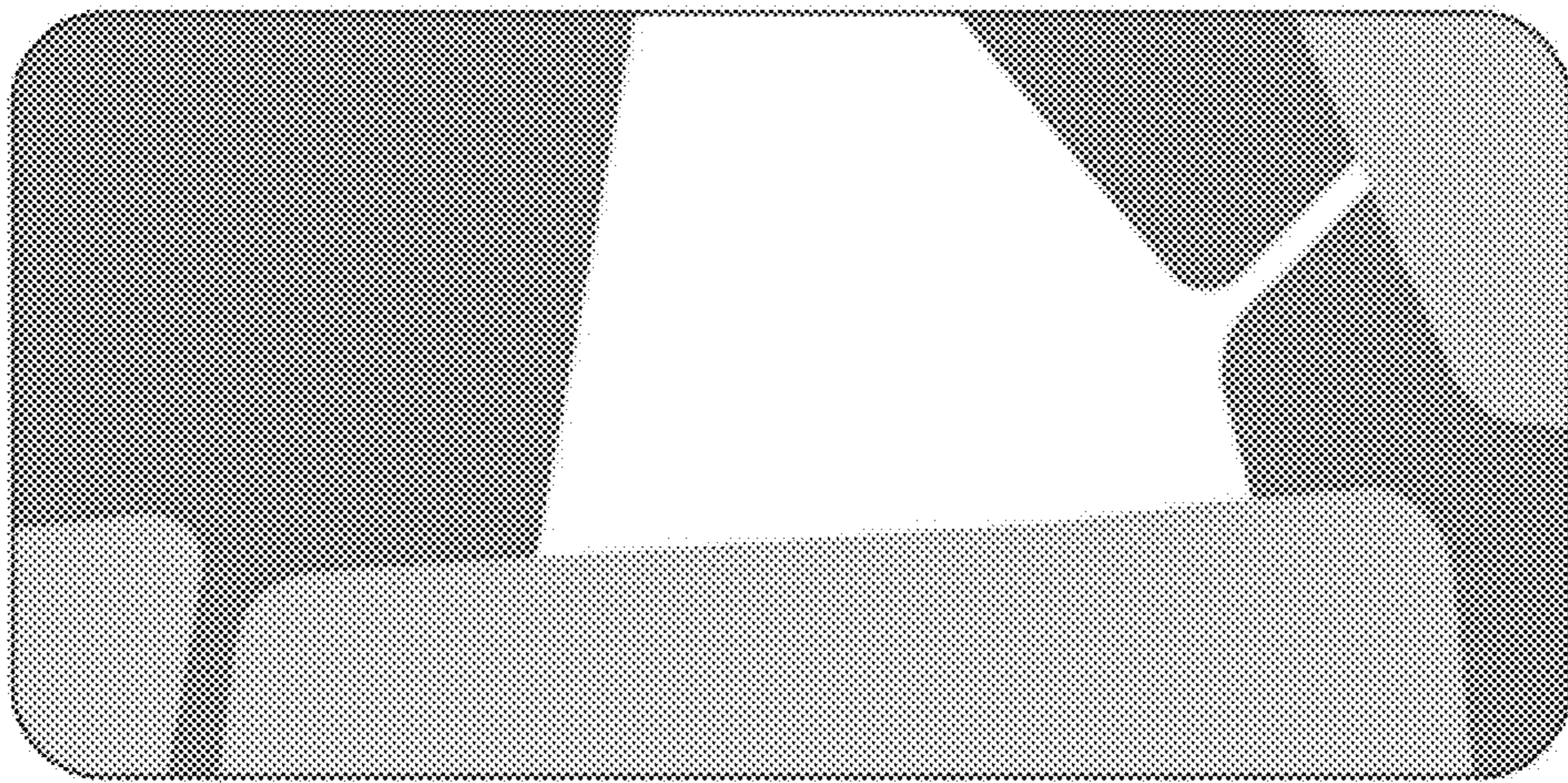

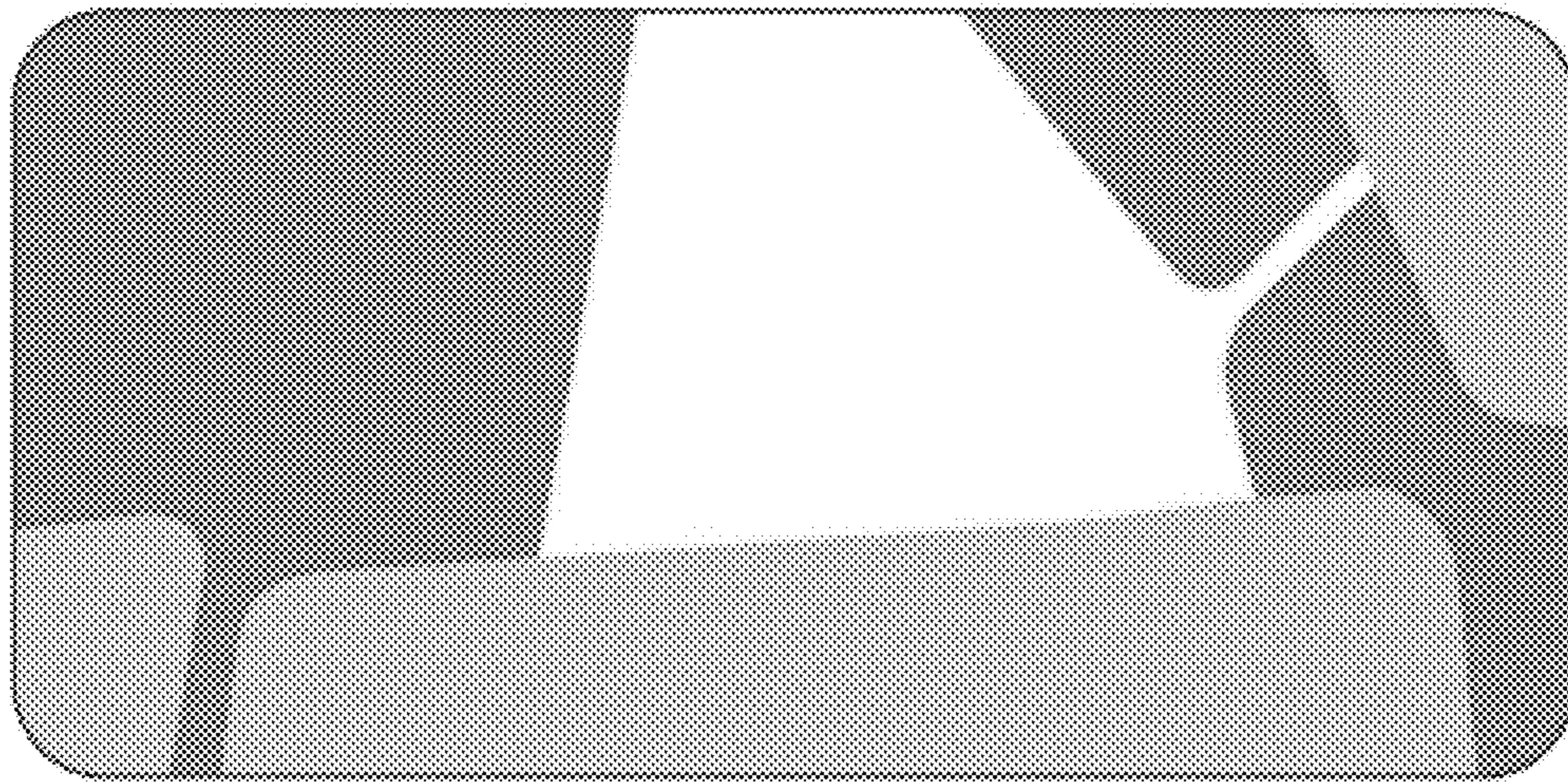
