**DESCRIPTION**

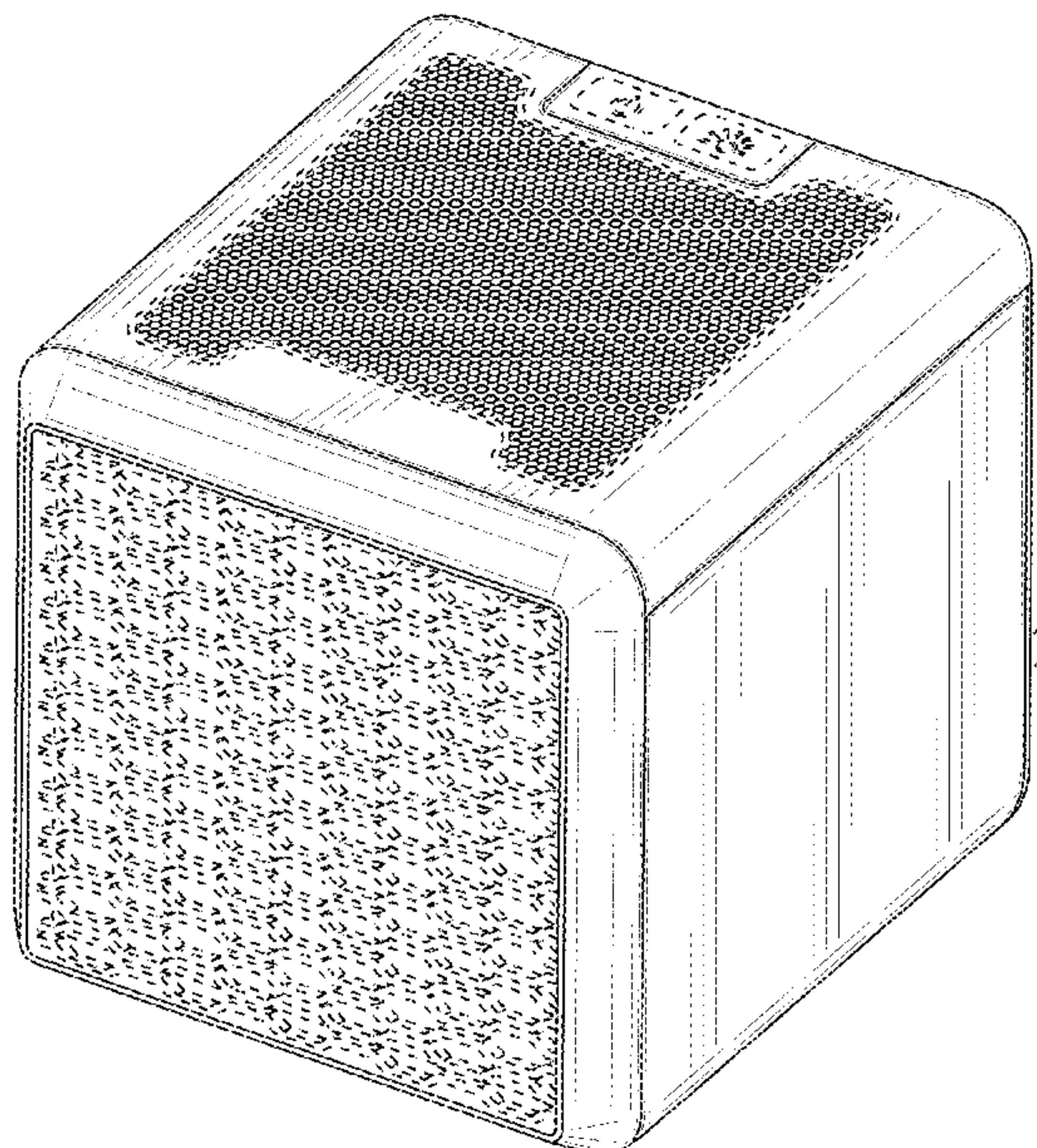
FIG. 1 is a perspective view of a personal heater showing my new design;

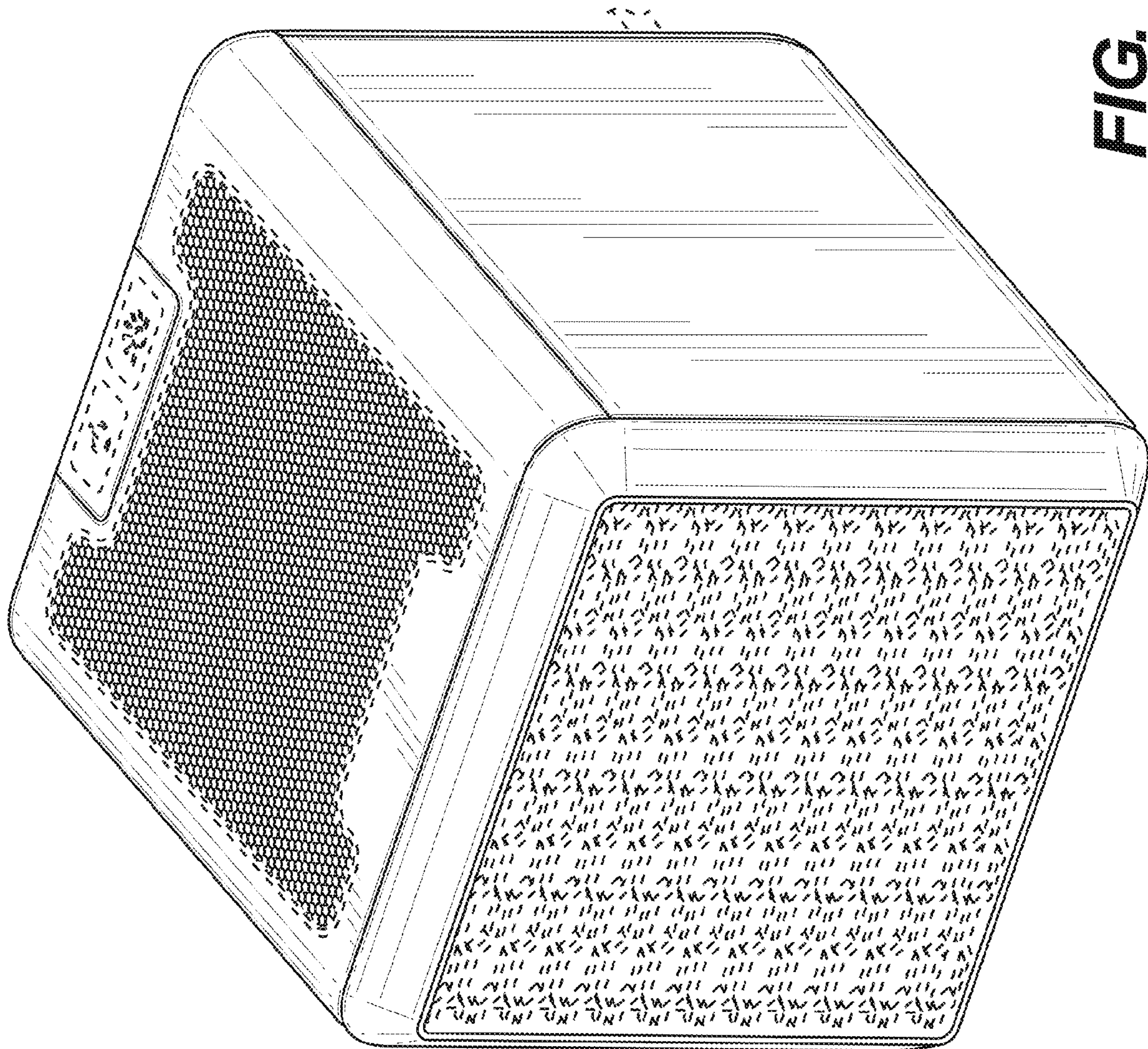
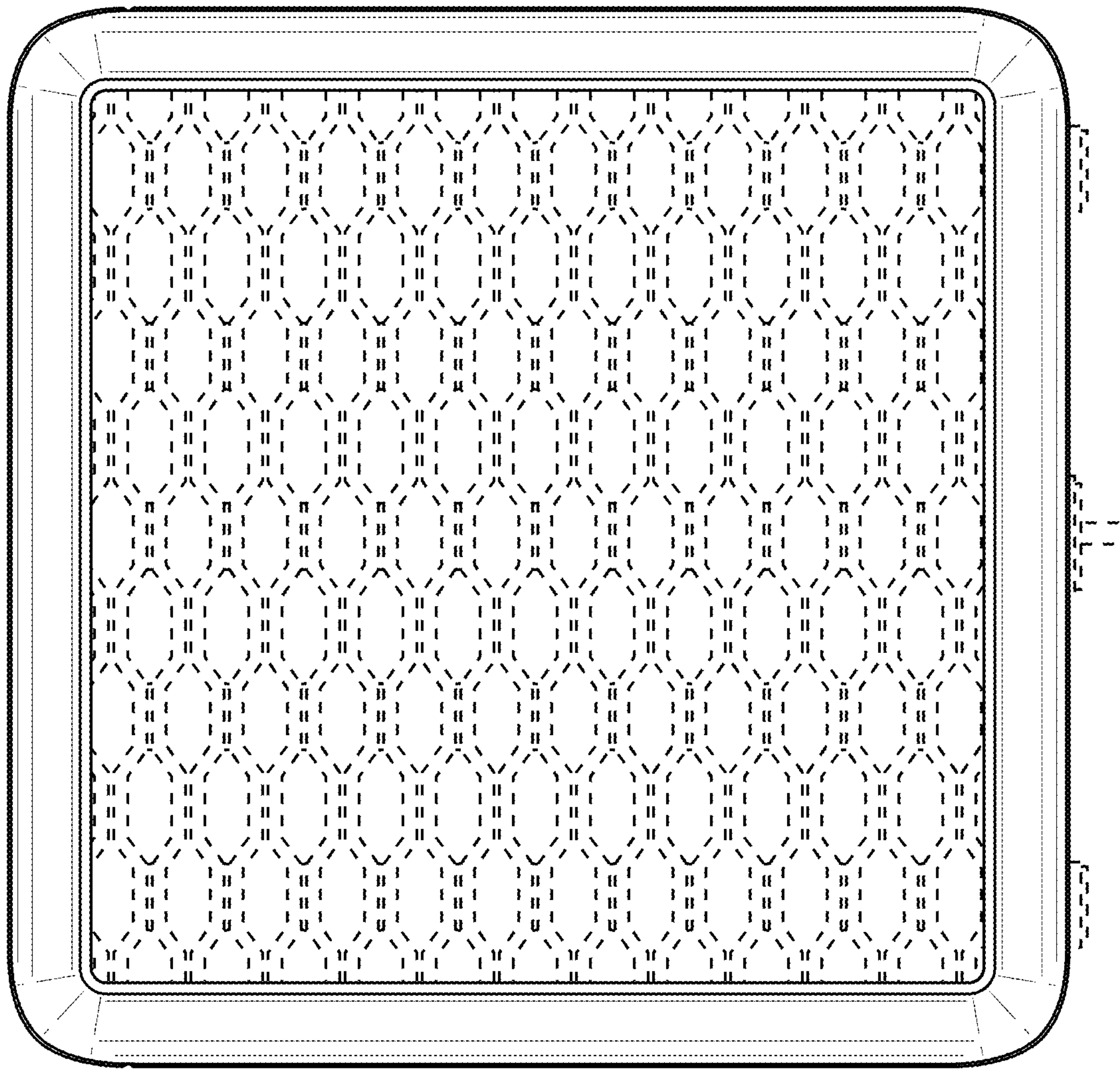
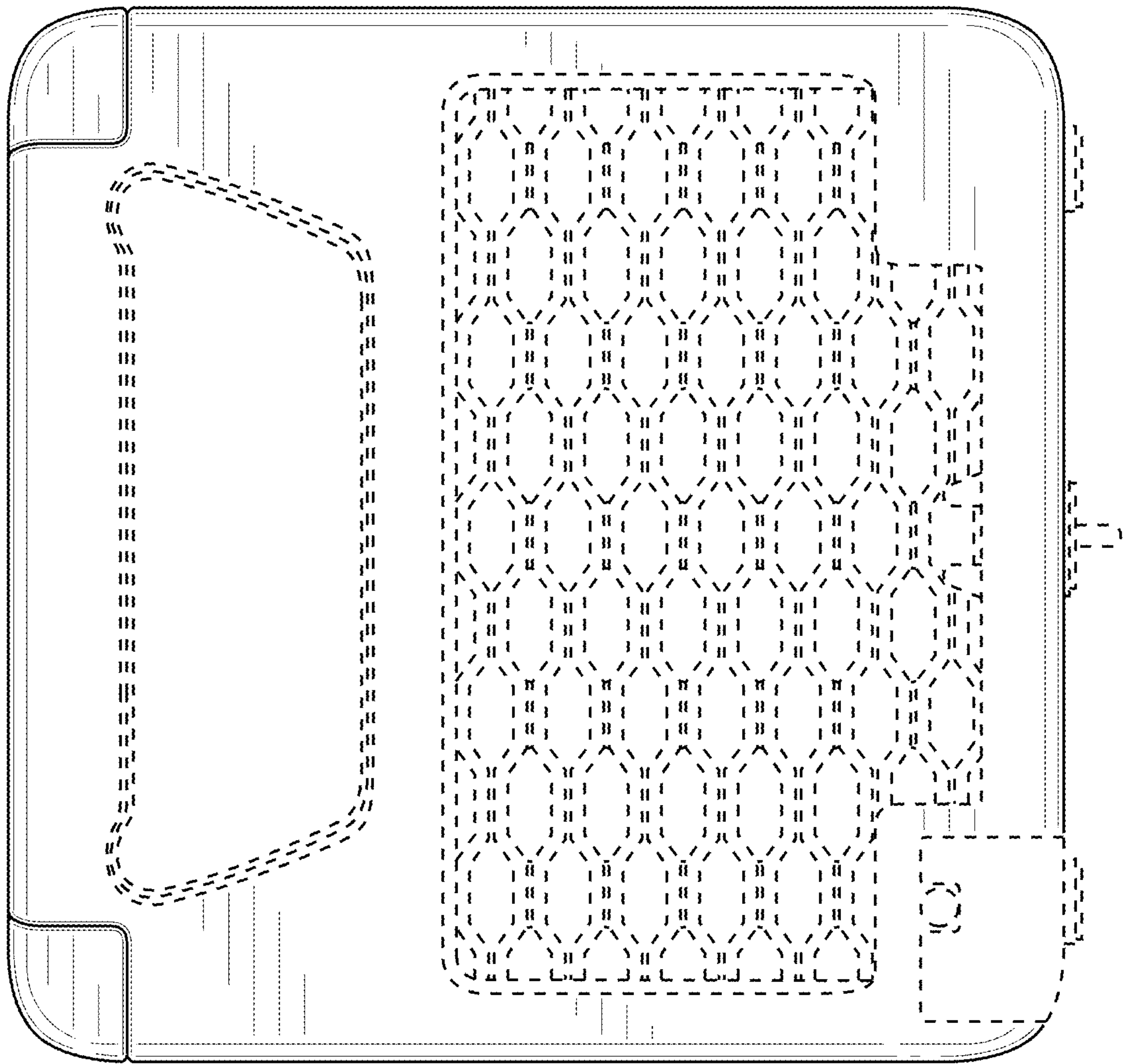

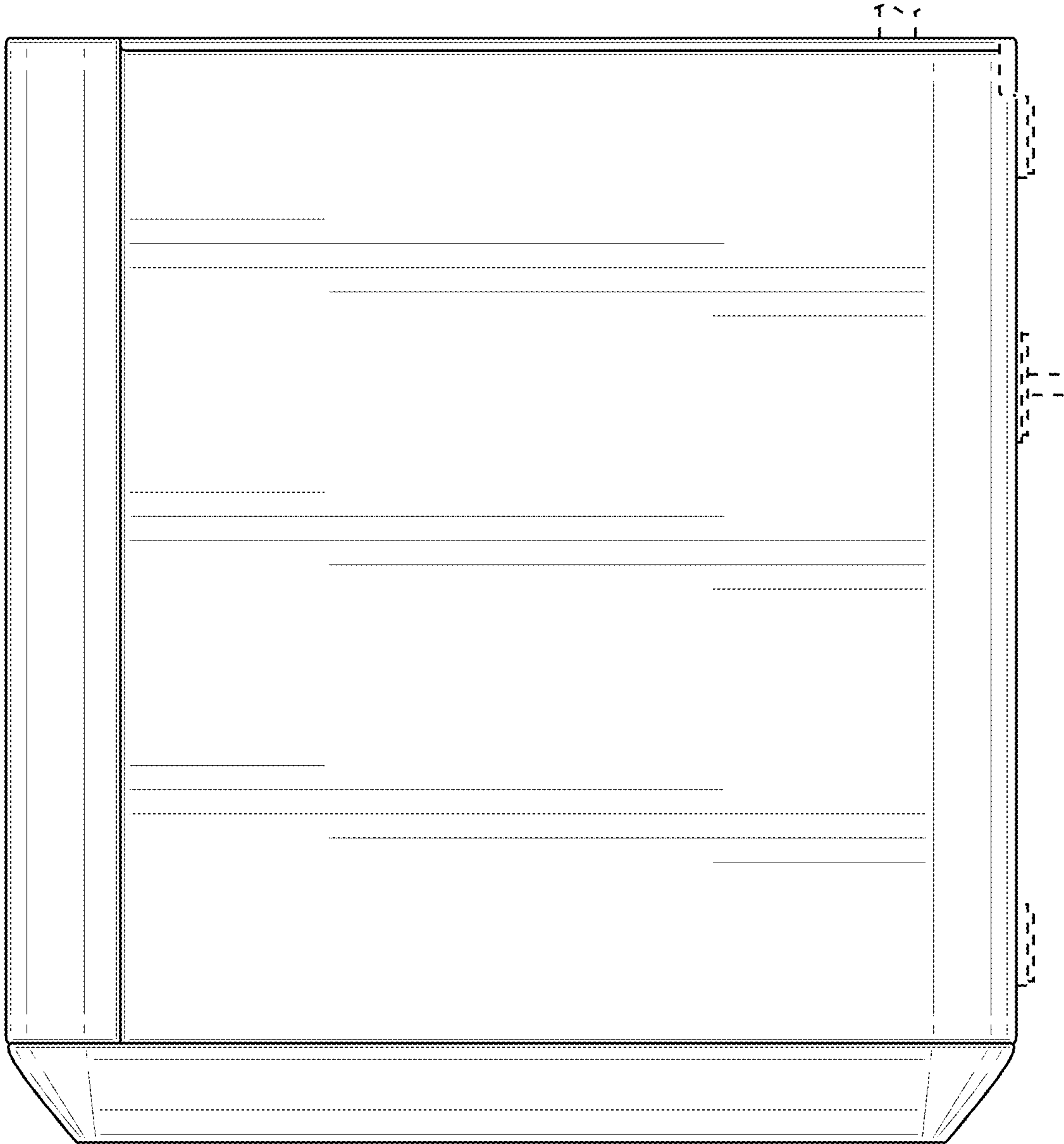

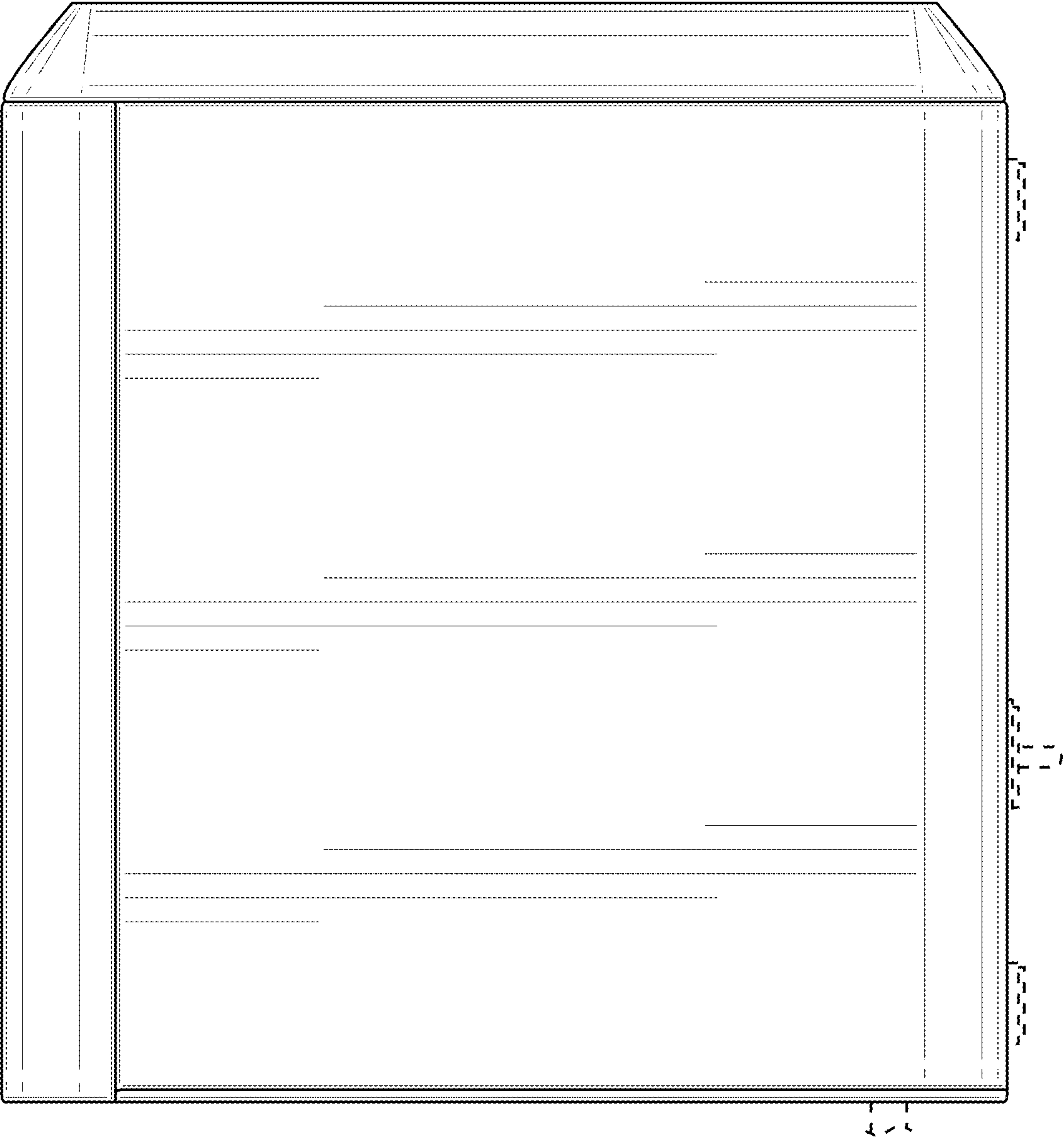




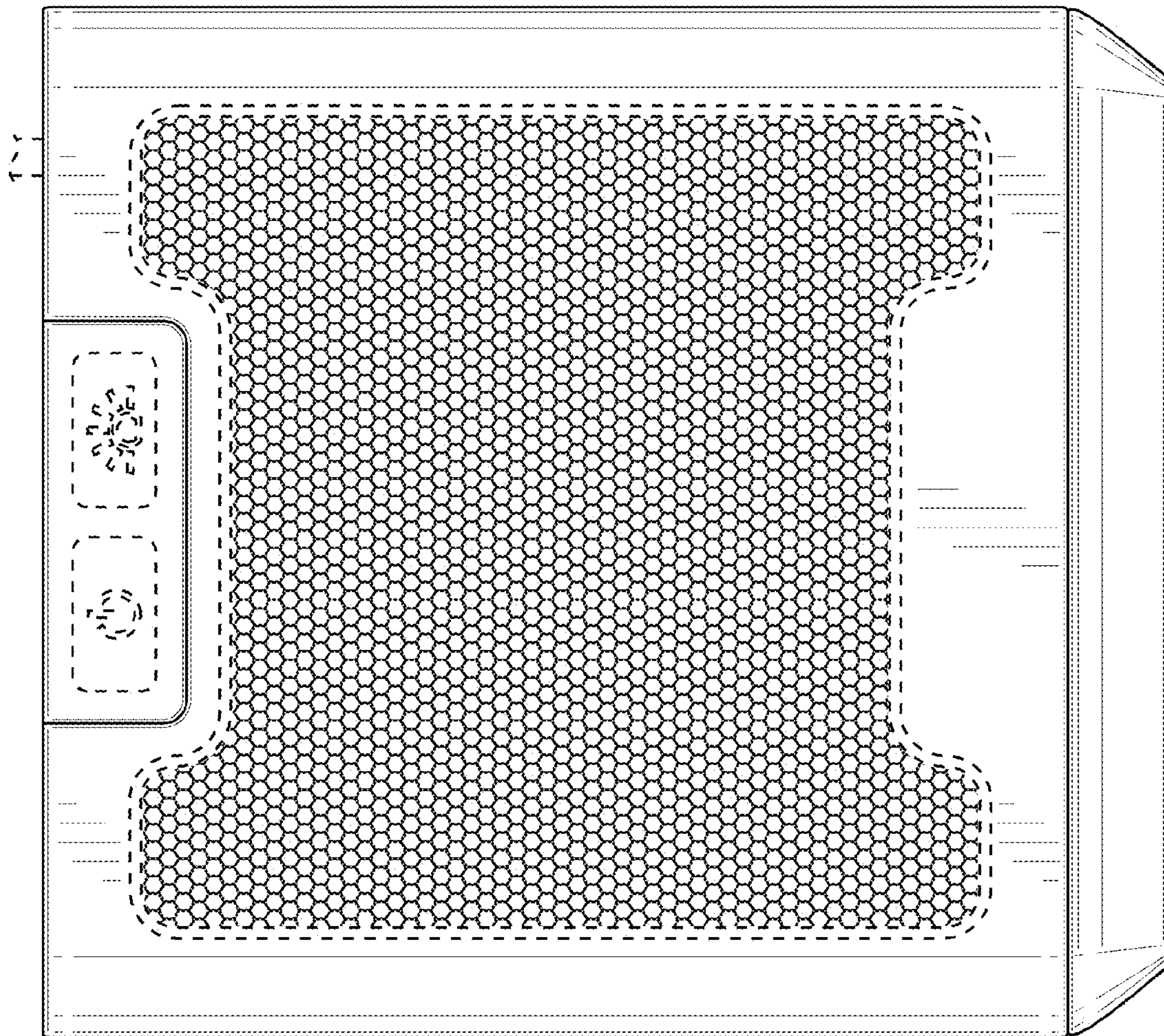

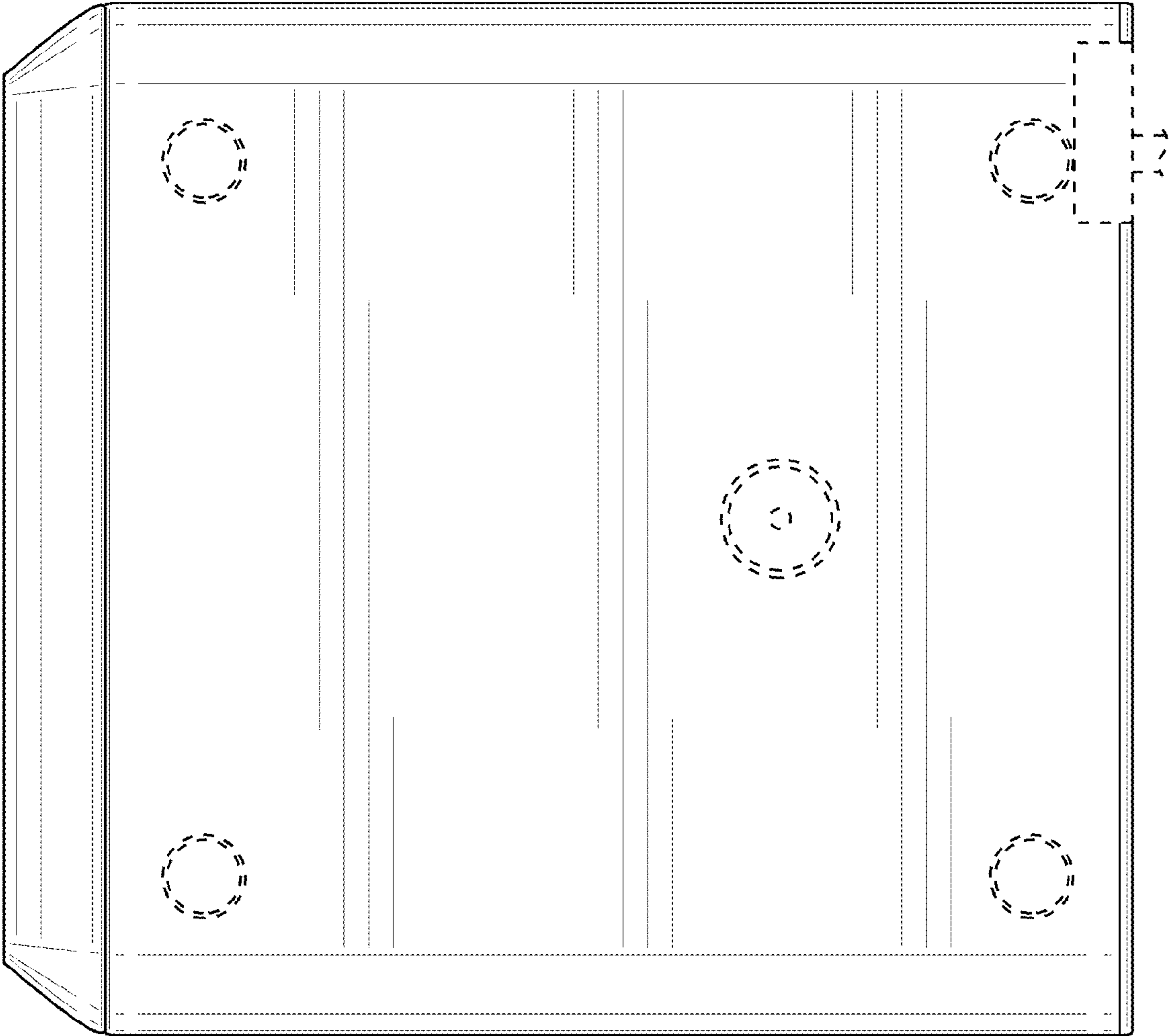
