(57) **CLAIM**

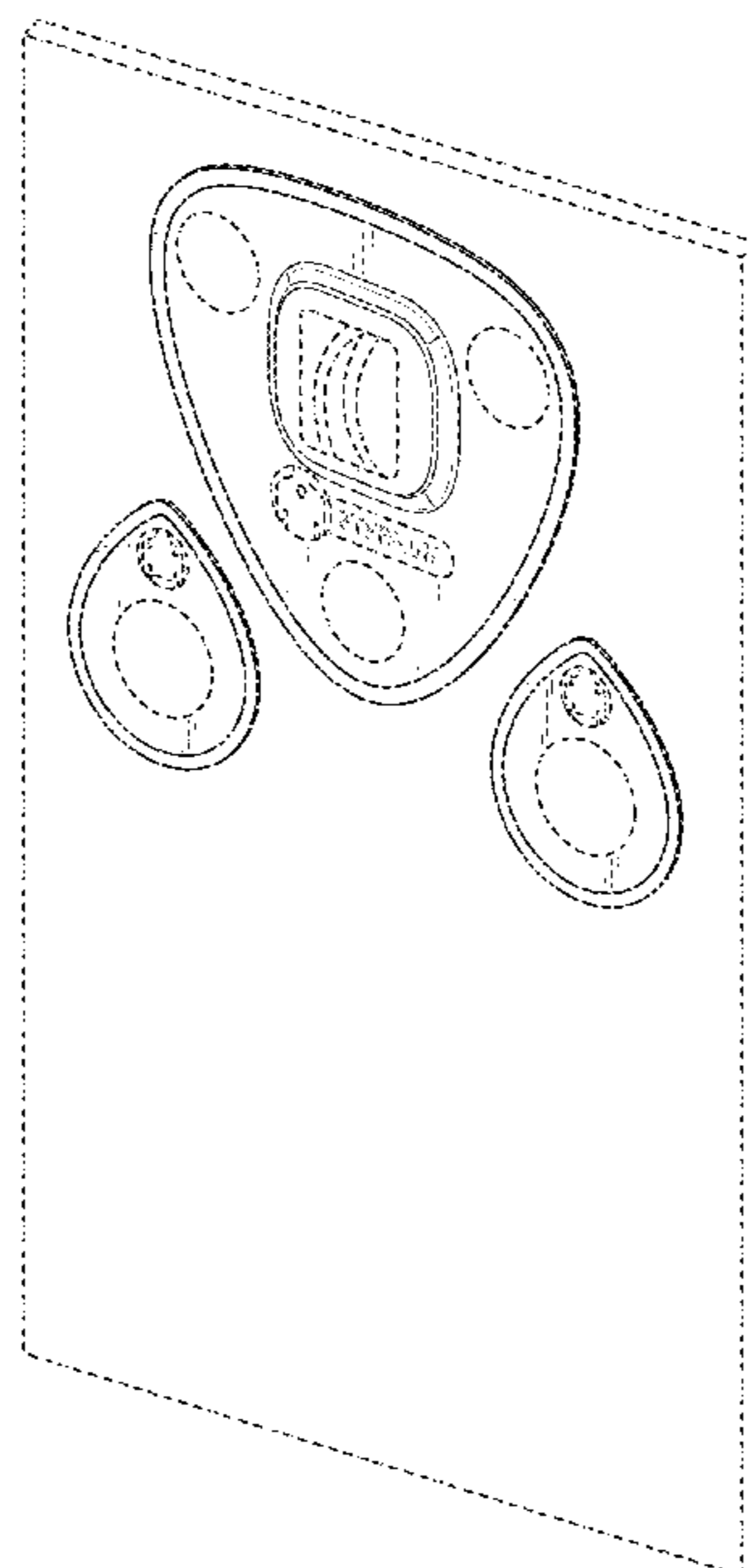
The ornamental design for a kit of positioning patches, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of a design of a kit of positioning patches.
 FIG. 2 is a front view of the design of the kit of positioning patches.
 FIG. 3 is a left side view of the design of the kit of positioning patches. The right side view of the design of the kit of positioning patches is the mirror image of the left side view of FIG. 3.
 FIG. 4 is a top view of the design of the kit of positioning patches; and,
 FIG. 5 is a bottom view of the design of the kit of positioning patches.
 The broken lines shown in FIGS. 1-5 represent portions of the design of the kit of positioning patches that form no part of the claim.

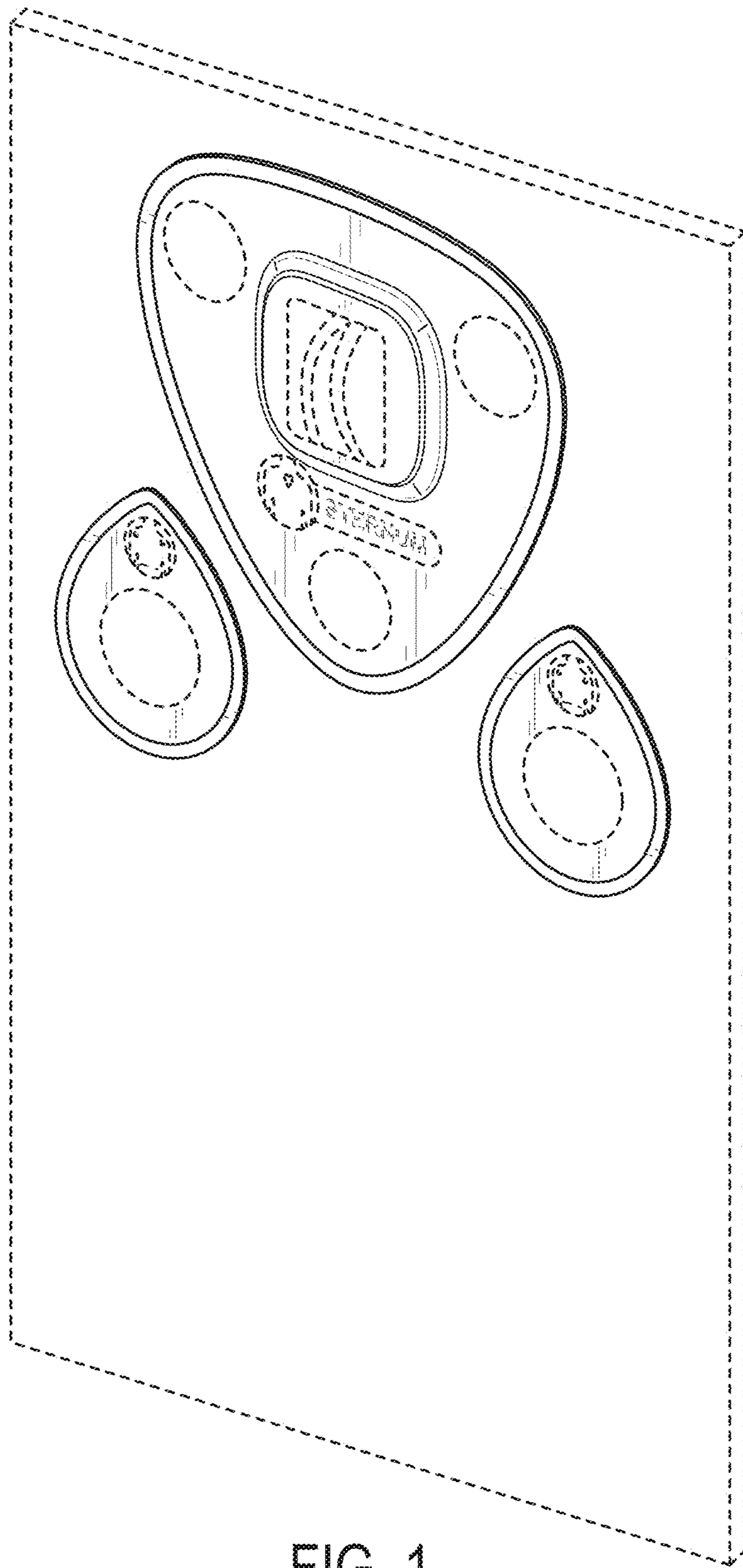

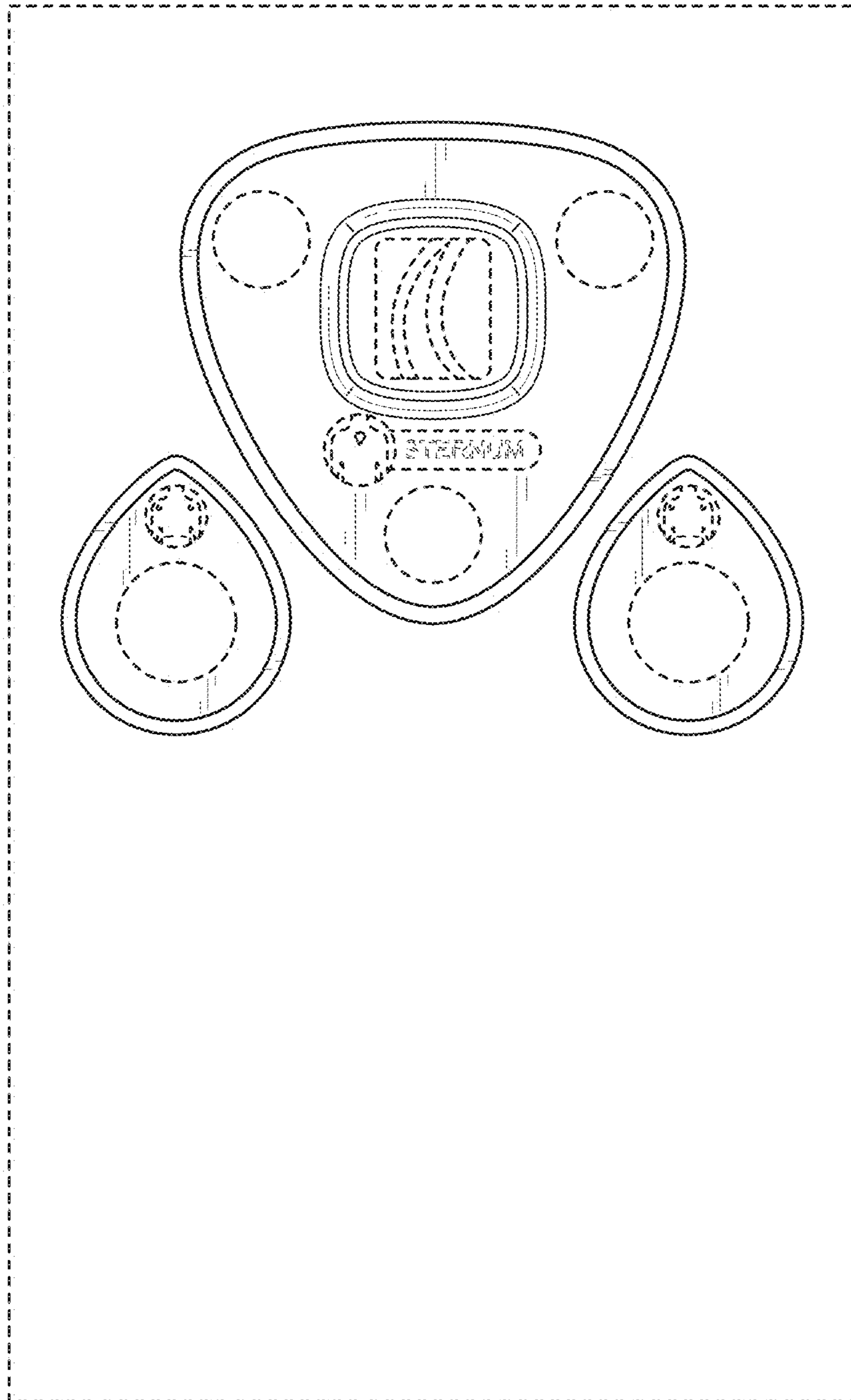

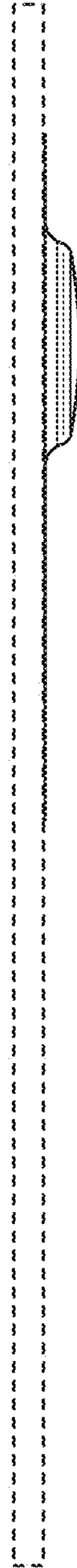

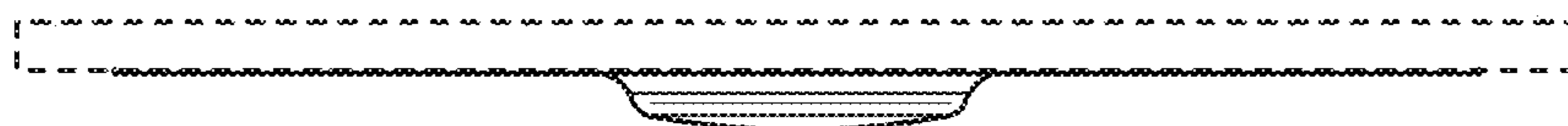

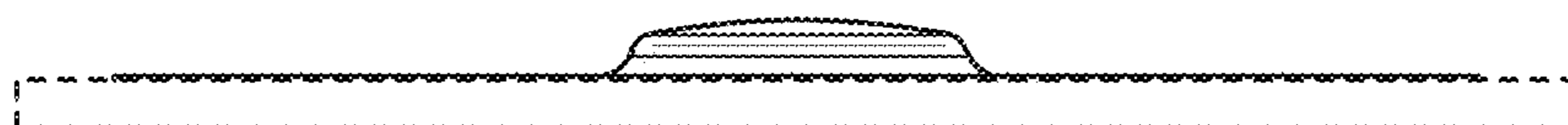
