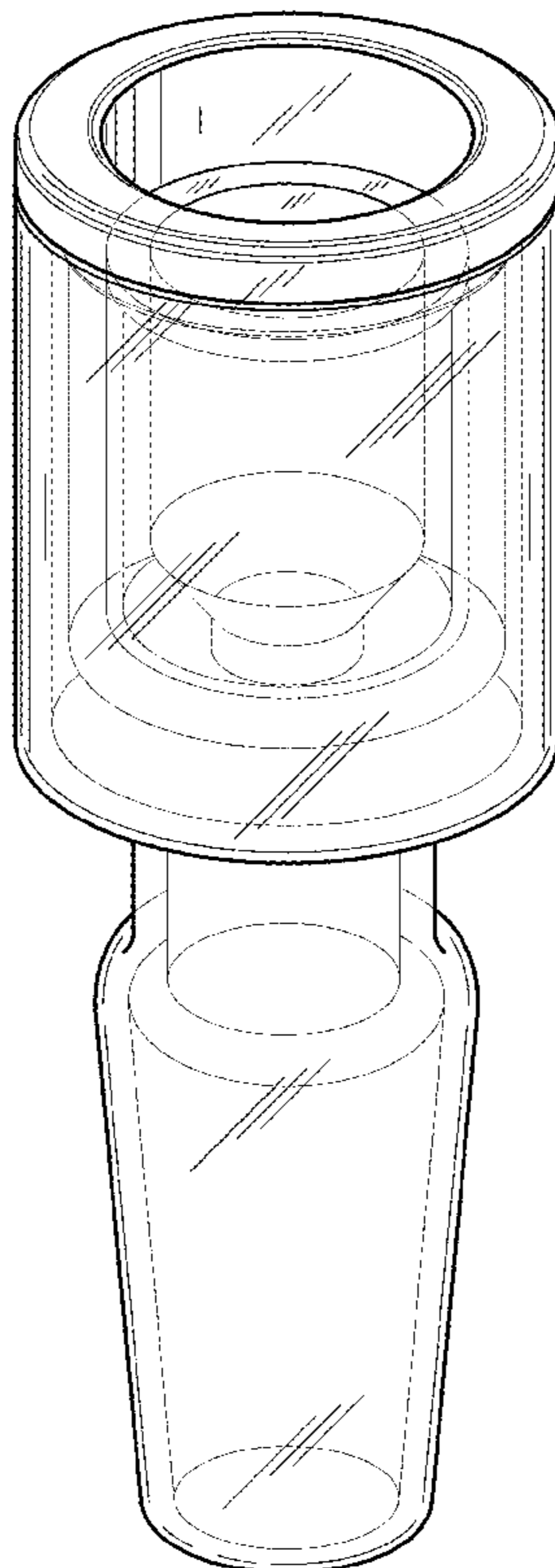

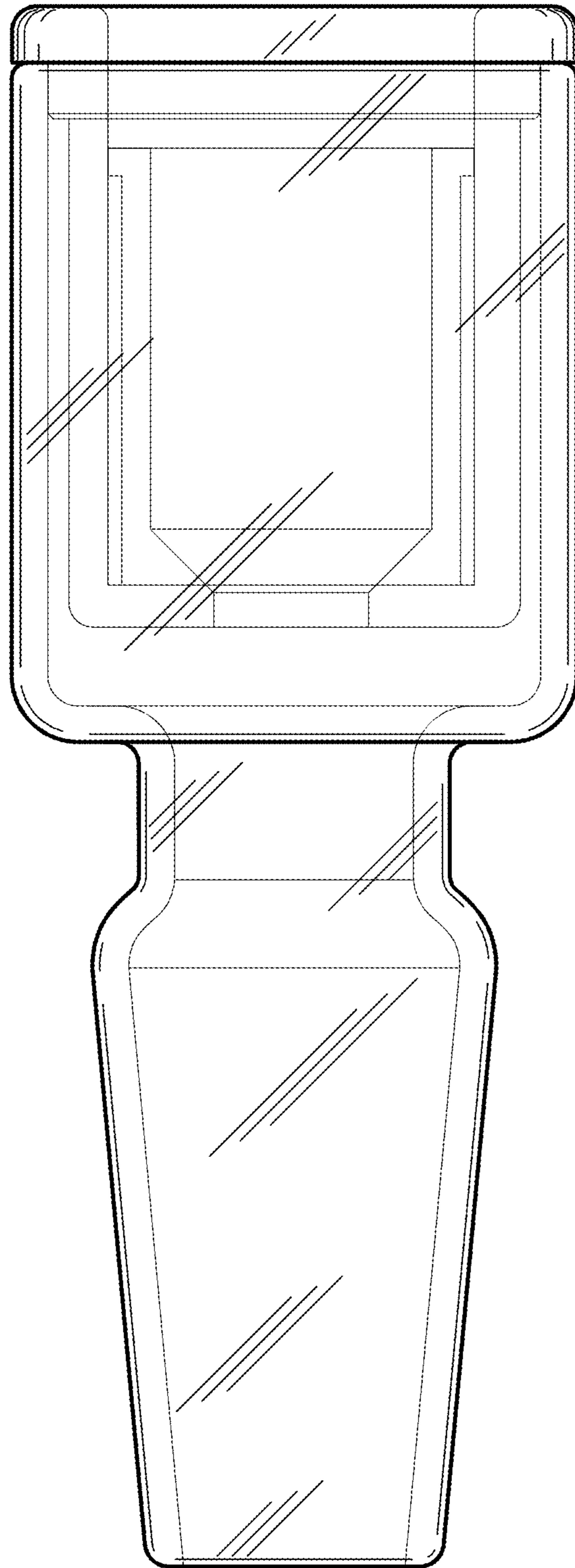
The ornamental design for a heating cup for an electronic cigarette, as shown and described.

**DESCRIPTION**

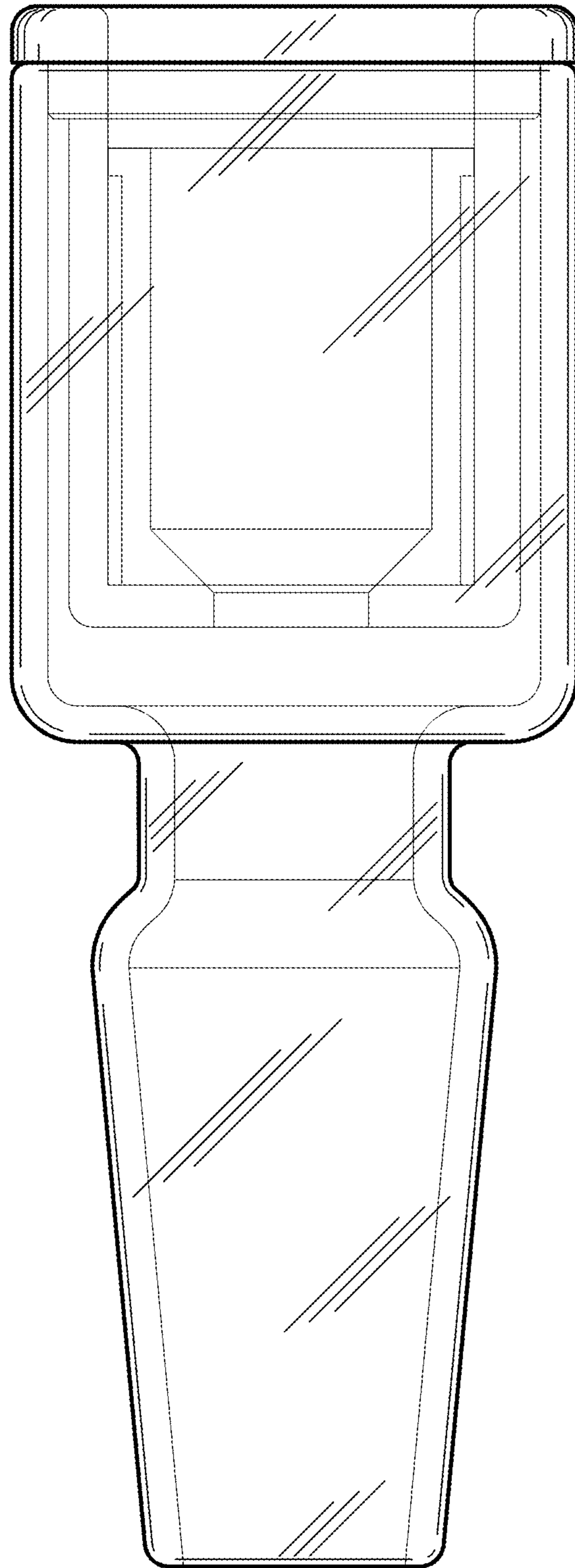
FIG. 1 is a front elevation view of a heating cup for an electronic cigarette, showing my new design;

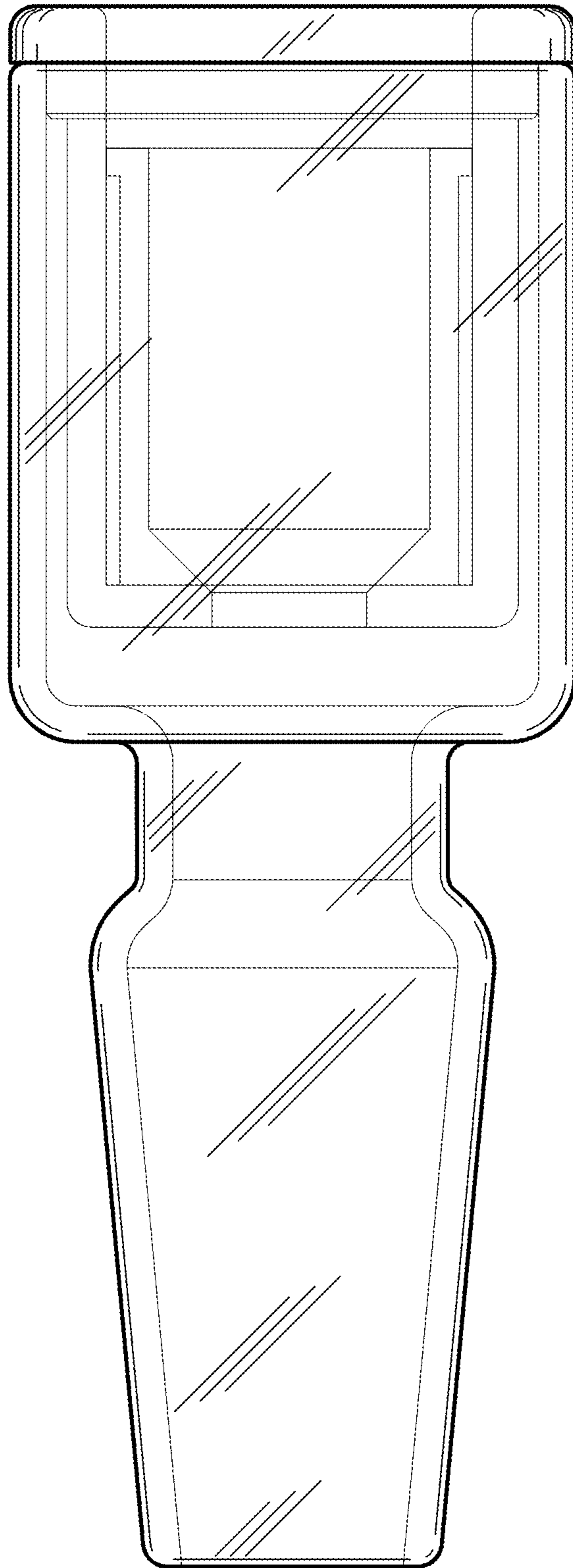




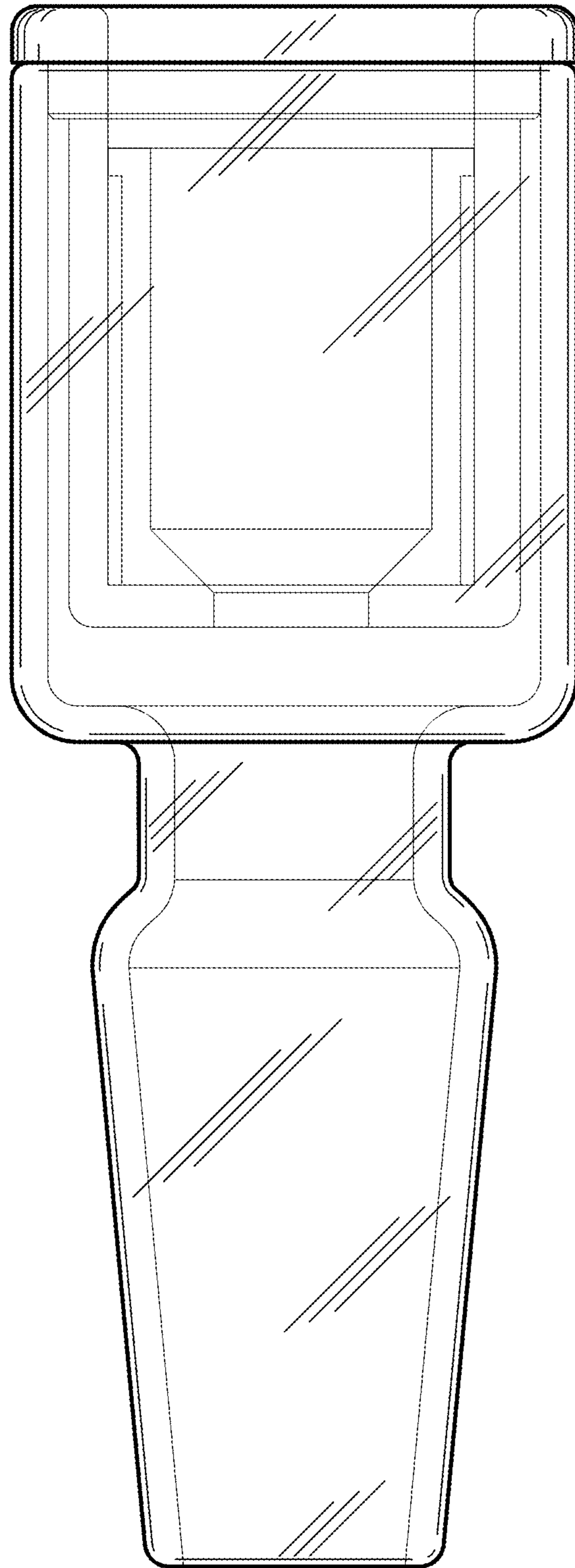

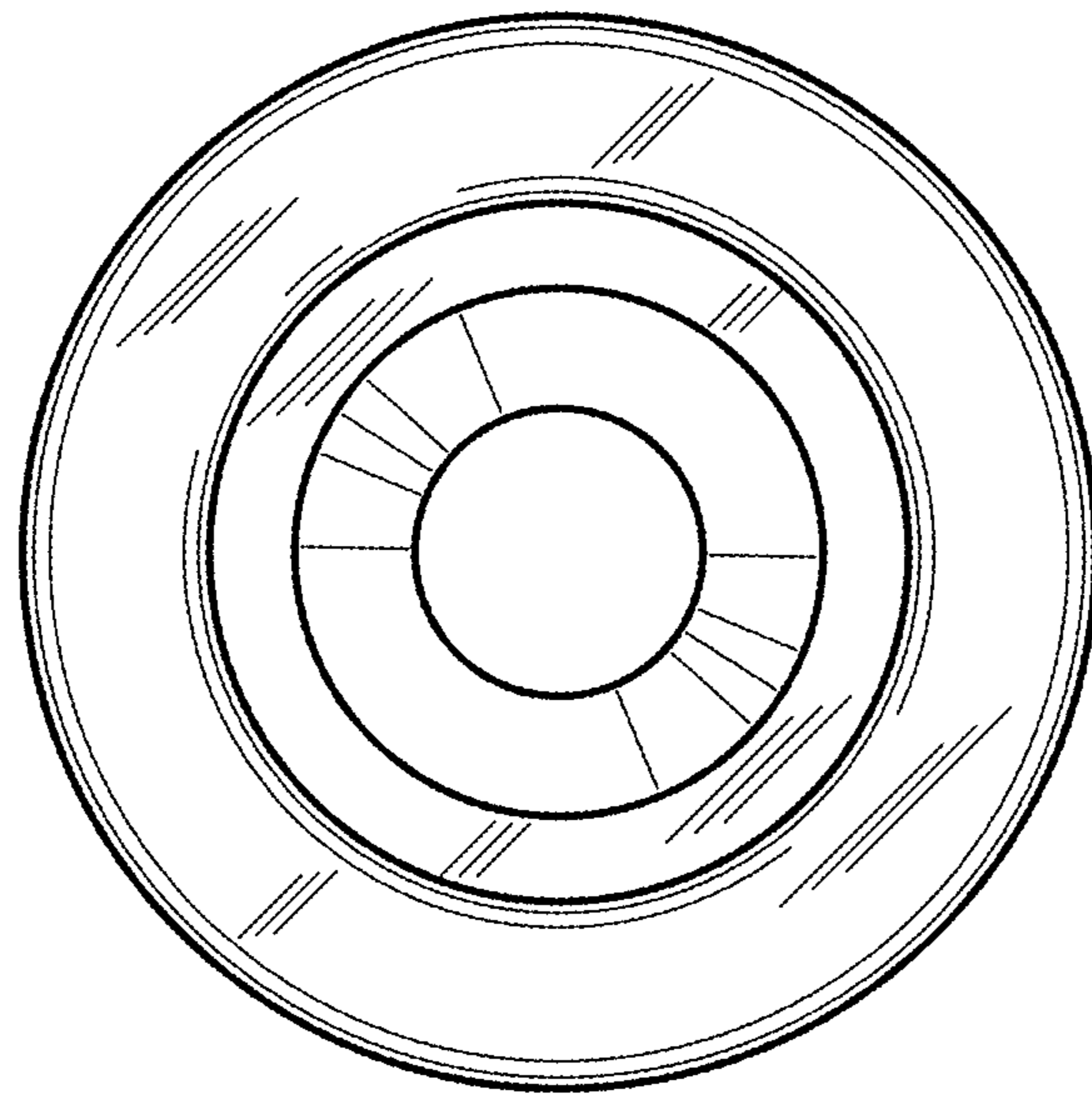

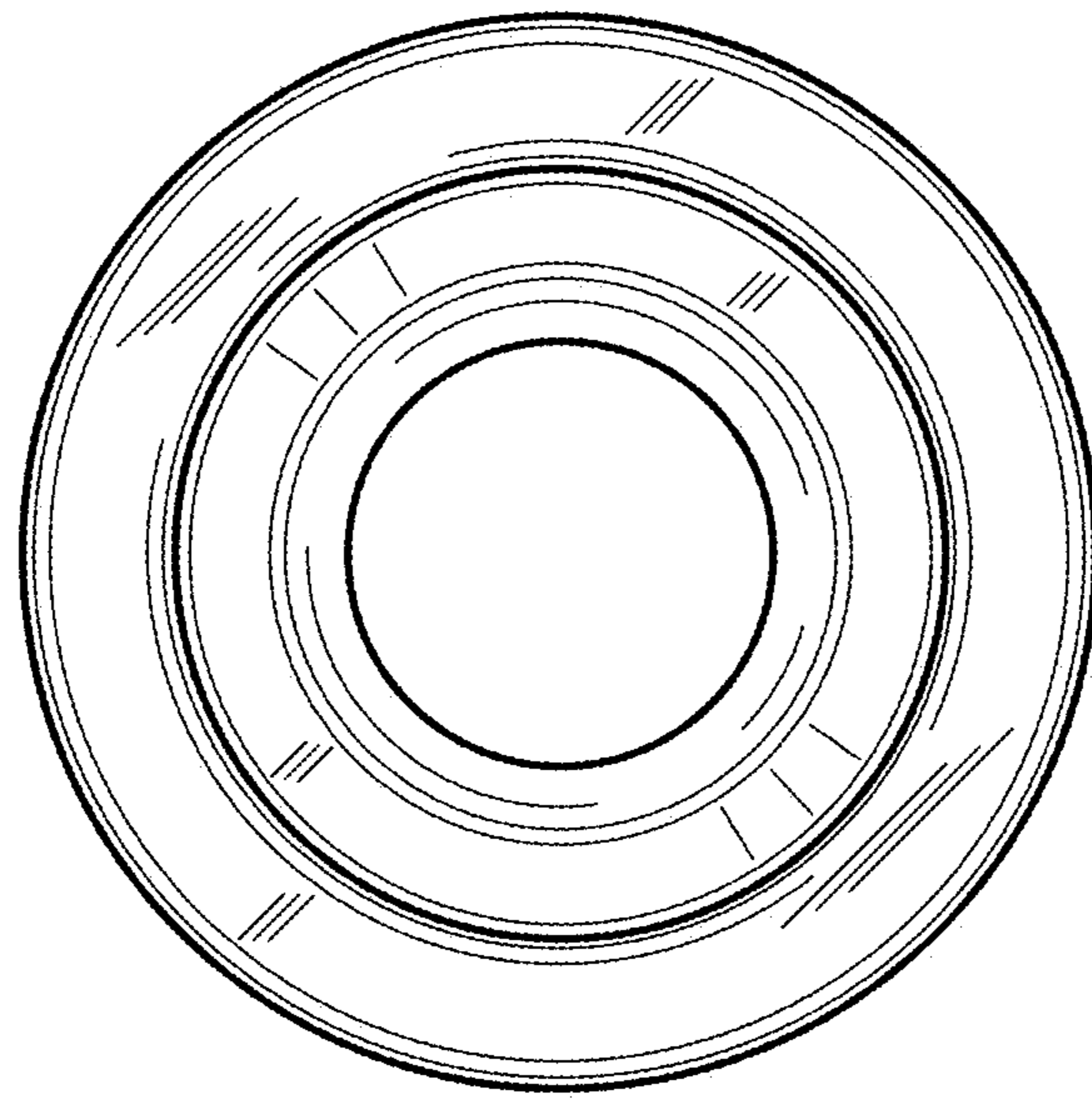

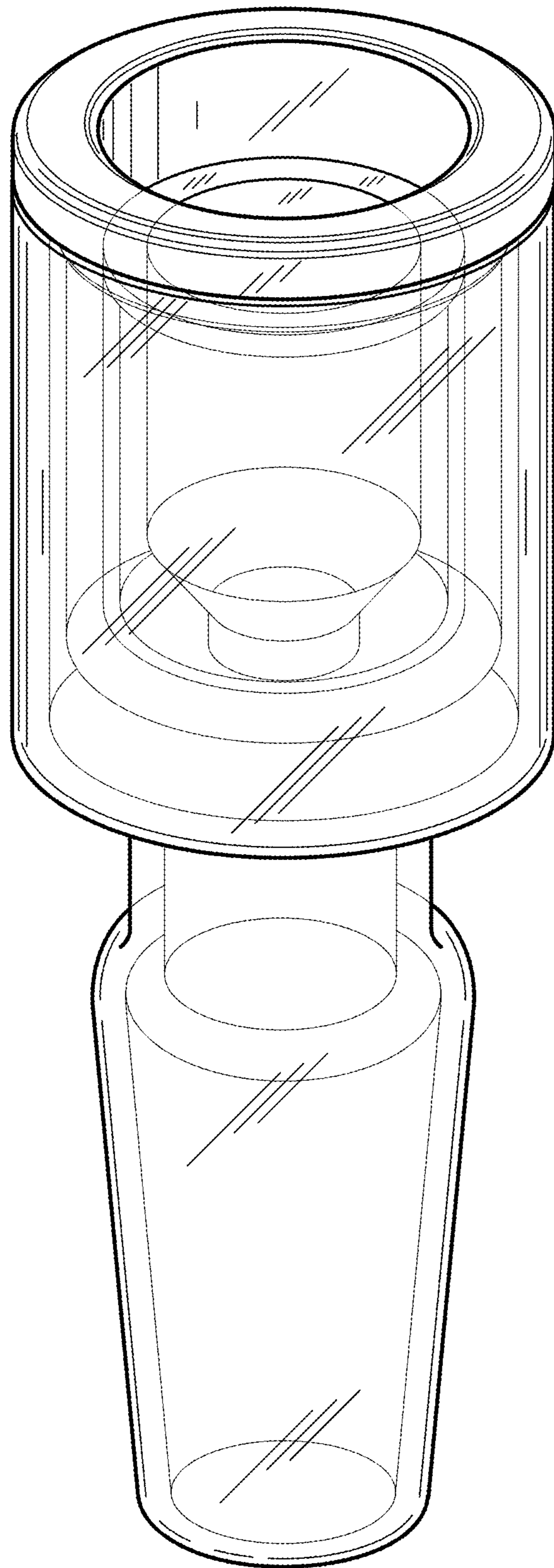
