The portions of the hearing protector in FIGS. 1-5 shown in broken lines are included to show features that form no part of the claimed design.

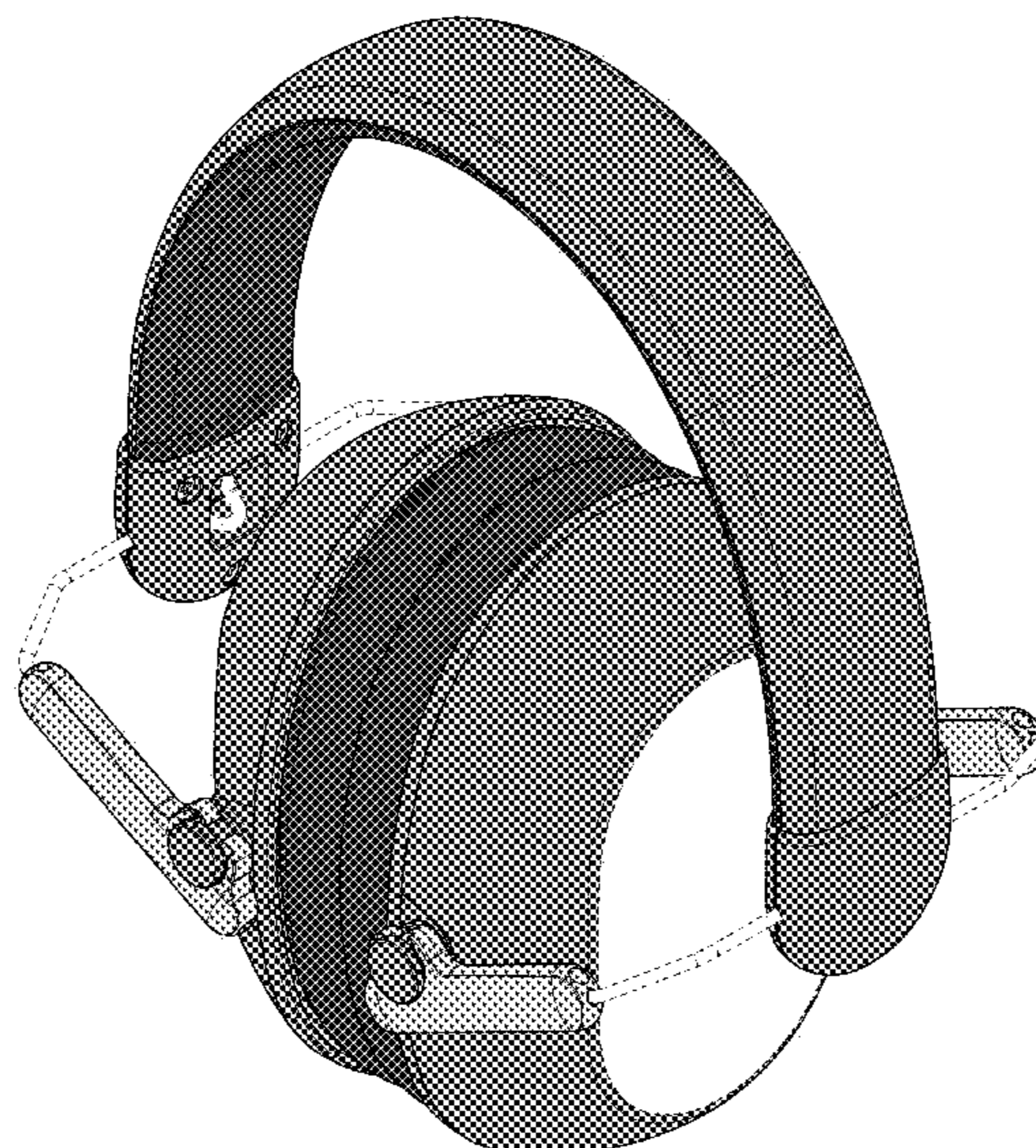

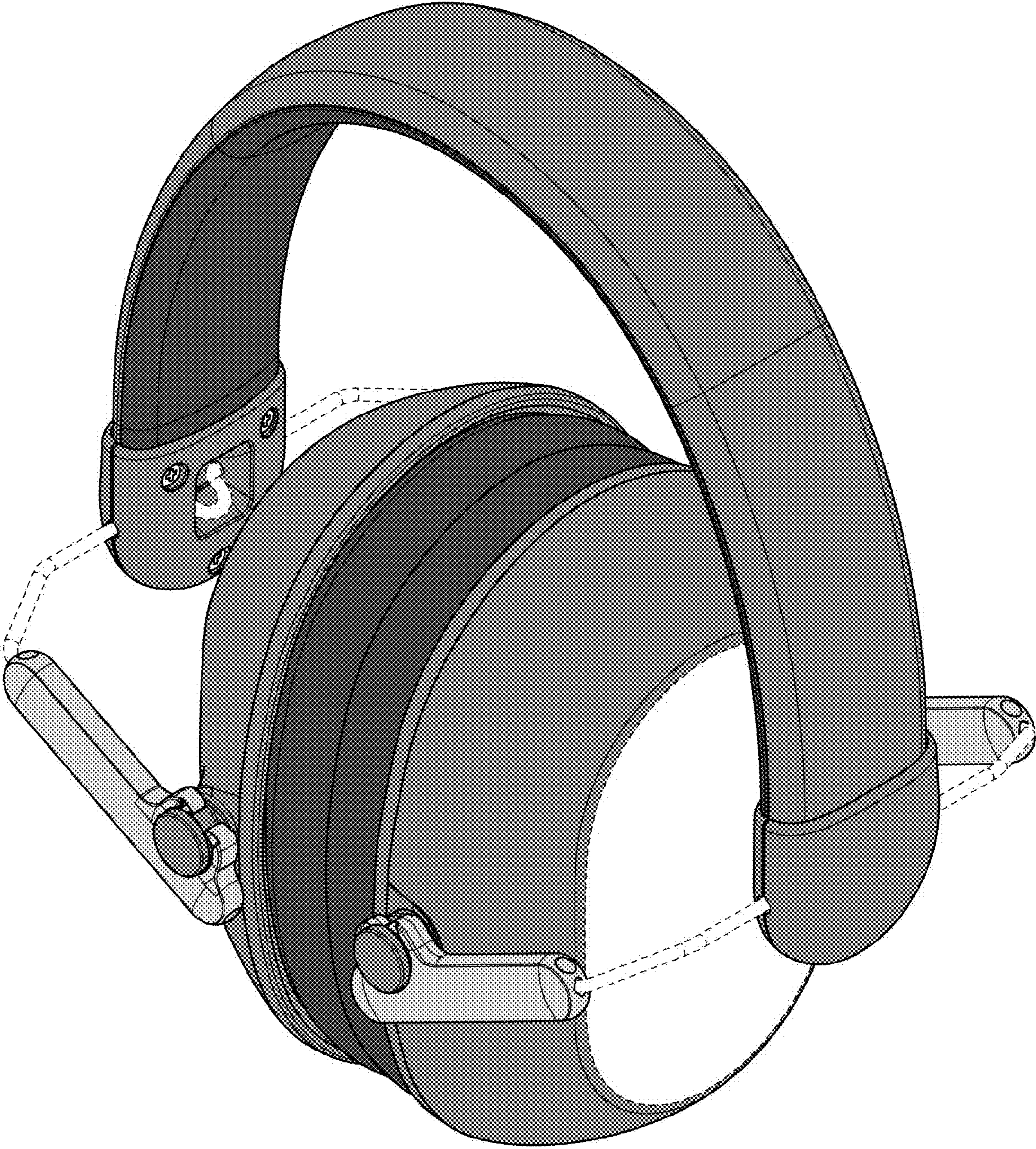

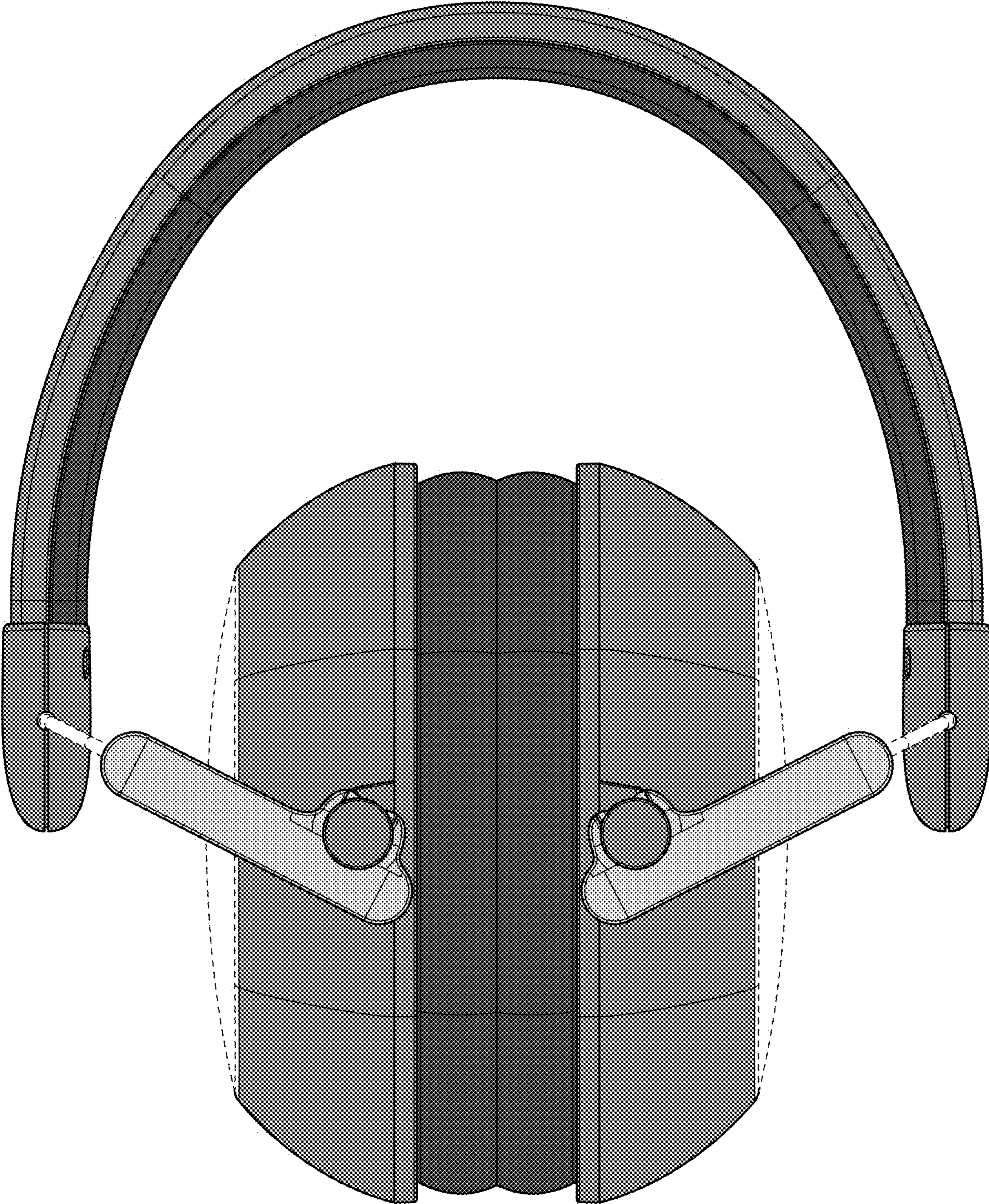

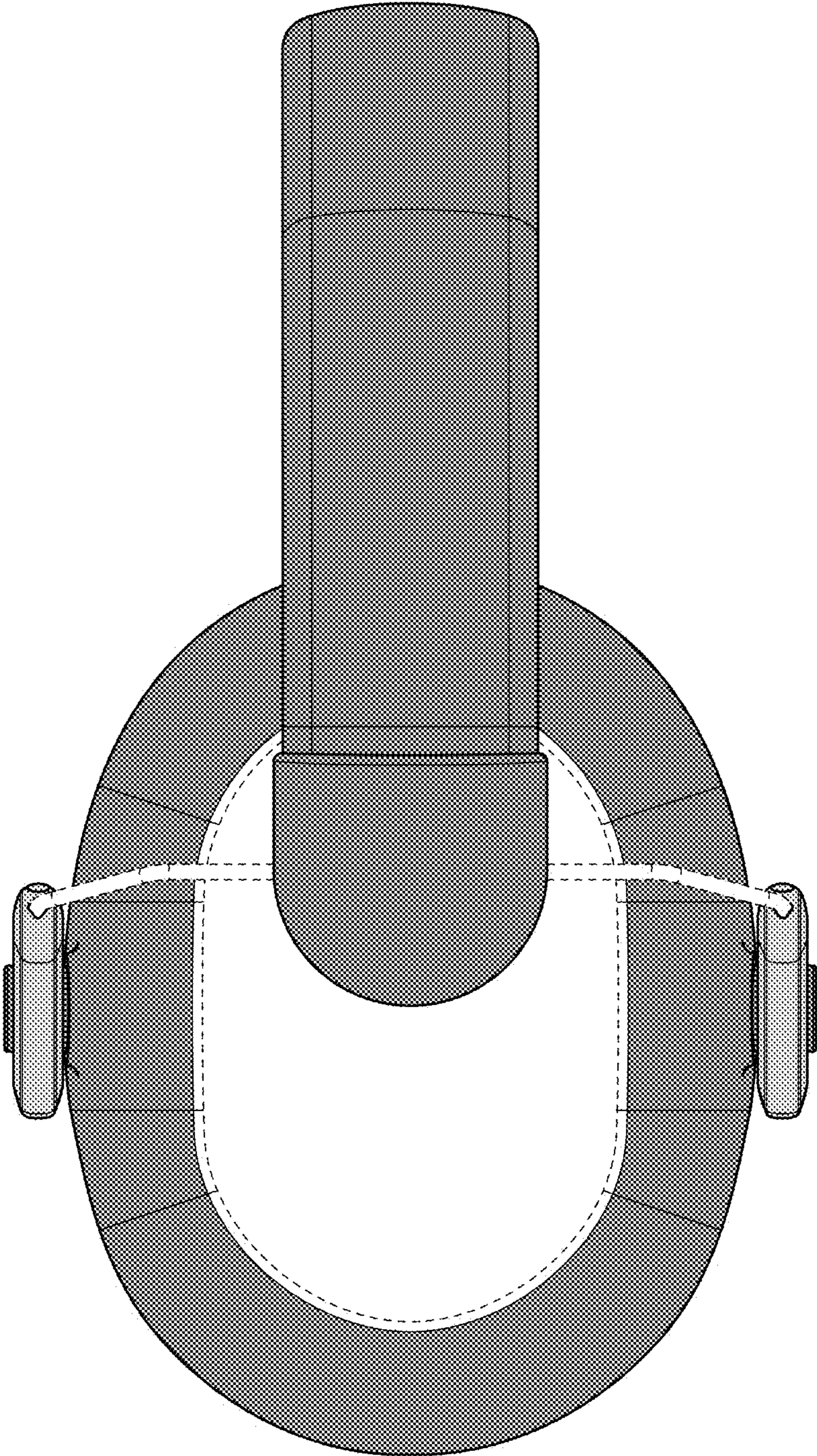

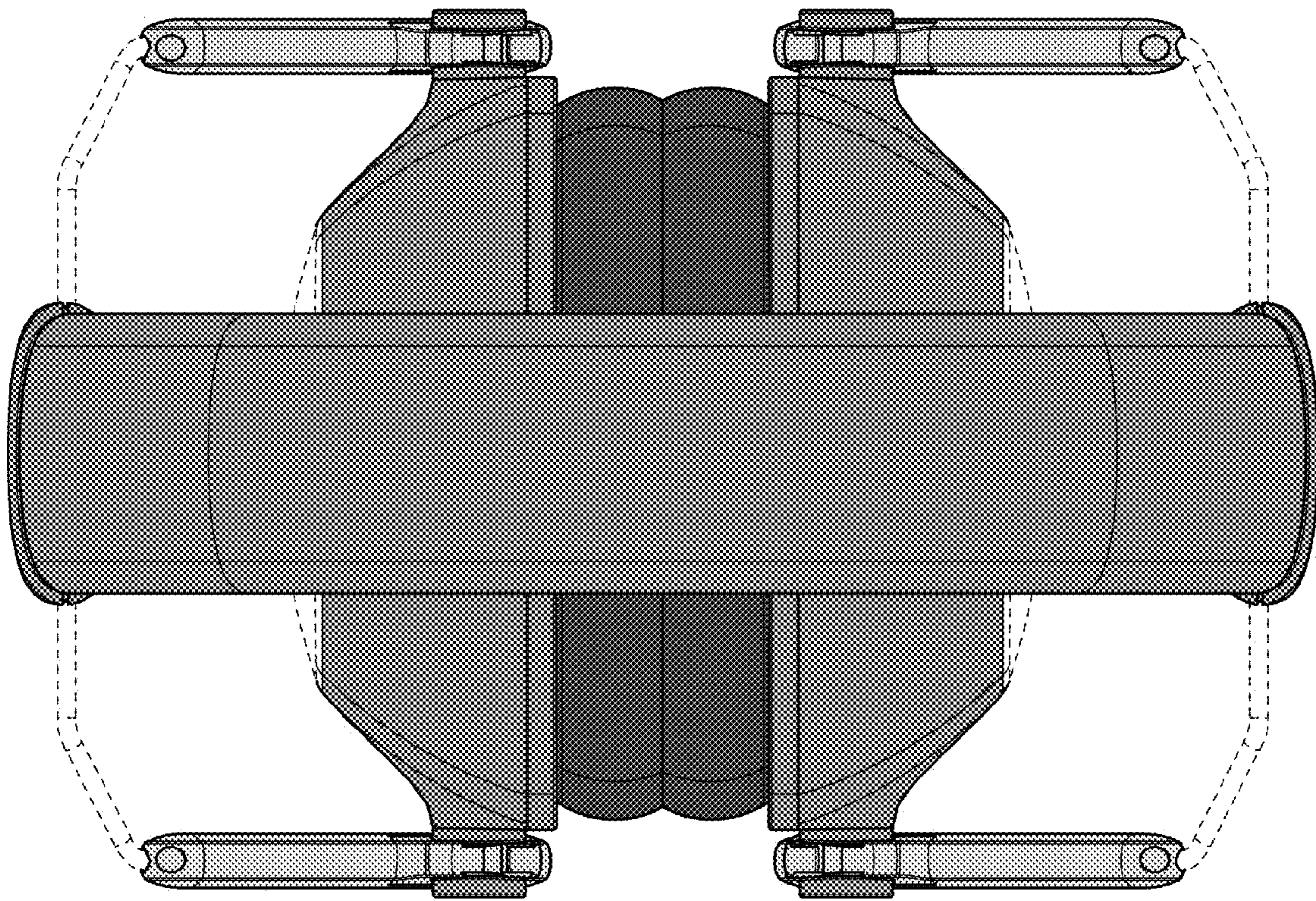

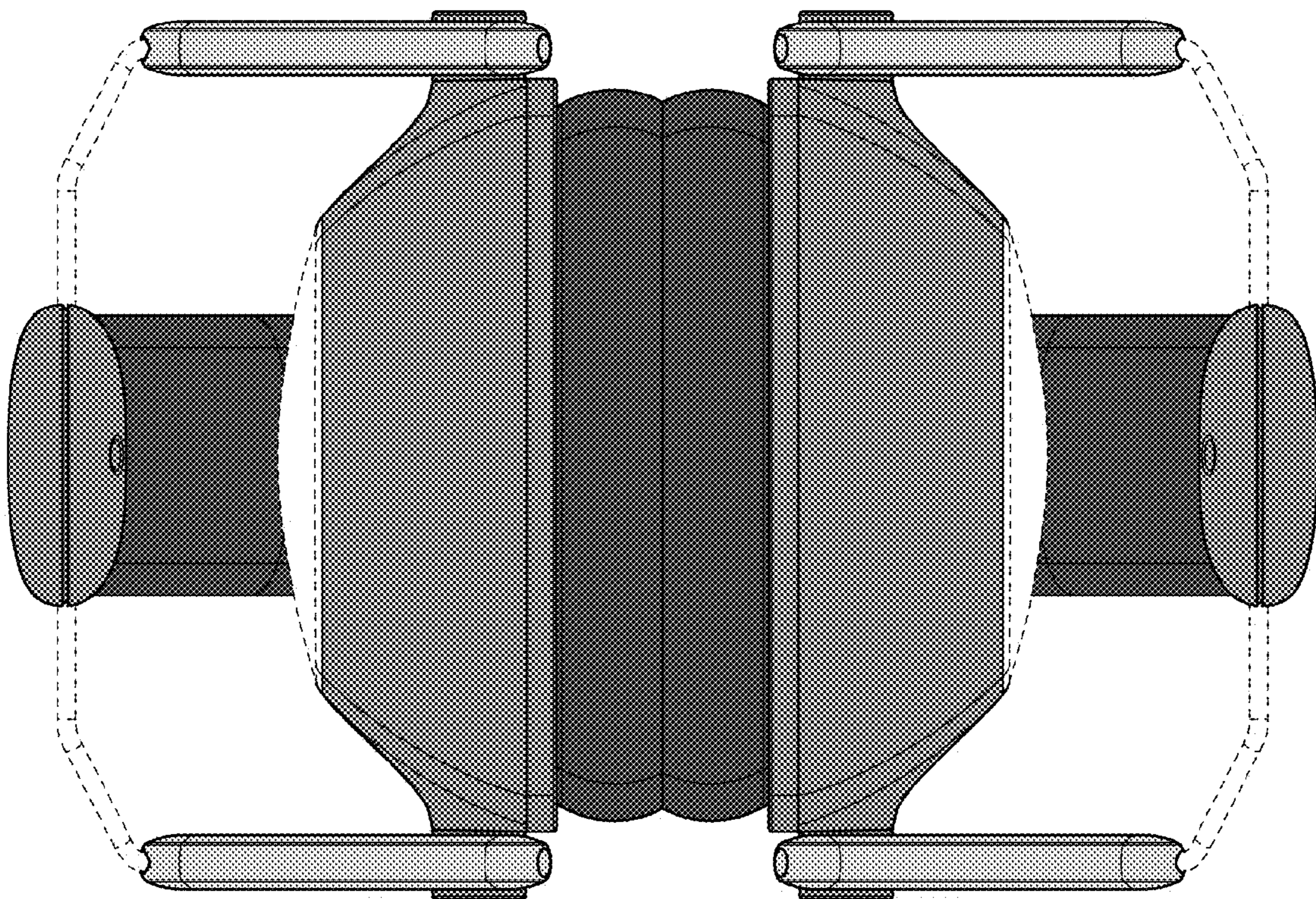
