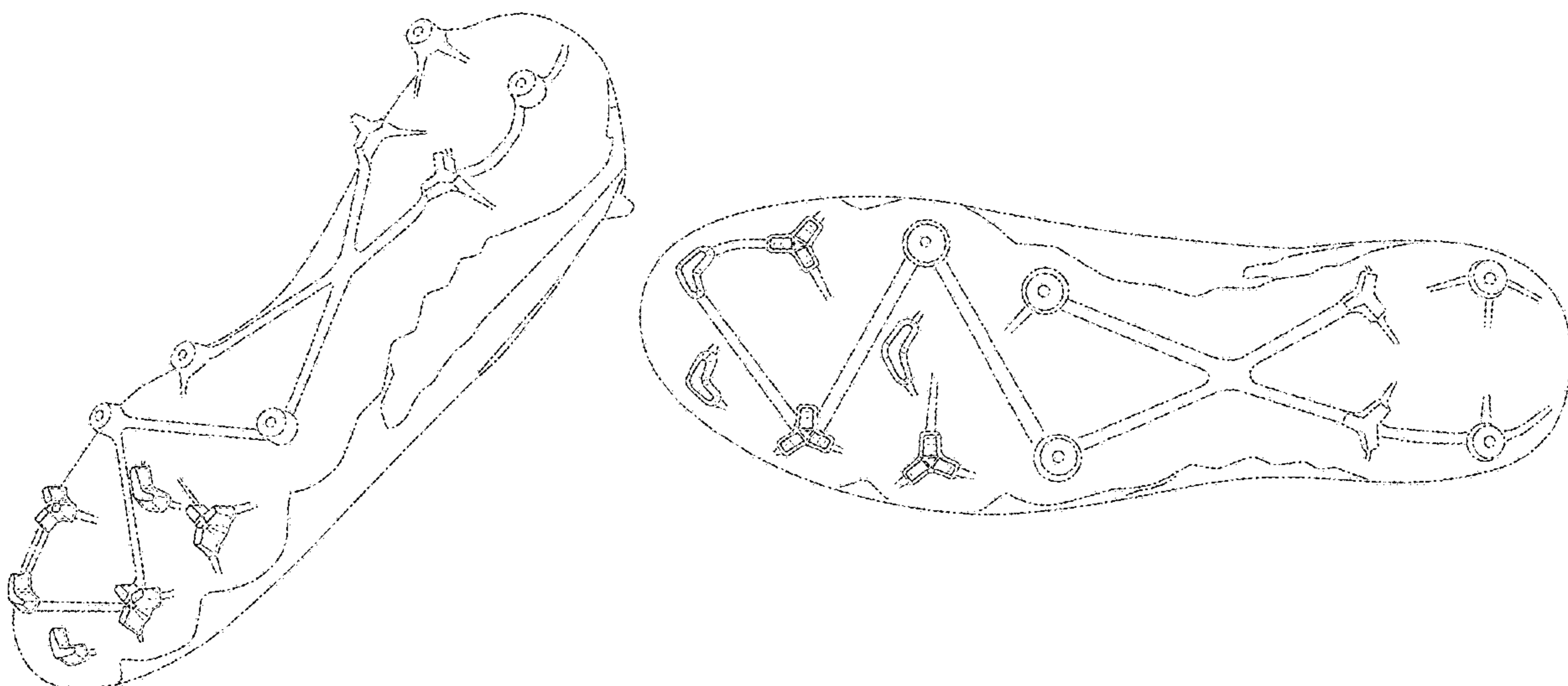
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a bottom front perspective view of a shoe showing my new design;
FIG. 2 is a bottom view thereof; and,
FIG. 3 is a bottom rear perspective view thereof.
The broken lines immediately adjacent to the shaded areas define the bounds of the claimed design and form no part thereof. The broken lines and unshaded regions in the central region of the three arrow-shaped cleats form no part of the claimed design. The broken lines depicting the remainder of the shoe form no part of the claimed design.

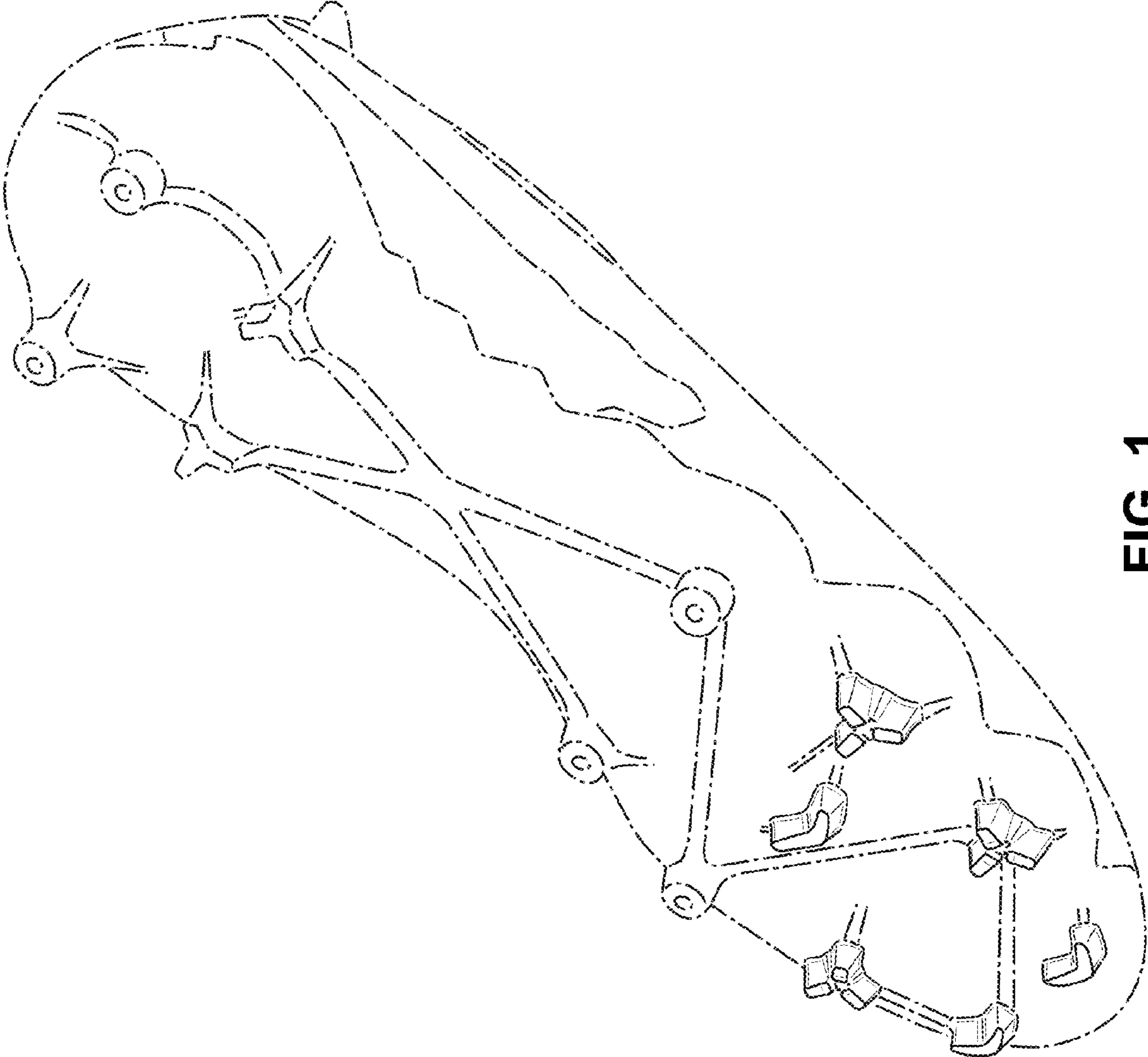

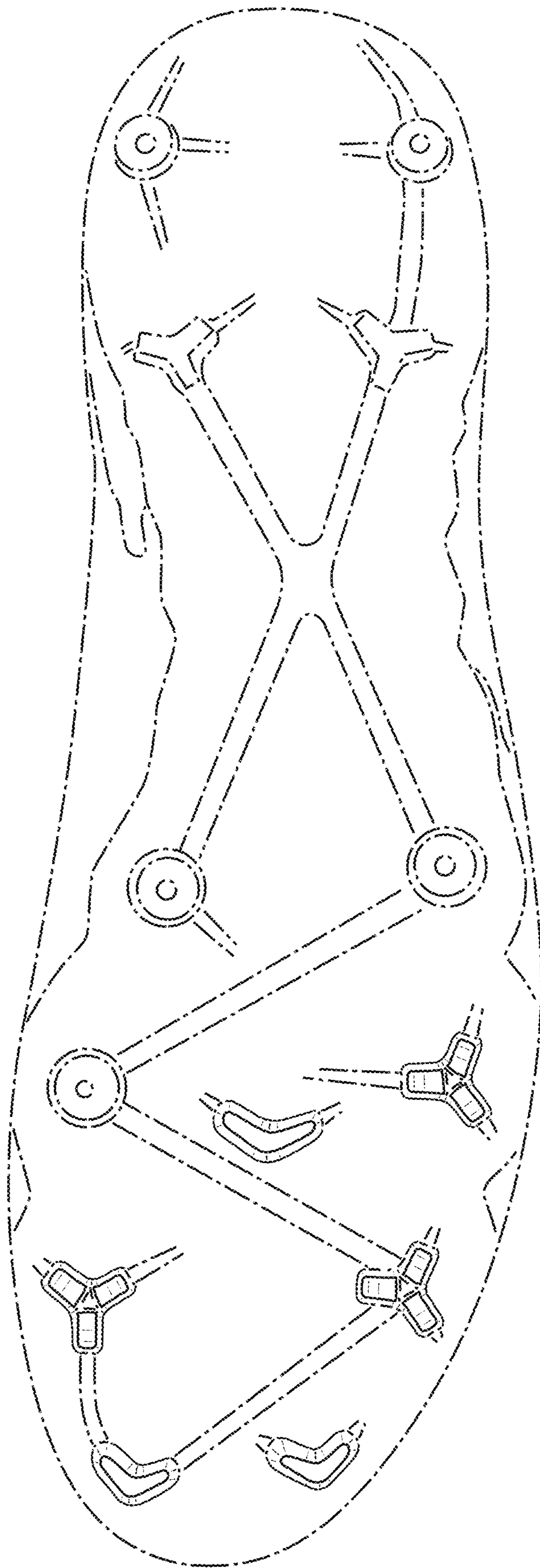

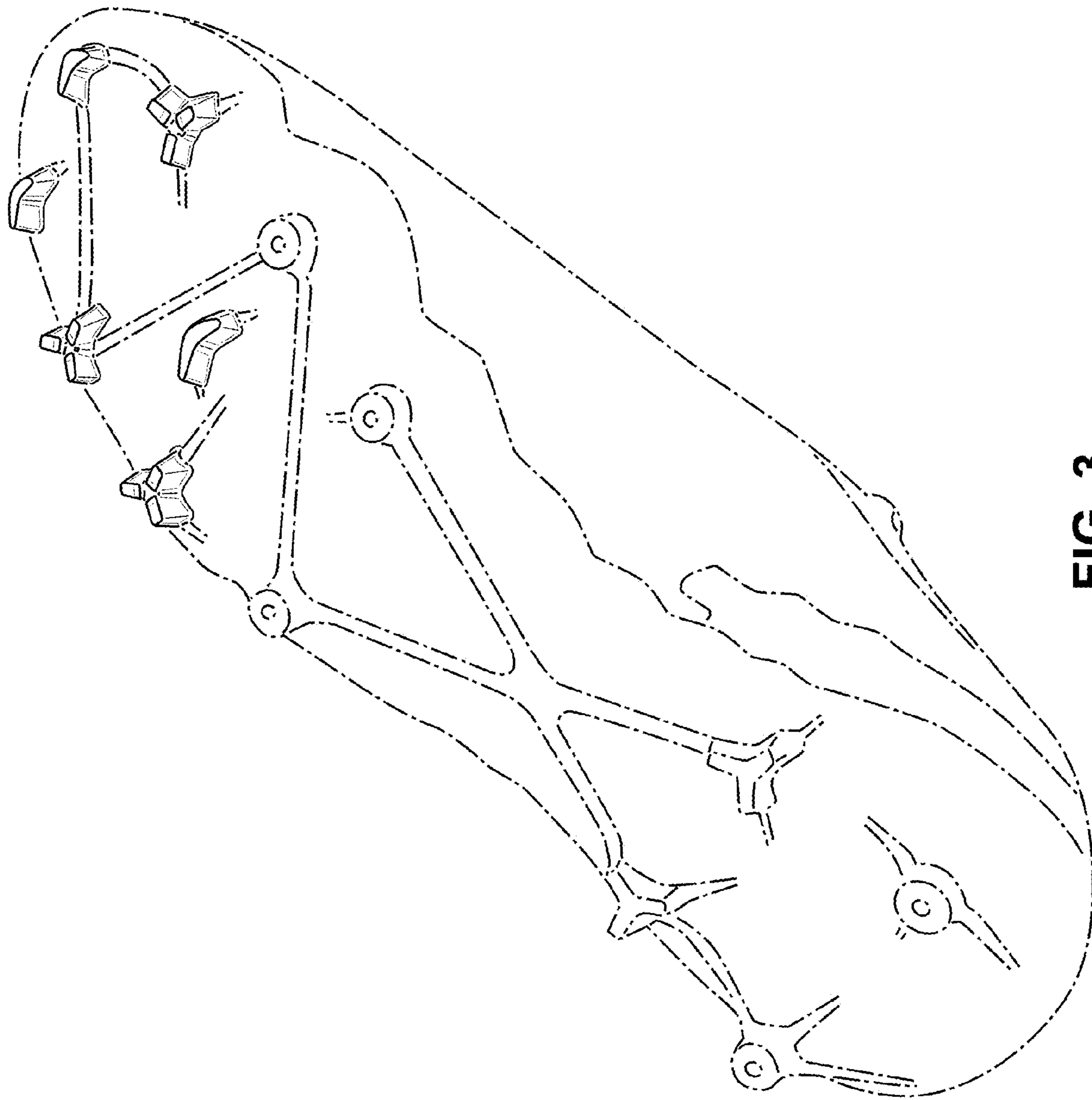
