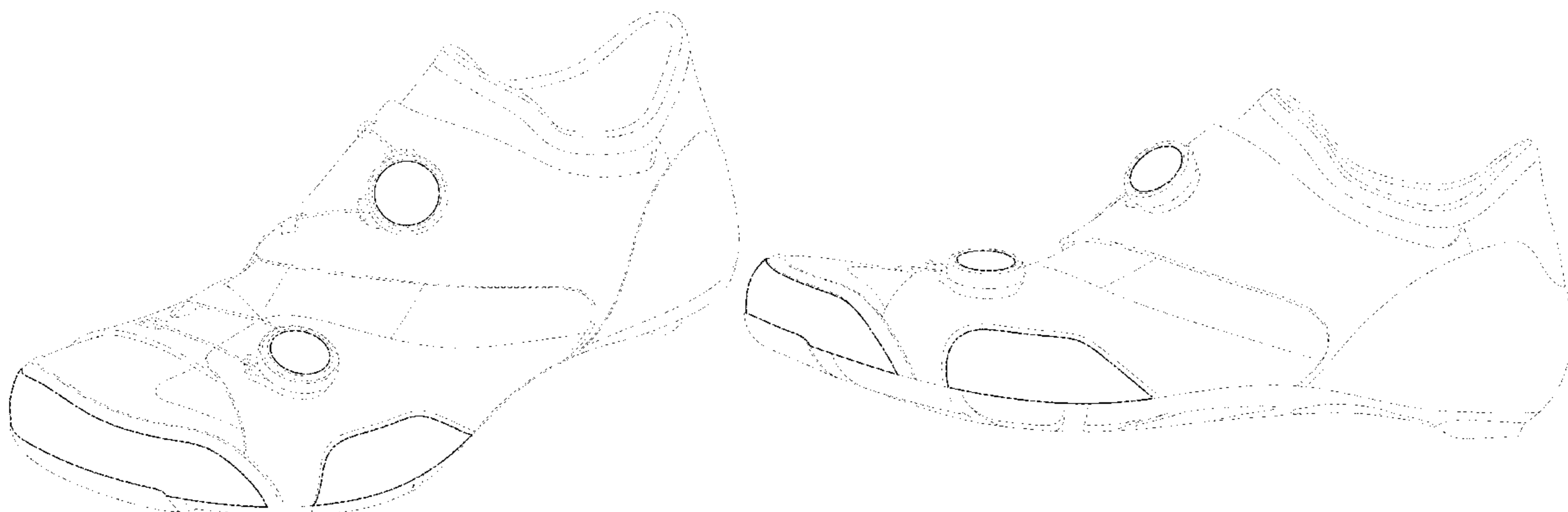
(57) **CLAIM**

The ornamental design for a bicycle shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a bicycle shoe embodying the design.  
FIG. 2 is a right side view of the design shown in FIG. 1.  
FIG. 3 is a left side view of the design shown in FIG. 1.  
FIG. 4 is a front view of the design shown in FIG. 1.  
FIG. 5 is a rear view of the design shown in FIG. 1.  
FIG. 6 is top view of the design shown in FIG. 1; and,  
FIG. 7 is a bottom view of the design shown in FIG. 1.  
The portions of the bicycle shoe shown in broken lines form no part of the claimed design.

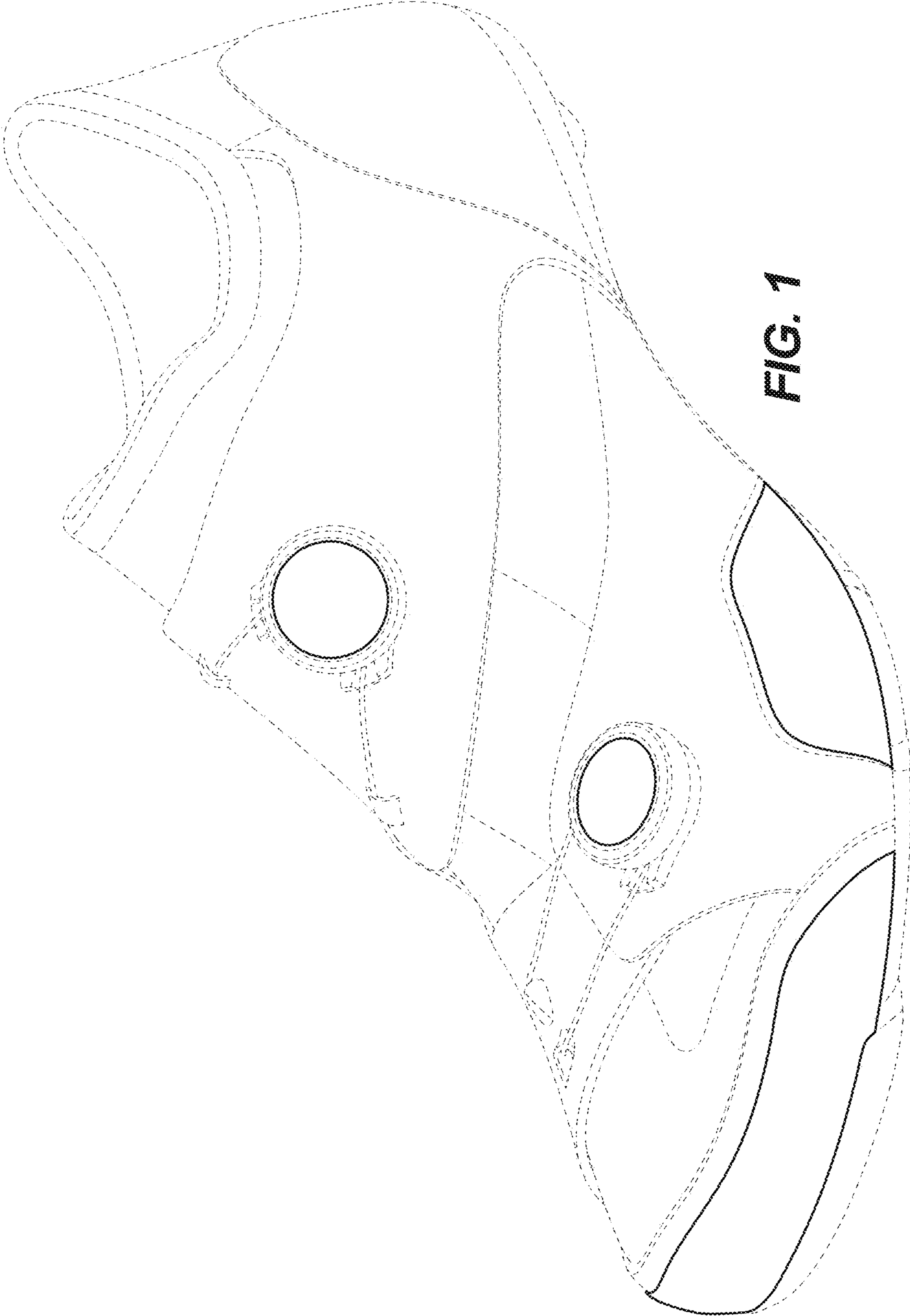

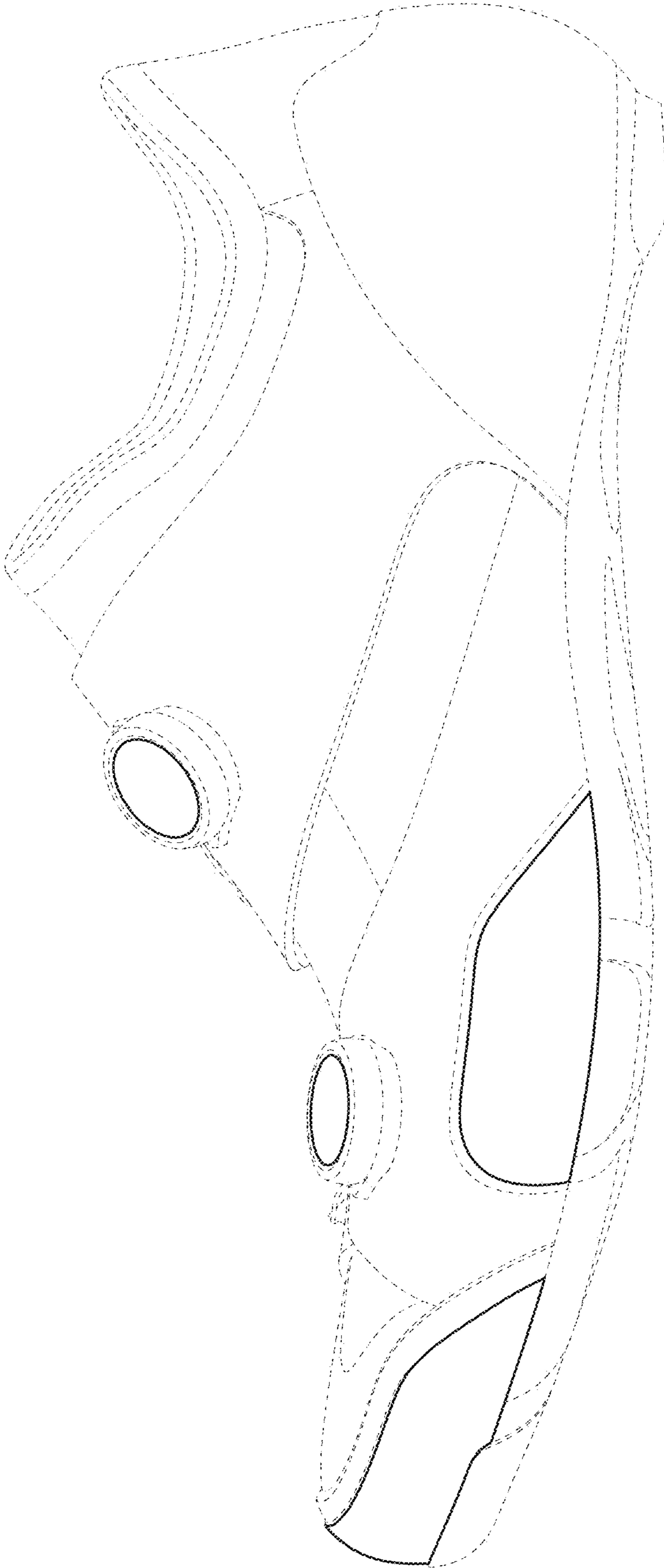

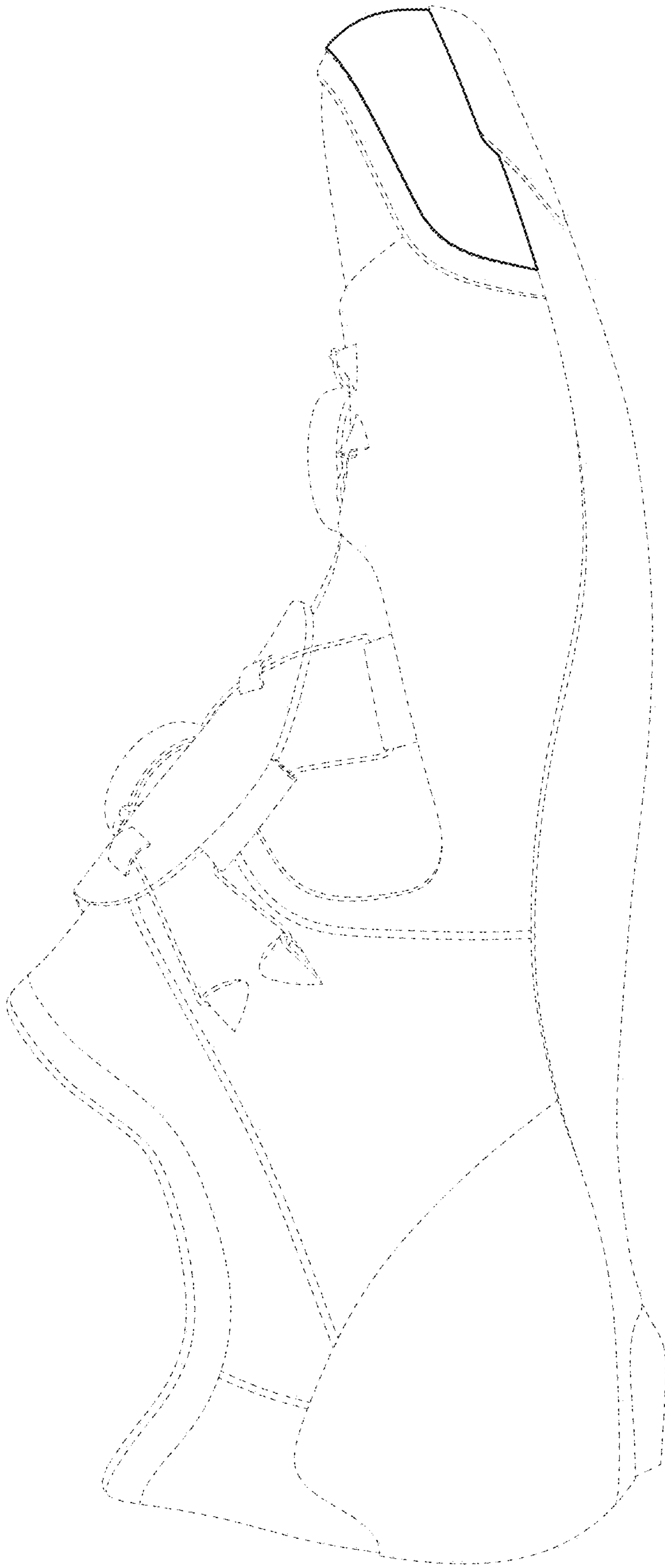
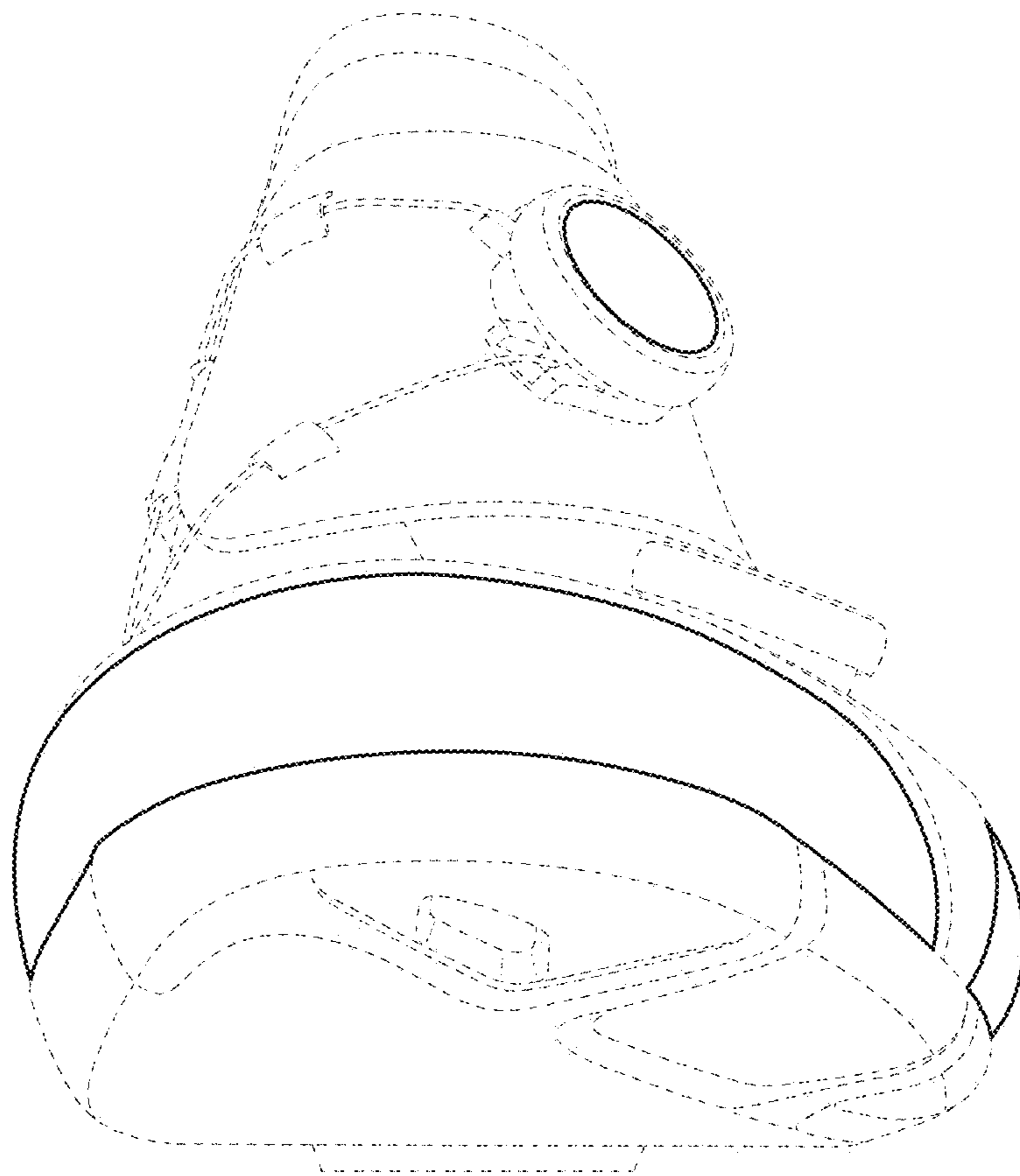
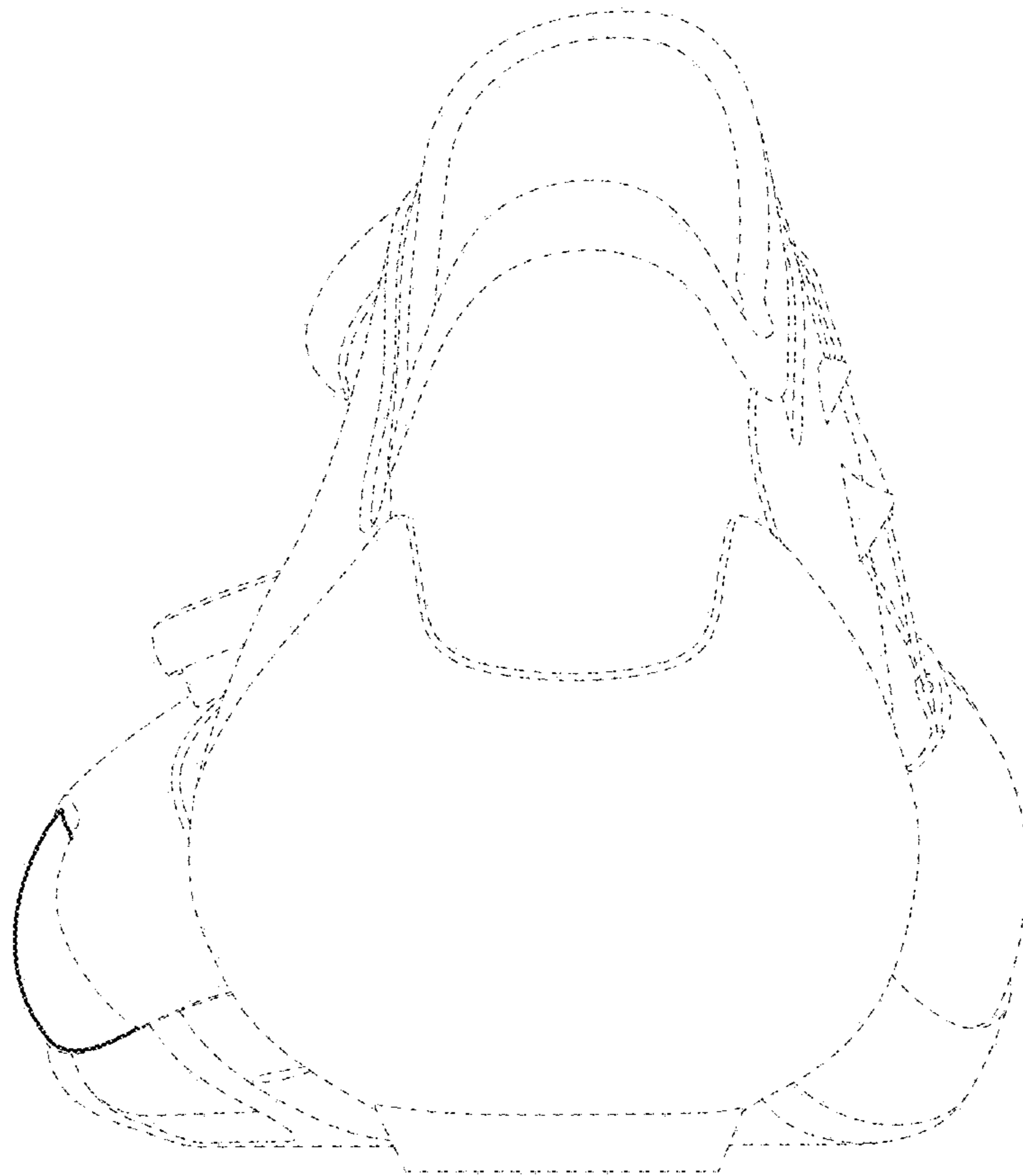

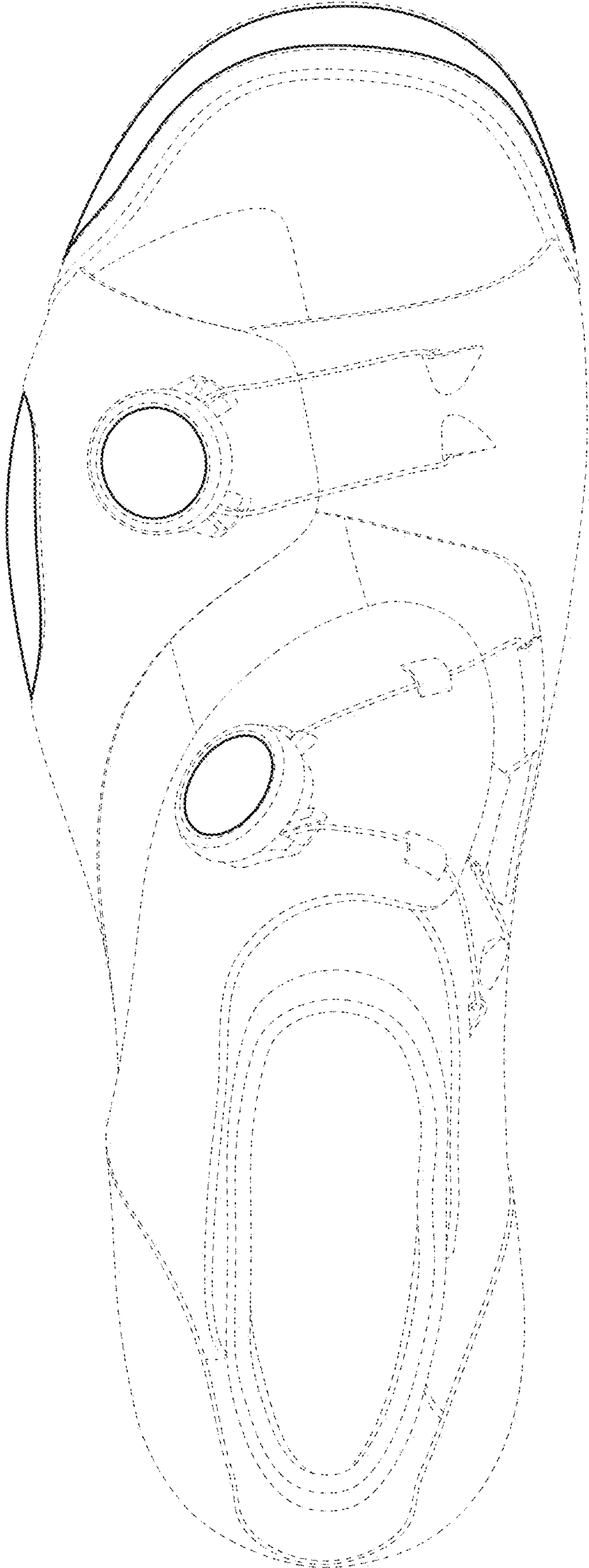

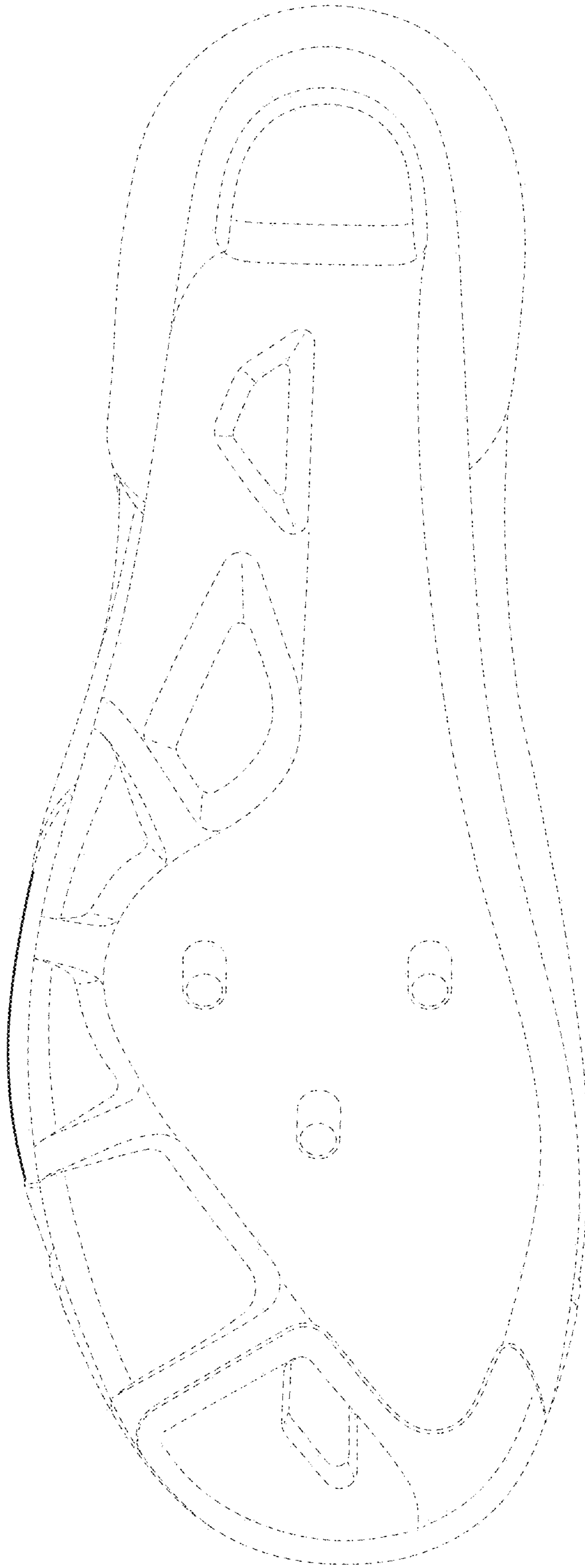
