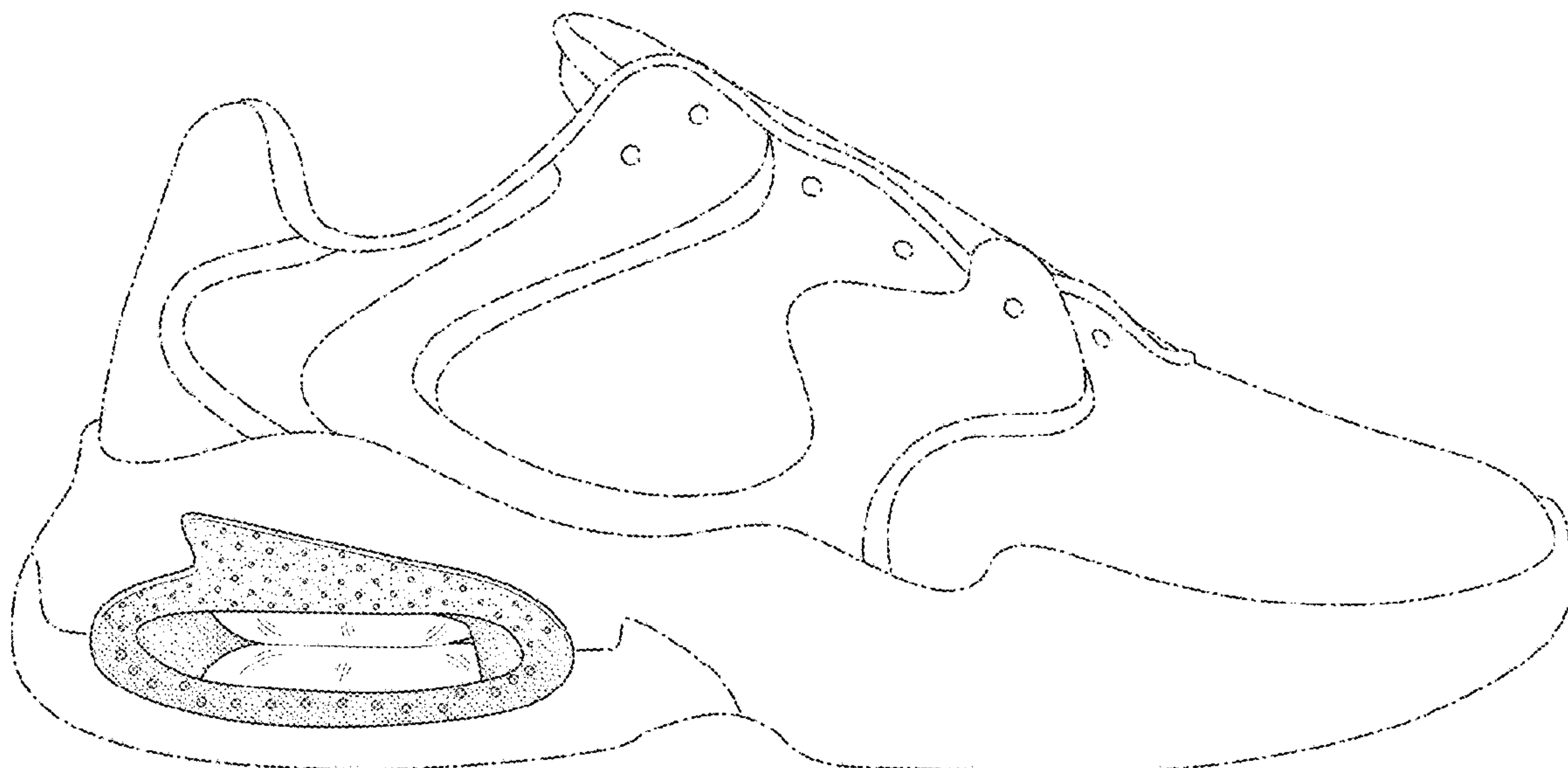
CLAIM

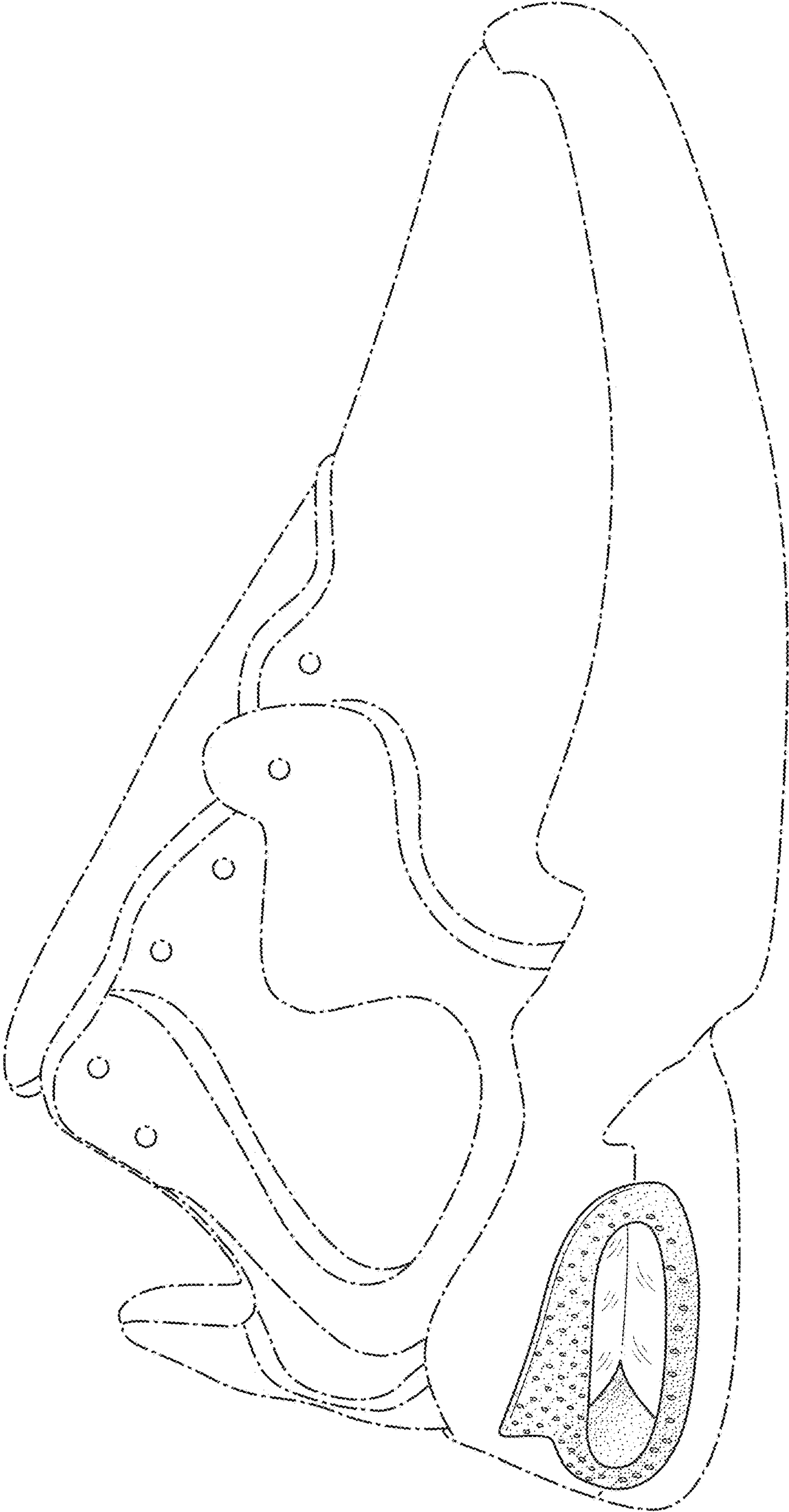

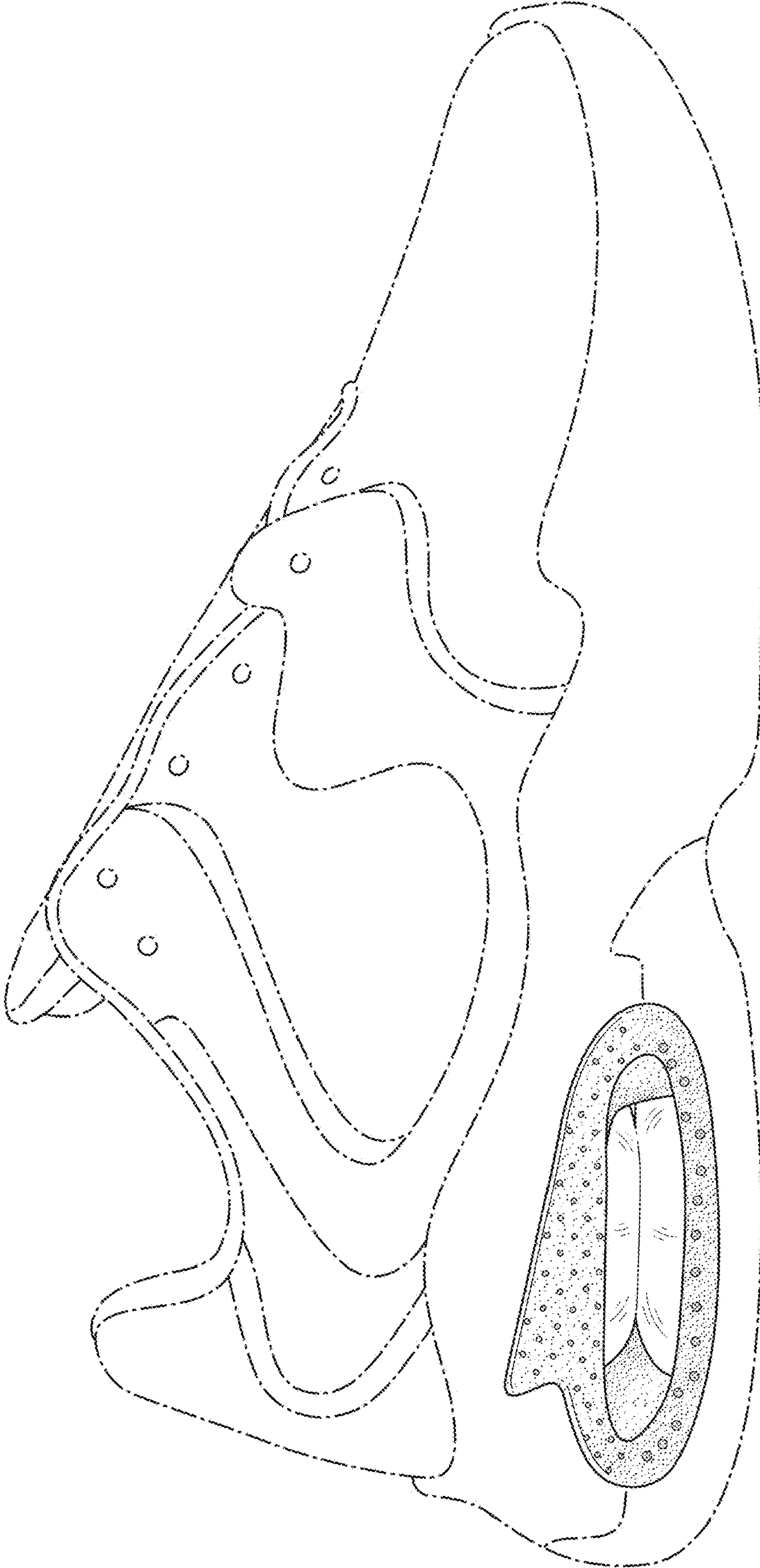

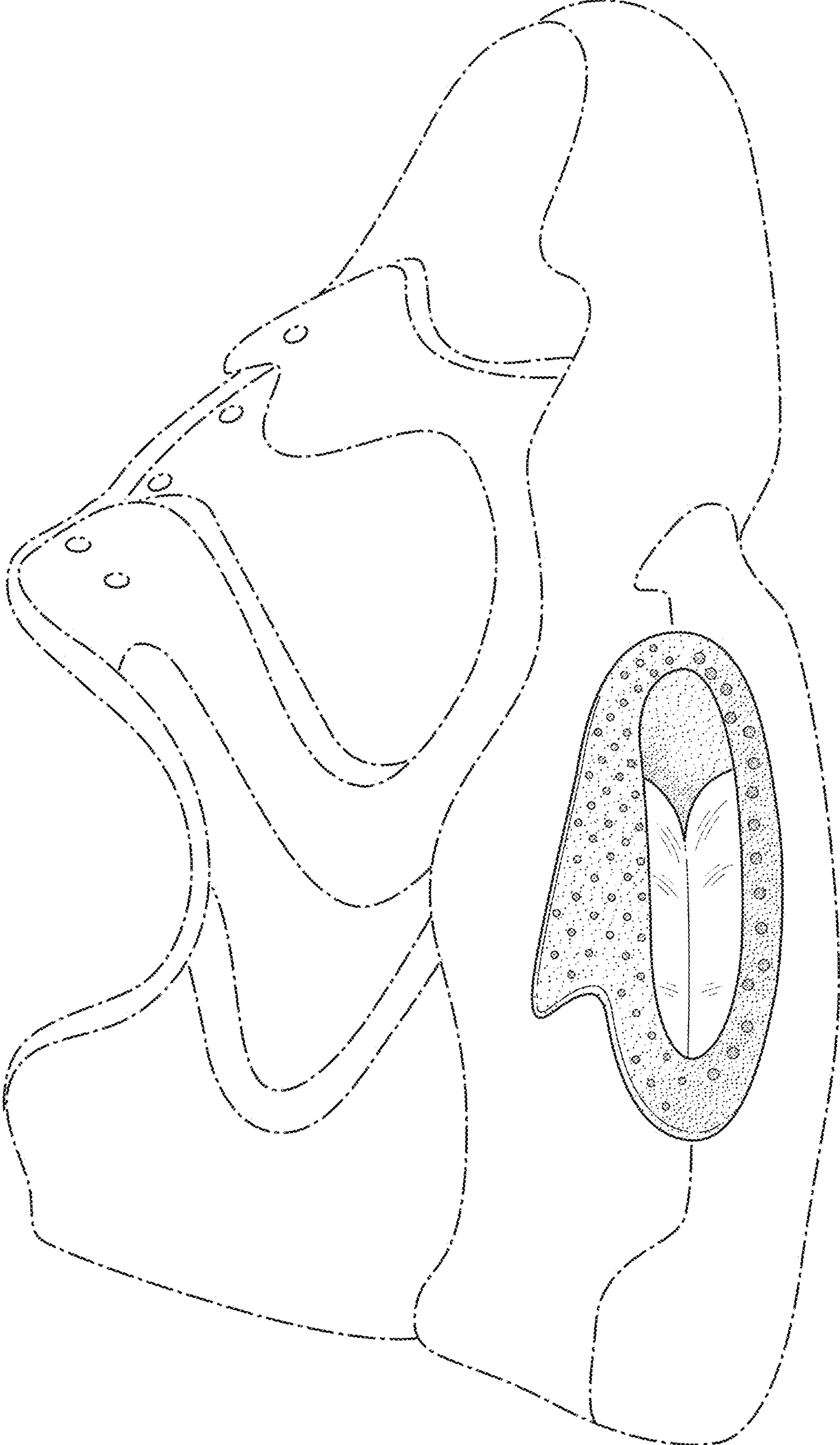
