The ornamental design for a multi-pocket holder, as shown and described.

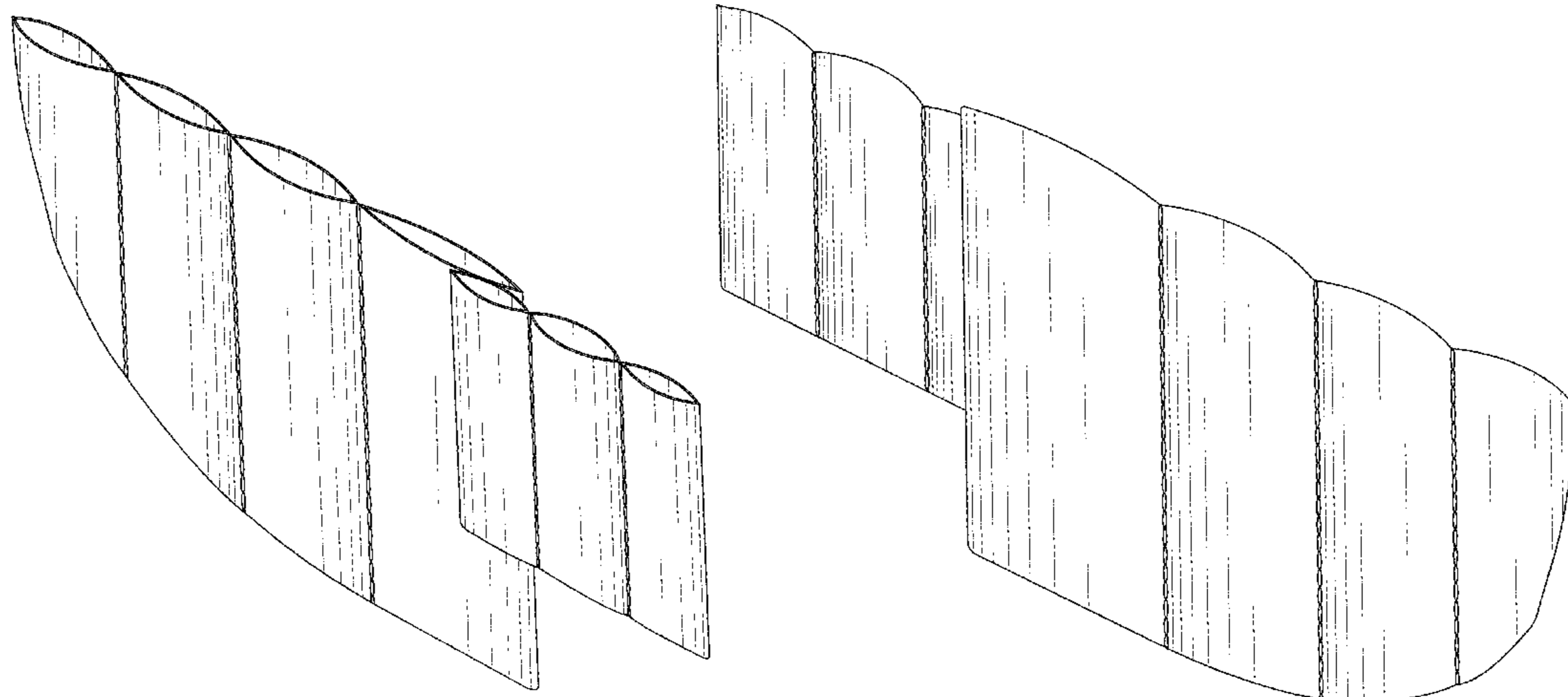
**DESCRIPTION**

FIG. 1 is a front top perspective view of a multi-pocket holder showing my new design;

FIG. 5 is a left side elevational view thereof;

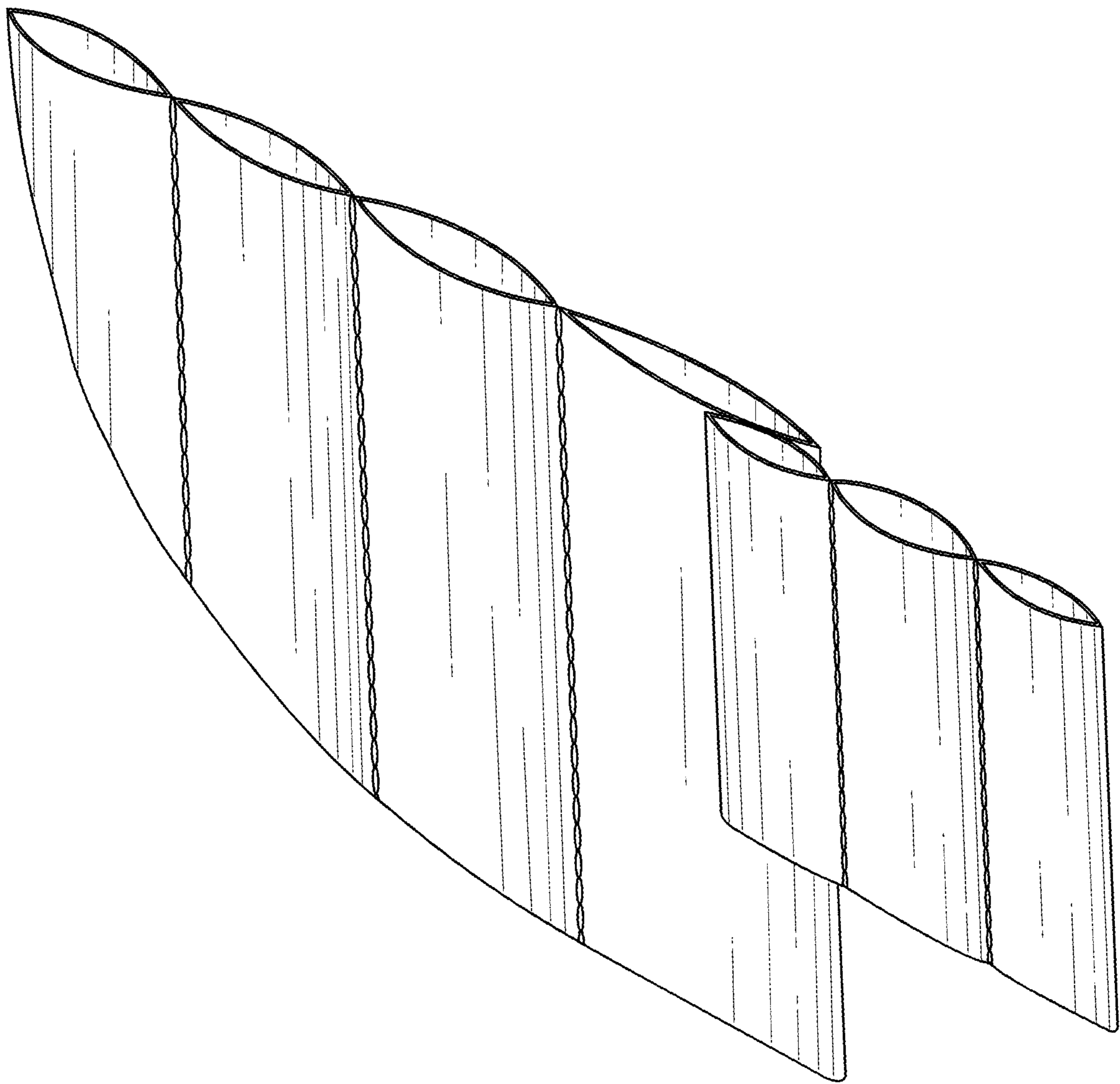

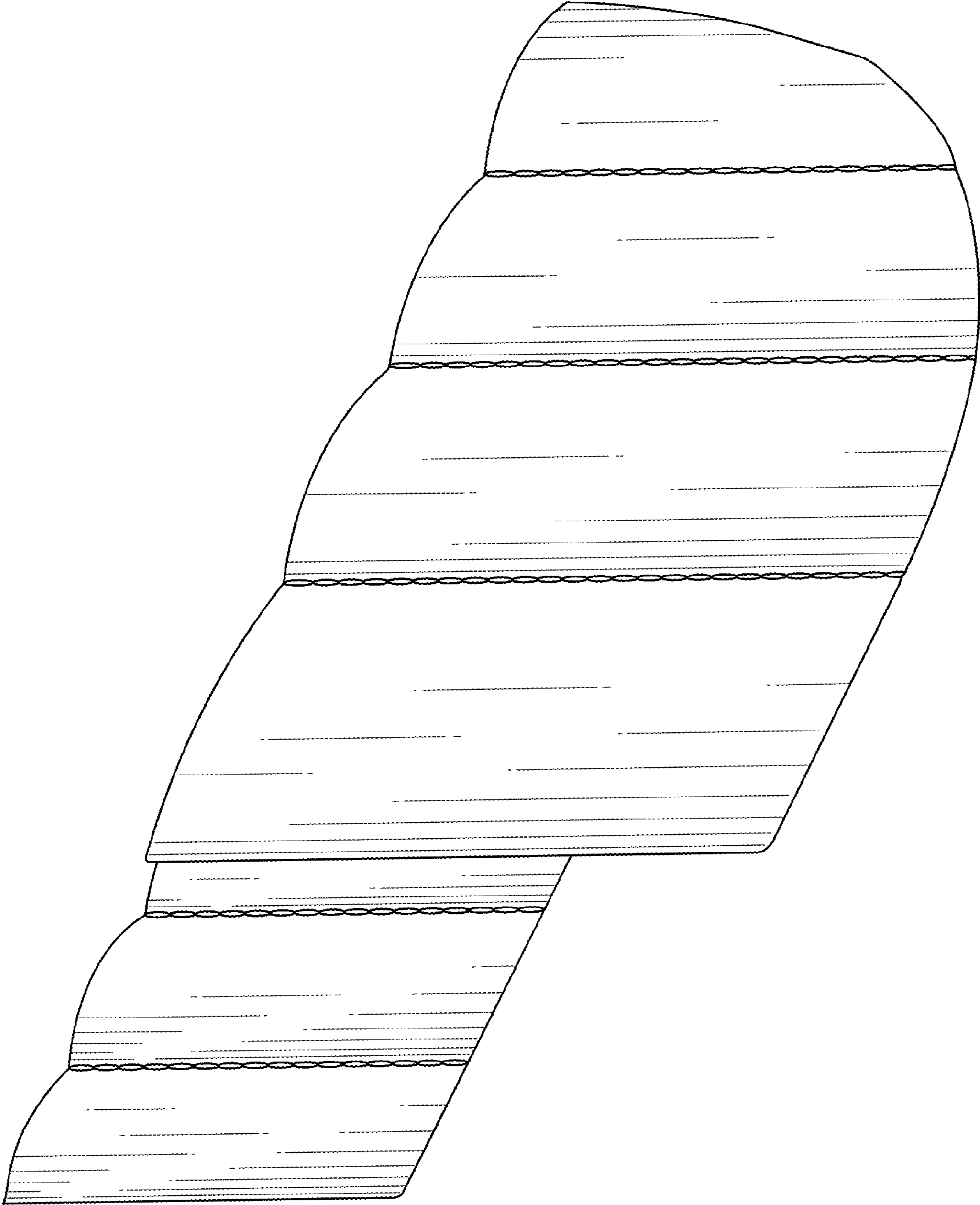

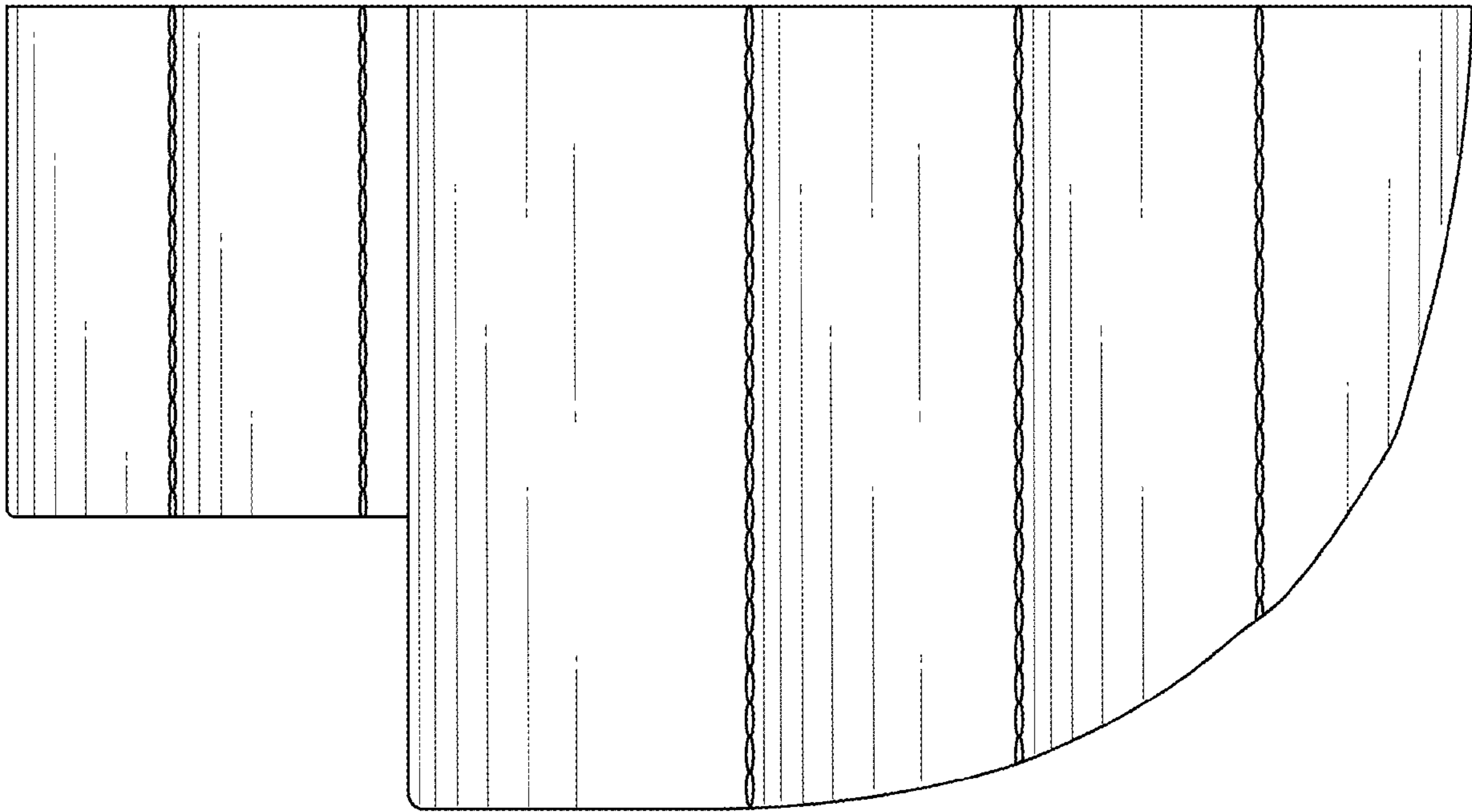

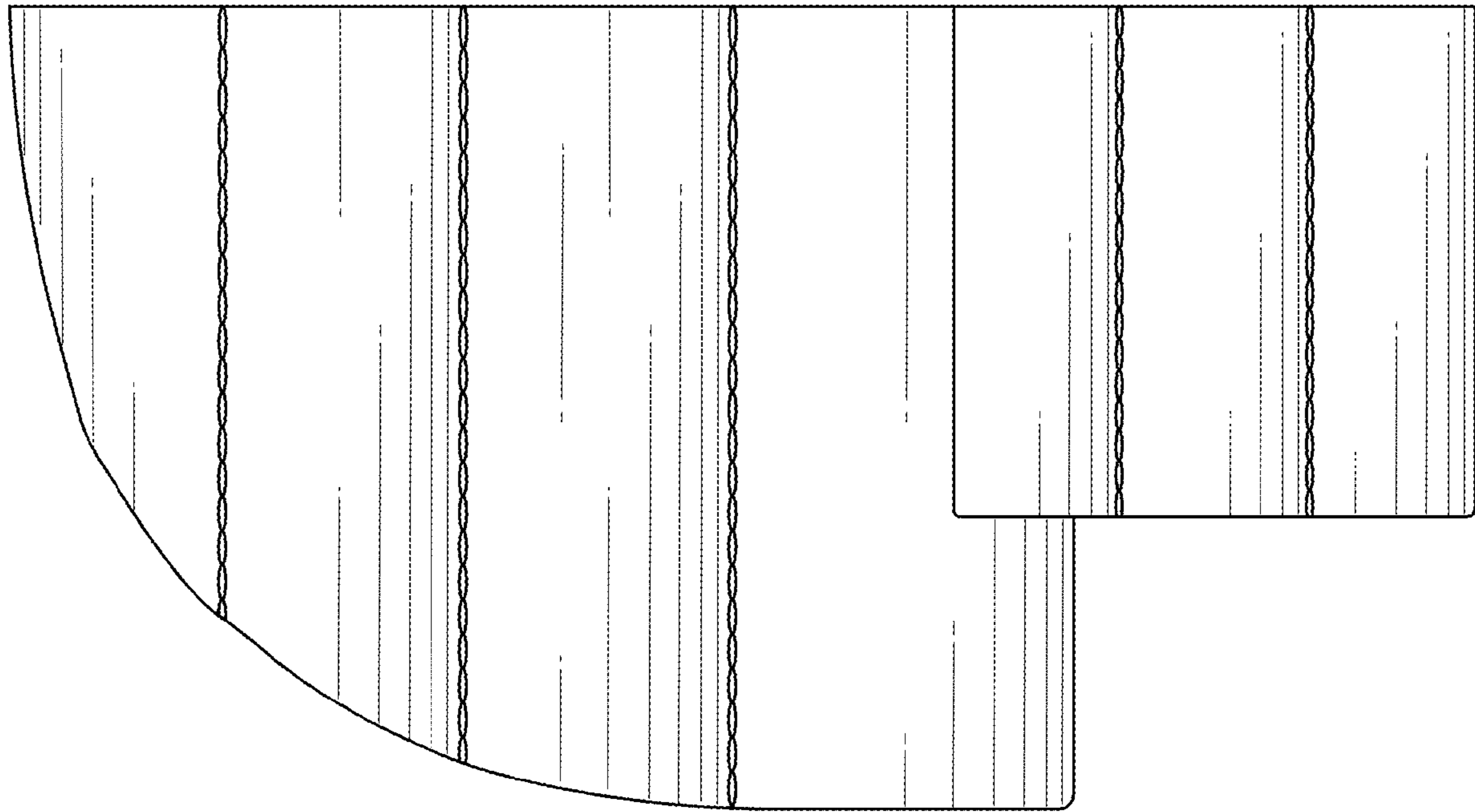

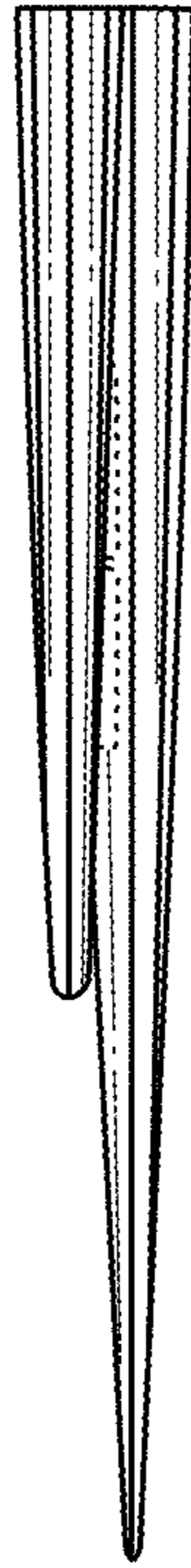

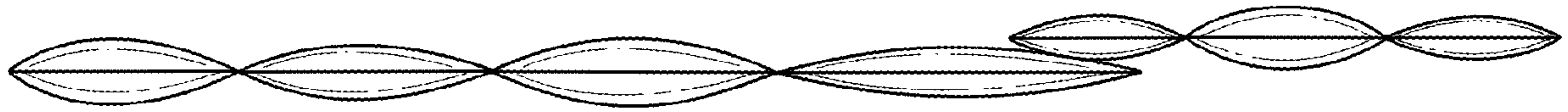
