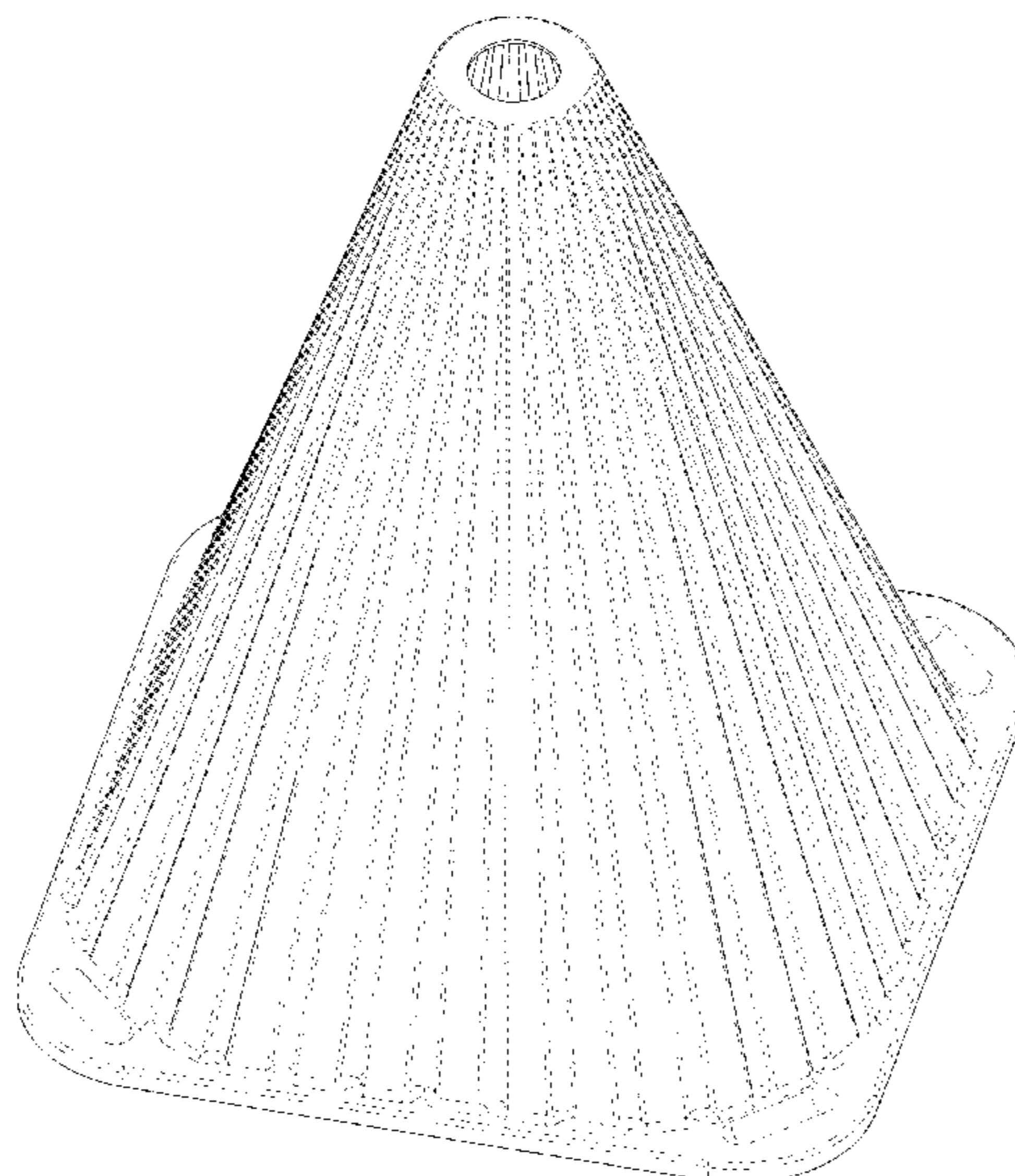
(57) **CLAIM**

The ornamental design for a plant bell cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a plant bell cover showing my new design;  
FIG. 2 is another perspective view thereof;  
FIG. 3 is a front elevational view thereof, the rear, left and right elevational views are identical;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a bottom plan view thereof; and,  
FIG. 6 is a cross-sectional view of 6-6 in FIG. 6.  
The broken lines in the figures are for the purposes of illustrating portions of the plant bell cover, which form no part of the claimed design.

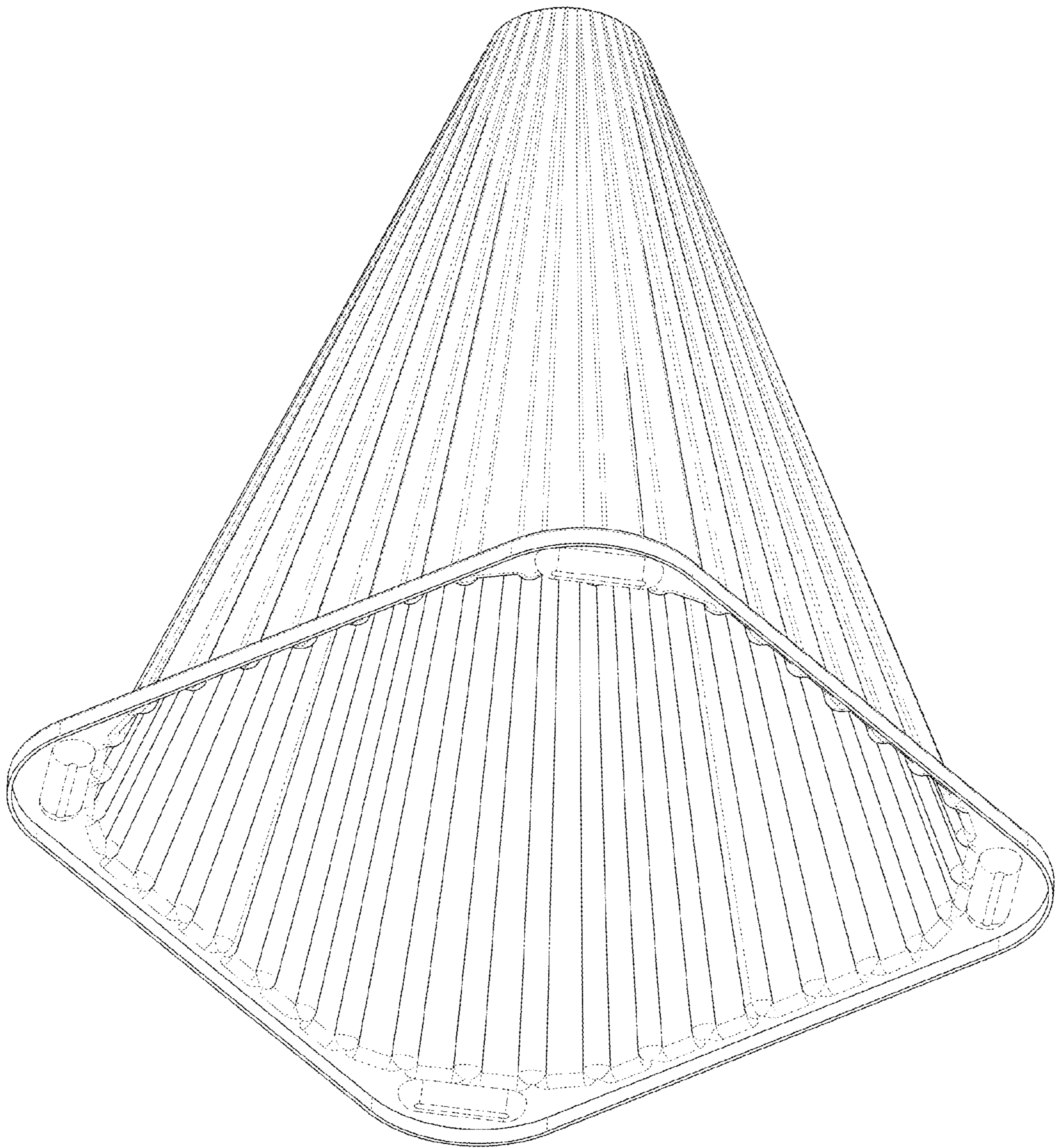

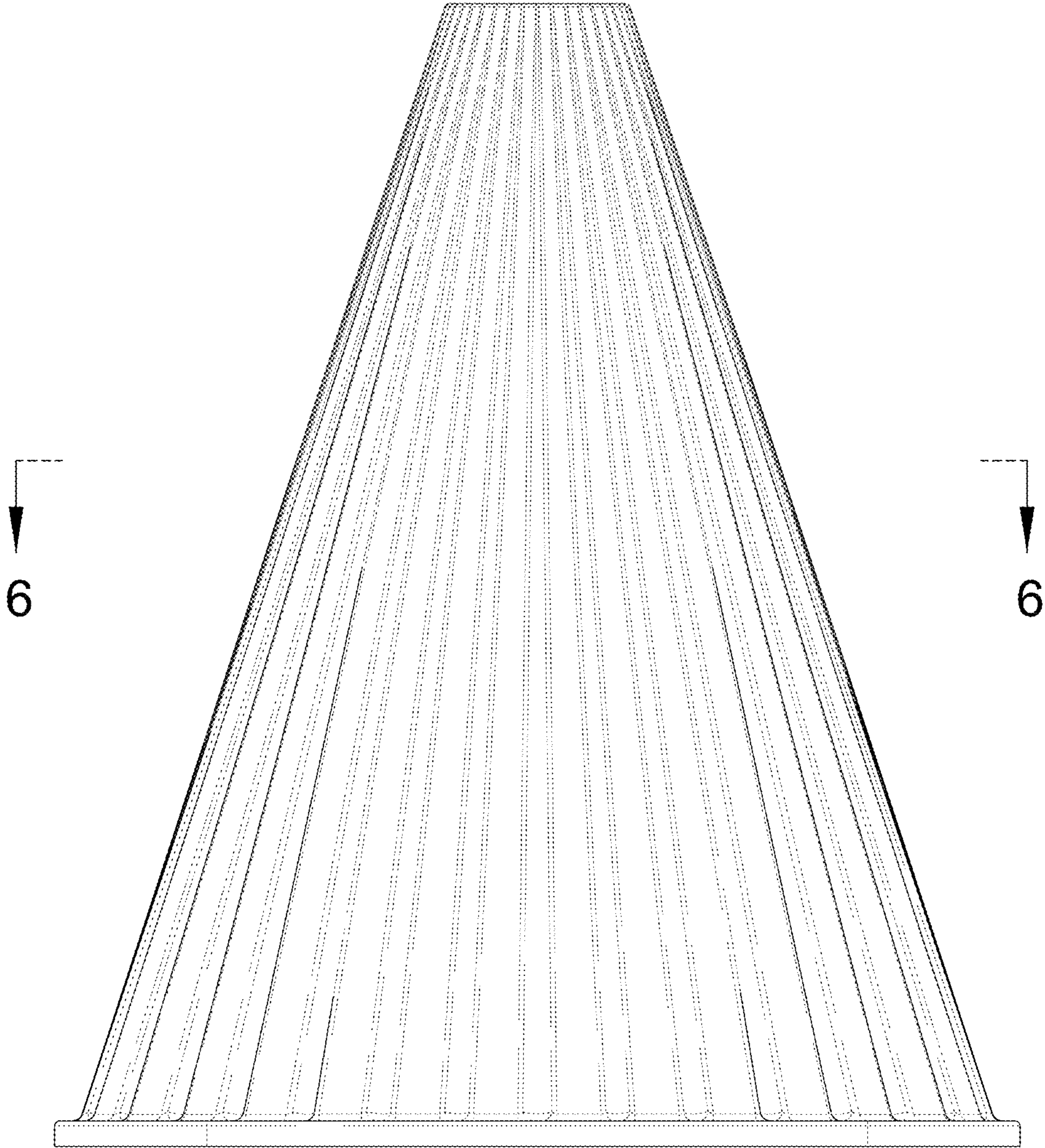

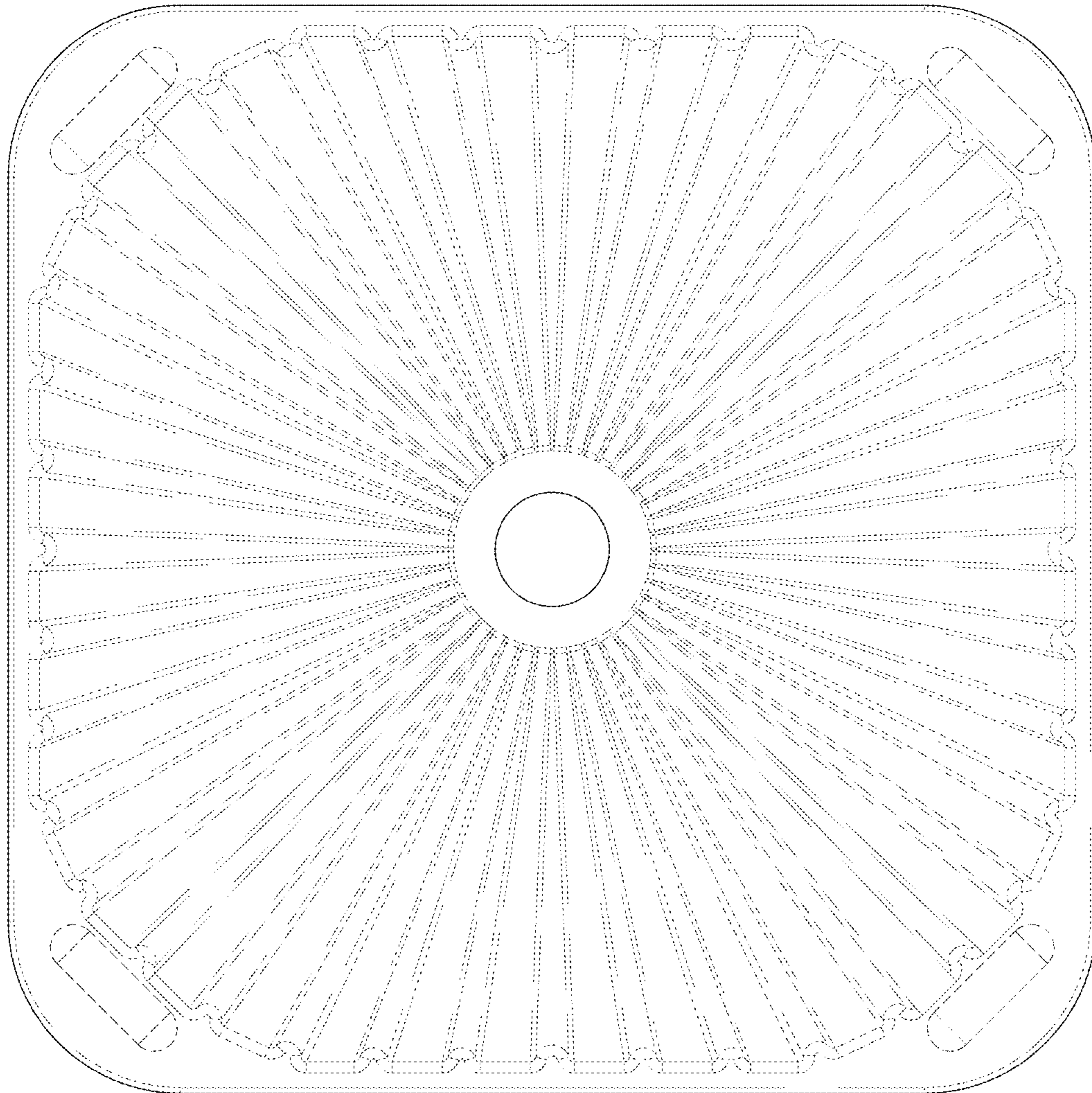

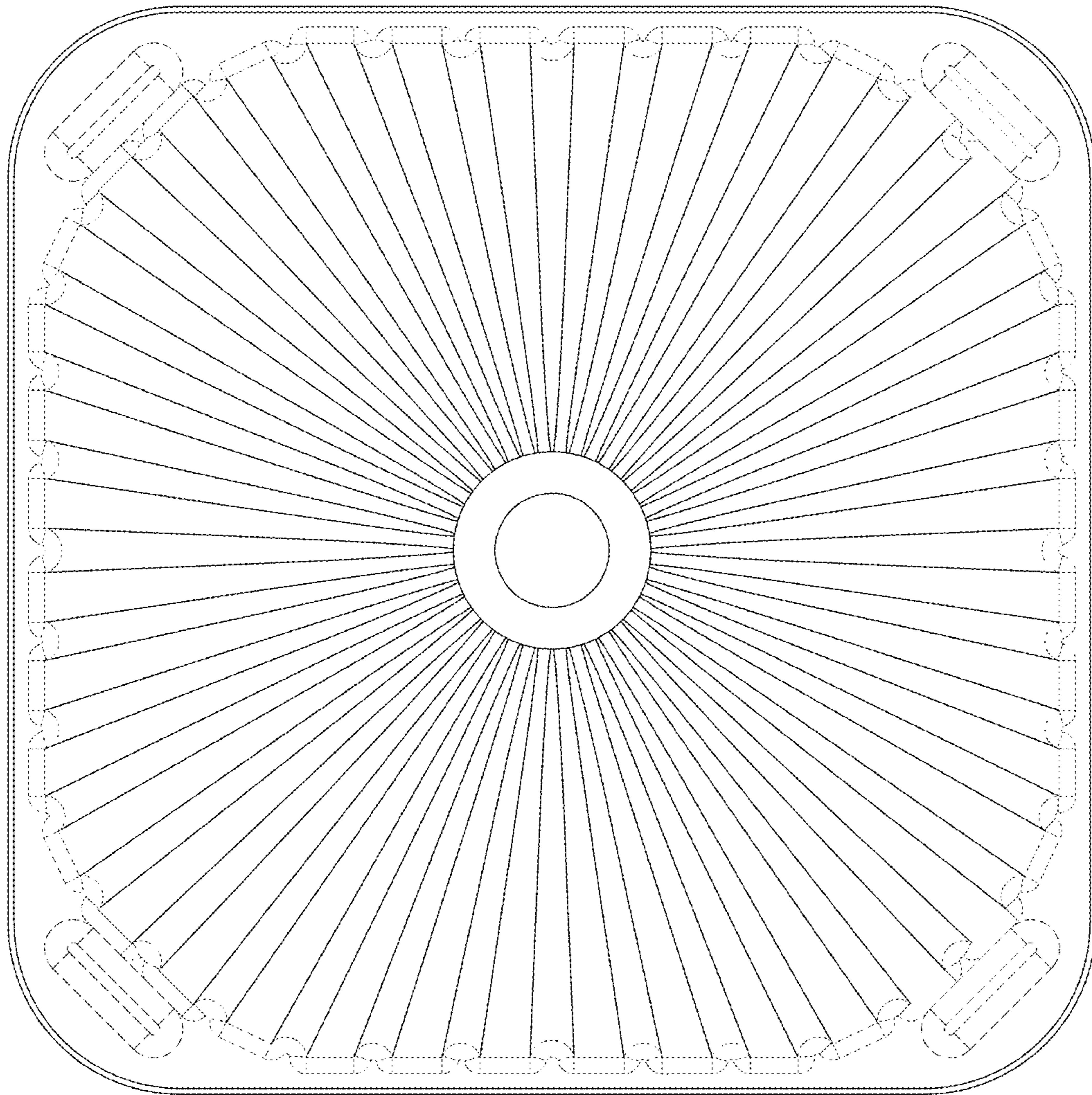

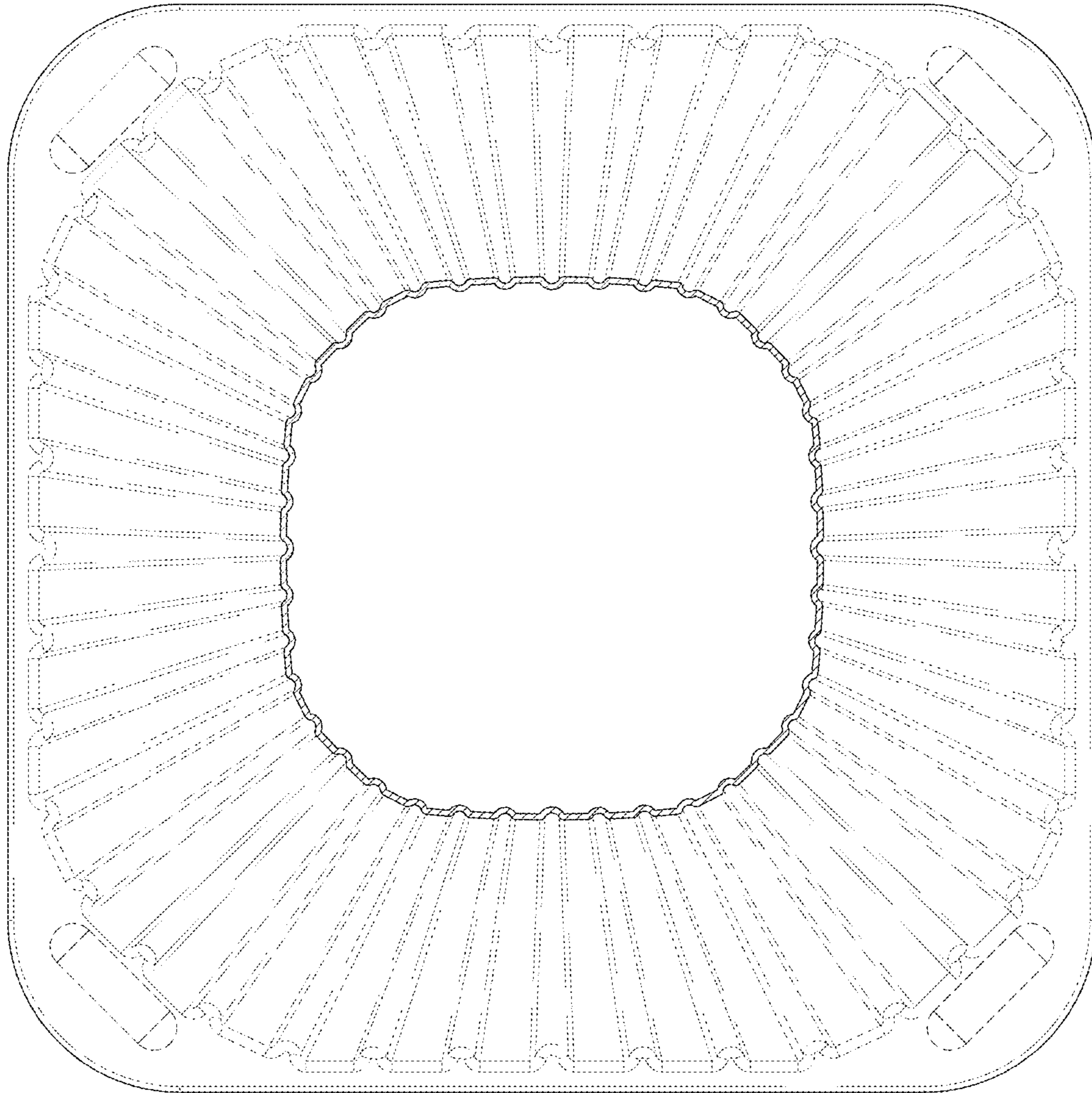
