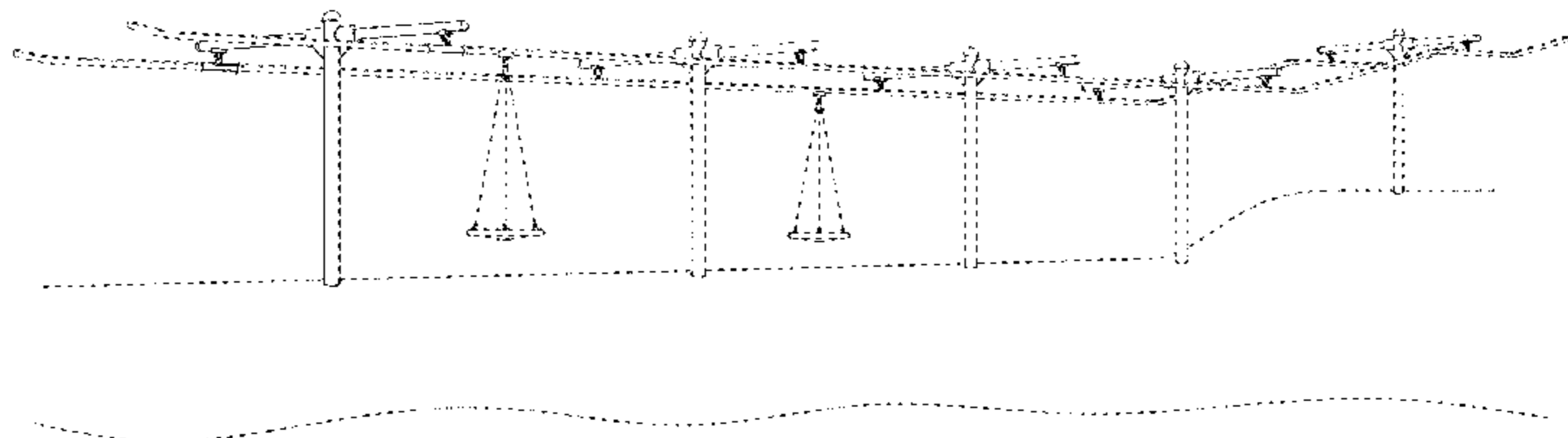
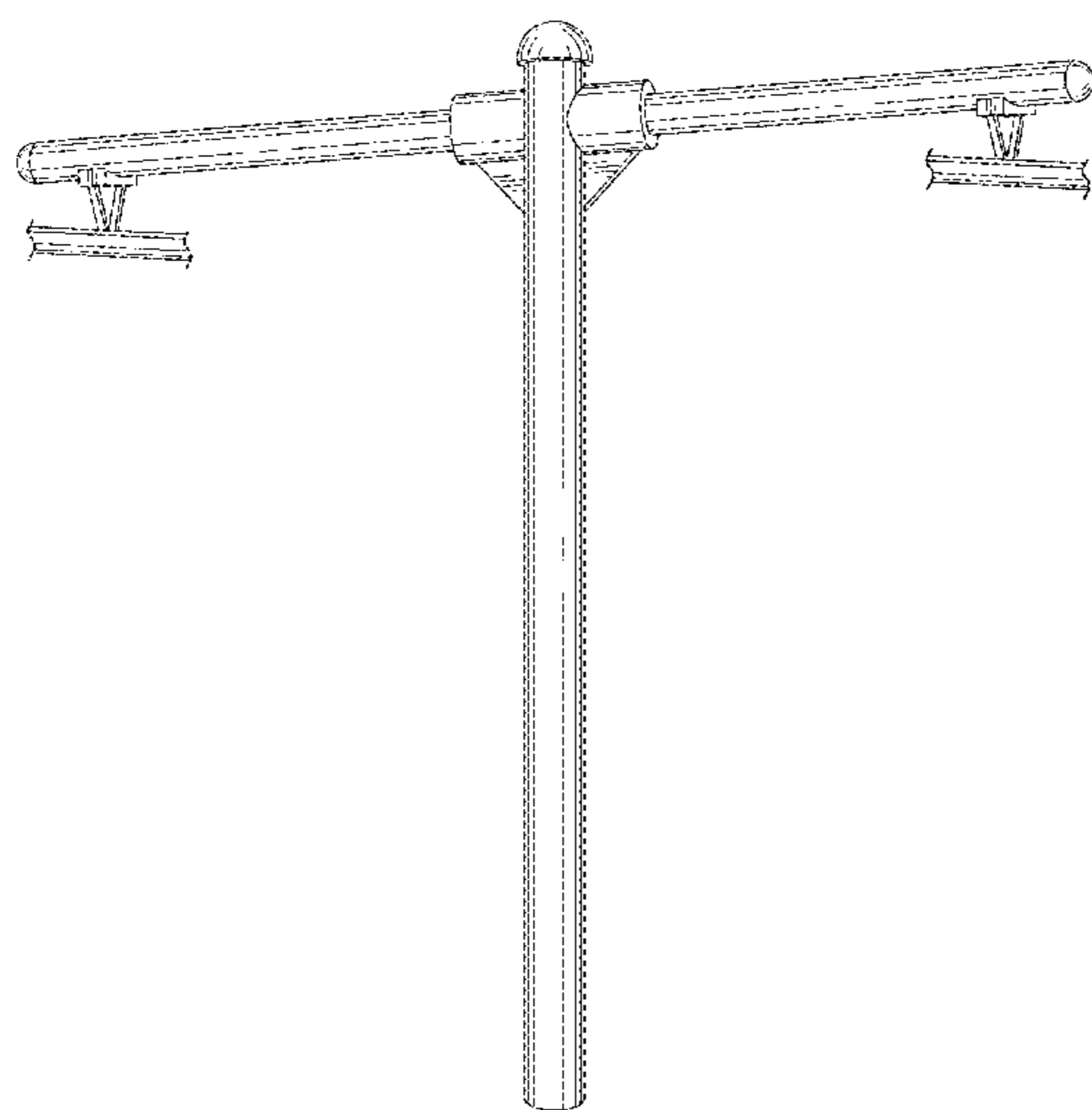
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a playground track ride module showing the new design;

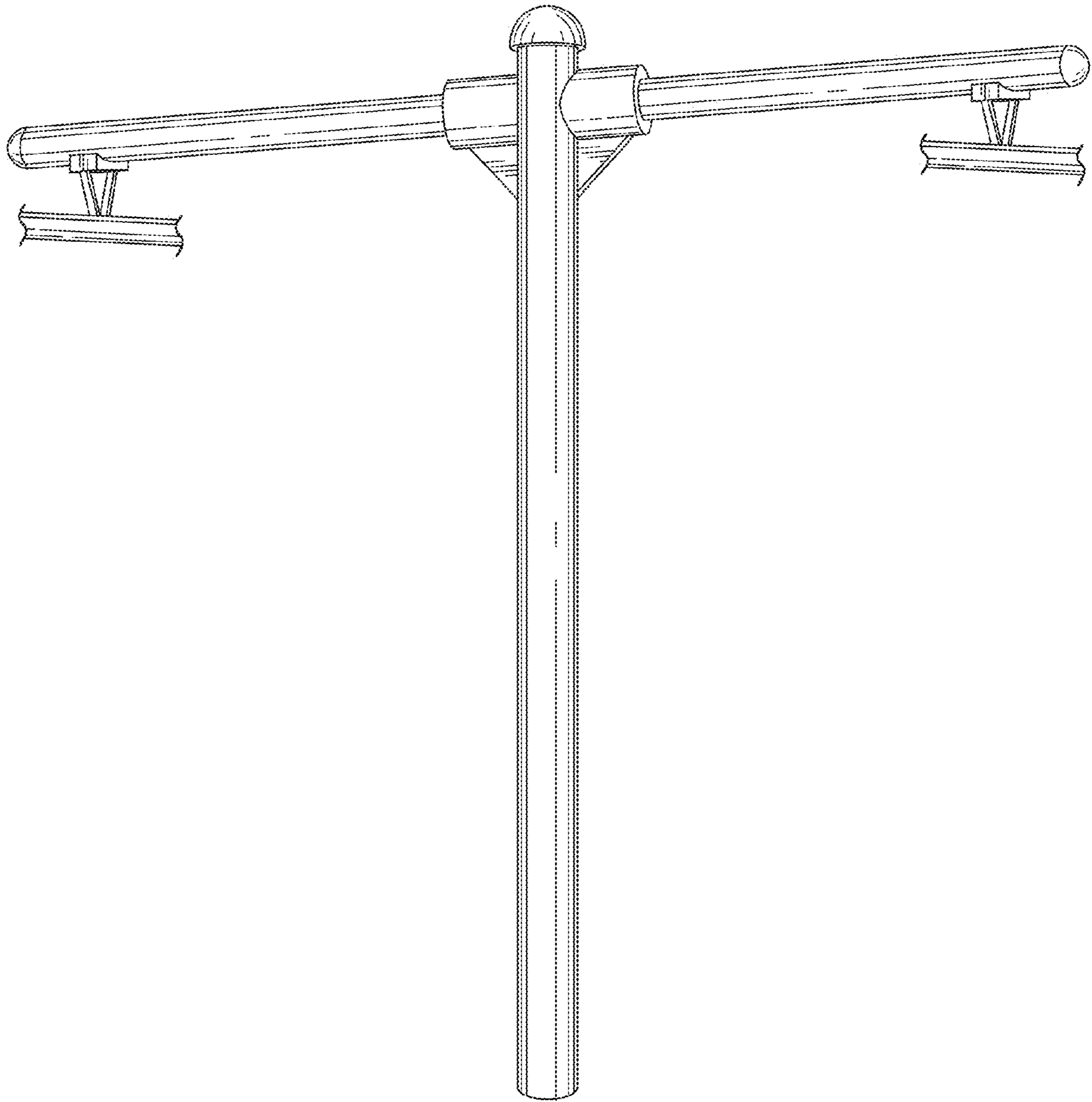

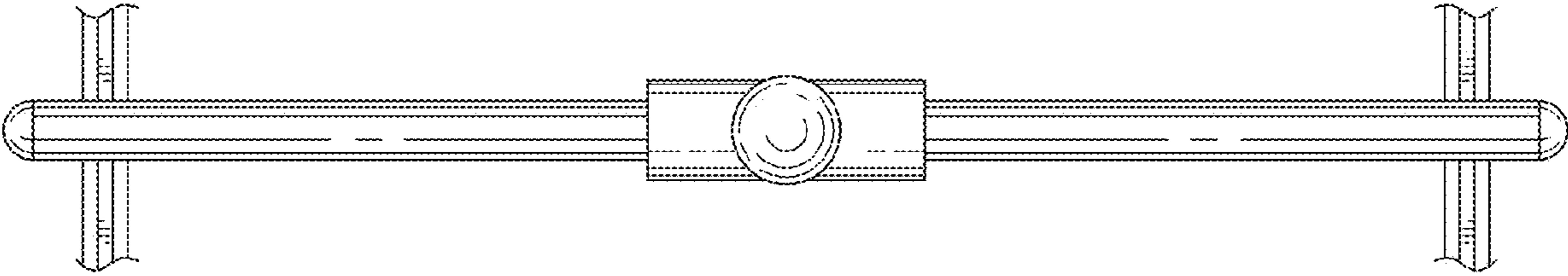

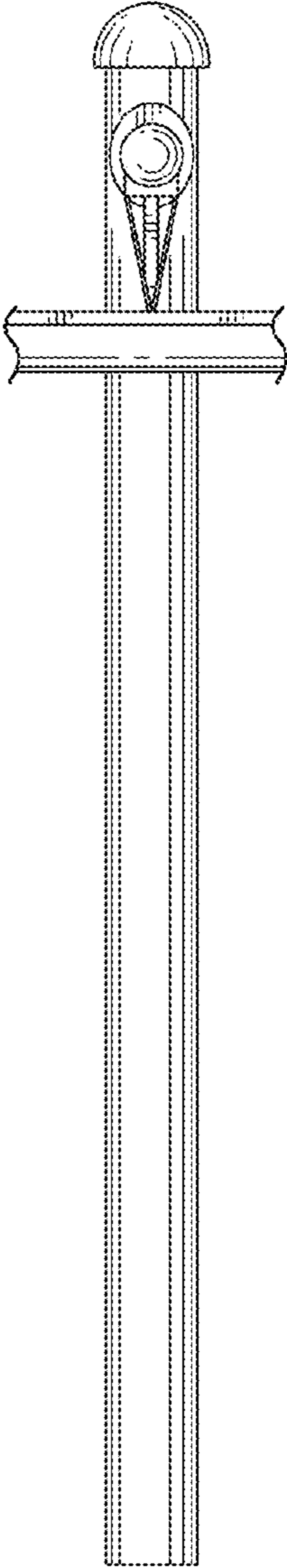

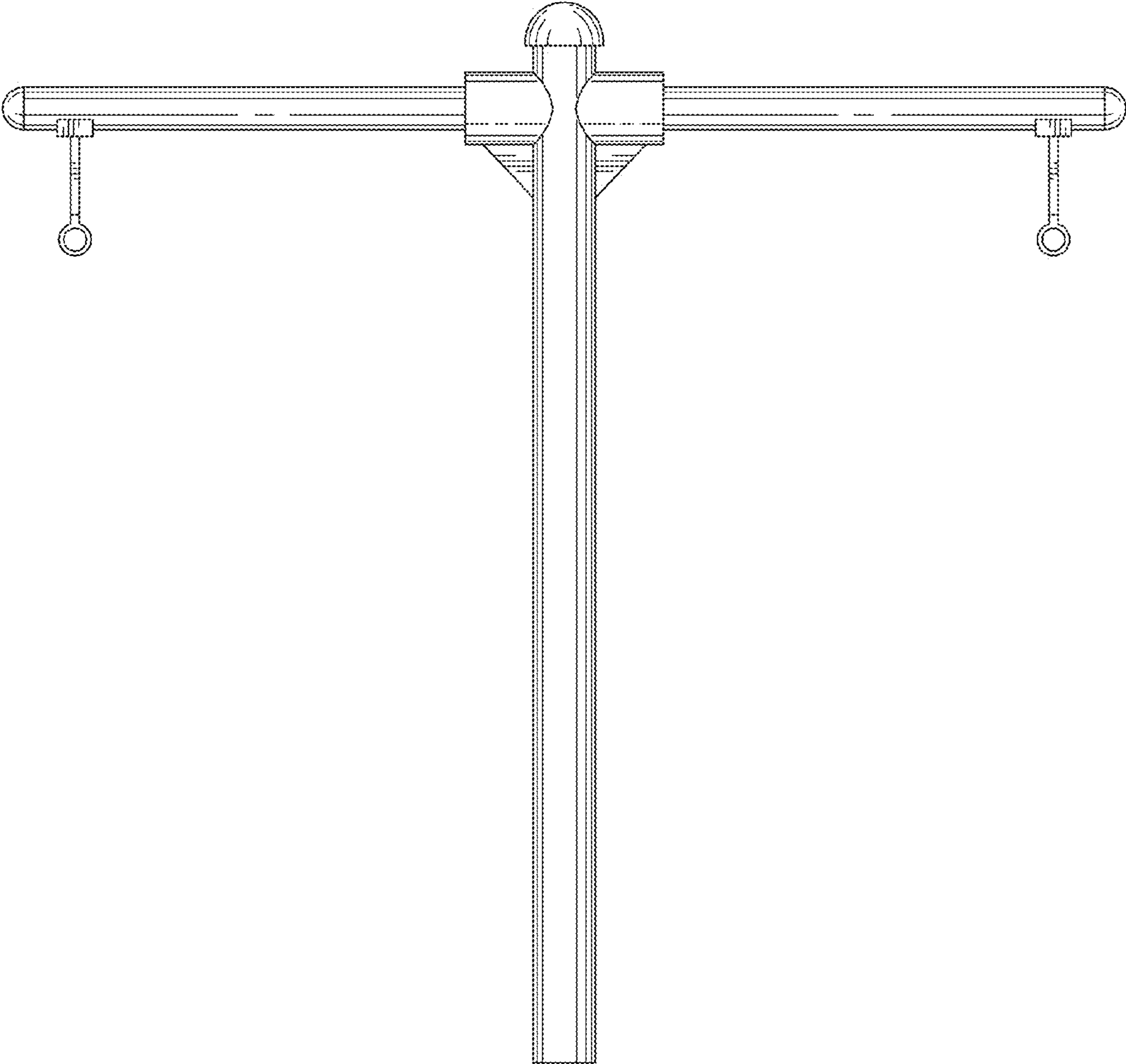

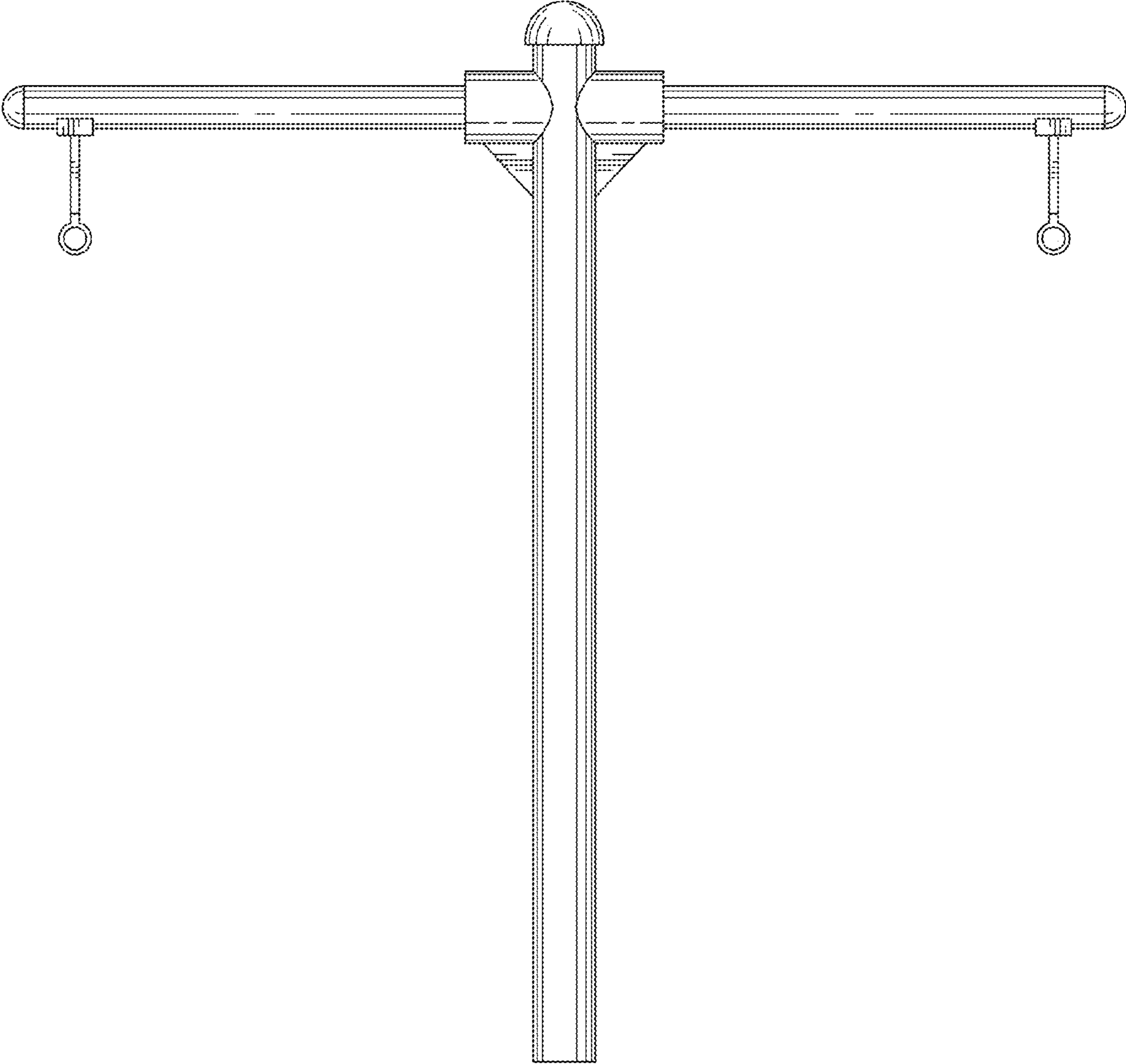

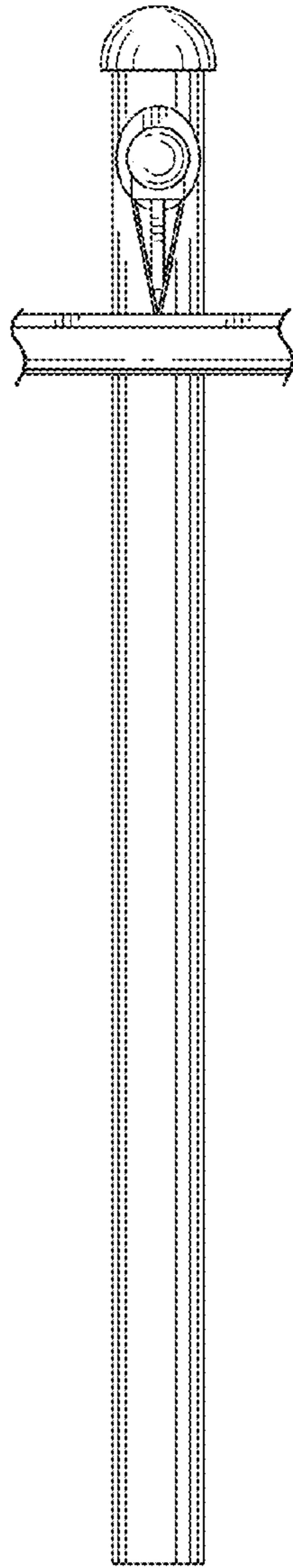

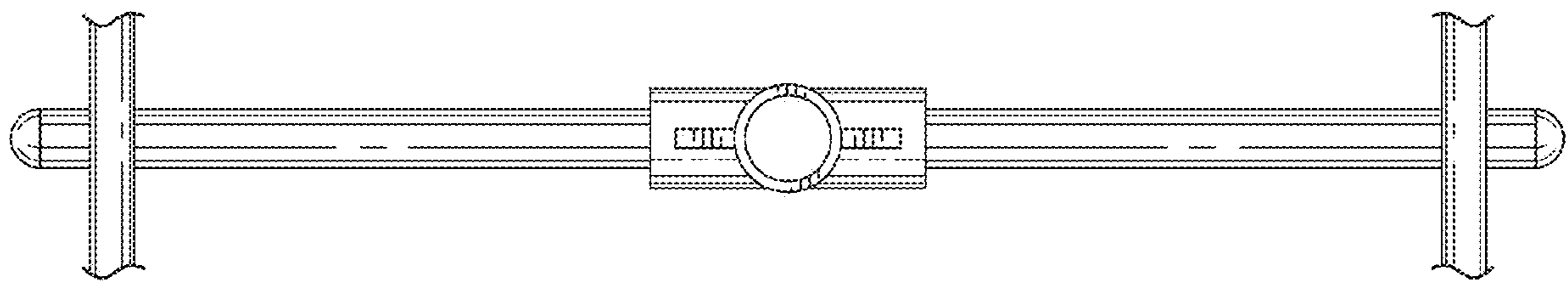

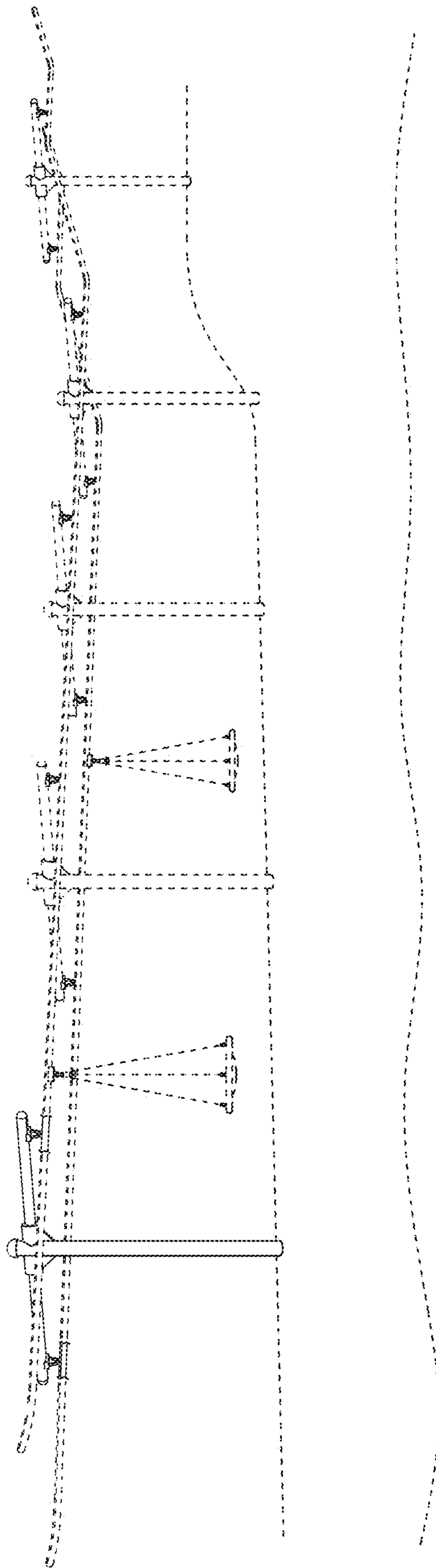
