 FIG. 5 is a rear view thereof;
 FIG. 6 is a top view thereof;
 FIG. 7 is a bottom view thereof; and,
 FIG. 8 is a front perspective view of the bulk bag showing flowable material (in broken lines) discharging from a bottom spout of the bulk bag. The flowable material shown in FIG. 8 is for illustrative purpose only and forms no part of the claimed design.

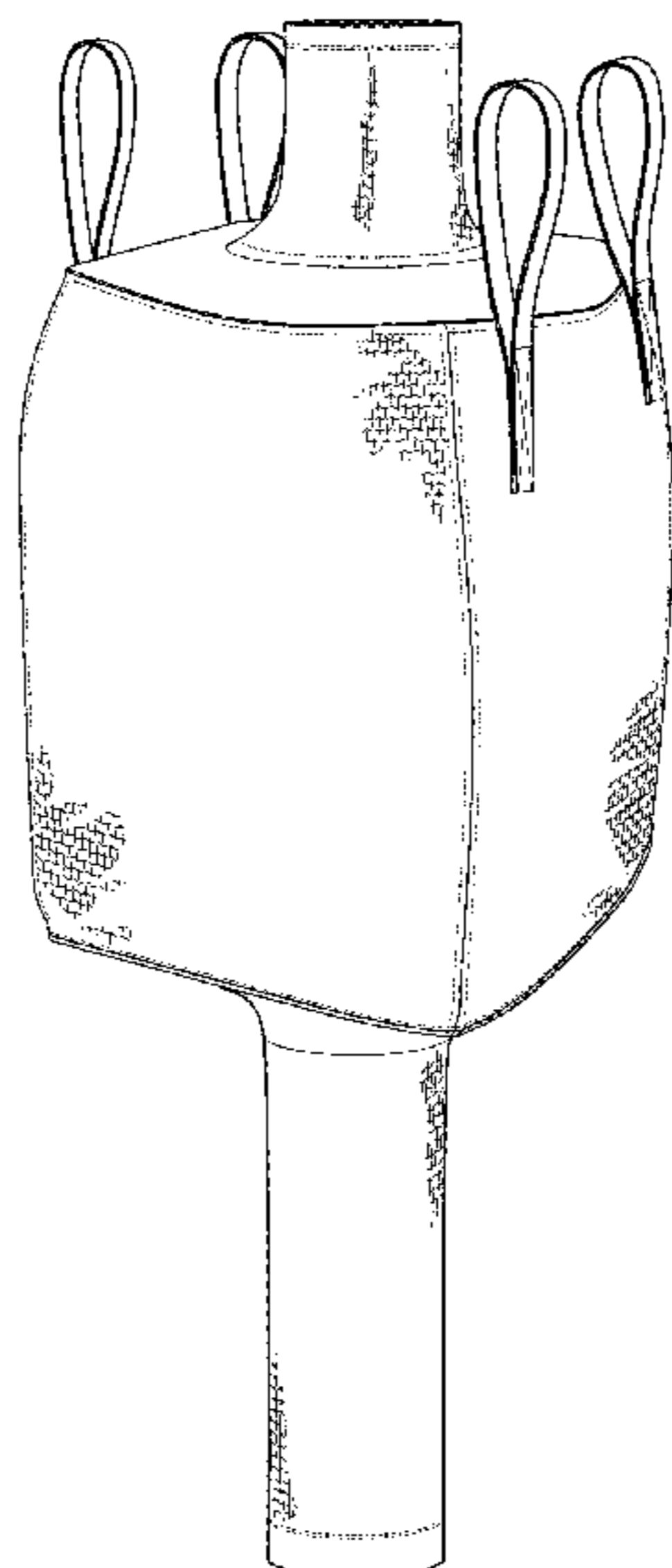

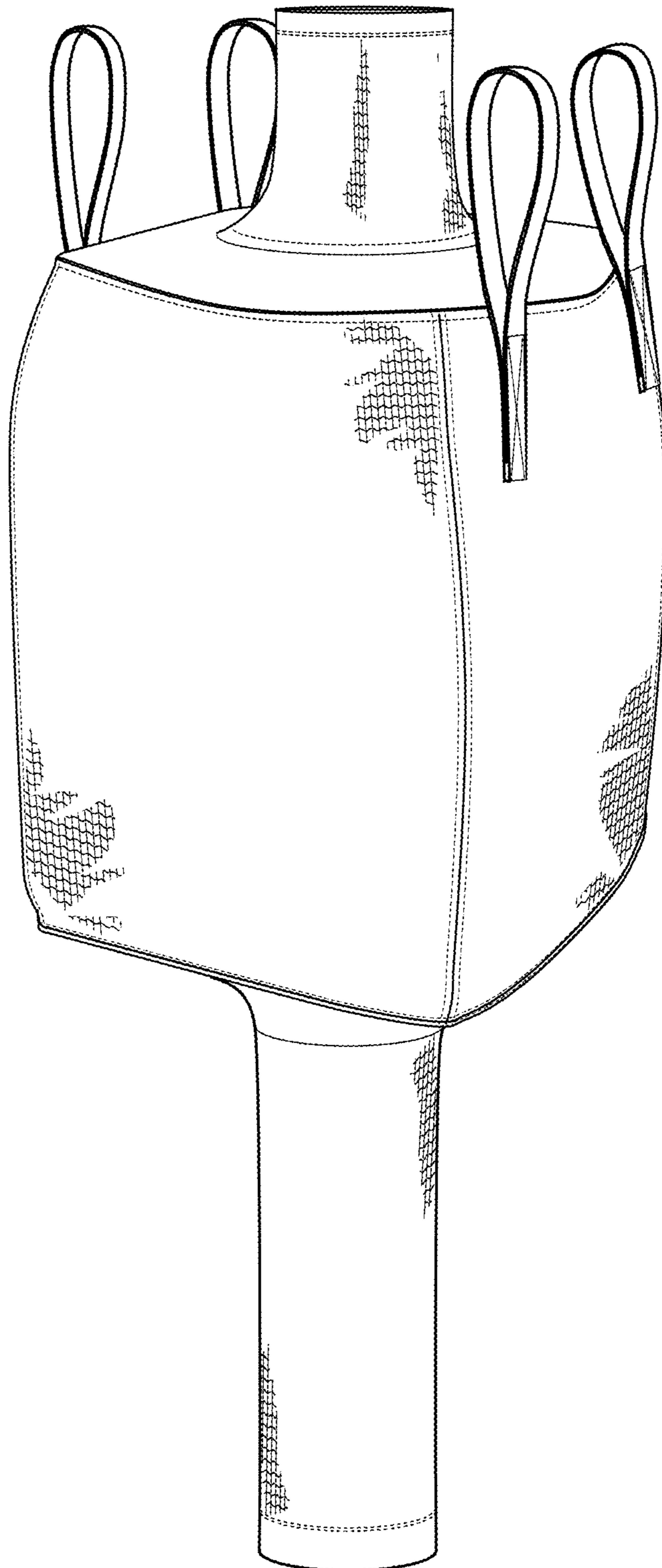

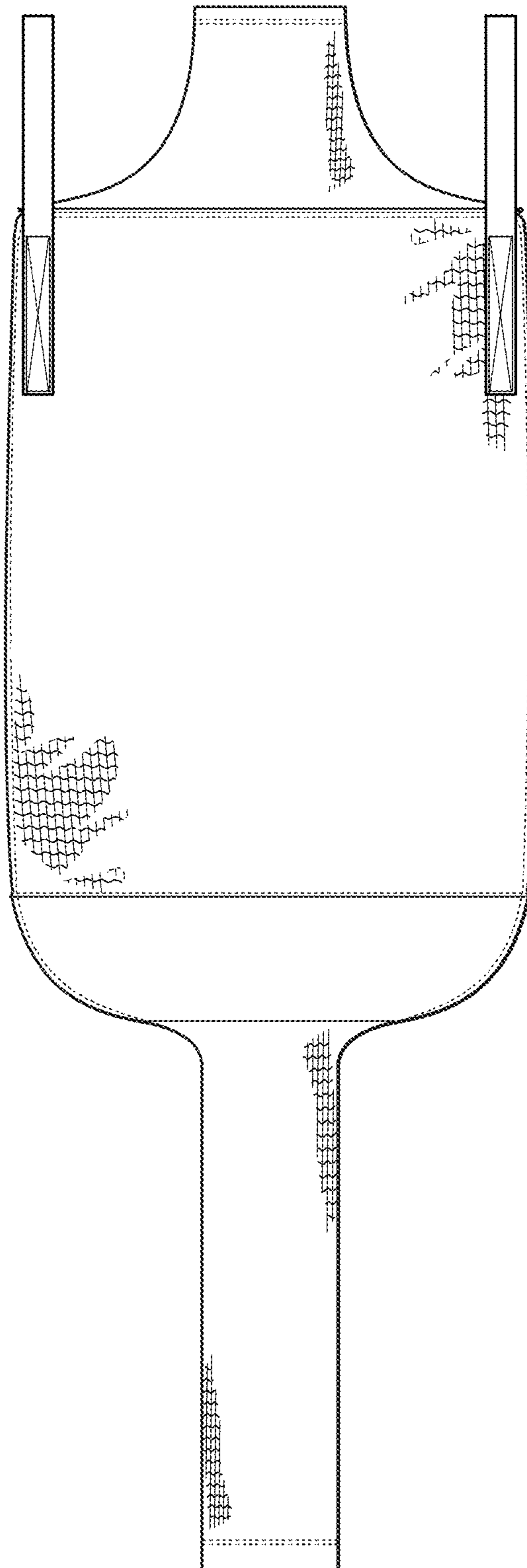

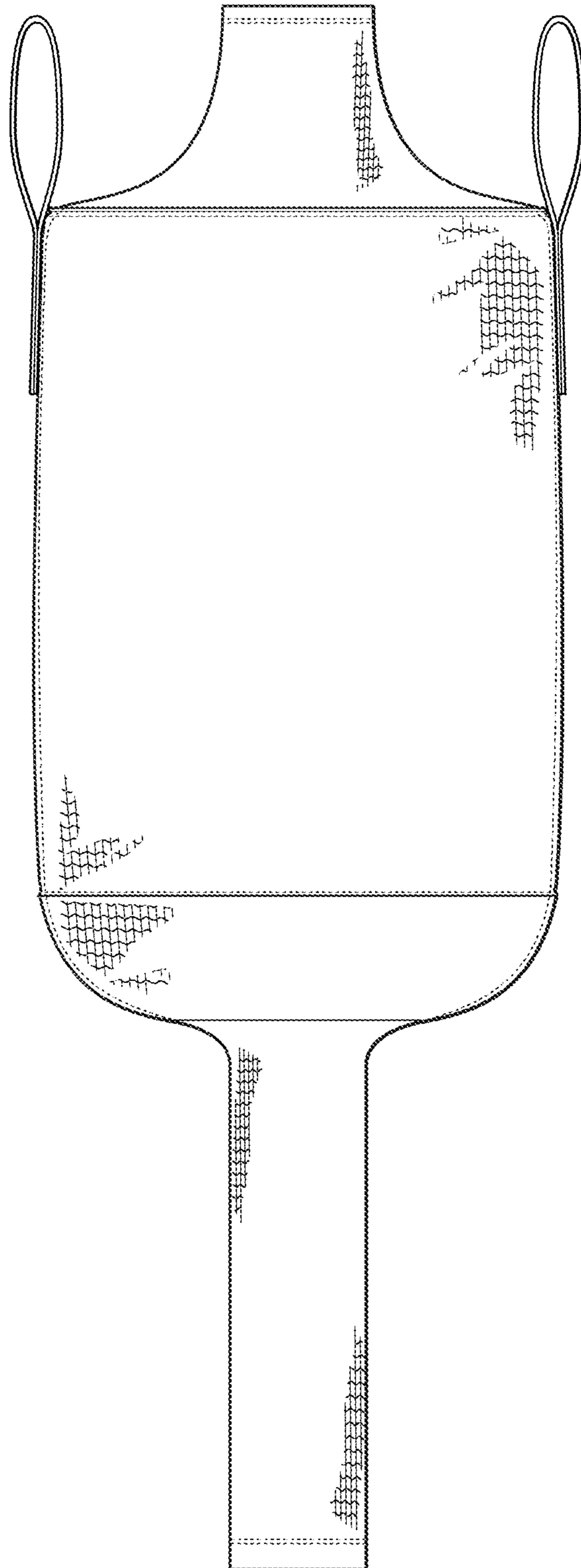

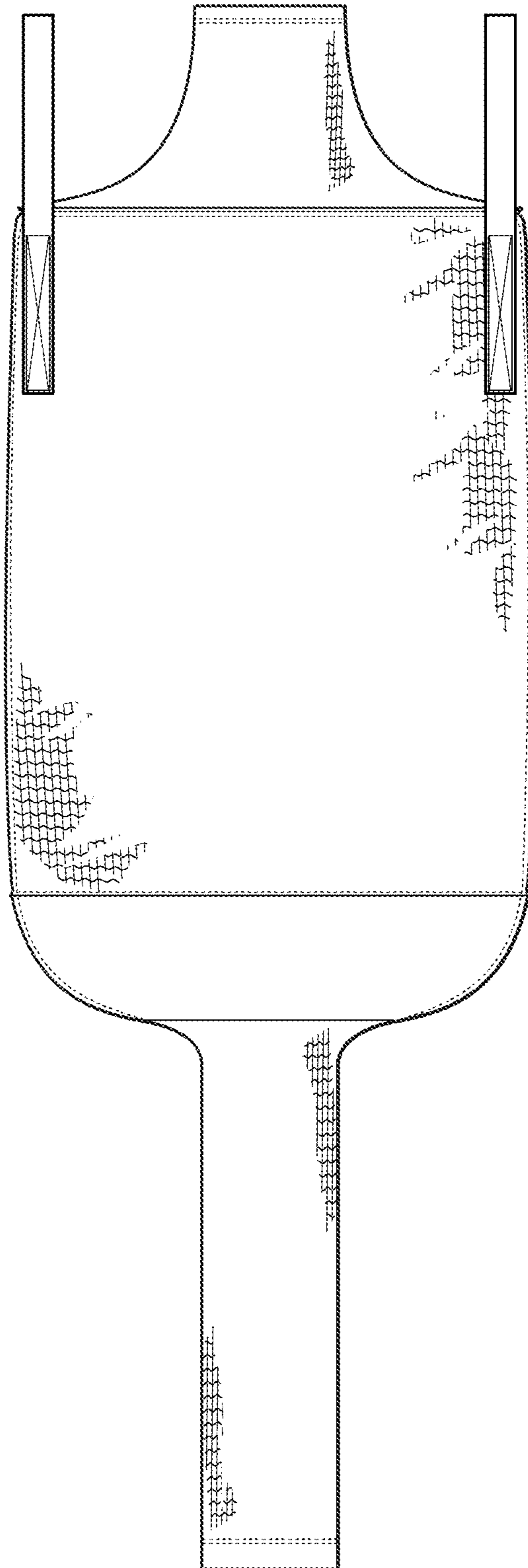

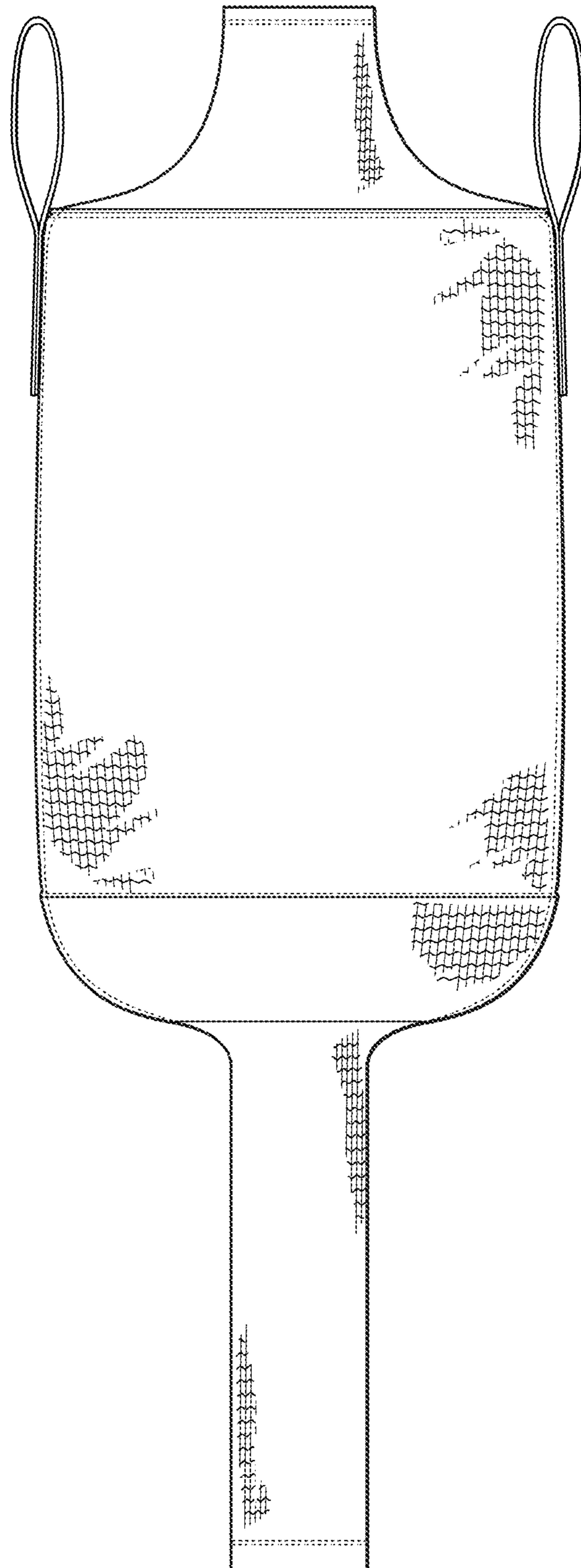

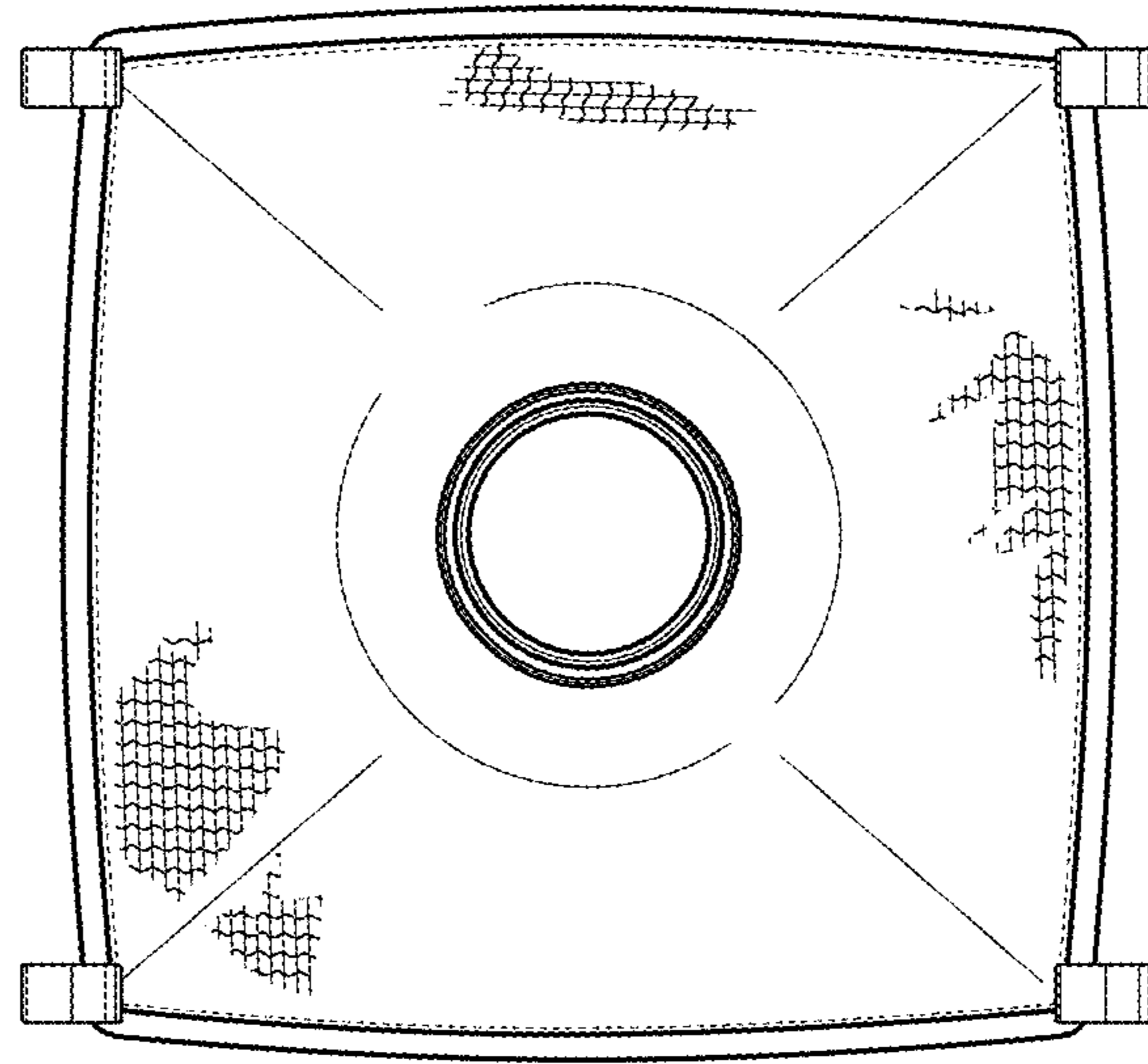

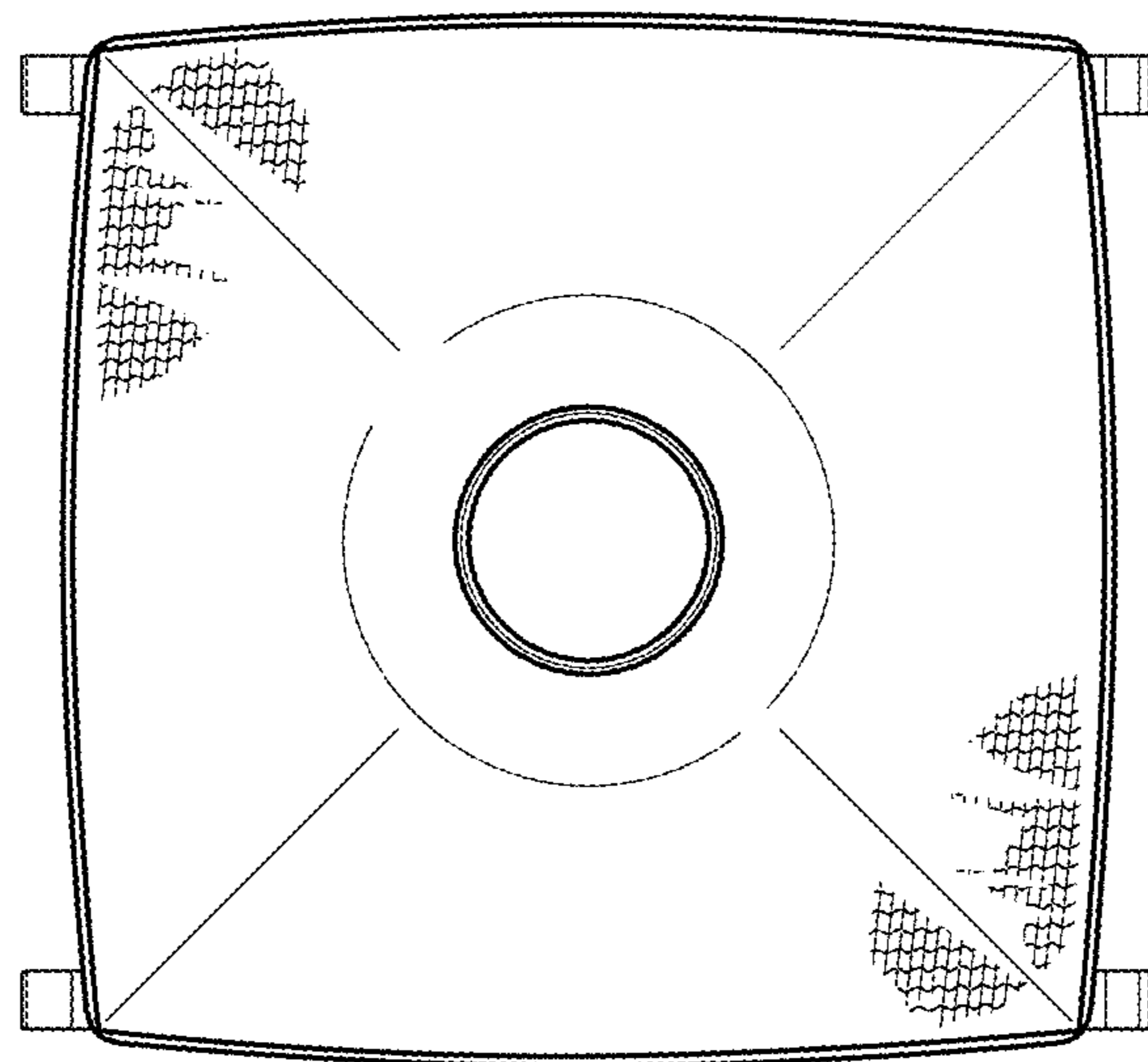
