(57) **CLAIM**

The ornamental design for an alarm device, as shown and described.

DESCRIPTION

Cross reference is made to copending U.S. design patent application Ser. No. 29/754,740 entitled “Alarm Device” by Weißhoff, Heiko, which was filed on Oct. 14, 2020.

FIG. 1 is a perspective view of an alarm device showing my new design;

FIG. 2 is a front side elevational view of the alarm device of FIG. 1;

FIG. 3 is a rear side elevational view of the alarm device of FIG. 1;

FIG. 4 is a right side elevational view of the alarm device of FIG. 1;

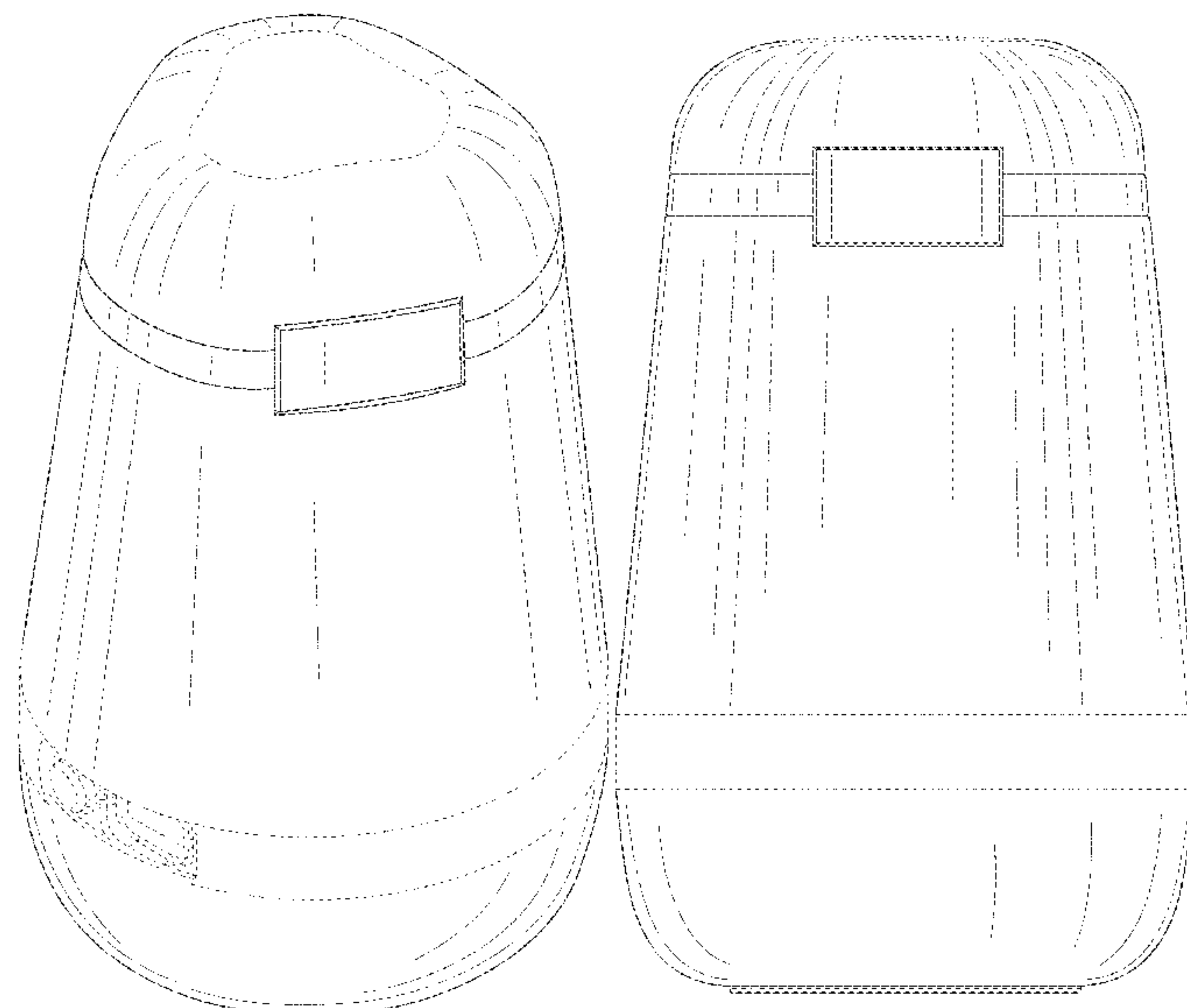
FIG. 5 is a left side elevational view of the alarm device of FIG. 1;

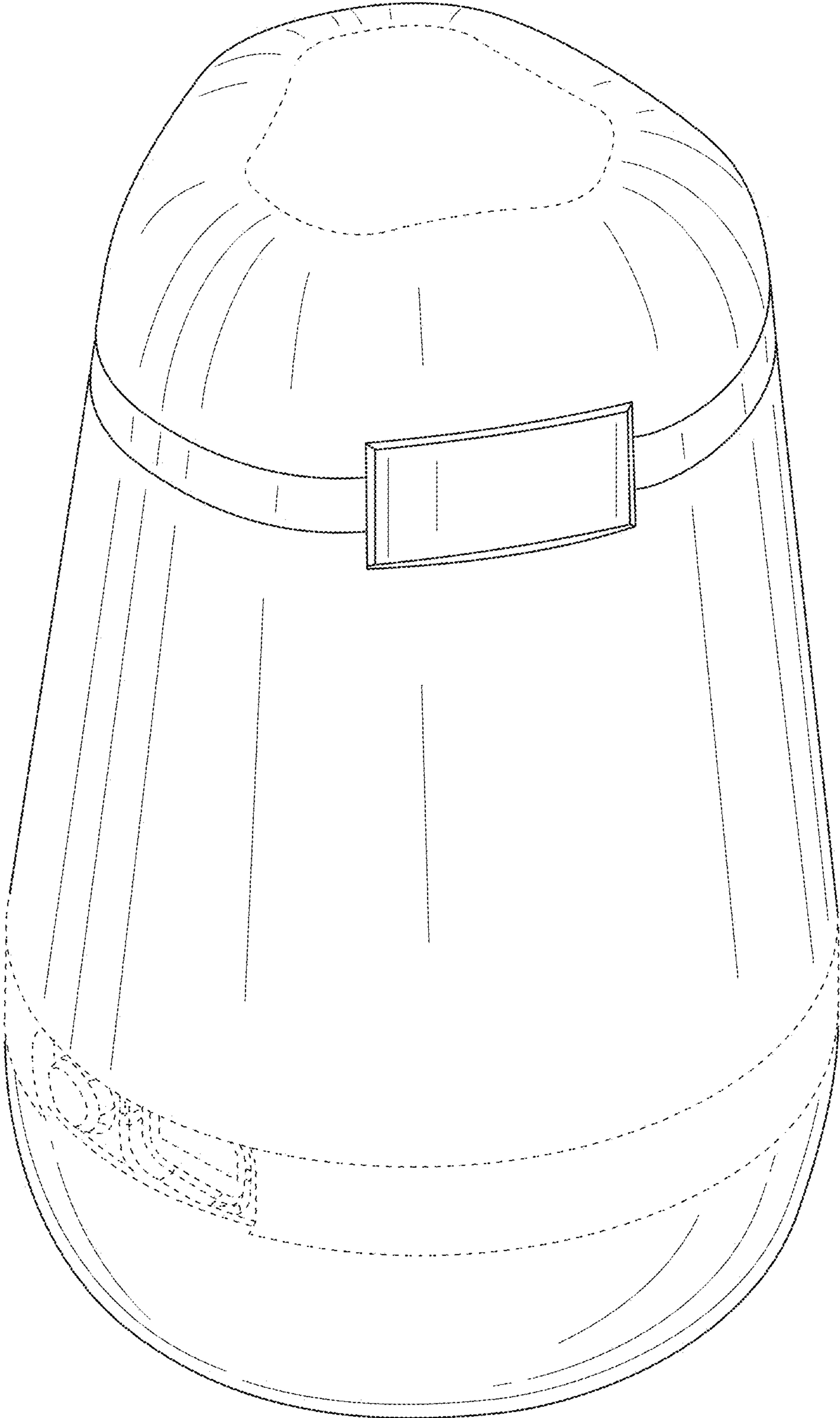

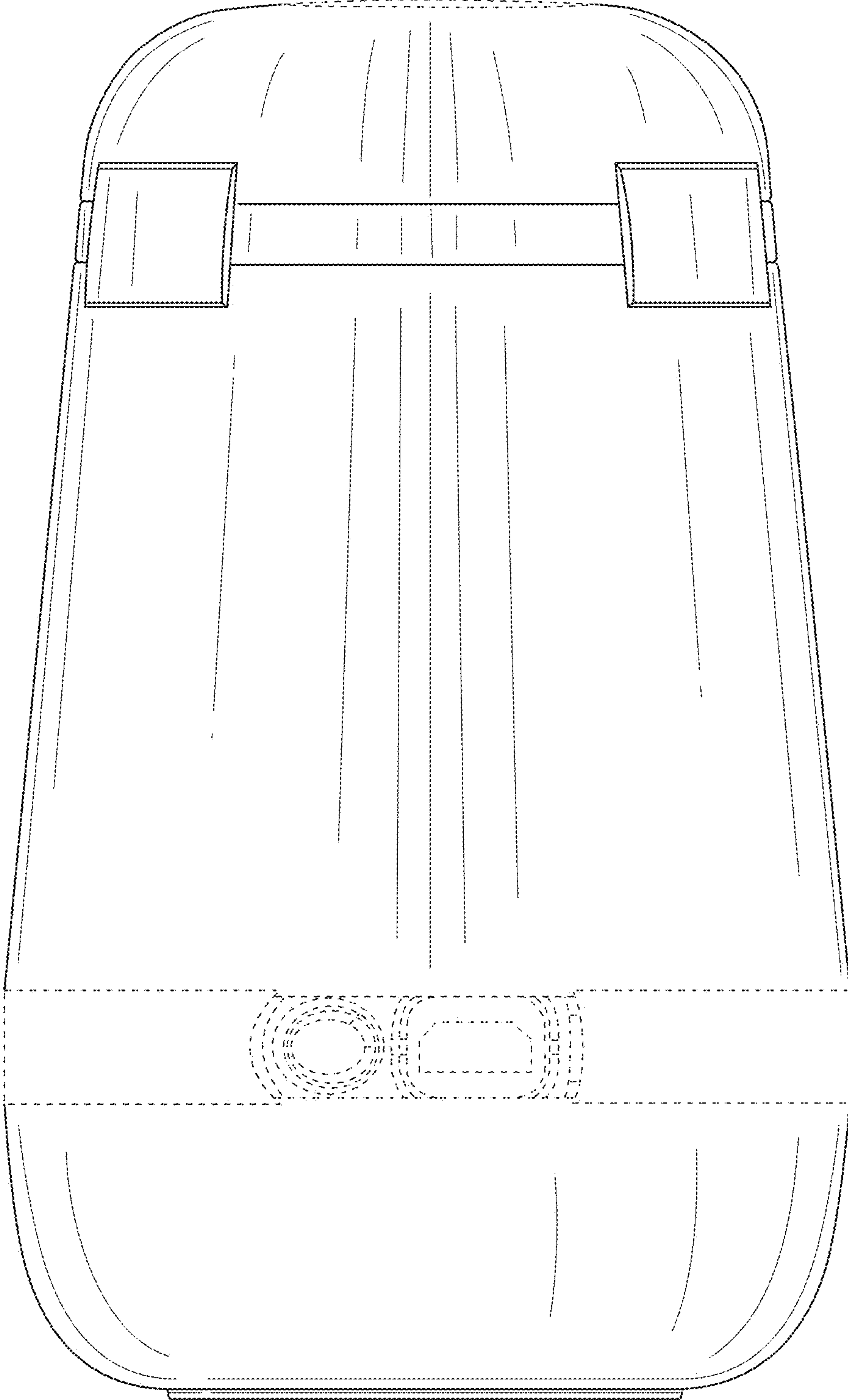

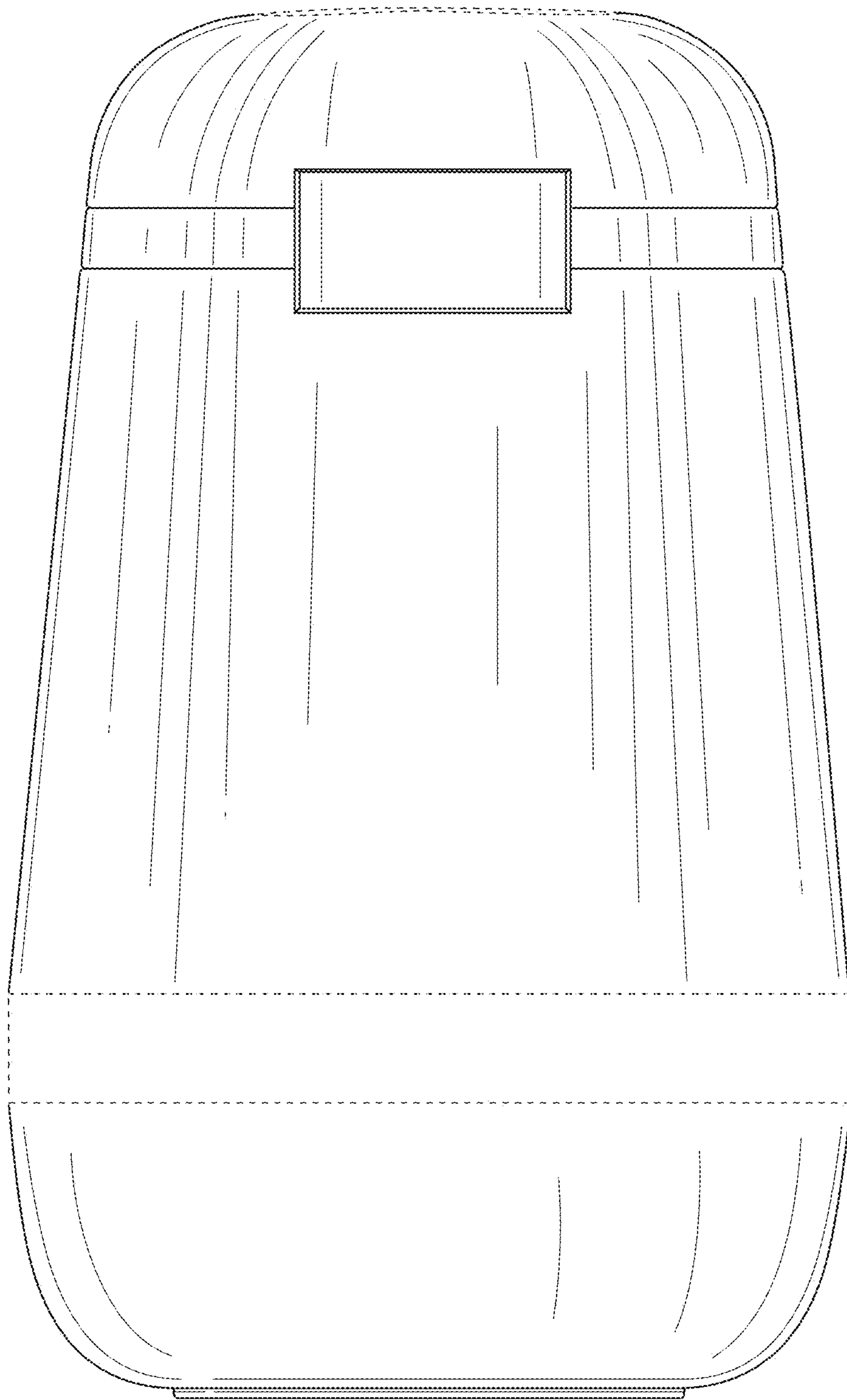

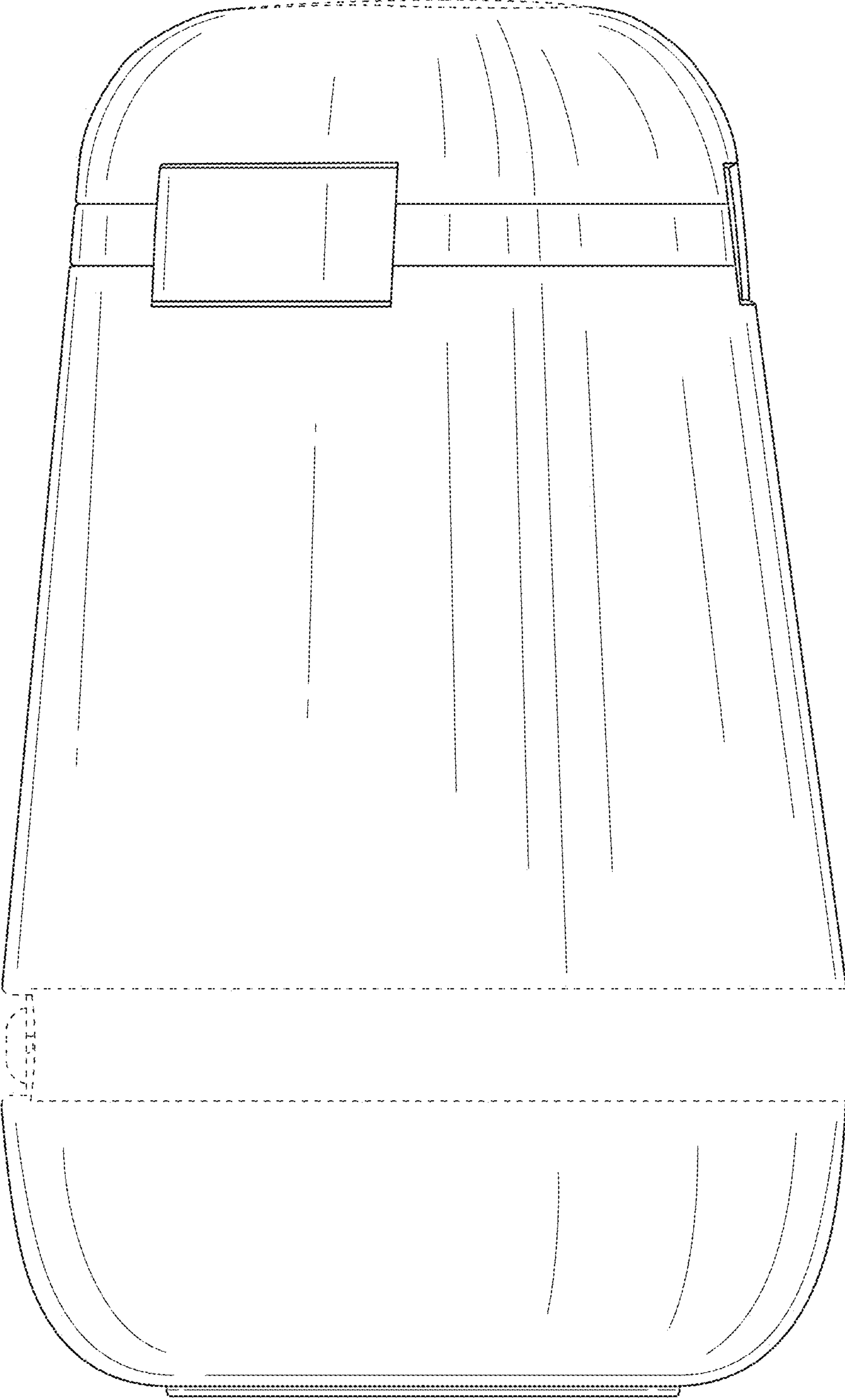

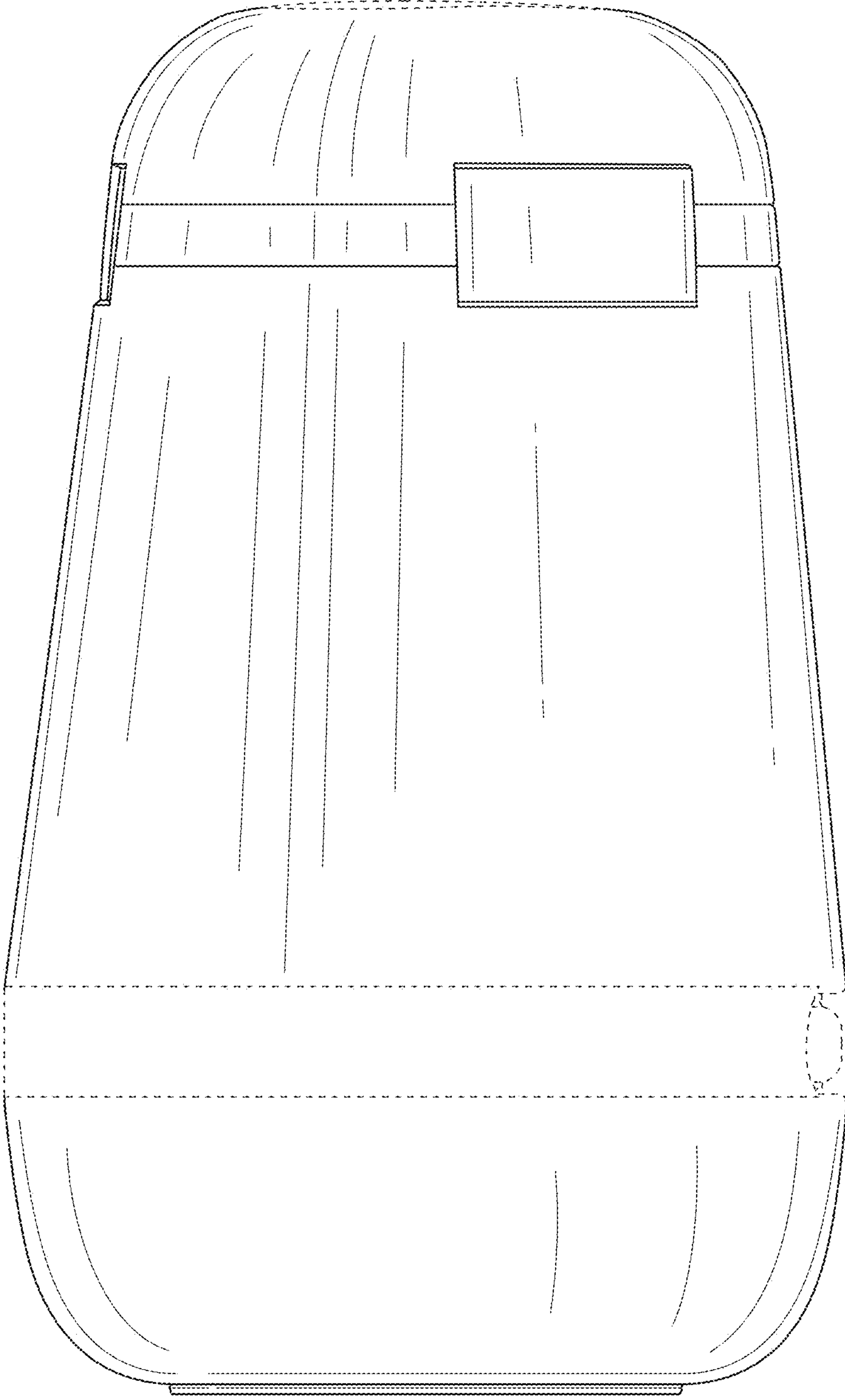

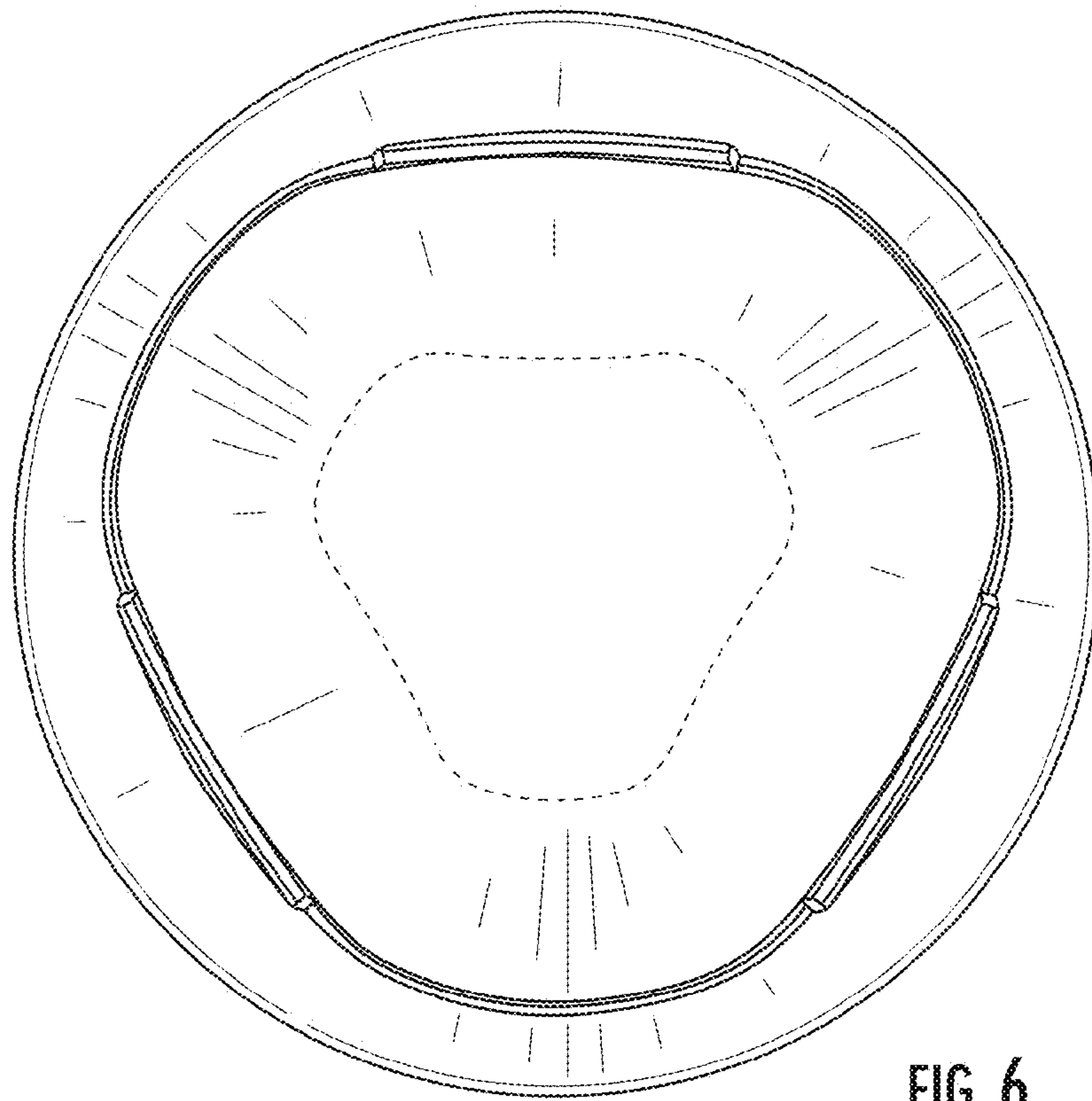

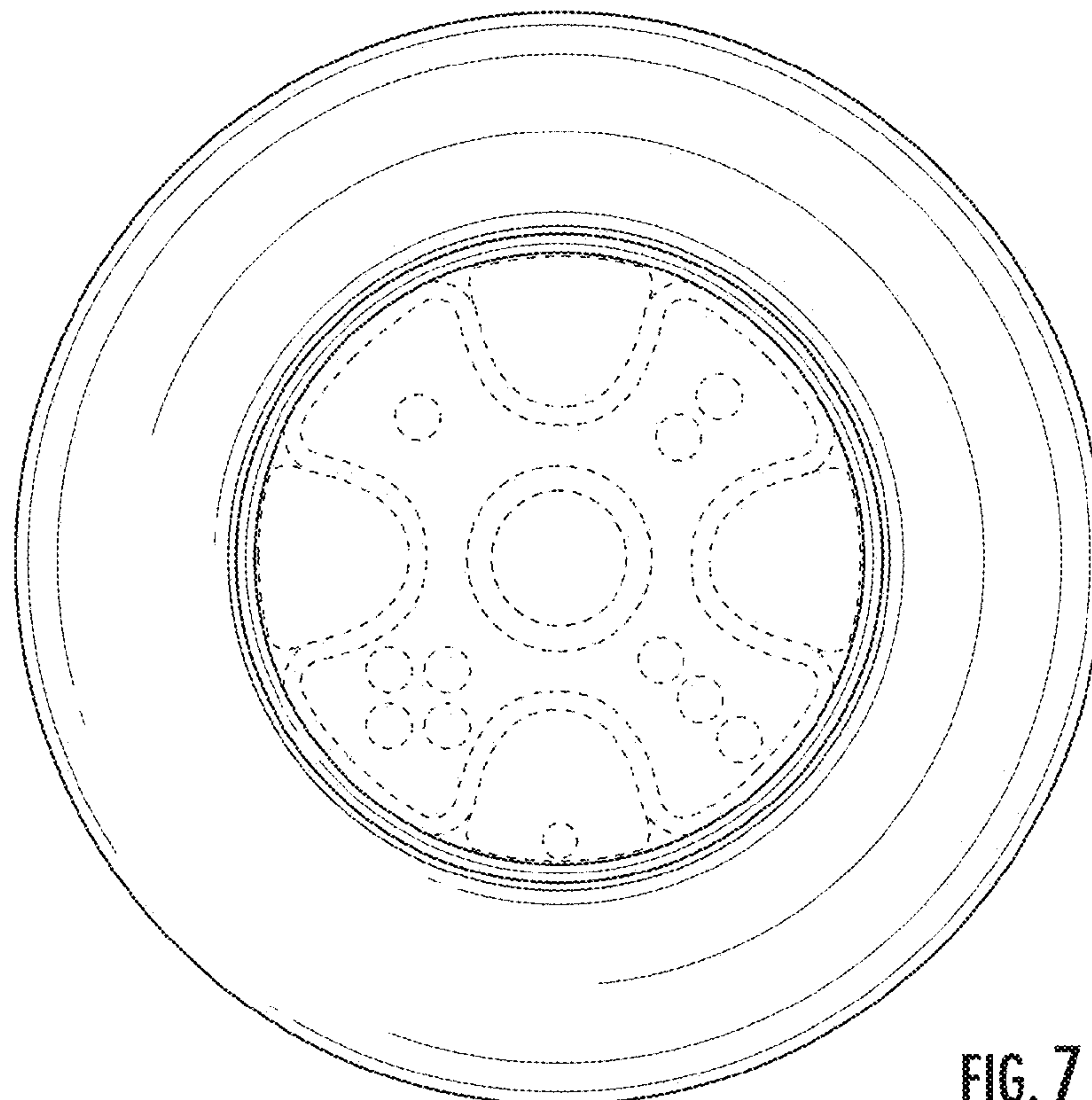
