FIG. 4 is a LEFT SIDE view of FIG. 1;

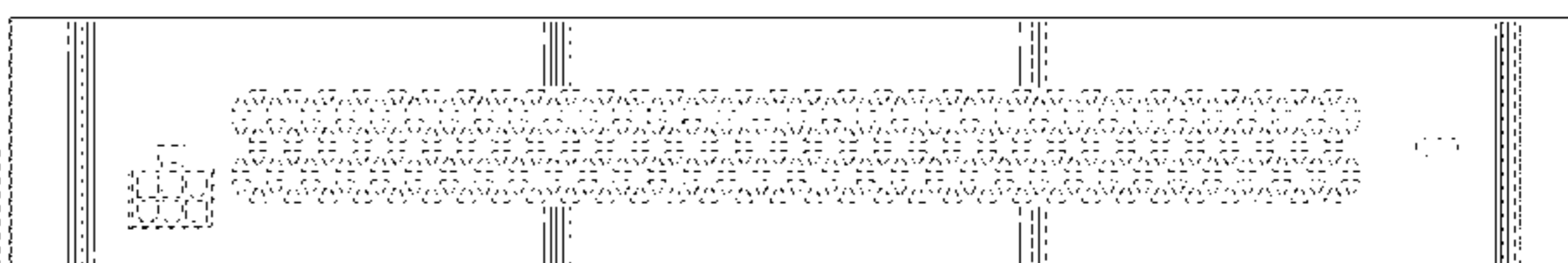
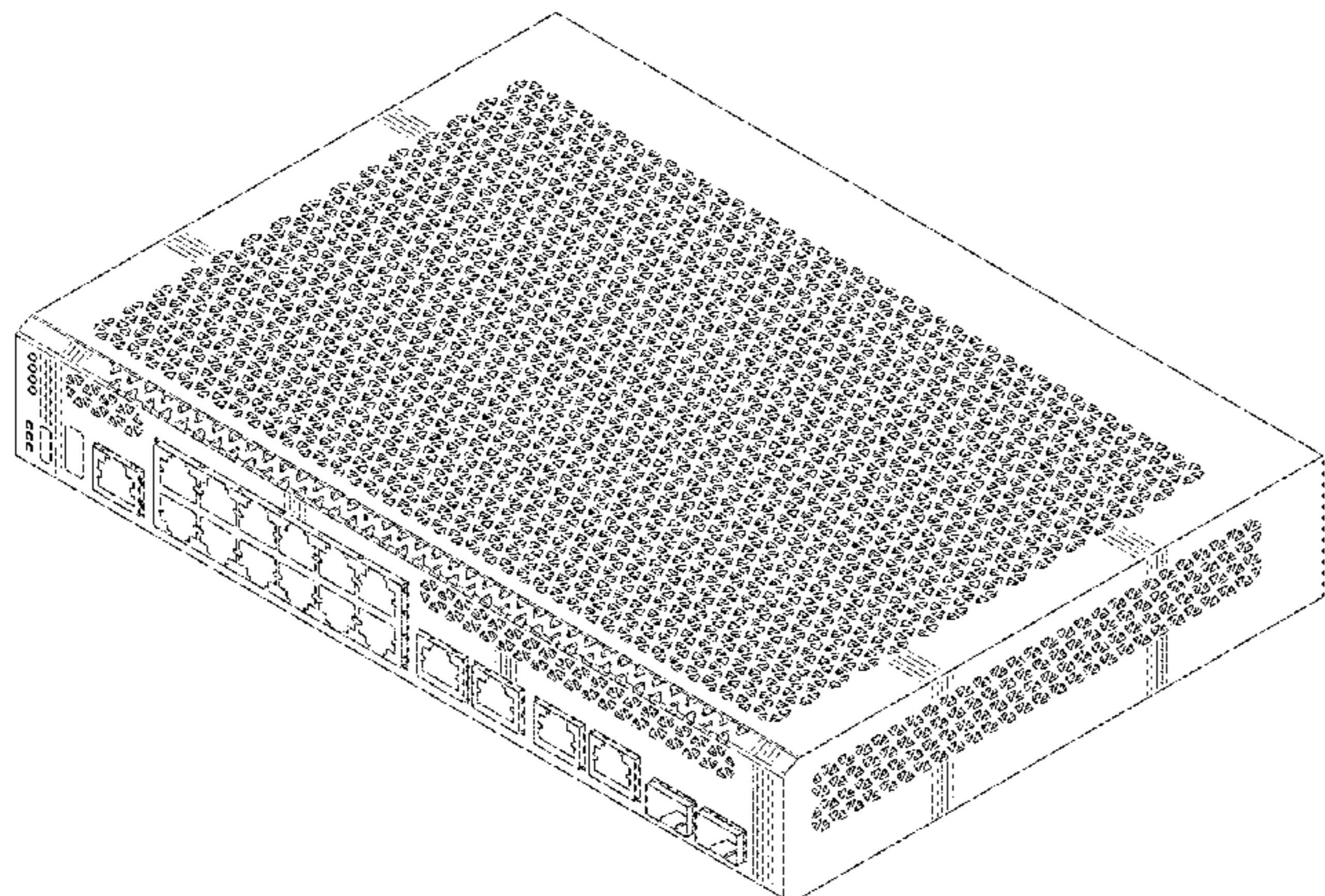
FIG. 5 is a RIGHT SIDE view of FIG. 1;

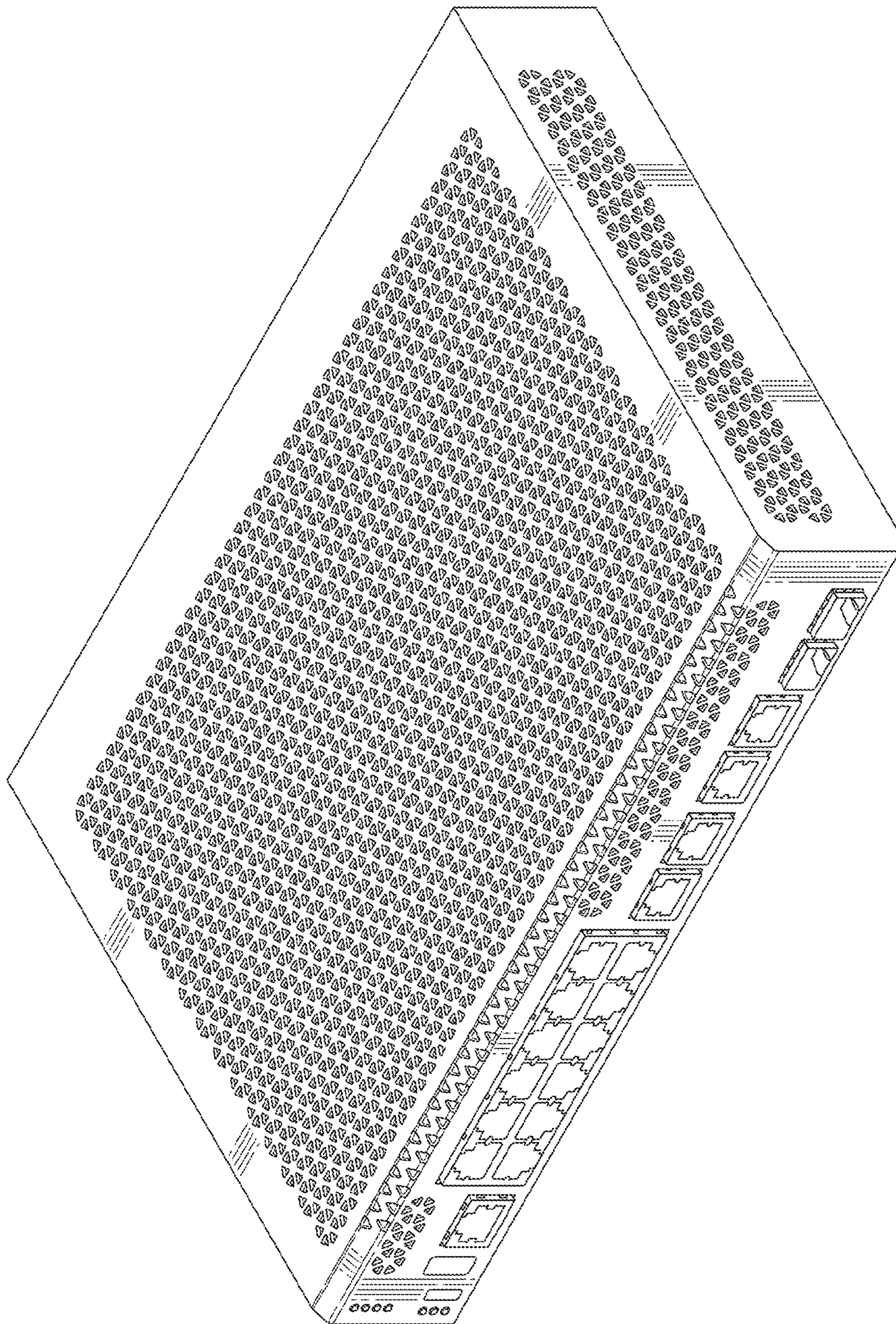

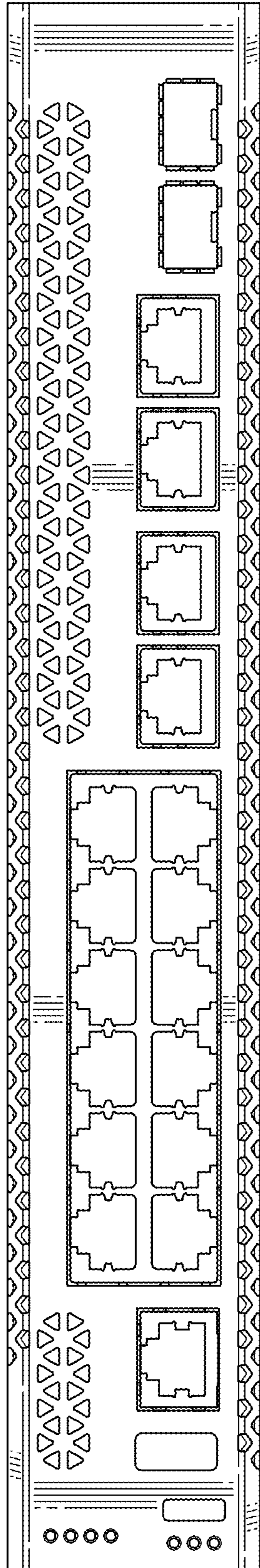

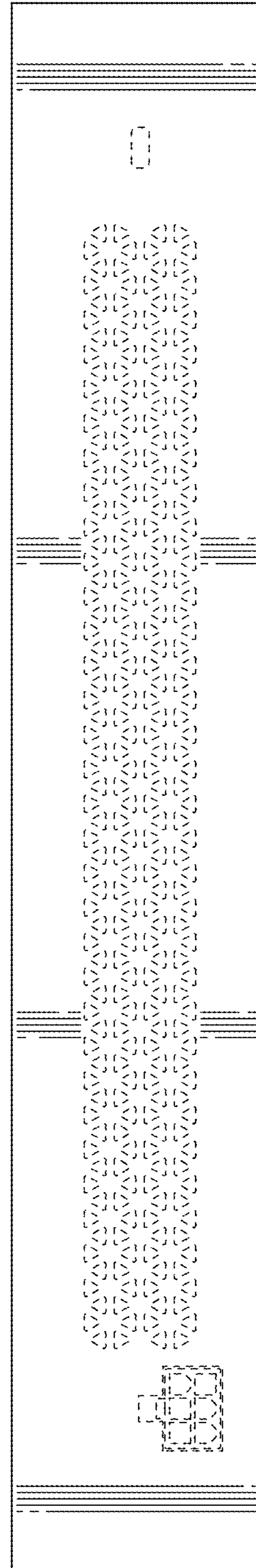

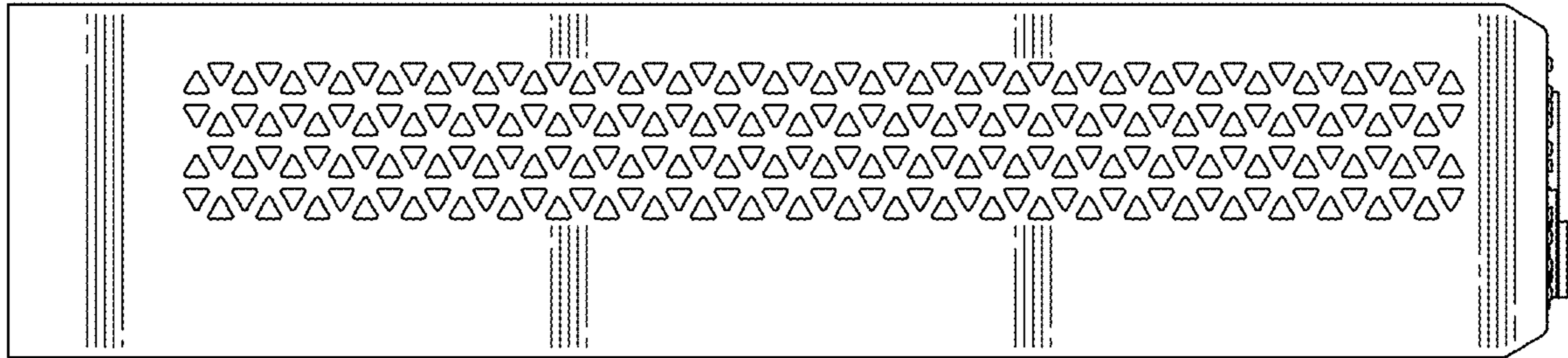

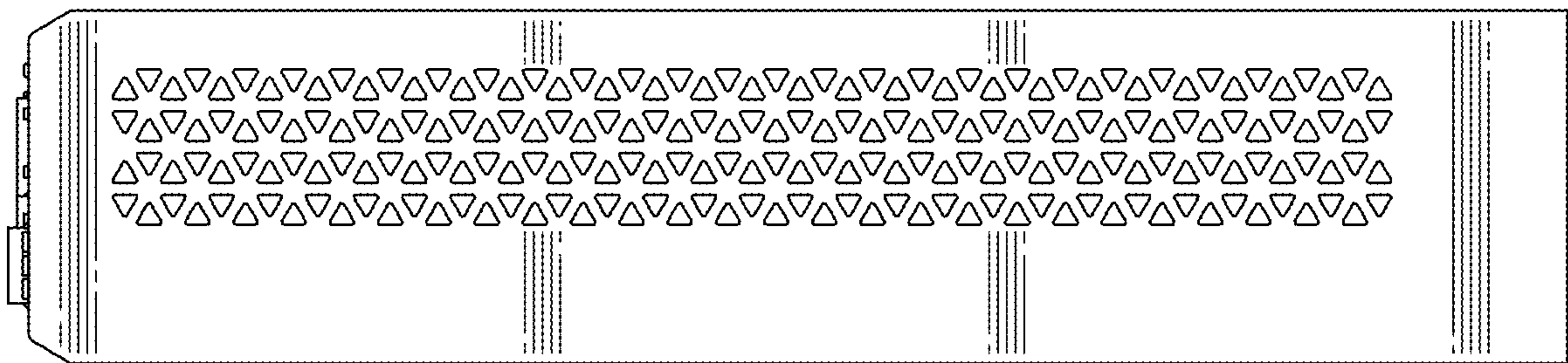

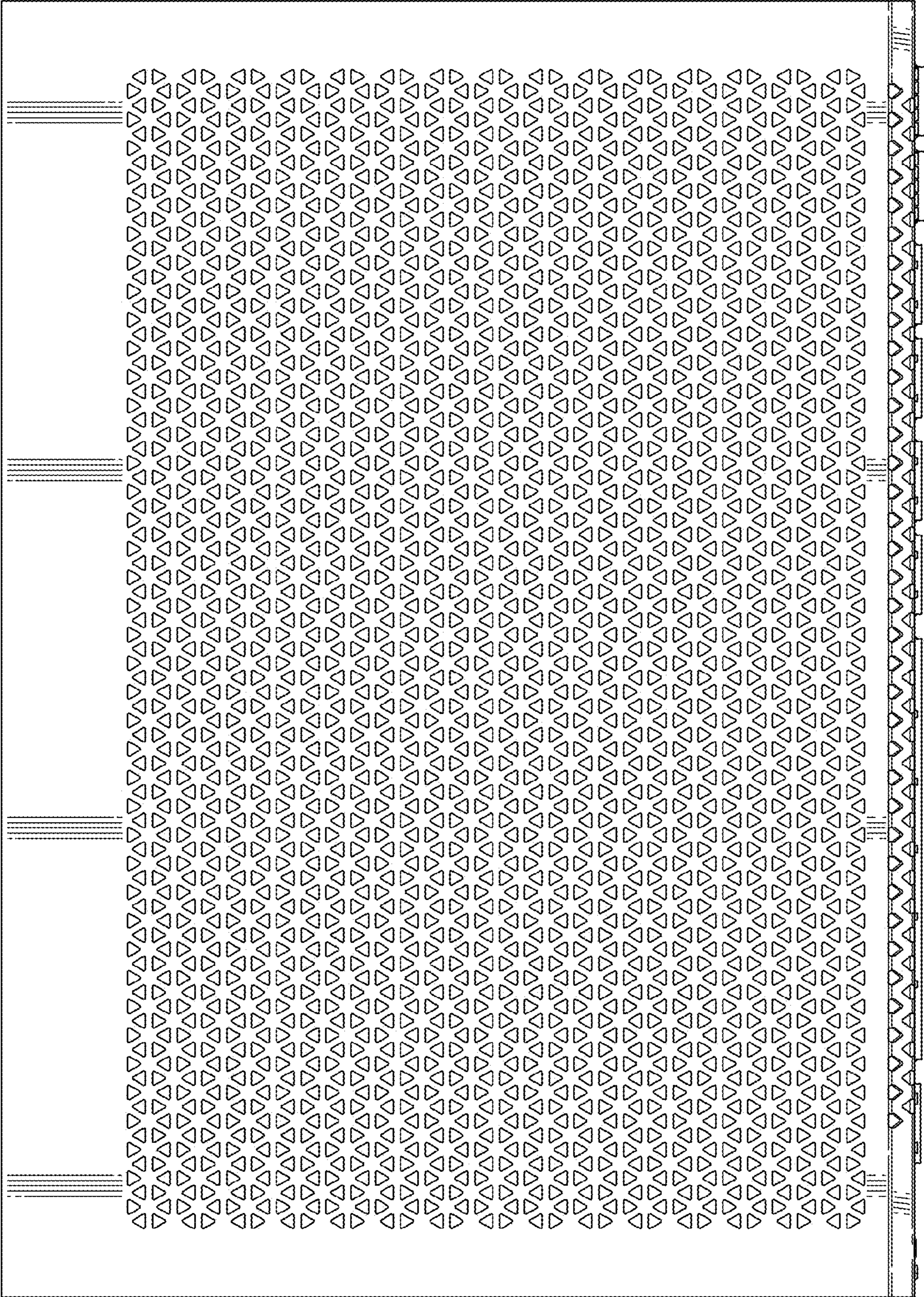

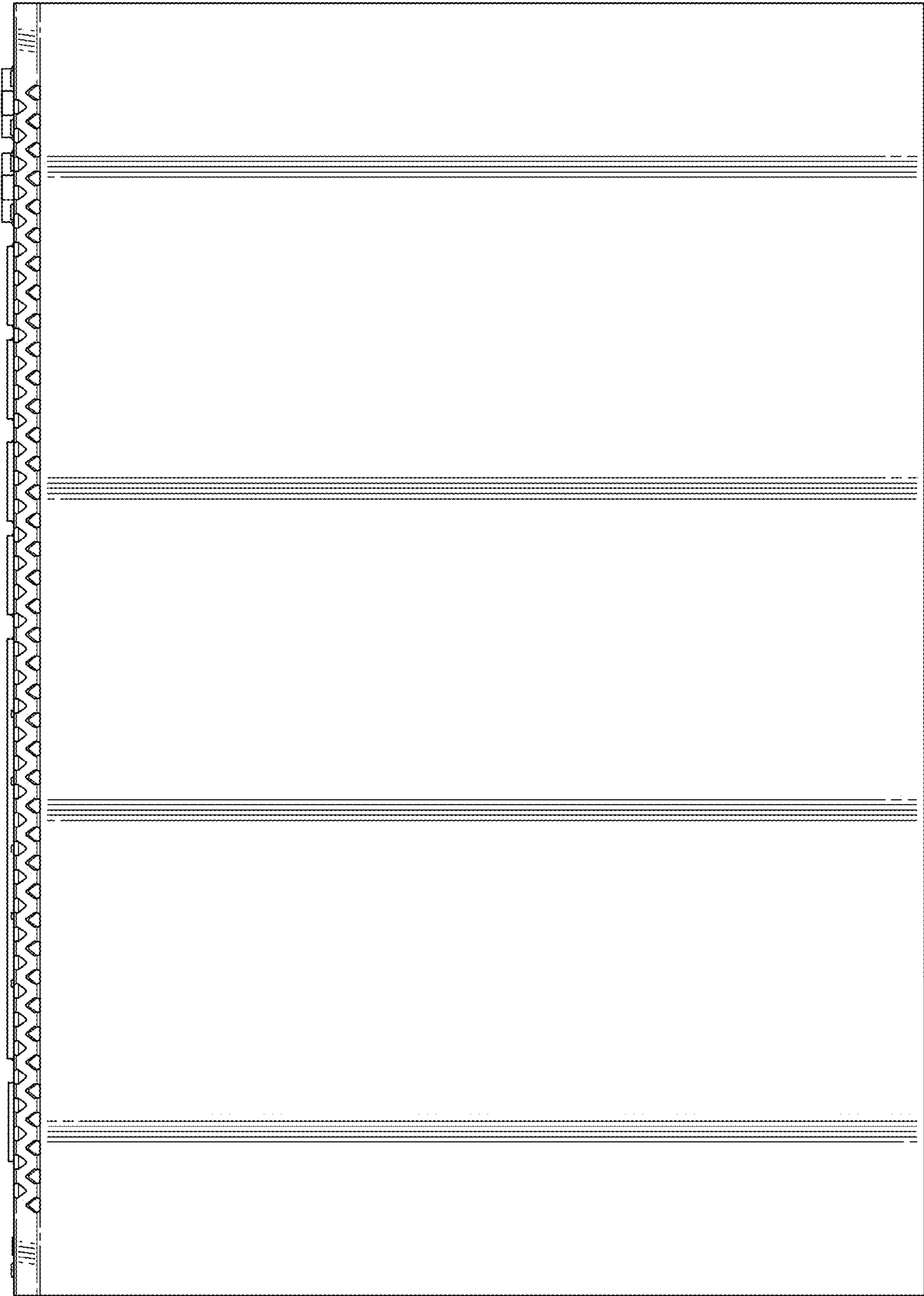
