FIG. 8 is a right side view thereof.

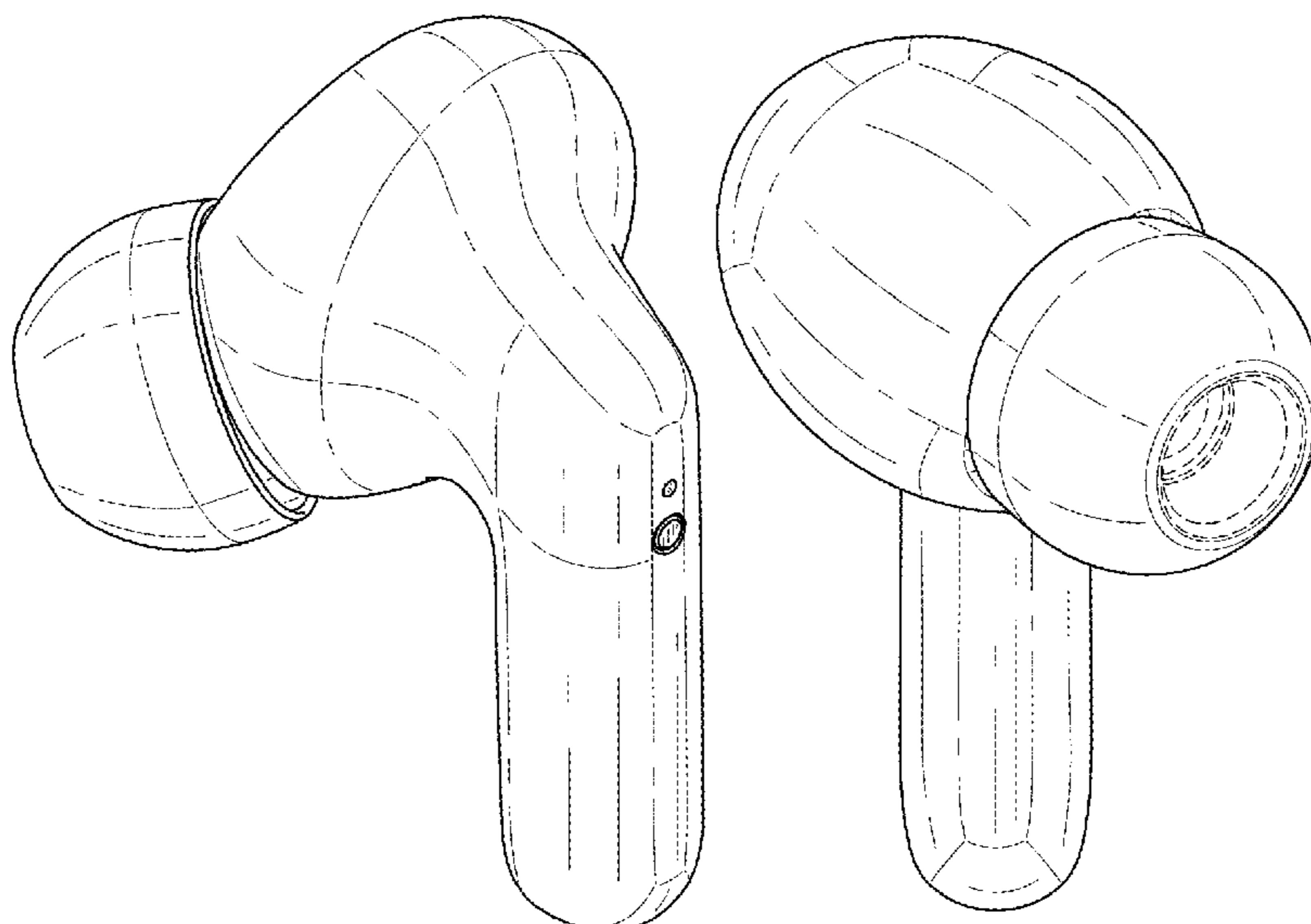
The broken lines in the drawings depict portions of the an earbud that form no part of the claimed design.

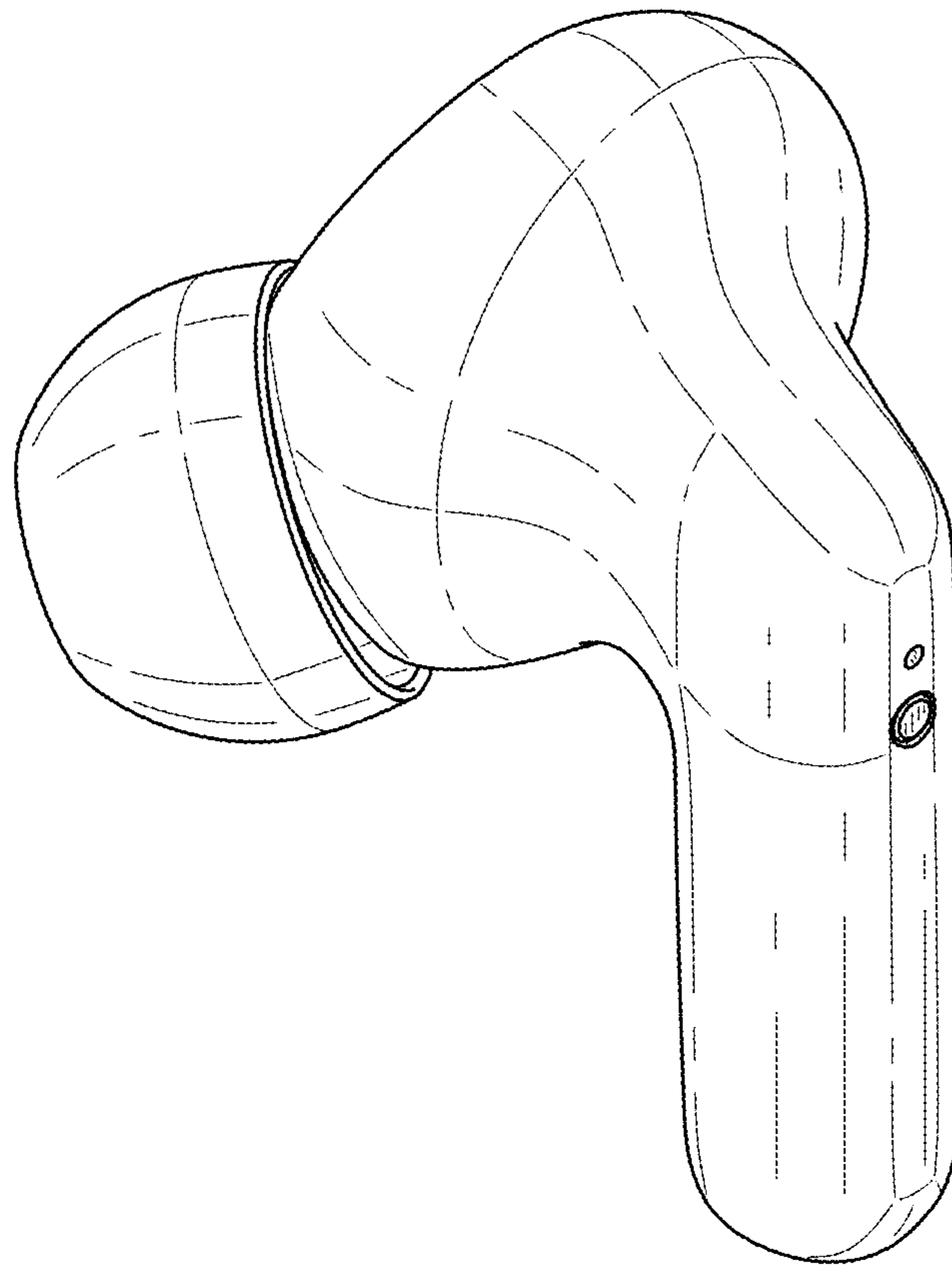

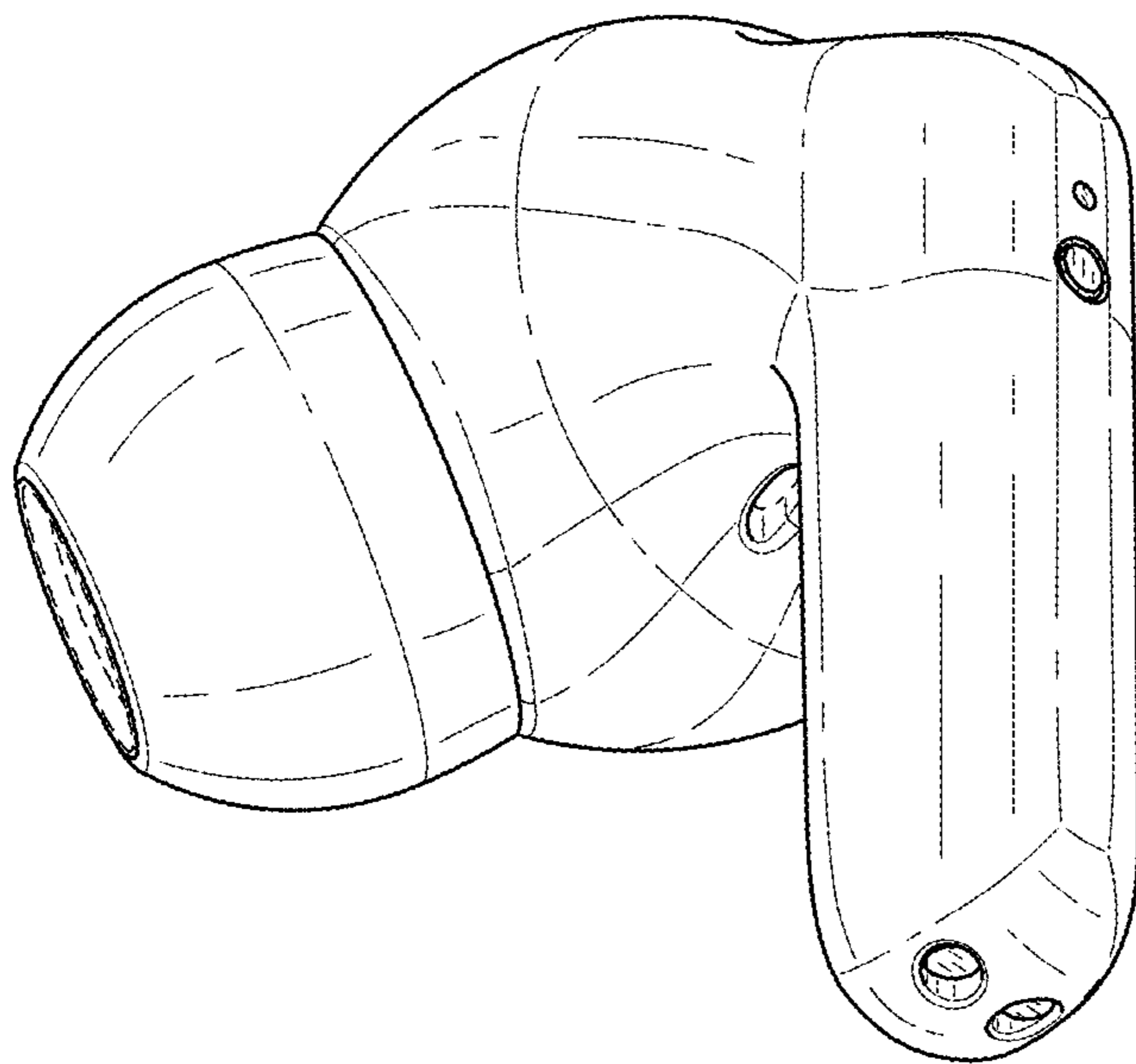

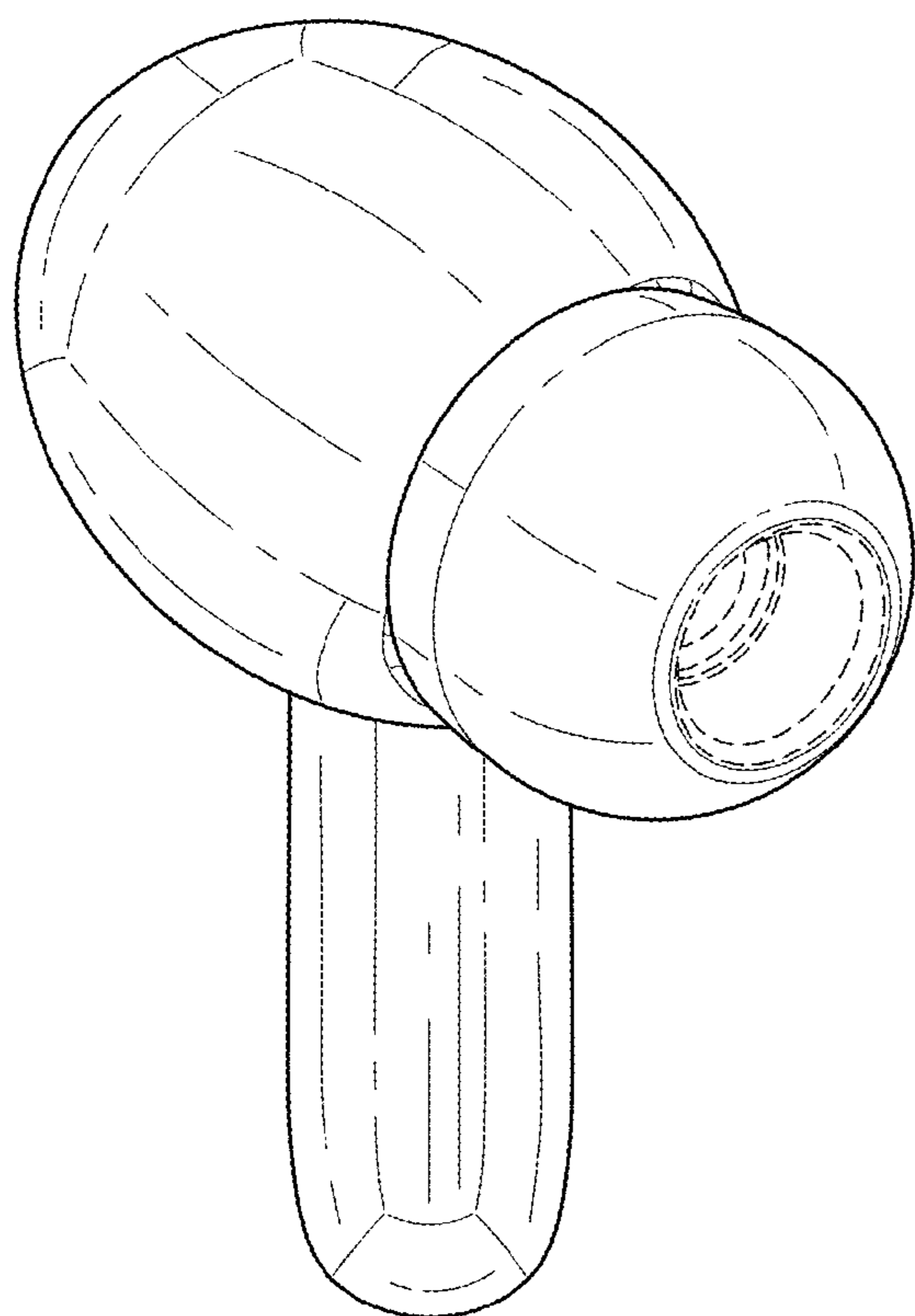

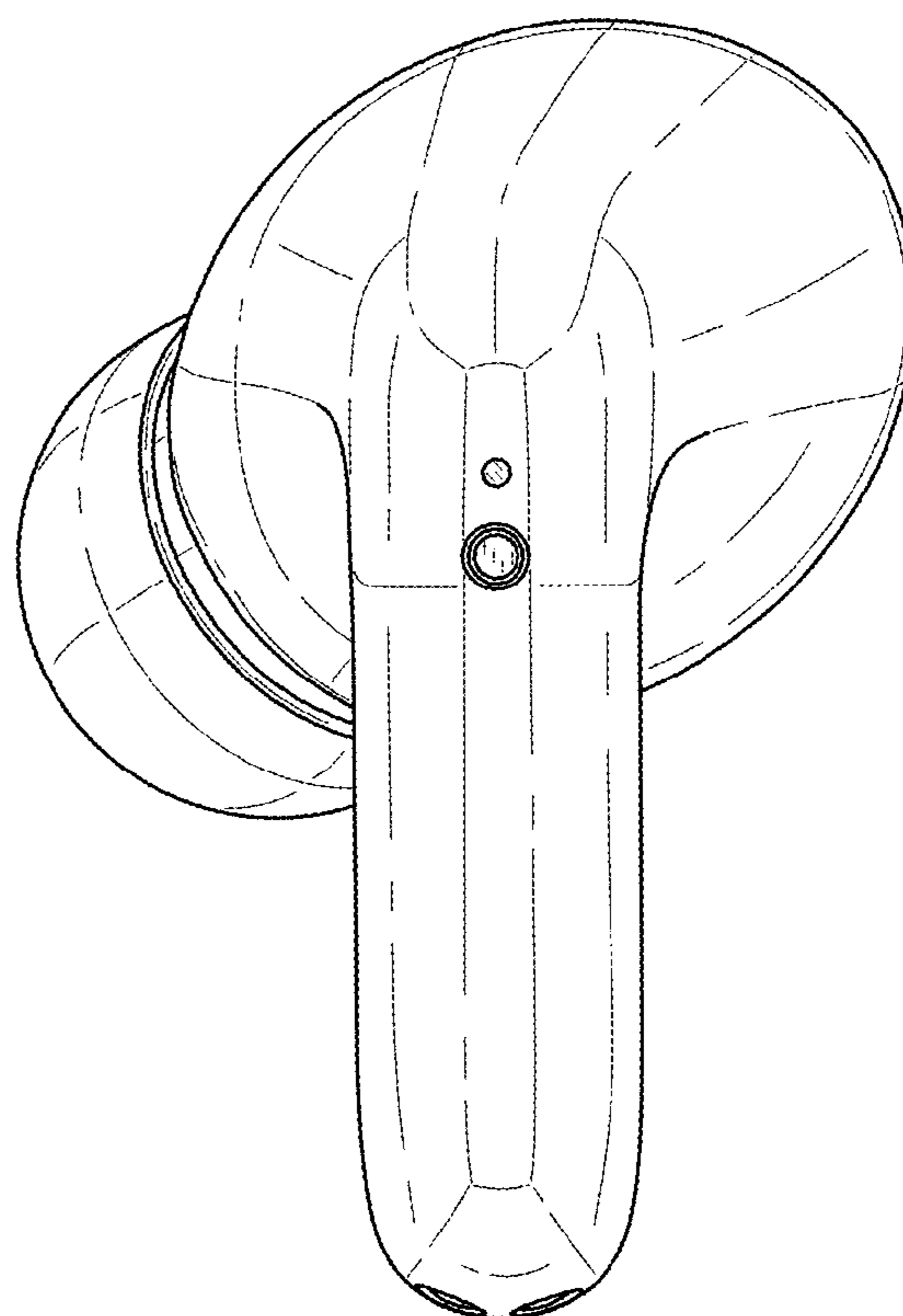

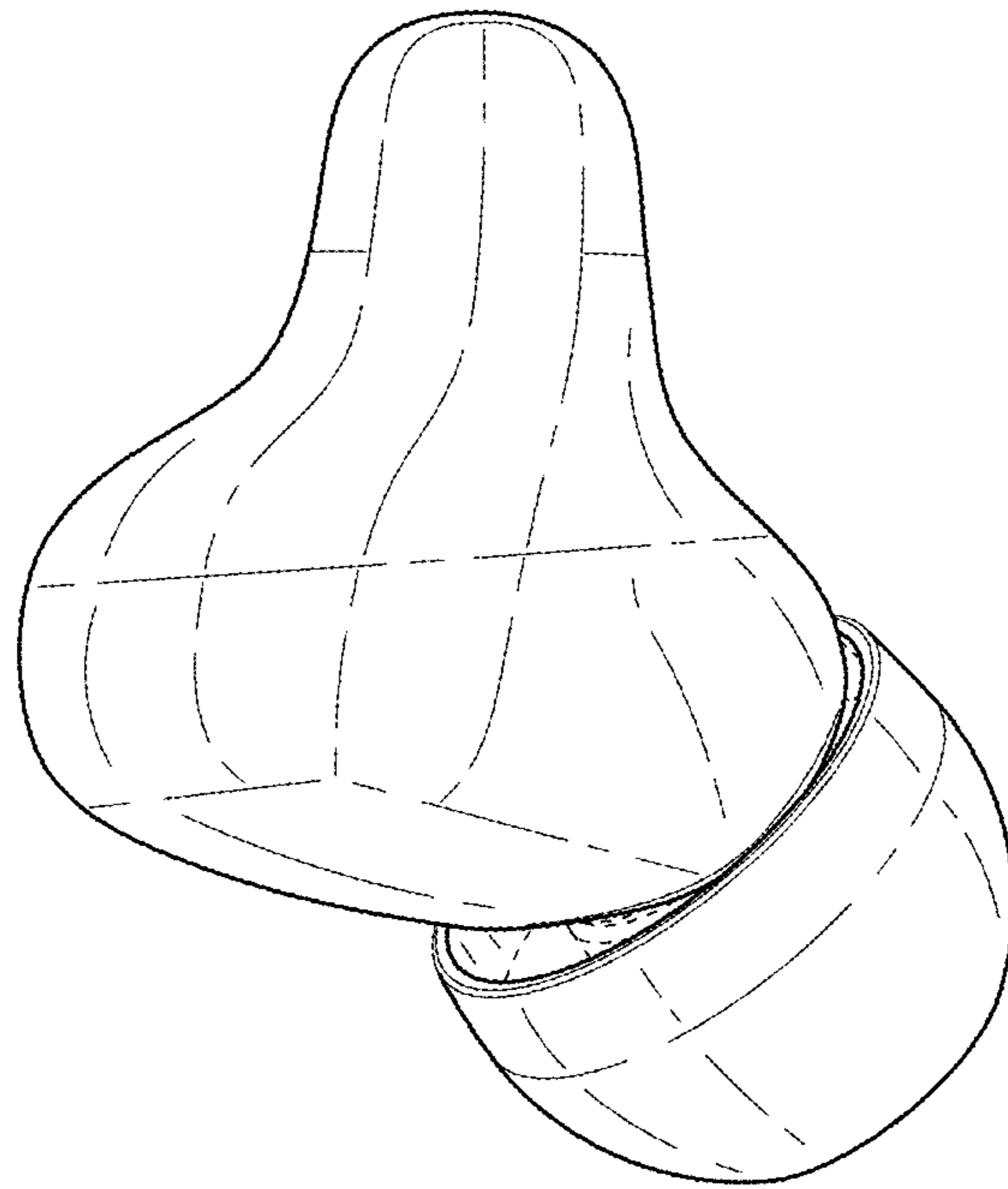

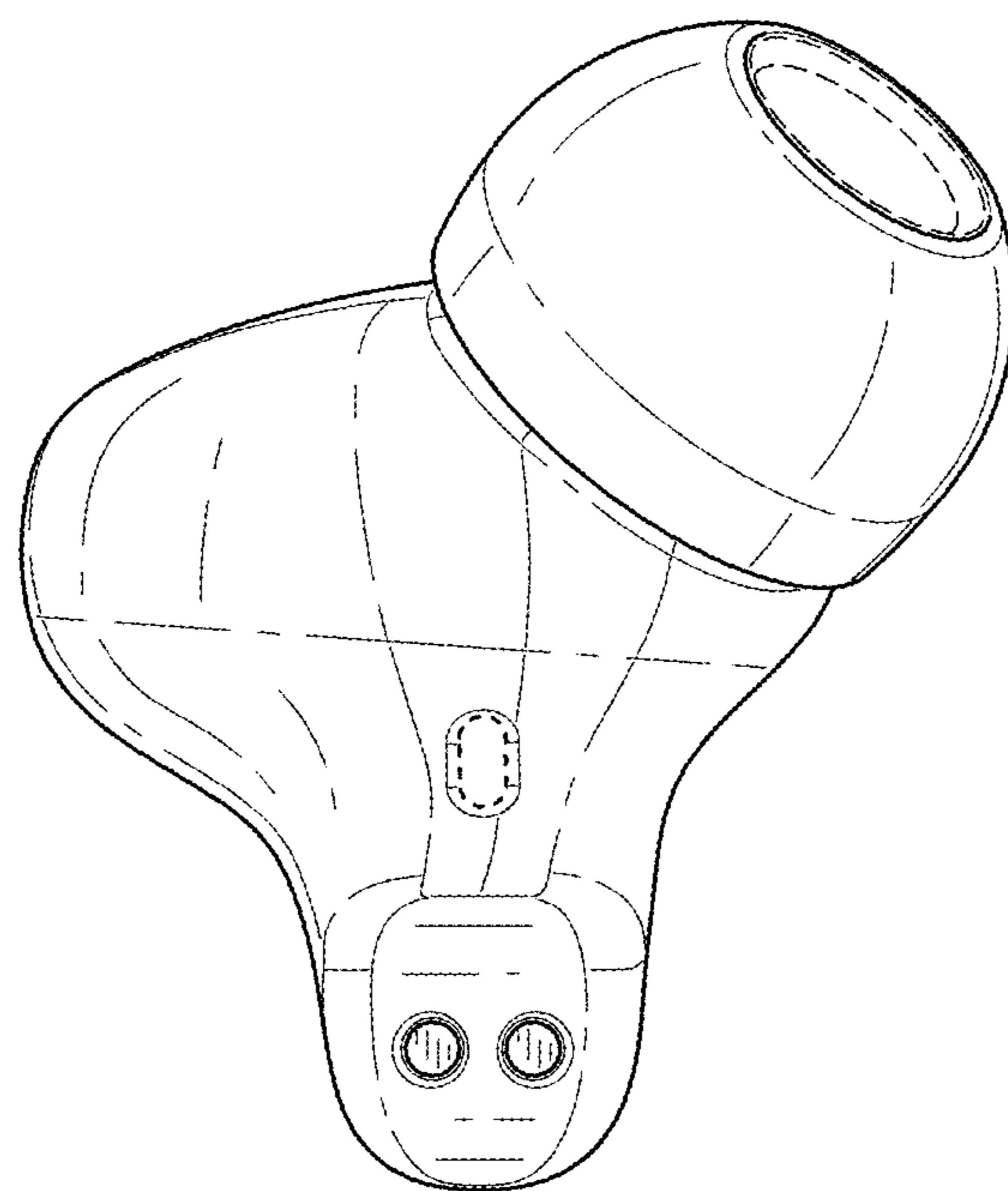

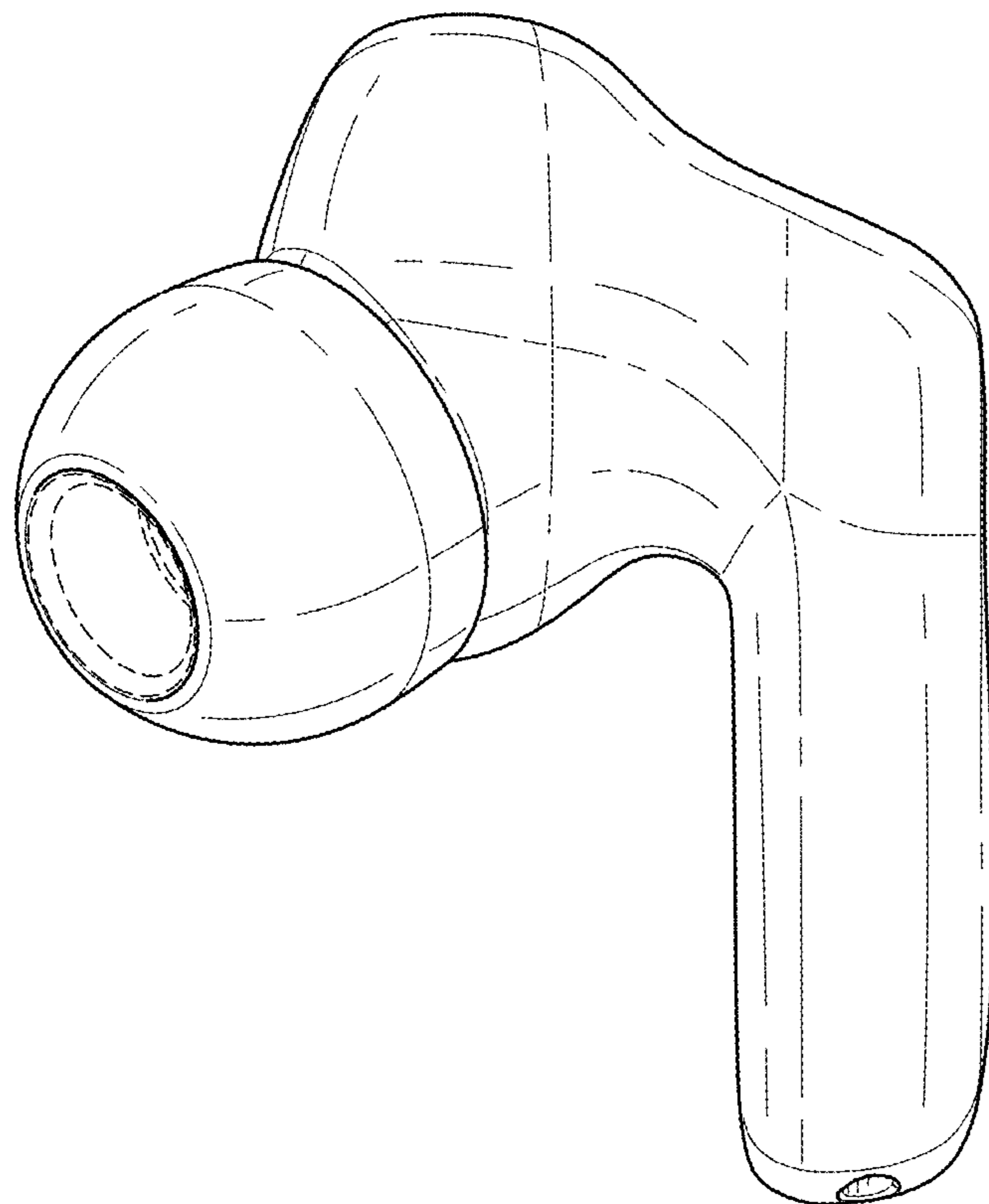
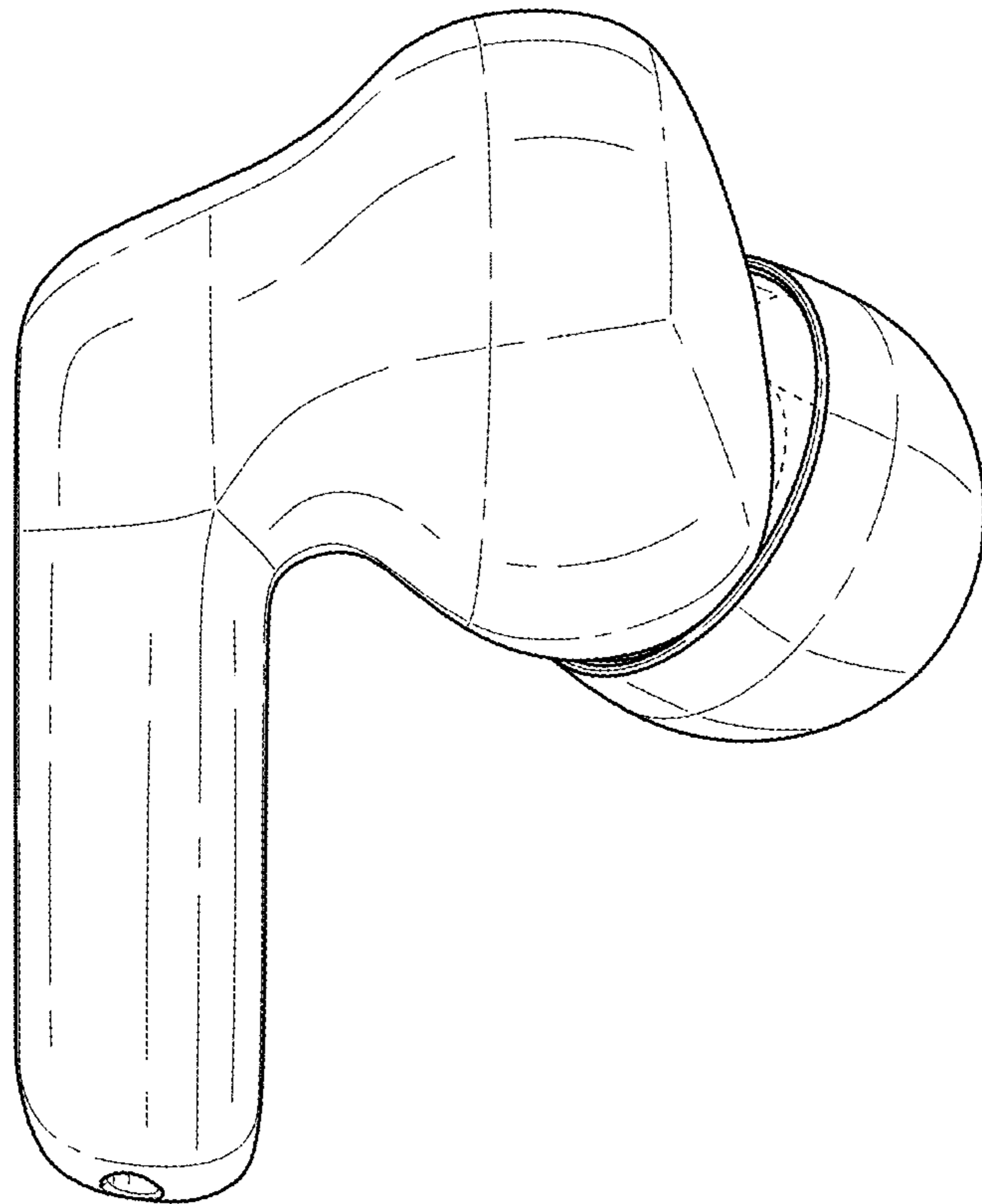
