The ornamental design for a wearable electronic device with transitional graphical user interface, as shown and described.

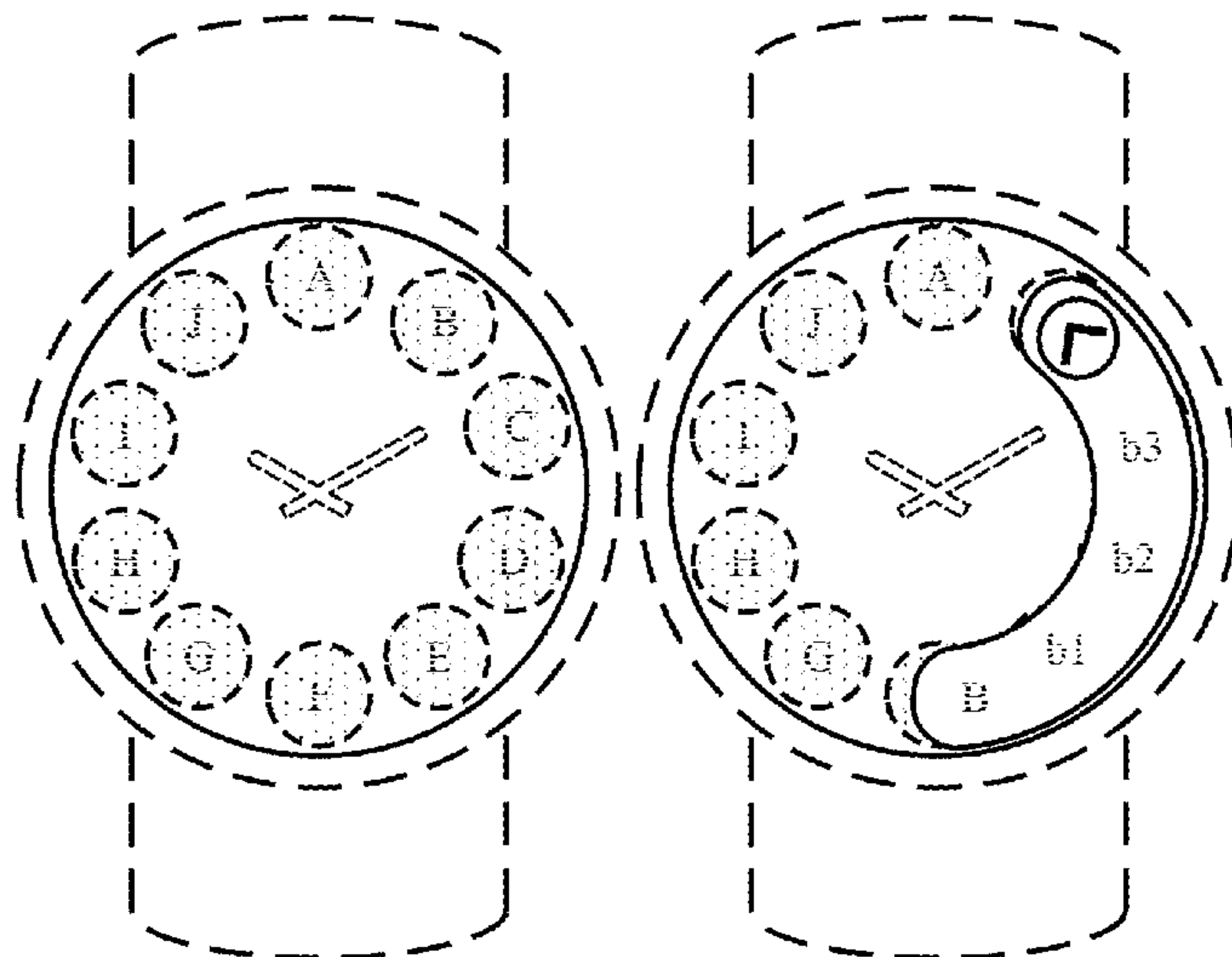
DESCRIPTION

FIG. 1 is a front view of a wearable electronic device with transitional graphical user interface showing a first image of a first embodiment of our new design;
FIG. 2 is a front view of the wearable electronic device with transitional graphical user interface showing a second image of the first embodiment;
FIG. 3 is a front view of the wearable electronic device with transitional graphical user interface showing the first image of a second embodiment;
FIG. 4 is a front view of the wearable electronic device with transitional graphical user interface showing the second image of the second embodiment;
FIG. 5 is a front view of the wearable electronic device with transitional graphical user interface showing the first image of a third embodiment; and,
FIG. 6 is a front view of the wearable electronic device with transitional graphical user interface showing the second image of the third embodiment.

In the first embodiment, the appearance of the transitional graphic user interface sequentially transitions between the images shown in FIGS. 1-2. In the second embodiment, the appearance of the transitional graphical user interface sequentially transitions between the images shown in FIGS. 3-4. In the third embodiment, the appearance of the transitional graphical user interface sequentially transitions between the images shown in FIGS. 5-6.

The ornamental design which is claimed is shown in solid lines in the drawings. The broken lines illustrating portions of the wearable electronic device with transitional graphical user interface, including all text within the graphical user interface and all dotted shading, illustrate portions of the article that form no part of the claimed design.

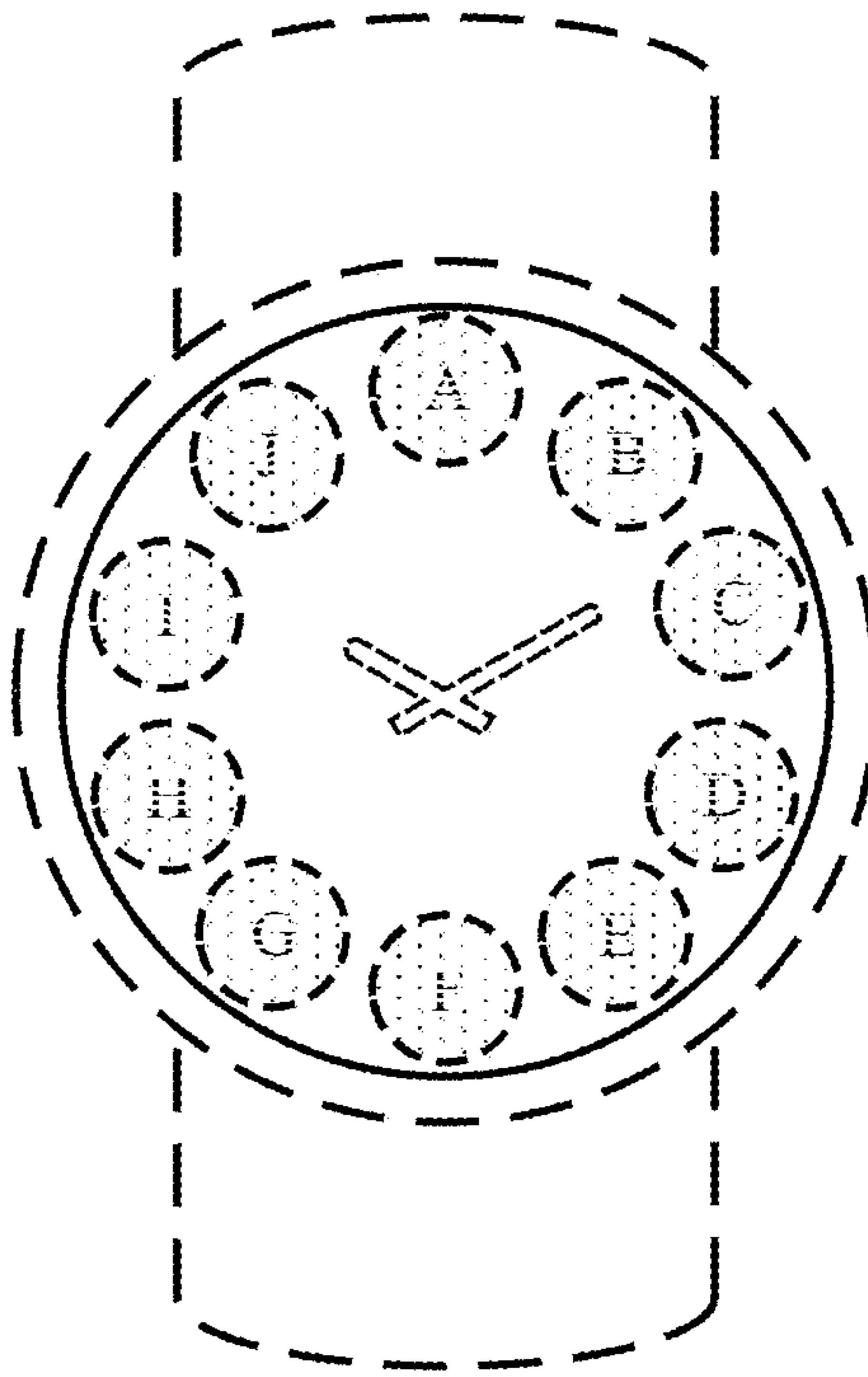

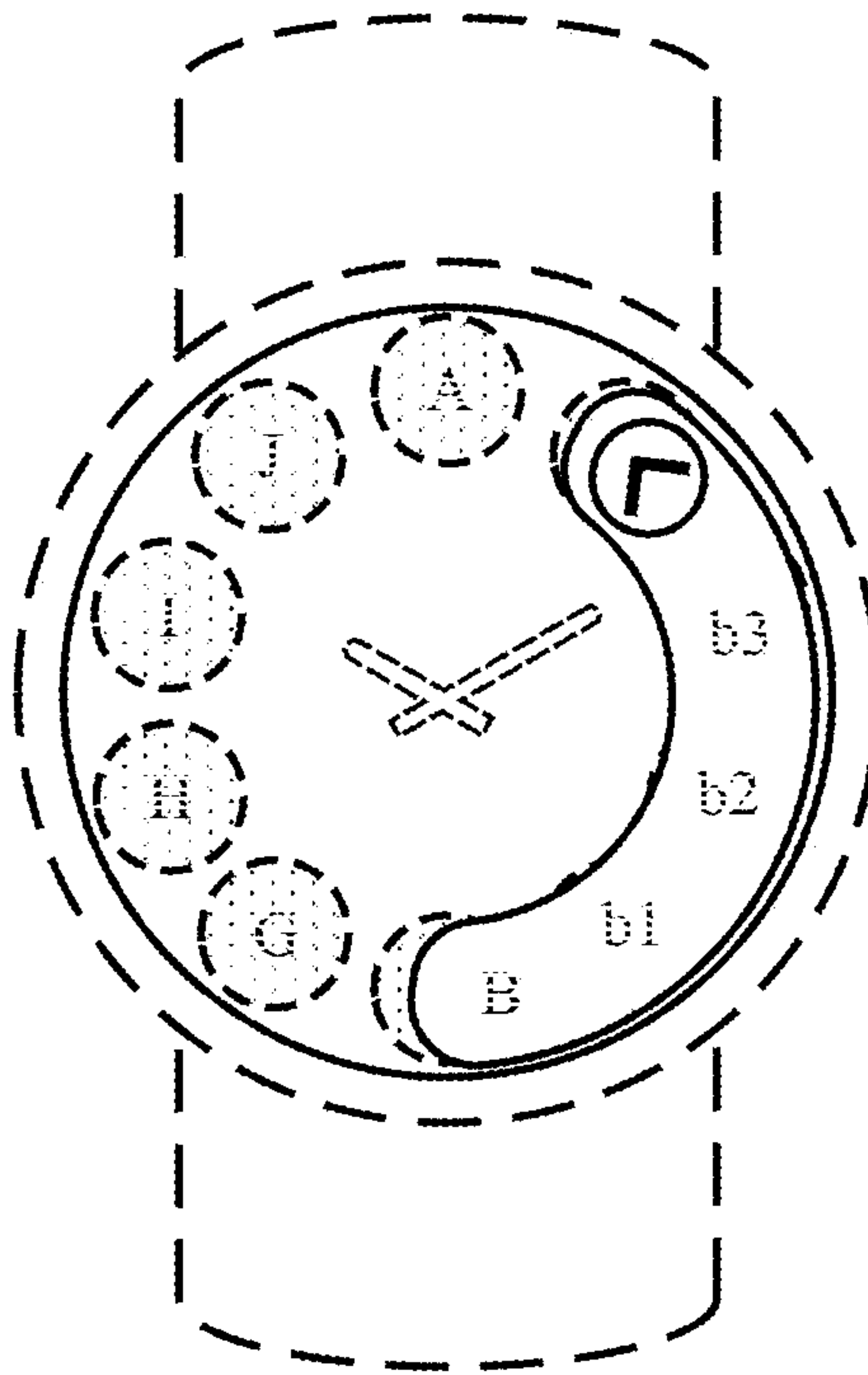

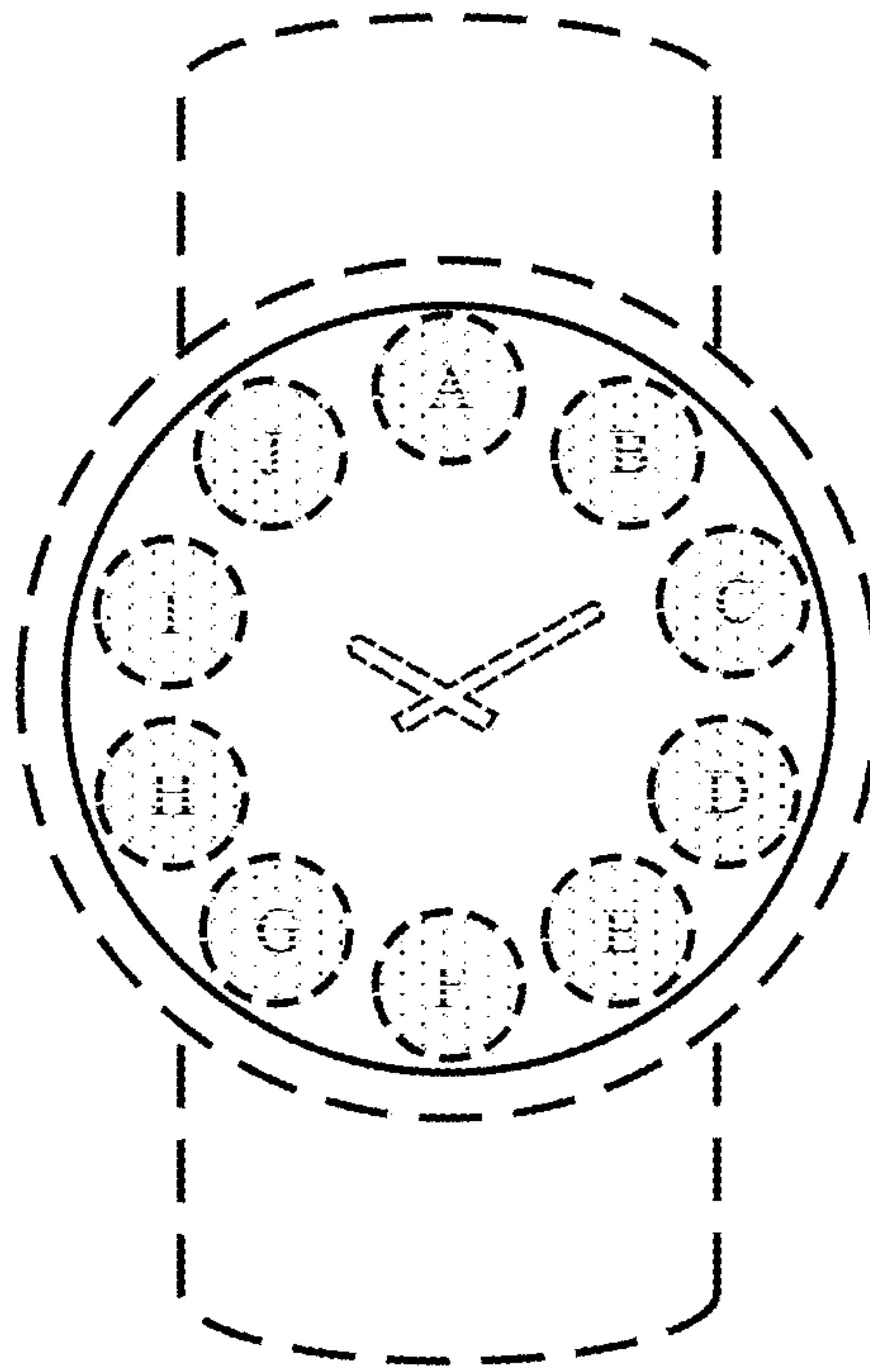

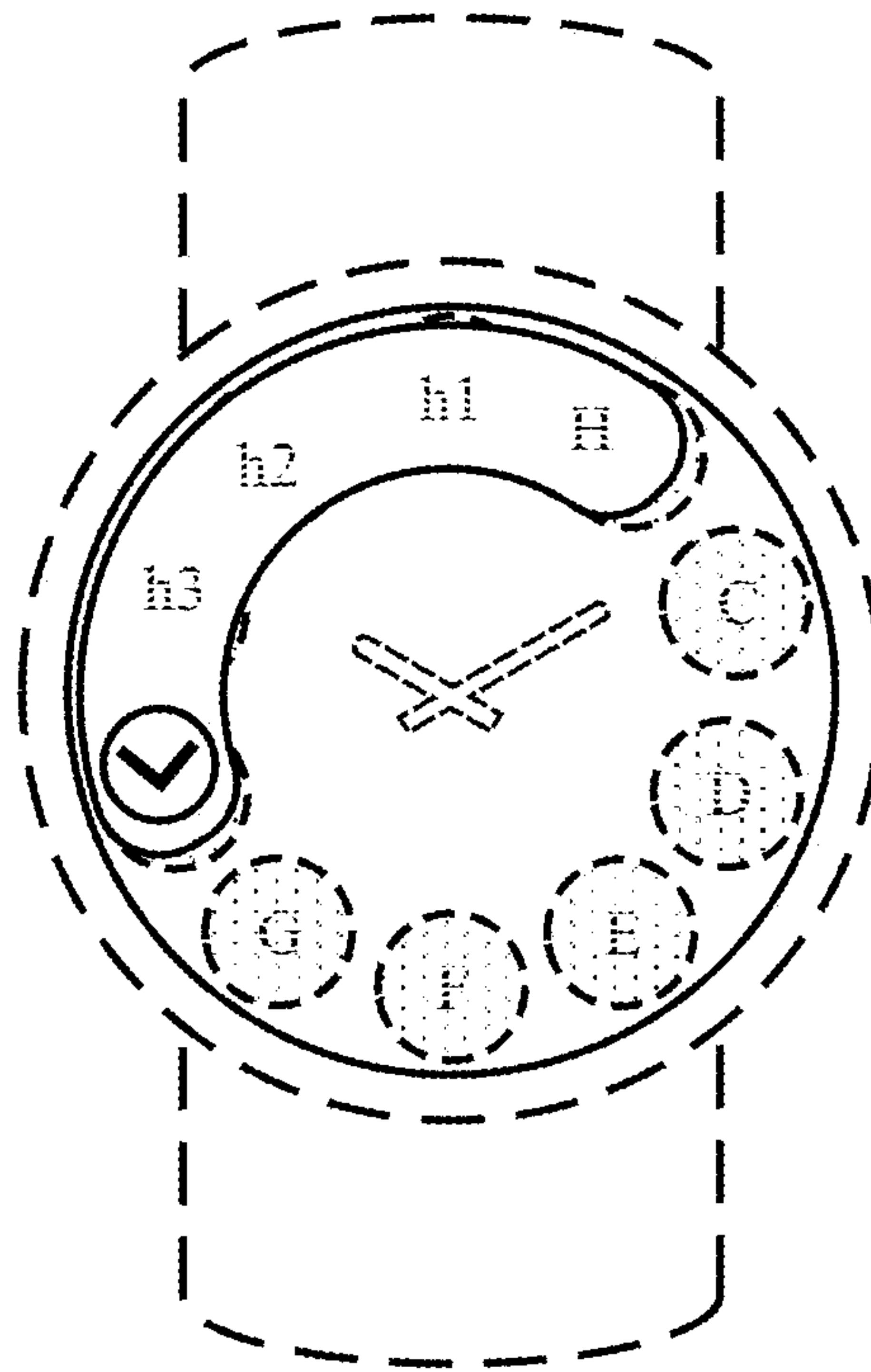

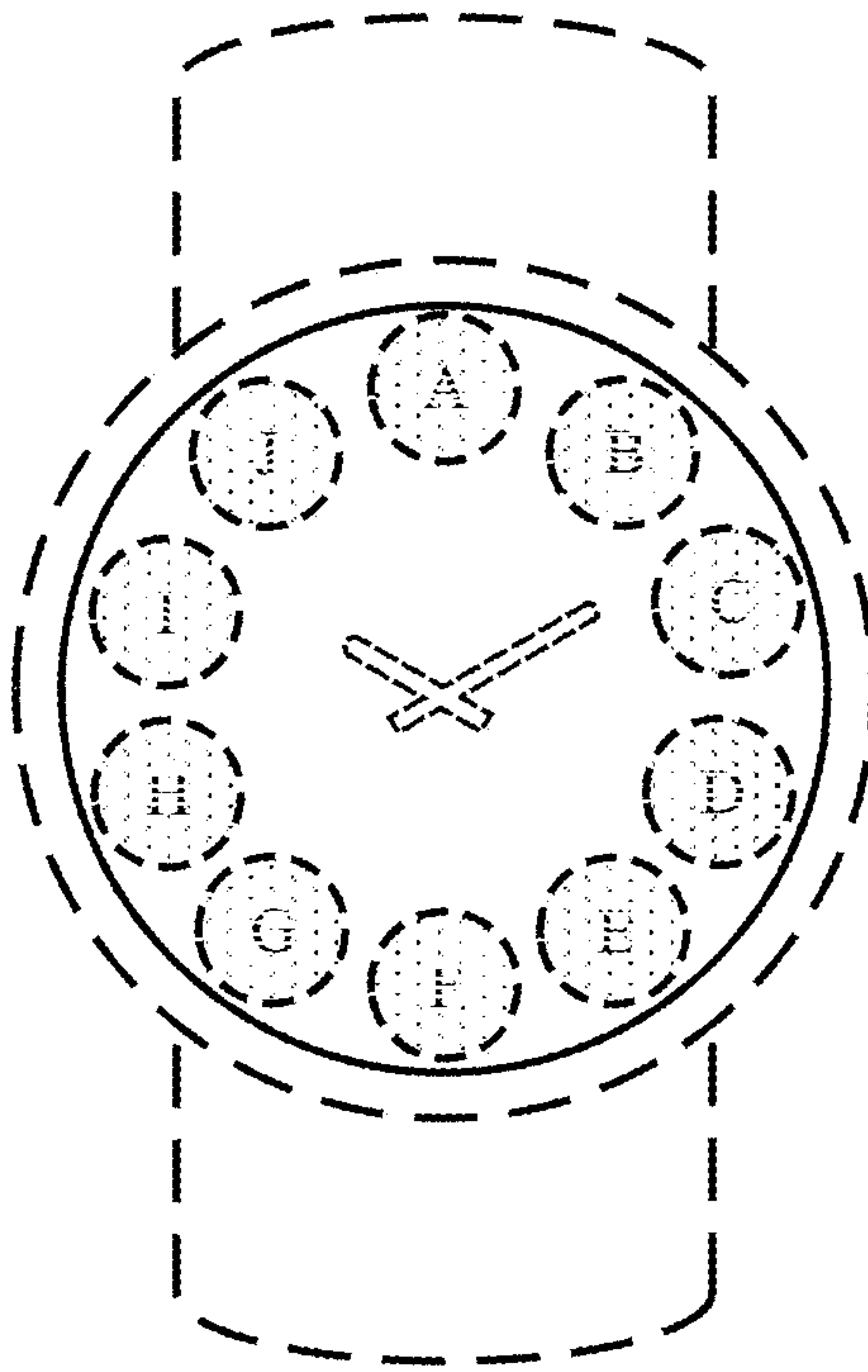

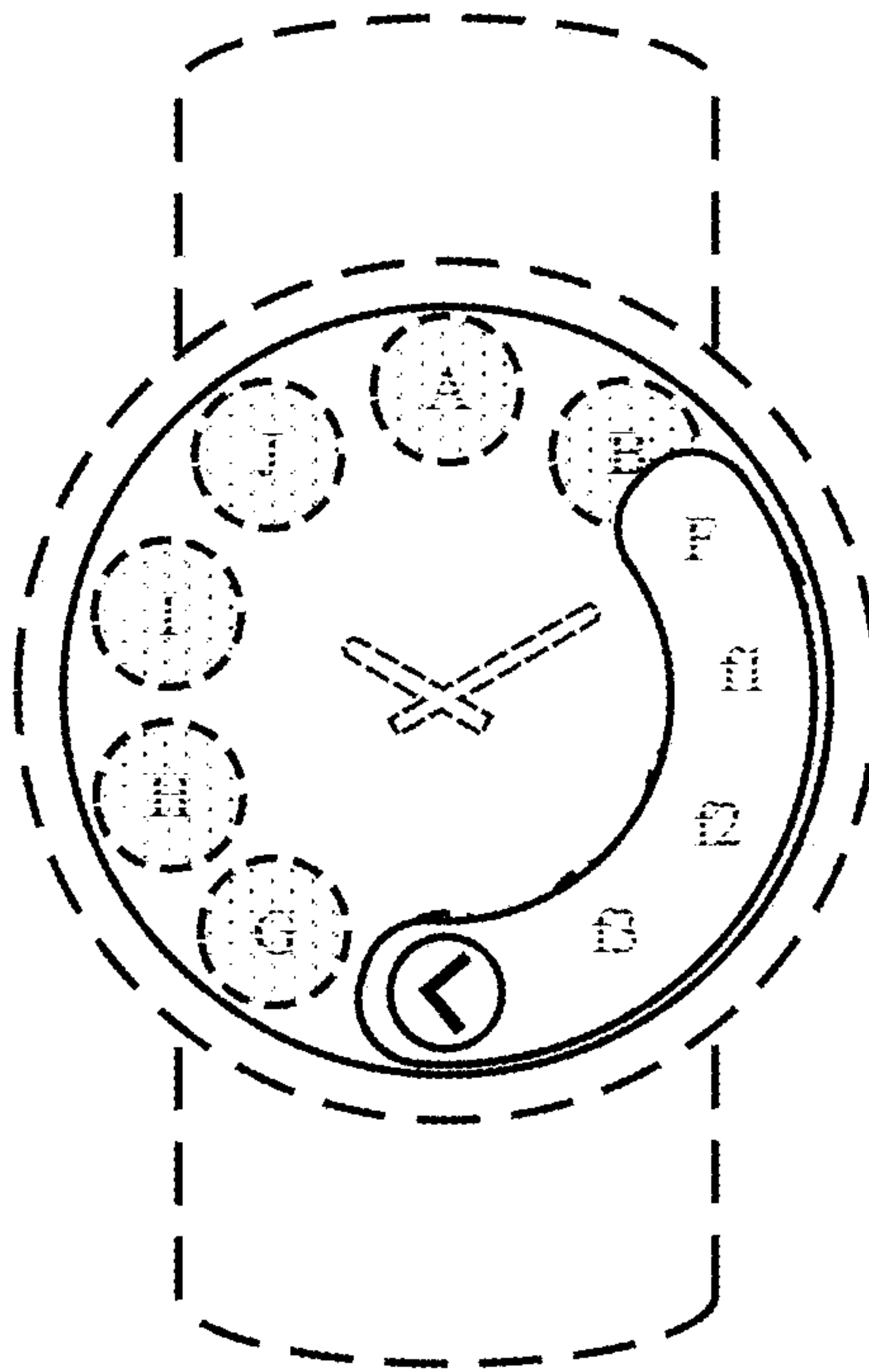
