FIG. 6 is a left side view of the agricultural planter;

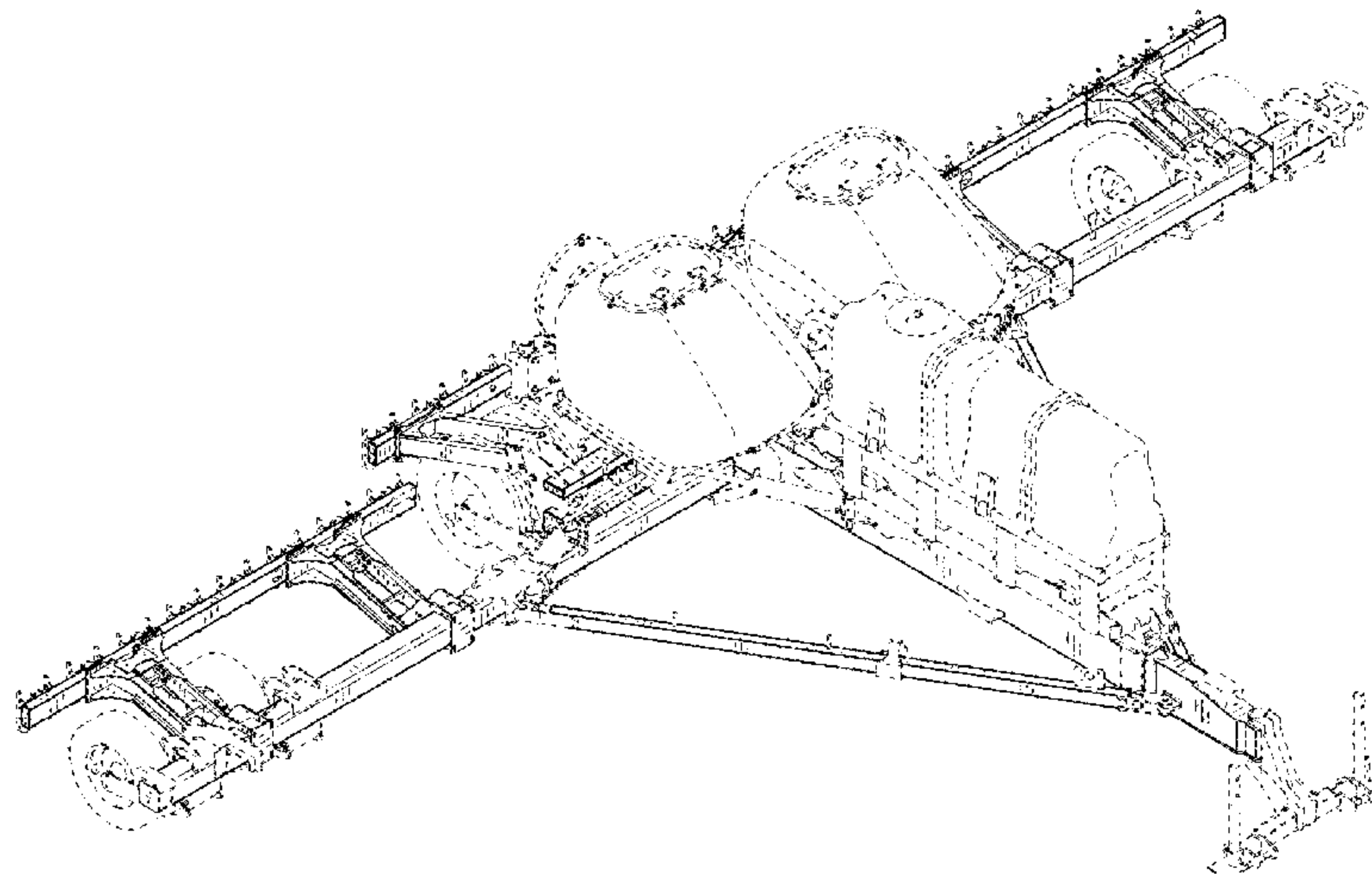
FIG. 7 is a top view of the agricultural planter;

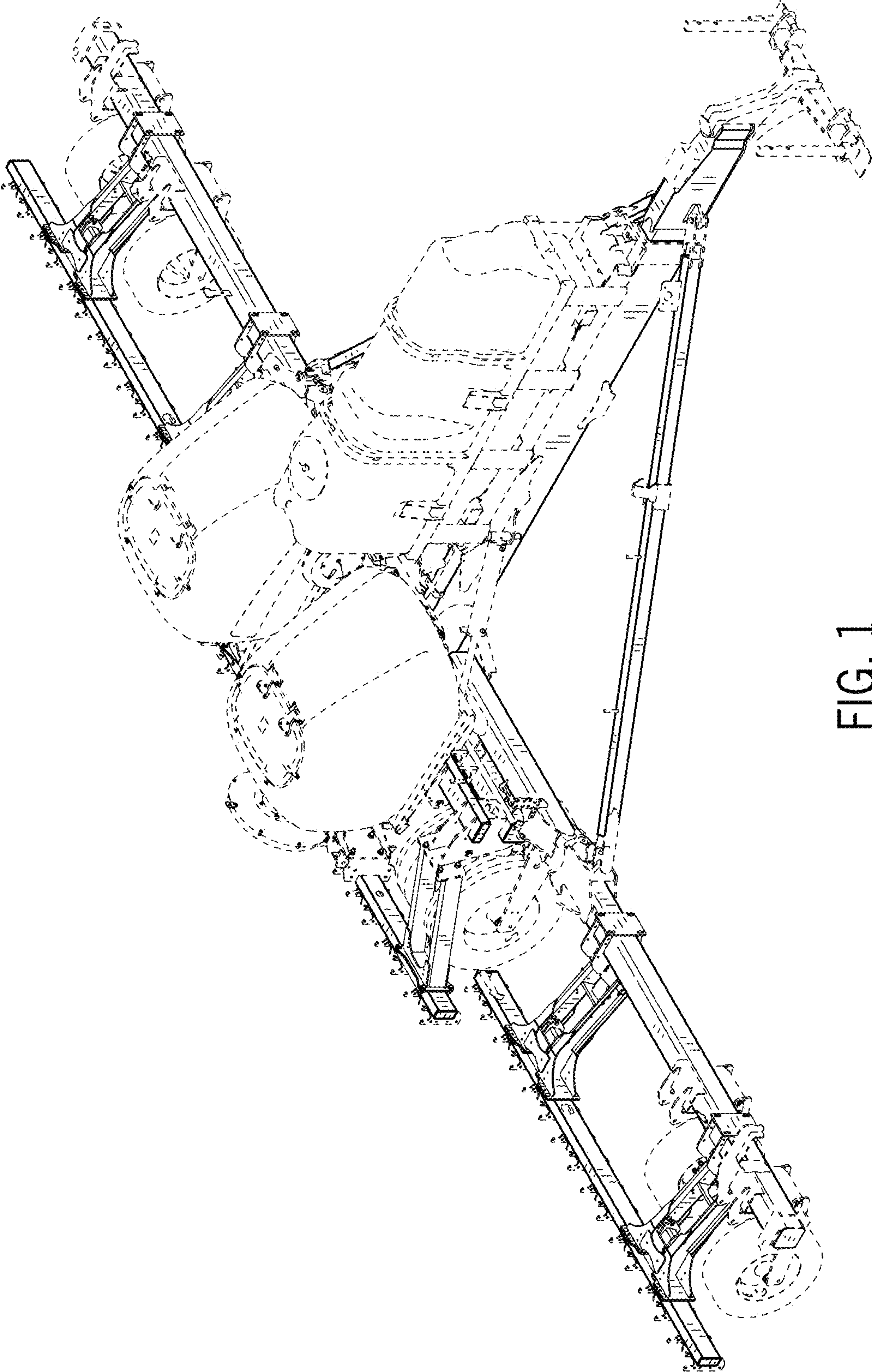

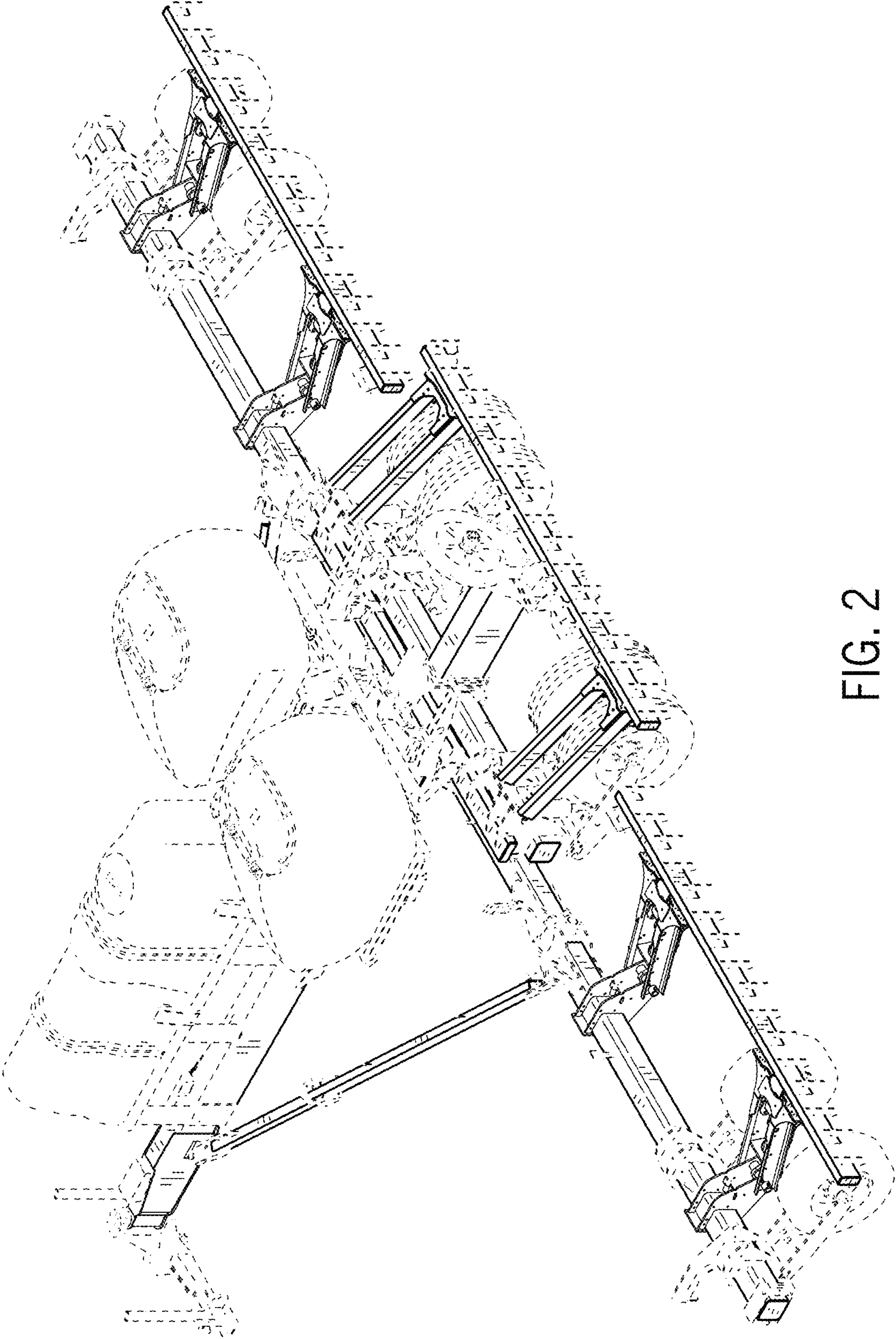

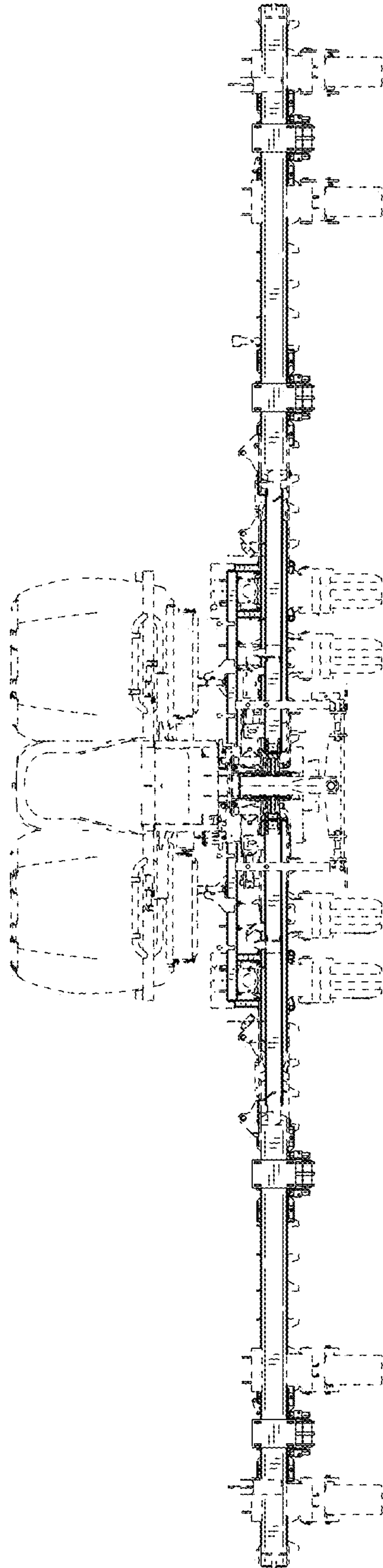

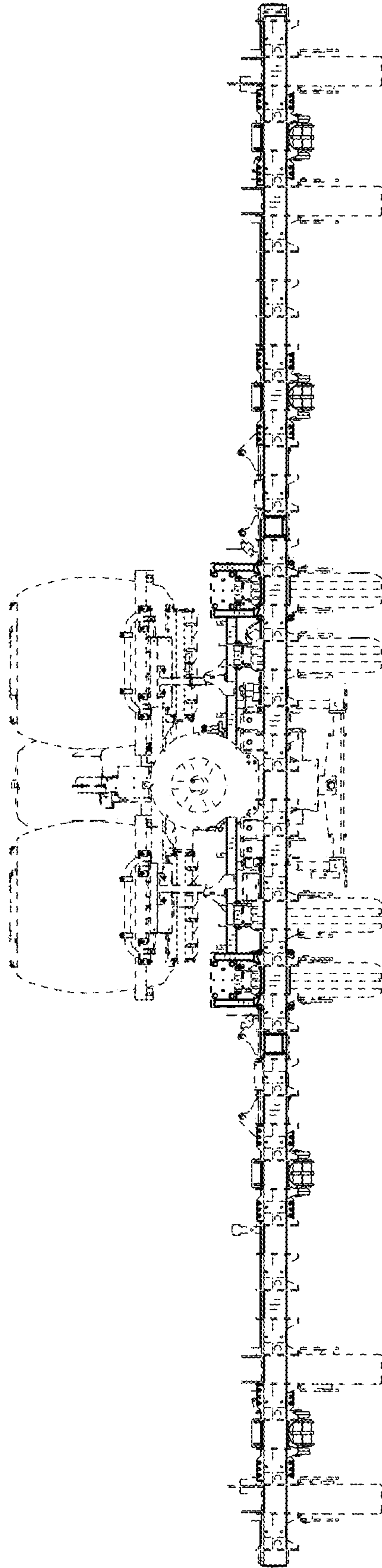

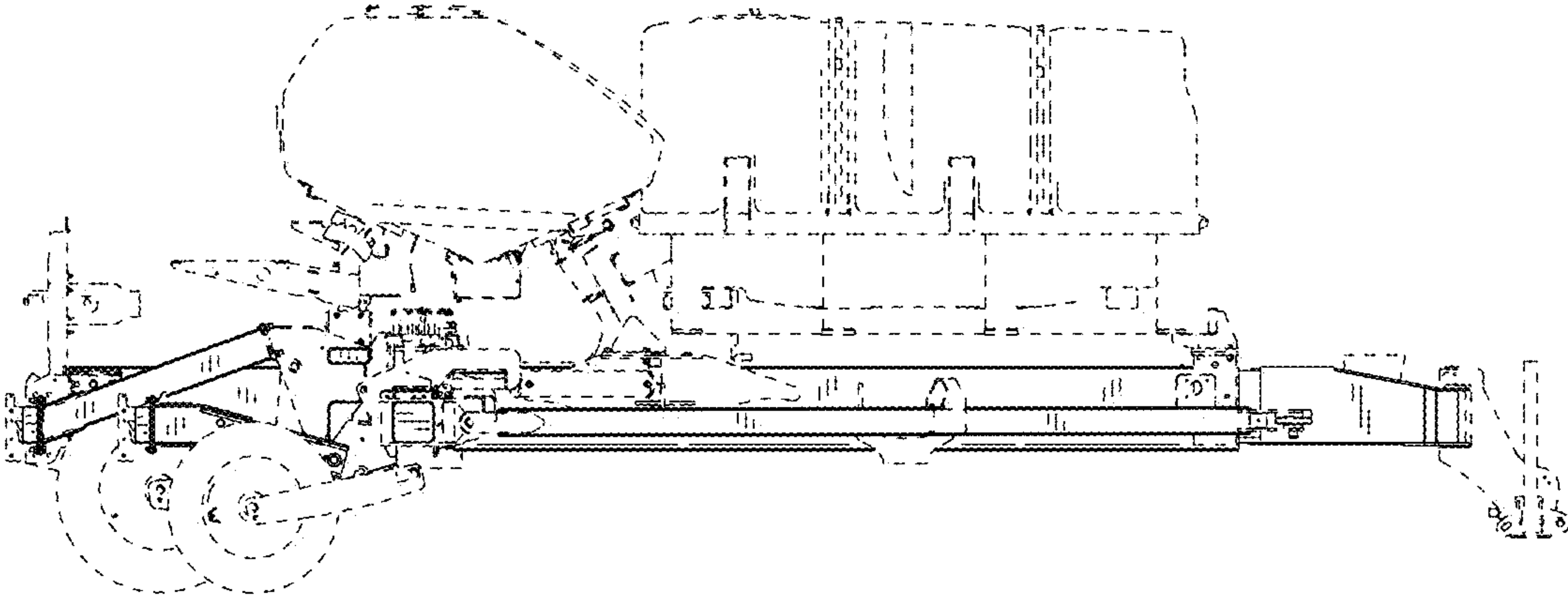

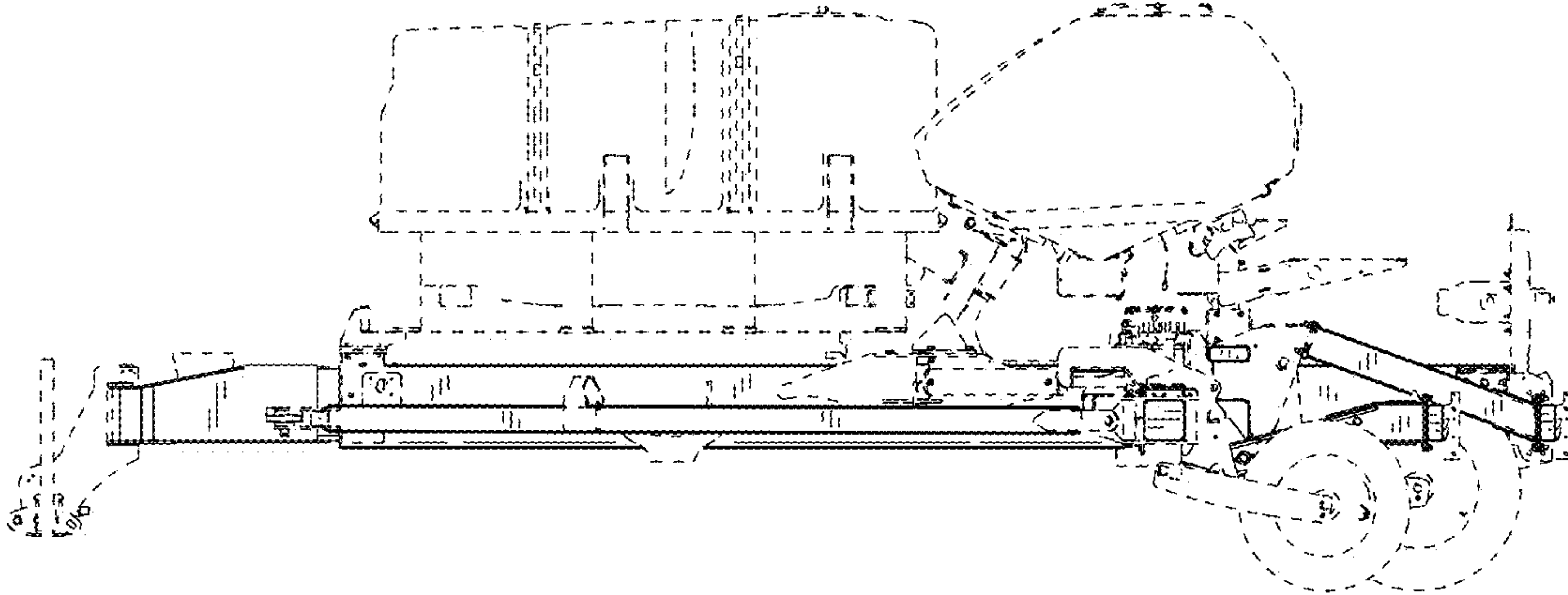

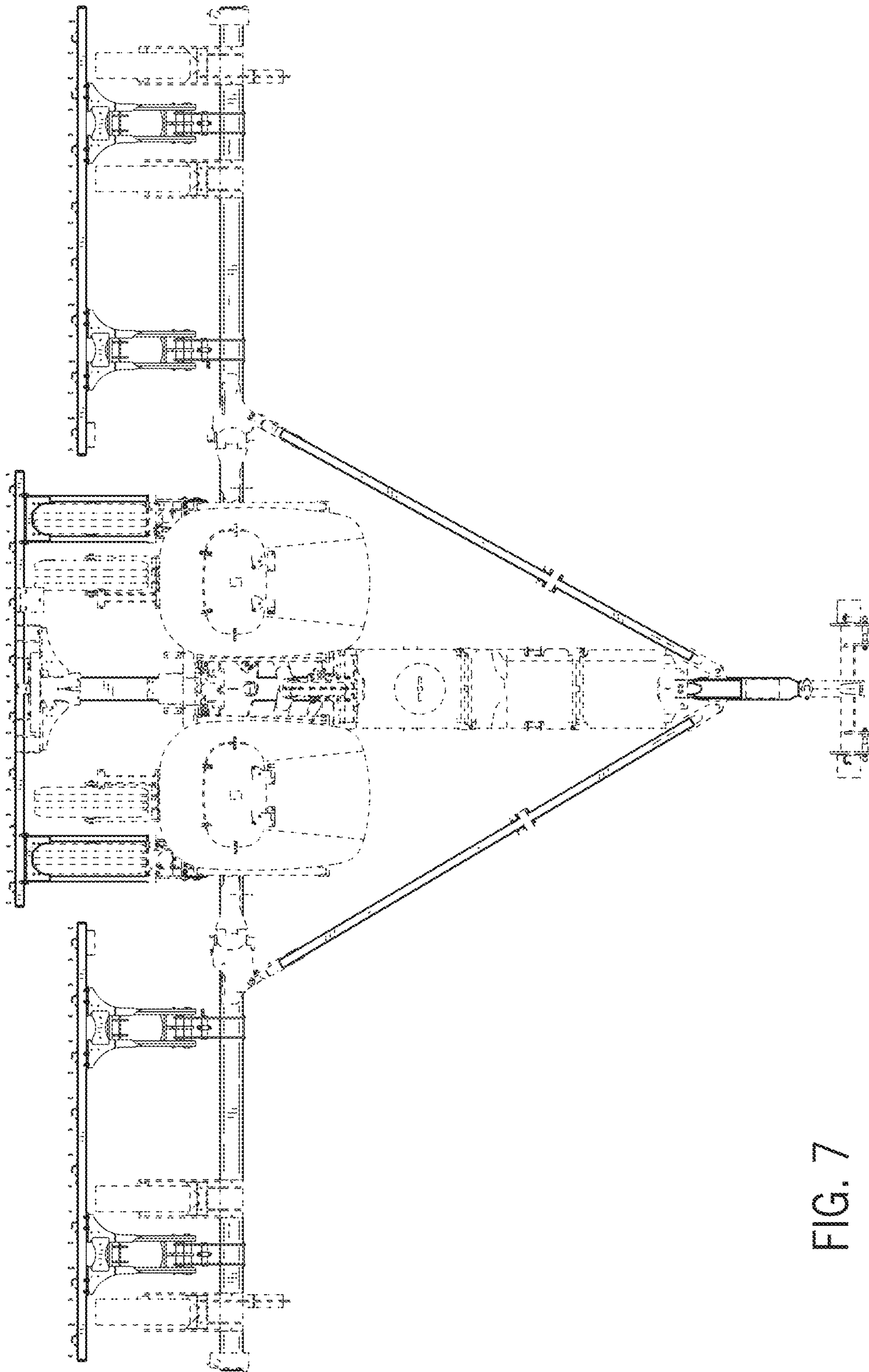

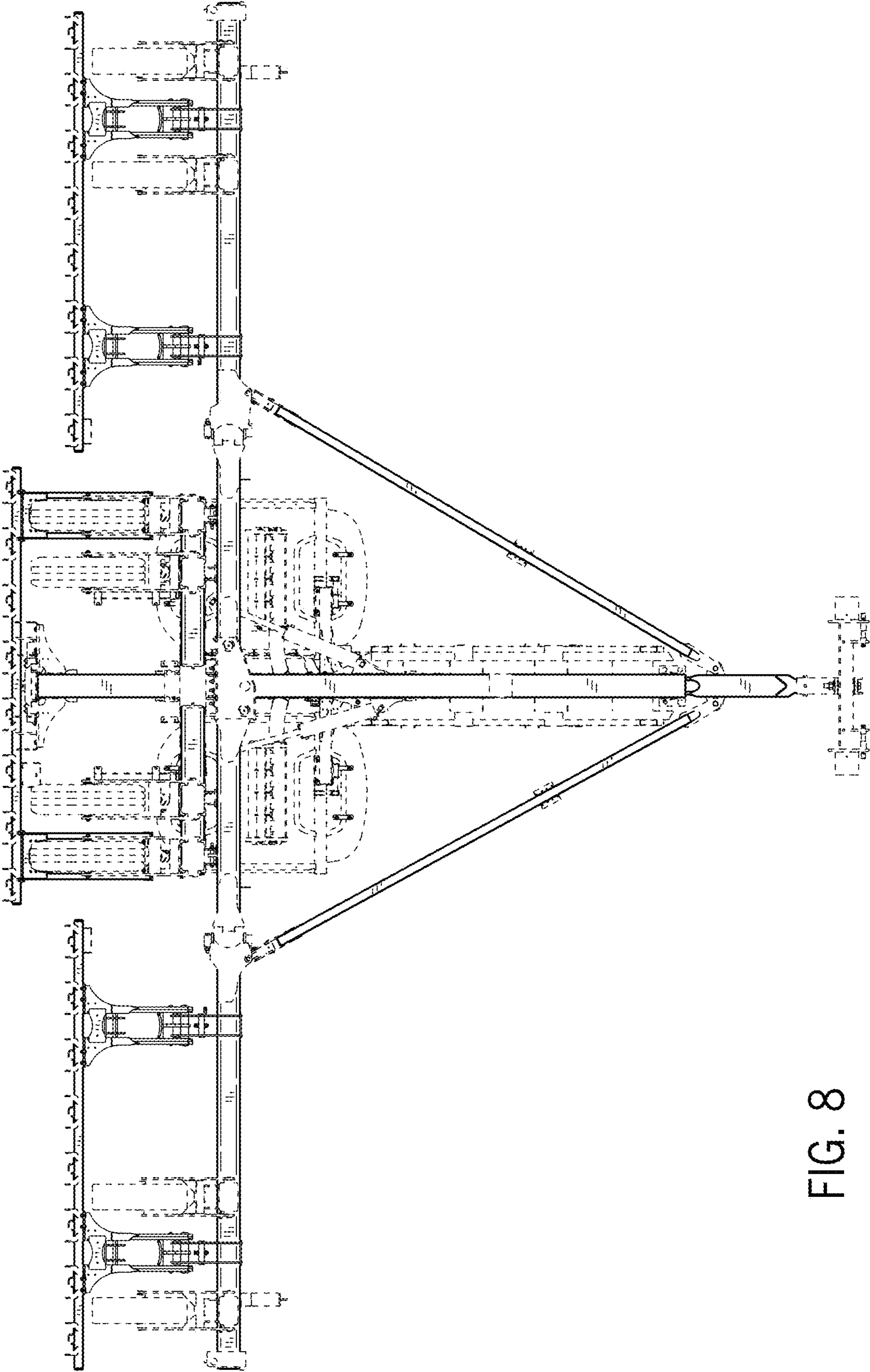

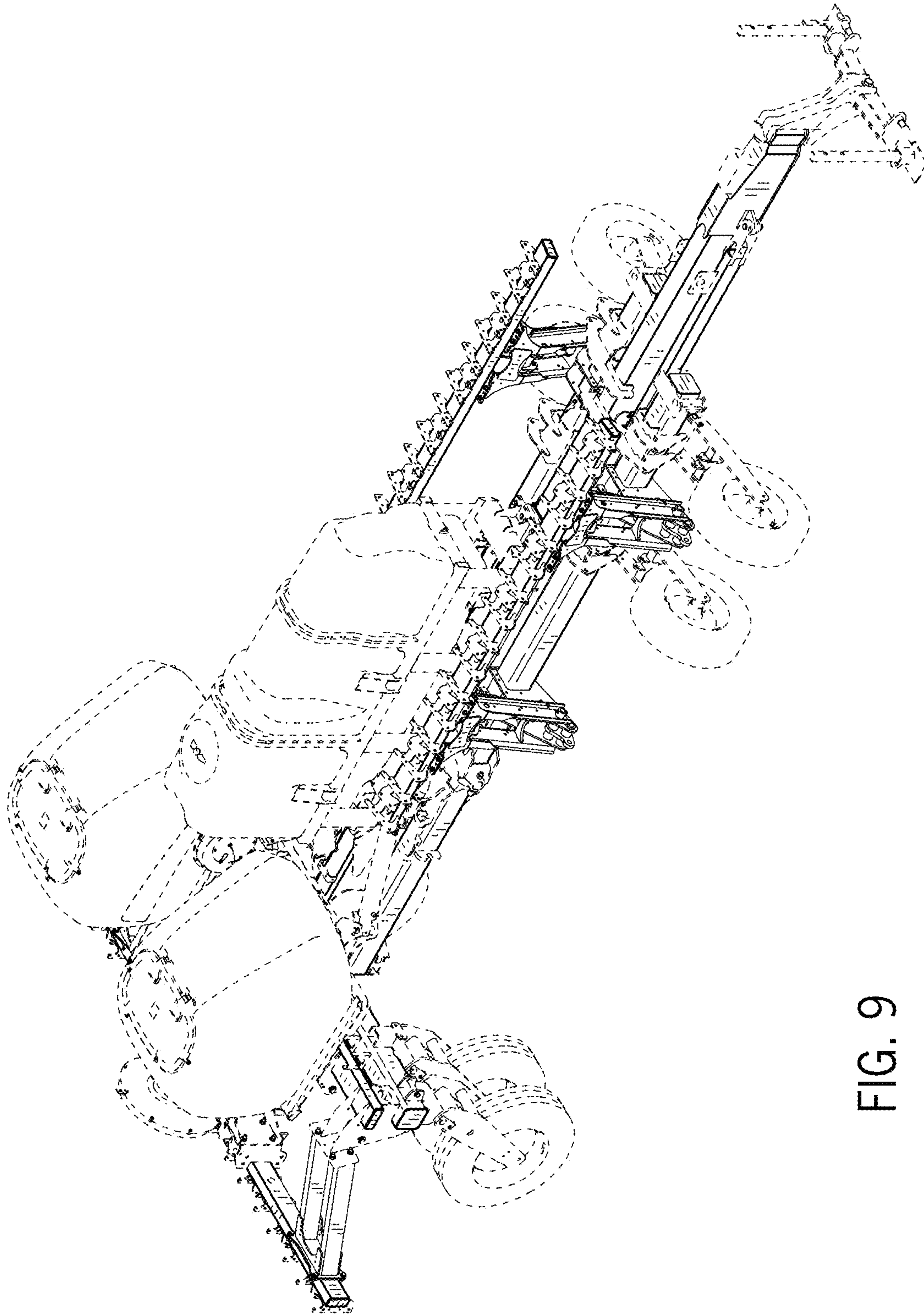
