(57) **CLAIM**

We claim the ornamental design for a game board, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a game board showing our new design; and,
FIG. 2 is a front view thereof.
The rear view, the right side view, and the left side view of the game board shown in FIGS. 1-2 are each identical to the front view shown in FIG. 2.
The bottom view of the game board shown in FIGS. 1-2 is flat and has no surface ornamentation.
The broken lines in the drawings illustrate portions of the game board that form no part of the claimed design.

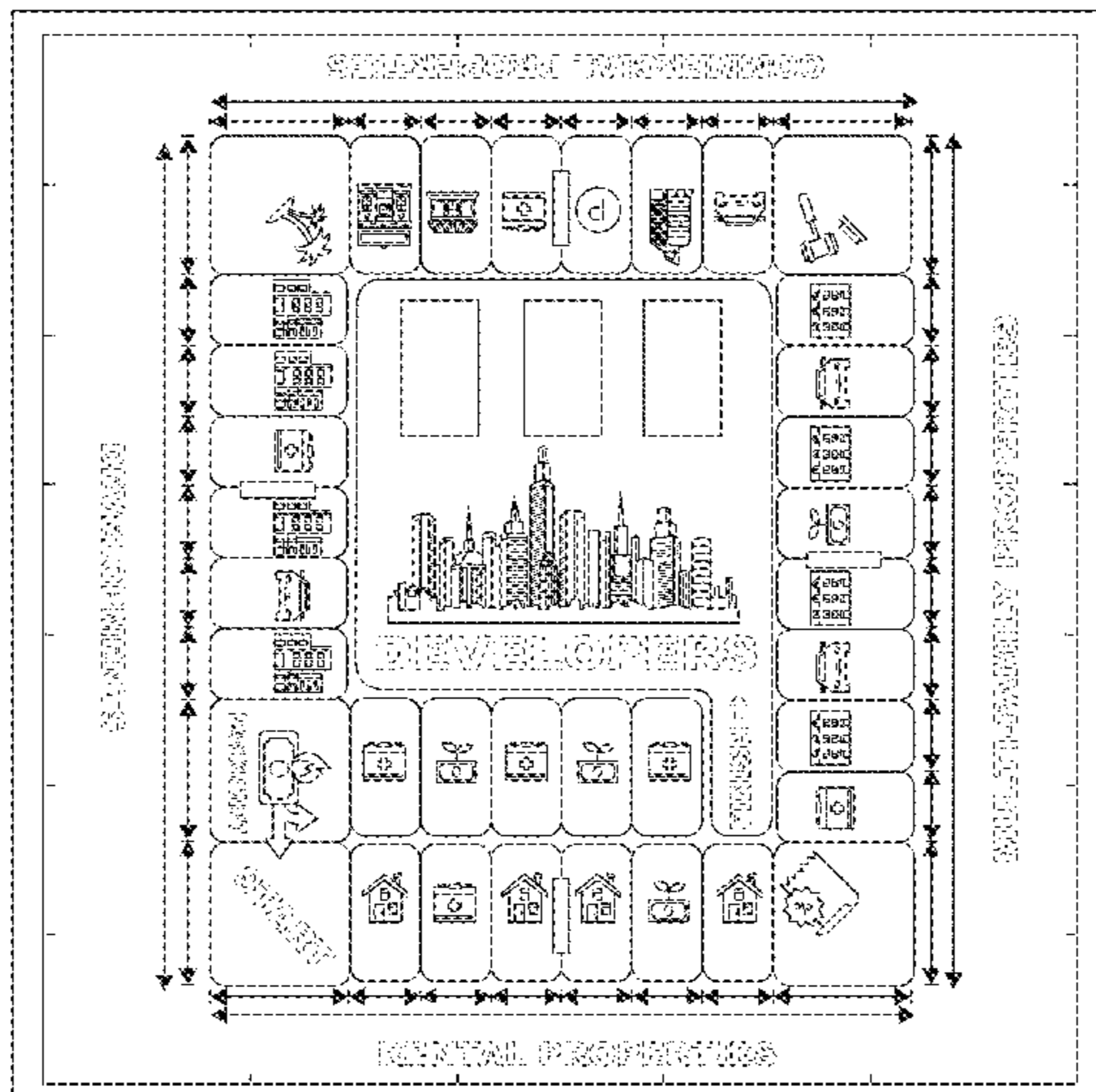

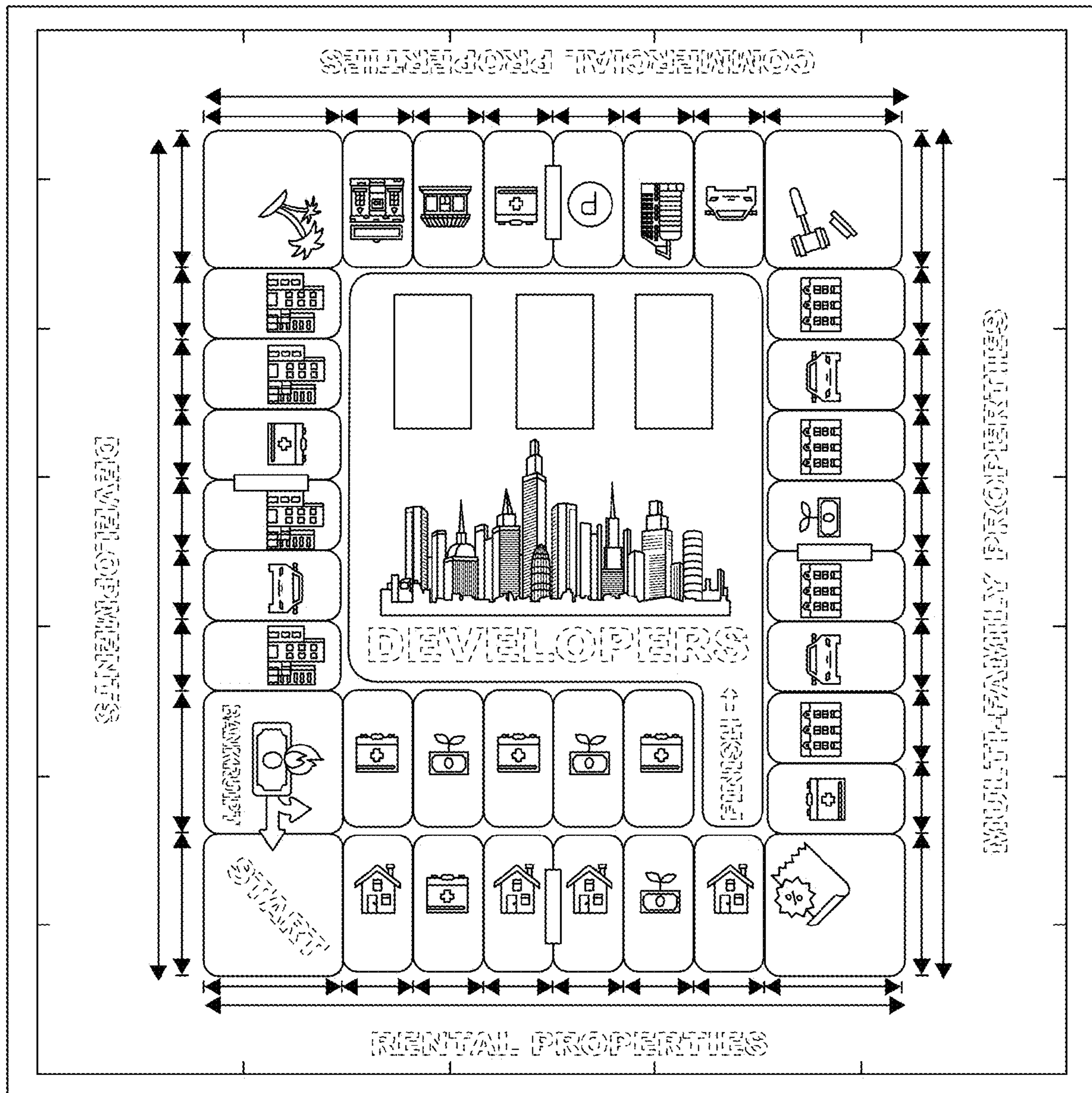
