**DESCRIPTION**

FIG. 5 is a front elevational view of the roller skate toe cap.

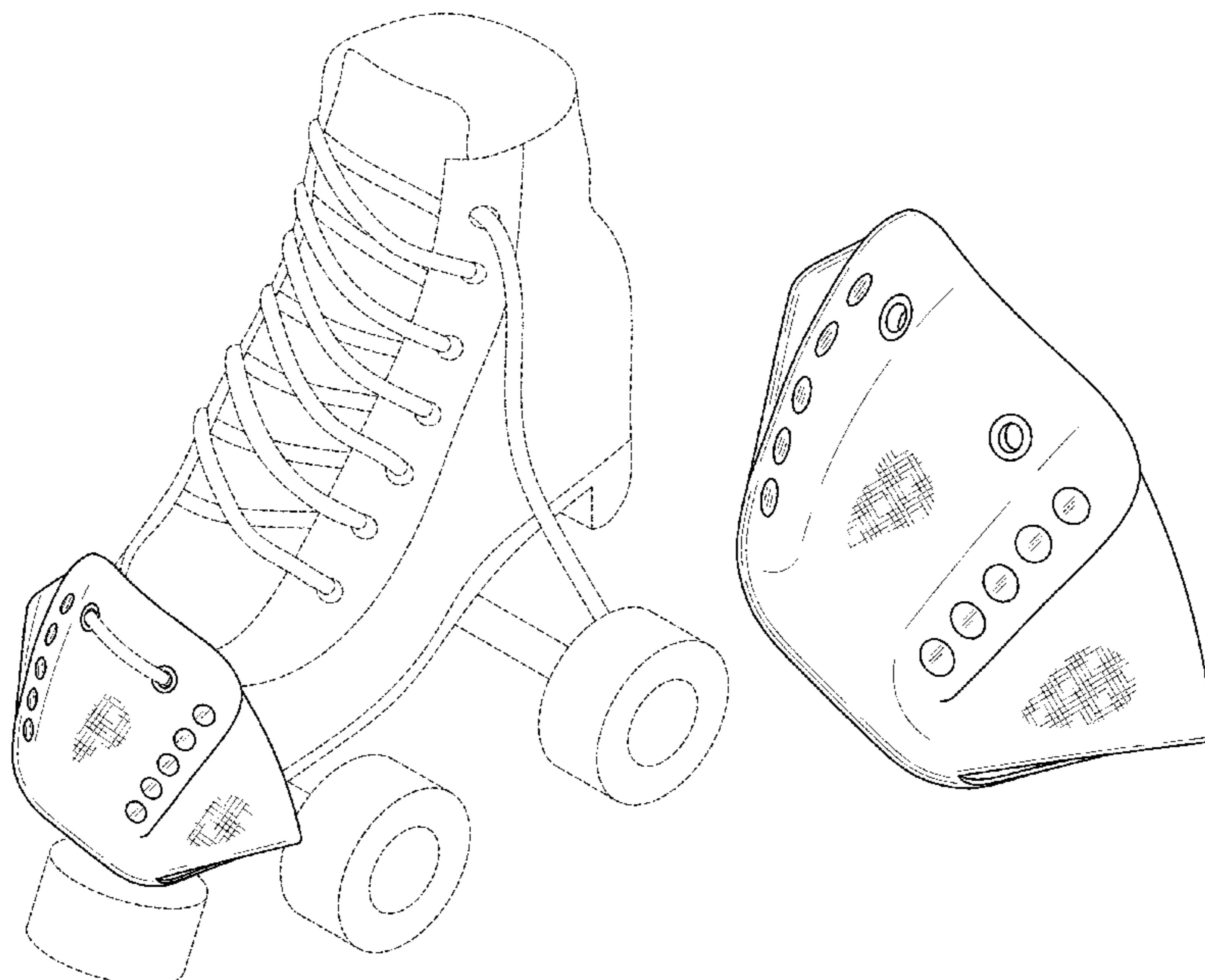
FIG. 6 is a rear elevational view of the roller skate toe cap.

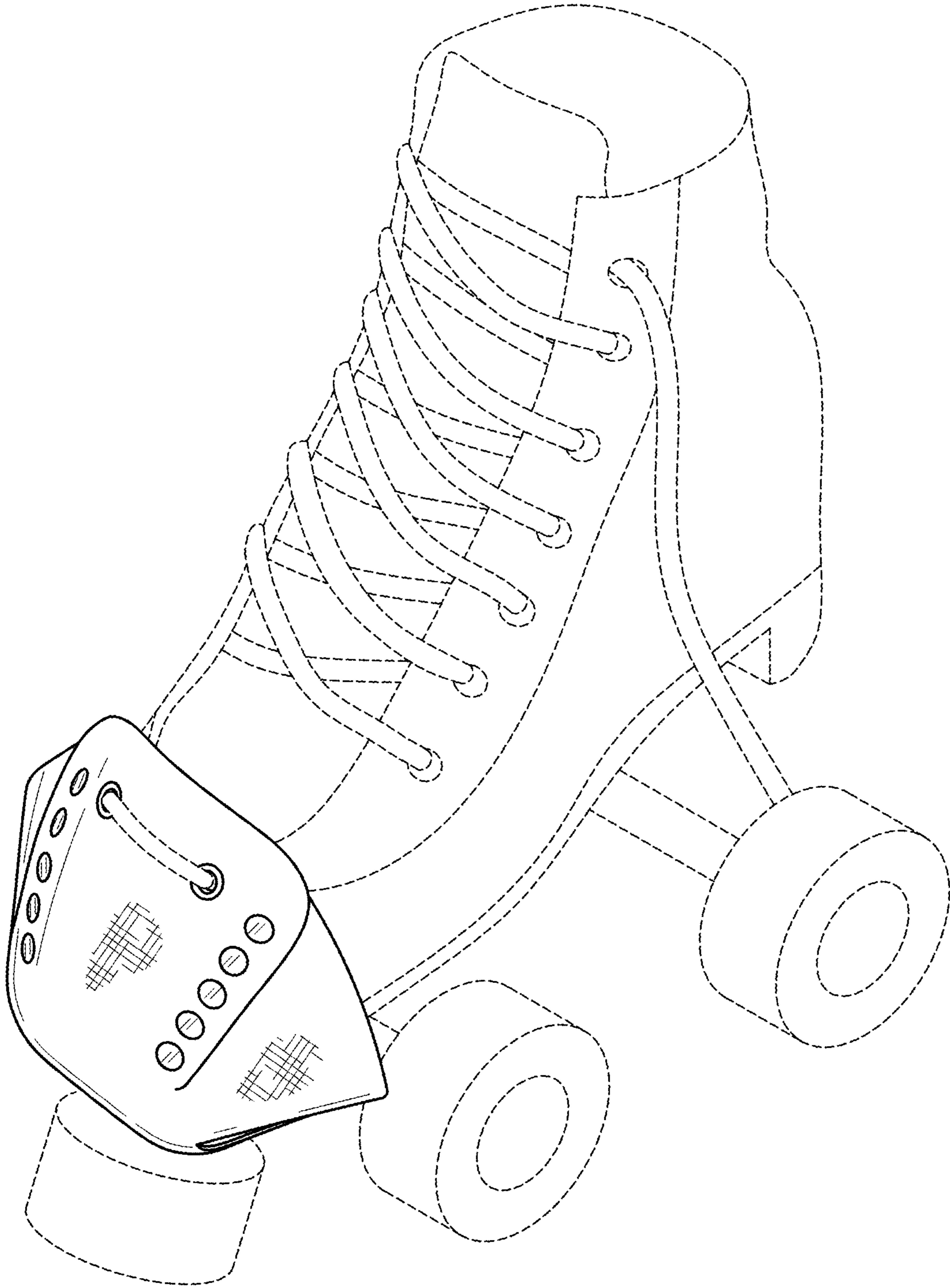

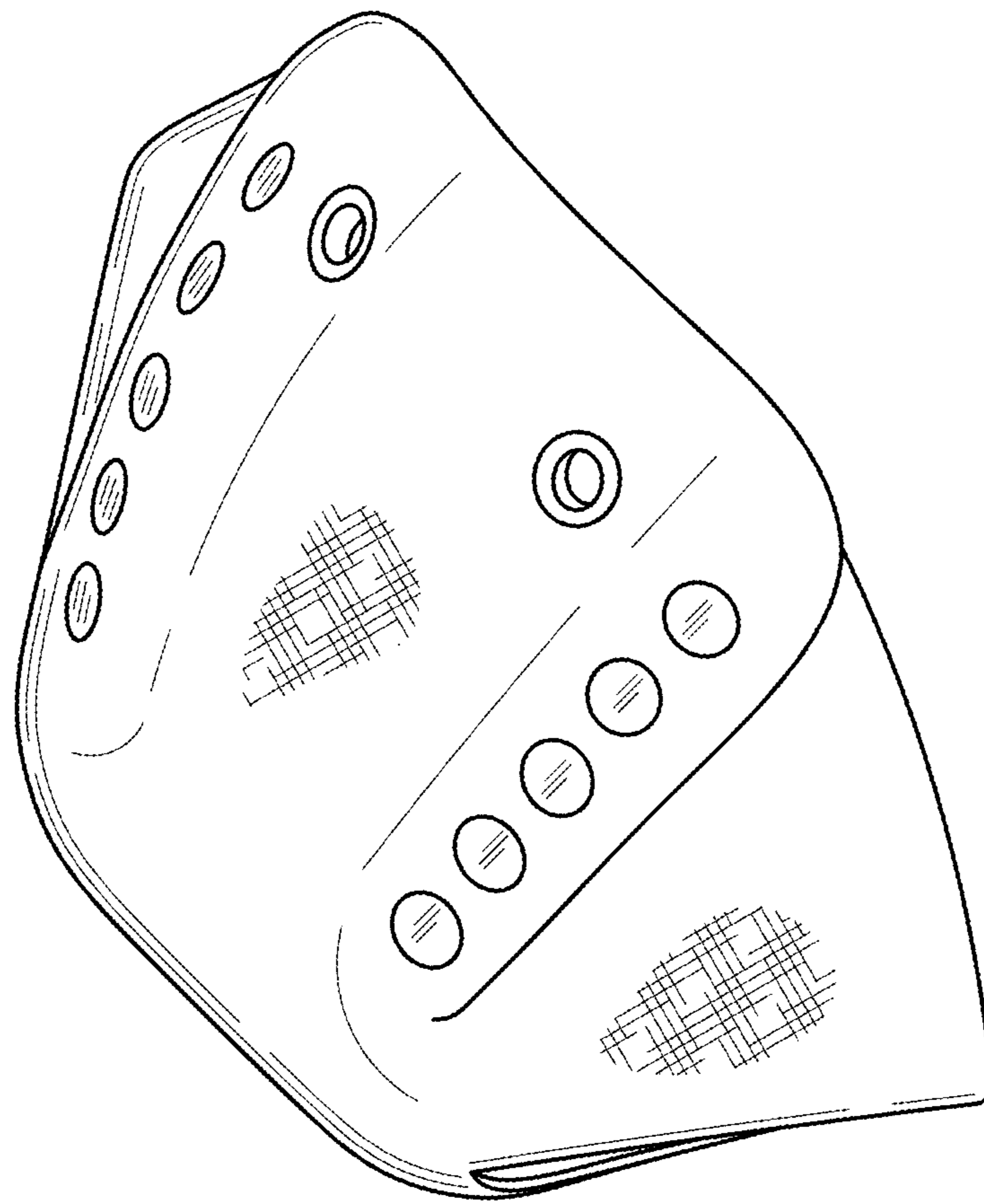

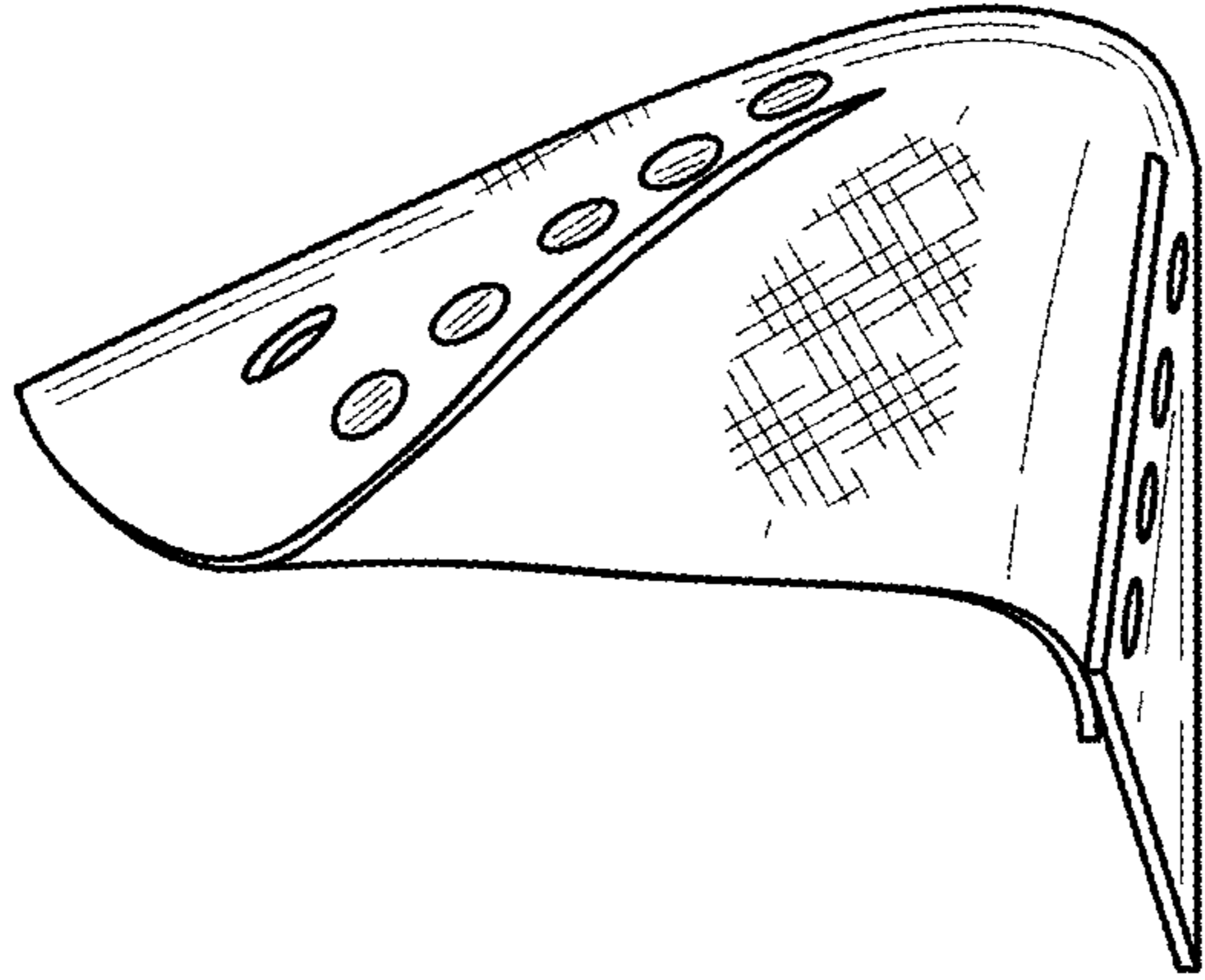

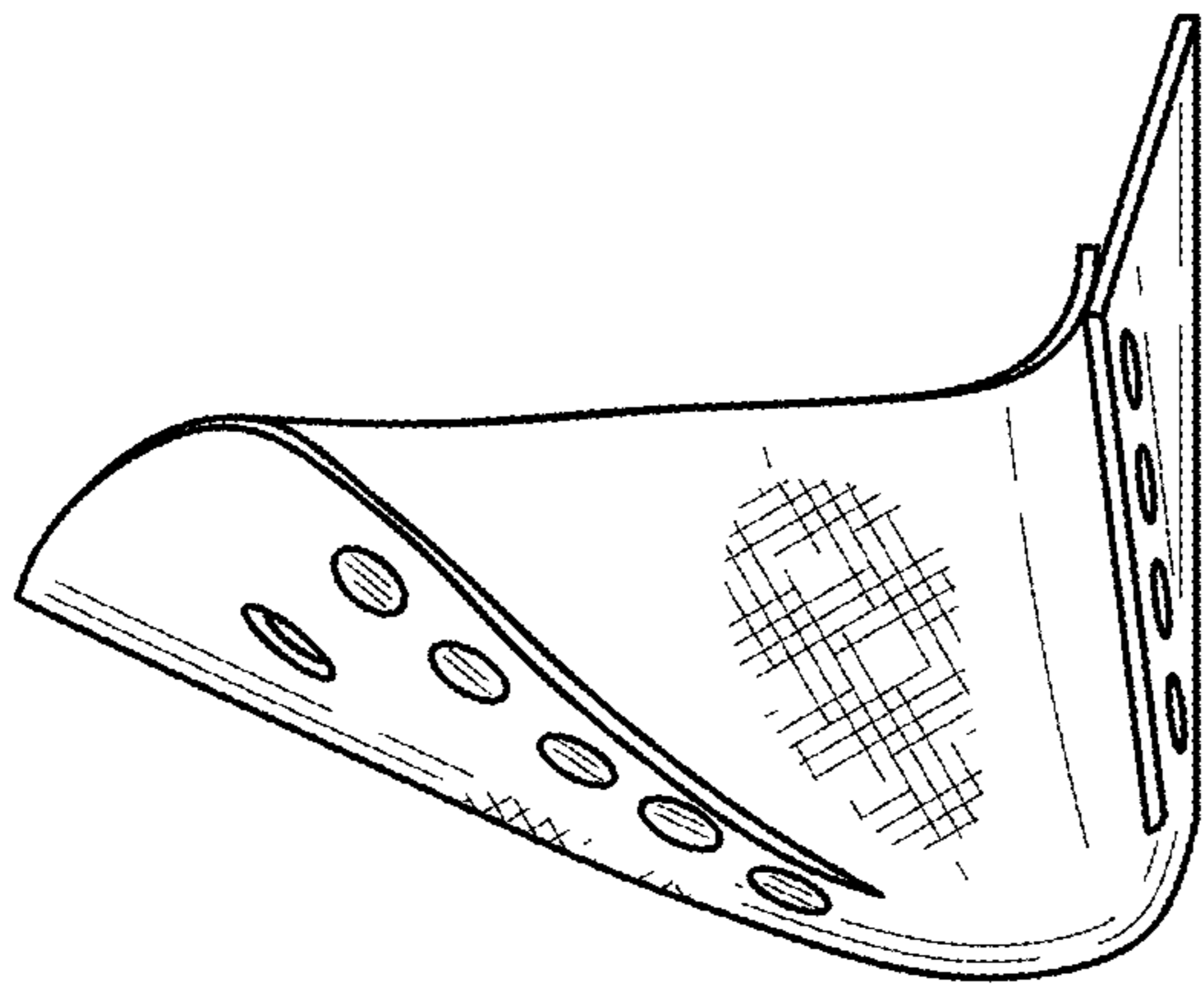
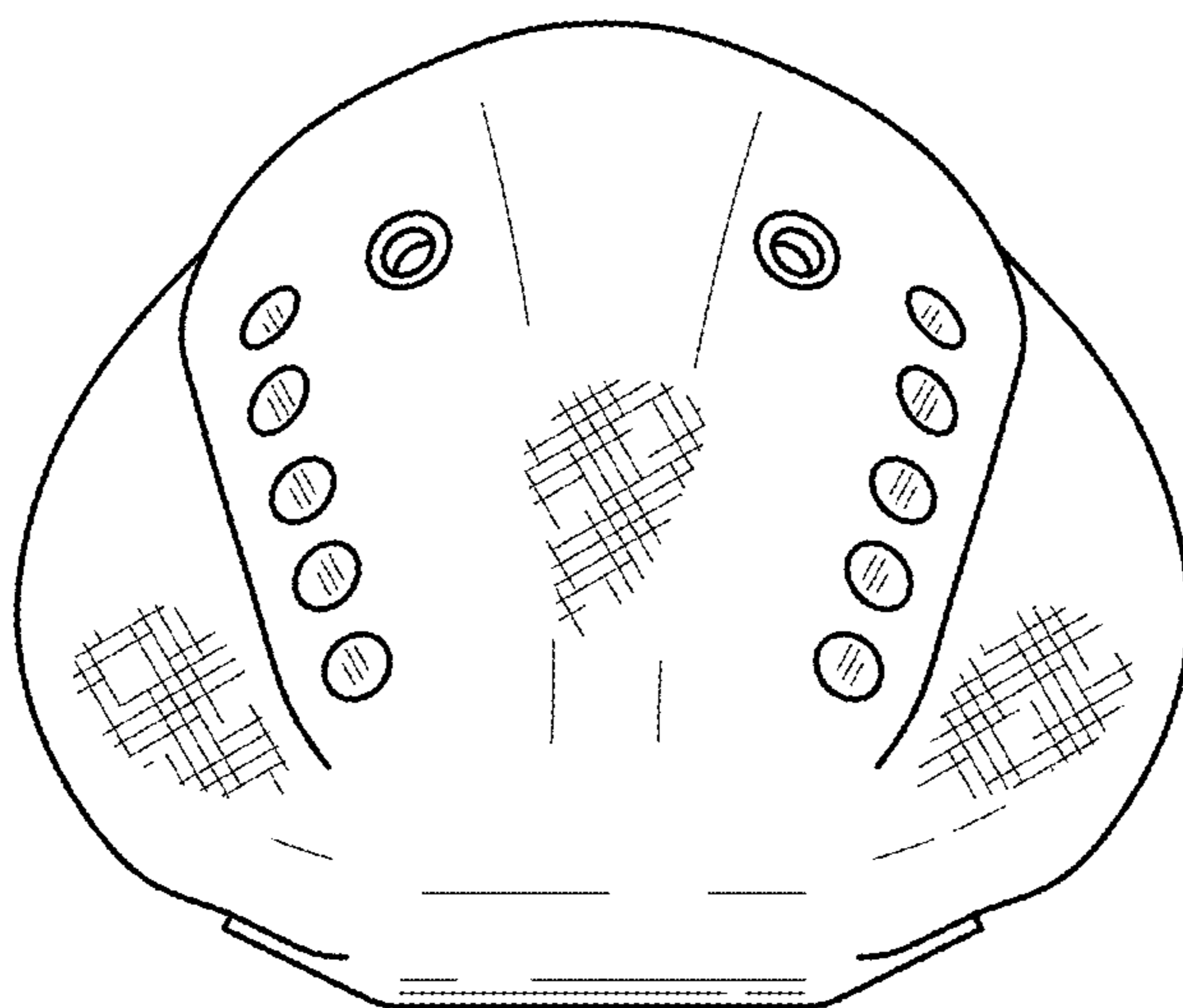
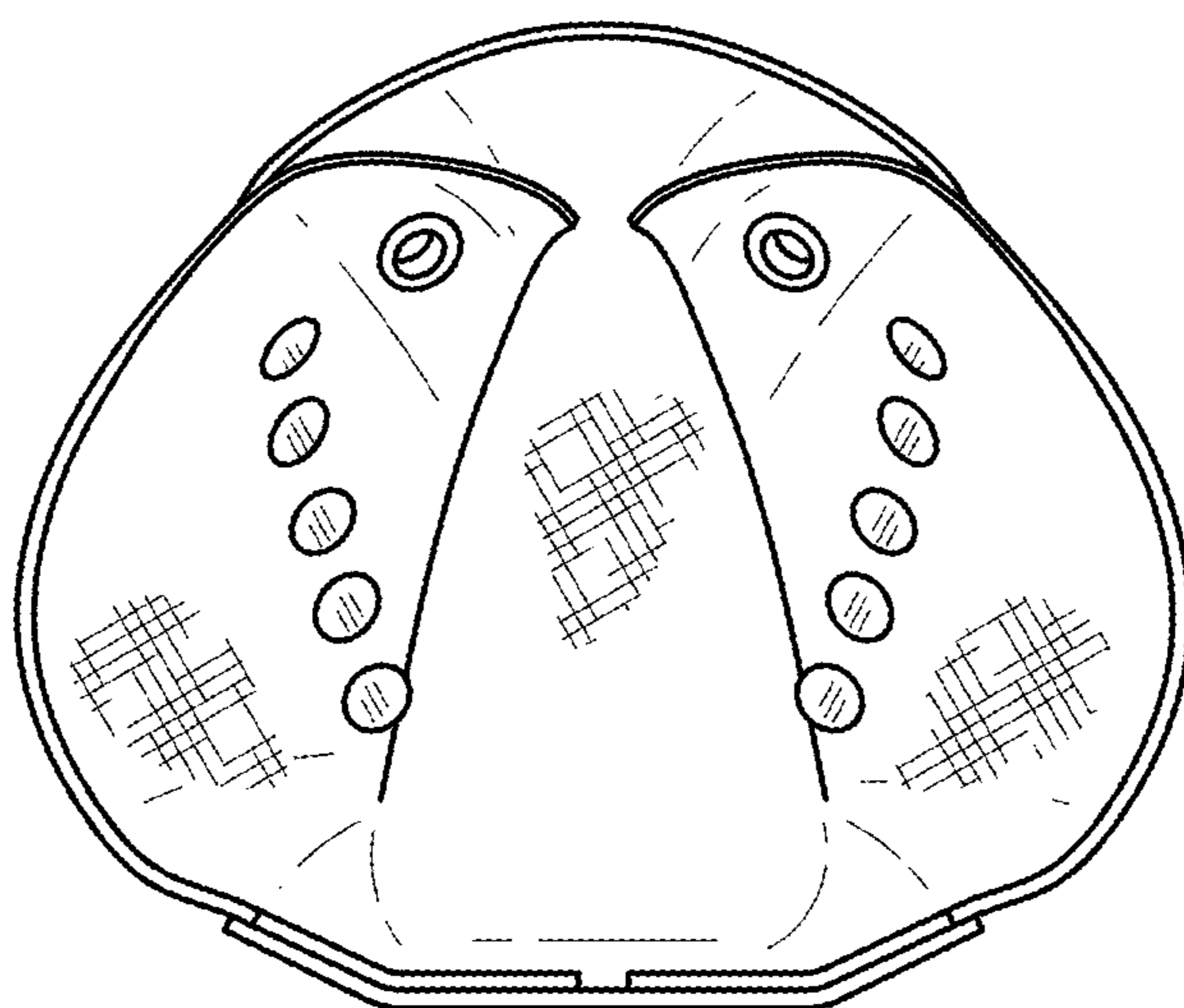

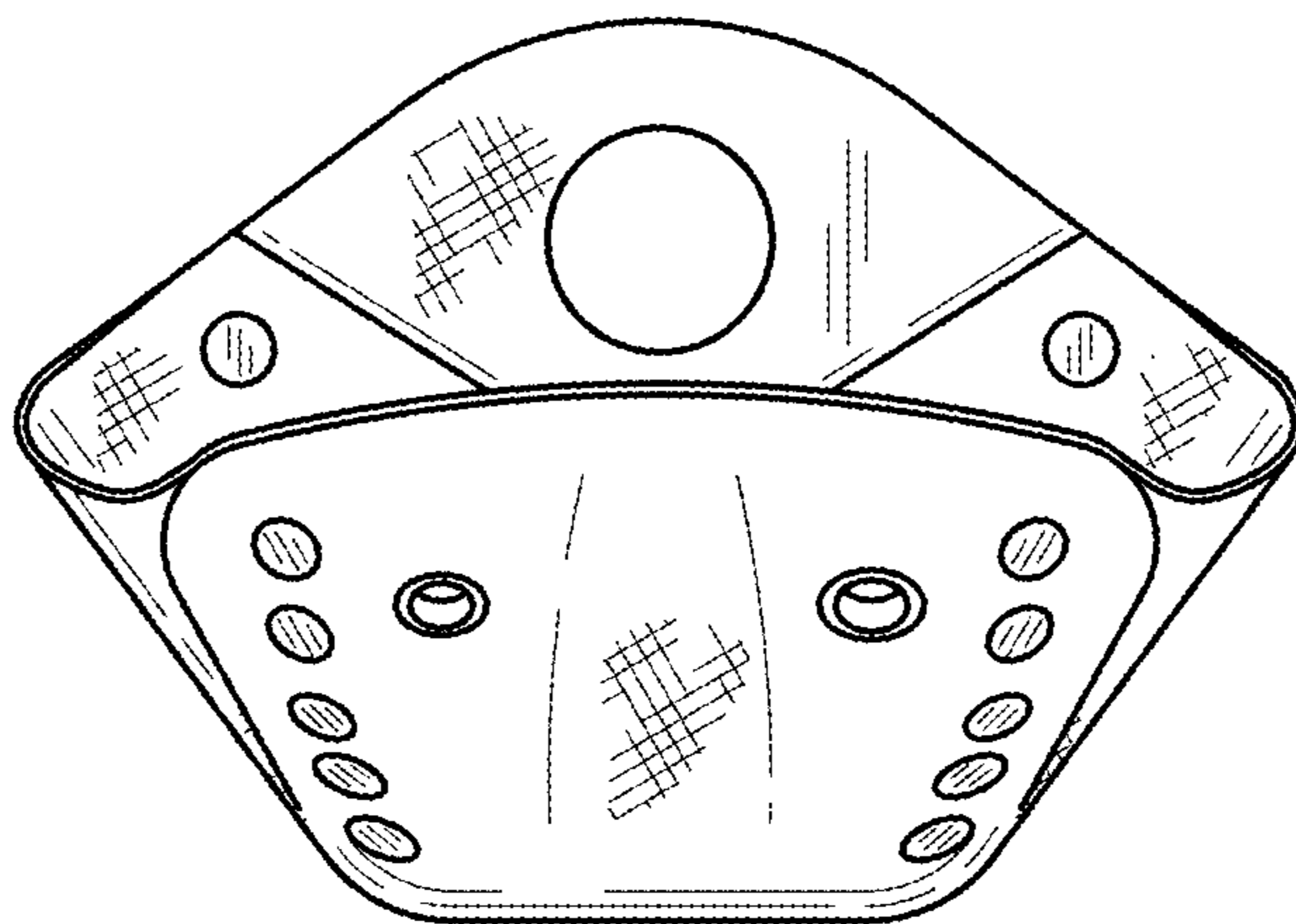

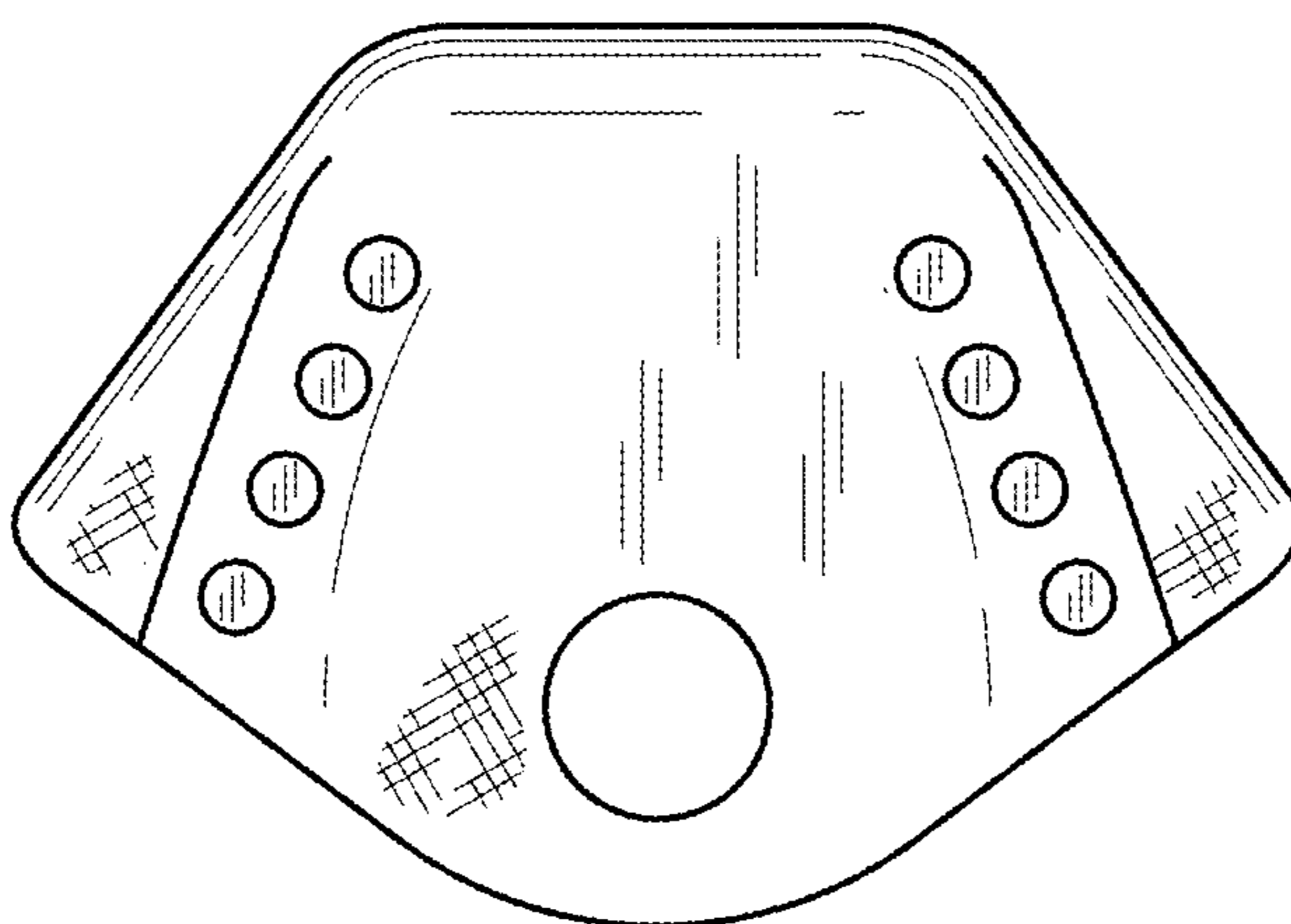
